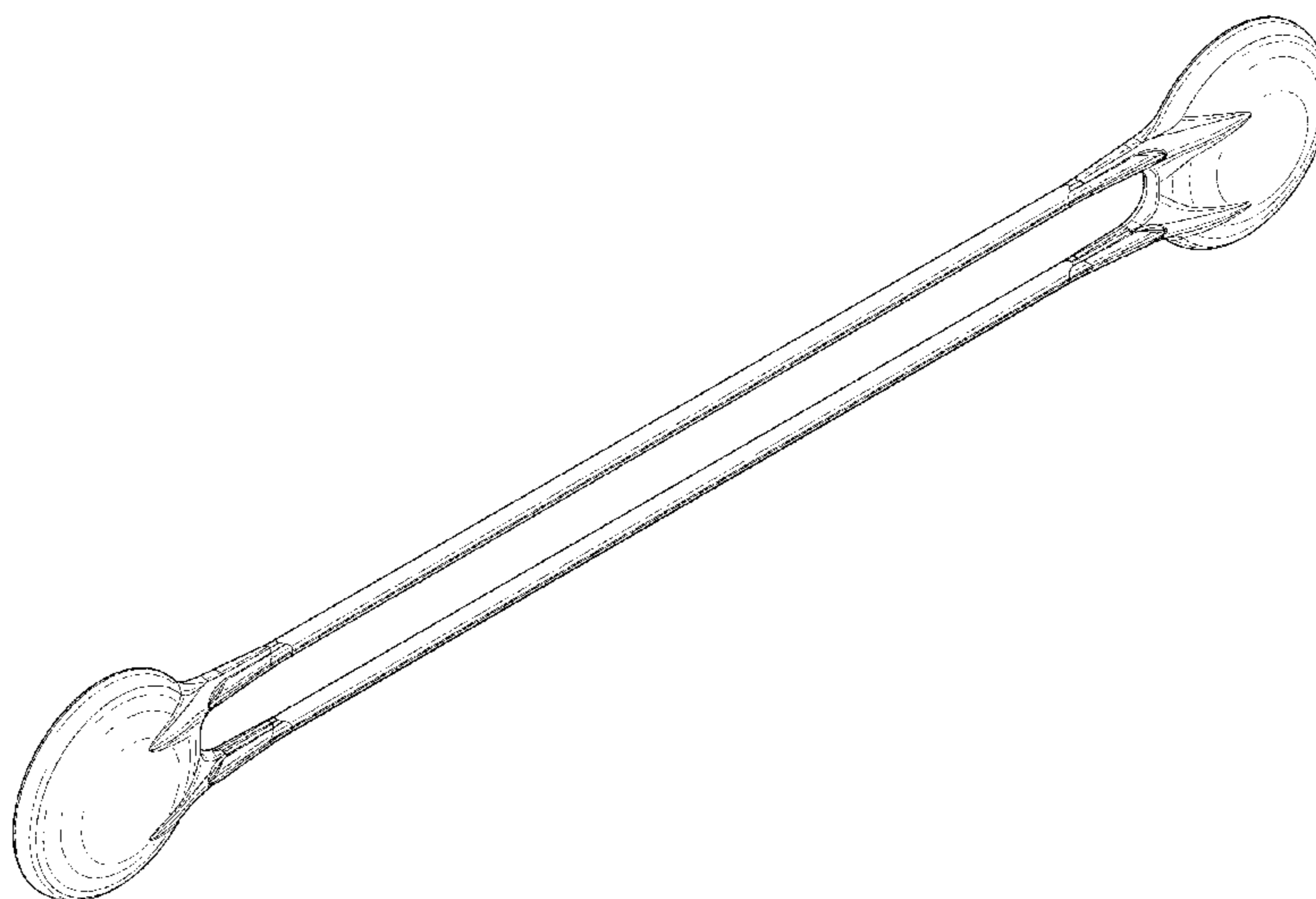
The ornamental design for a garment securing device, as shown and described.

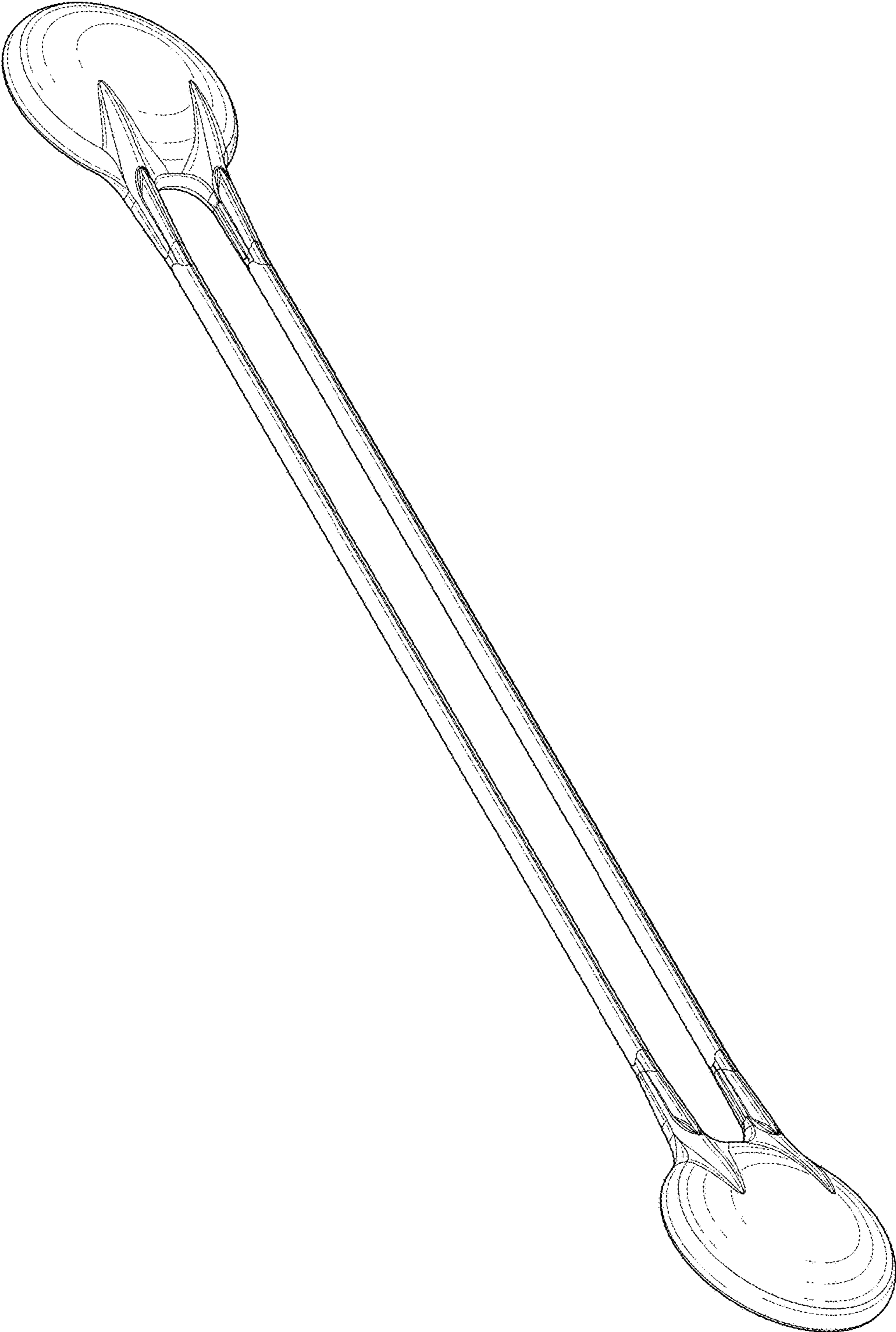

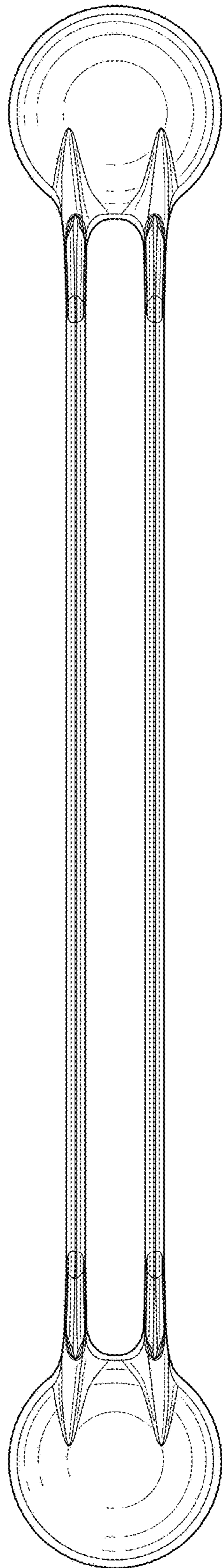

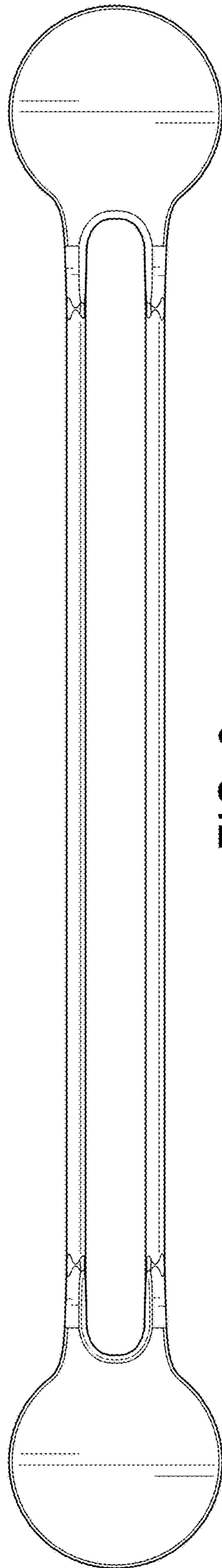

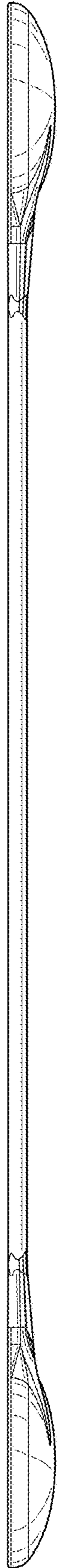
