(57) **CLAIM**

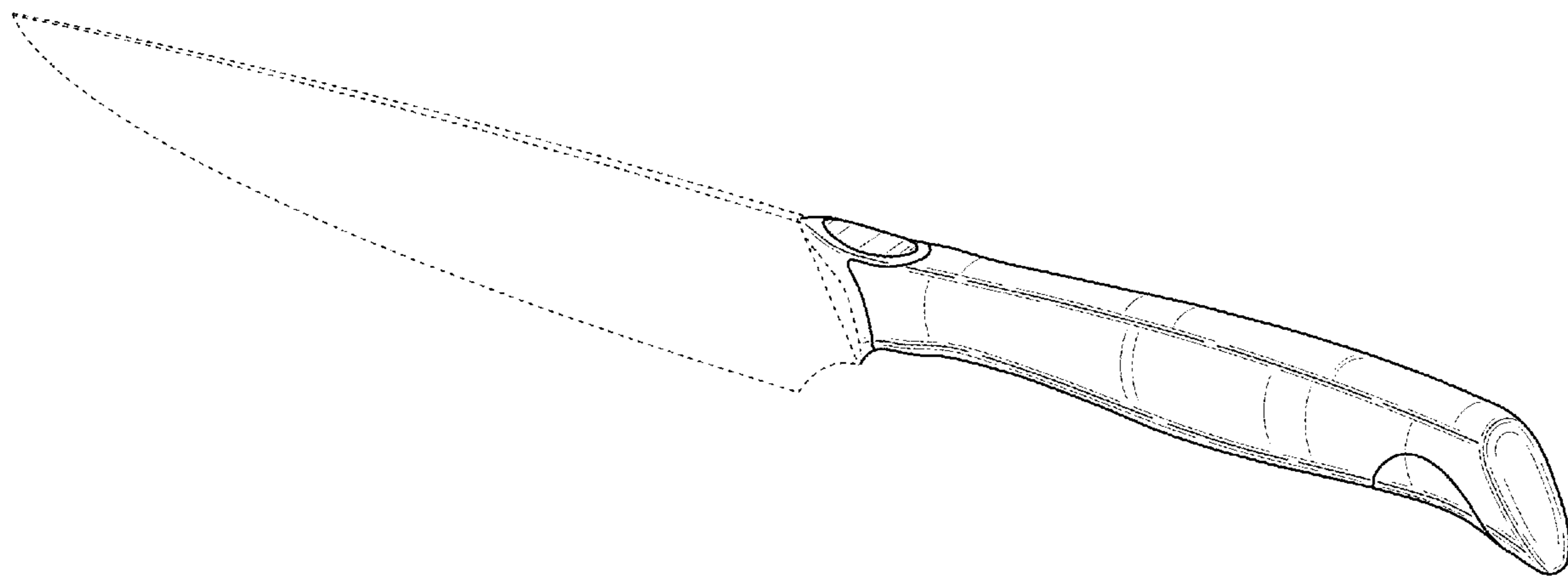
The ornamental design for a utensil handle and/or replica thereof, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a utensil handle and/or replica thereof in accordance with the present design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof, the left side view thereof being a mirror image of the right side view;

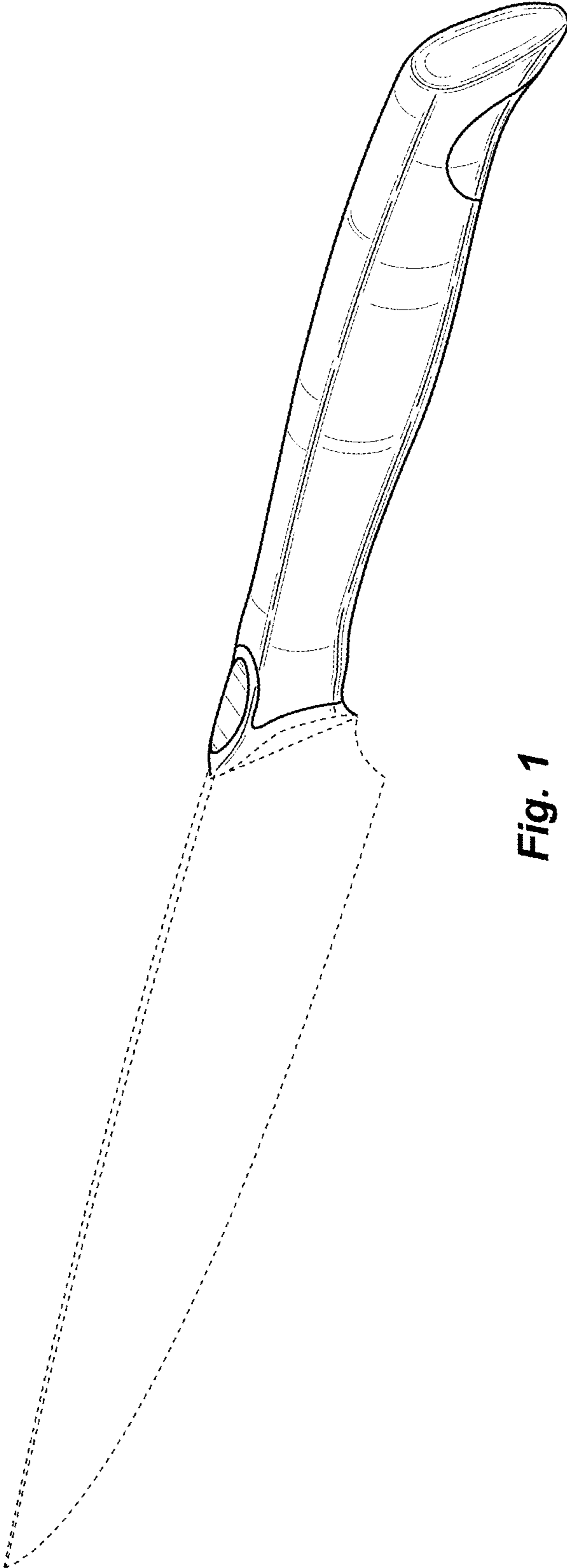

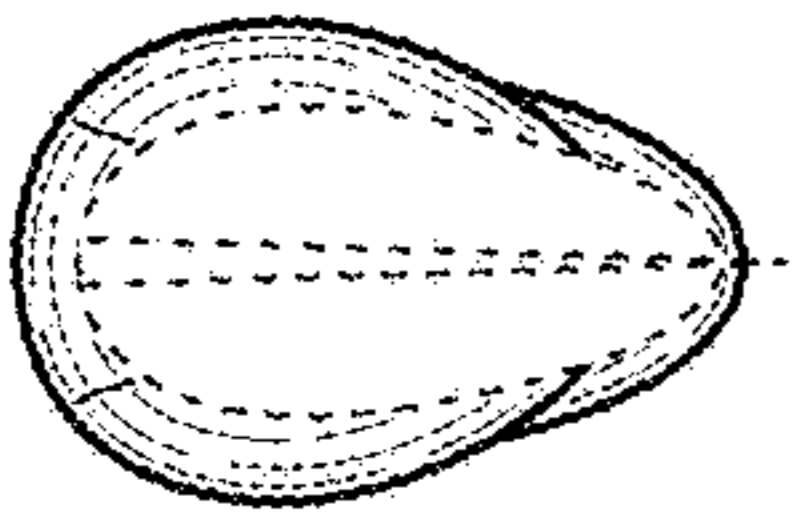

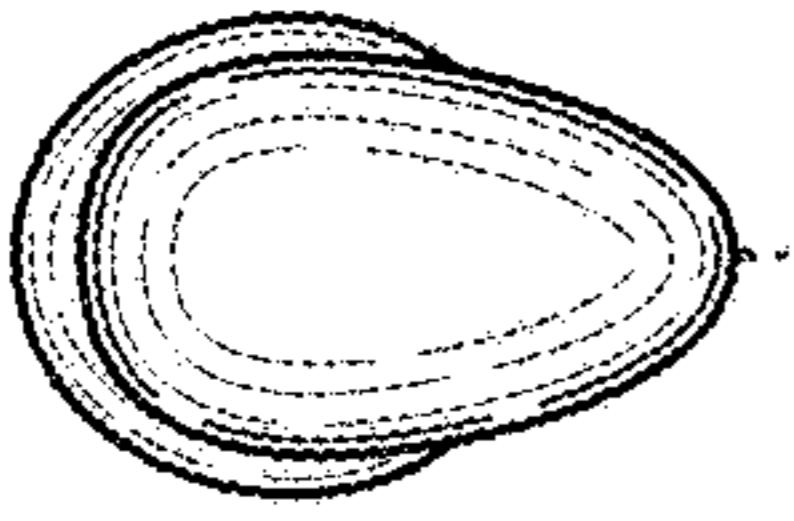

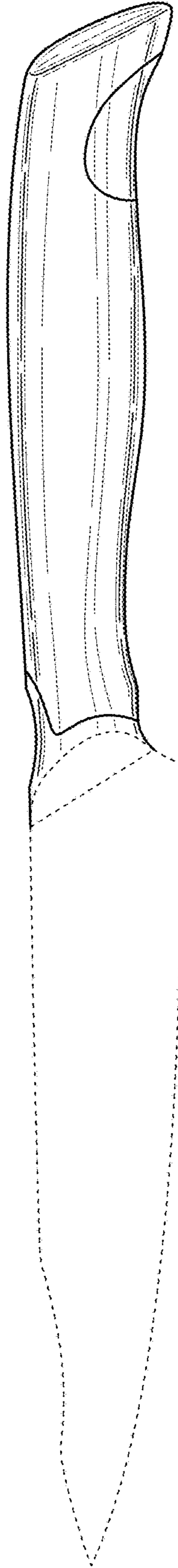

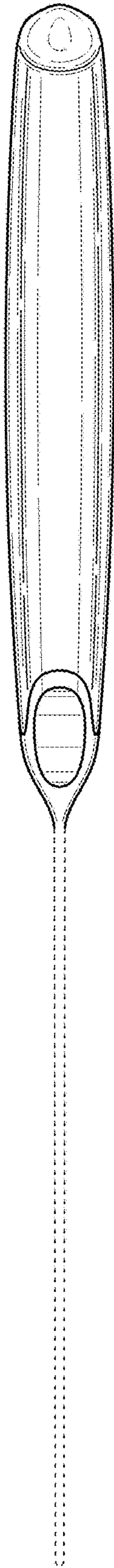

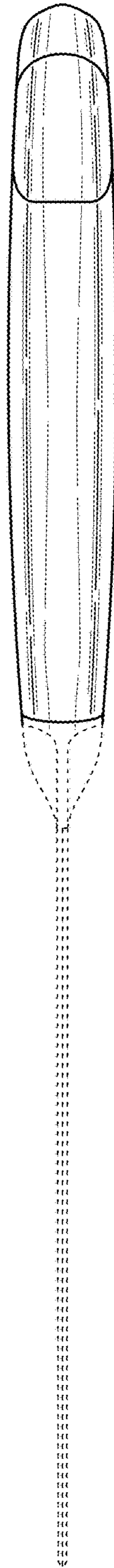
