The ornamental design for the floor mat, as shown and described.

DESCRIPTION

FIG. 1 is a front right isometric view of a first embodiment of my new floor mat design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is front side view thereof;
 FIG. 5 is right side view thereof;
 FIG. 6 is a rear side view thereof;
 FIG. 7 is a left side view thereof;
 FIG. 8 is cross sectional view taken along line 8-8 of FIG. 2; and
 FIG. 9 is cross sectional view taken along line 9-9 of FIG. 2.
 FIG. 10 is a top plan view of a second embodiment of my new floor mat design; and,
 FIG. 11 is a bottom plan view thereof; the front side, right side, rear side, and left side views being identical to FIGS. 4-7, respectively, and the cross-sectional views being mirror images of FIGS. 8-9.
 The broken dash line hatching shown in the cross sectional views of FIGS. 8 and 9 represent non-claimed subject matter and does not form any part of the claimed invention. The broken dash lines shown in the drawing views represent non-claimed subject matter and form no part of the claimed invention.

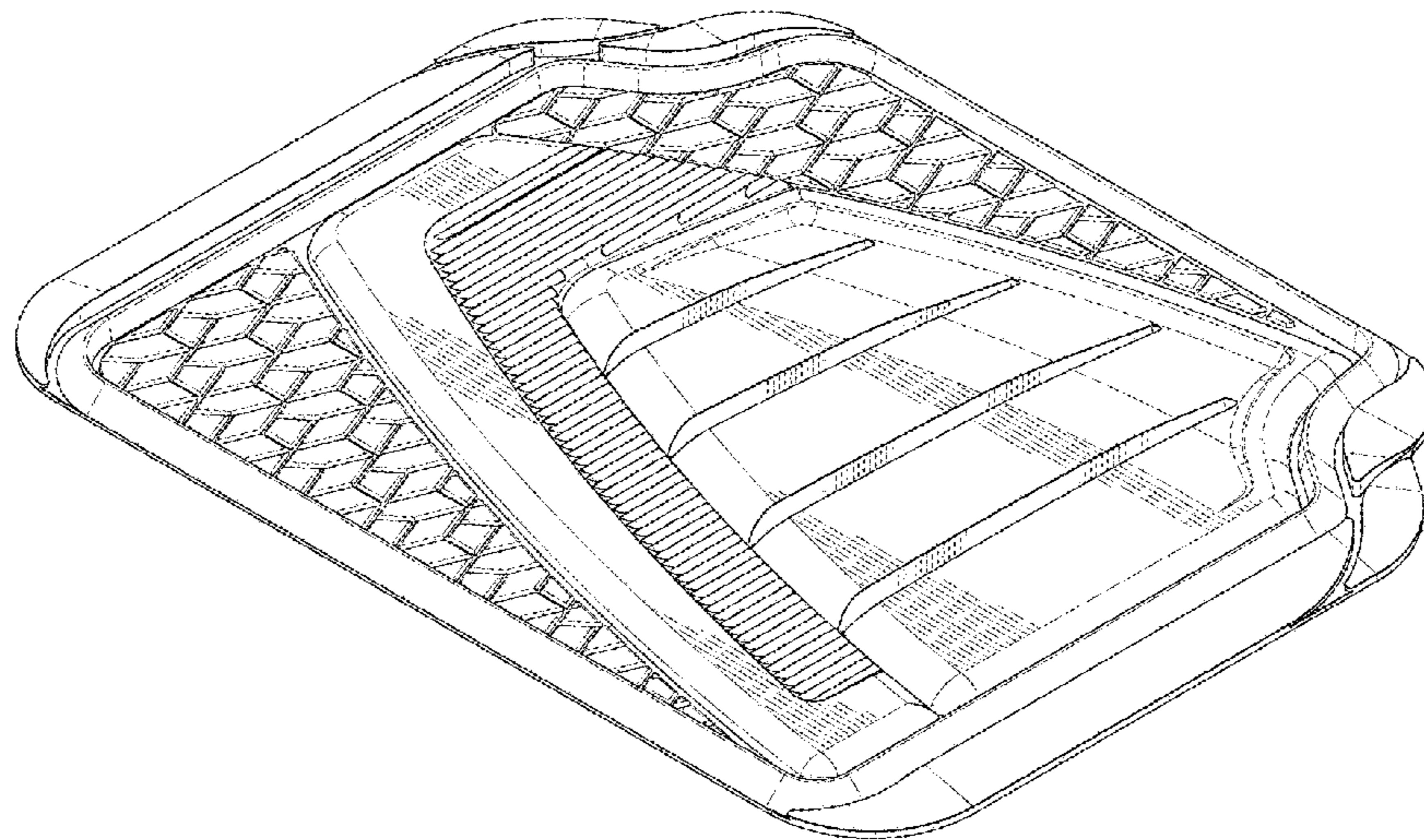

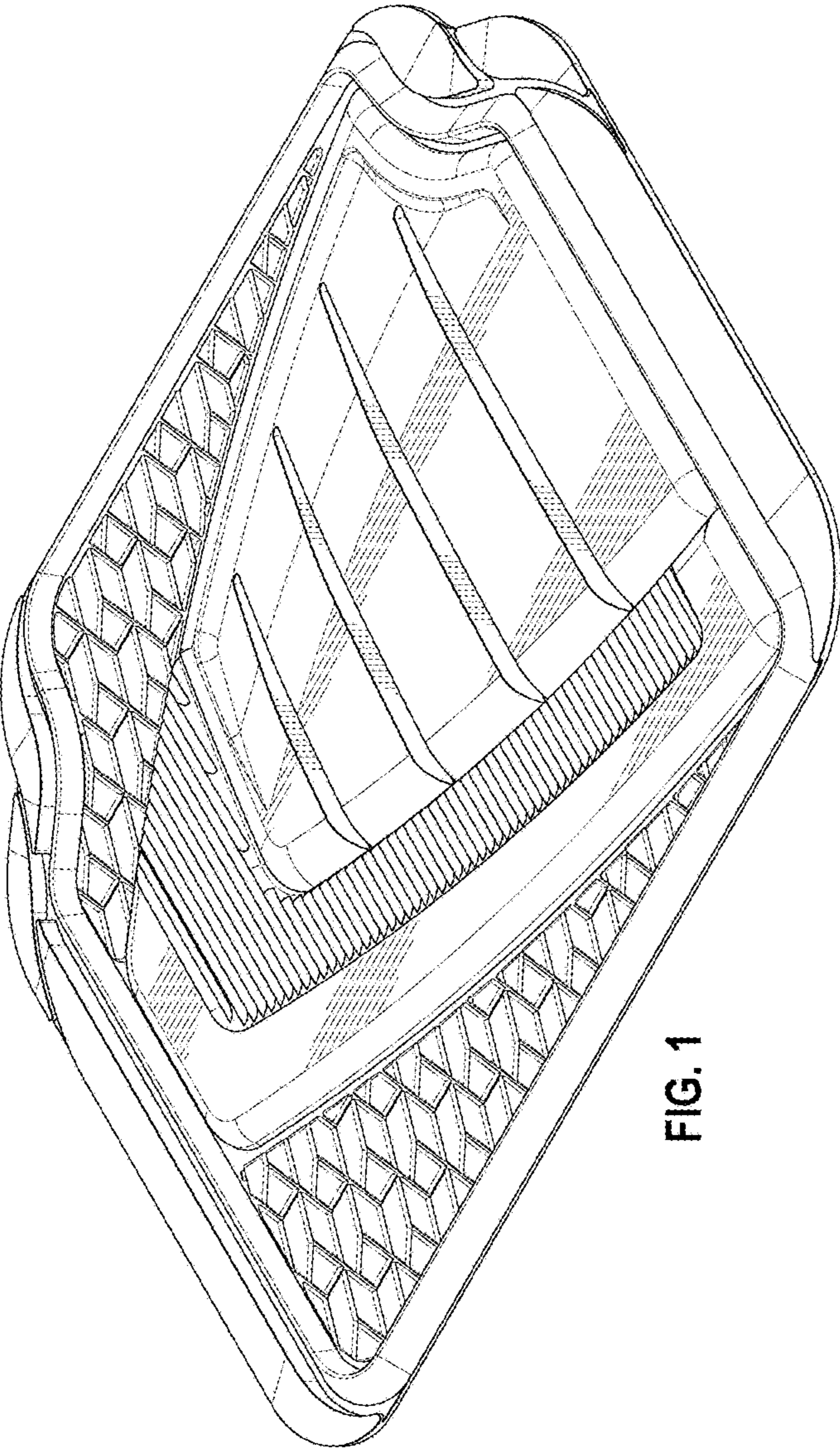

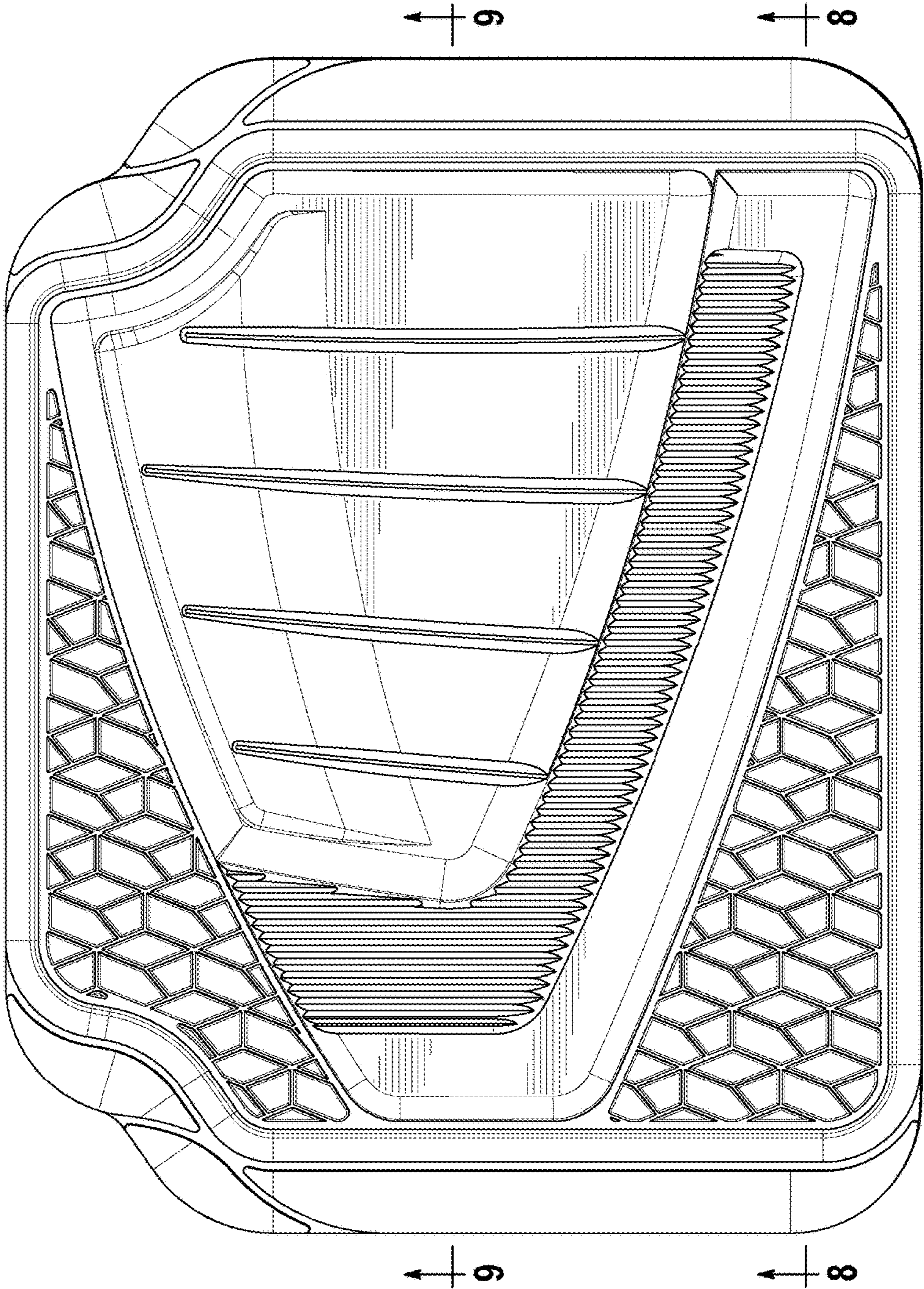

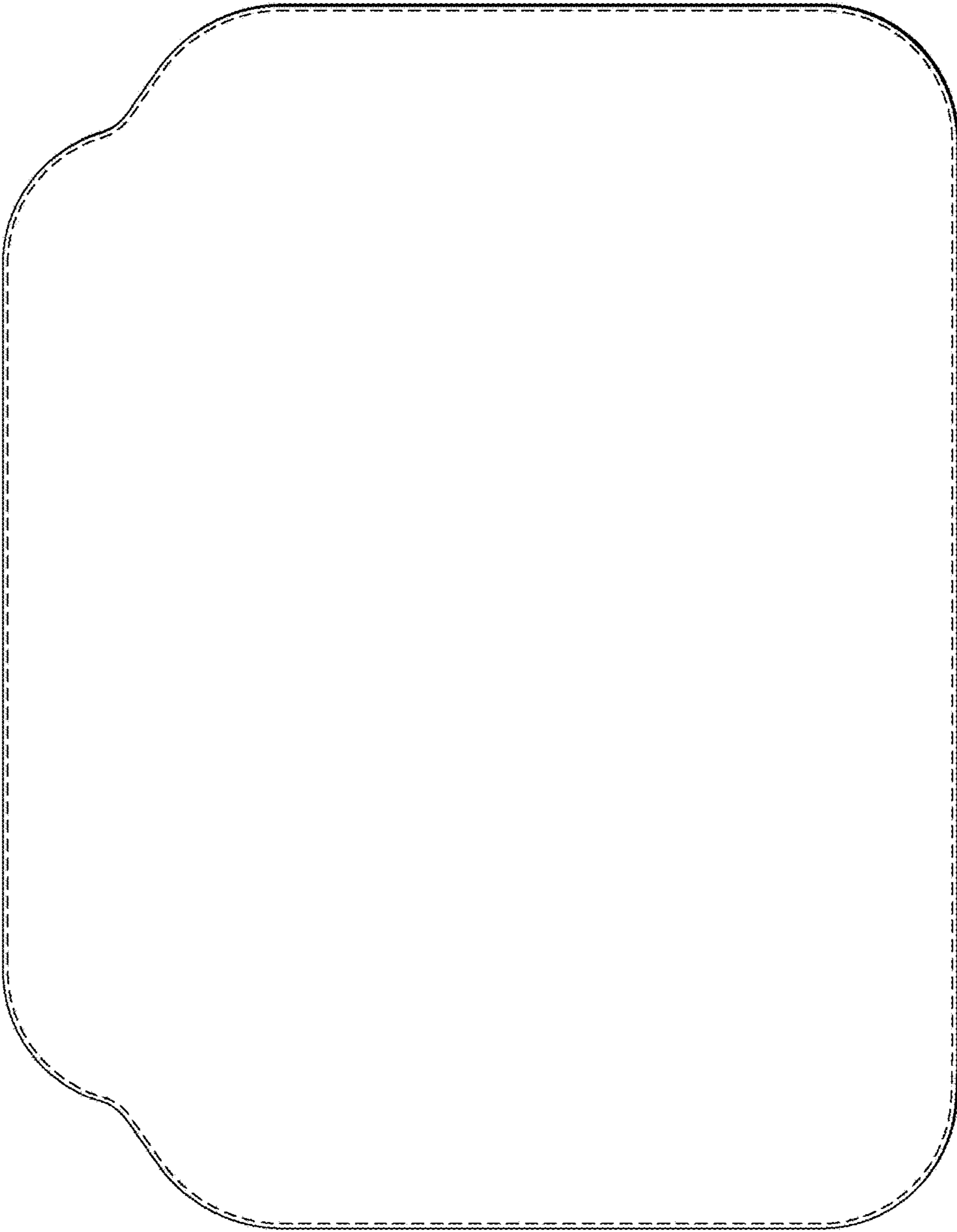

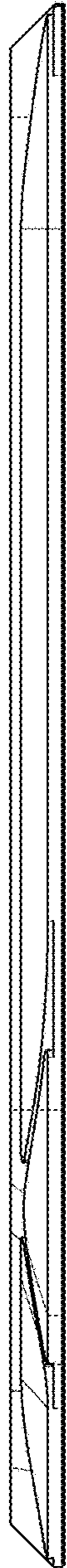

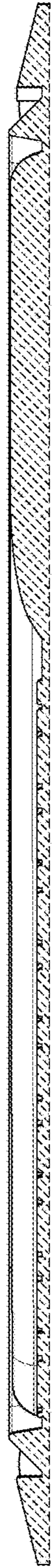

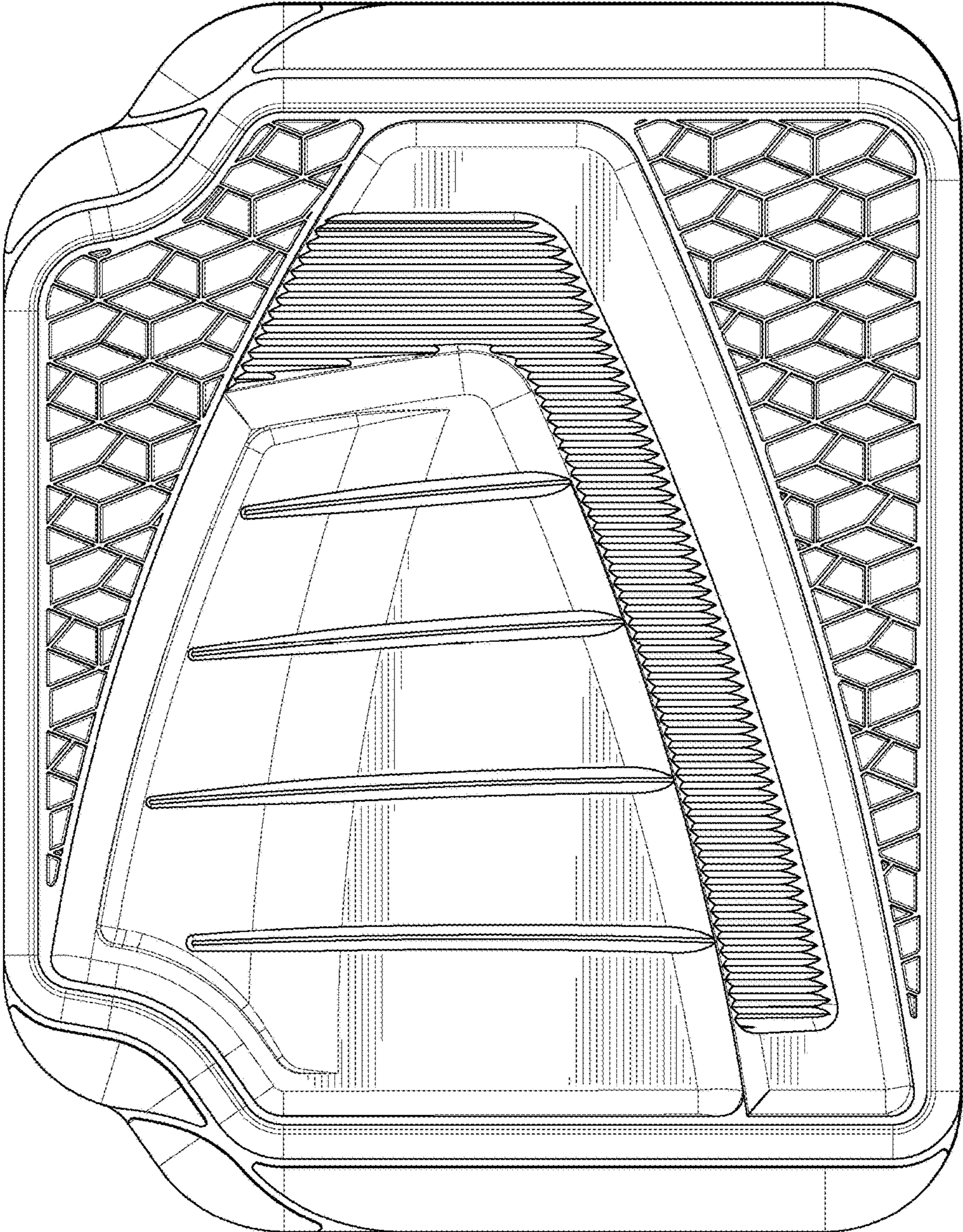

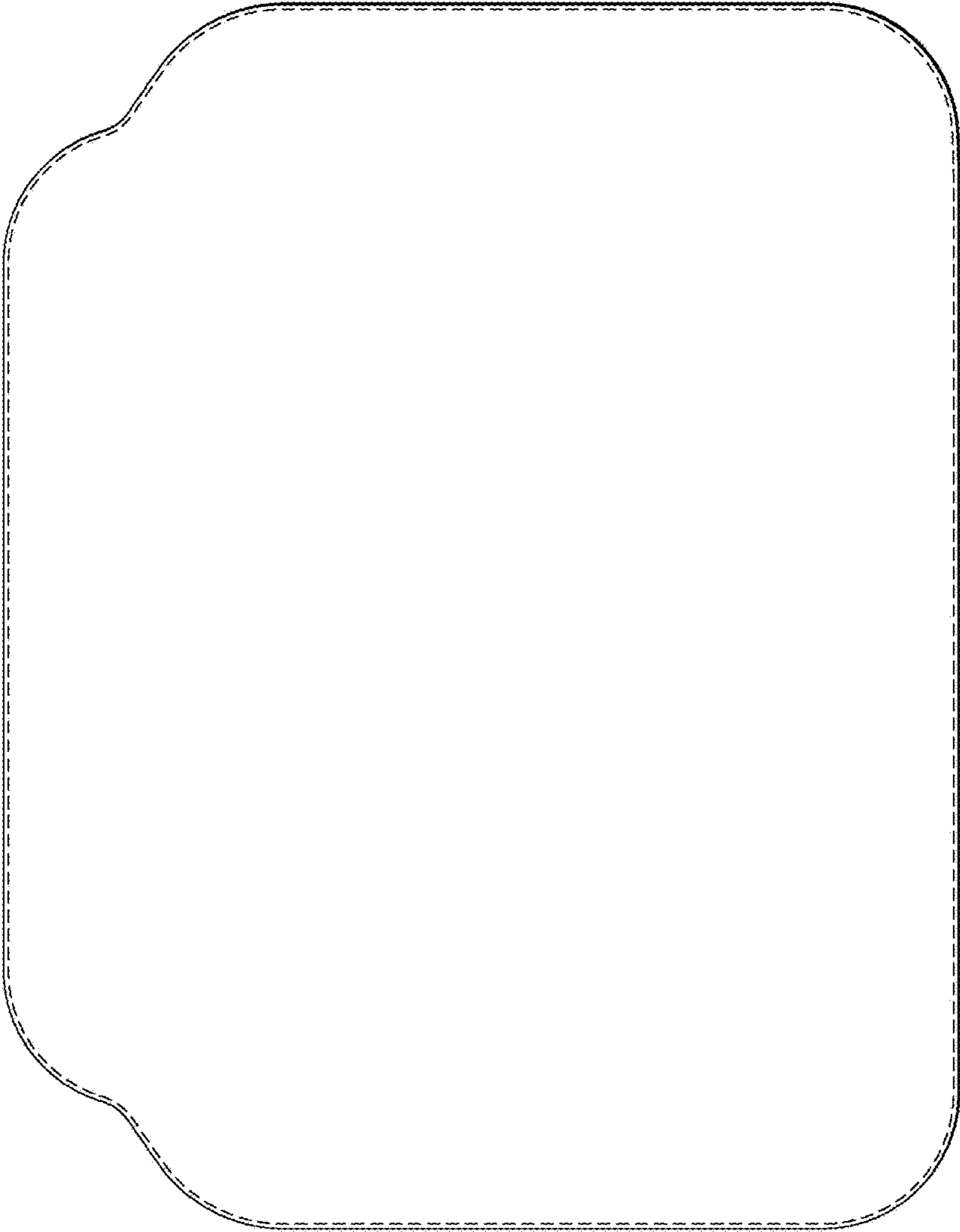
