(57) **CLAIM**

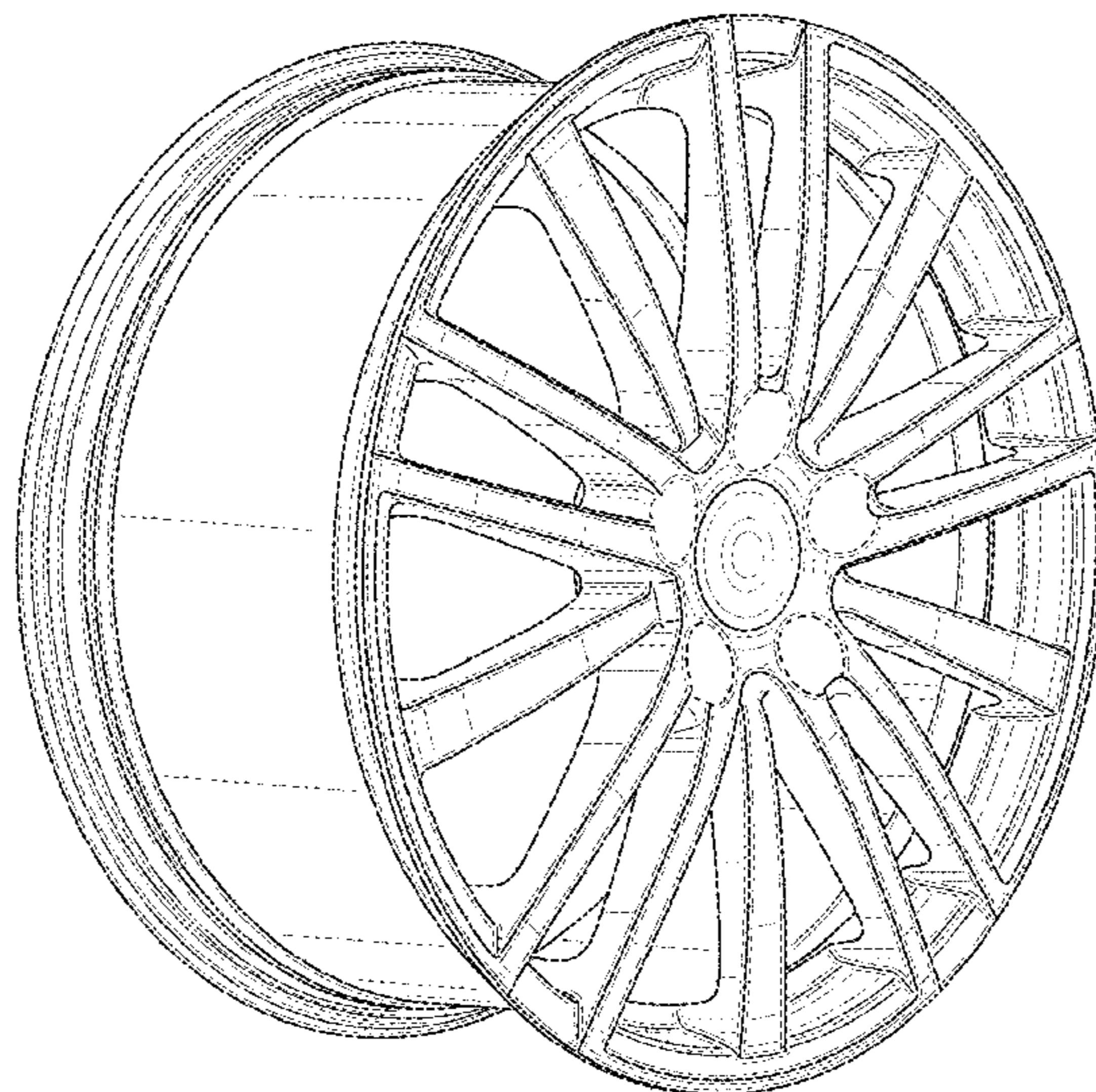
The ornamental design for a wheel for motor vehicle, as shown and described.

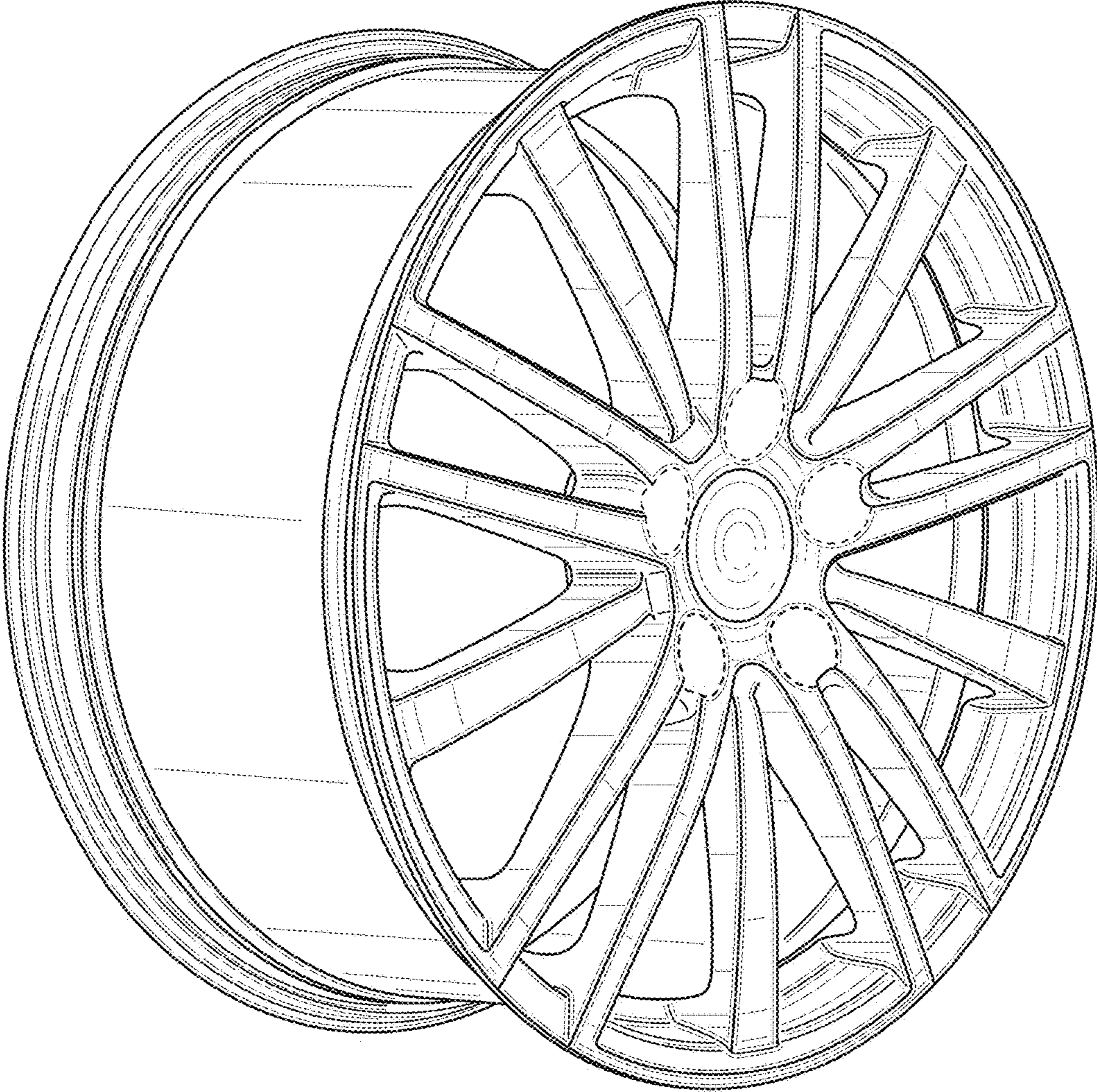

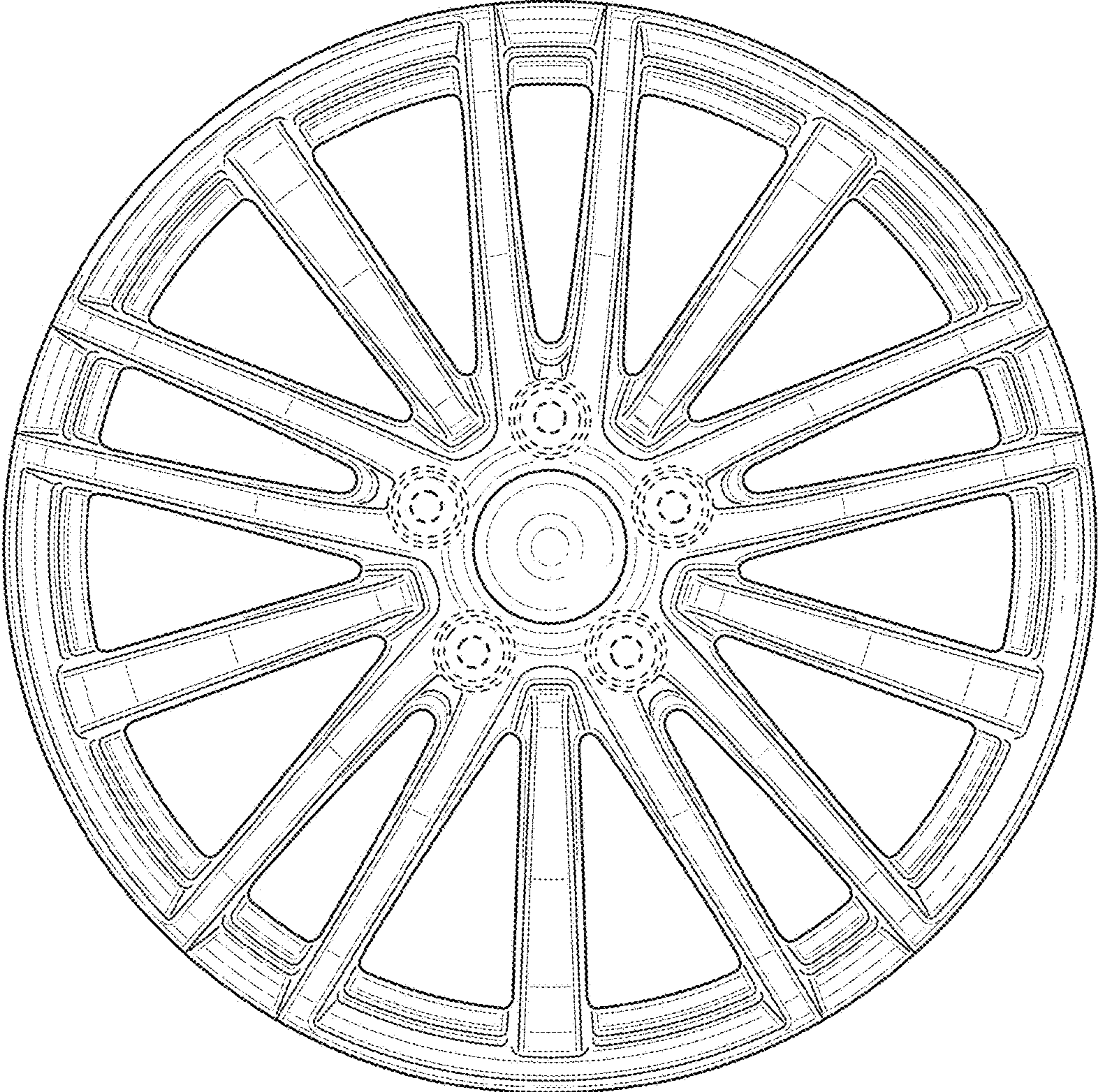

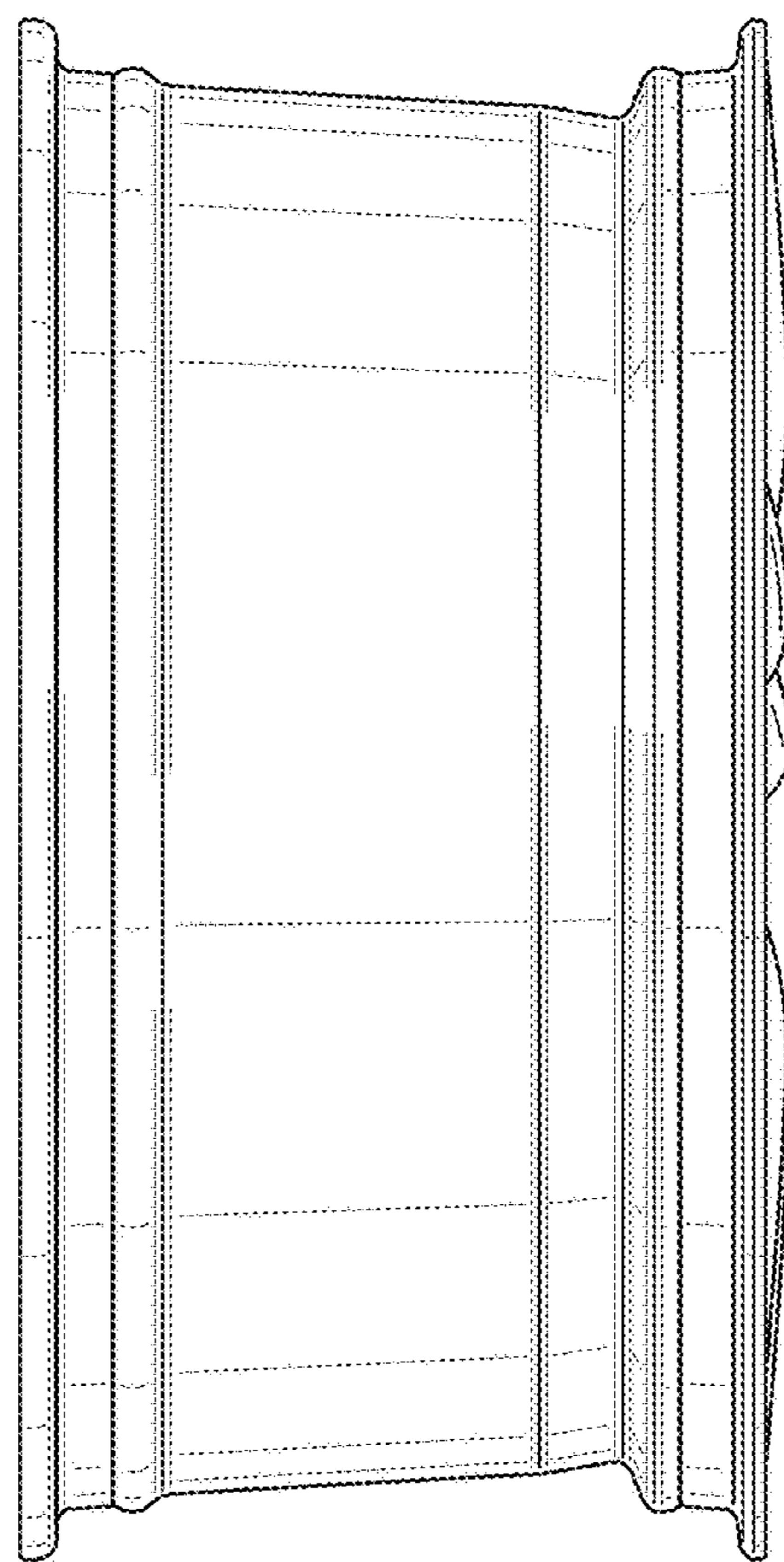
