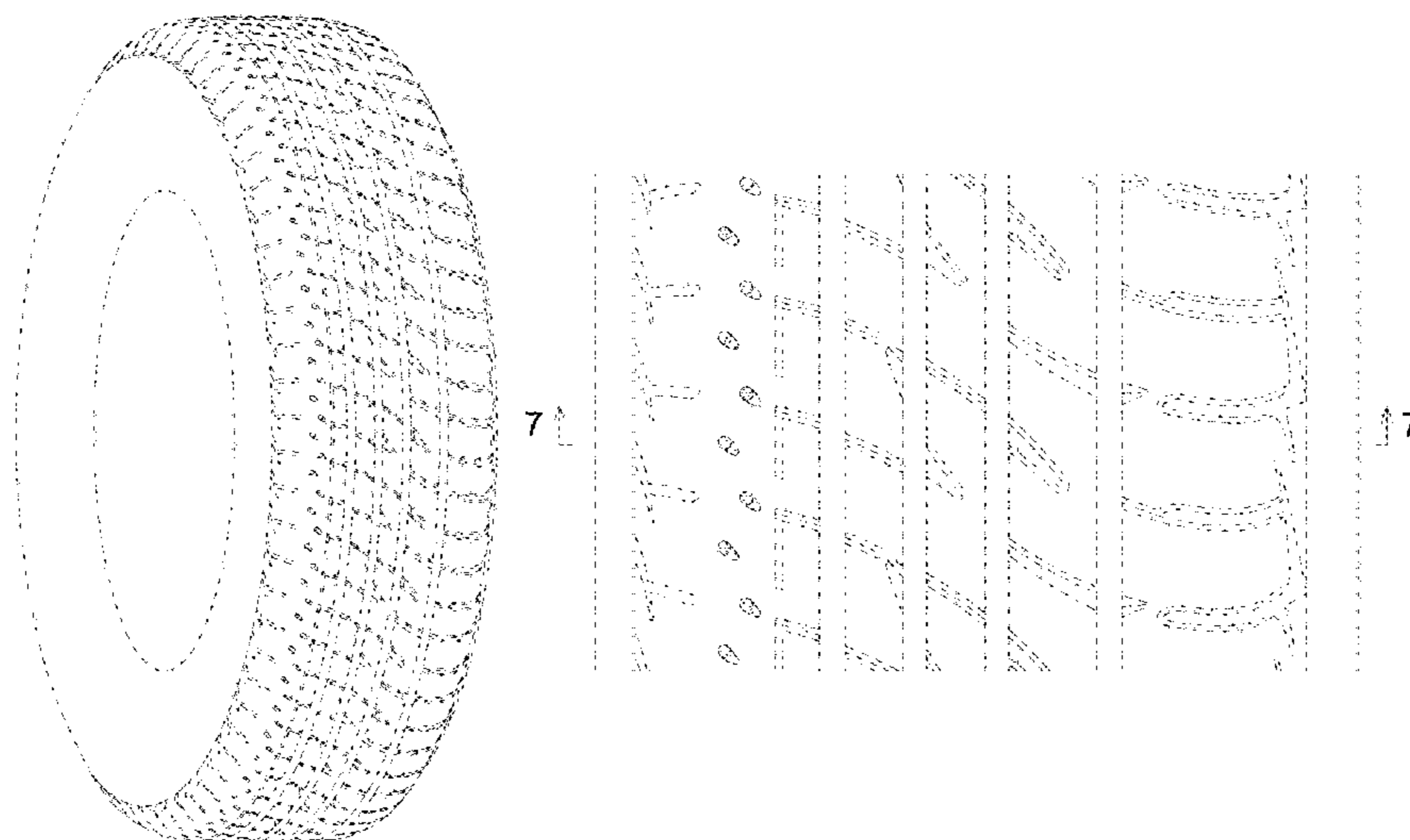
(57) **CLAIM**

The ornamental design for a tread of an automobile tire, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tread of an automobile tire
showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a fragmentary enlarged front view showing the
details of the tread thereof; and,
FIG. 7 is a section view taken along line 7-7 in FIG. 6.
The broken lines in the drawings showing portions of the tire
are included to illustrate environment and form no part of the
claimed design.

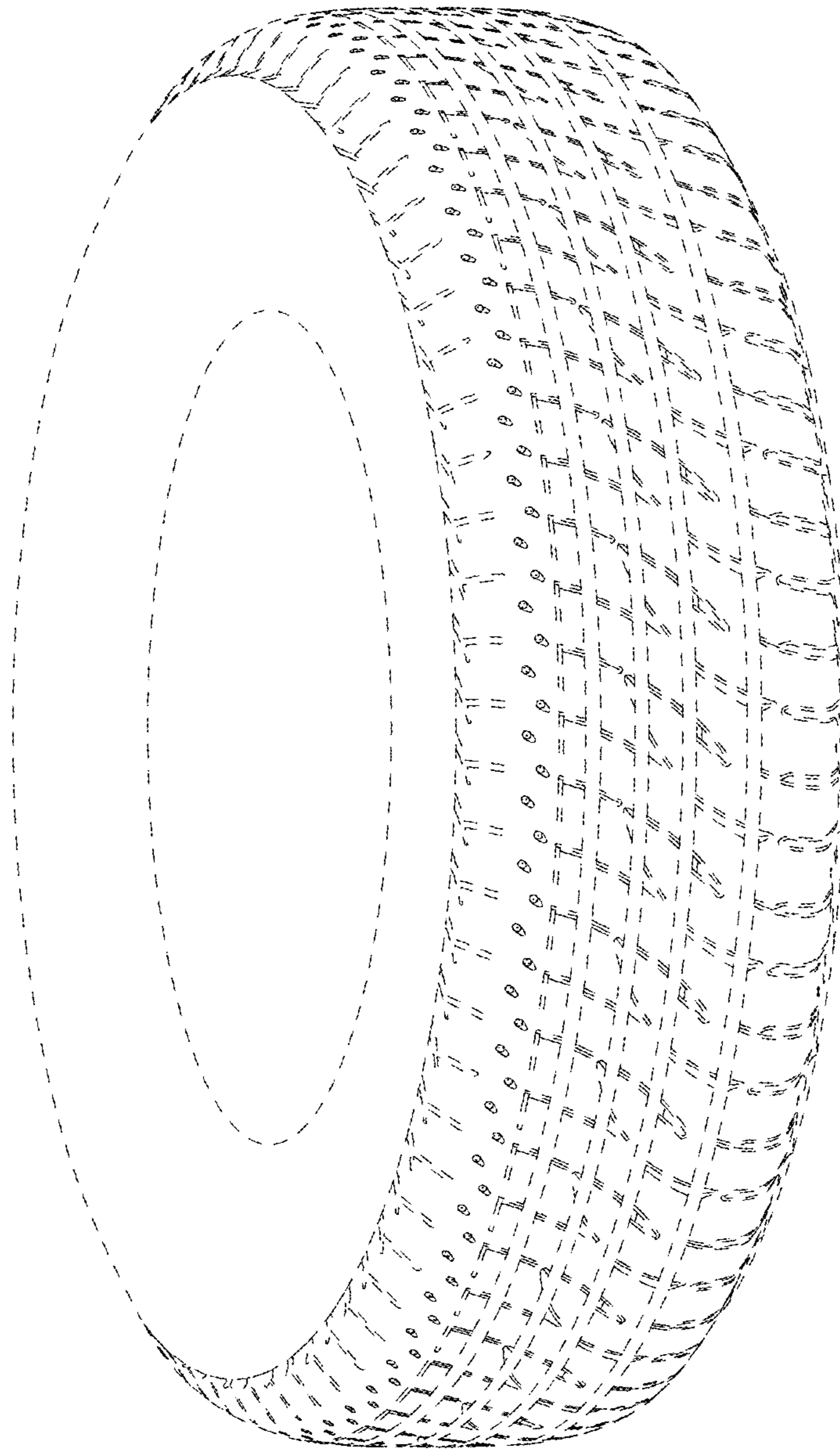

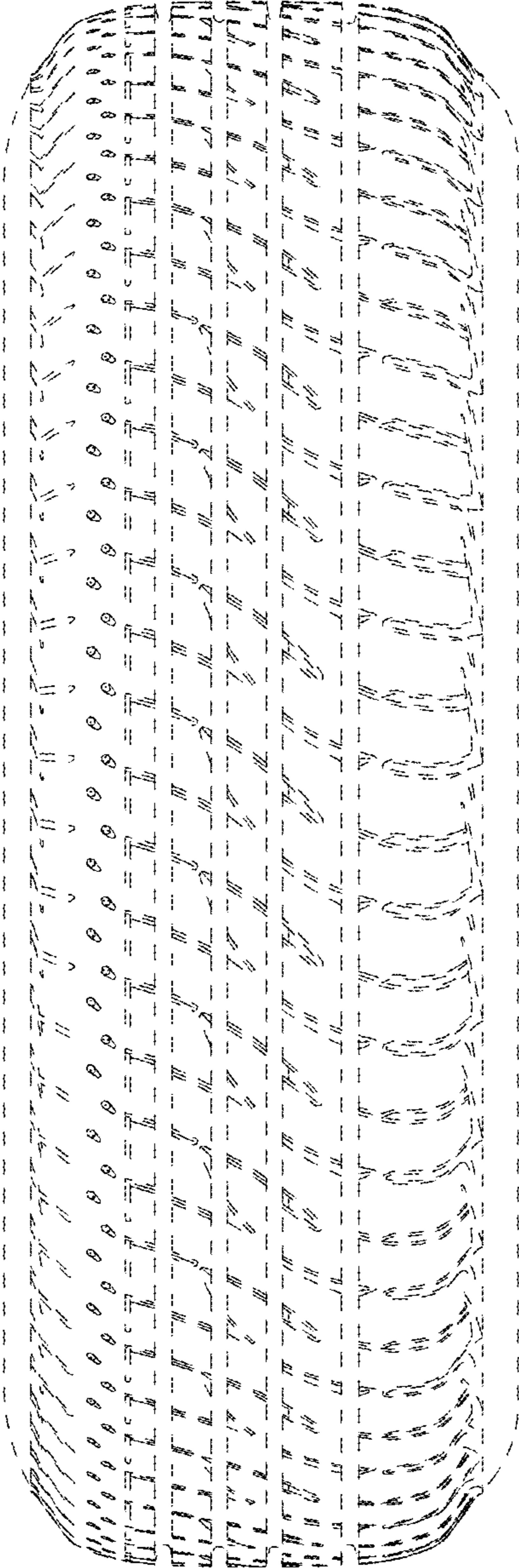

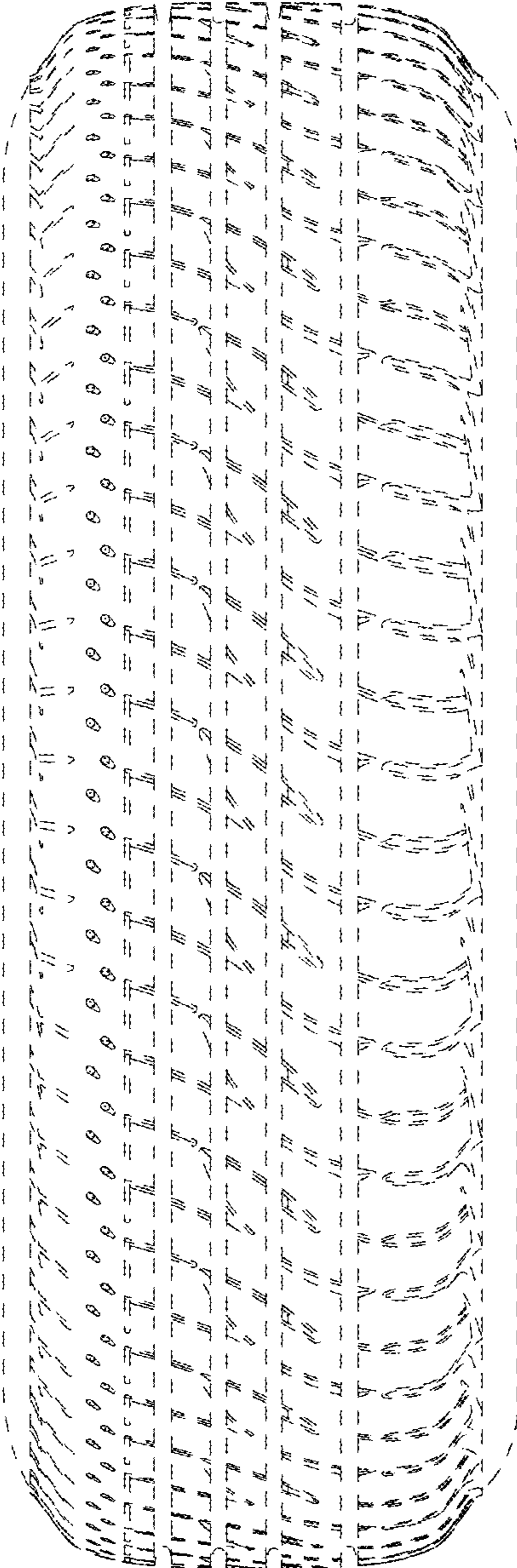

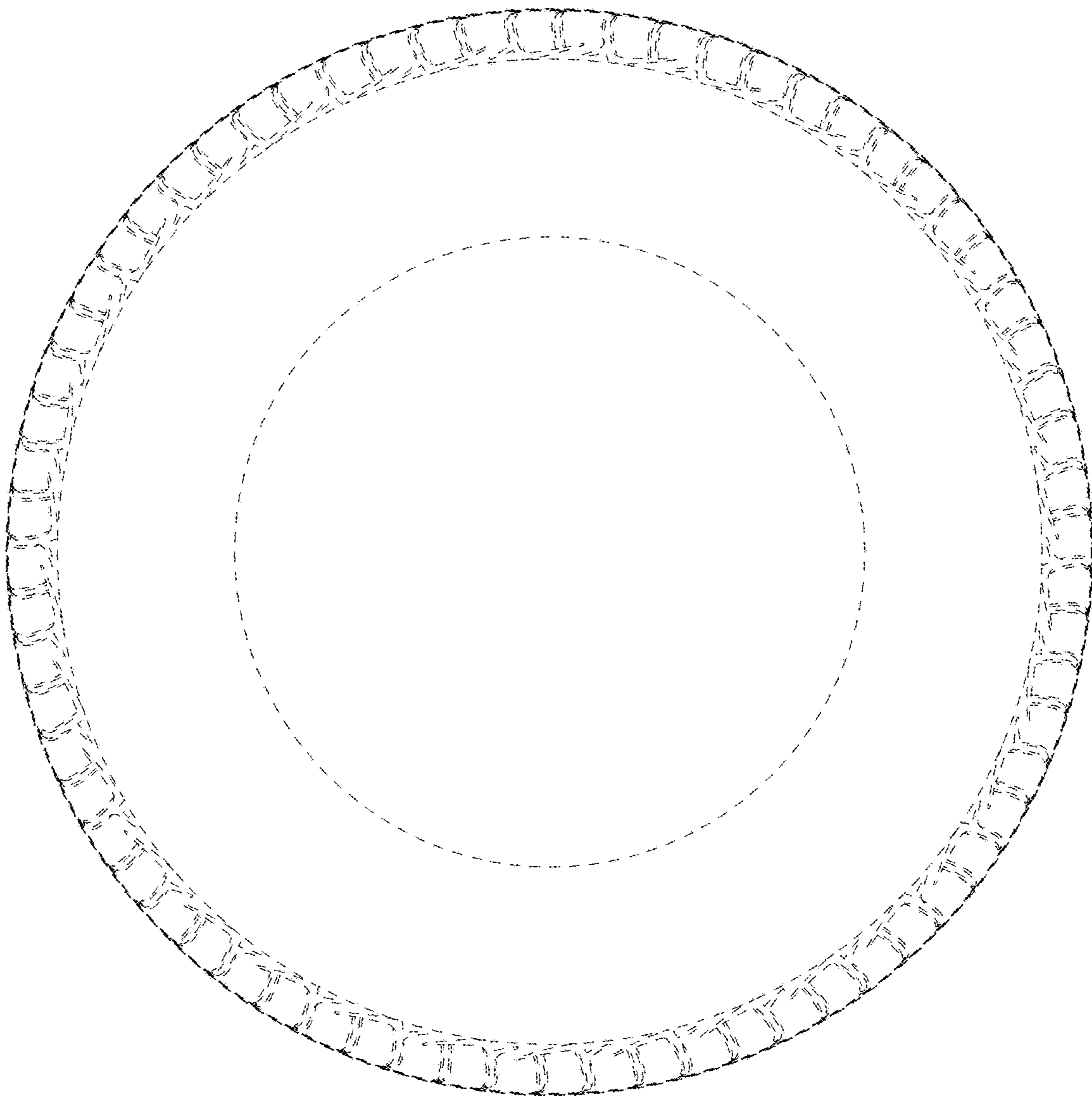

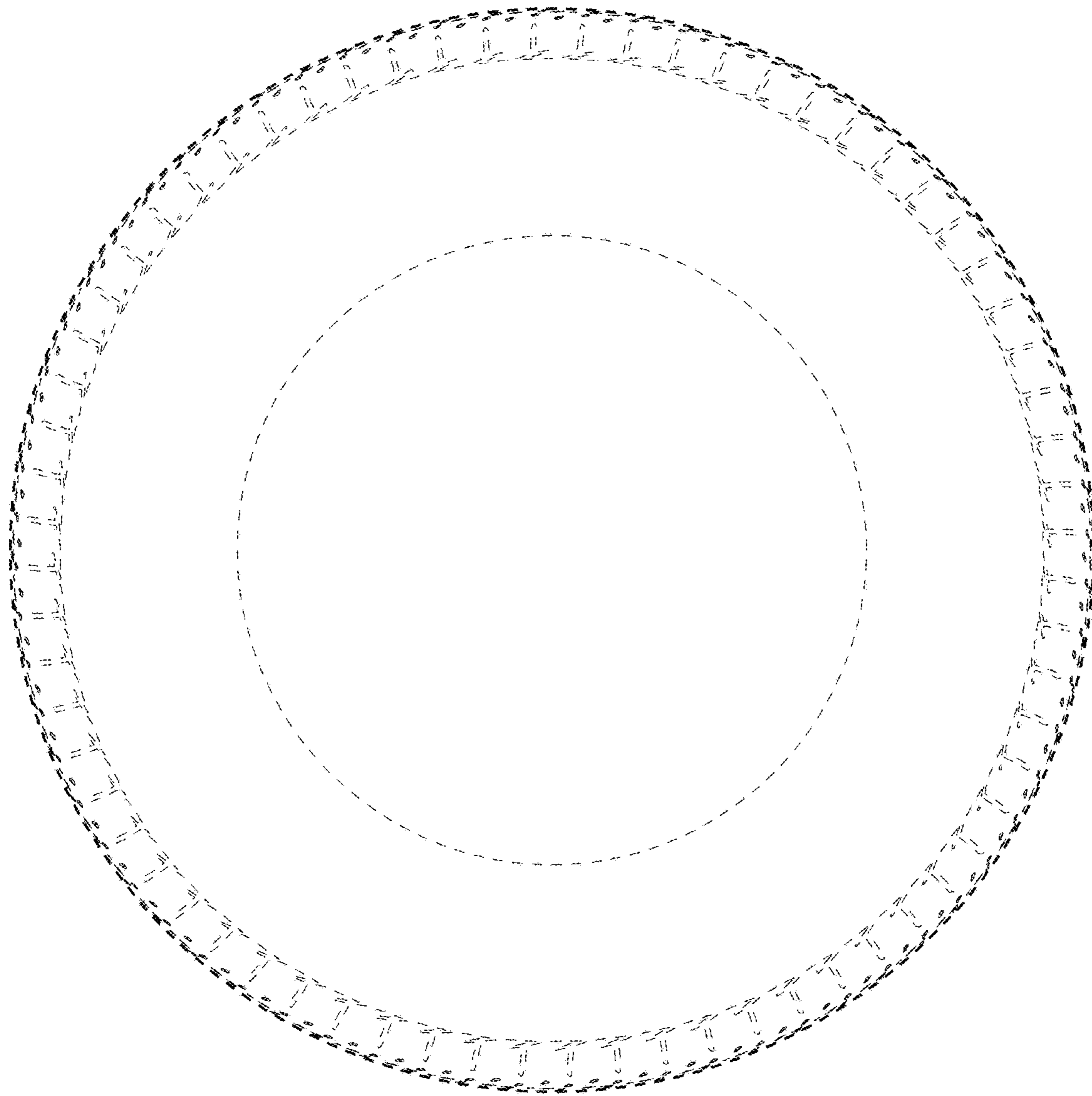

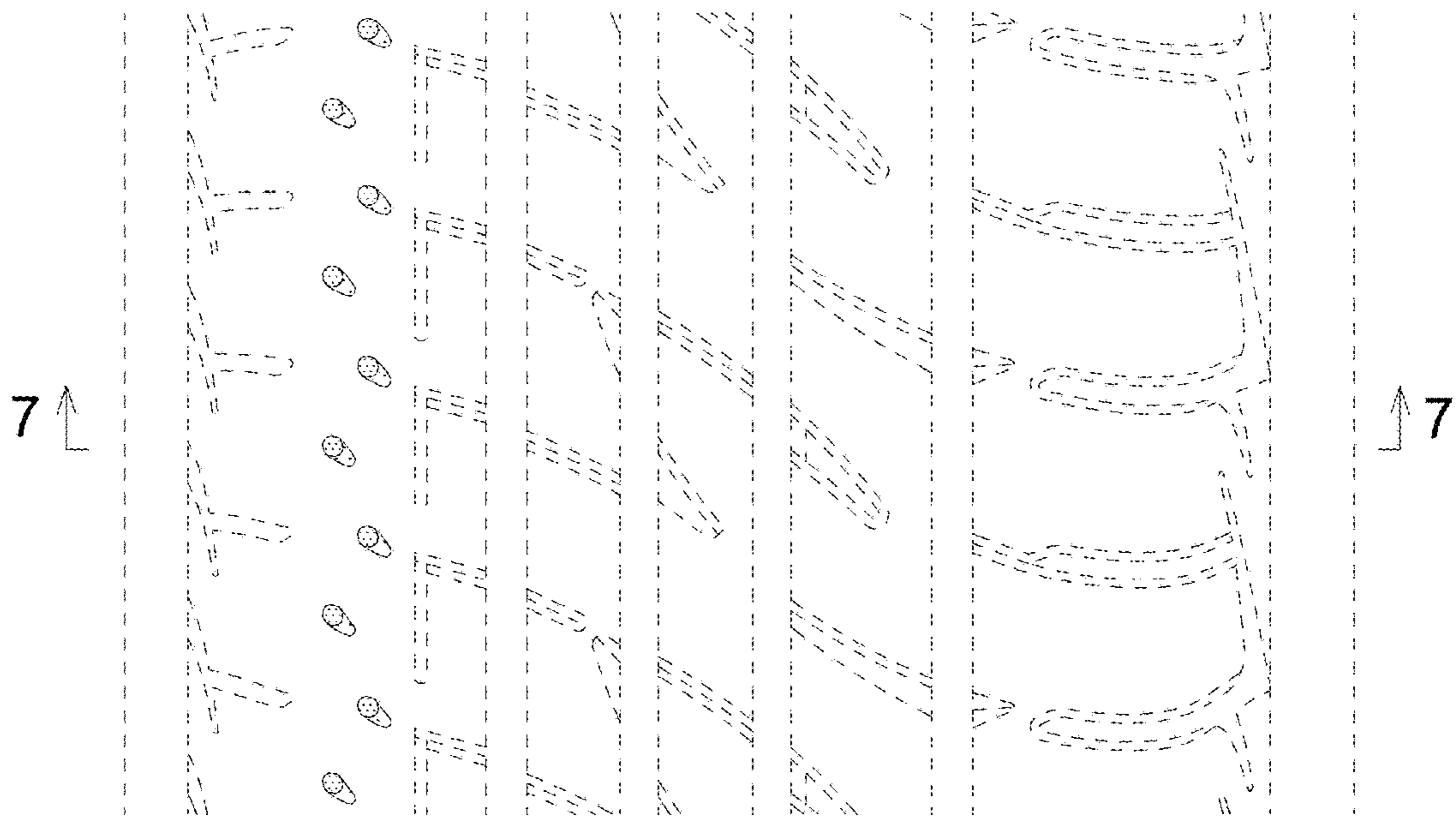
