(57) **CLAIM**

The ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is the first image in a sequence for a display screen or portion thereof with transitional graphical user interface showing my new design;

FIG. 4 is the fourth image thereof;

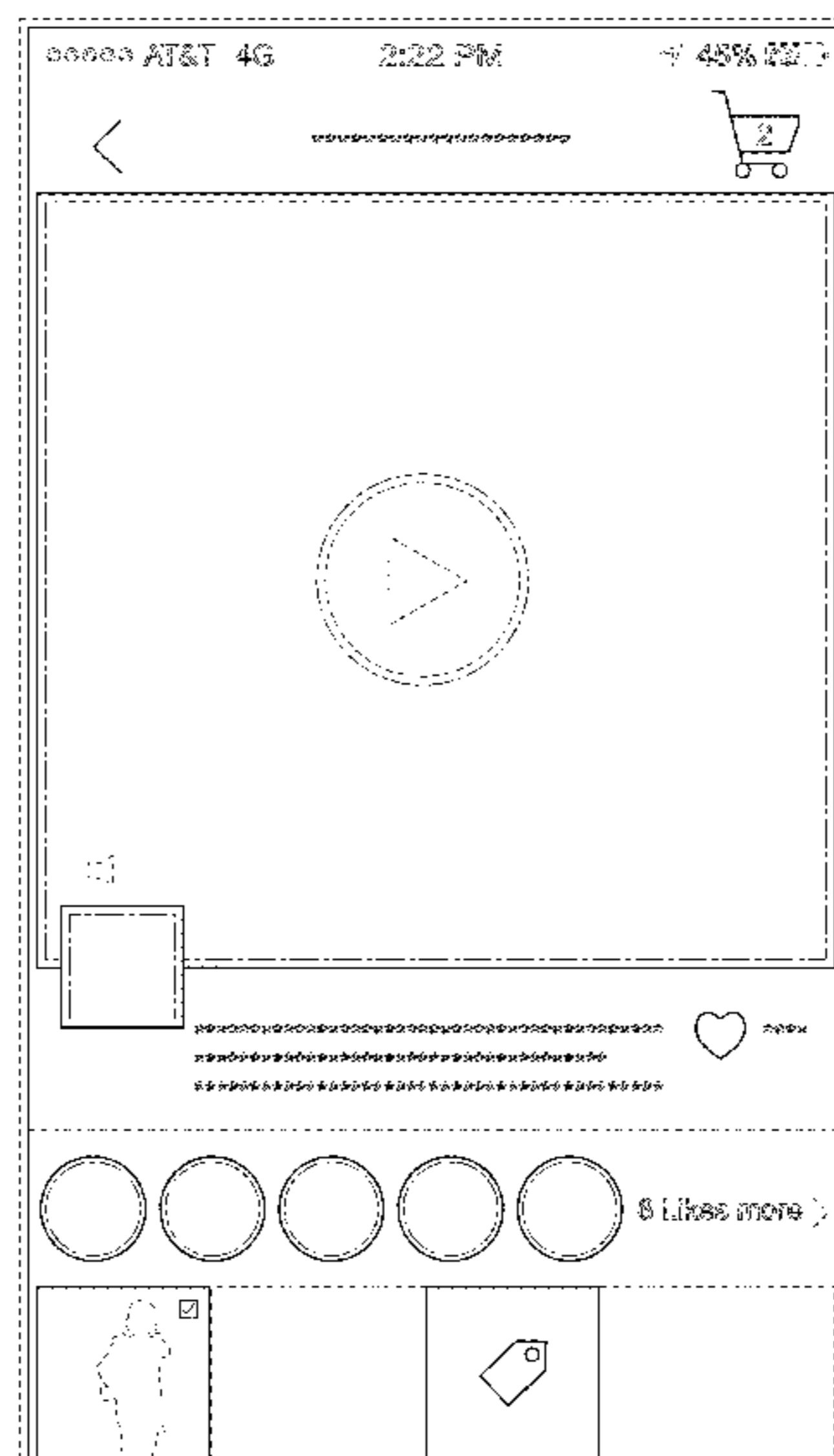
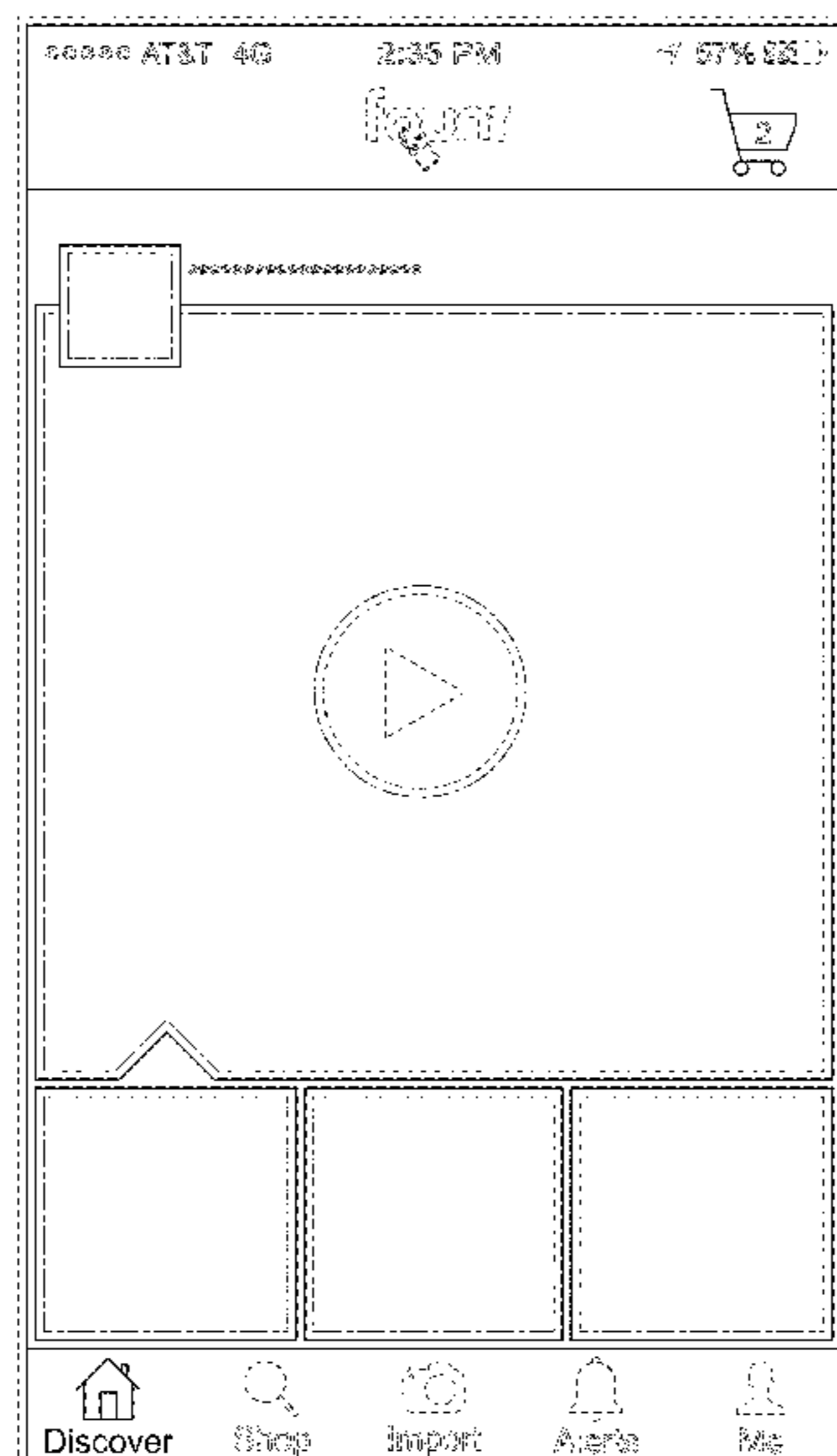
FIG. 5 is the fifth image thereof; and,

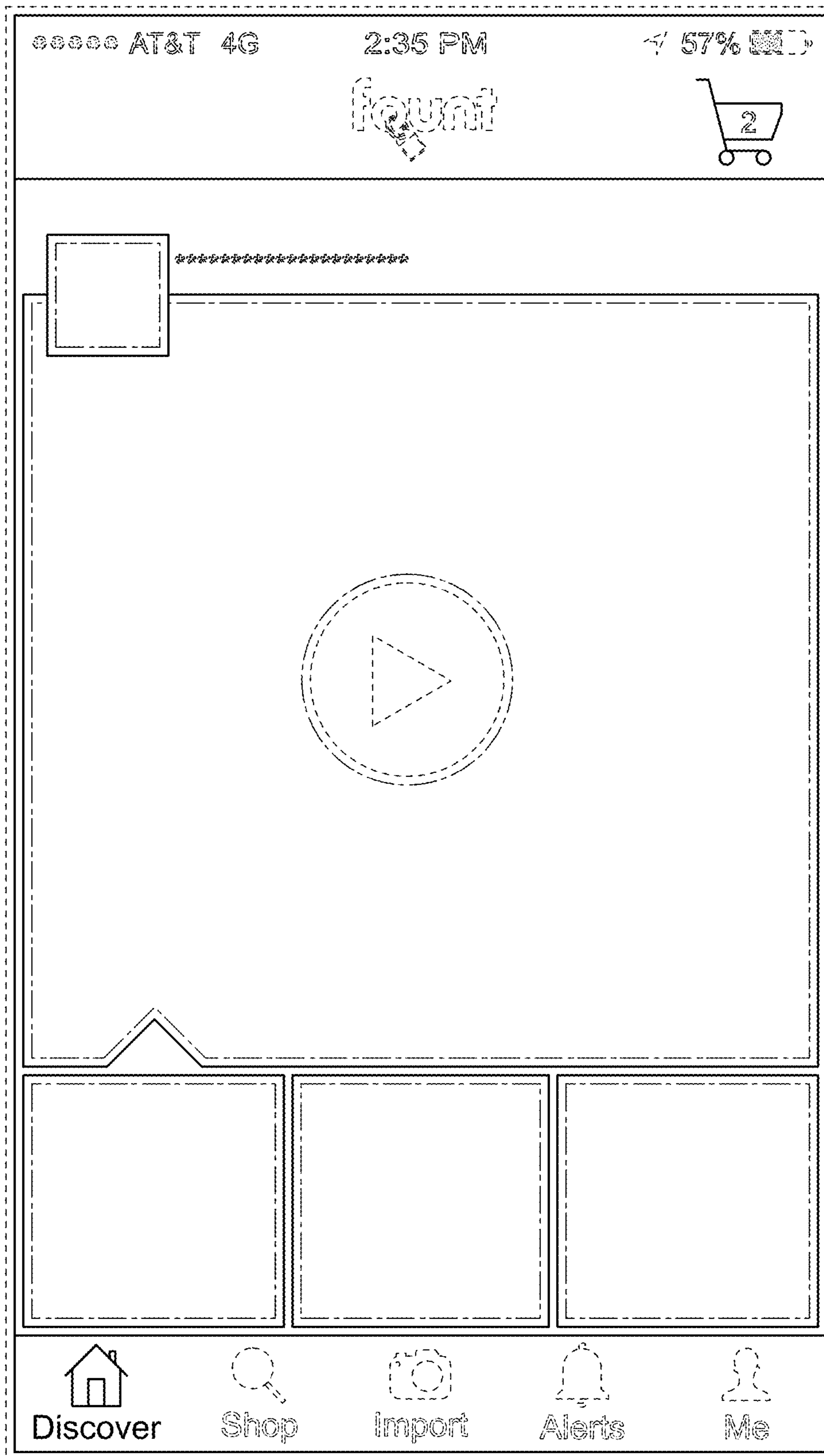

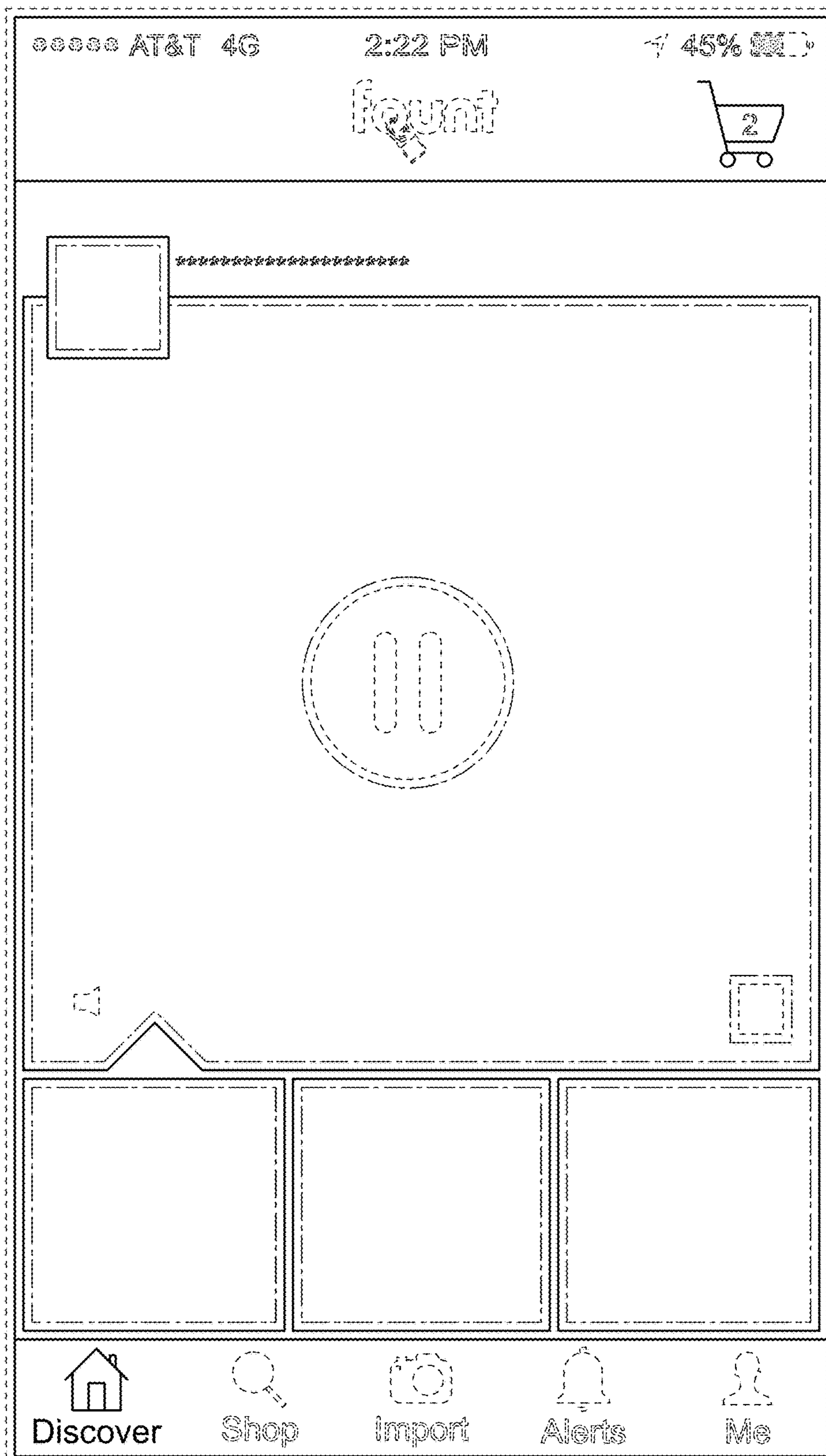

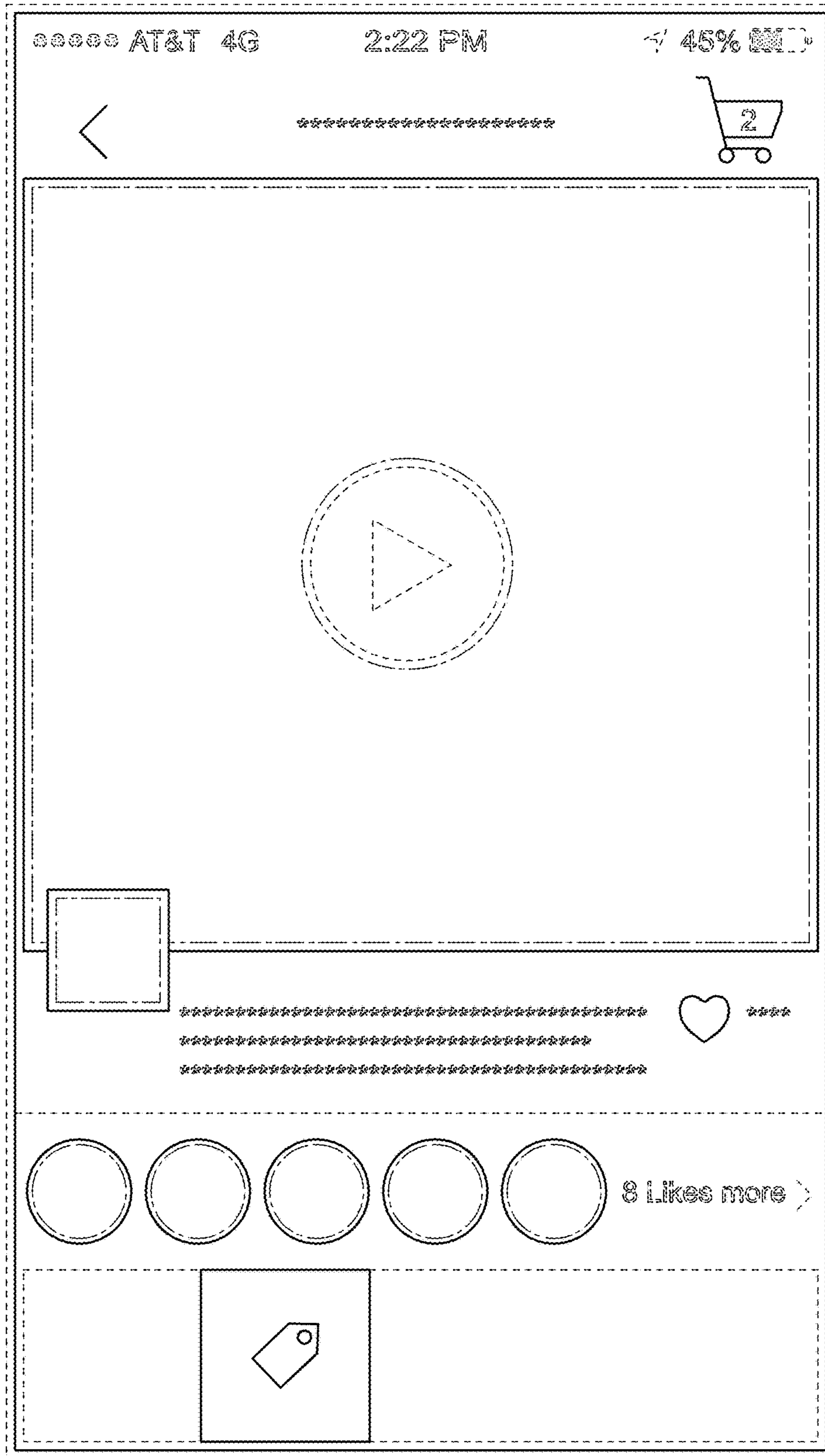

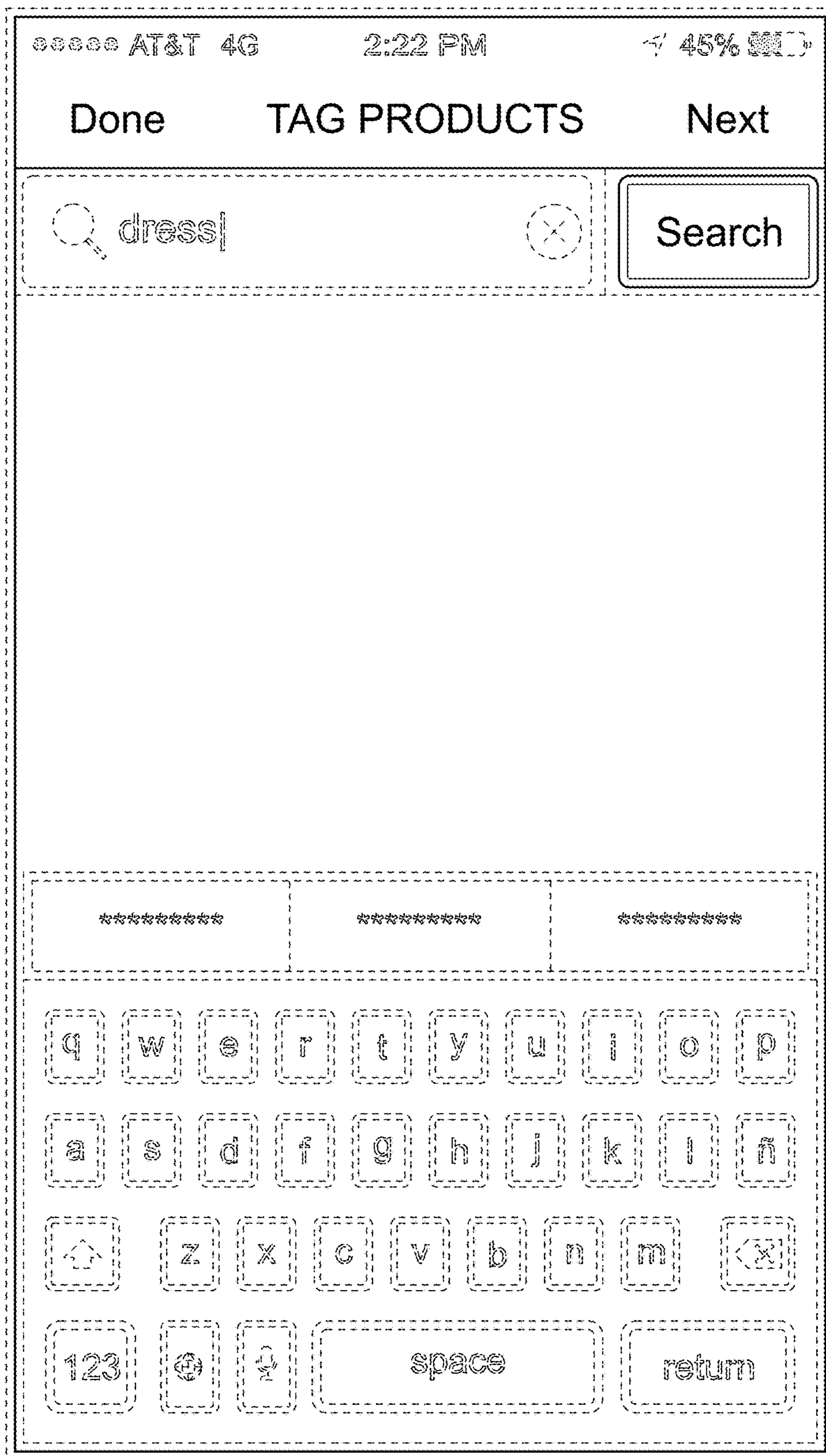

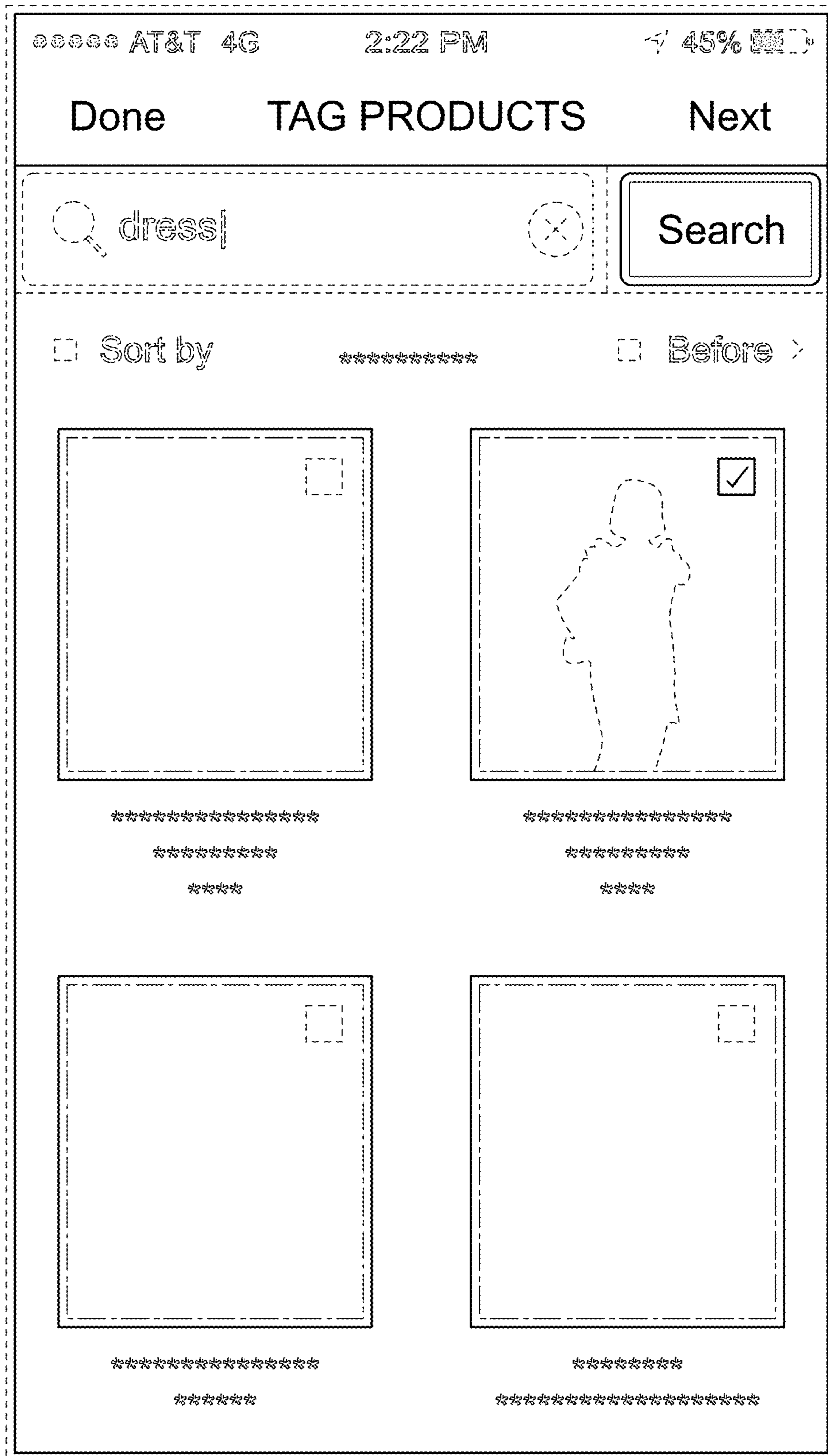

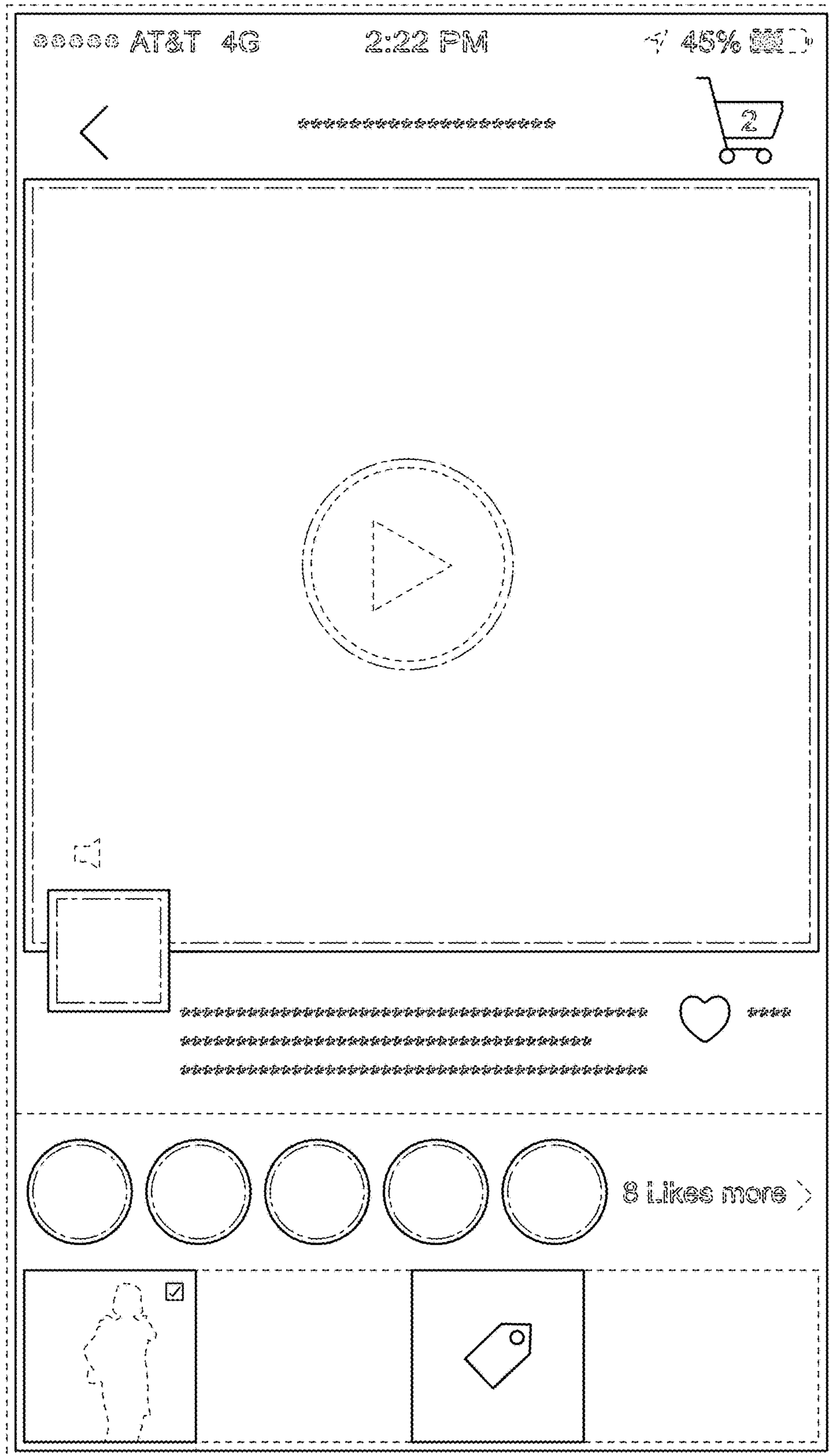
