(57) **CLAIM**

The ornamental design for a toy building block, as shown and described.

**DESCRIPTION**

FIG. 1 shows a top and side perspective view of the toy building block.

FIG. 2 shows a bottom and side perspective view thereof. FIG. 3 shows first elevation view thereof, the opposite site being a mirror image thereof.

FIG. 4 shows a second elevation view thereof, the opposite site being a mirror image thereof.

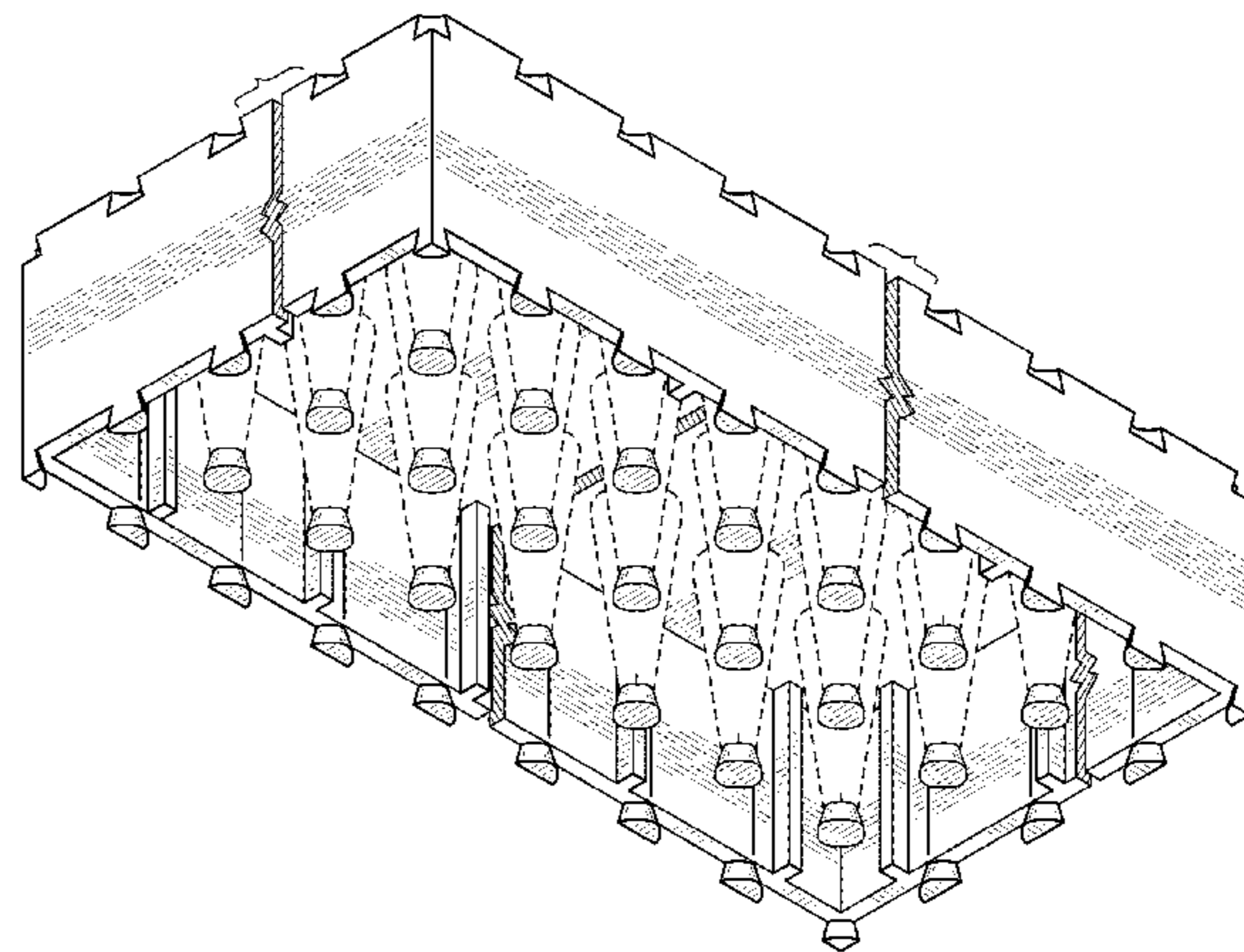
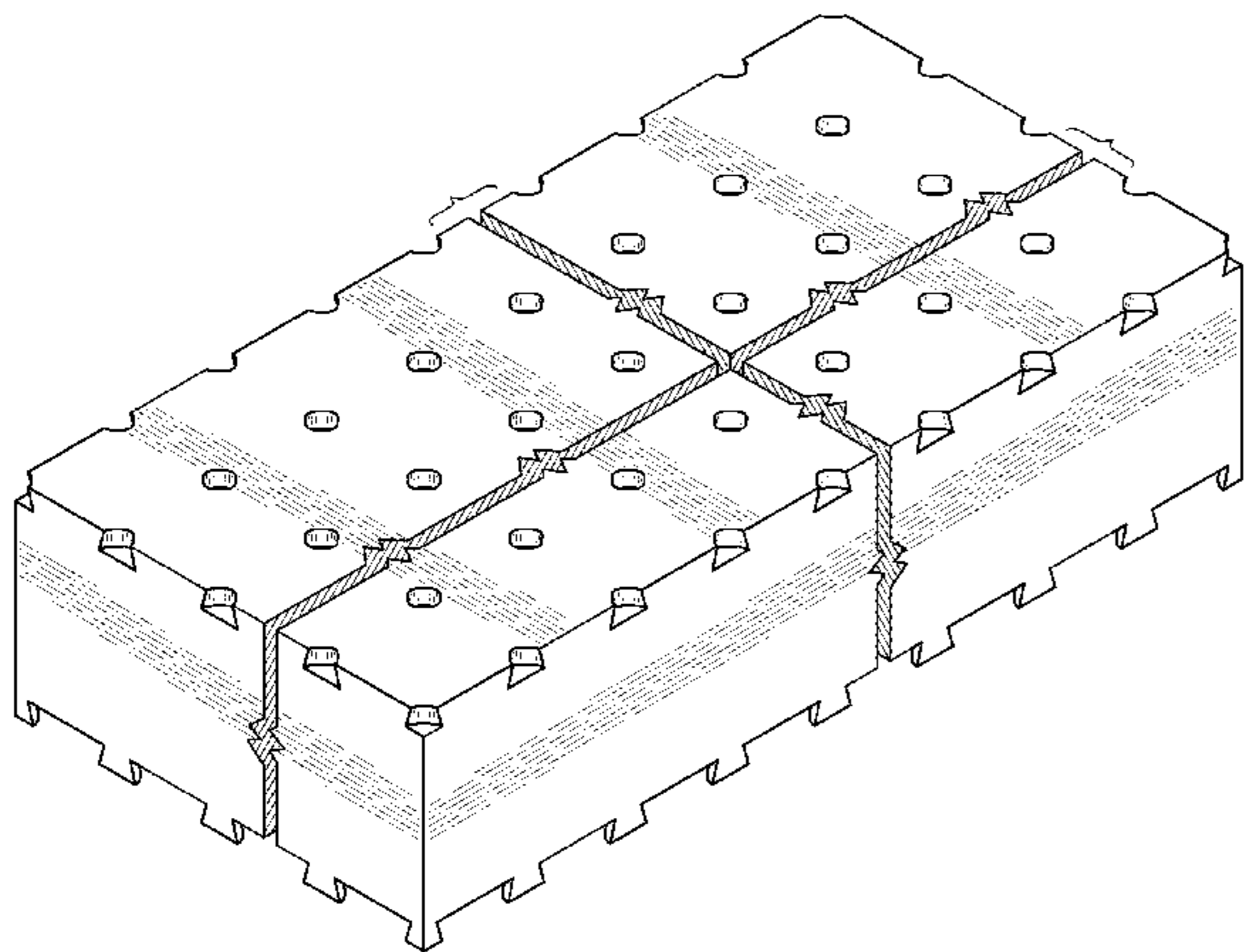
FIG. 5 shows a top plan view thereof.

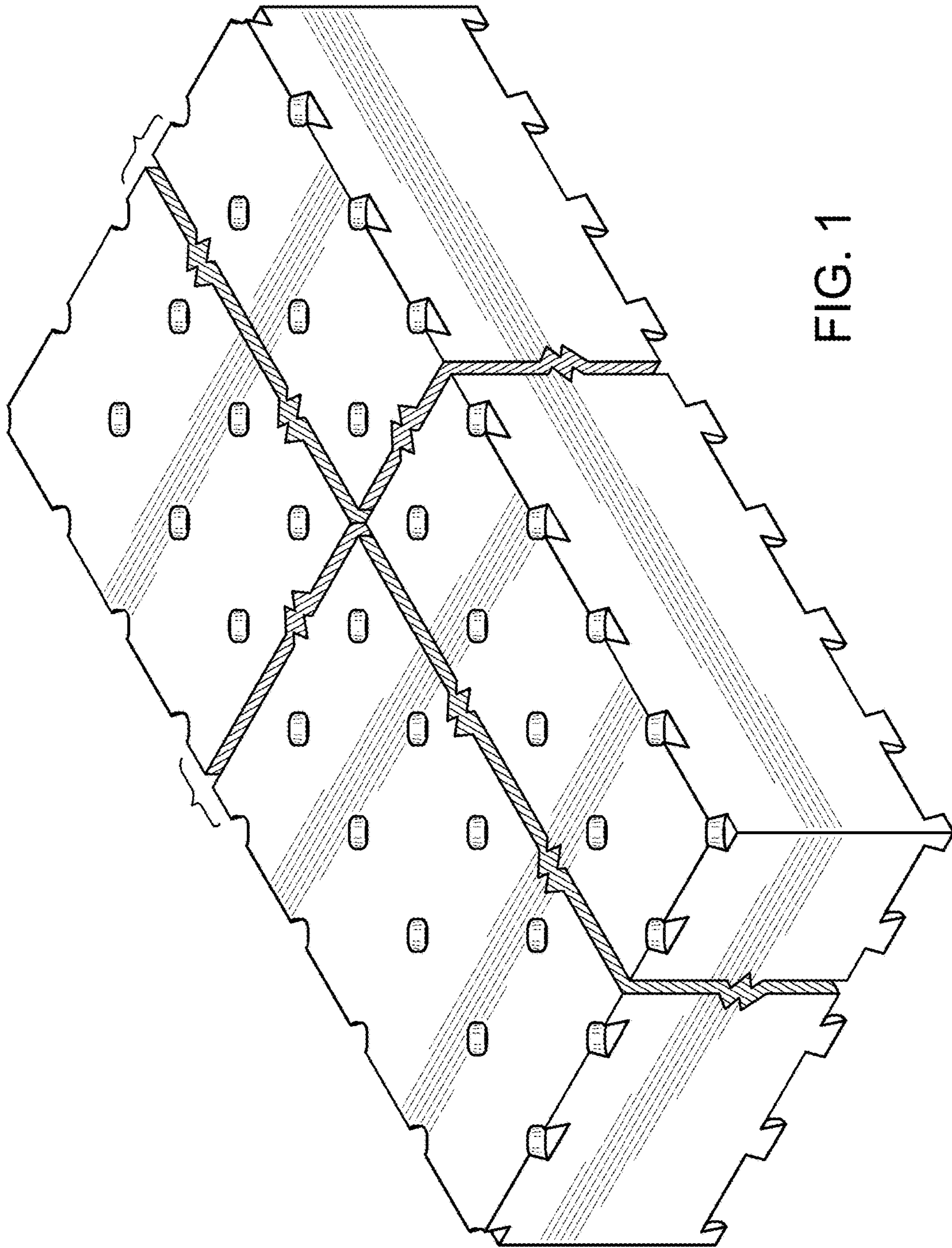

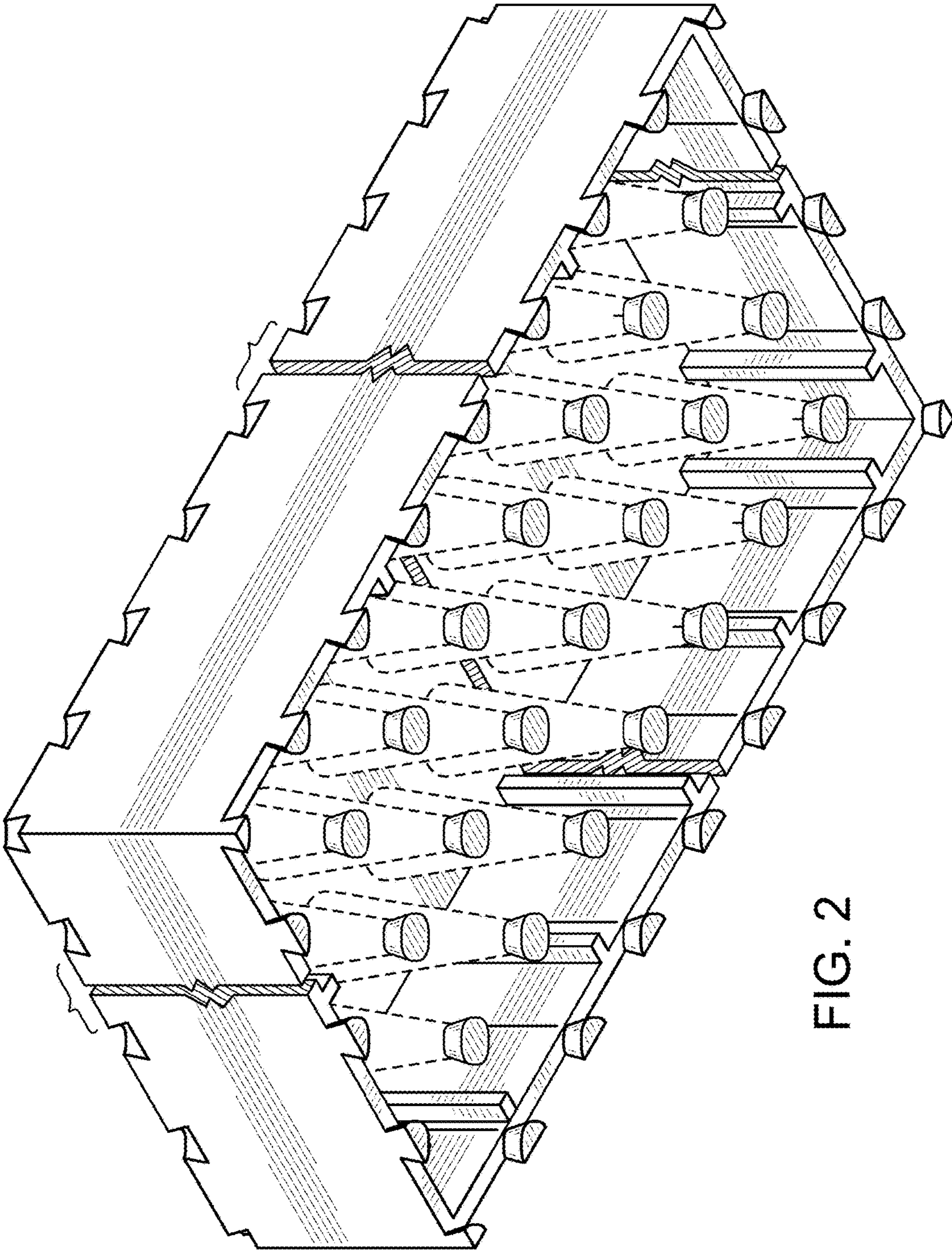

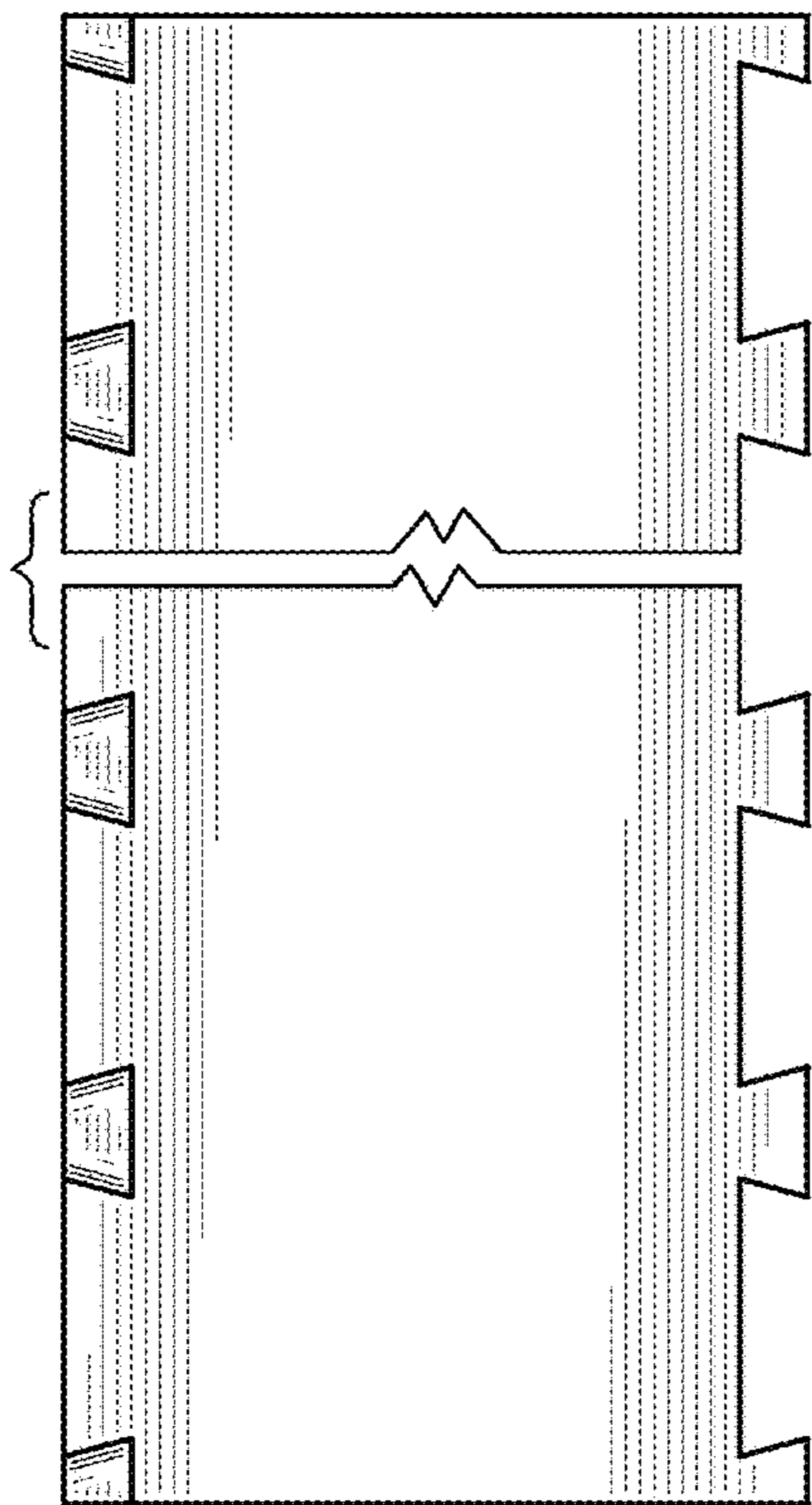

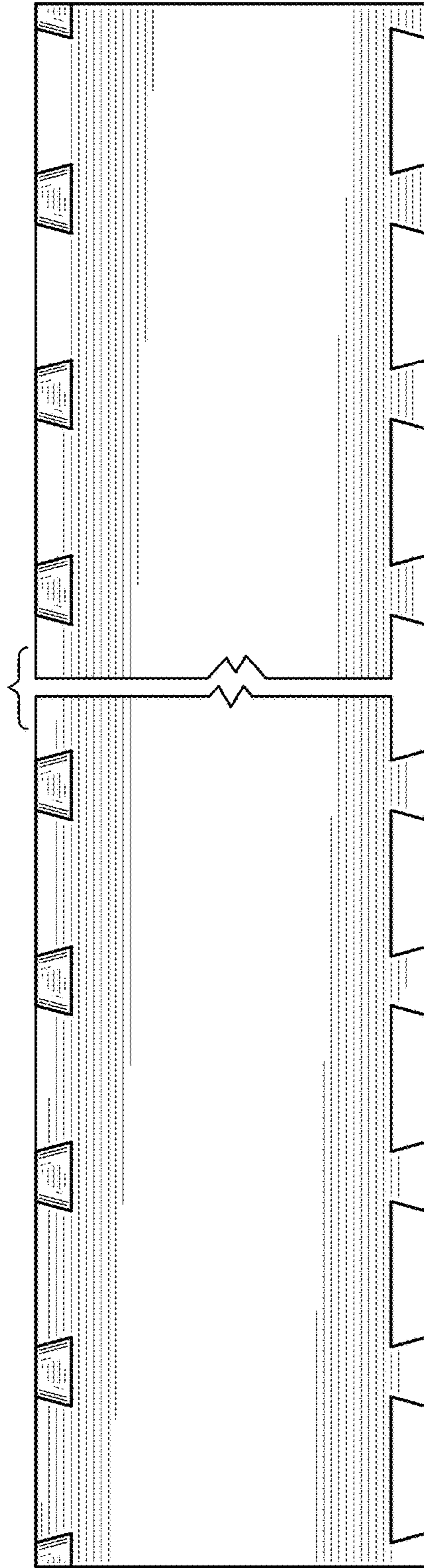

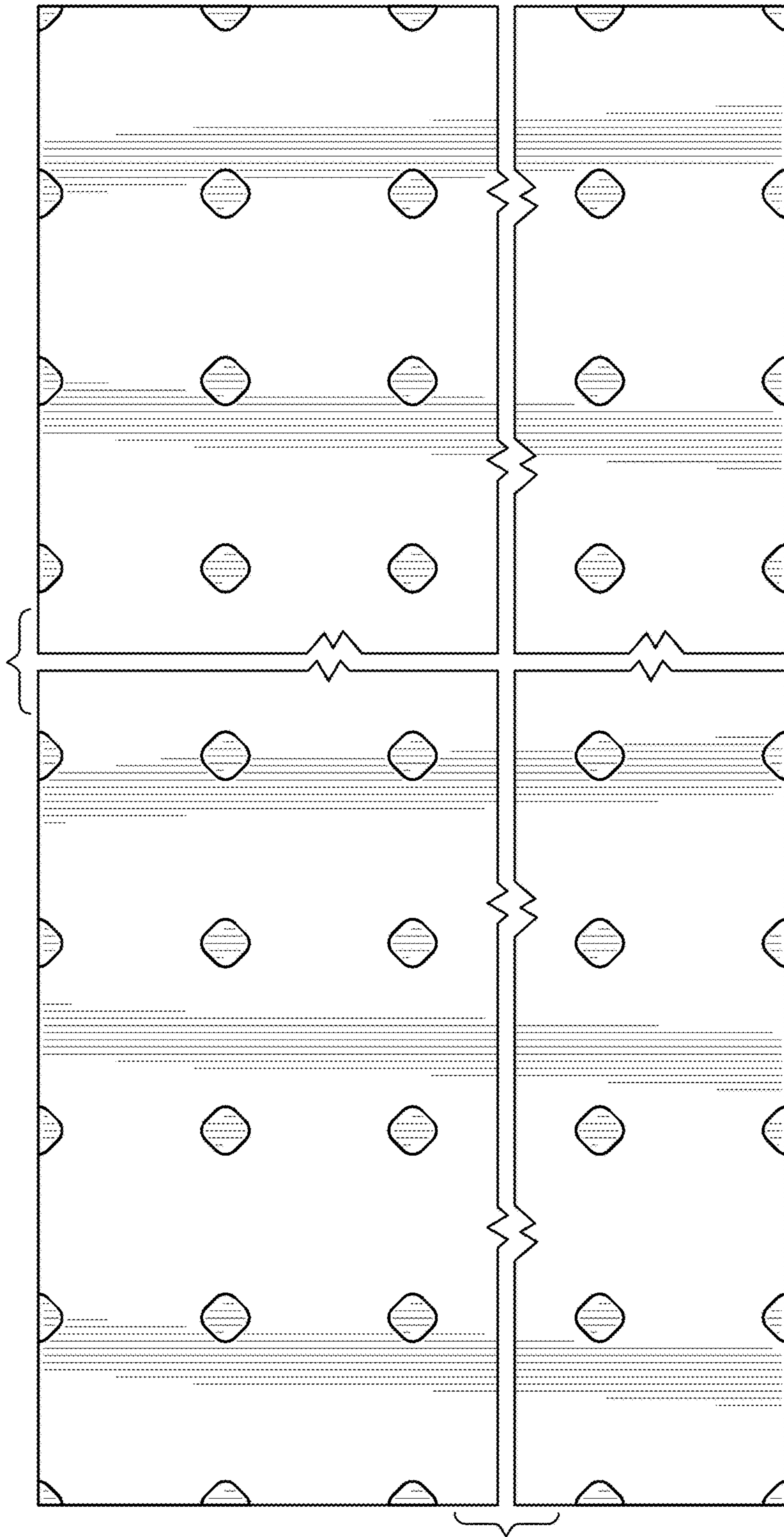

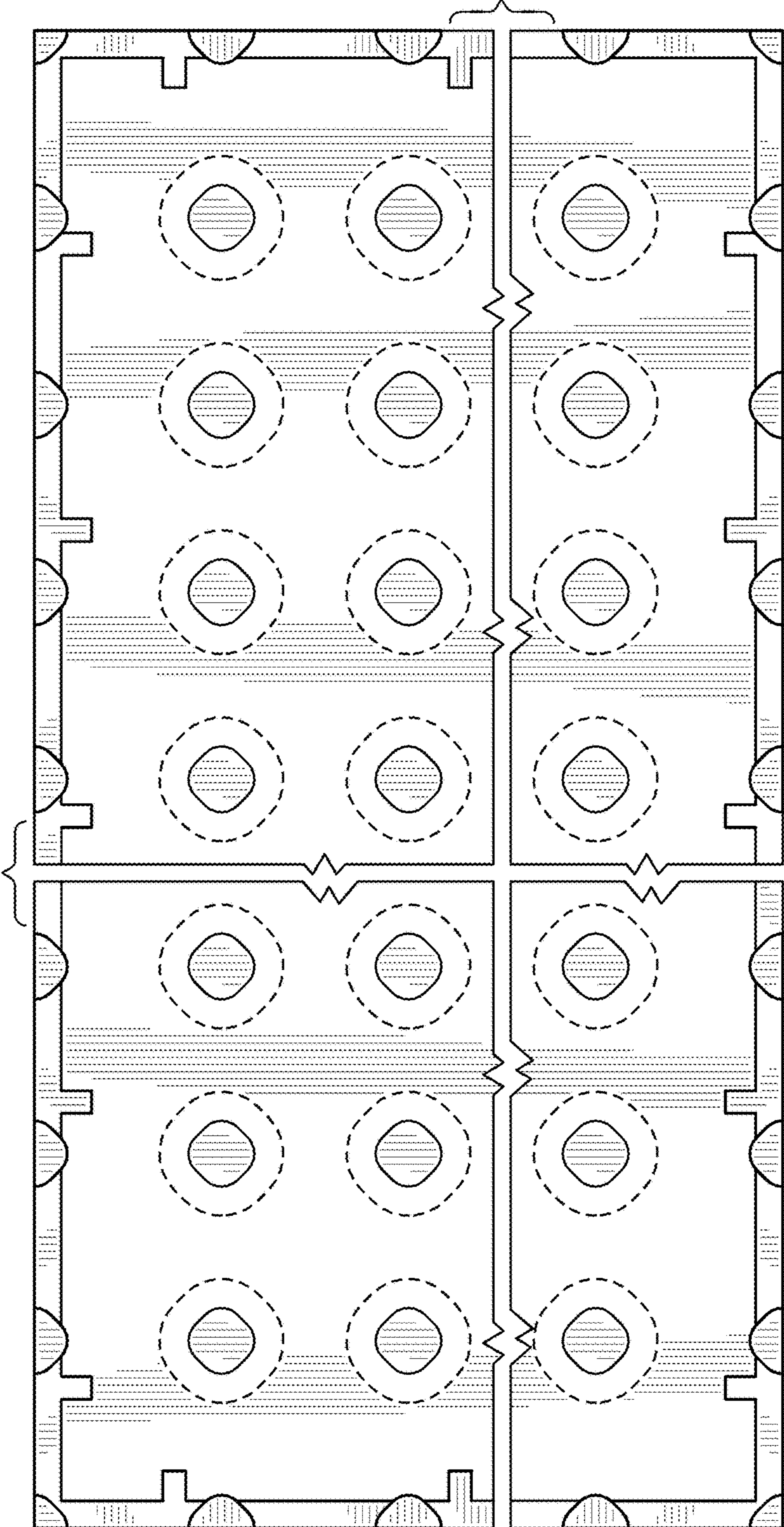

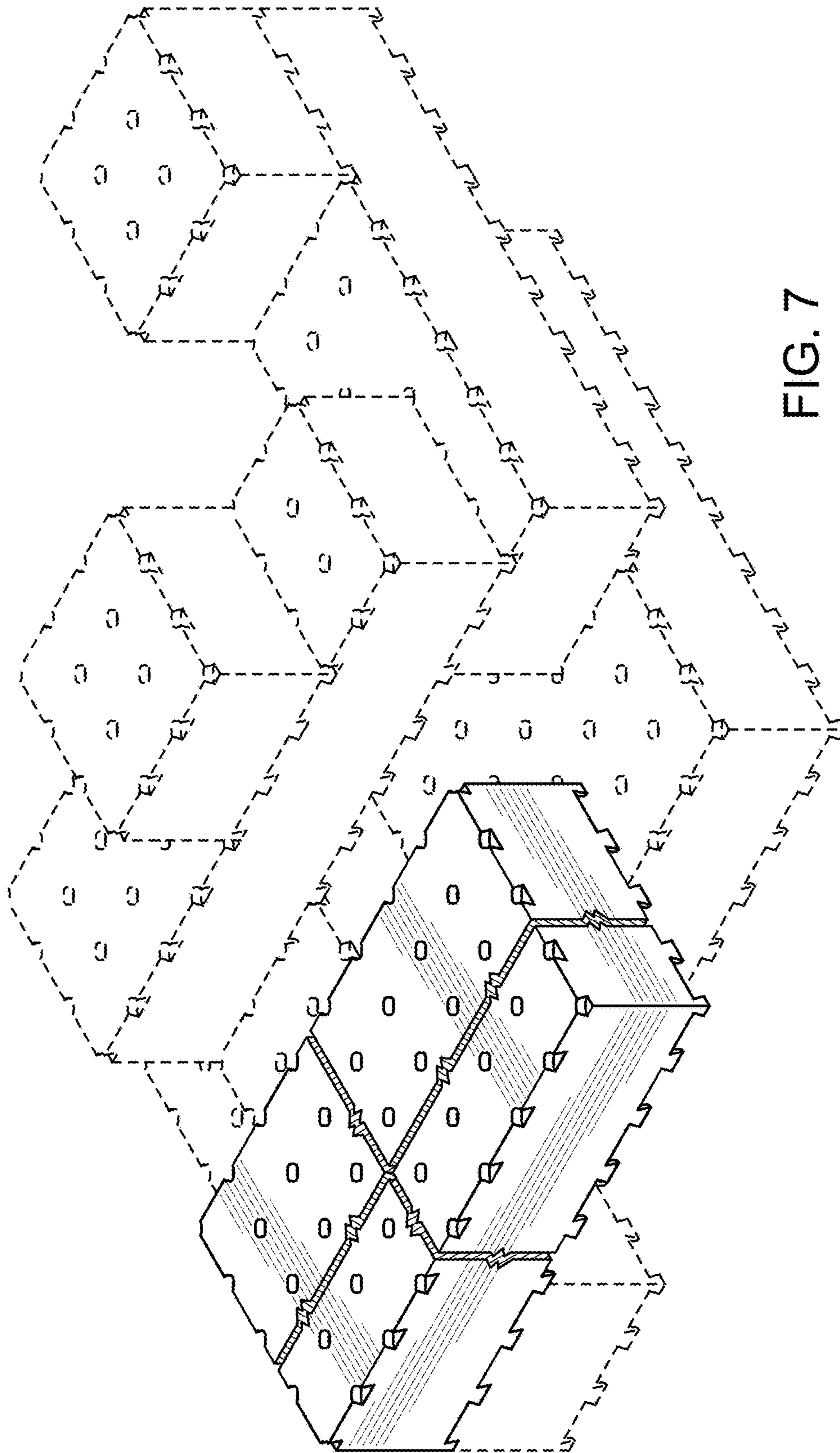
