(57) **CLAIM**

The ornamental design for a scented disc, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a first side of a scented disc in accordance with a preferred embodiment of the claimed design;

FIG. 2 is a perspective view of the first side thereof;

FIG. 3 is a side elevational view thereof;

FIG. 4 is a perspective view of a second side thereof; and,

FIG. 5 is a plan view of the second side thereof.

The broken line showing of concentric circles in FIGS. 4 and 5 is for the purpose of illustrating environmental structure and forms no part of the claimed design.

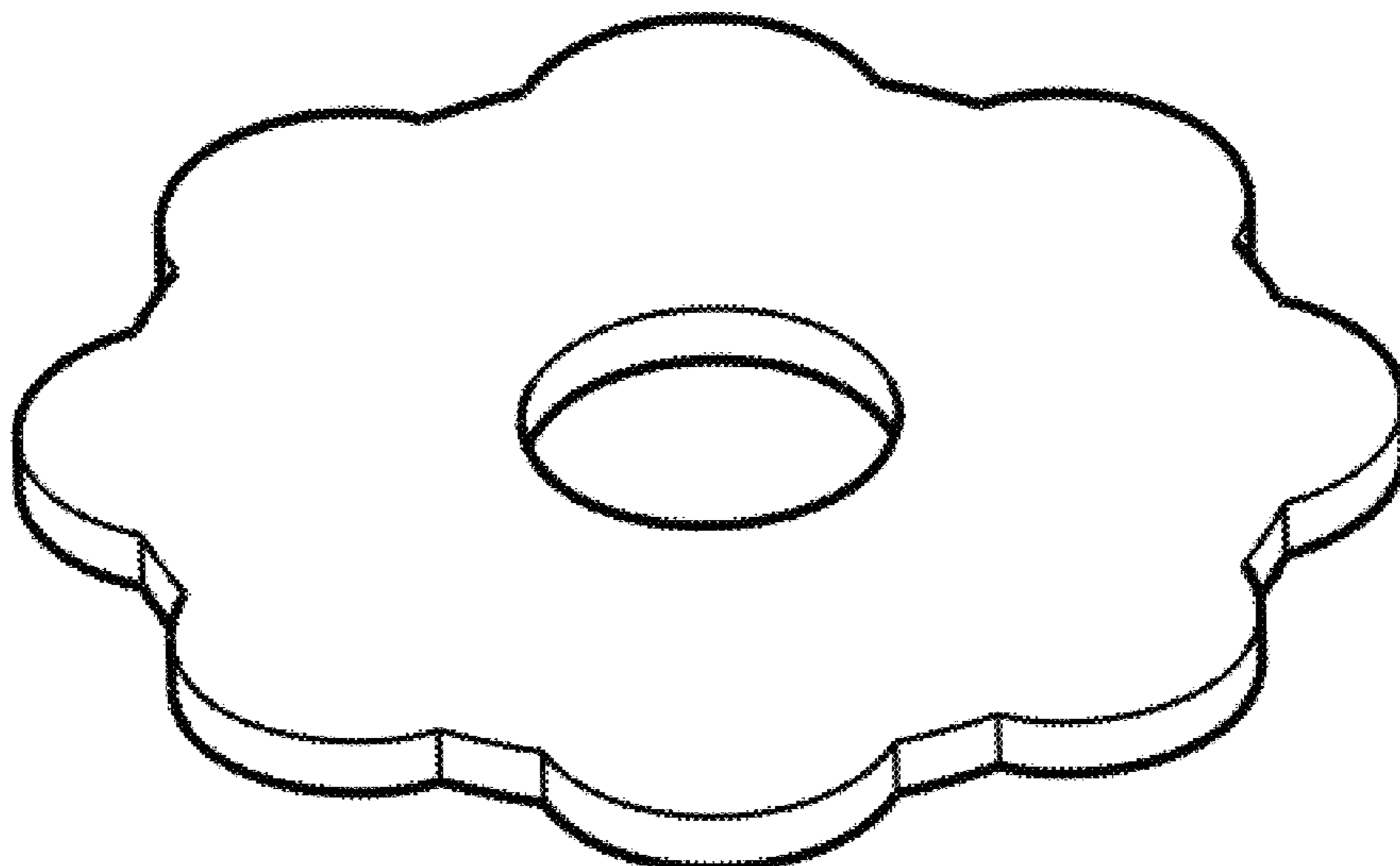

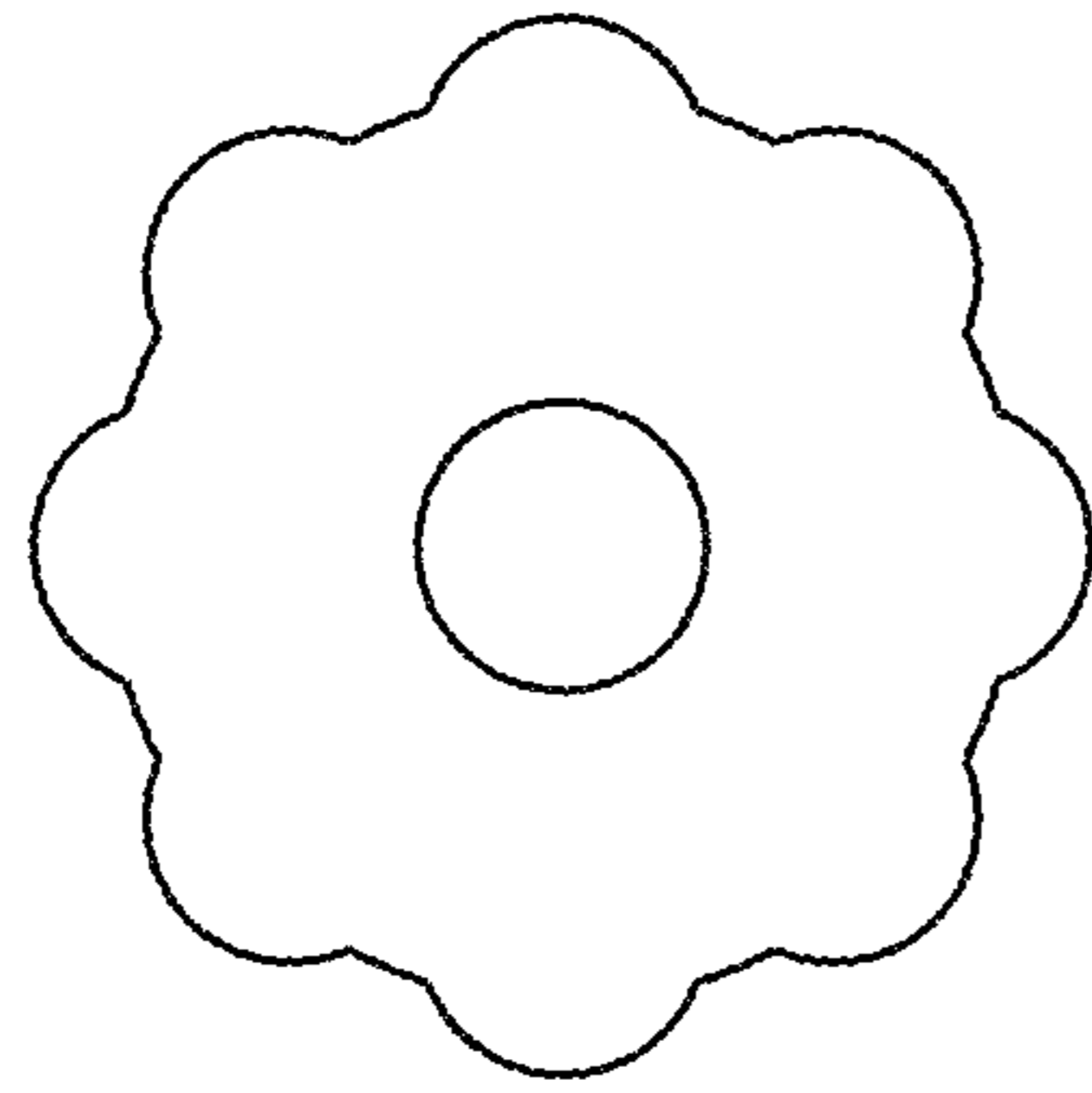

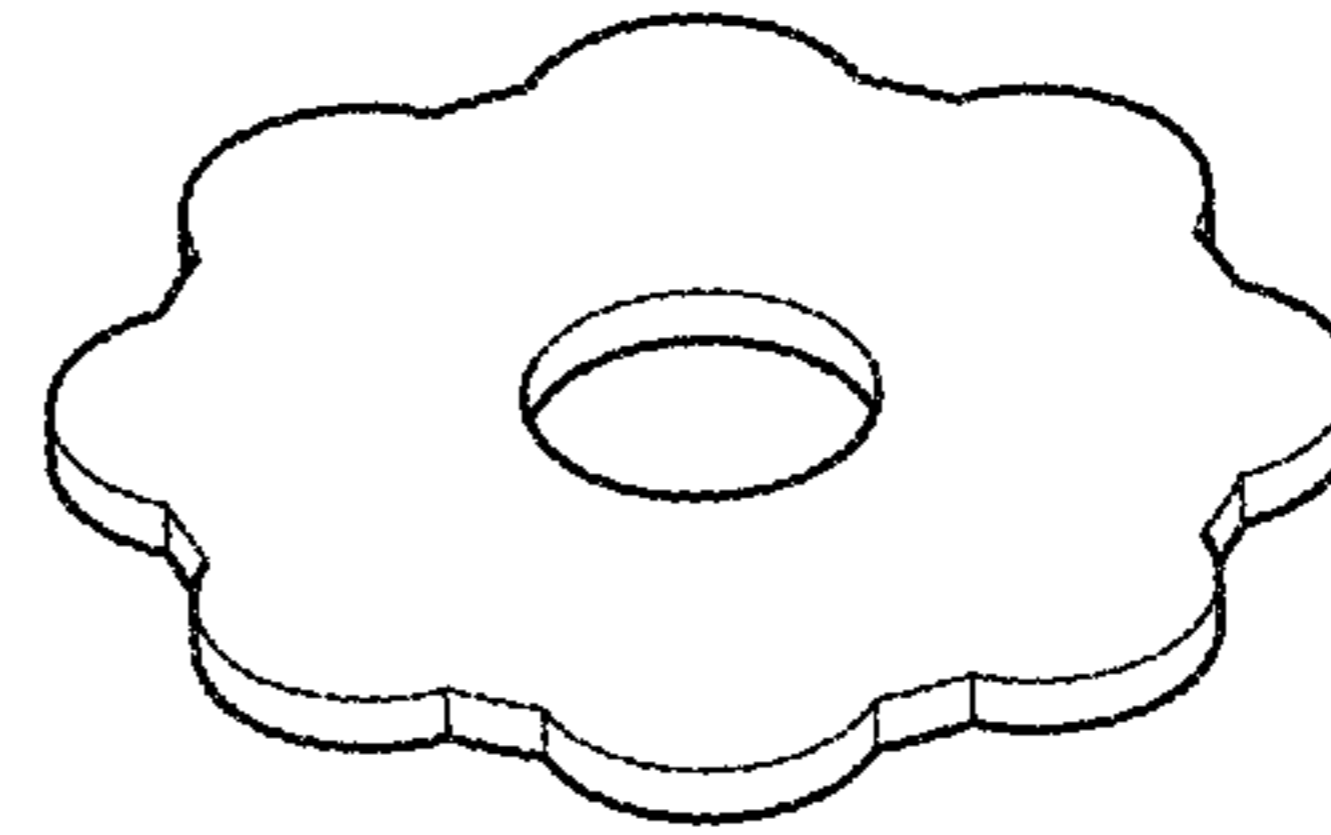

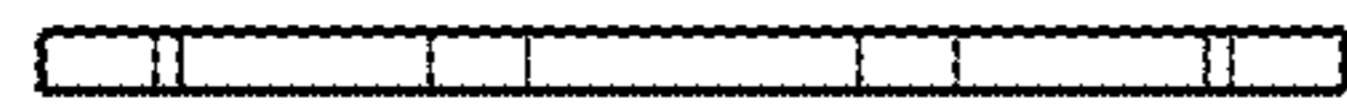

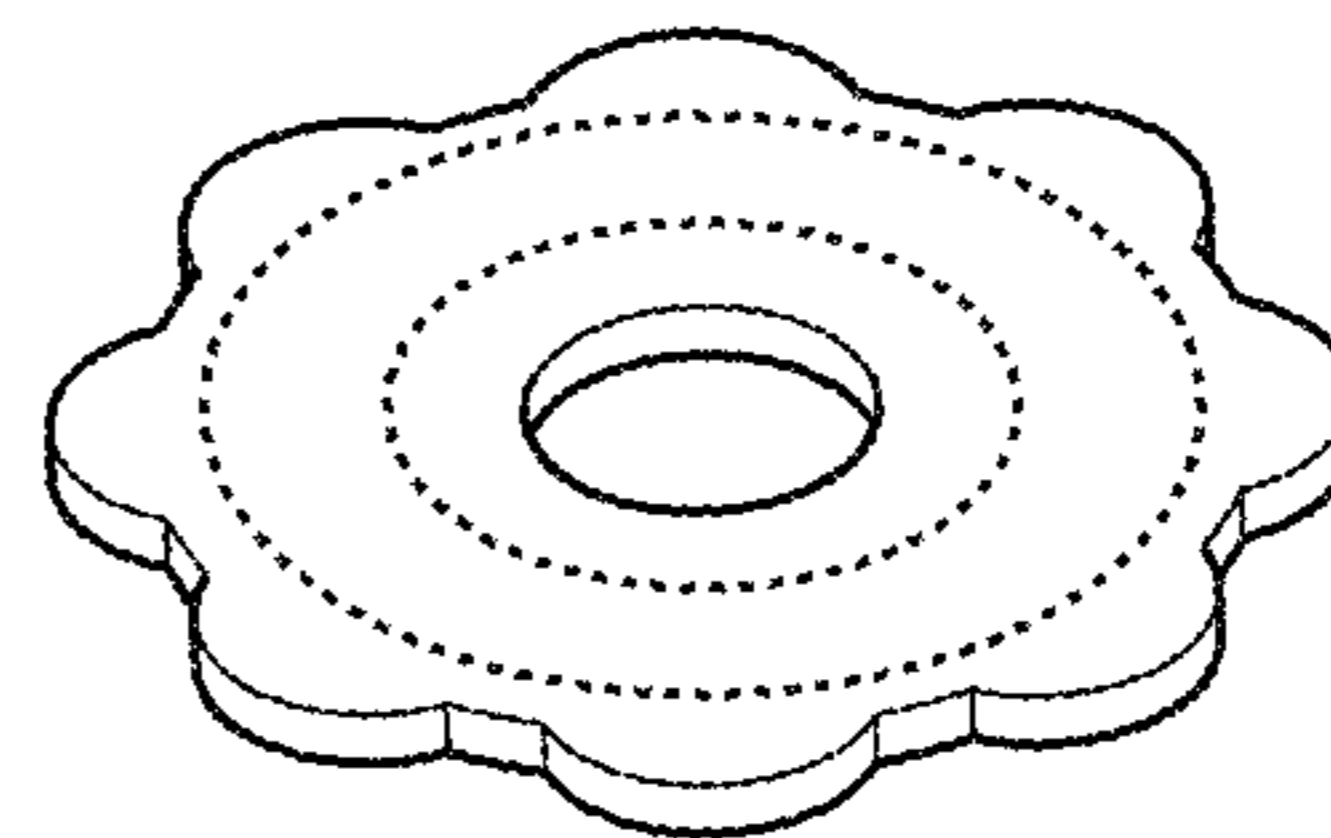
