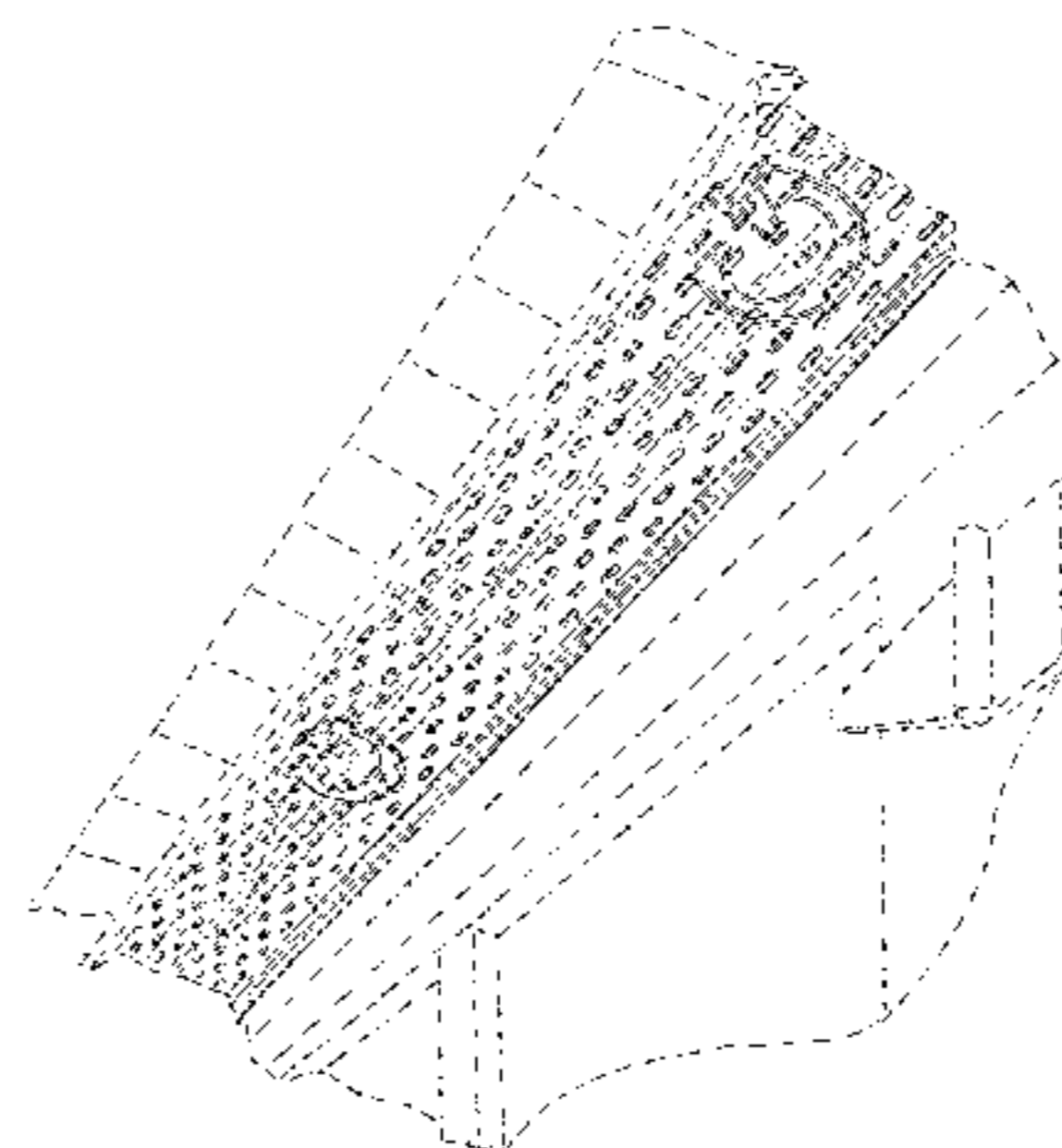
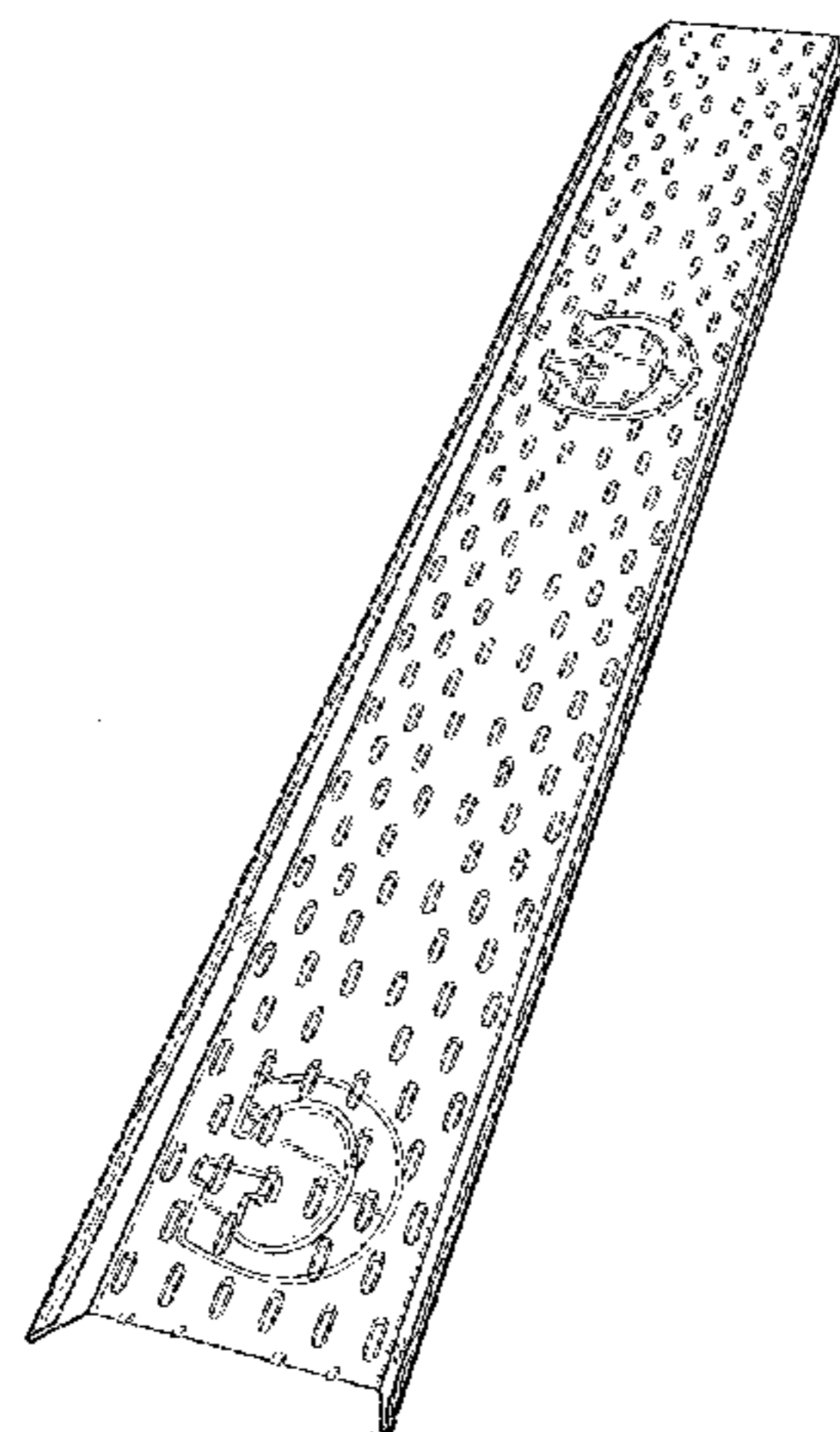


FIG. 7 is a top, front, and right side perspective view thereof; and,

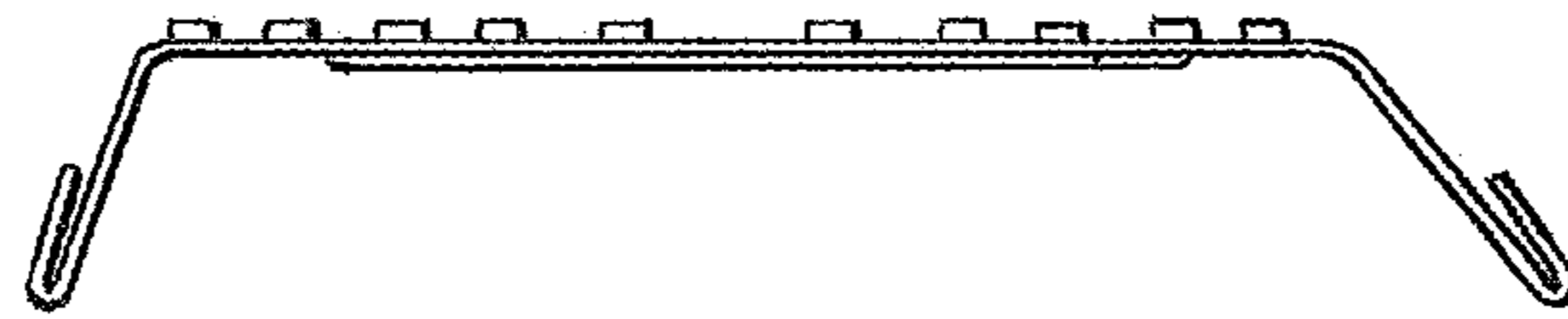

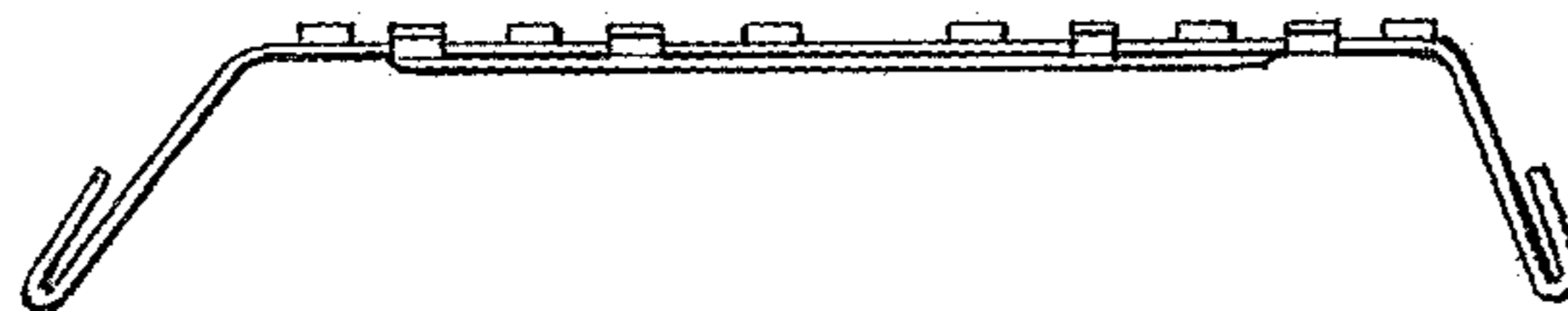

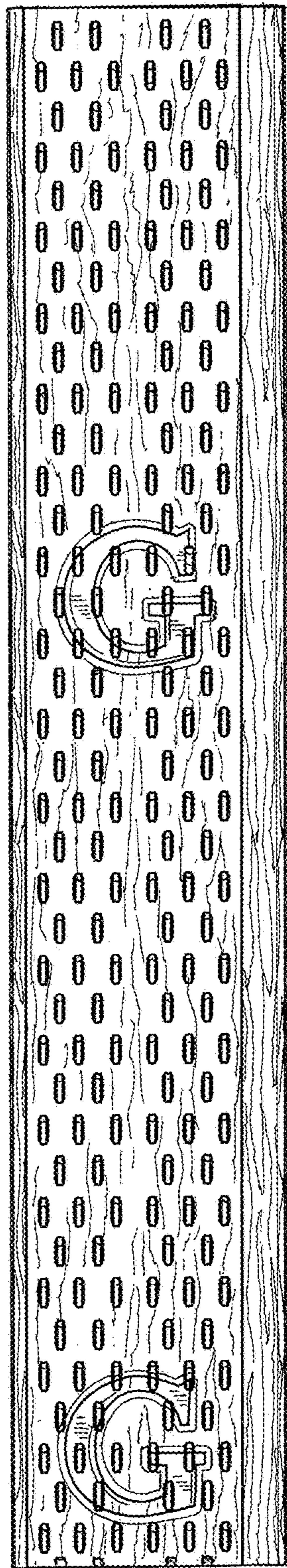

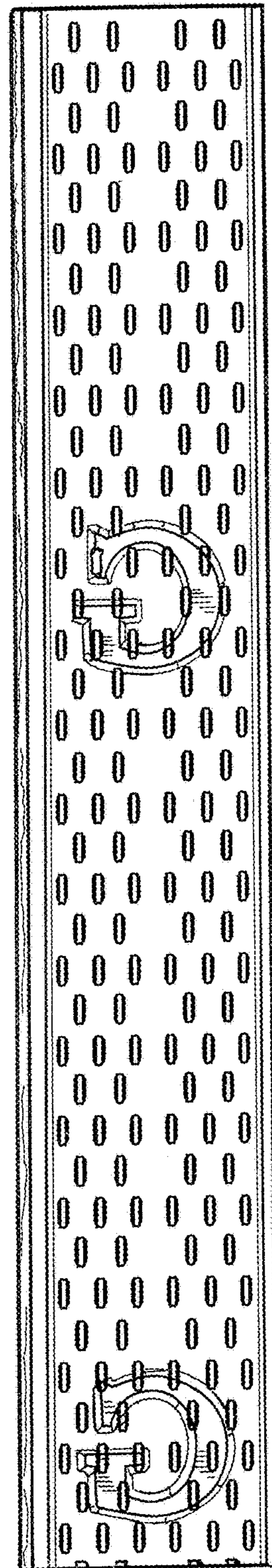

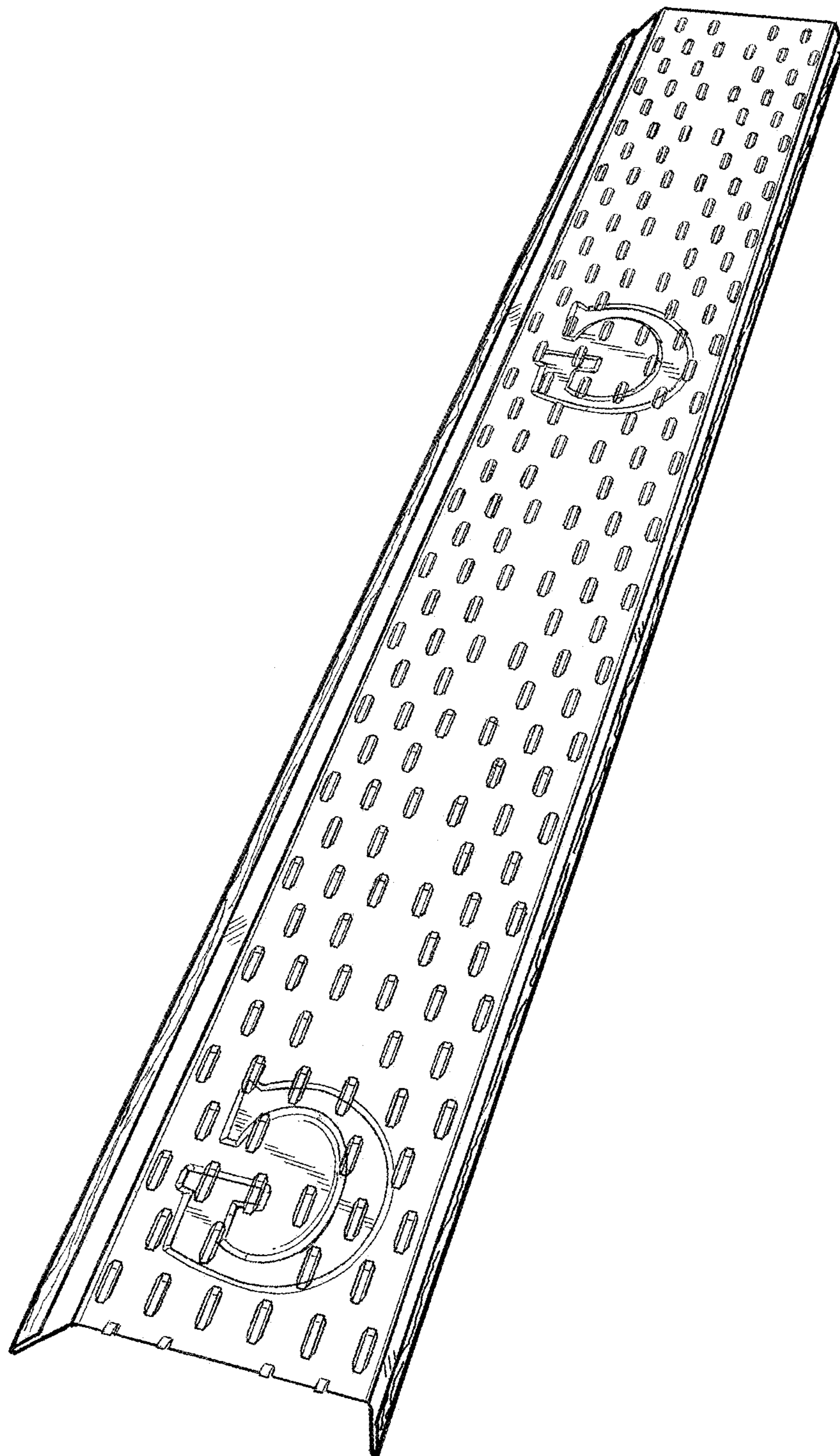

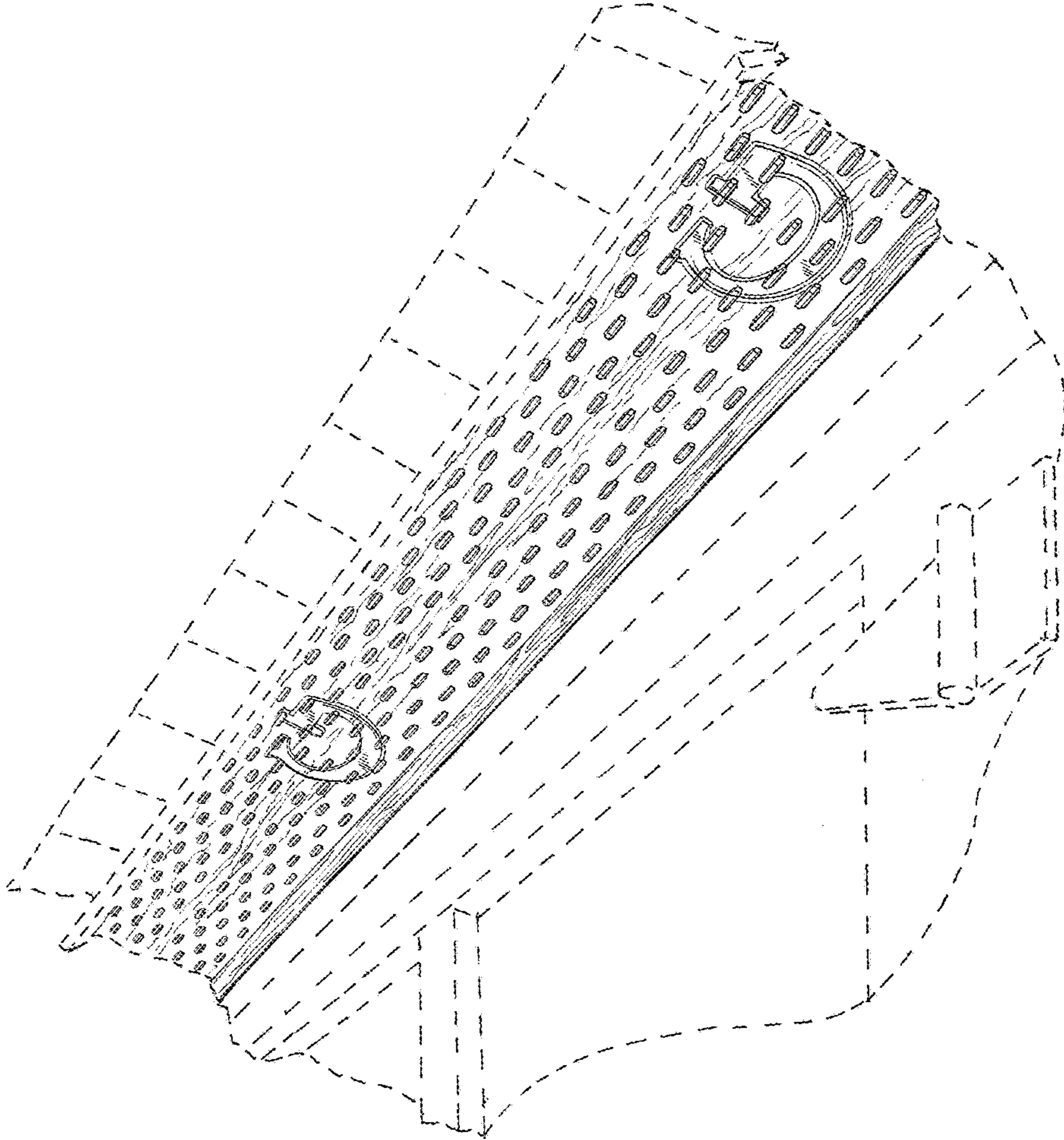
