DESCRIPTION

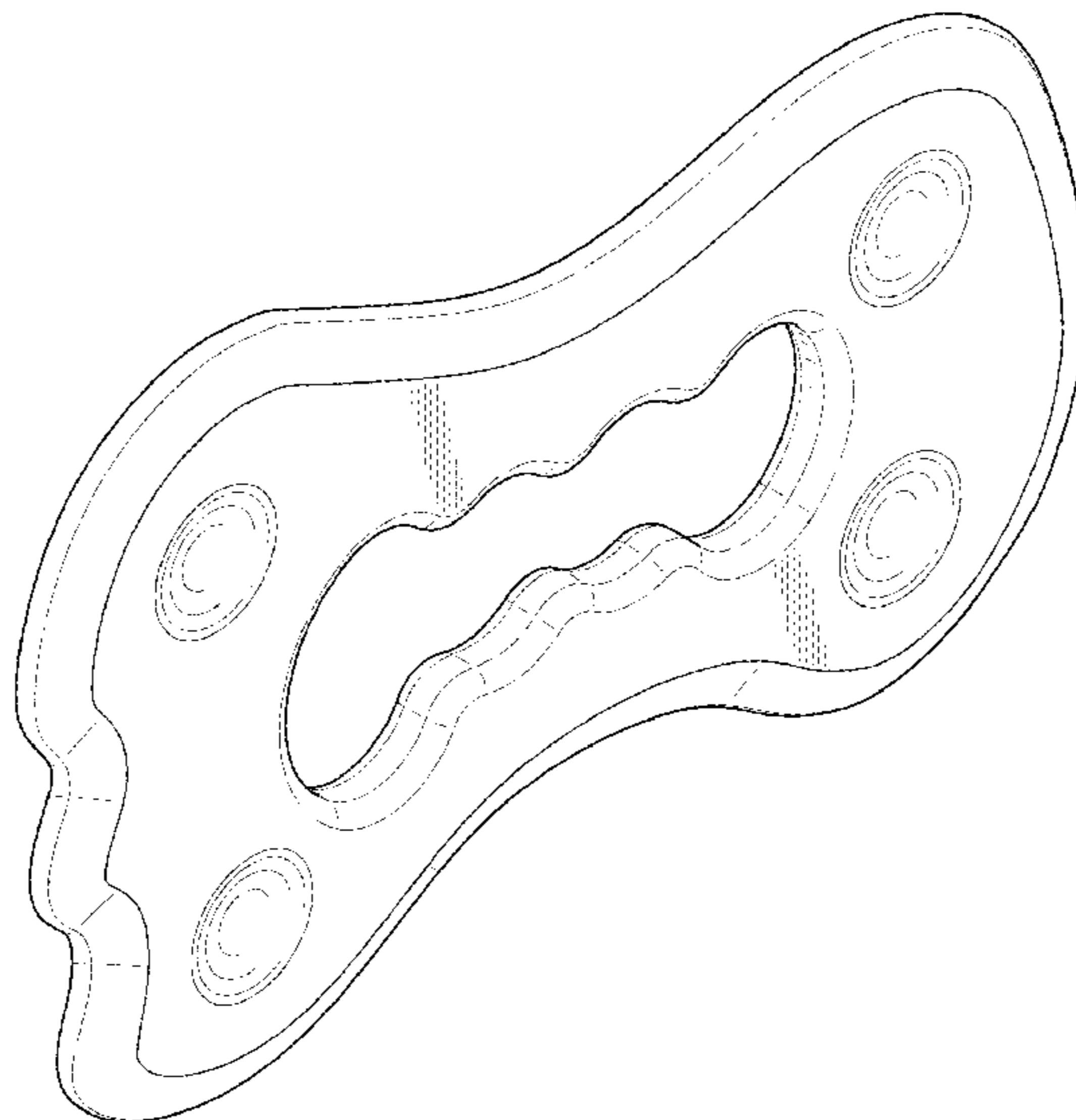
FIG. 1 is a front, right and top perspective view of a massage tool;

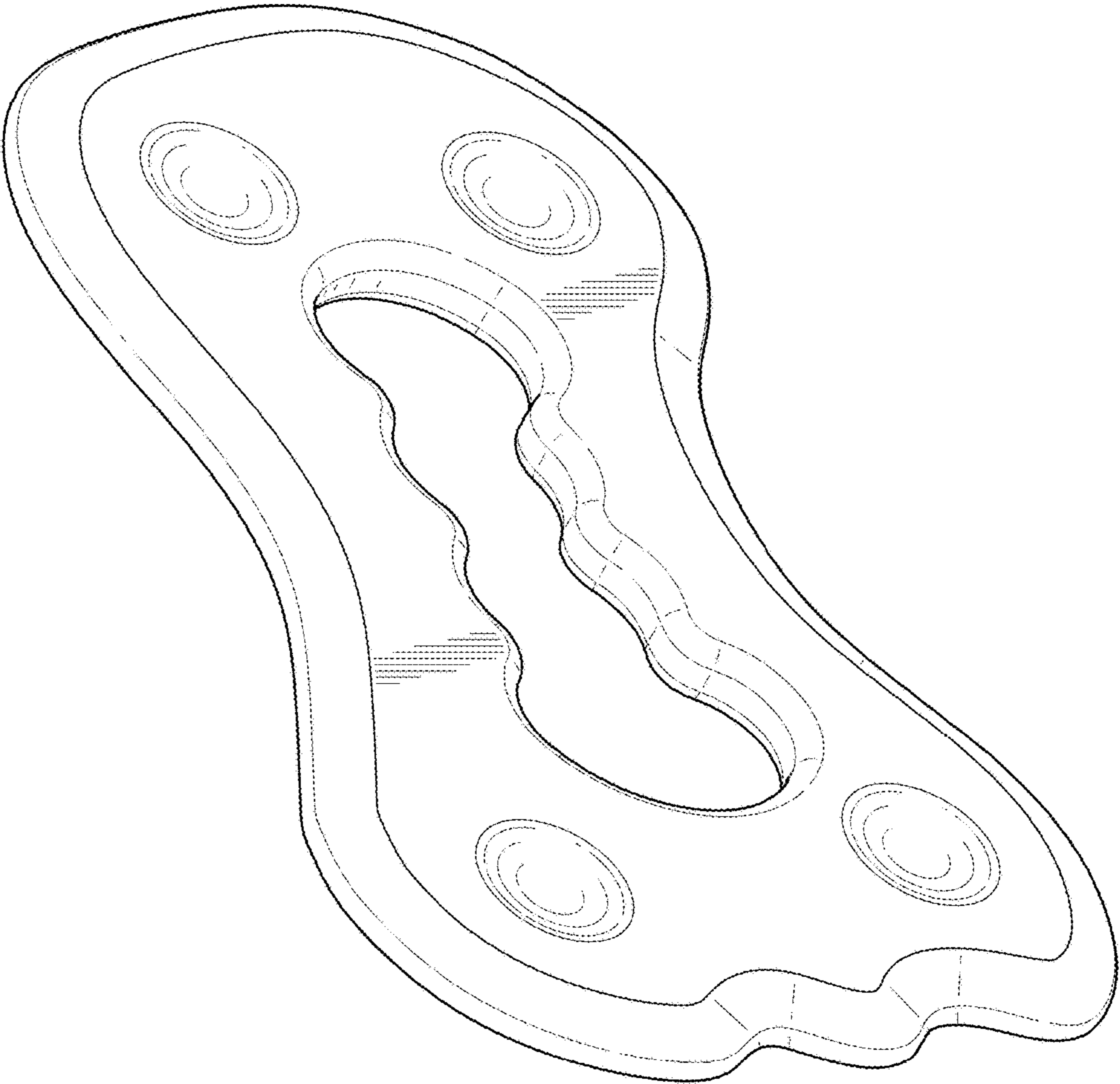

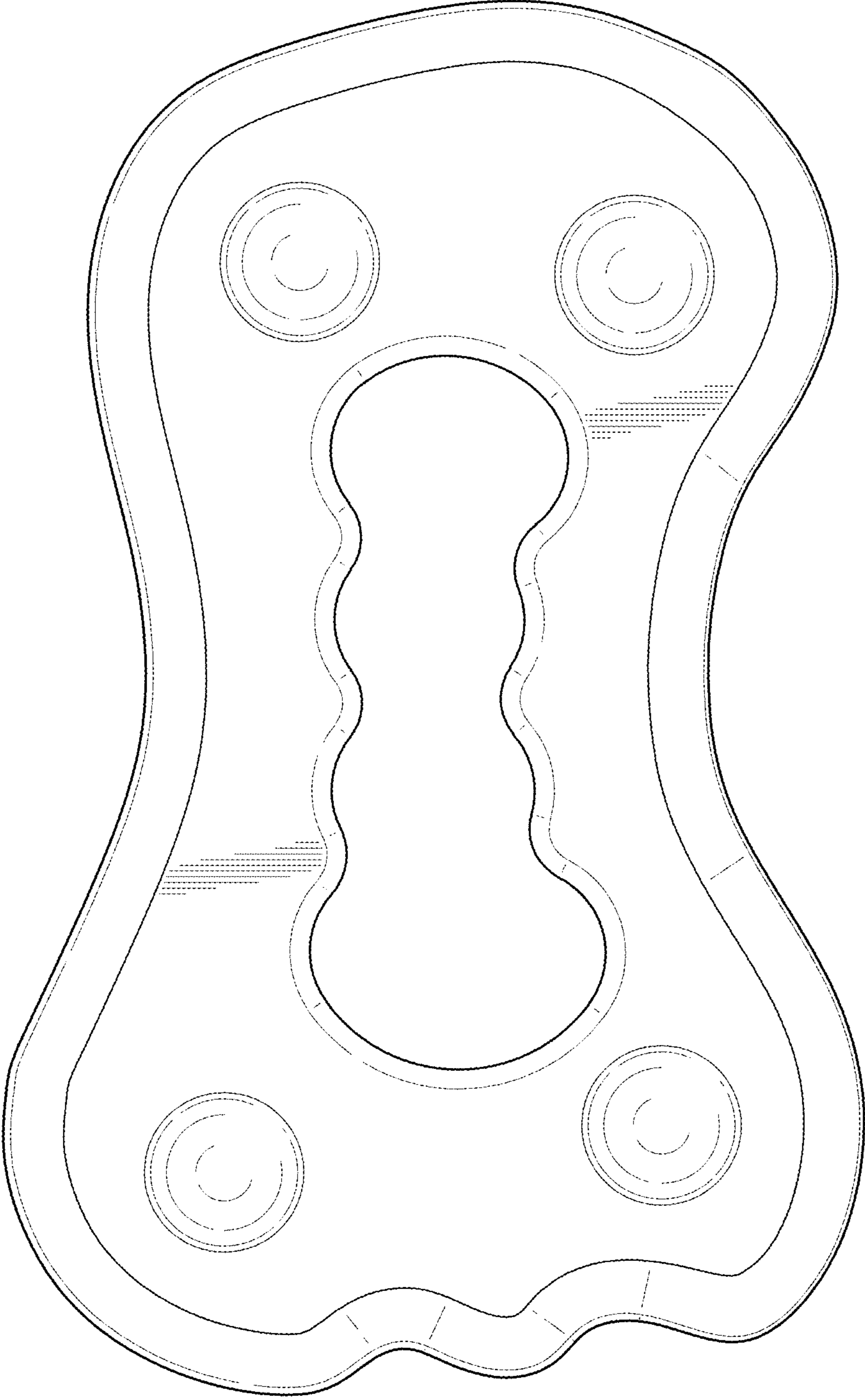

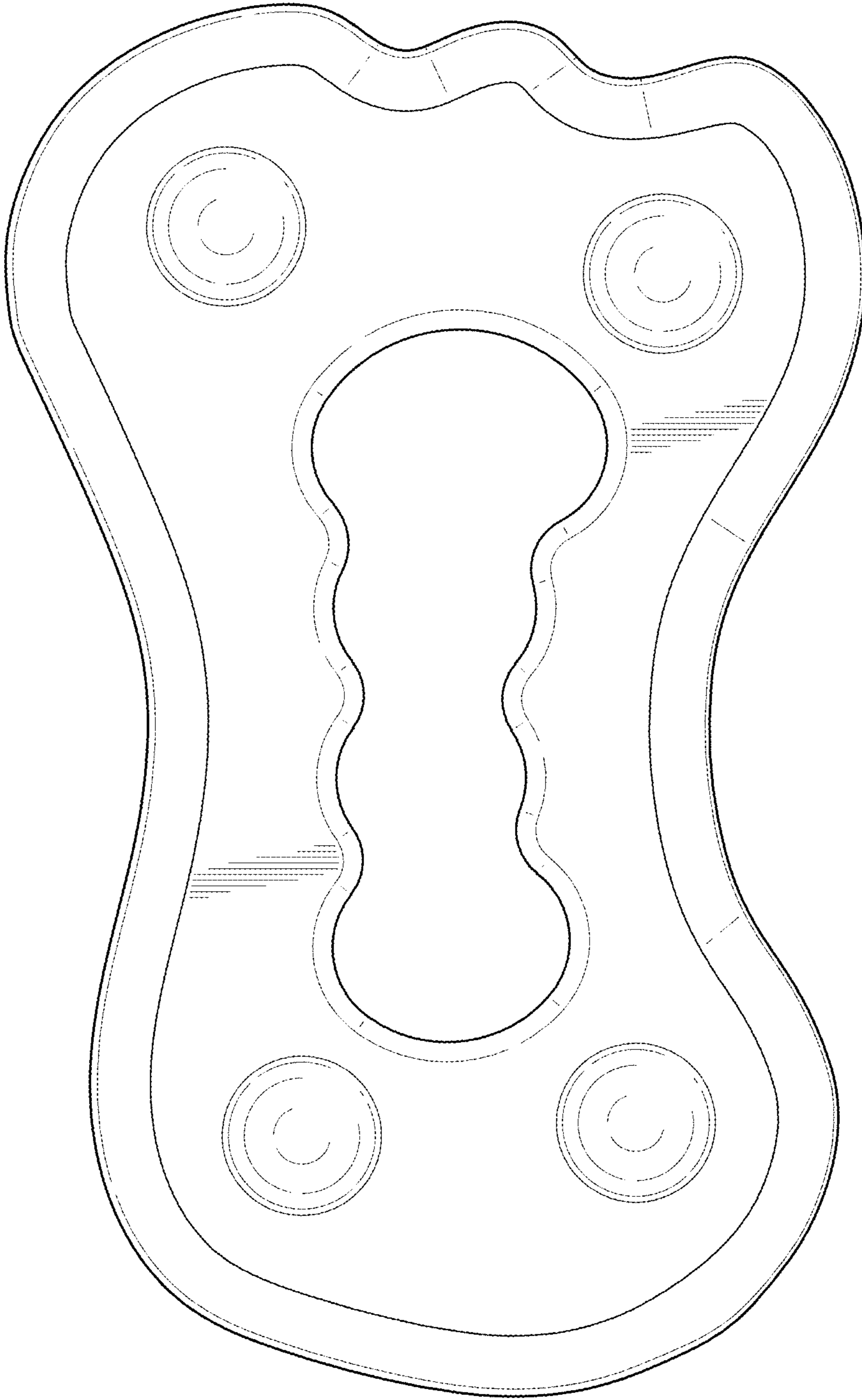

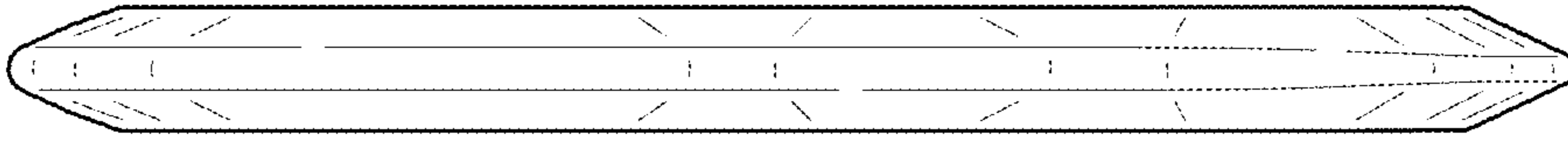

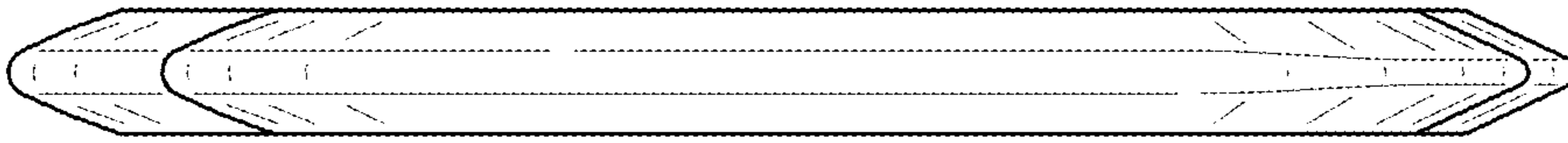

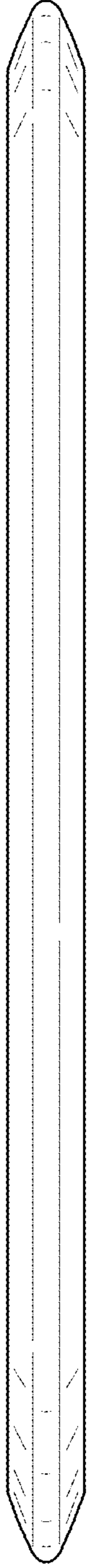

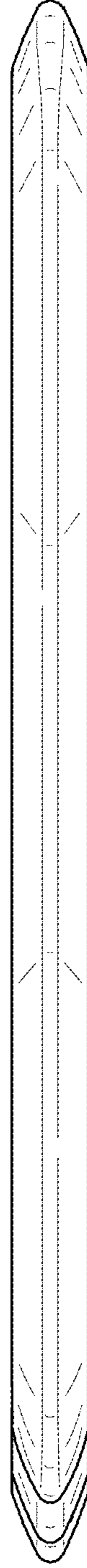
