DESCRIPTION

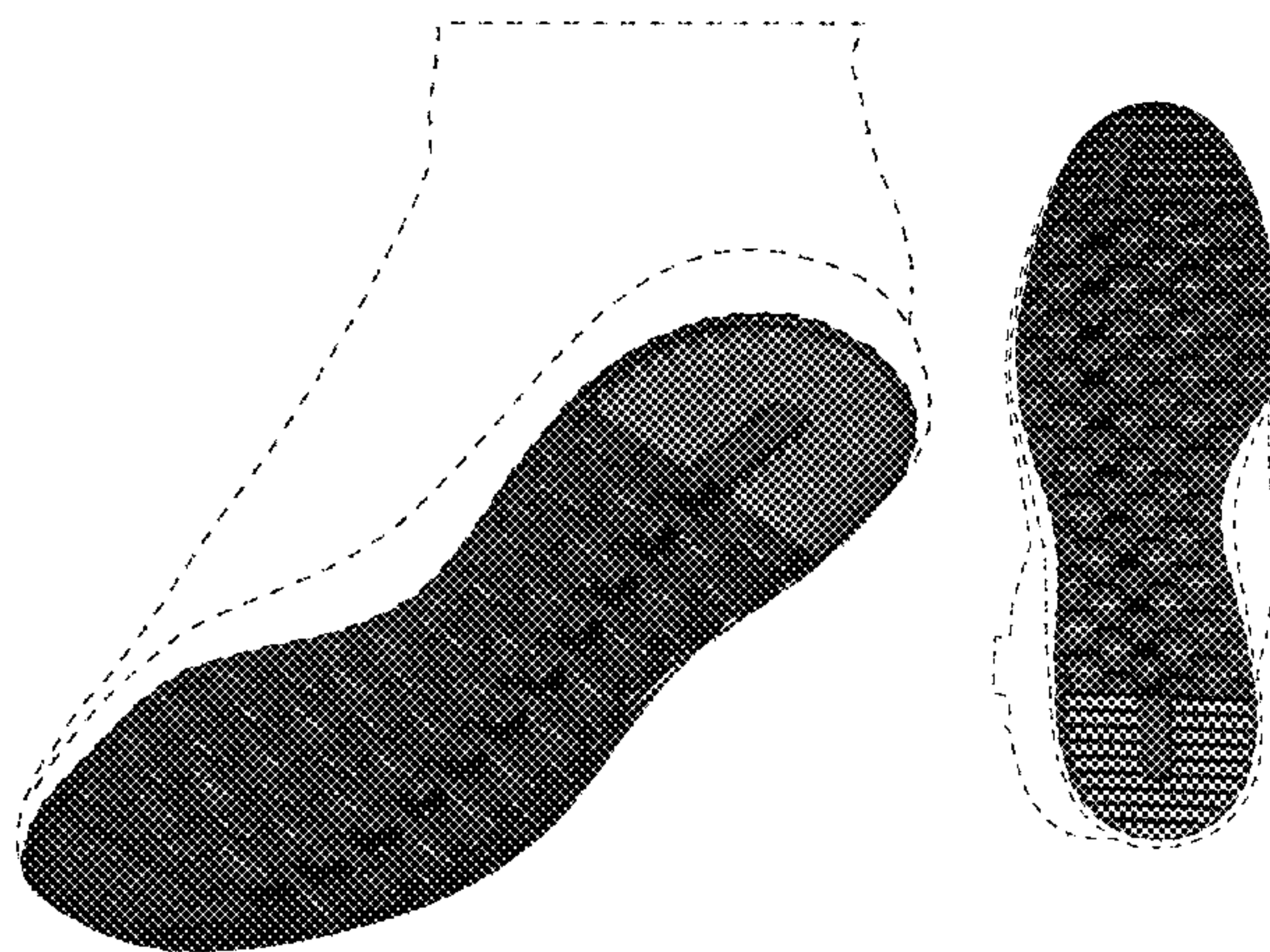
FIG. 1 is a medial perspective view of a sole for footwear showing my new design;

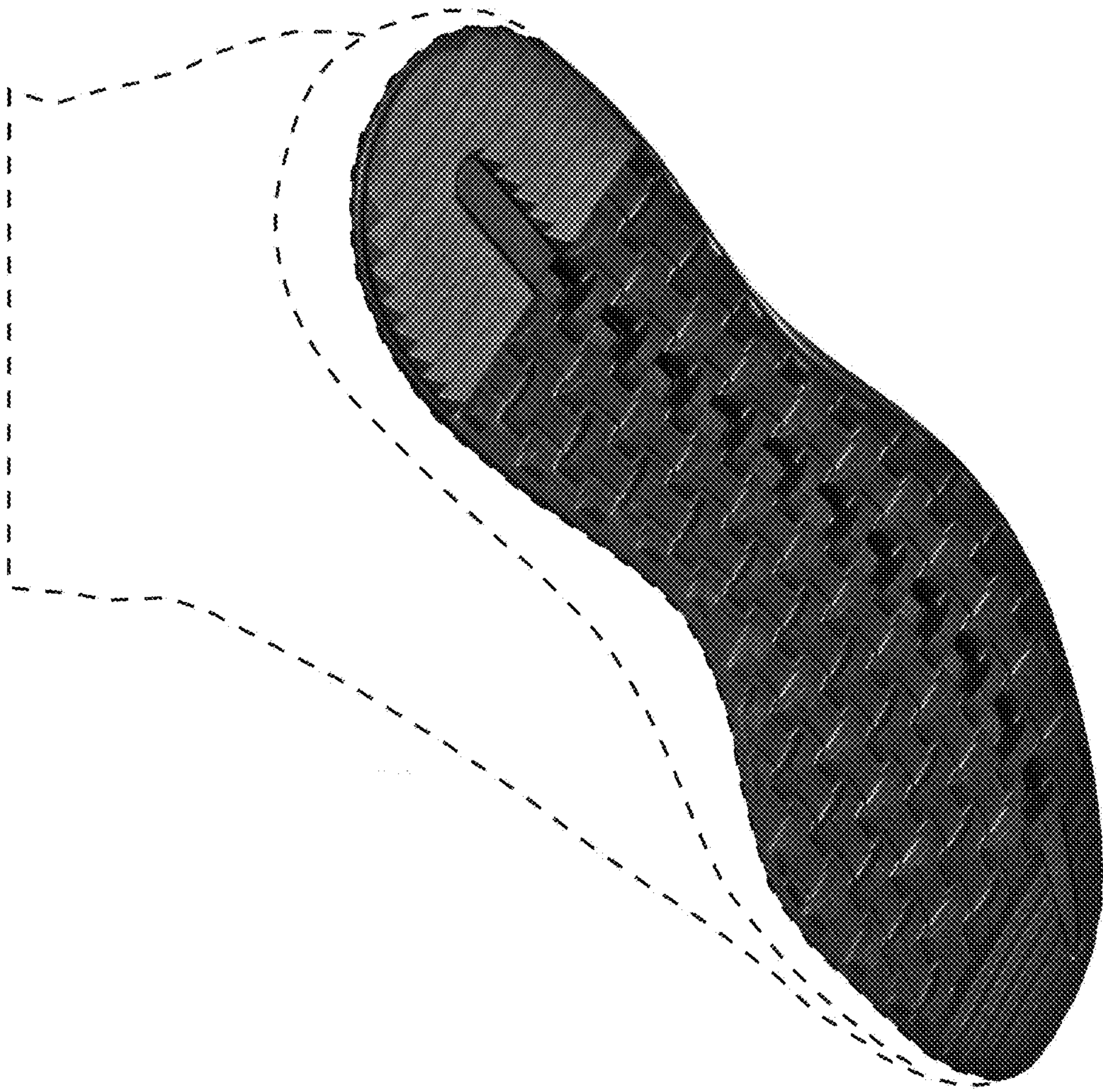

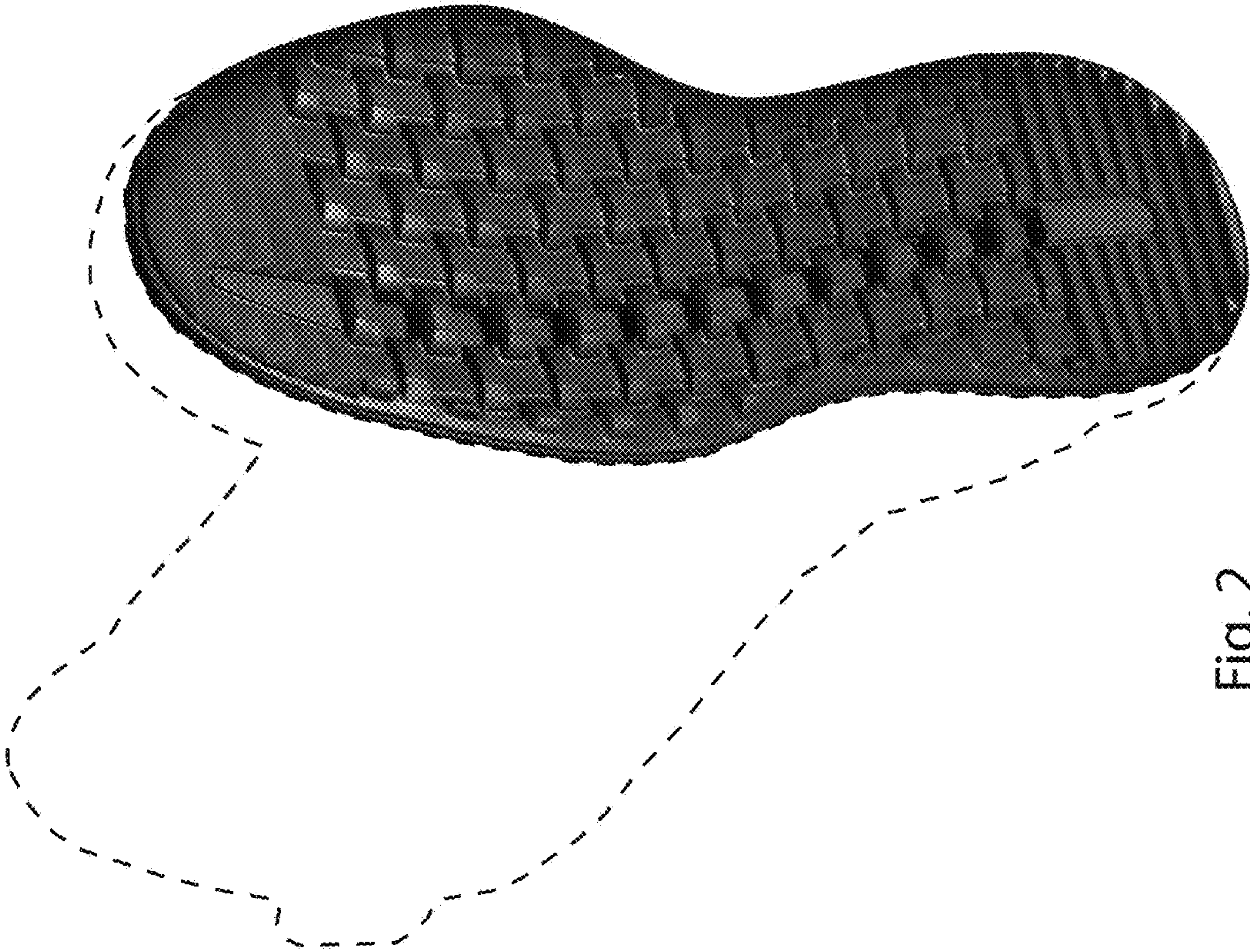

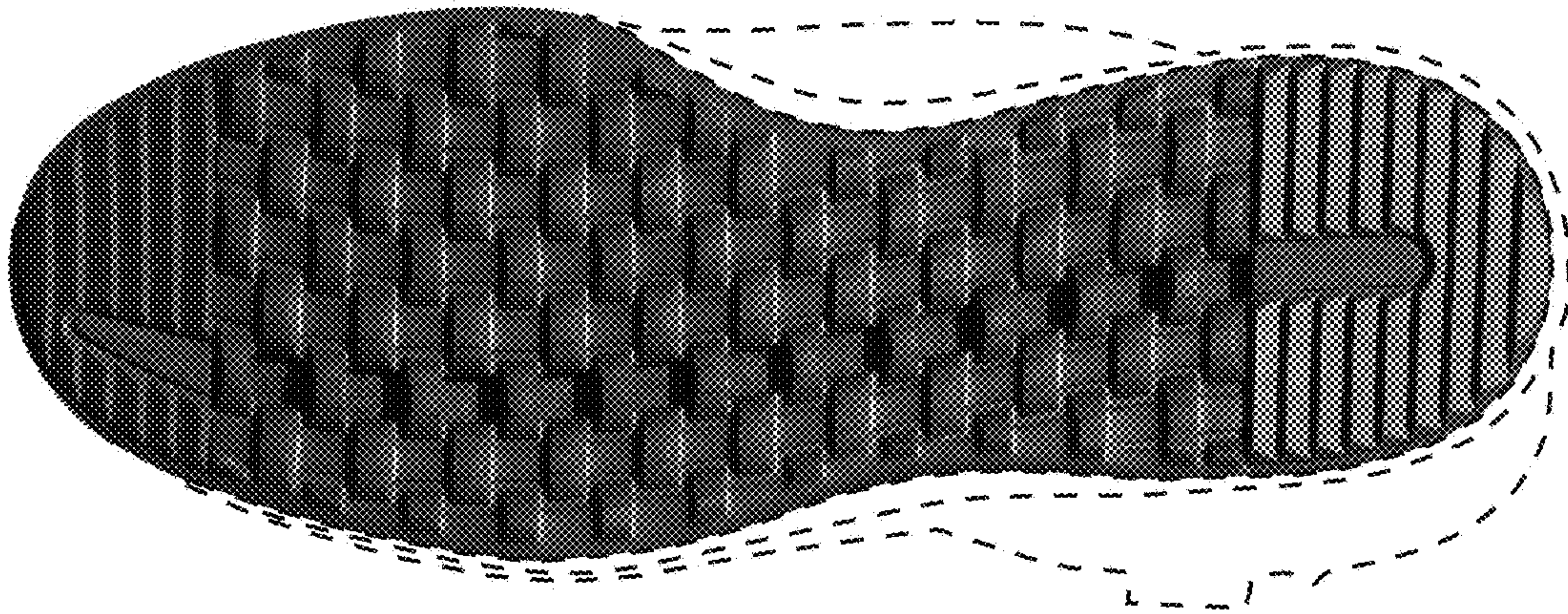
