DESCRIPTION

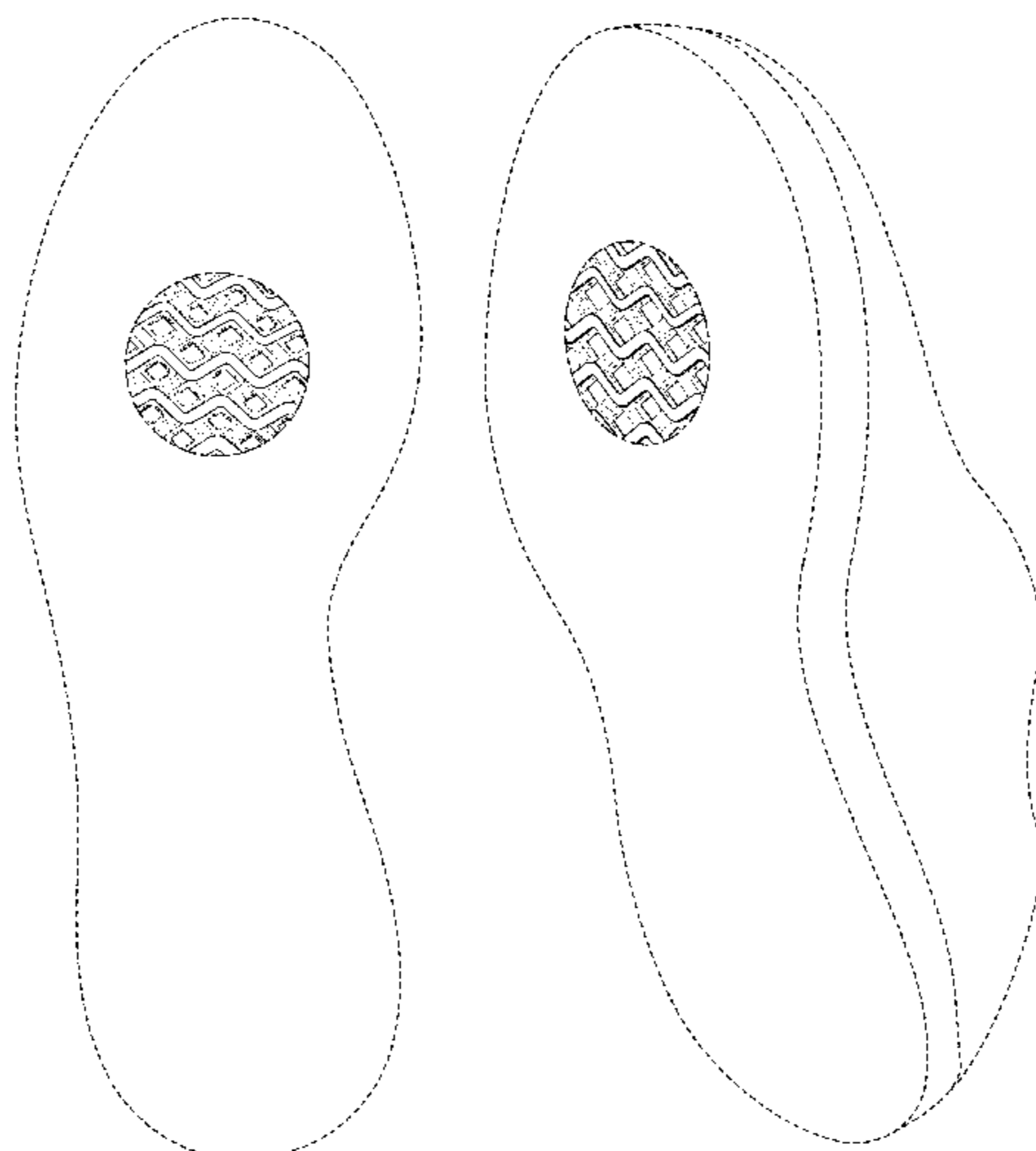
FIG. 1 is a bottom plan view of a shoe outsole showing the new design;

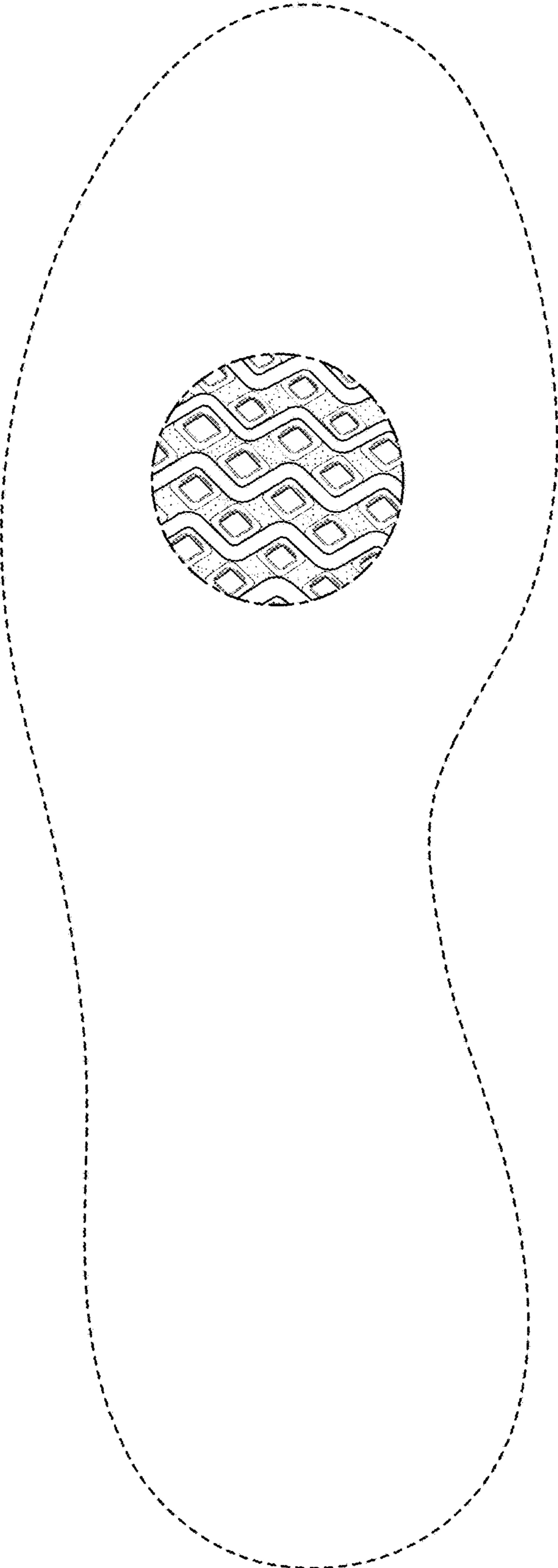

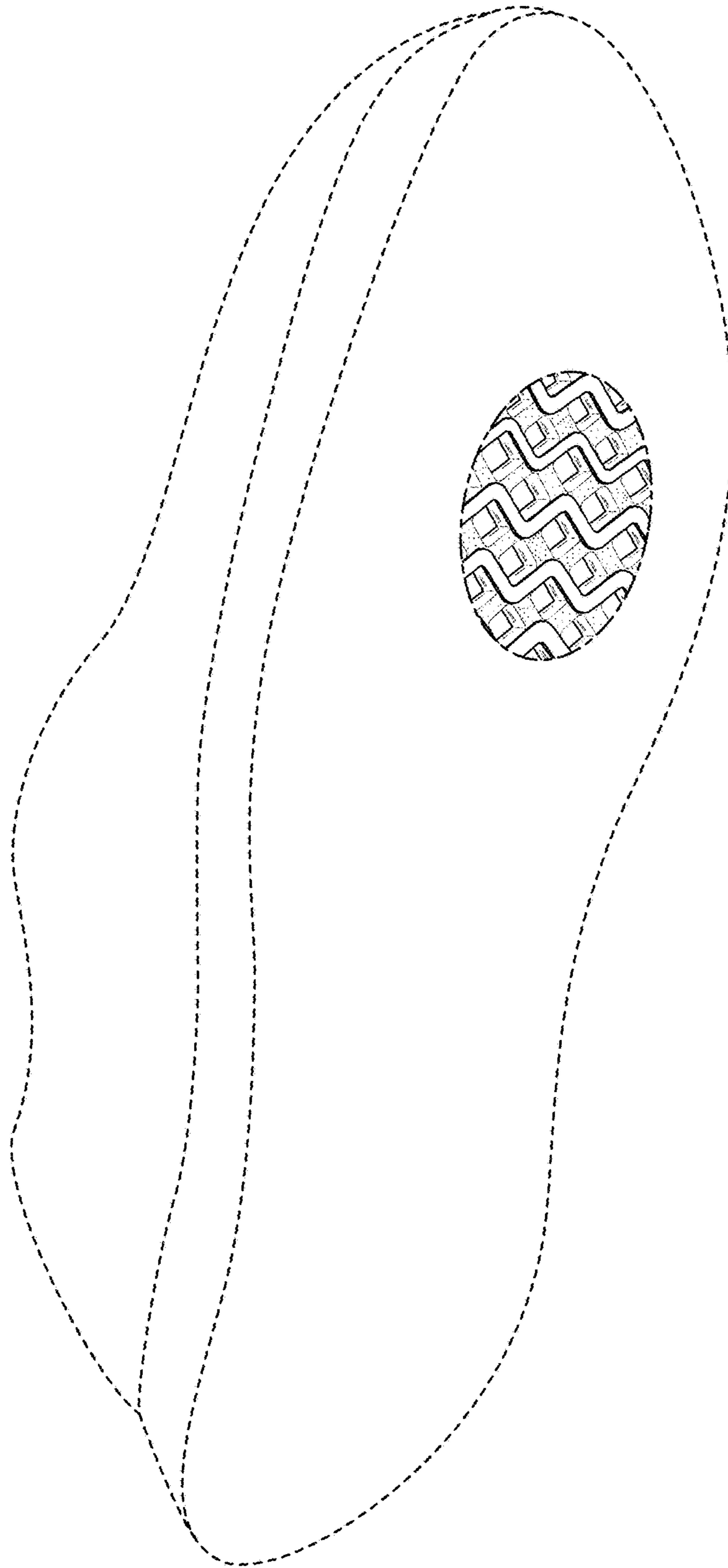

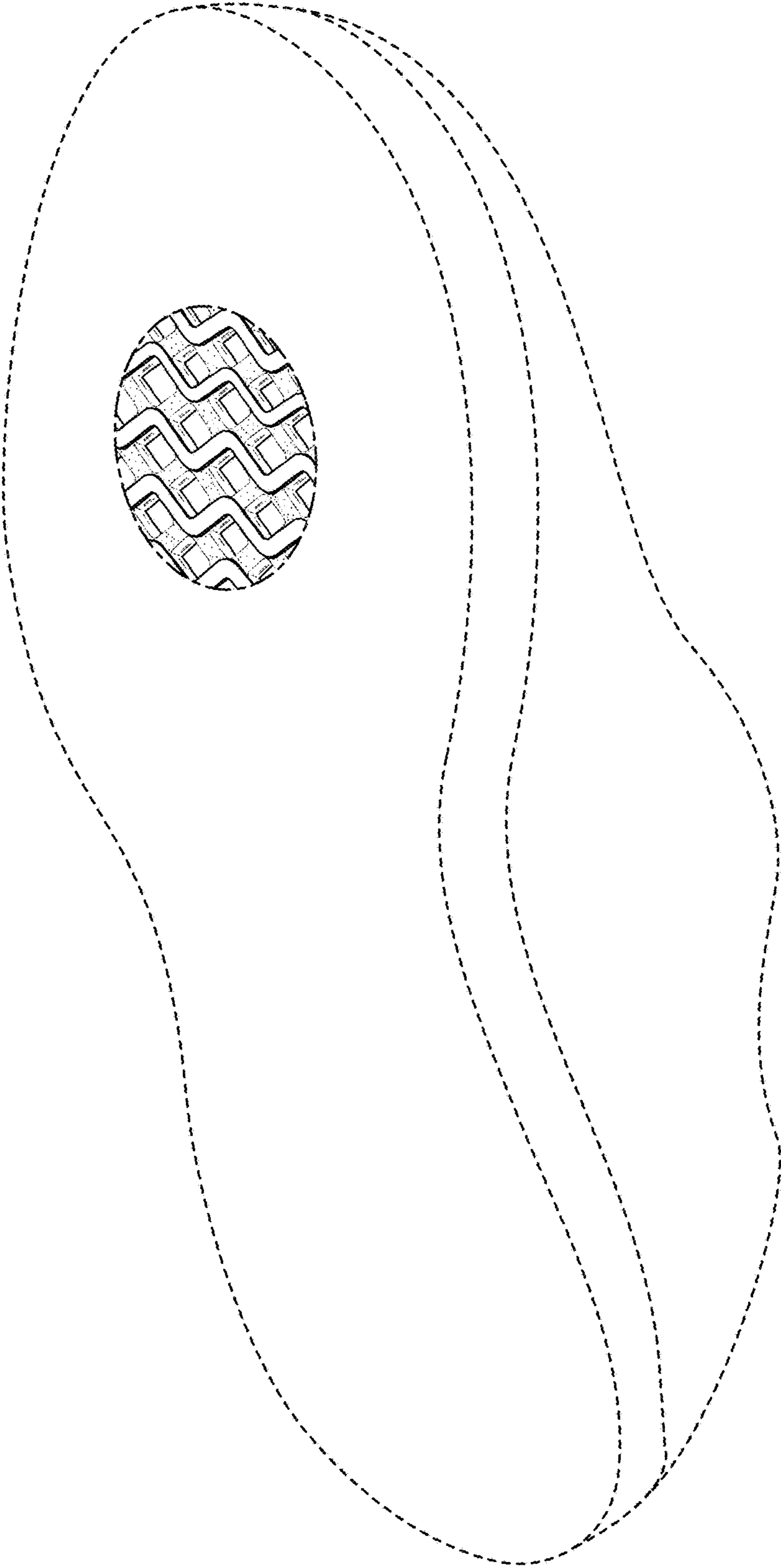
