DESCRIPTION

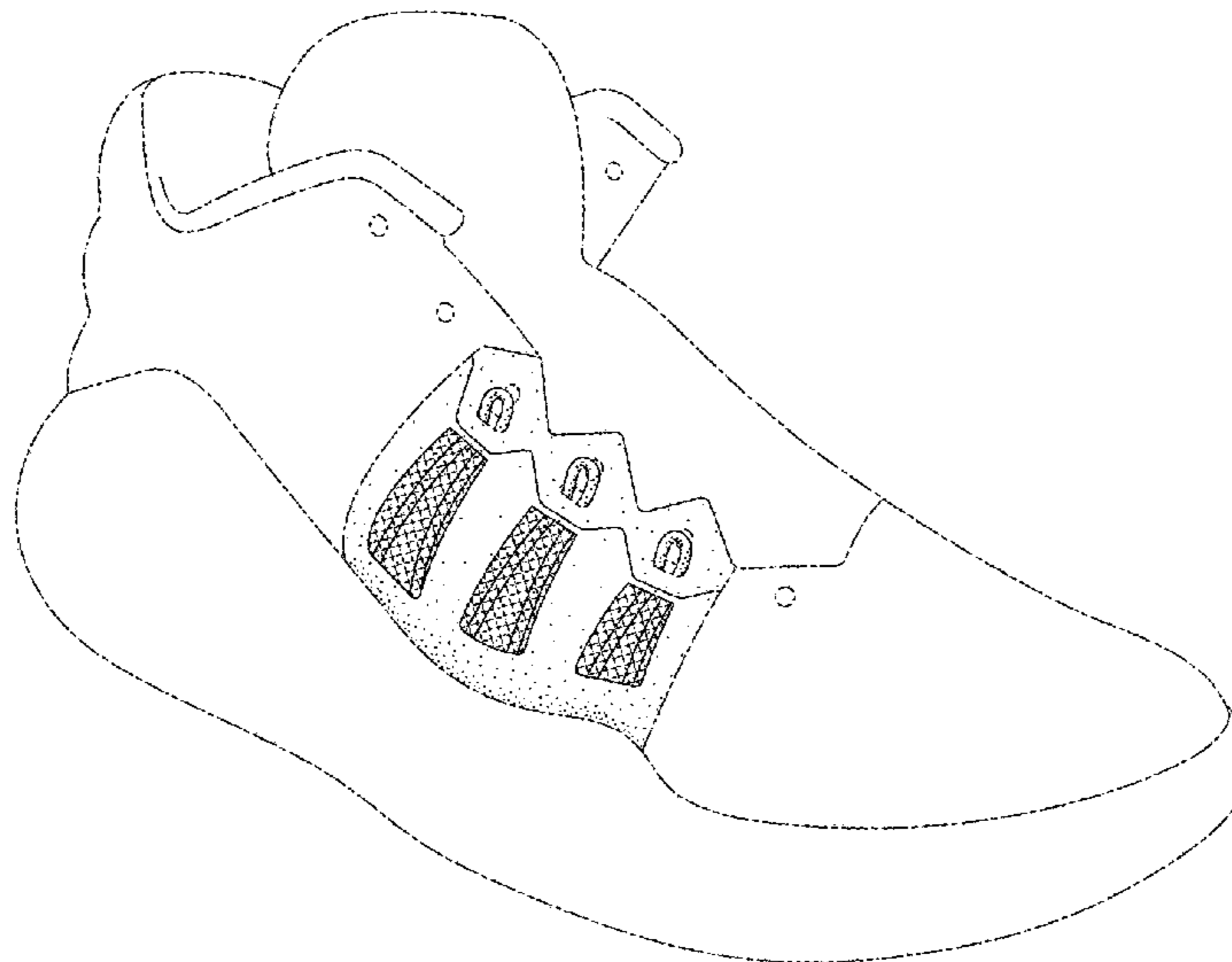
FIG. 1 is a front perspective view of a shoe upper showing my new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The six unshaded regions within the shaded area that are demarcated by broken lines form no part of the claimed design. 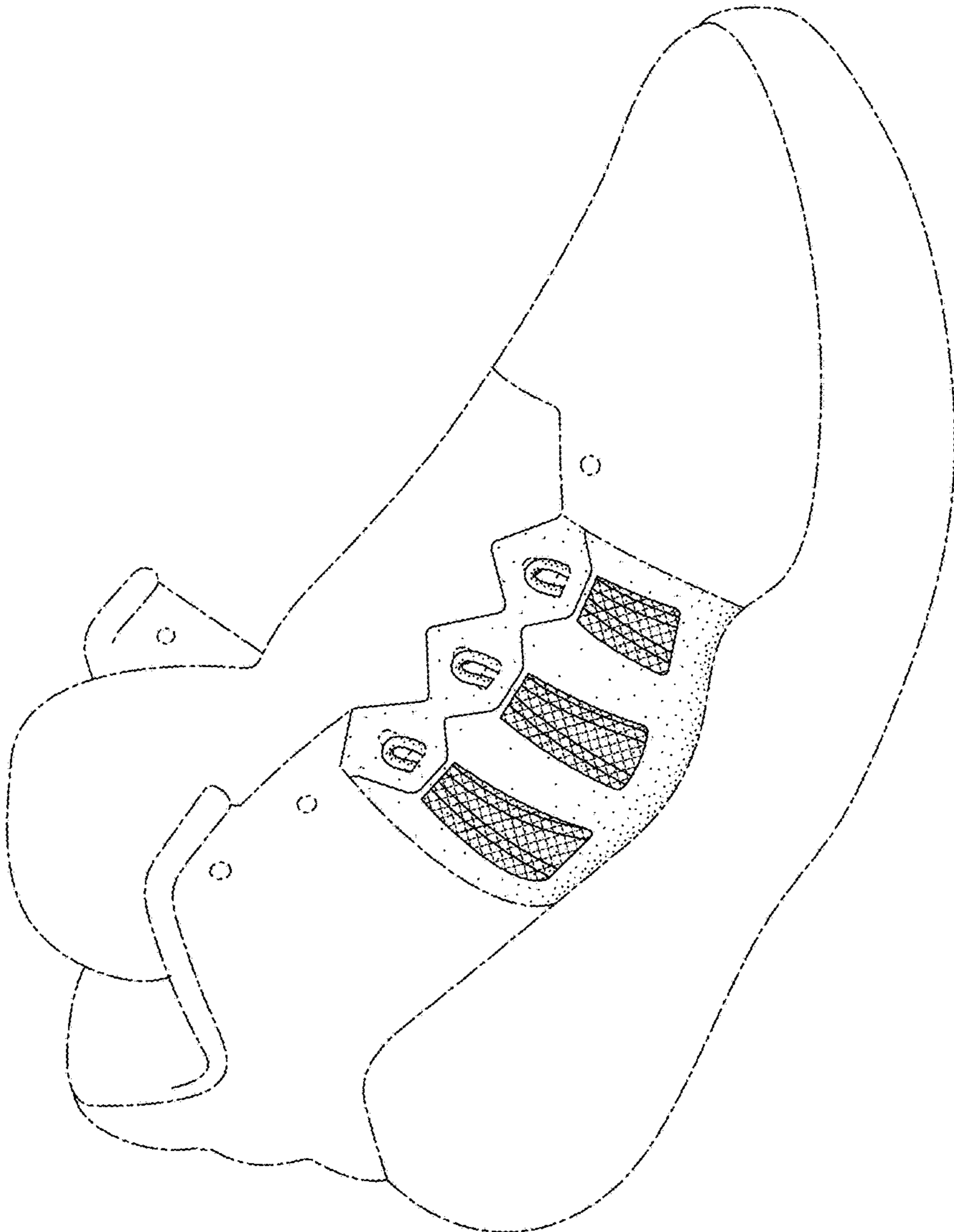

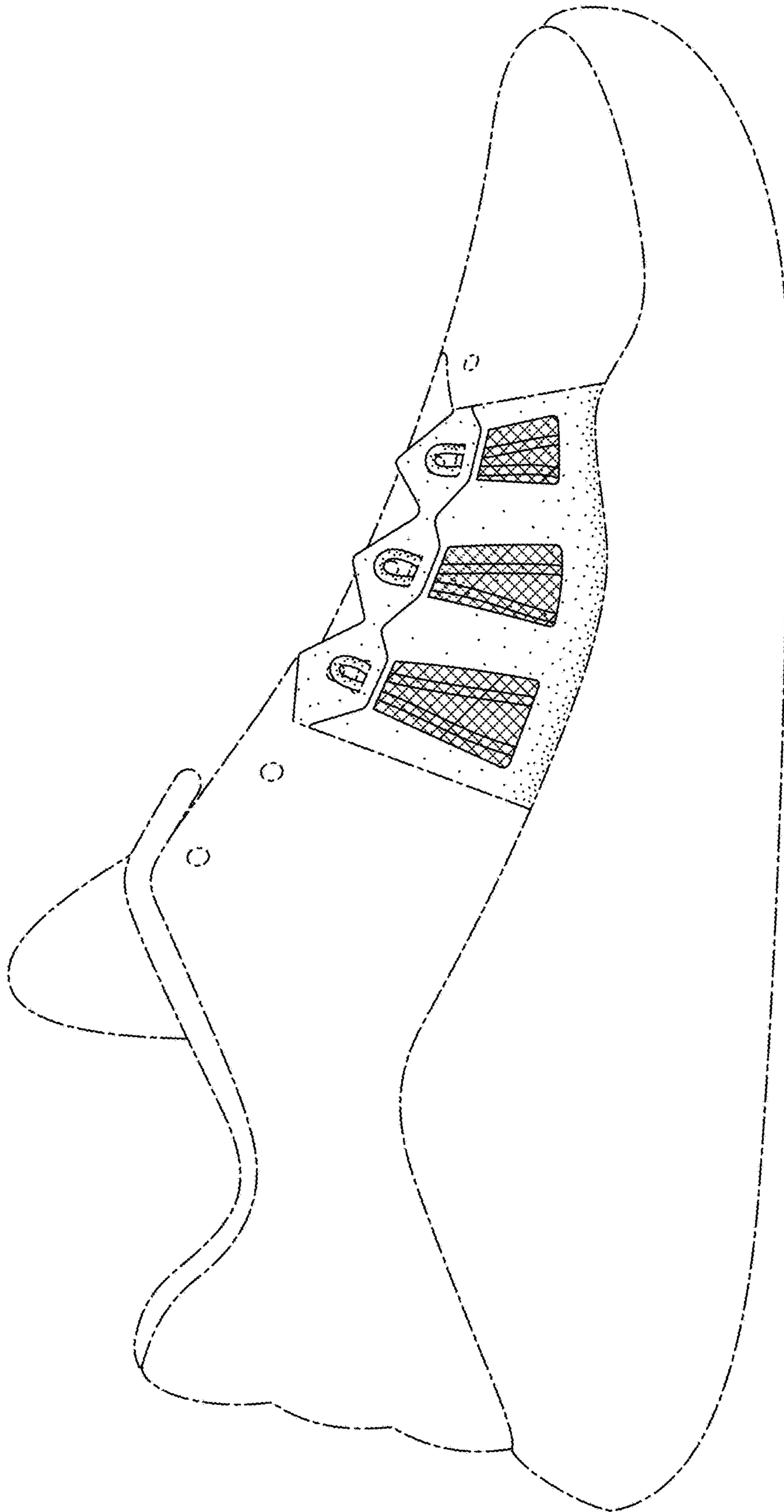

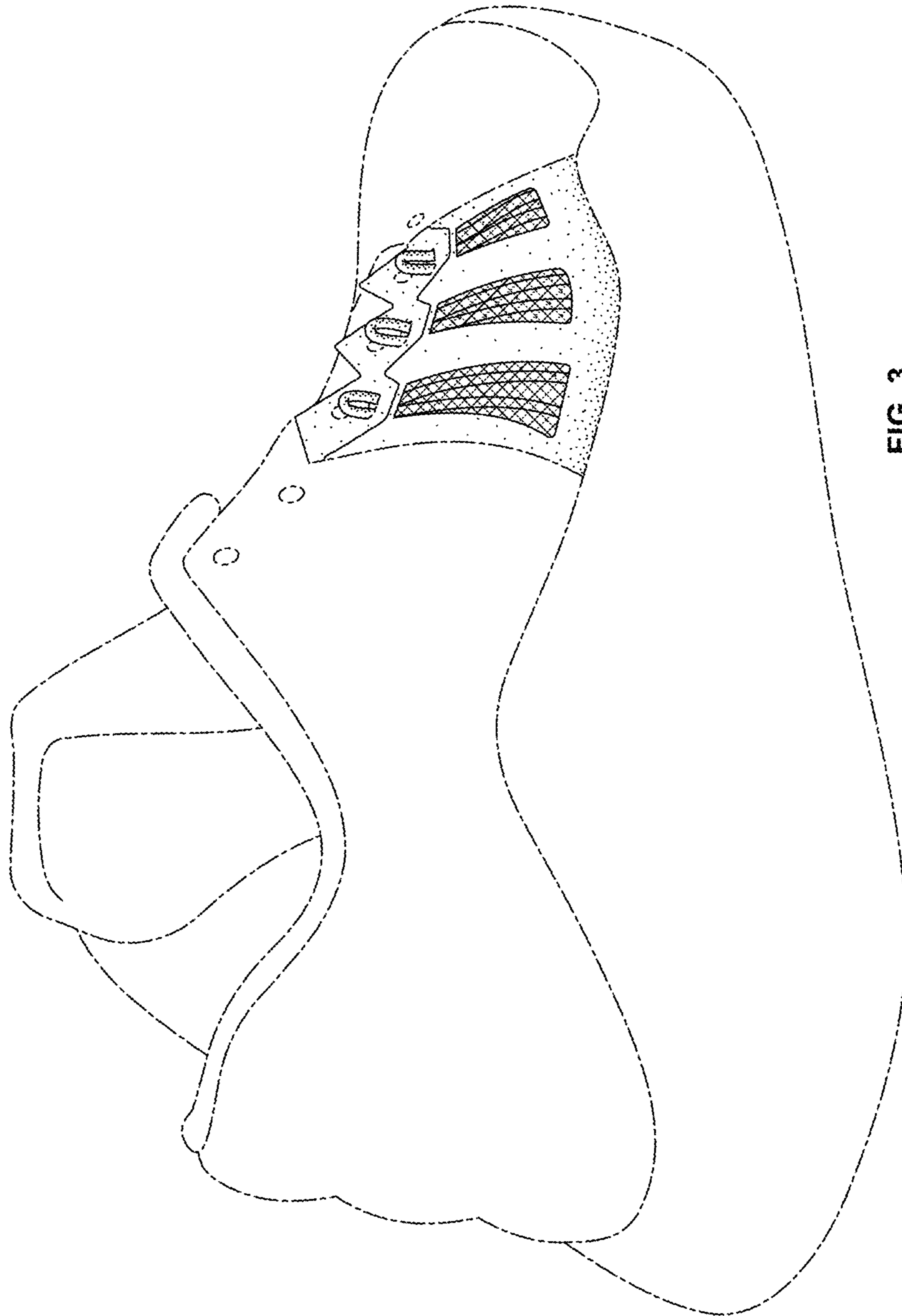
