The ornamental design for a sheet with camouflage pattern, as shown and described.

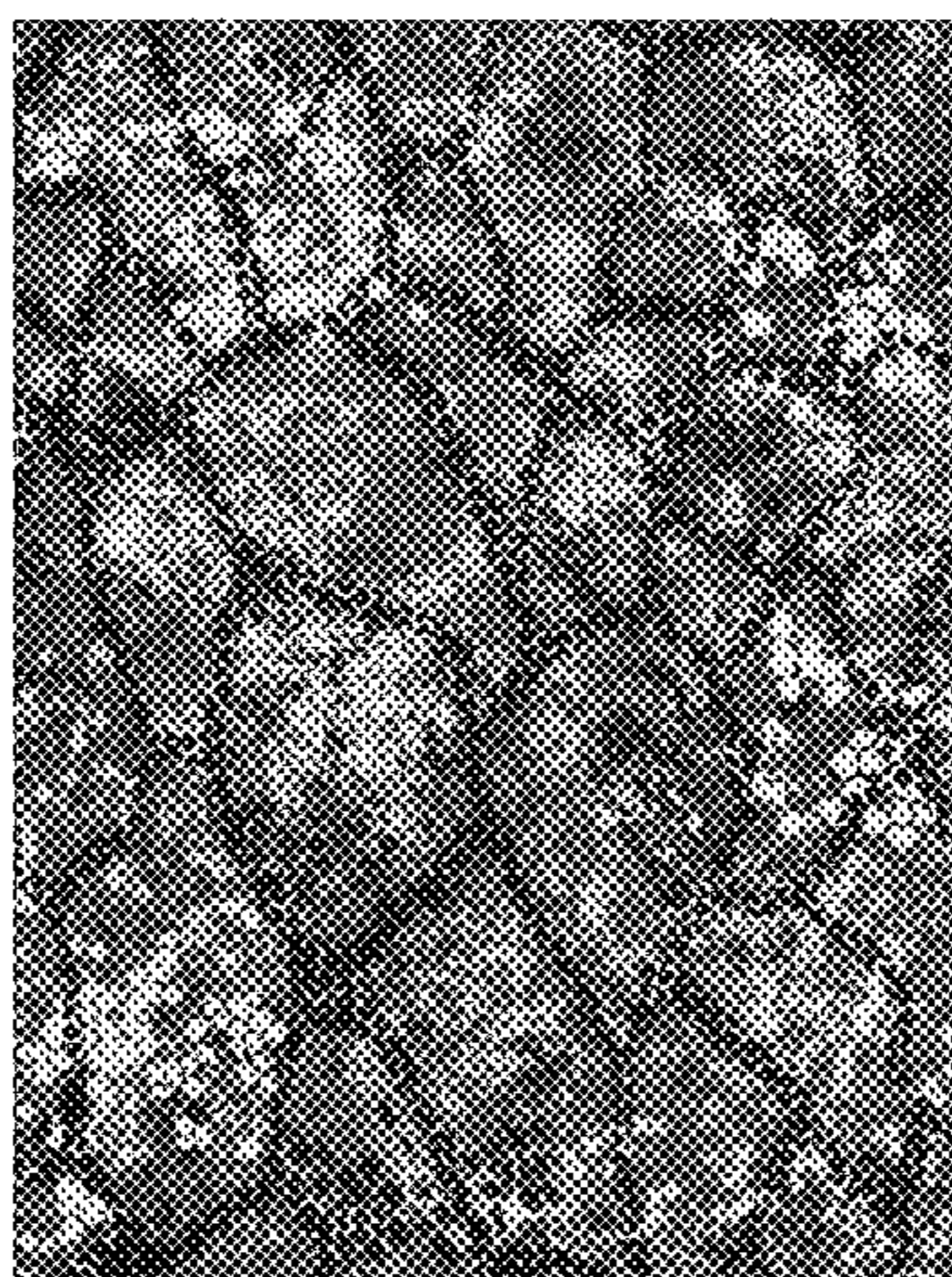
**DESCRIPTION**
