The ornamental design for a seat, as shown and described.

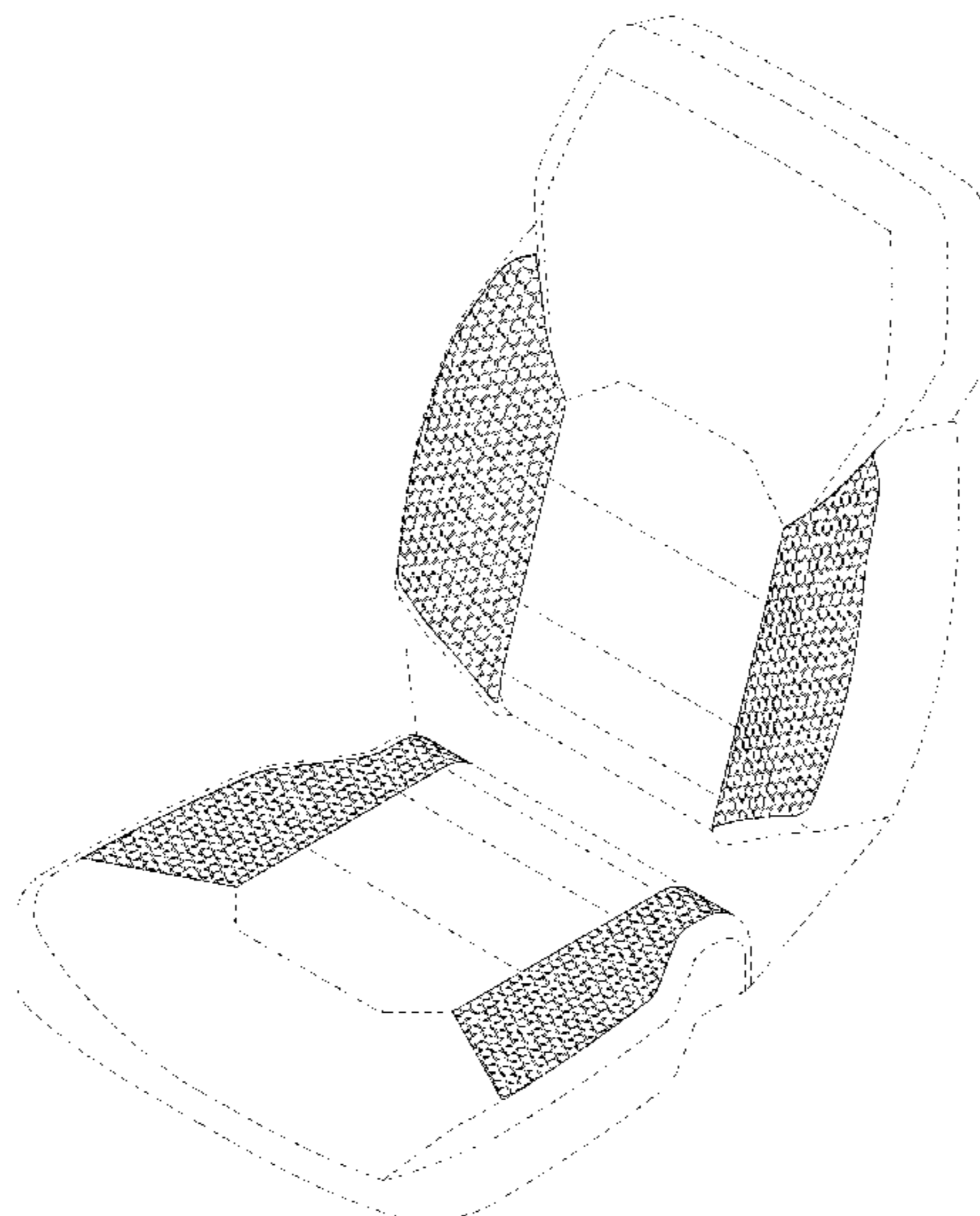
DESCRIPTION

FIG. 1 is a perspective view of a seat showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front view thereof;

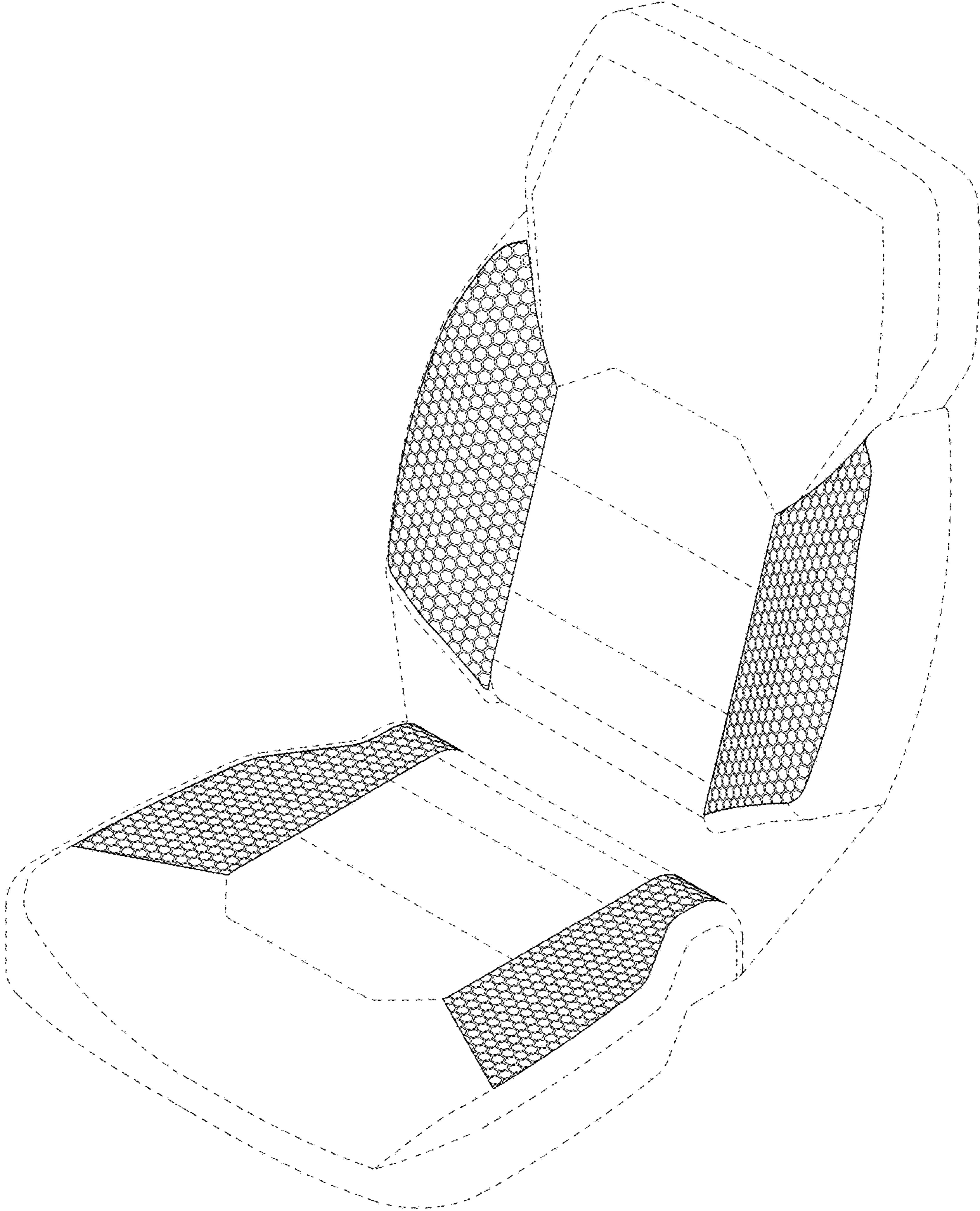

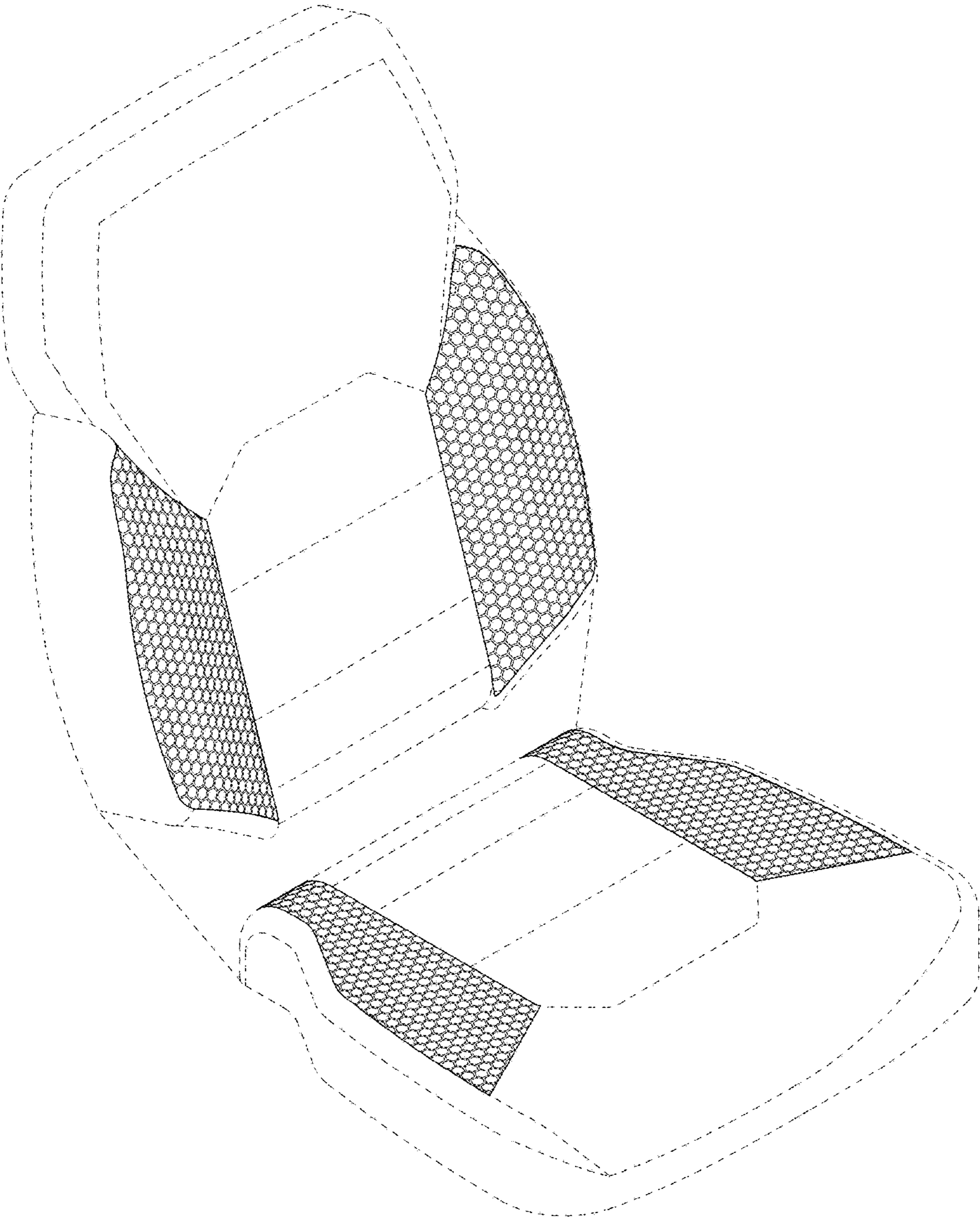

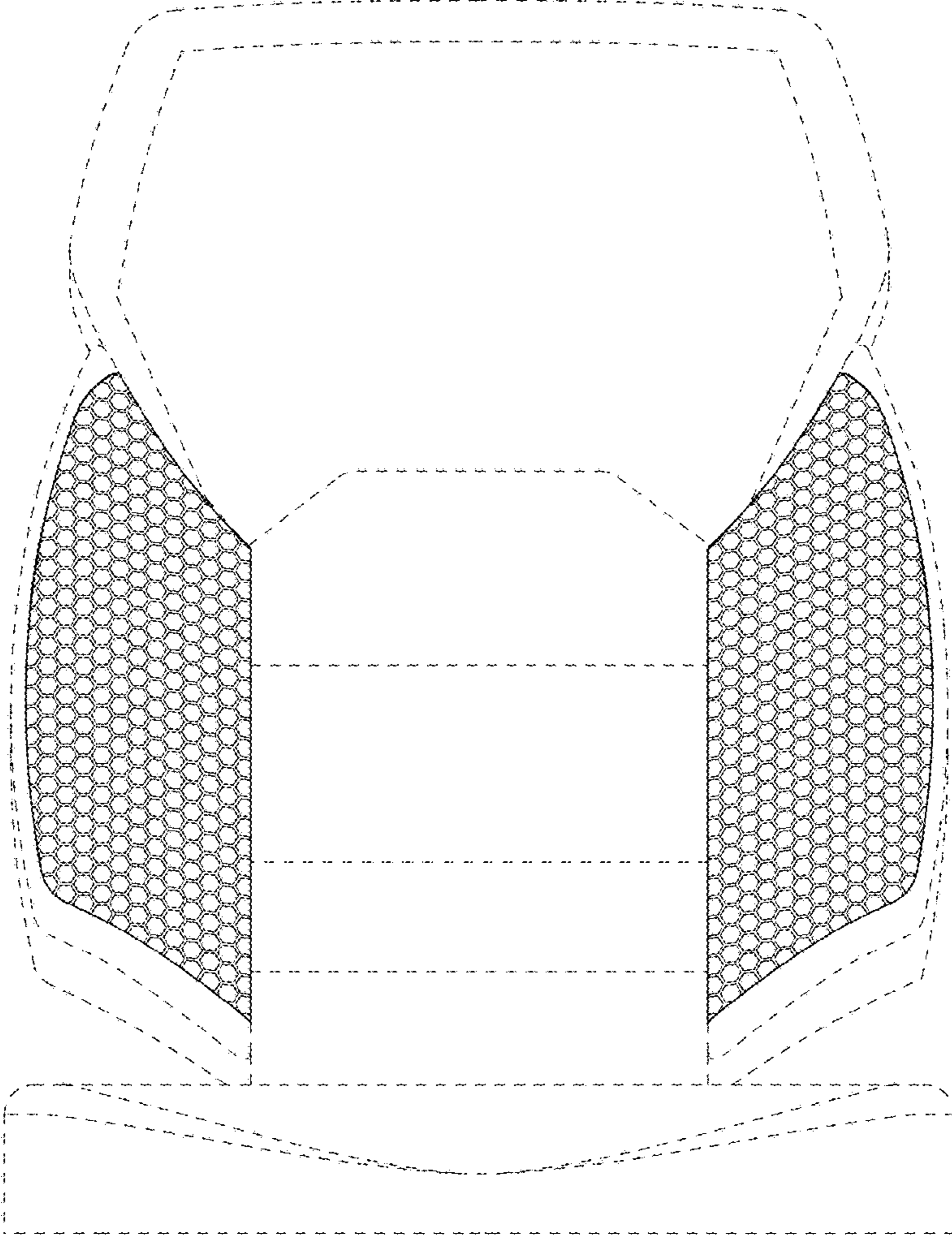

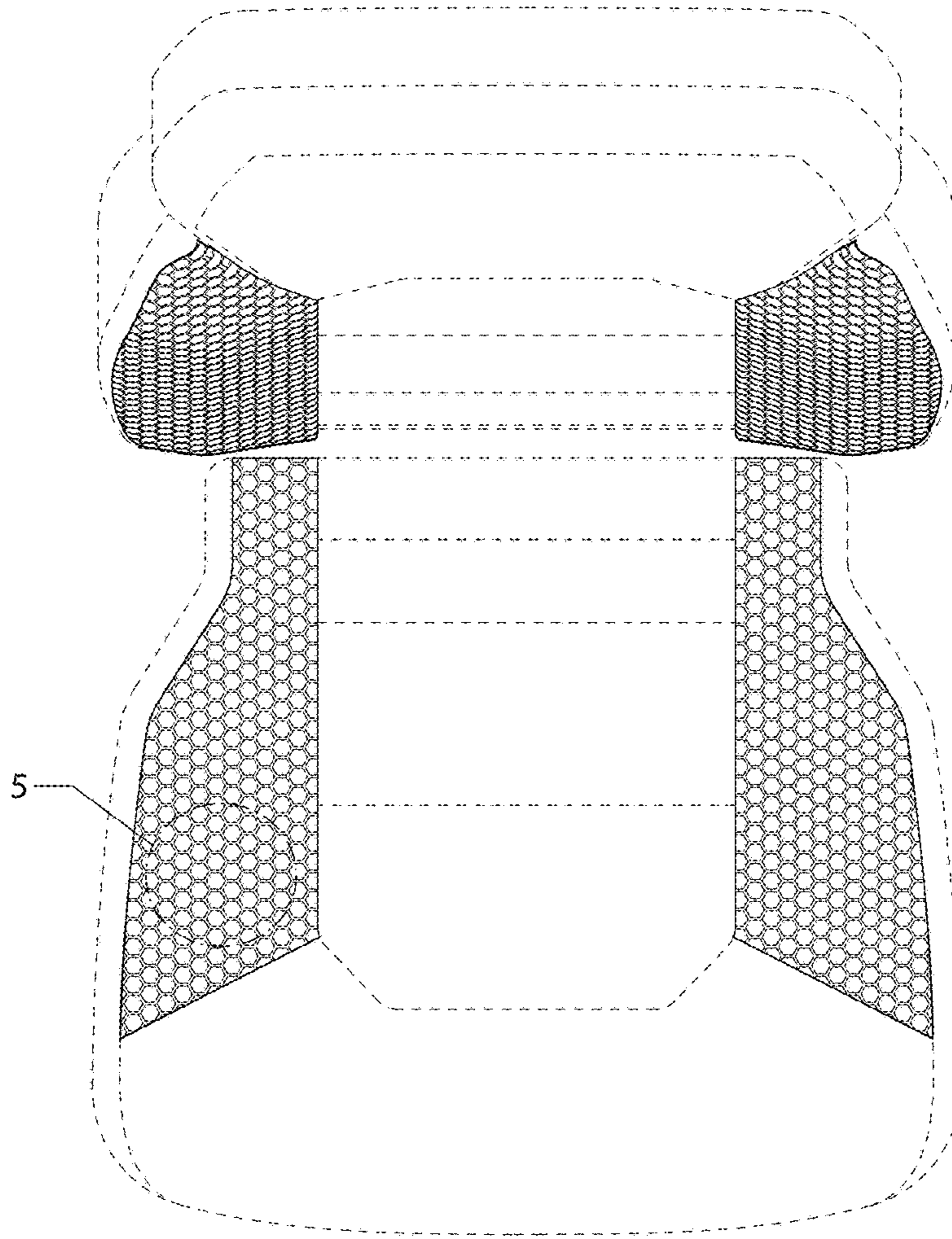

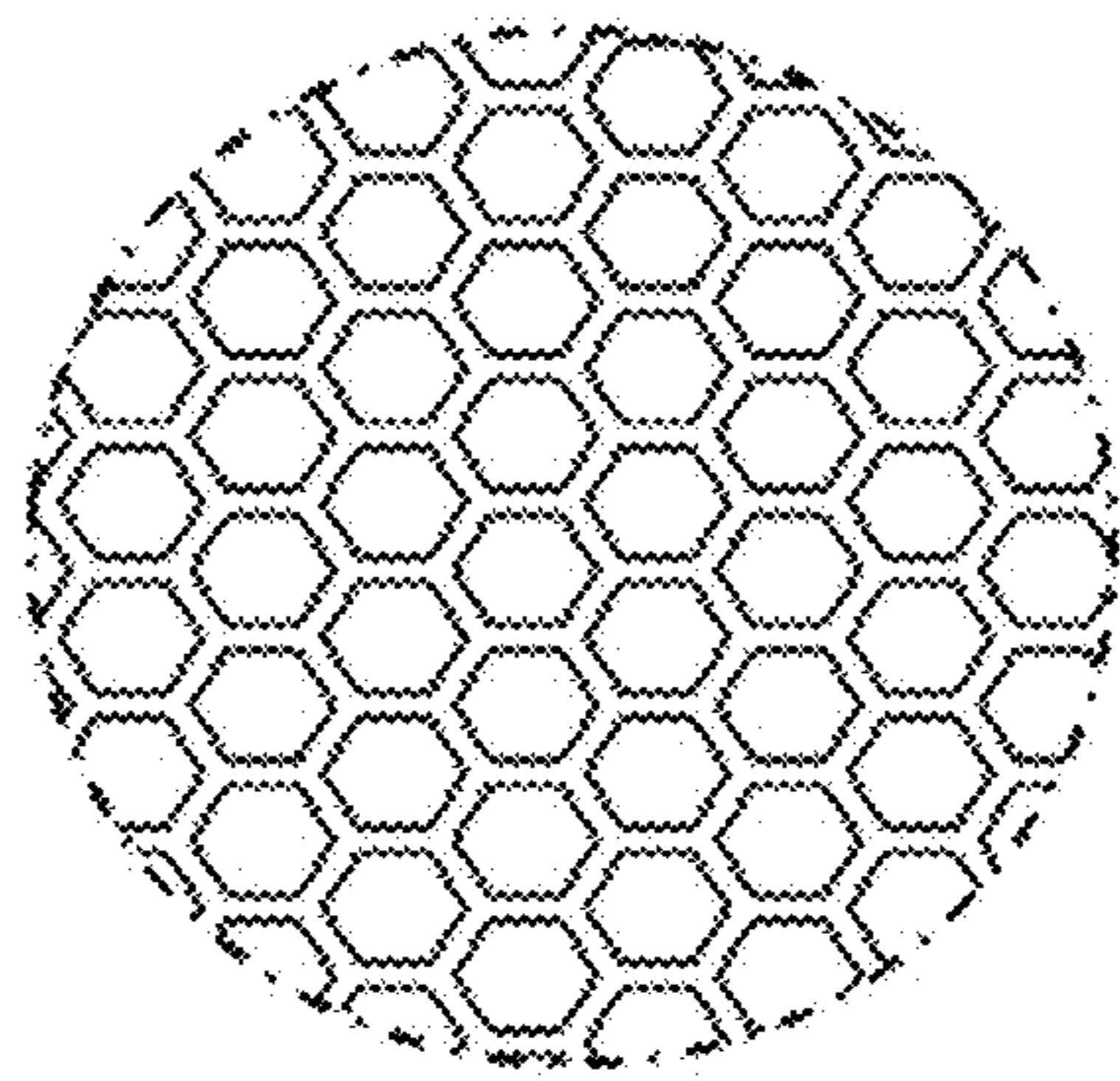

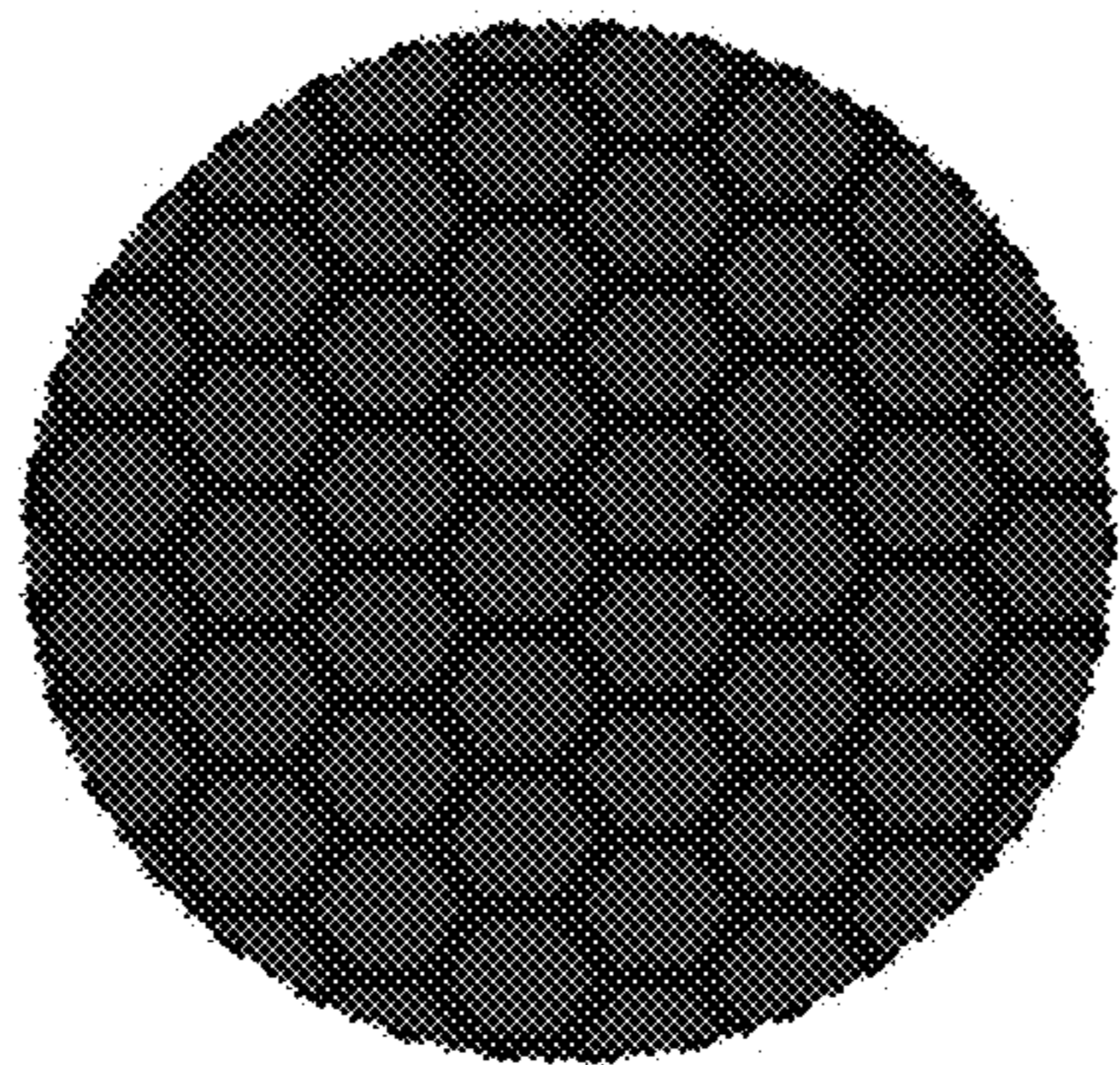
