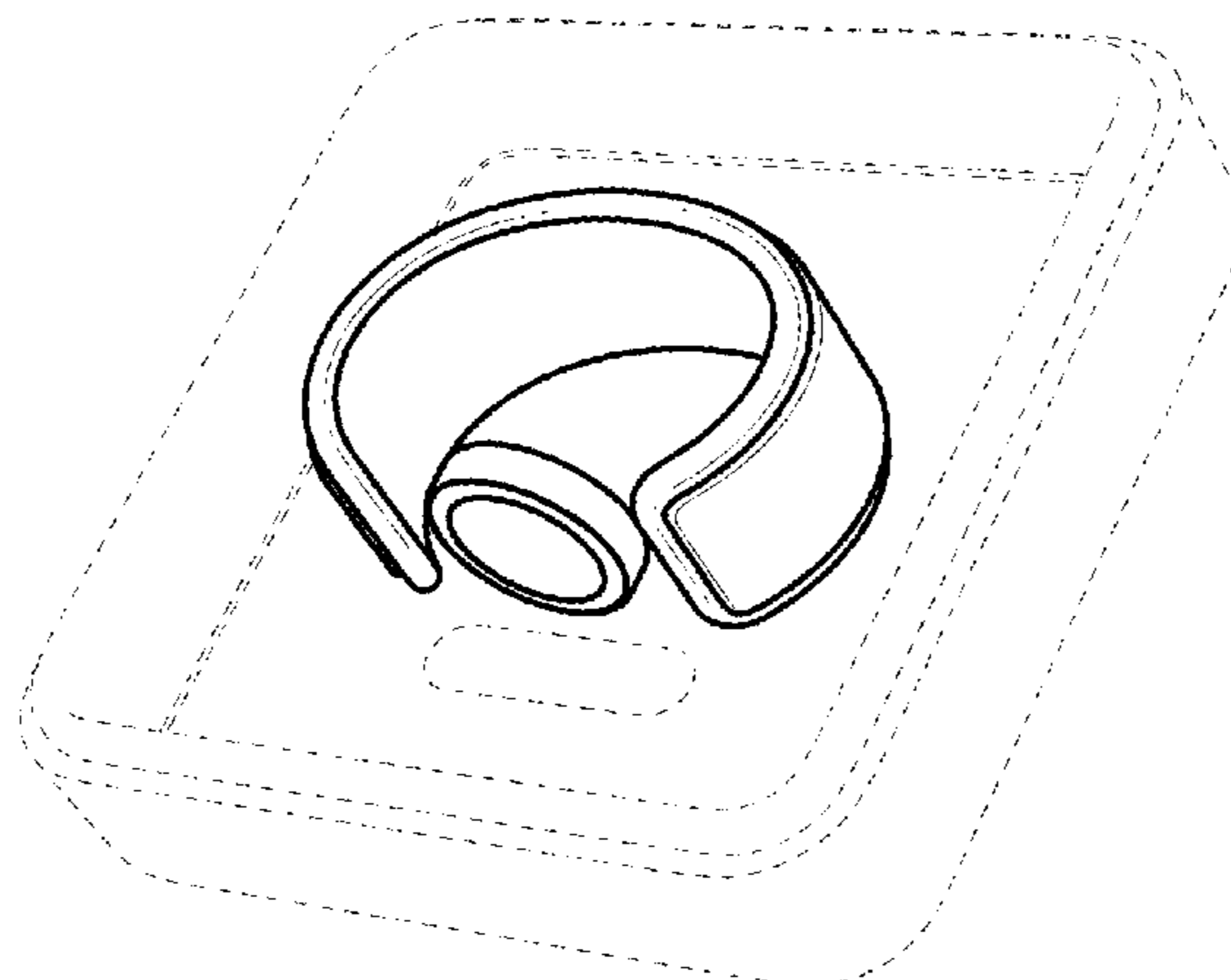


FIG. 8 is a top view thereof showing the packaging in an environment in which it may be used.

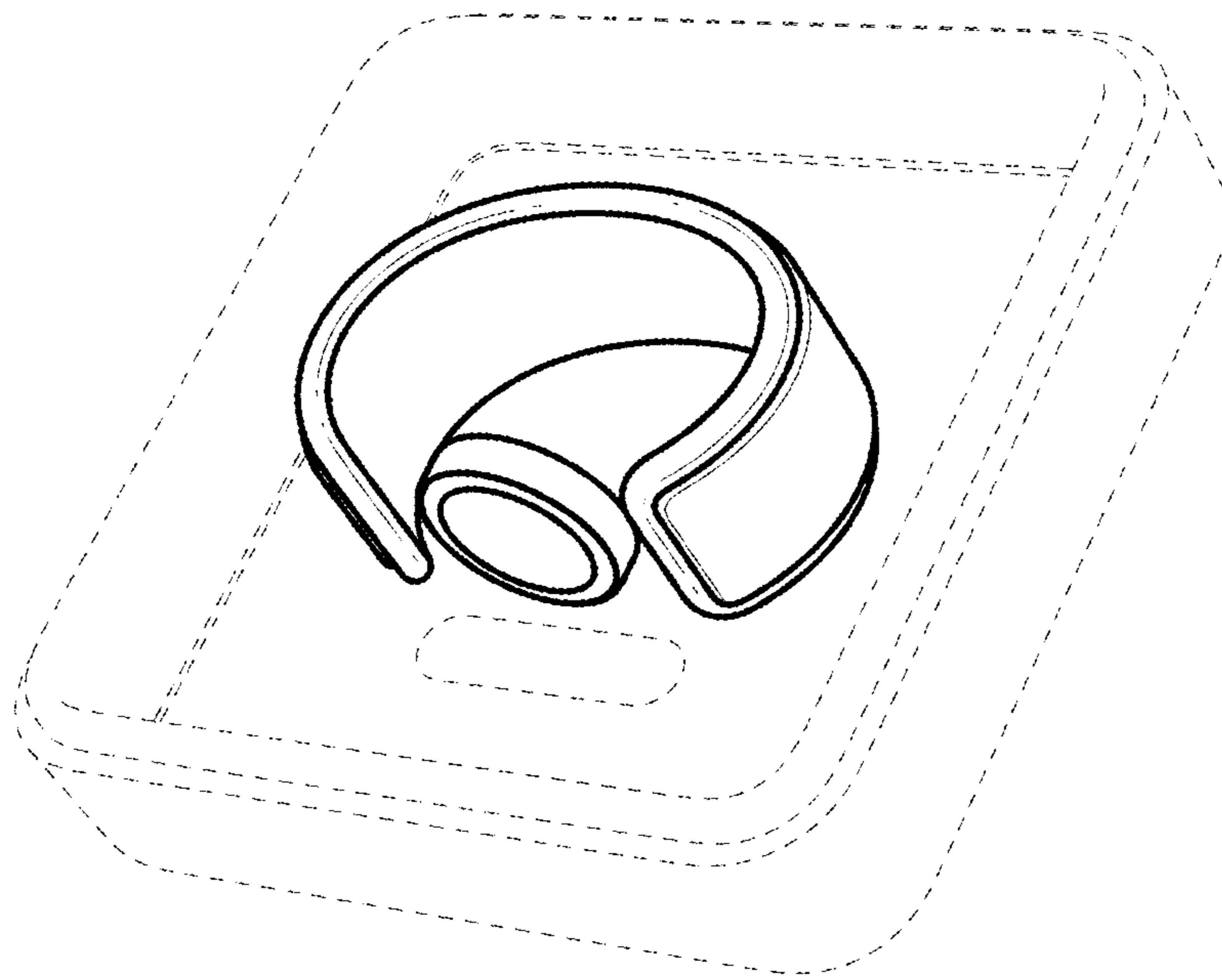

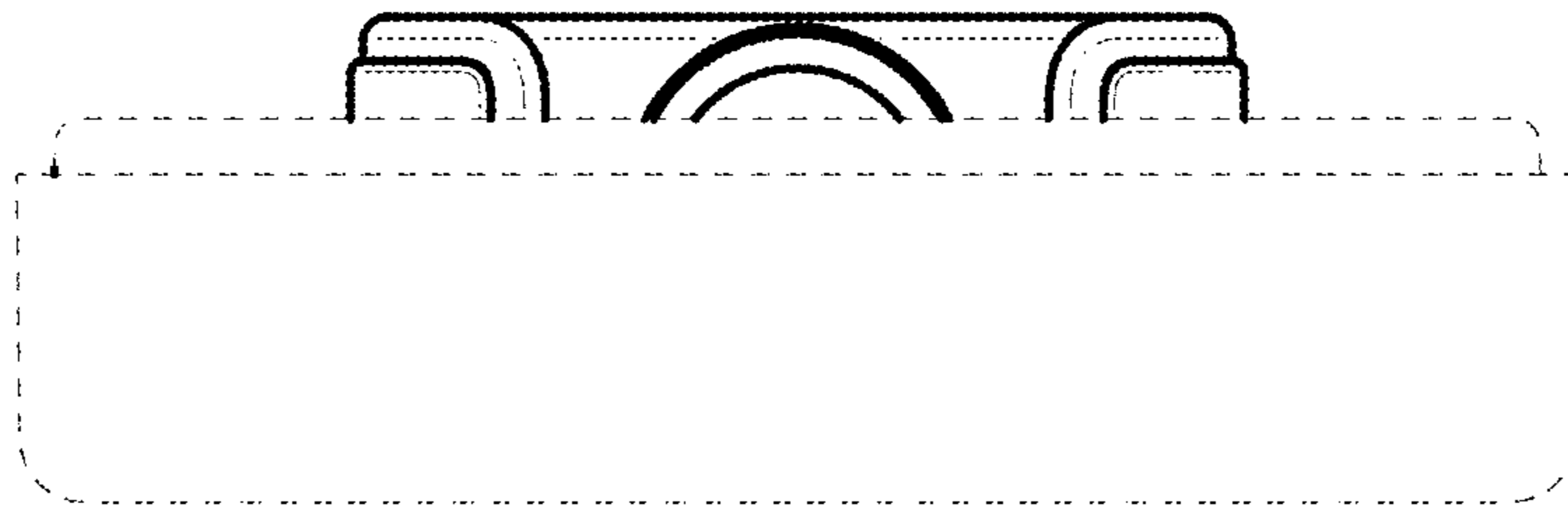

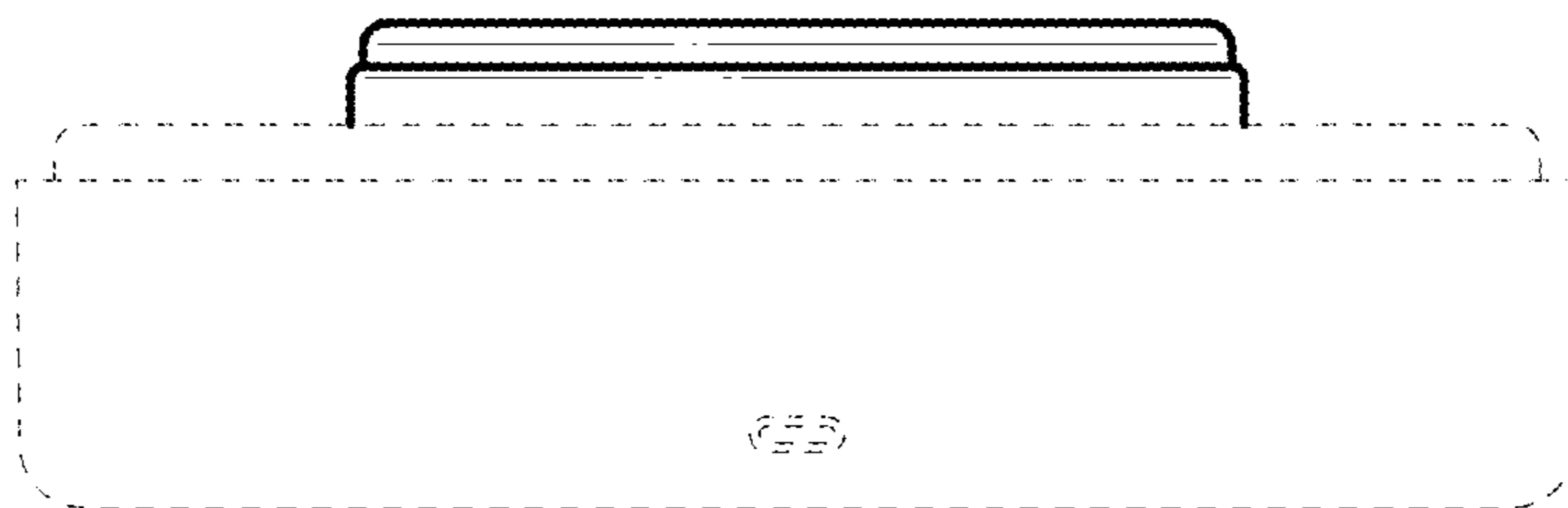

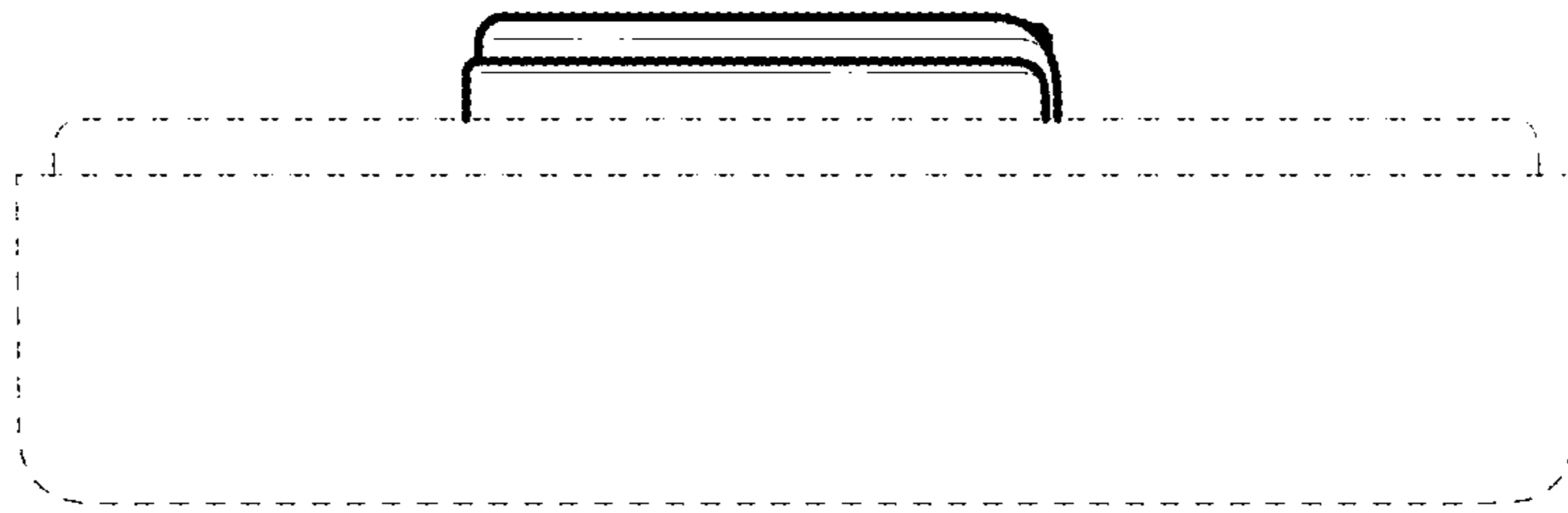

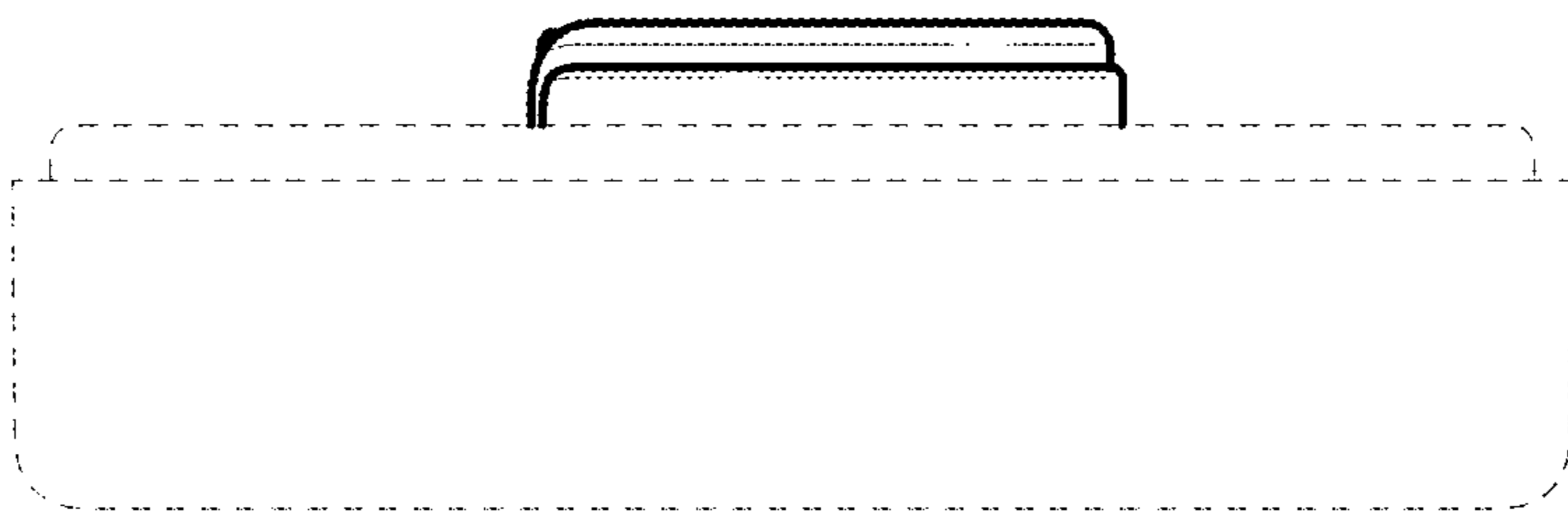

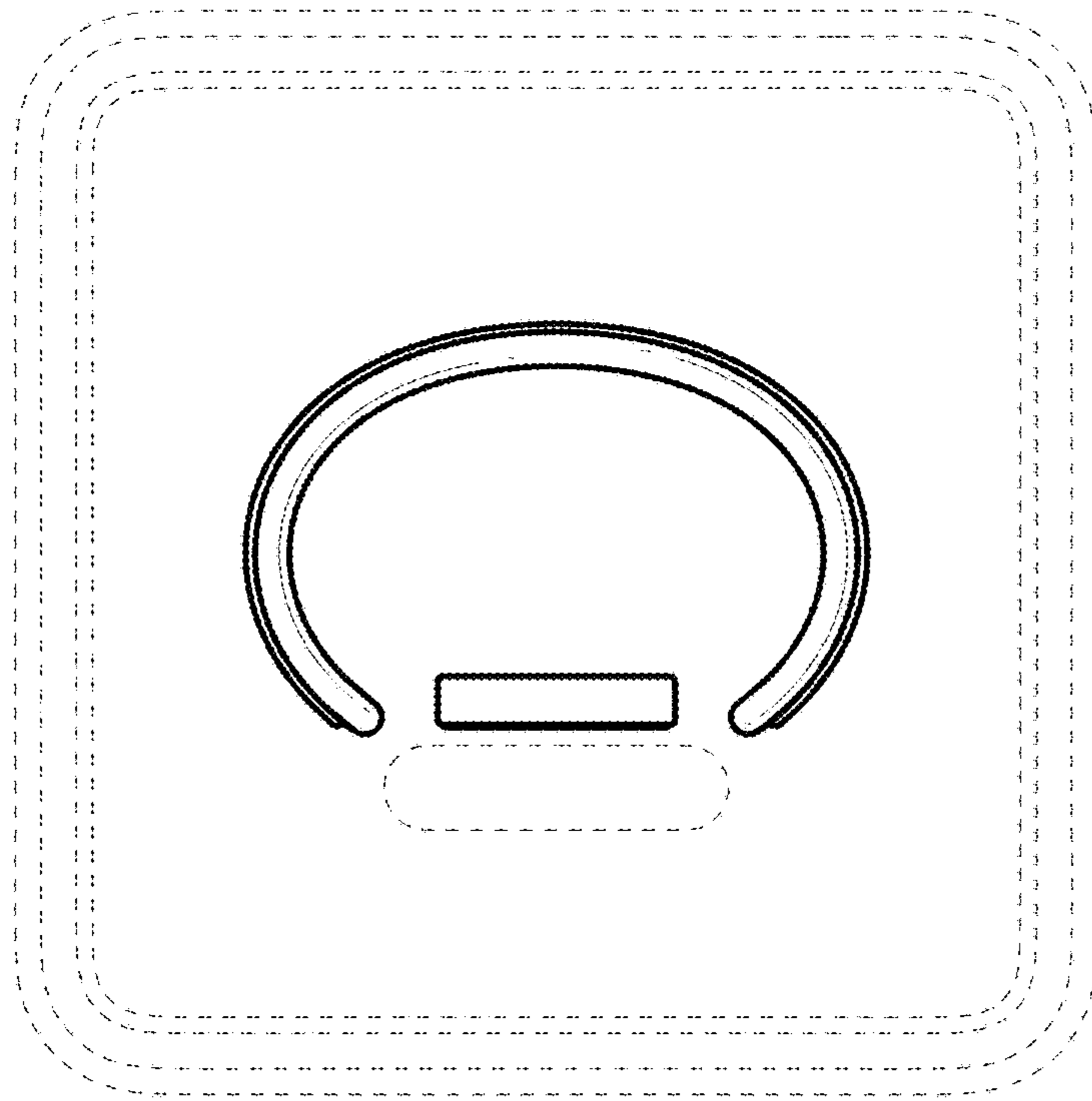

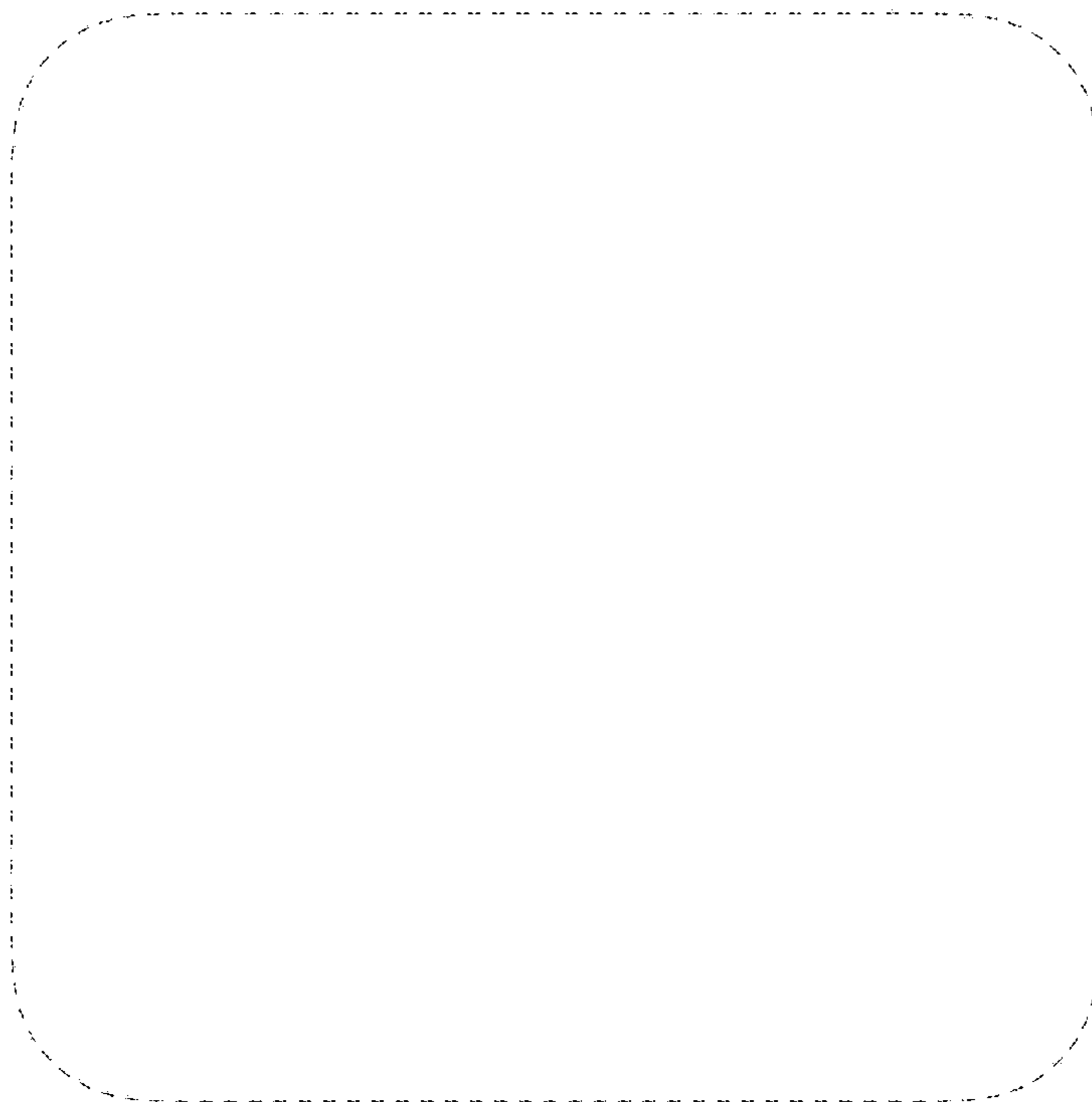

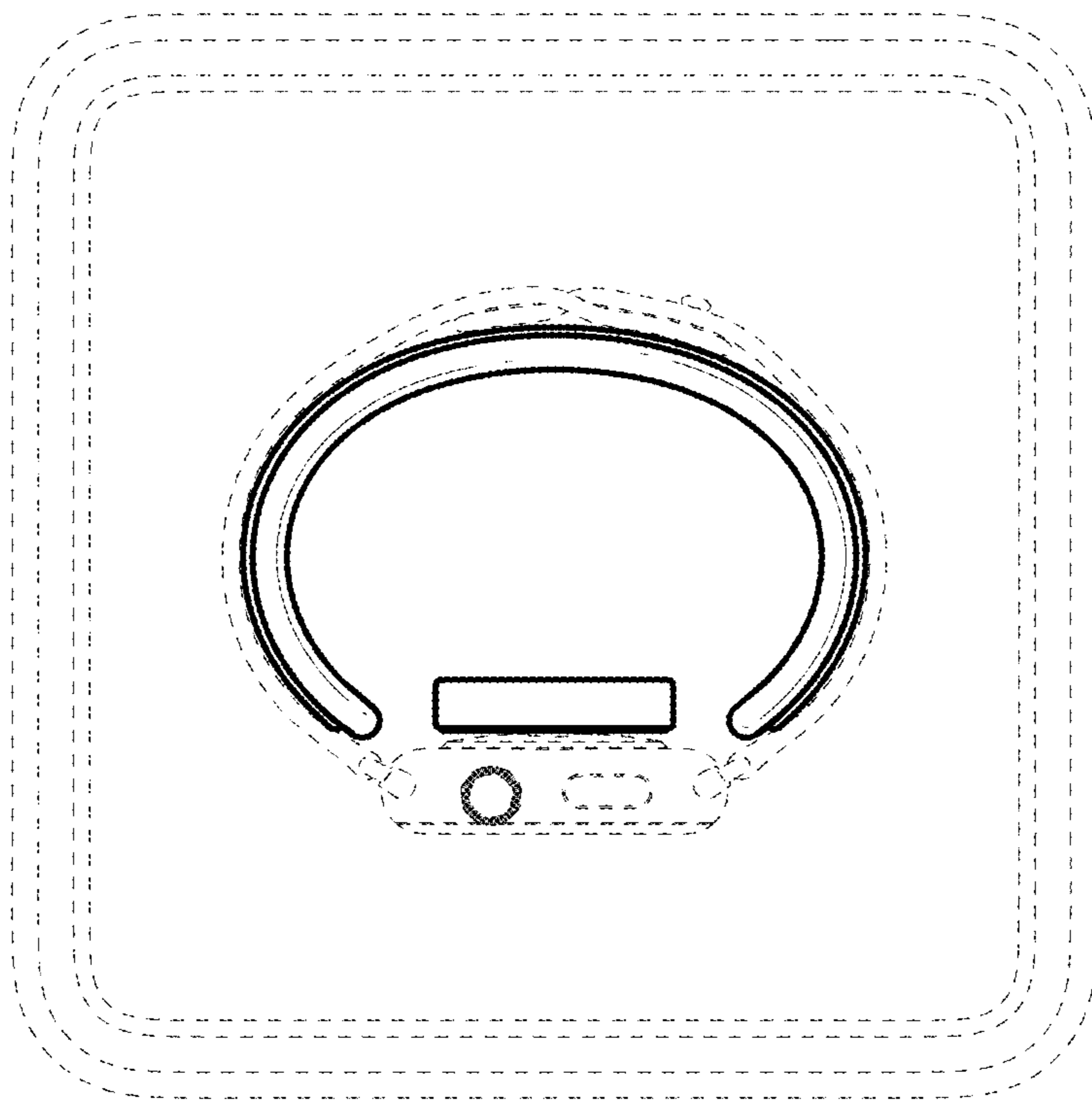
