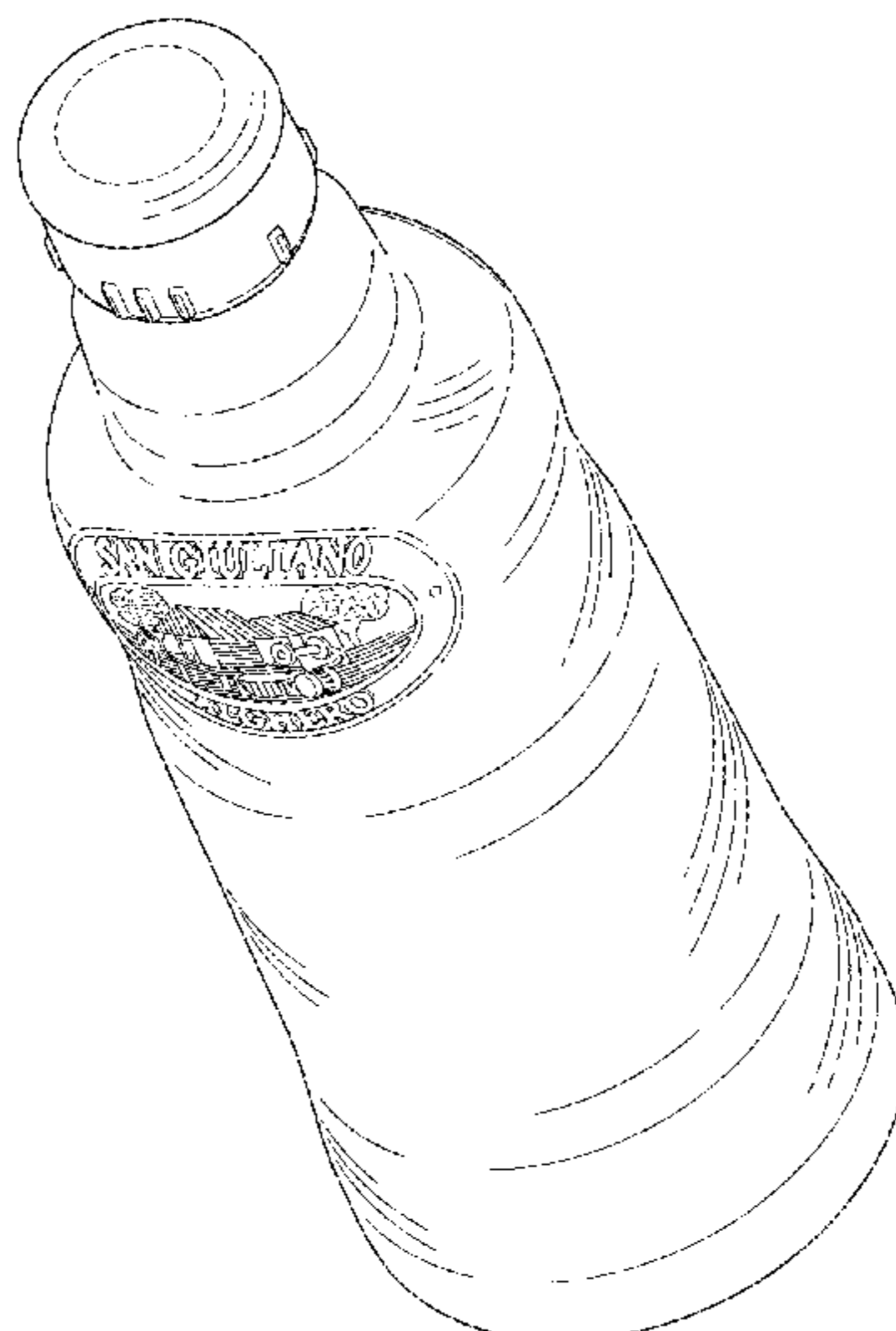
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottle;
FIG. 2 is a left side view of the bottle;
FIG. 3 is a front view of the bottle;

FIG. 5 is a rear view of the bottle; and,
FIG. 6 is a top view of the bottle.

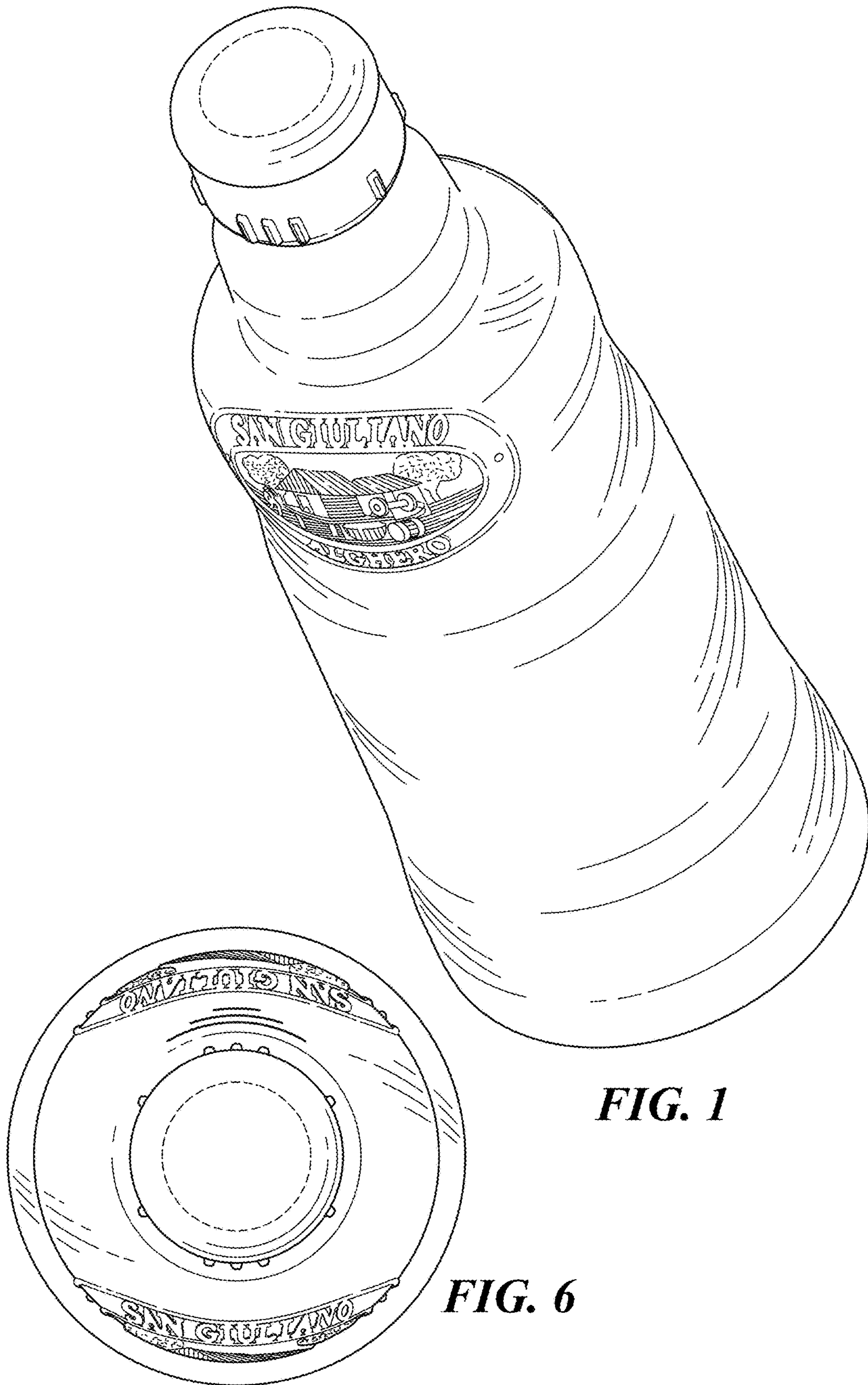

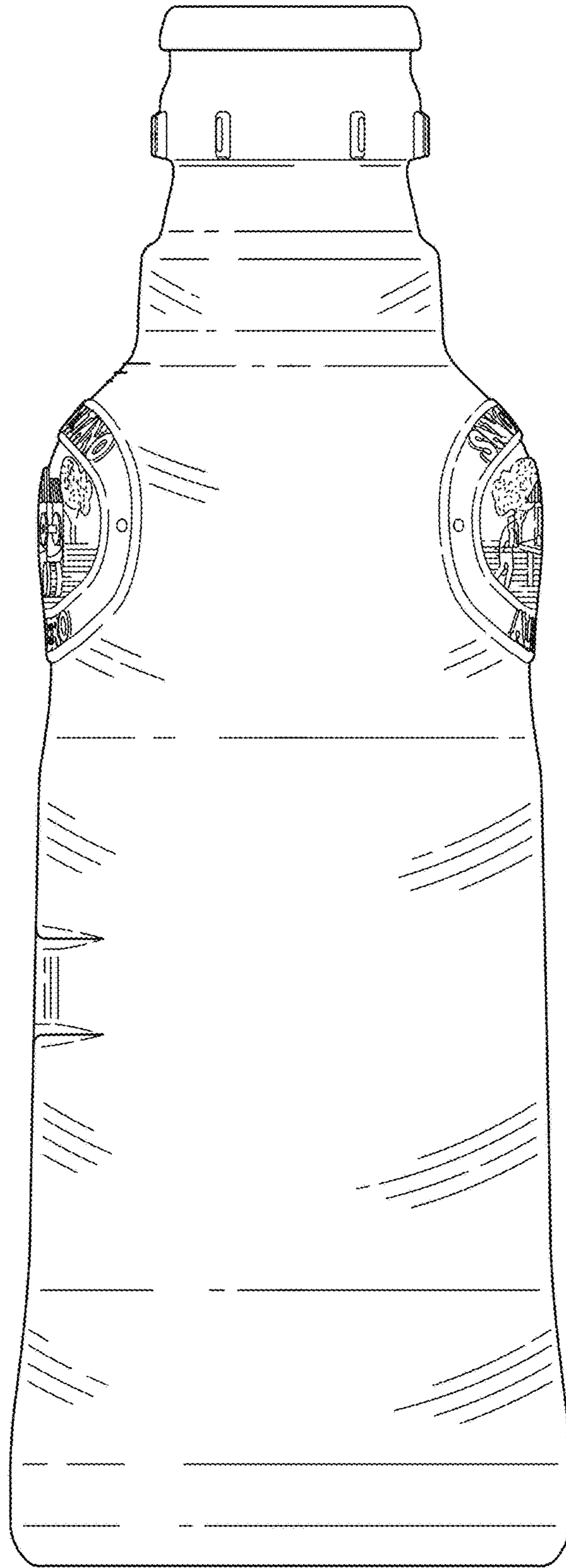

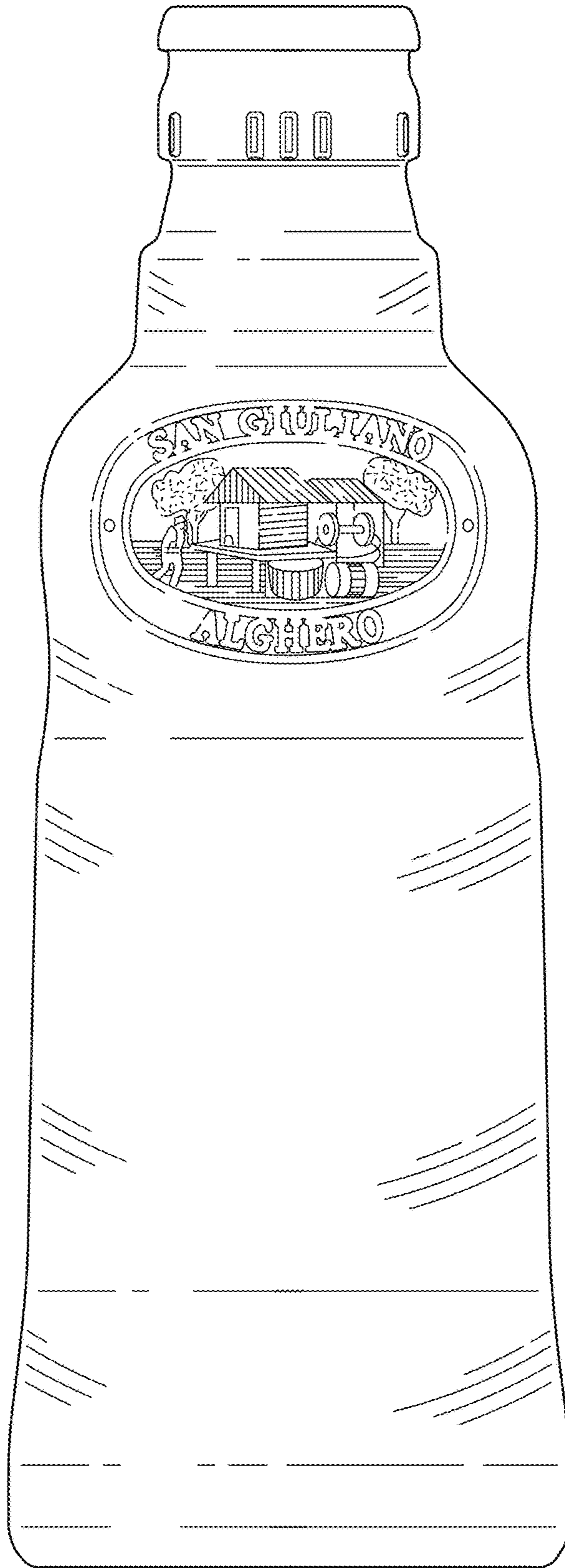

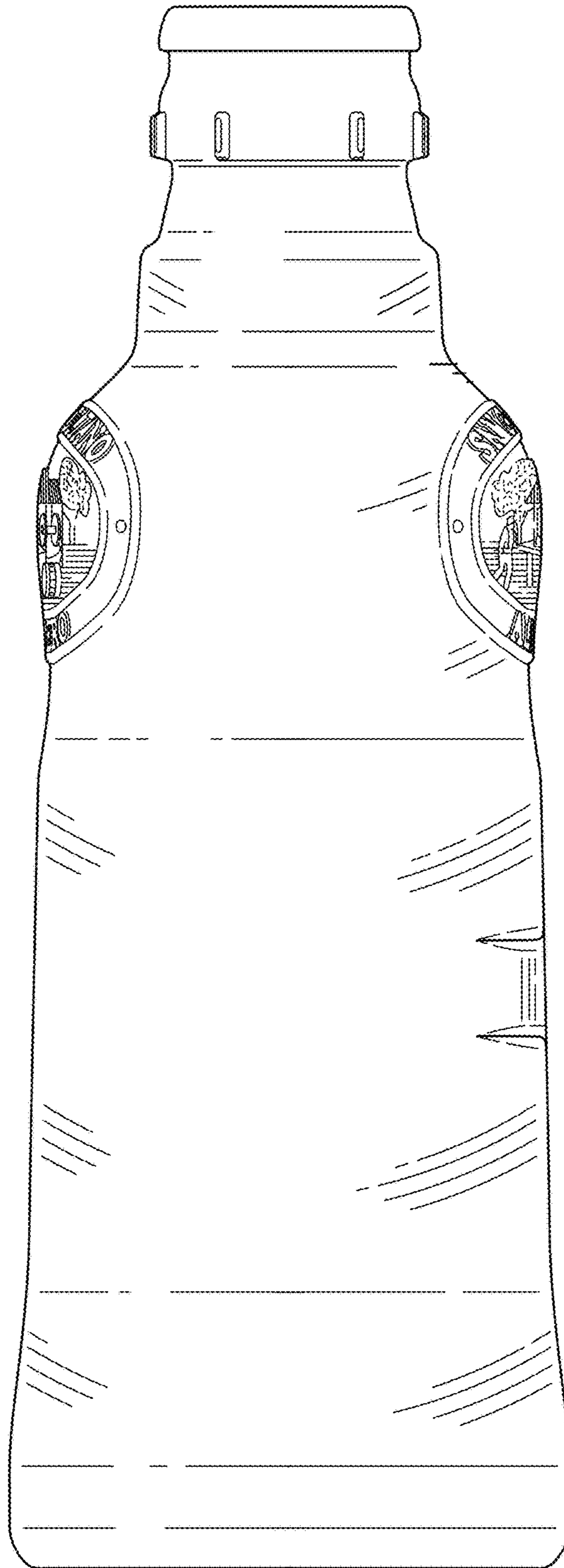

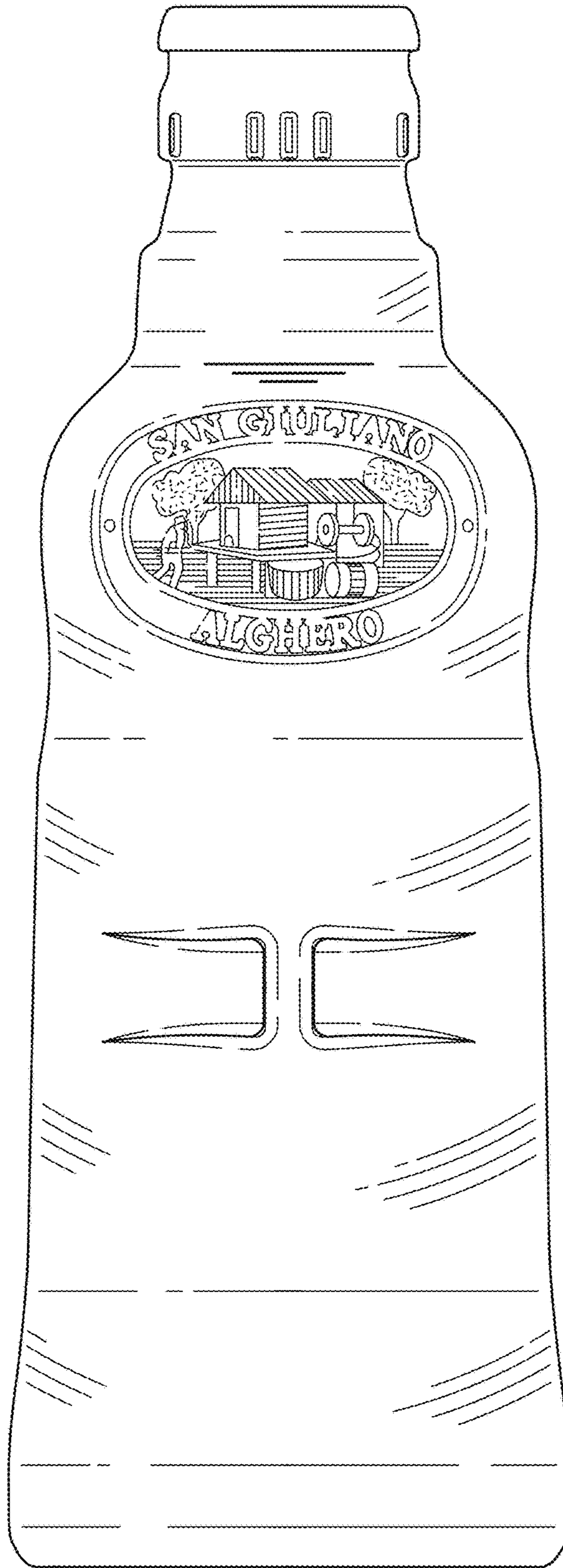
