(57) **CLAIM**

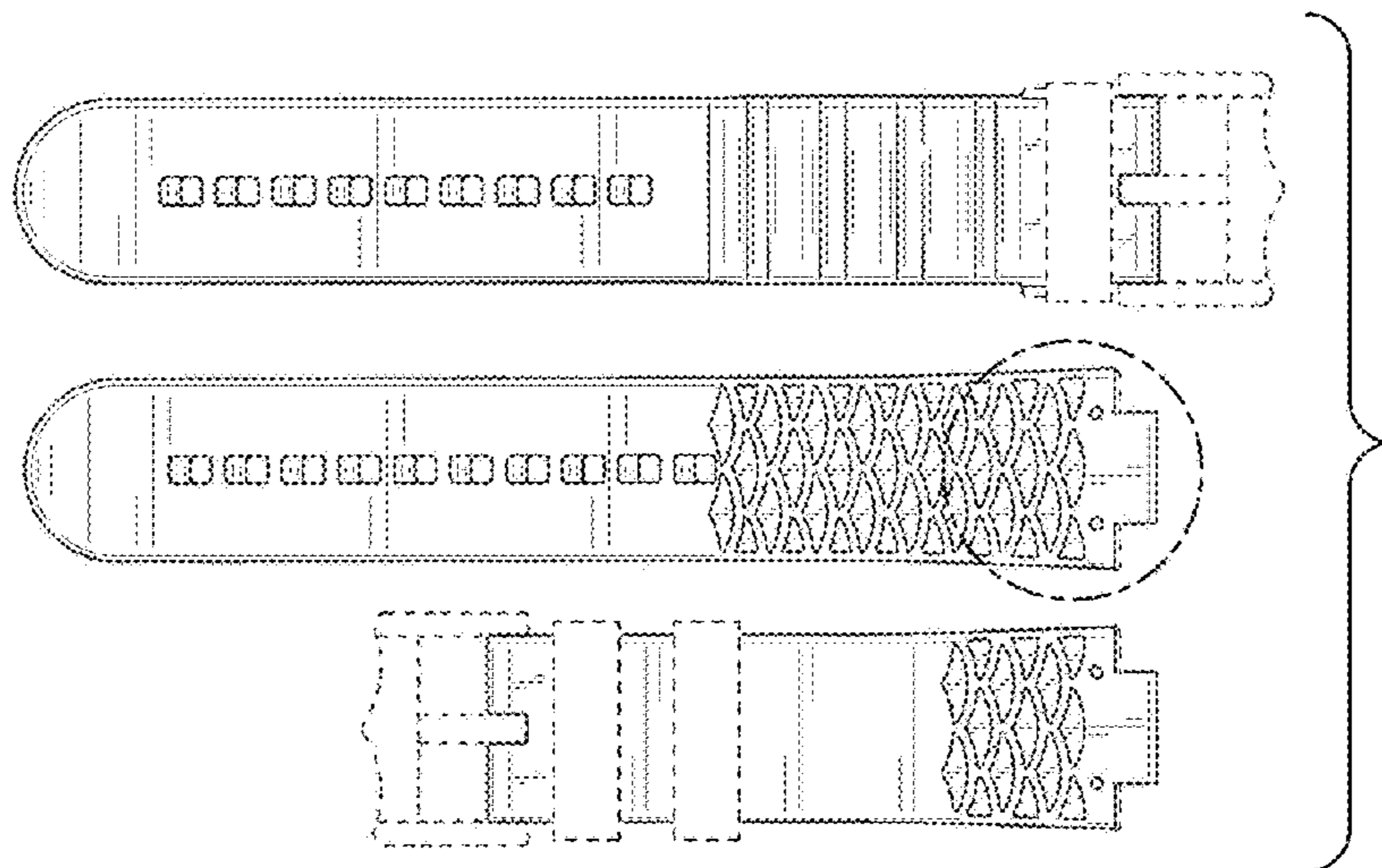
The ornamental design for a watch band, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view a watch band shown in an unassembled condition;
FIG. 2 is a side view thereof;
FIG. 3 is a bottom perspective view thereof; and,
FIG. 4 is an enlarged partial view thereof taken from FIG. 1.

The dot-dash style broken lines shown in FIGS. 1 and 4 represent the unclaimed boundary of the enlarged partial view shown in FIG. 4. The remaining broken lines represent portions of the watch band which form no part of the claimed design.

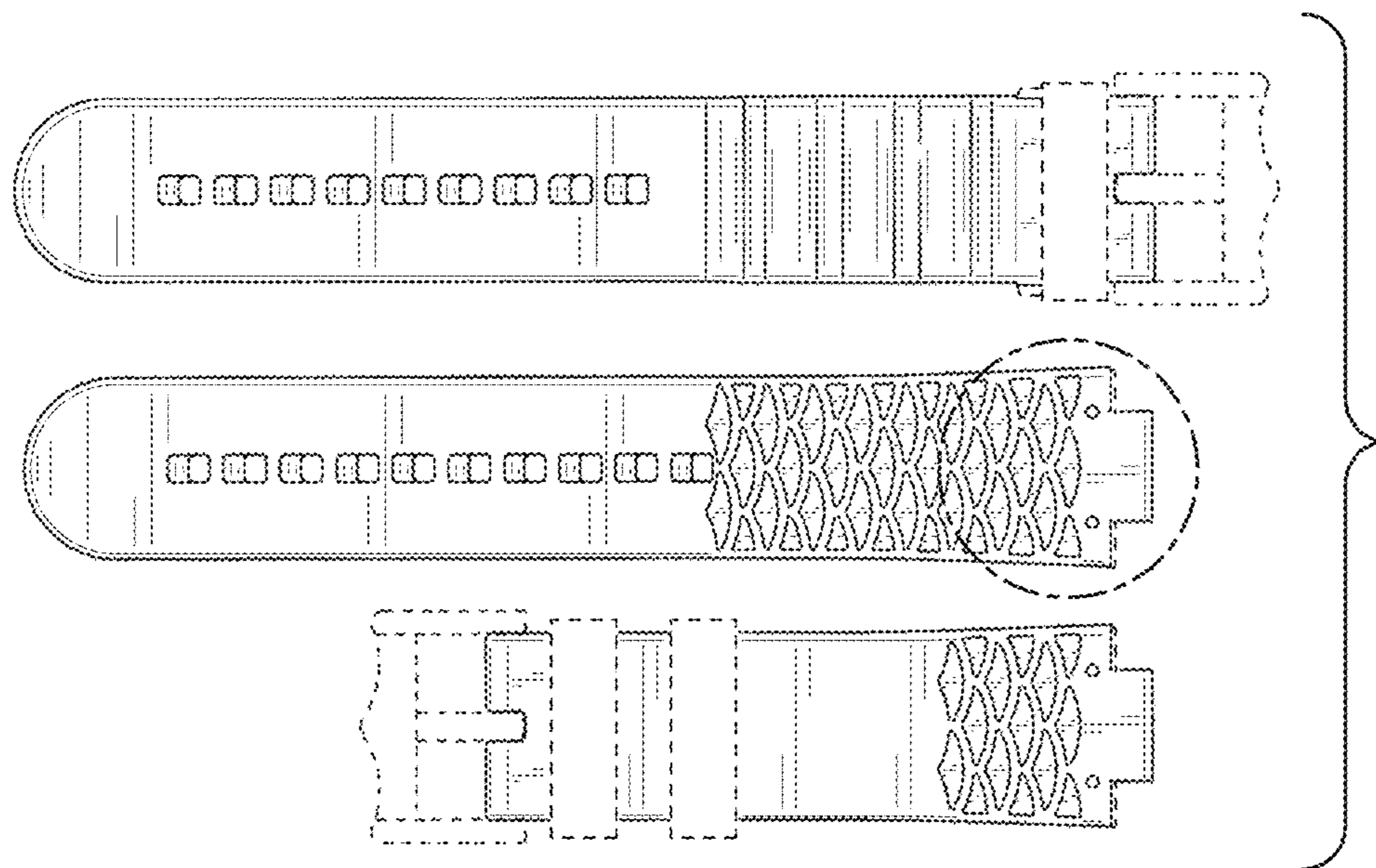

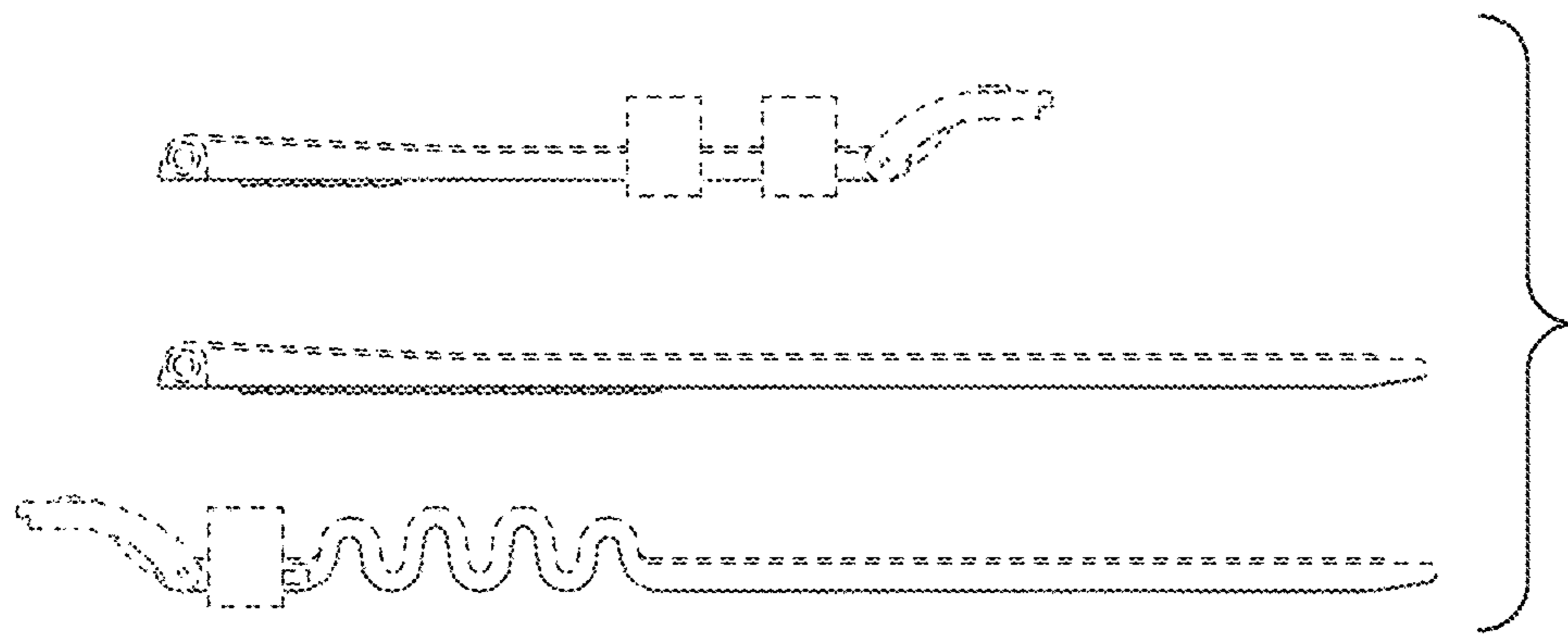

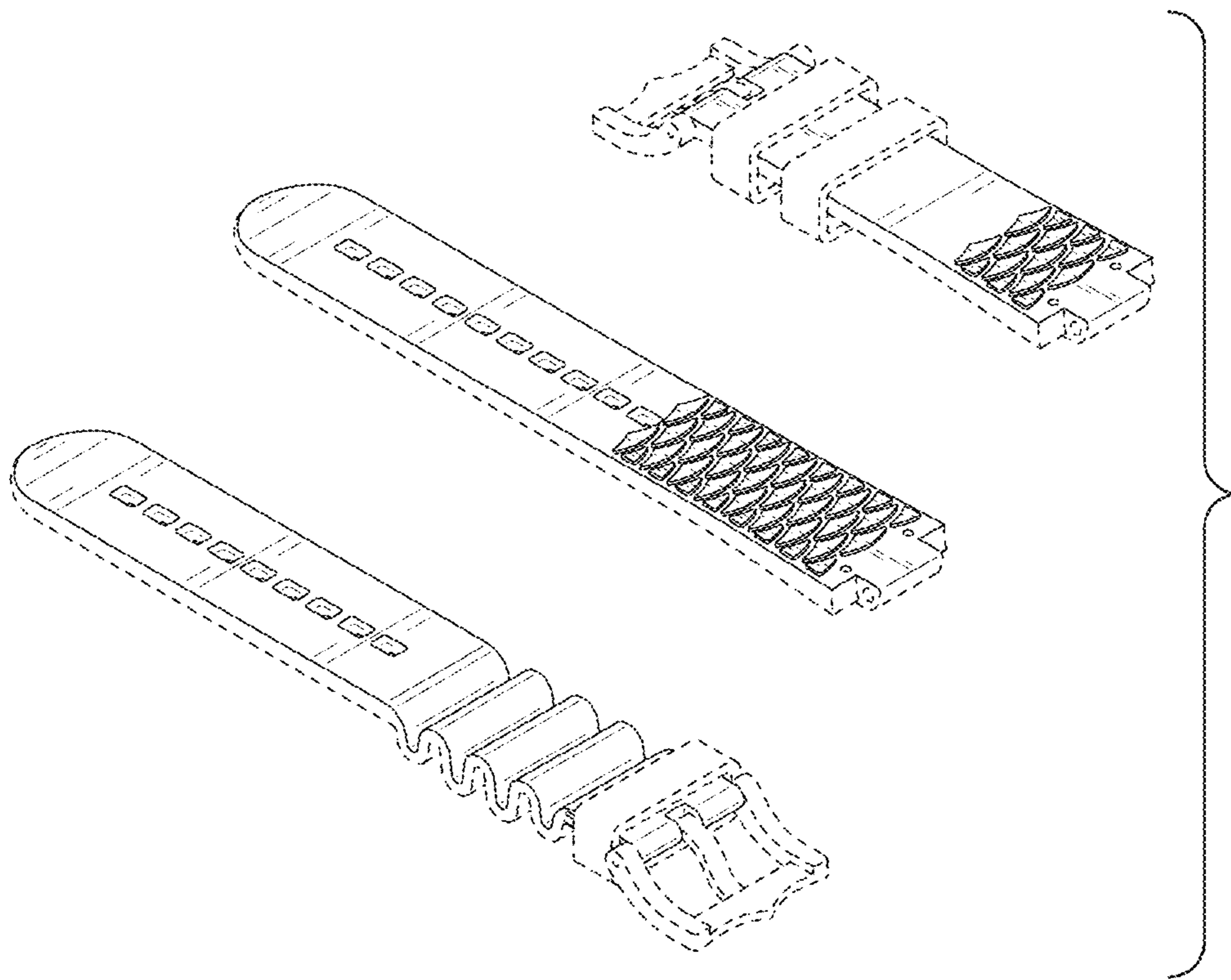

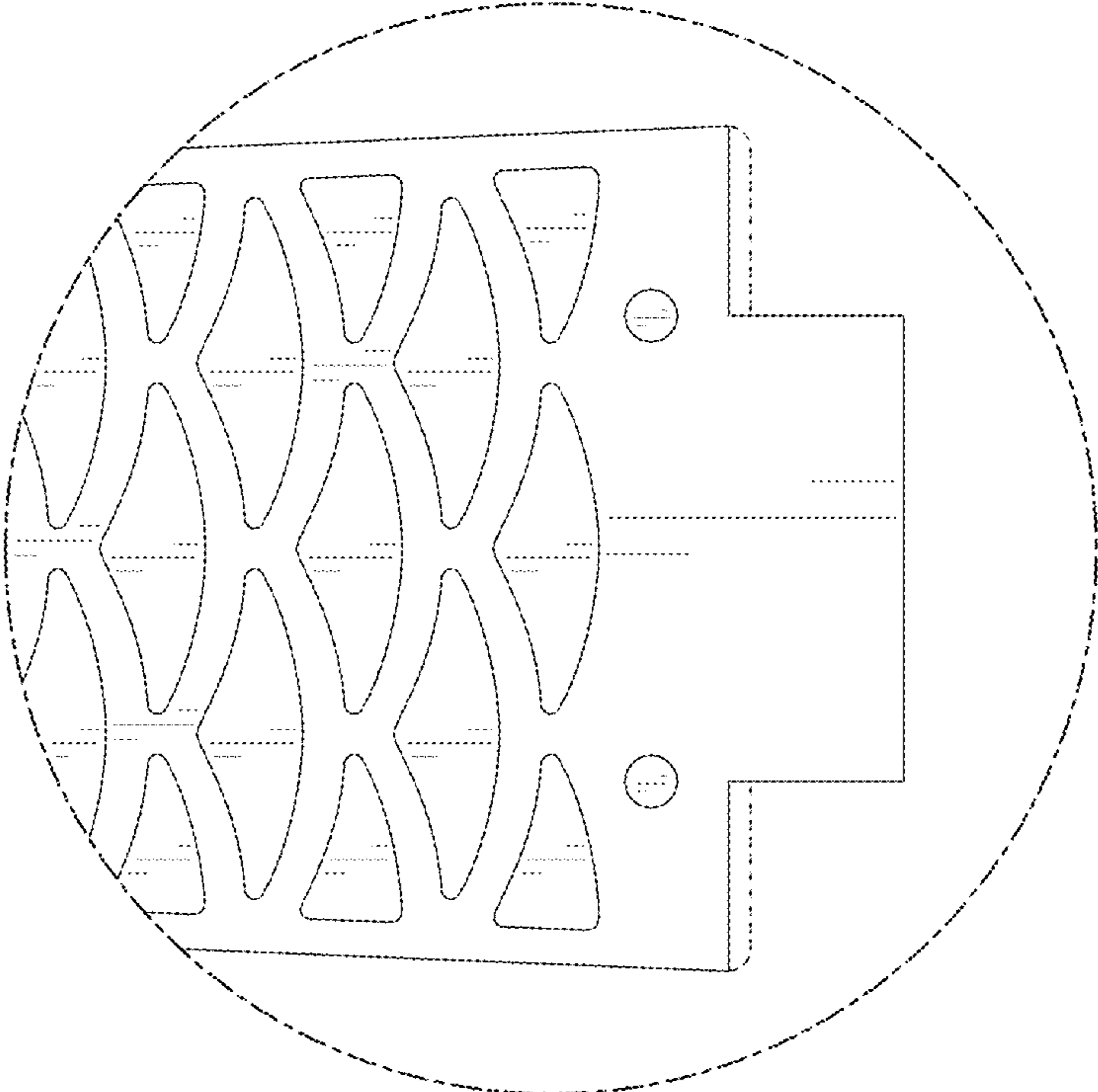
