FIG. 1 is a front perspective view of a design for a tulip ring according to the present disclosure;

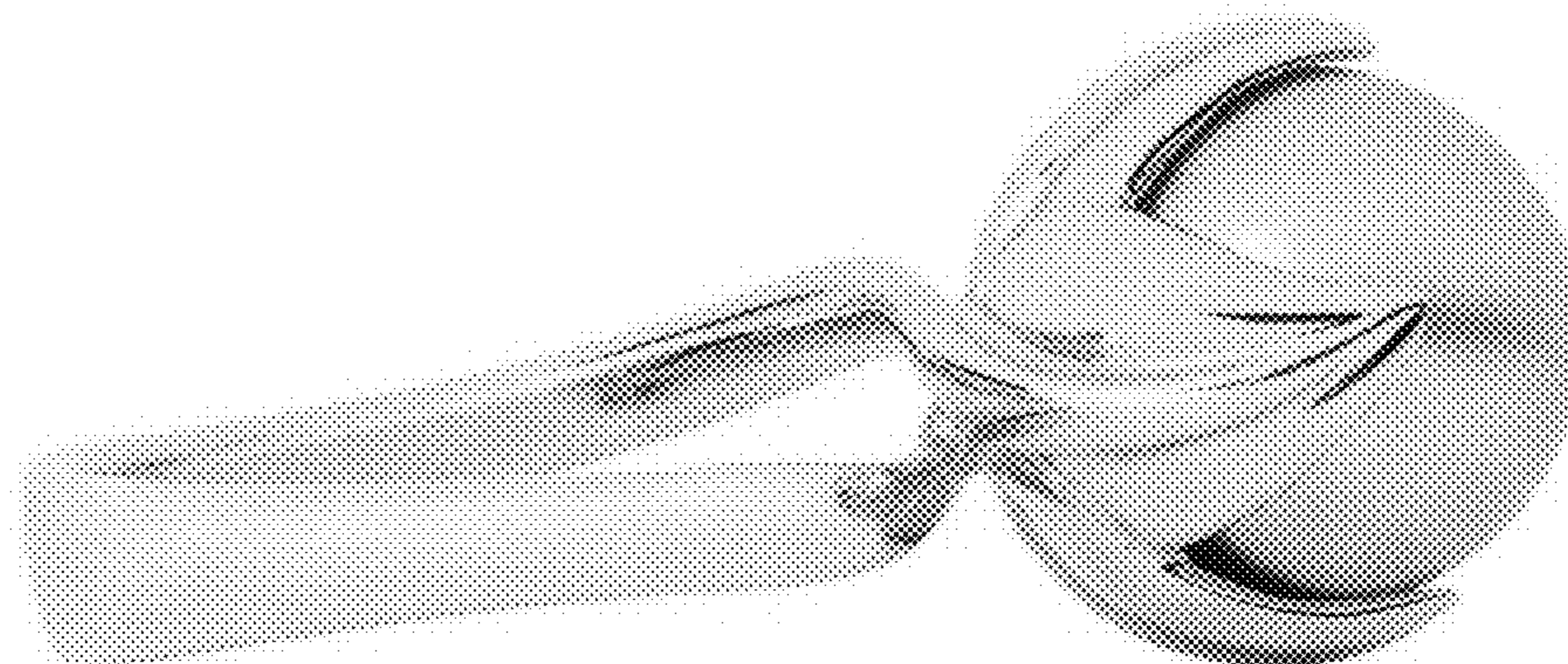
FIG. 2 is a left side perspective view thereof;

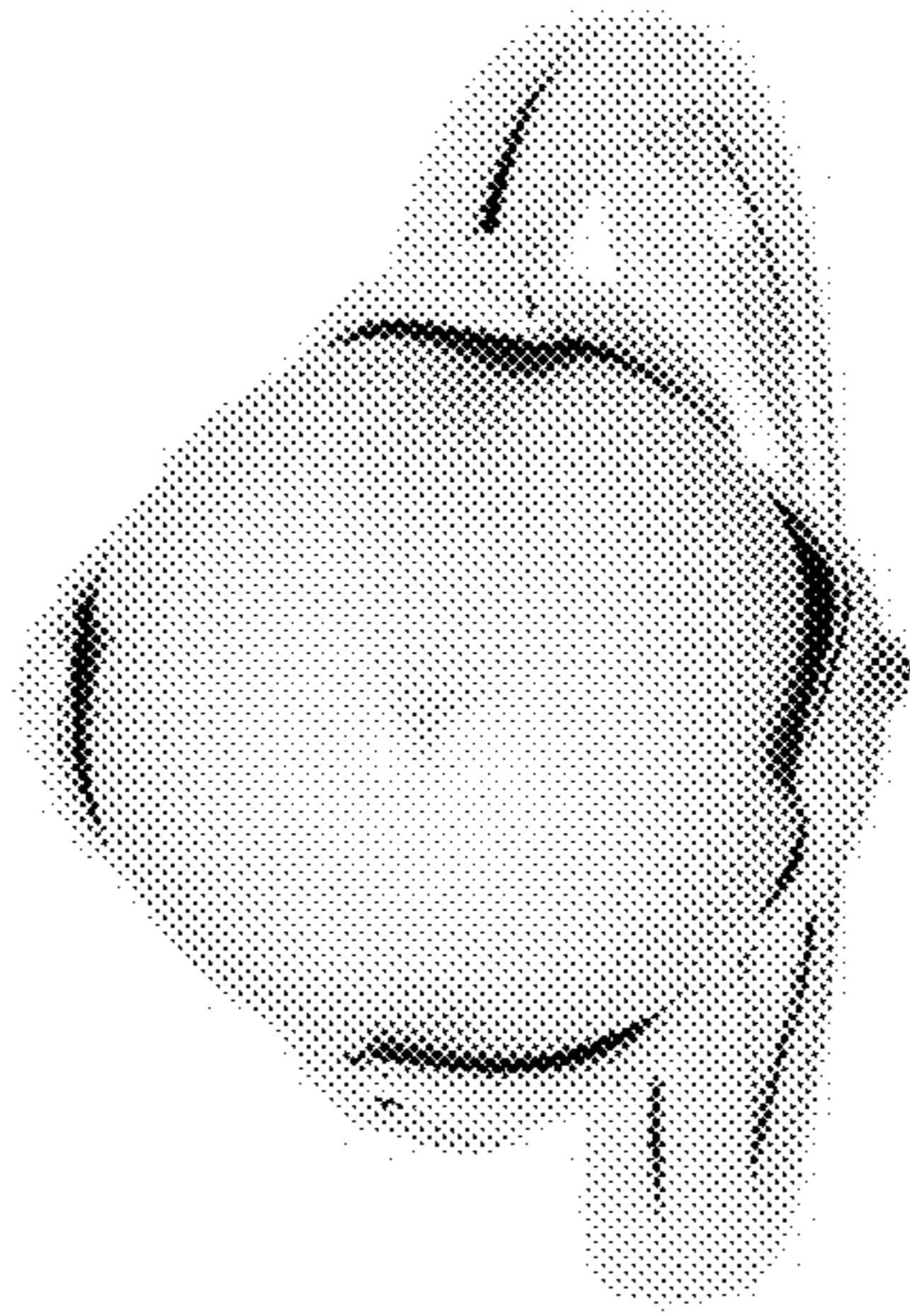

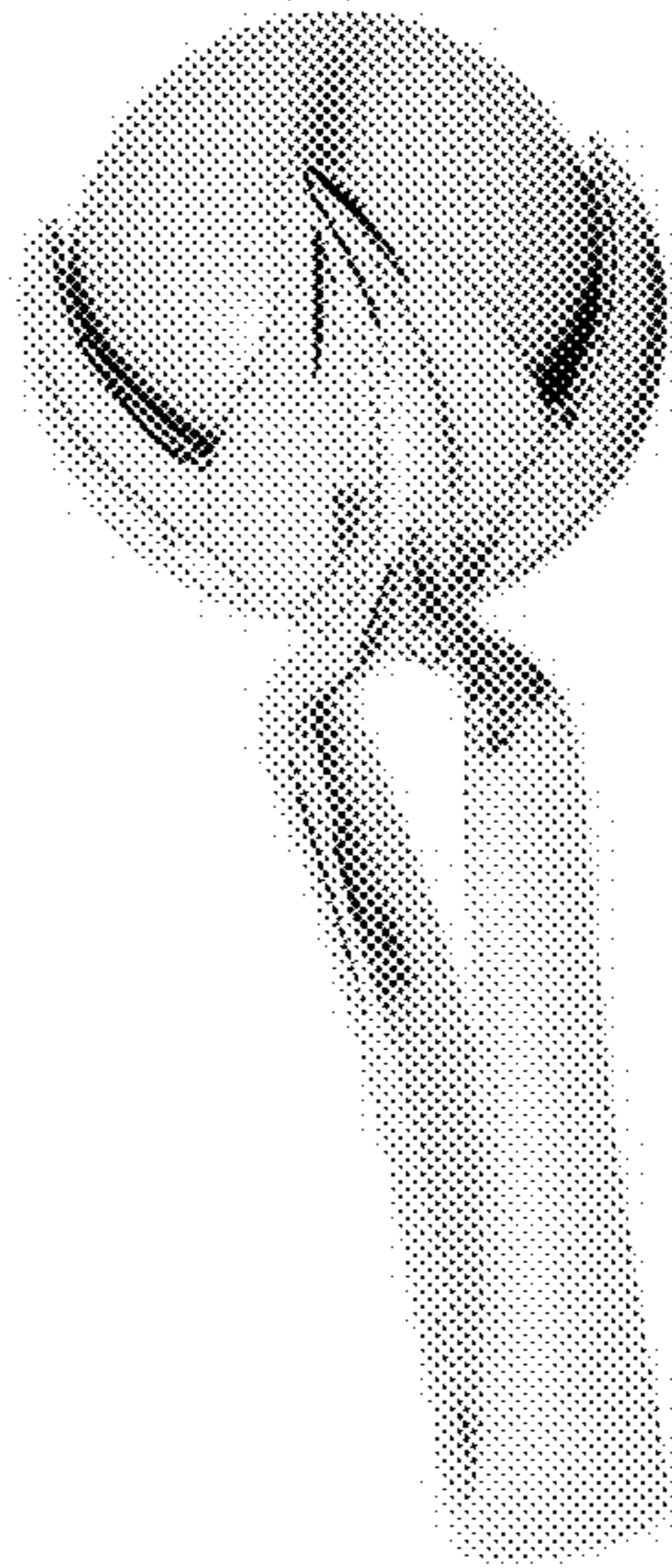

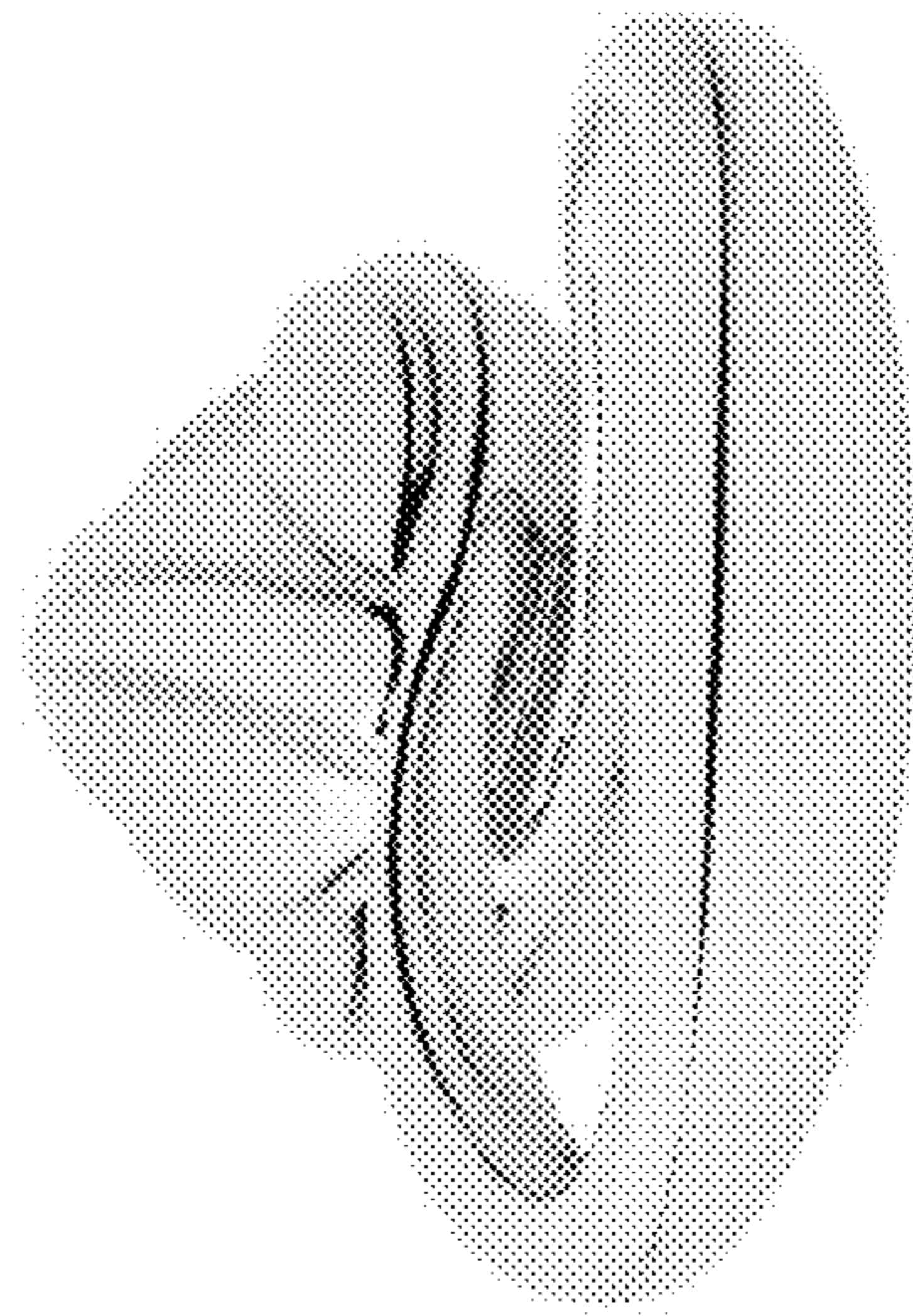

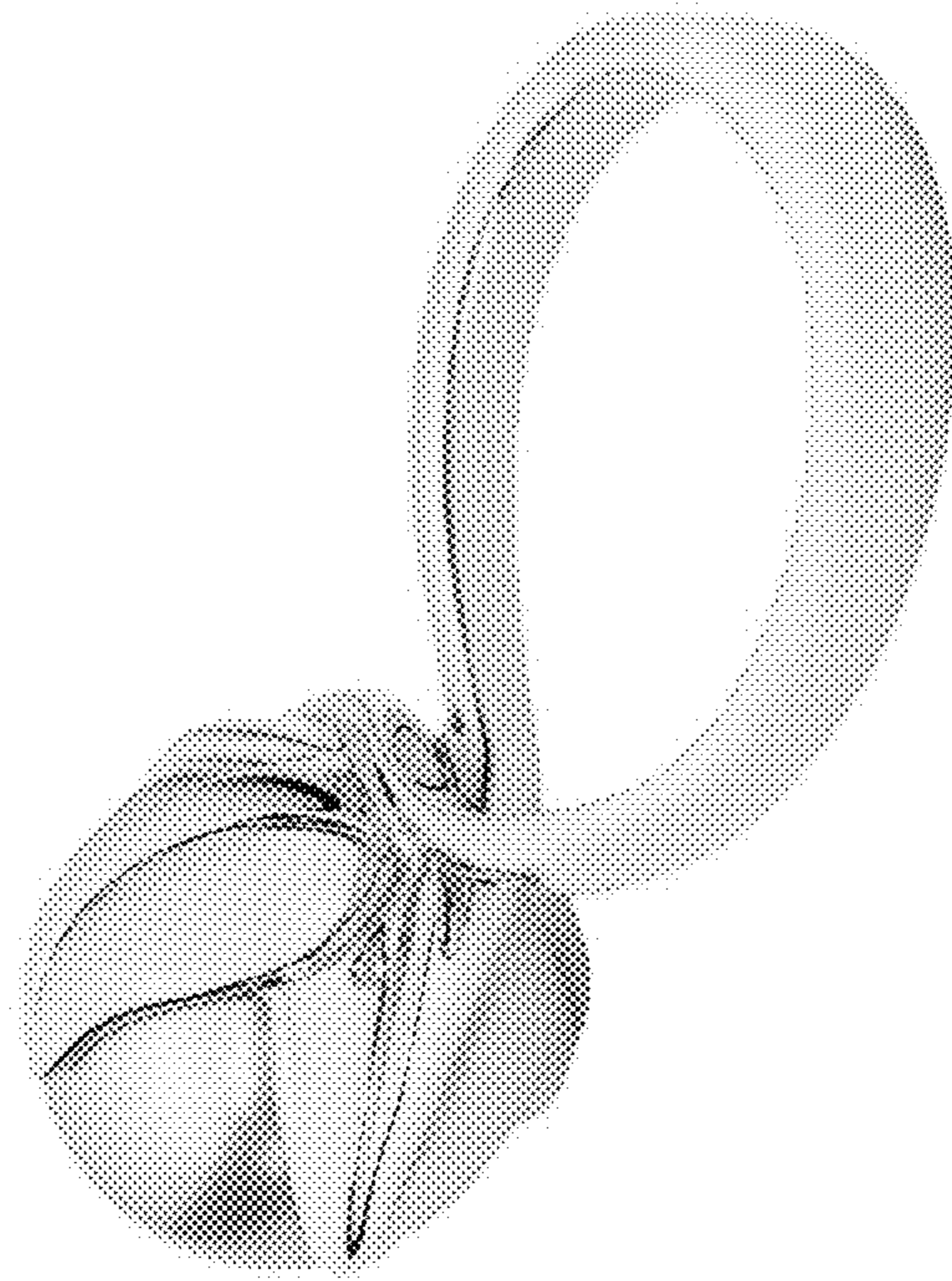
