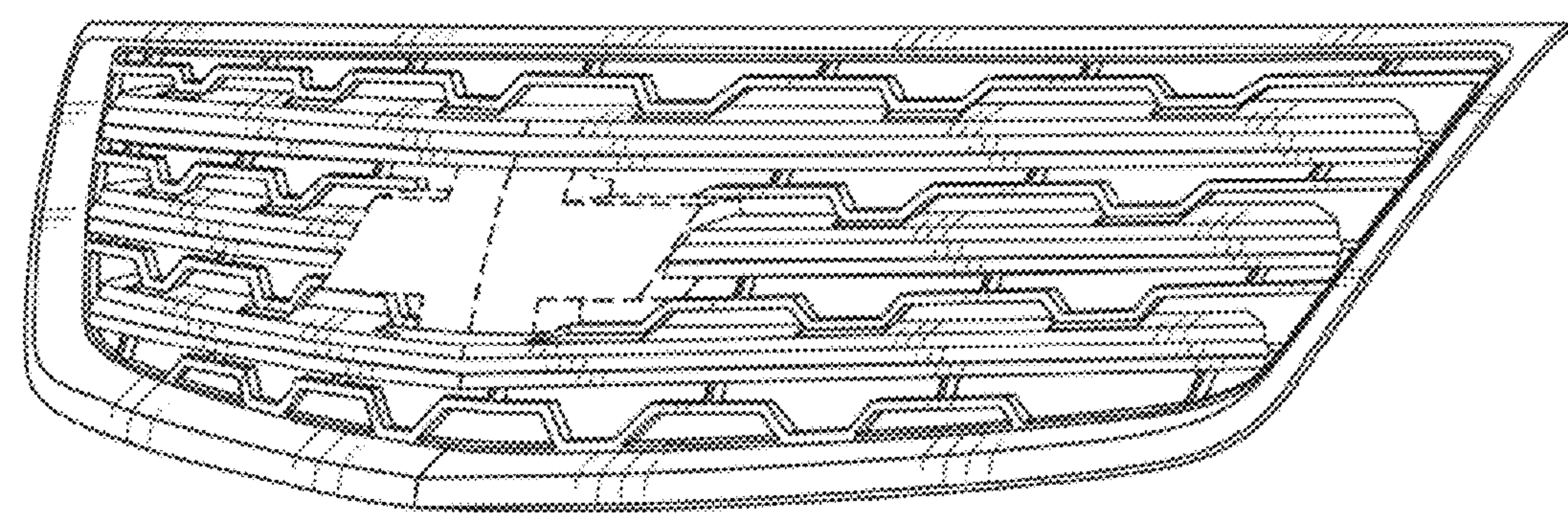
(57) **CLAIM**

I claim the ornamental design for an upper vehicle grille, as shown and described.

DESCRIPTION

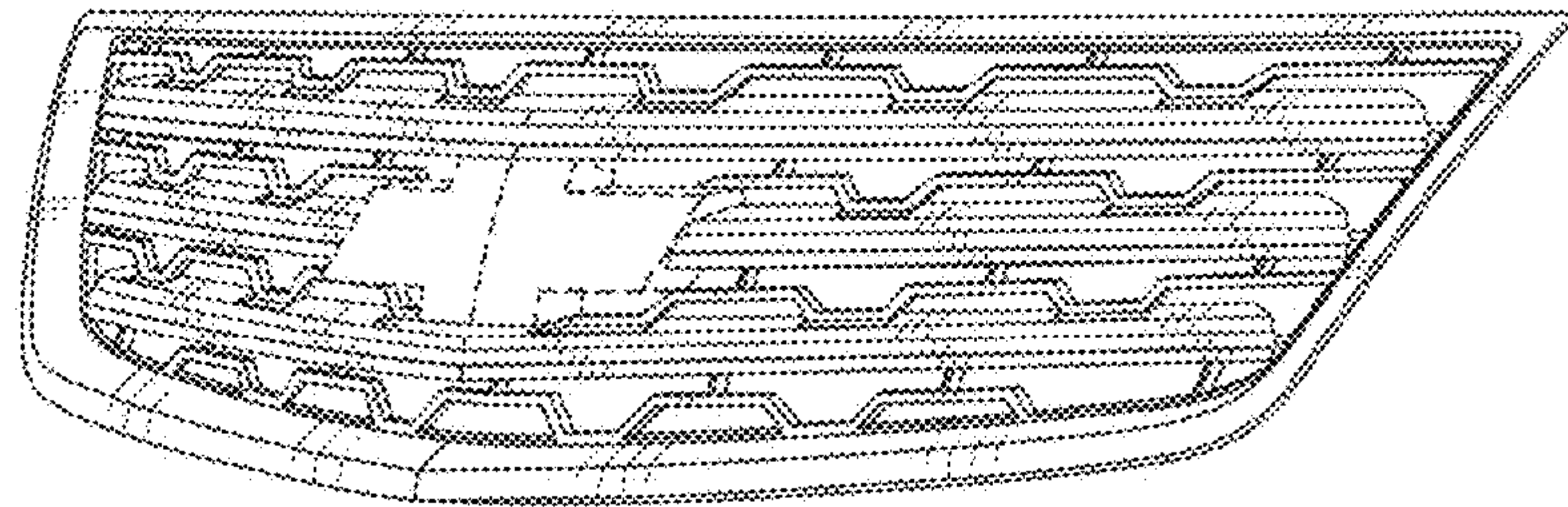

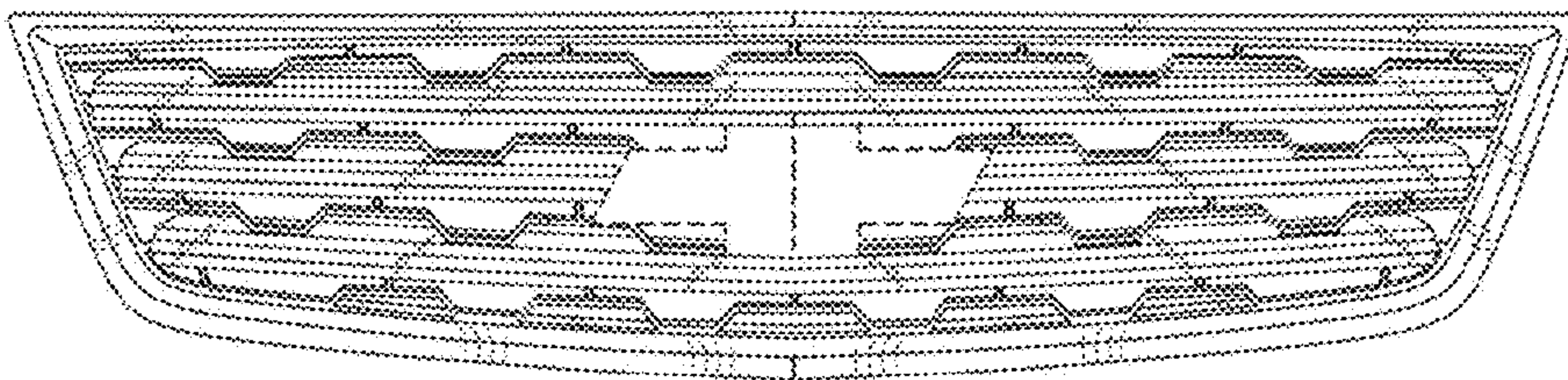

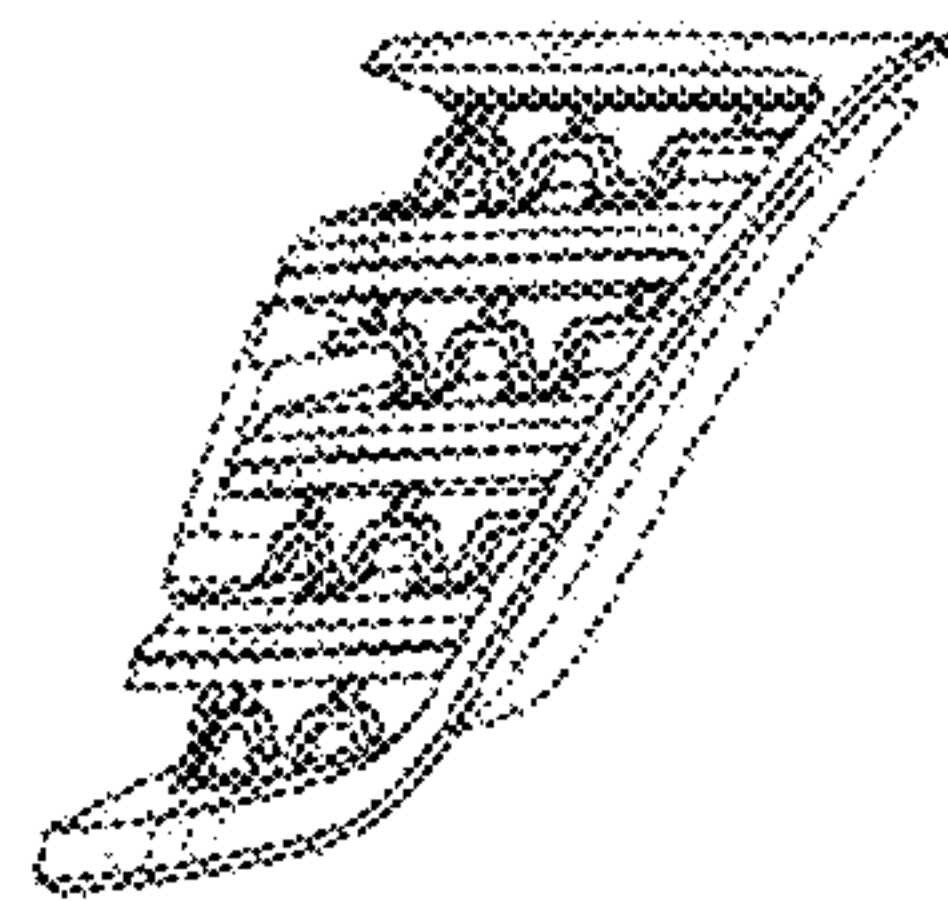
