(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire showing the claimed design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side view thereof;

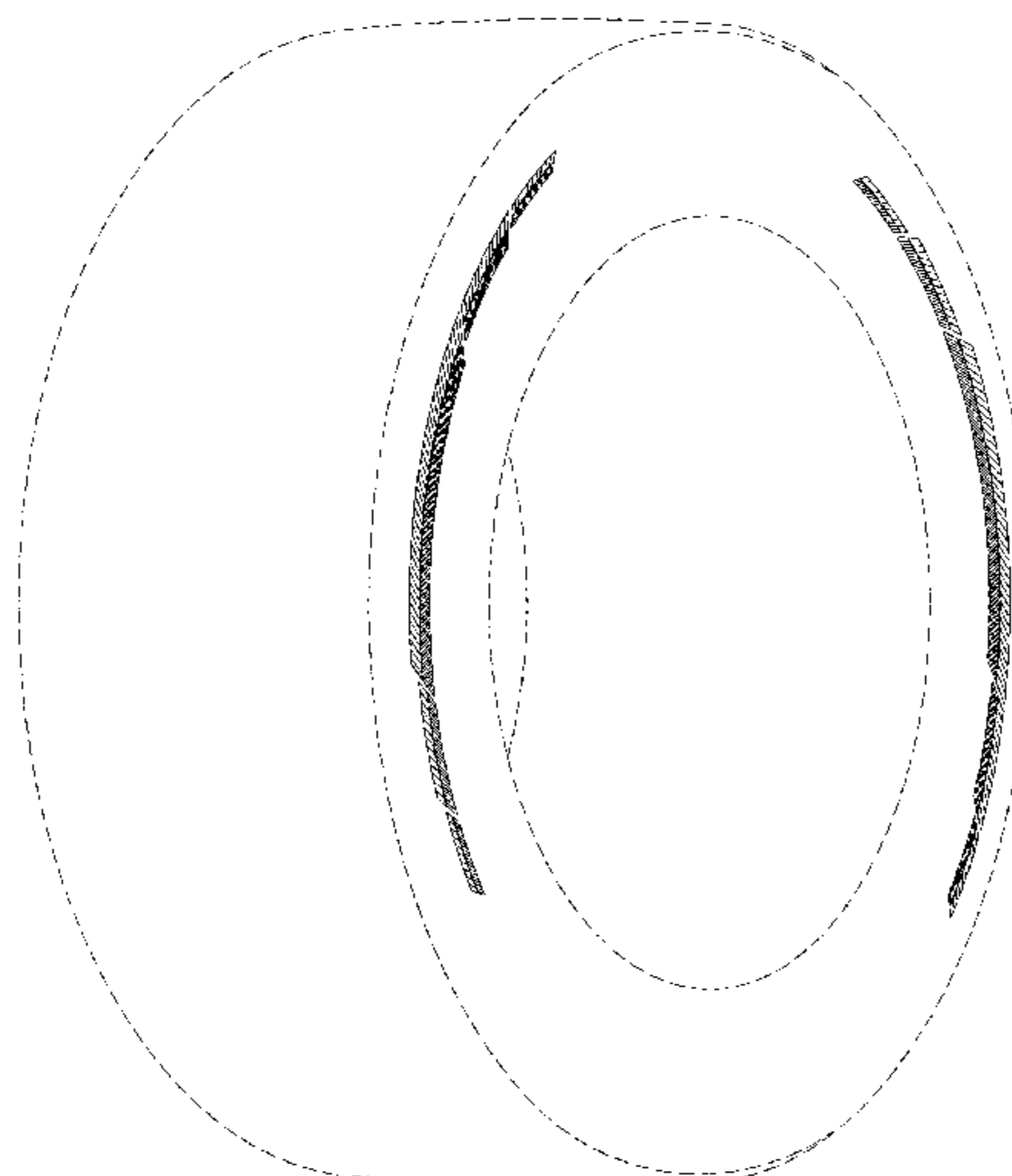
FIG. 7 is a left side view thereof;

FIG. 8 is an enlarged view of the portion between 8-8 and 8-8' in FIG. 2; and,

FIG. 9 is an enlarged cross-sectional view taken along line 9"-9" in FIG. 8 within the portion 9'-9' in FIG. 8 to line 9-9 in FIG. 4.

In the drawings, the broken lines showing portions of the tire tread, sidewall, and inner bead depict portions of the tire that form no part of the claimed design.

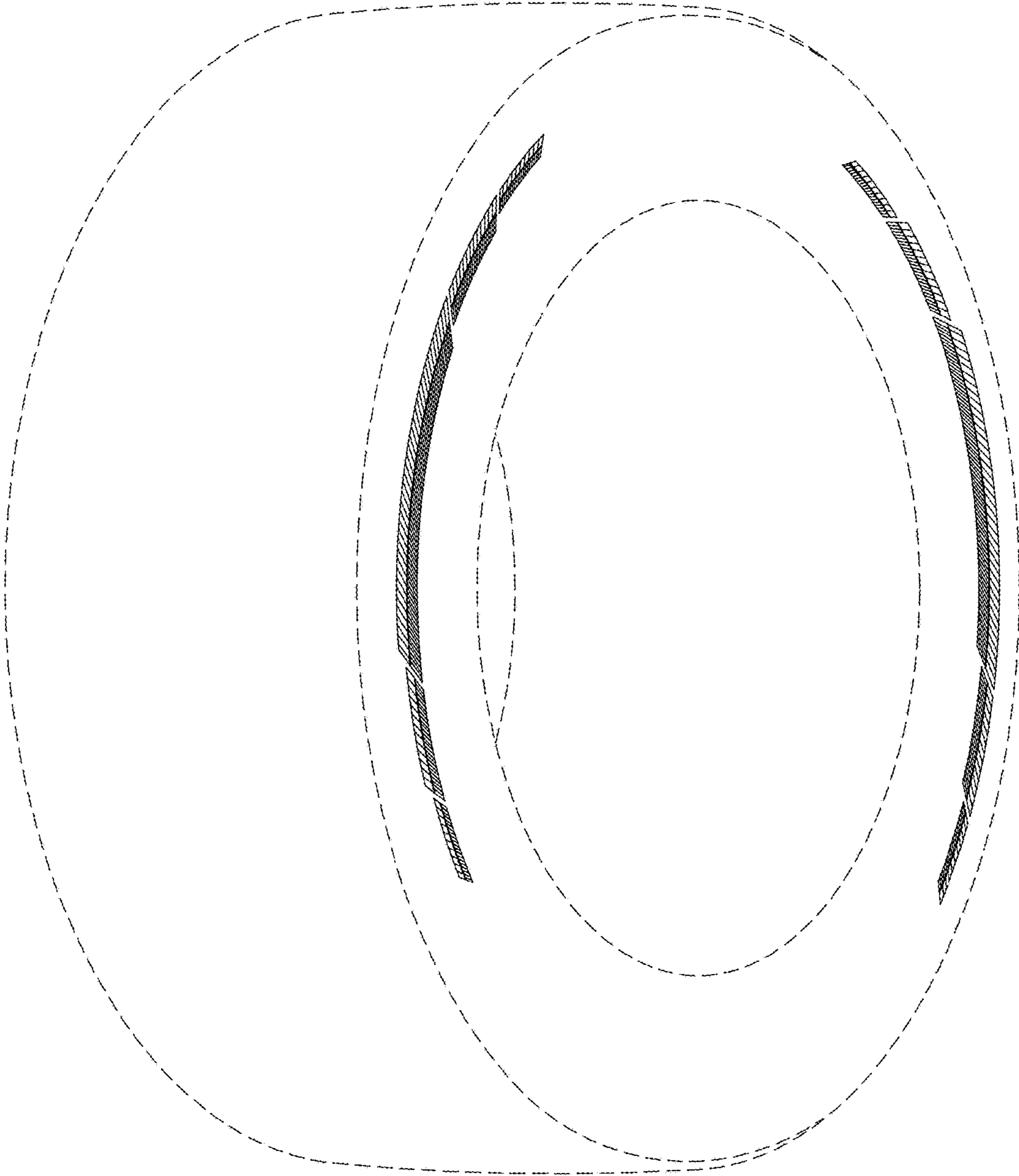

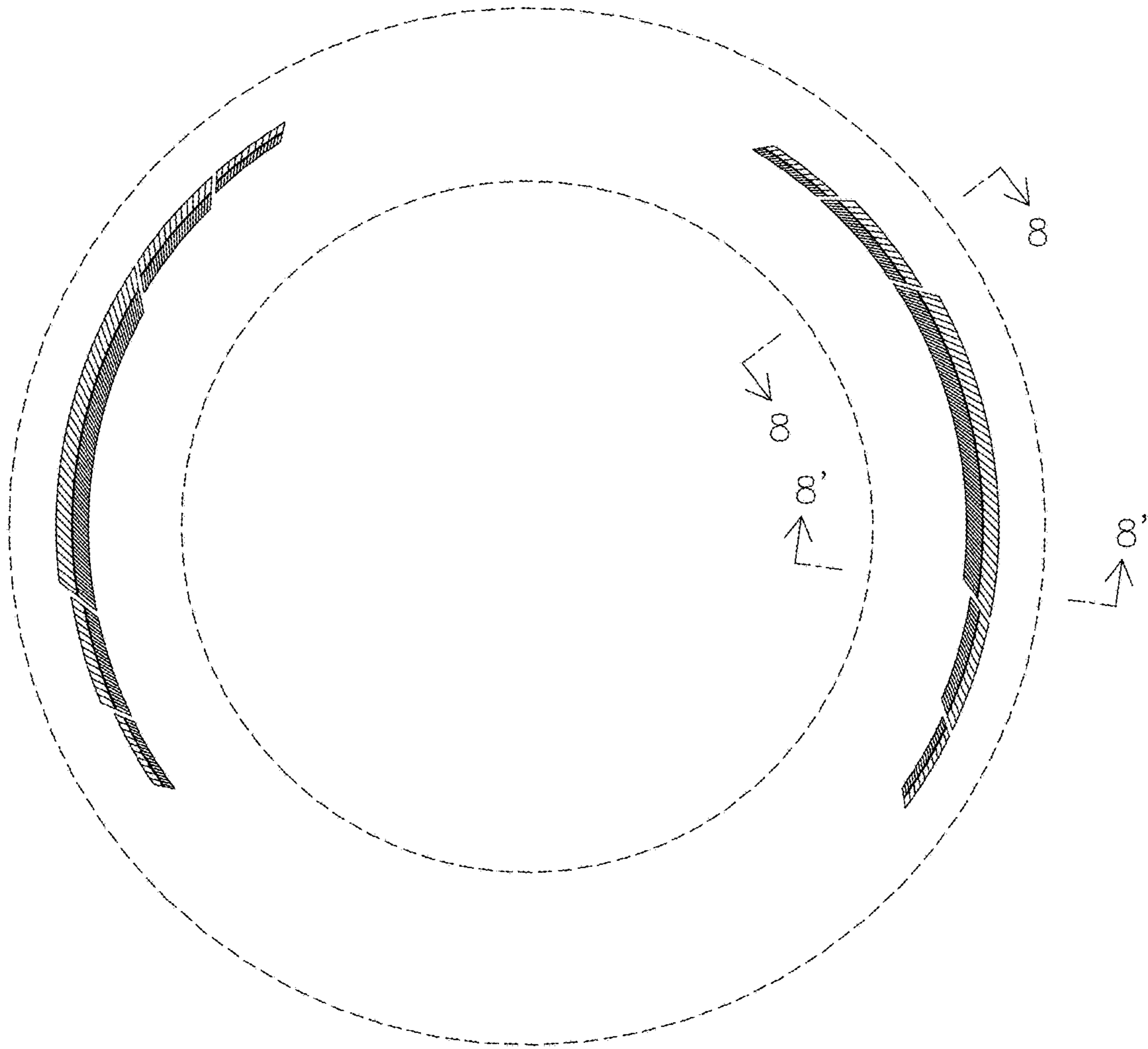

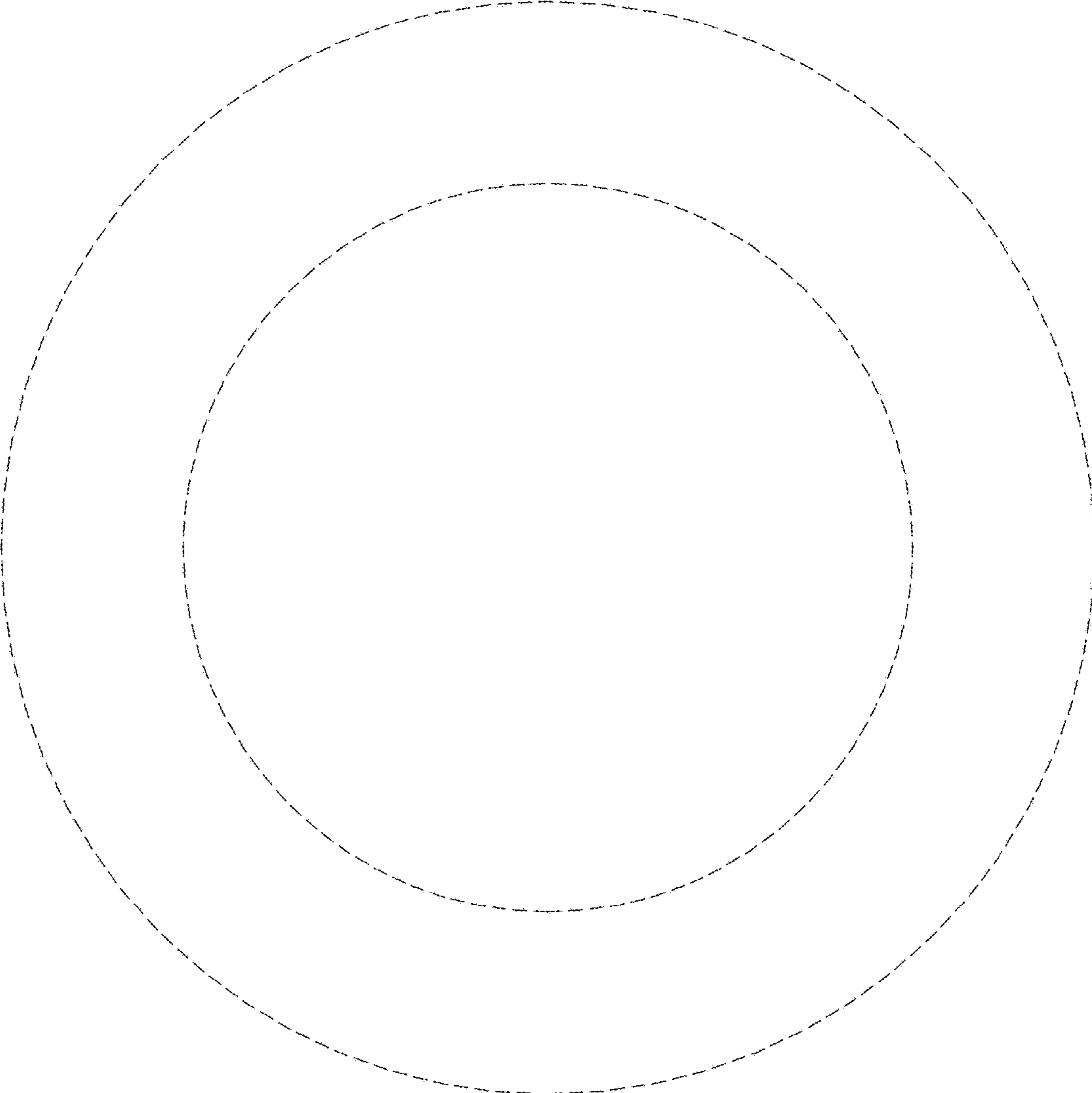

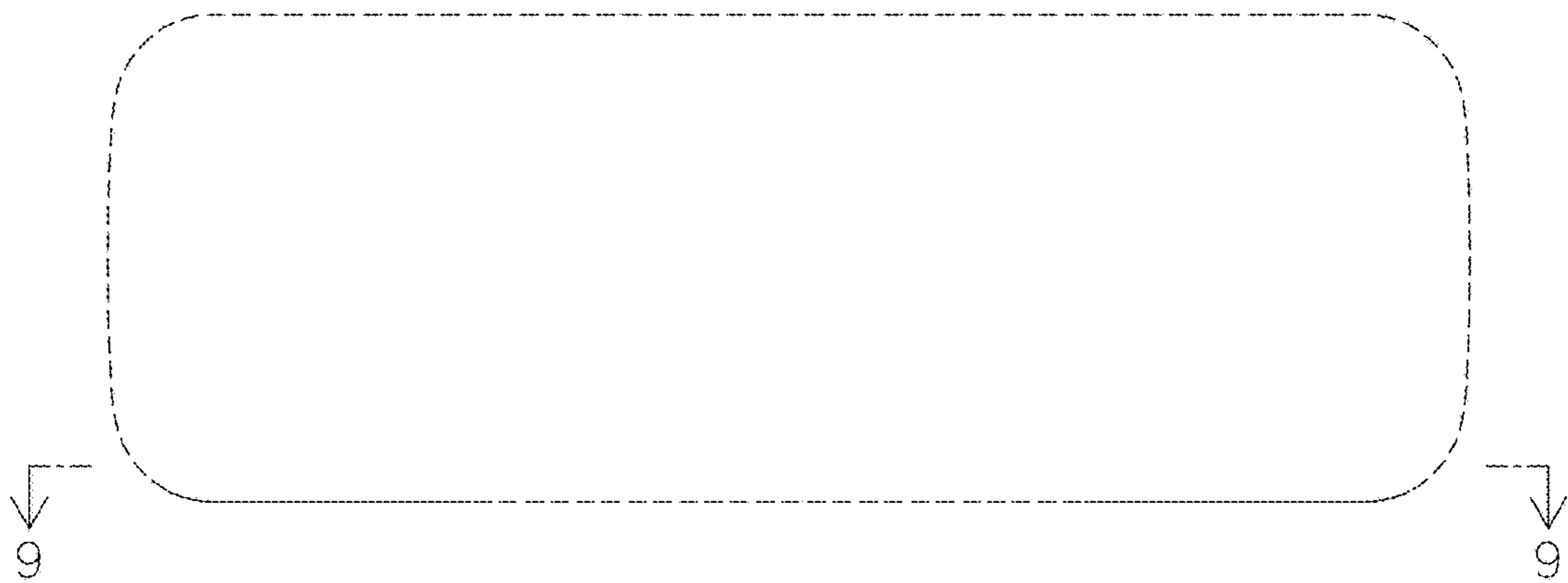

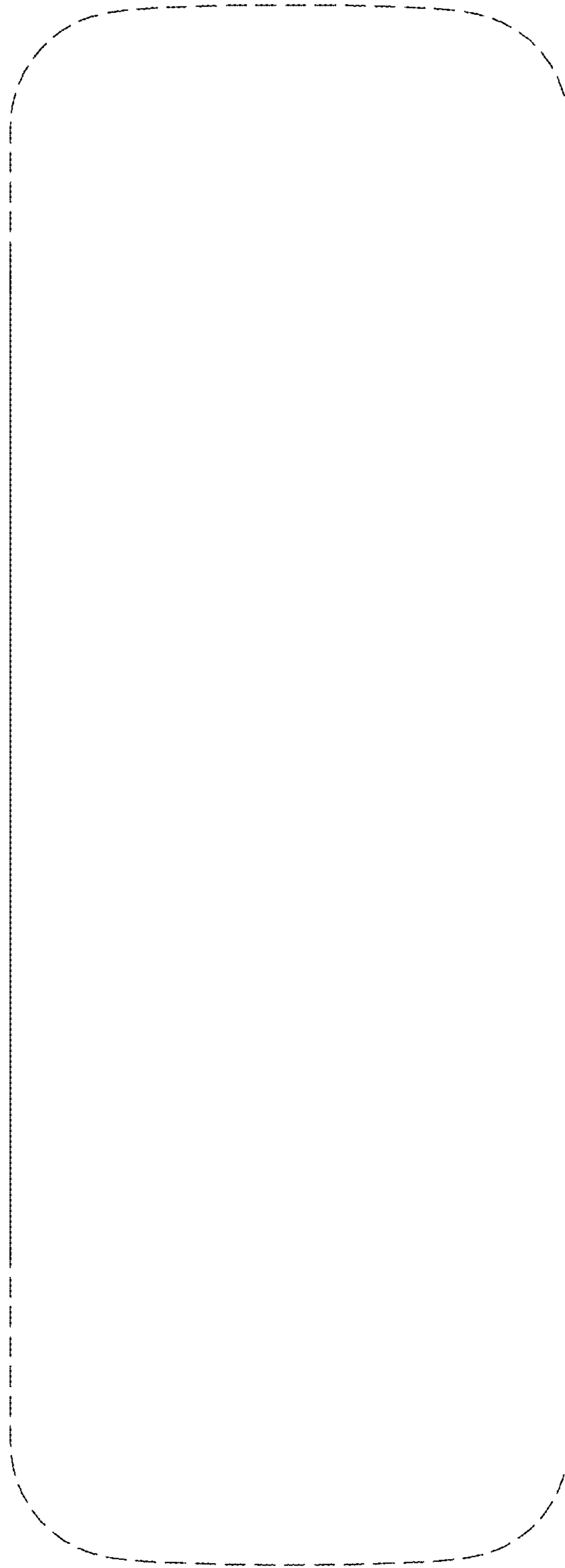

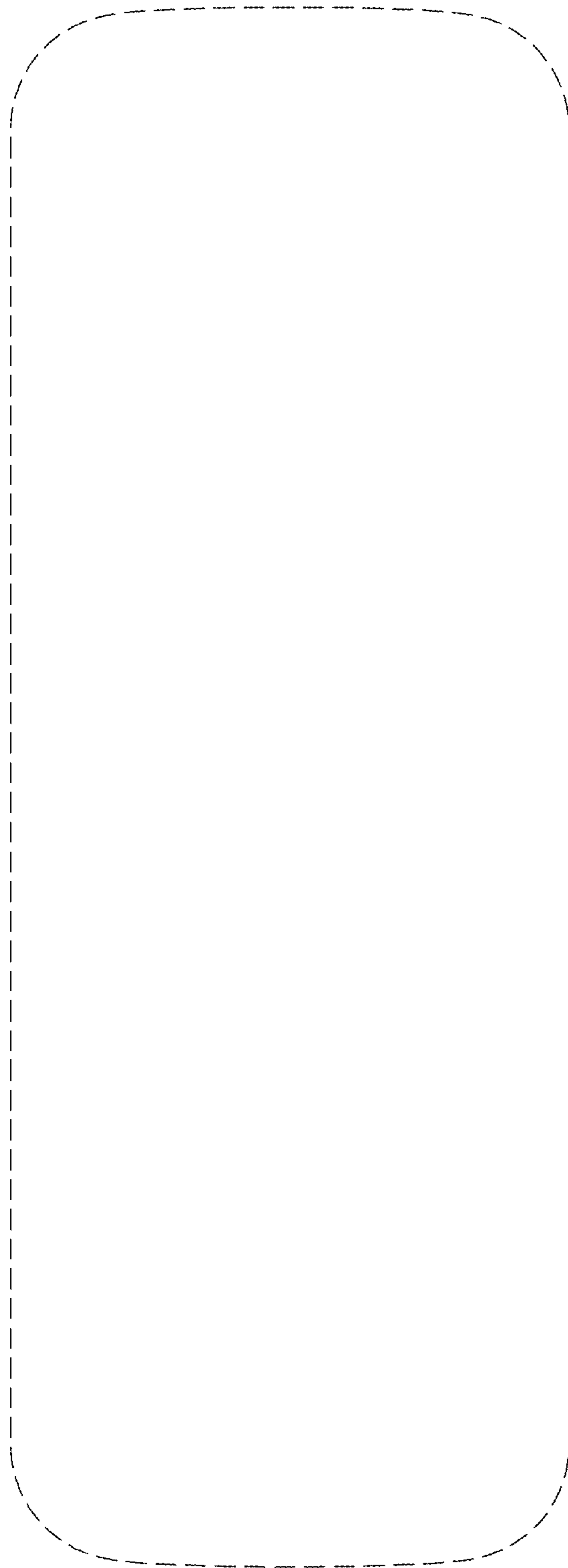

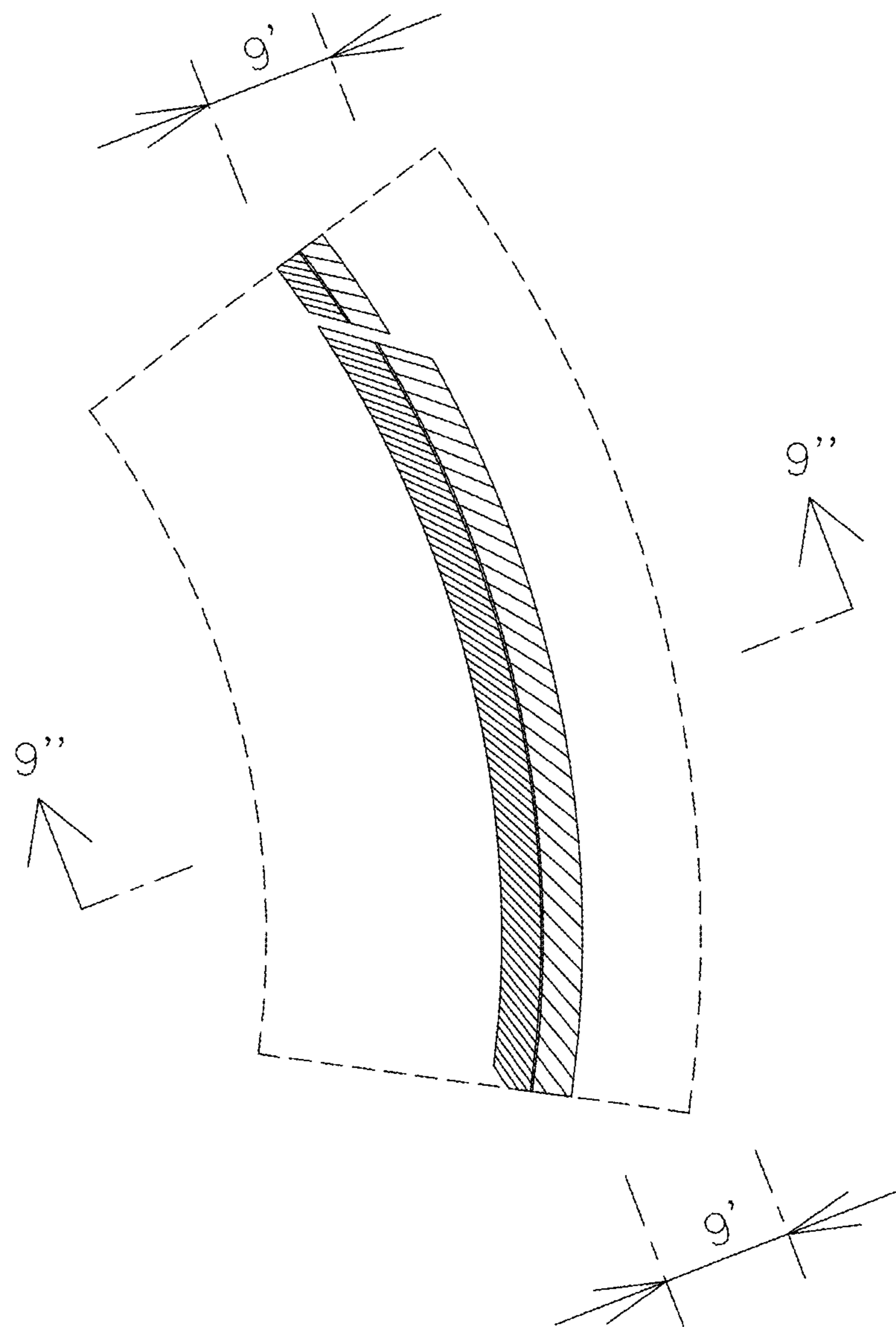

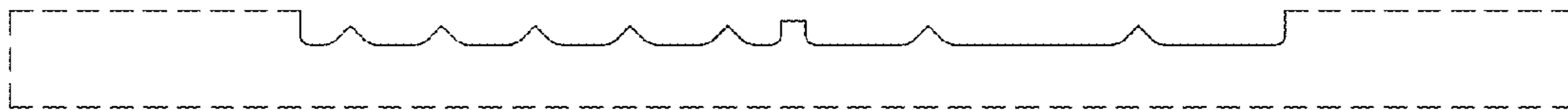
