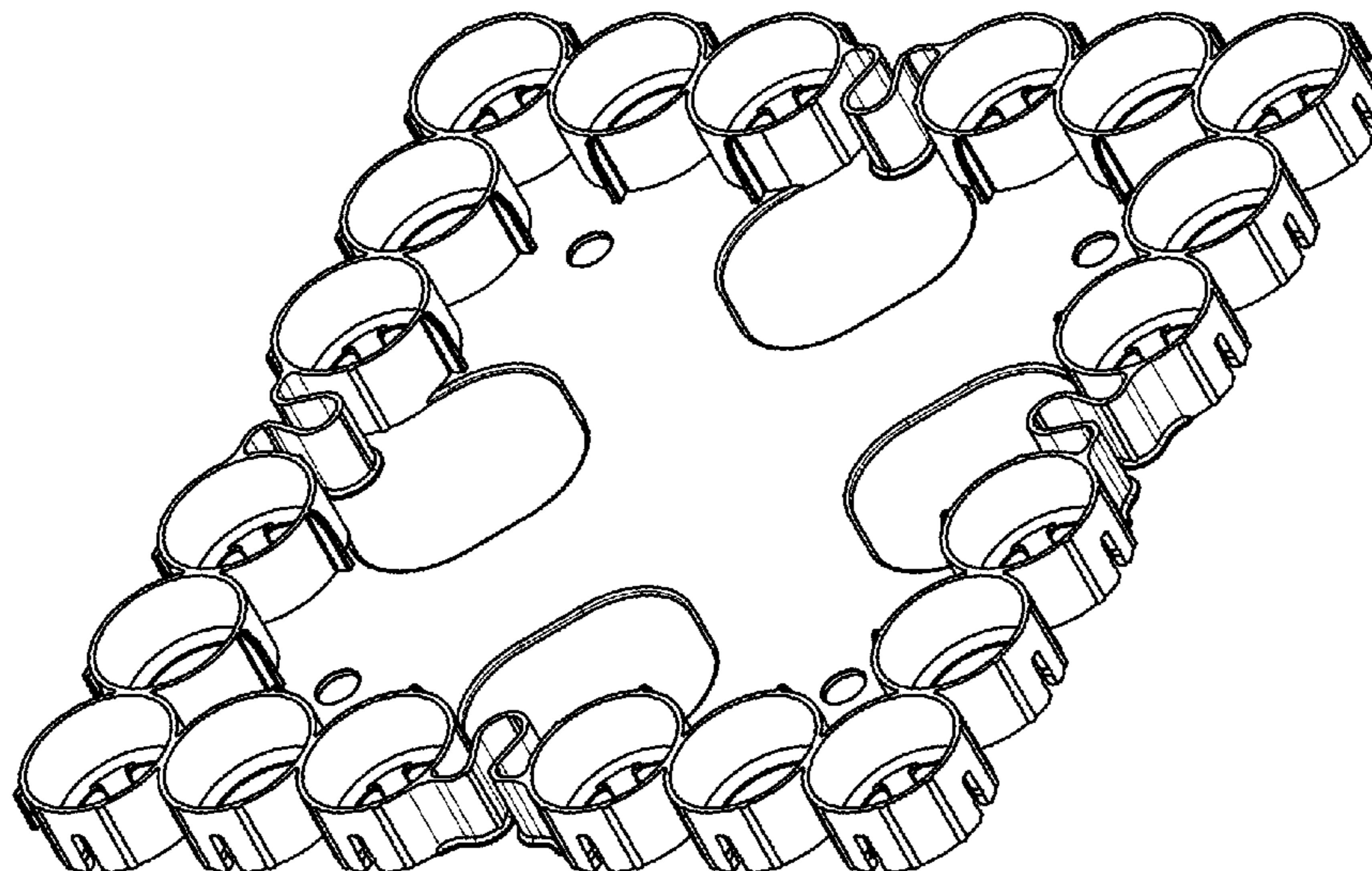
(57) **CLAIM**

The ornamental design for a paver grid, as shown and described.

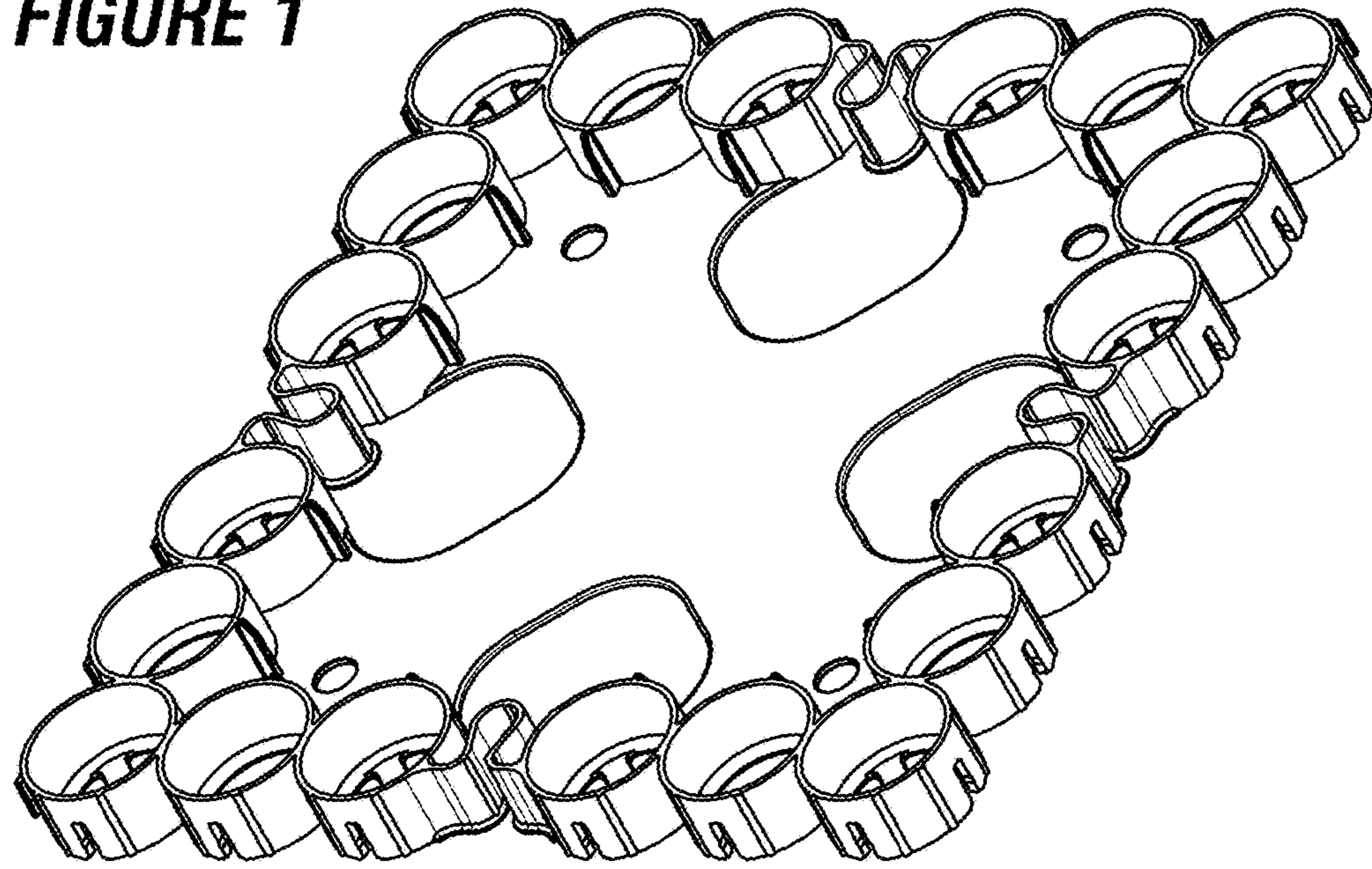
**DESCRIPTION**

FIG. 8 is a left elevation view of the paver grid.

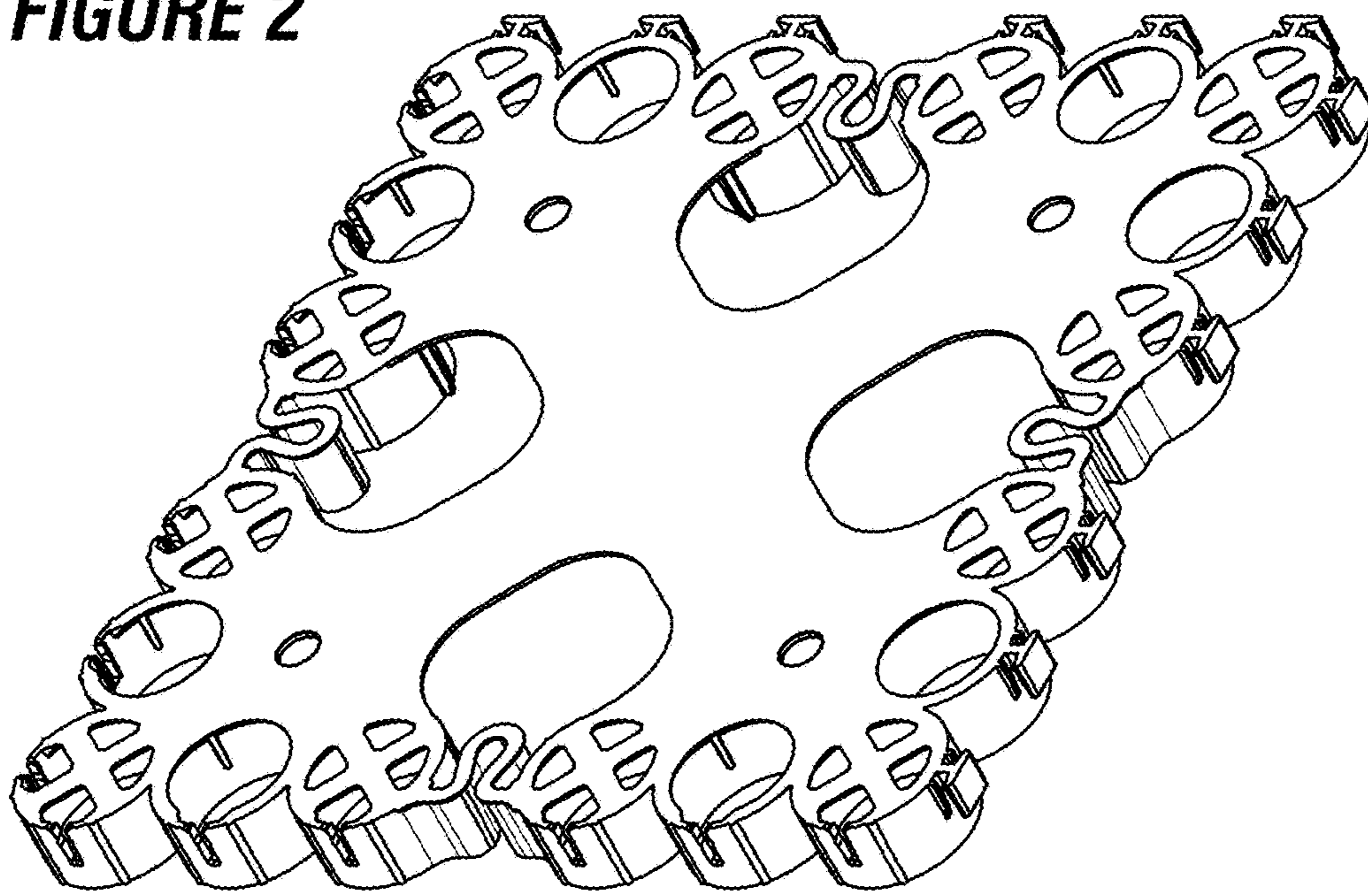

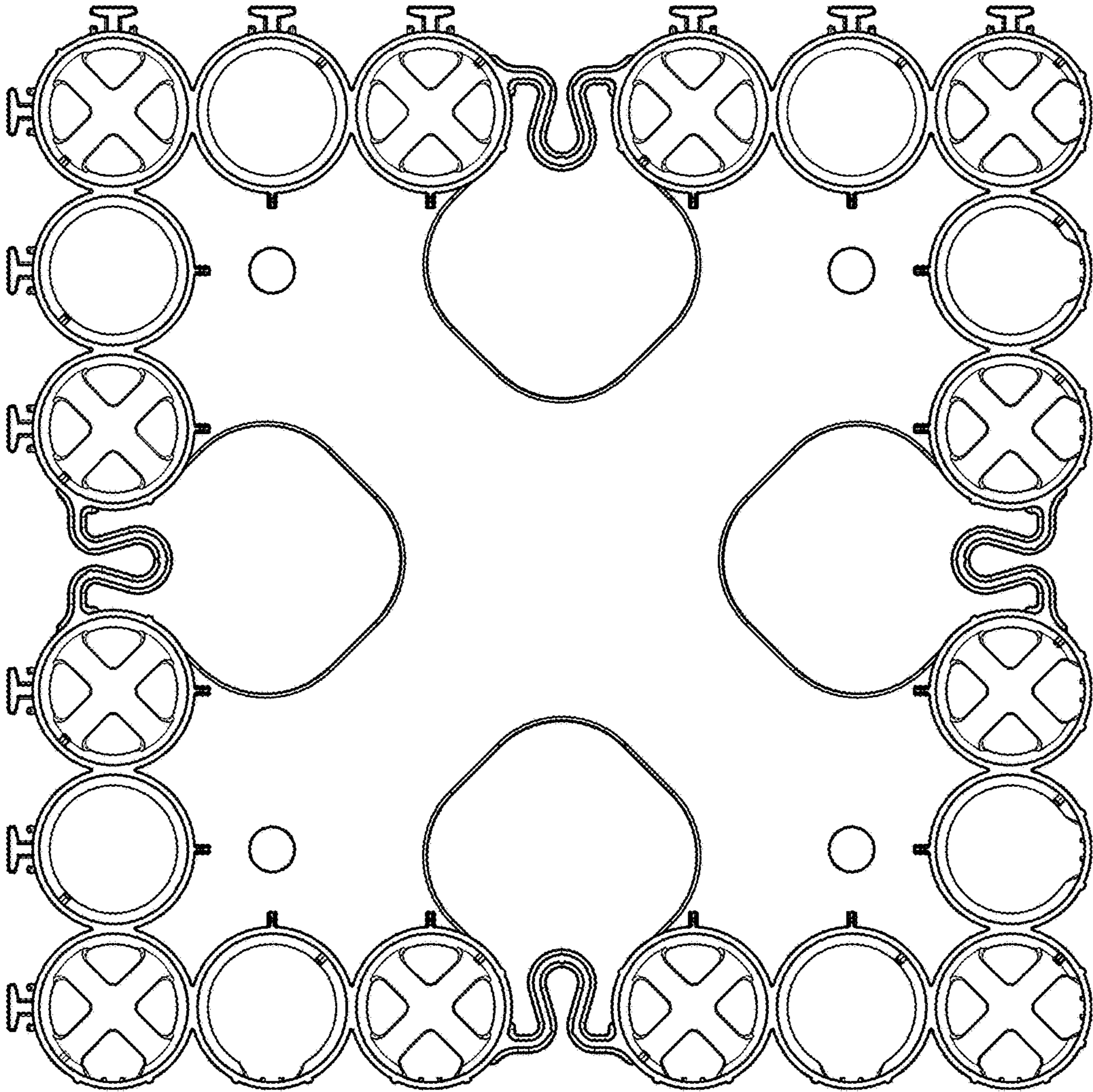

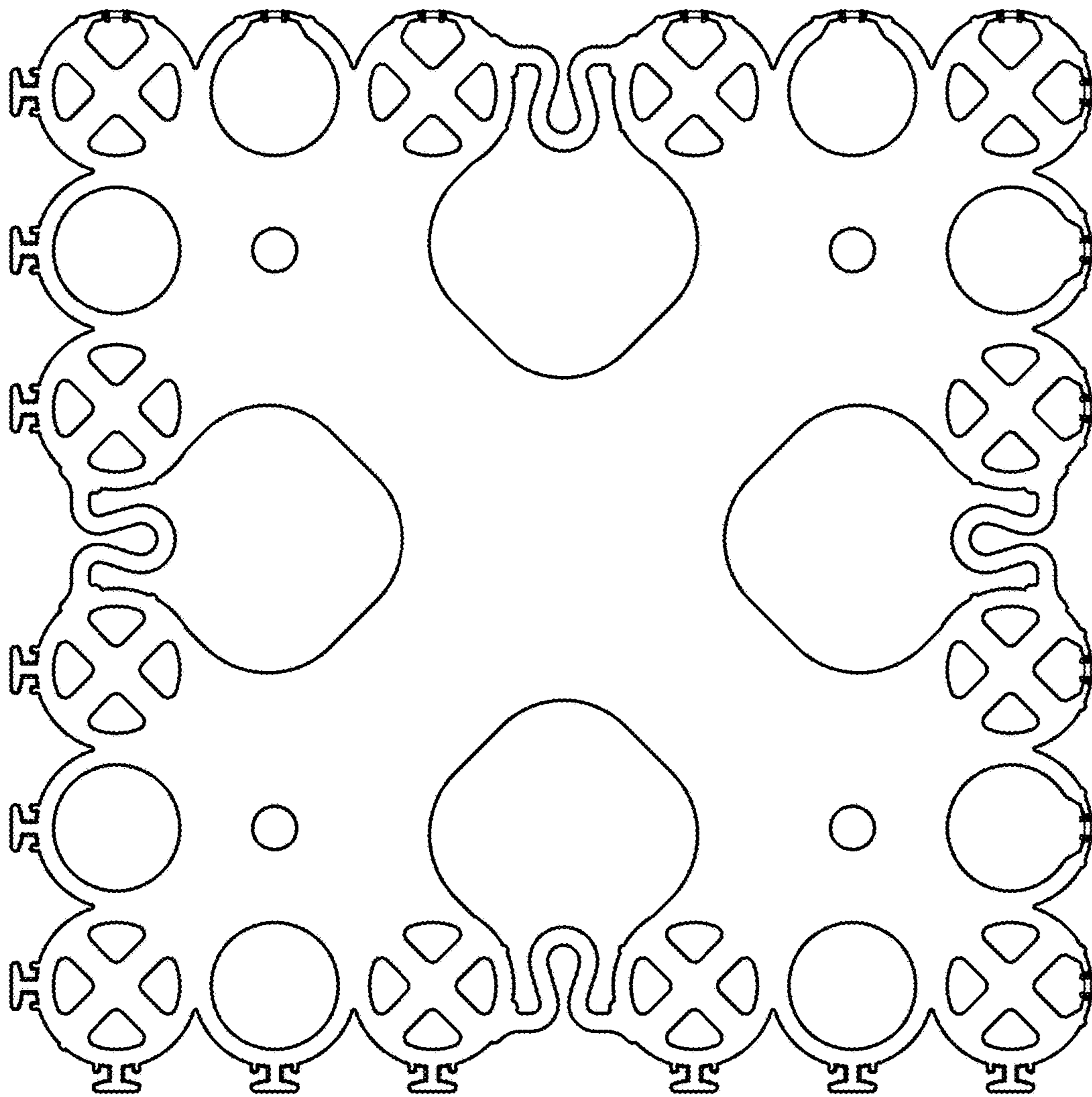

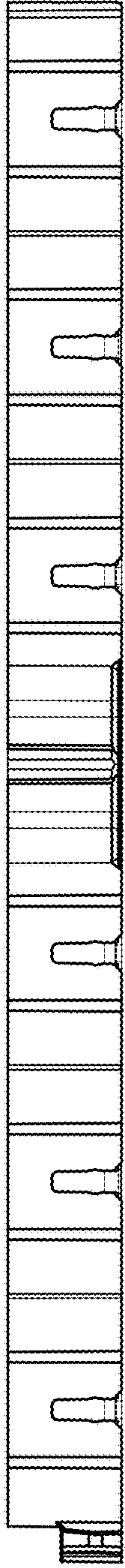

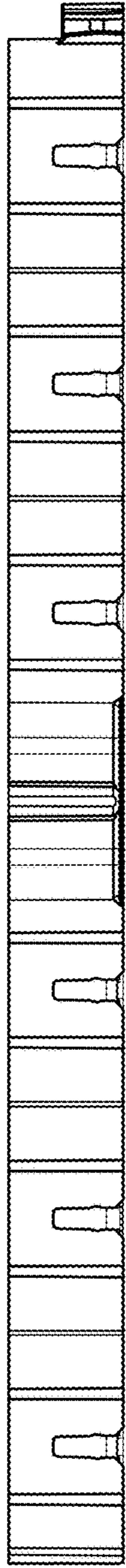

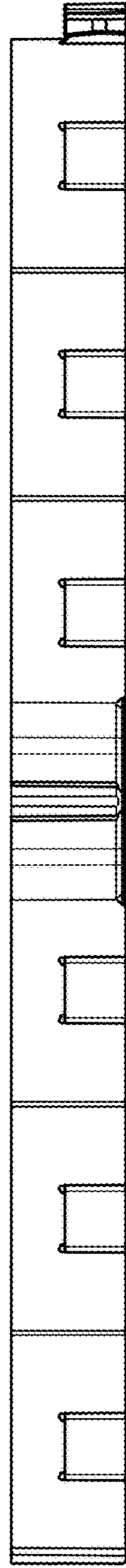




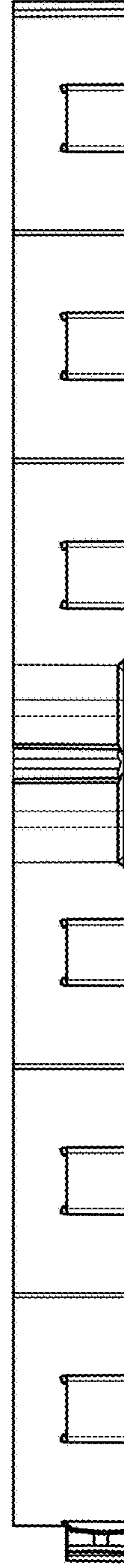
