DESCRIPTION

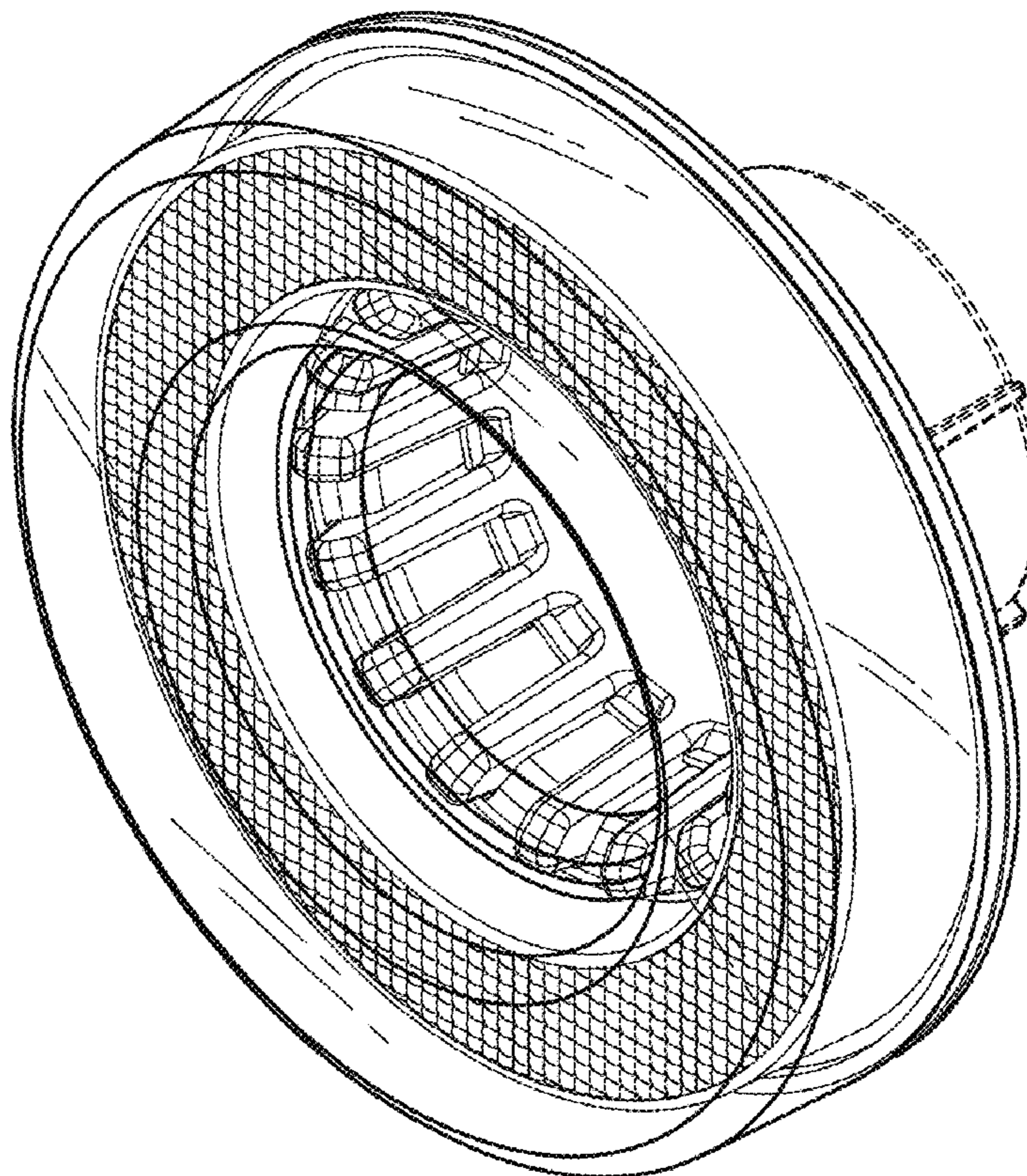
FIG. 1 is a perspective view of the vehicle tail light;

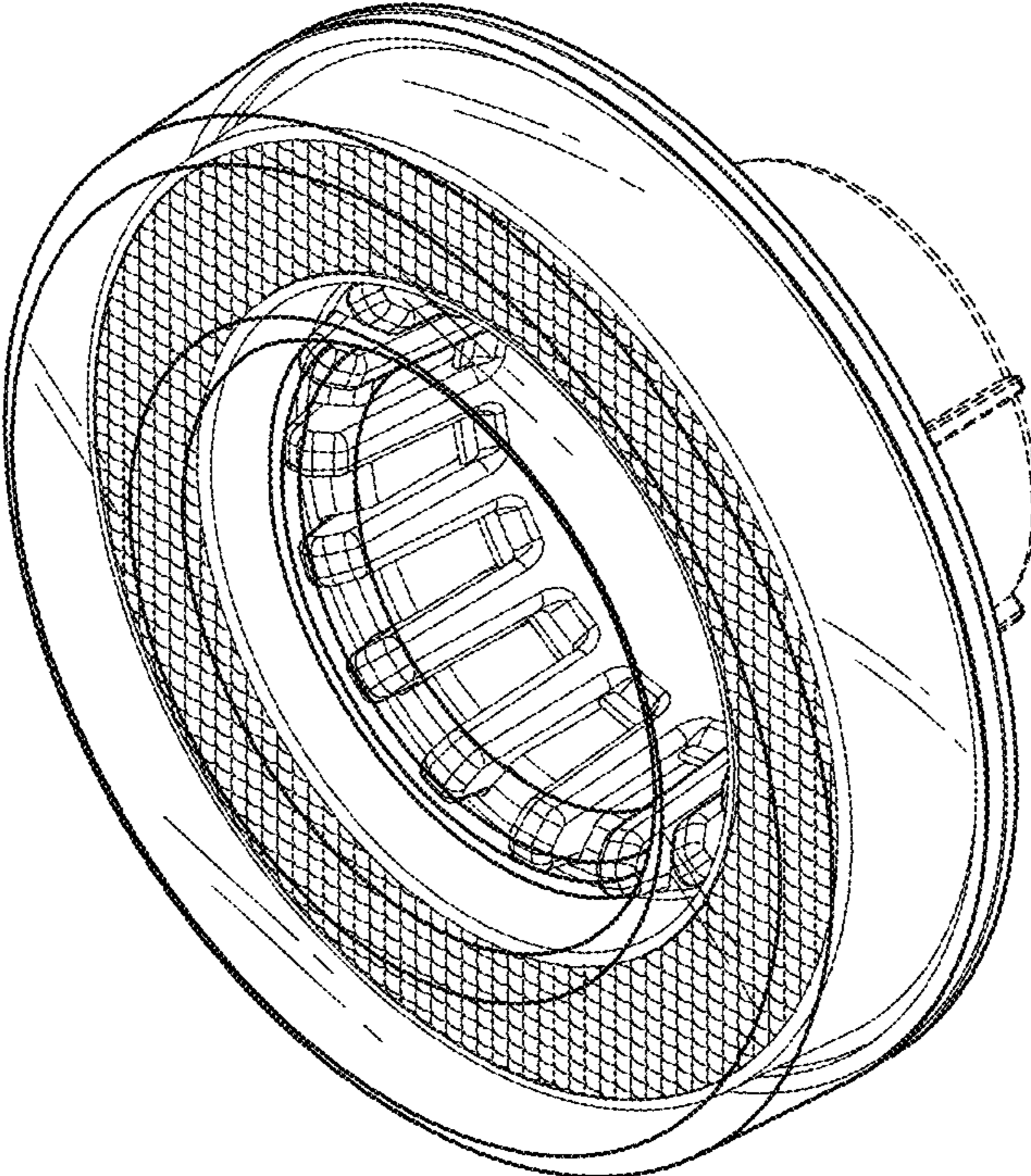

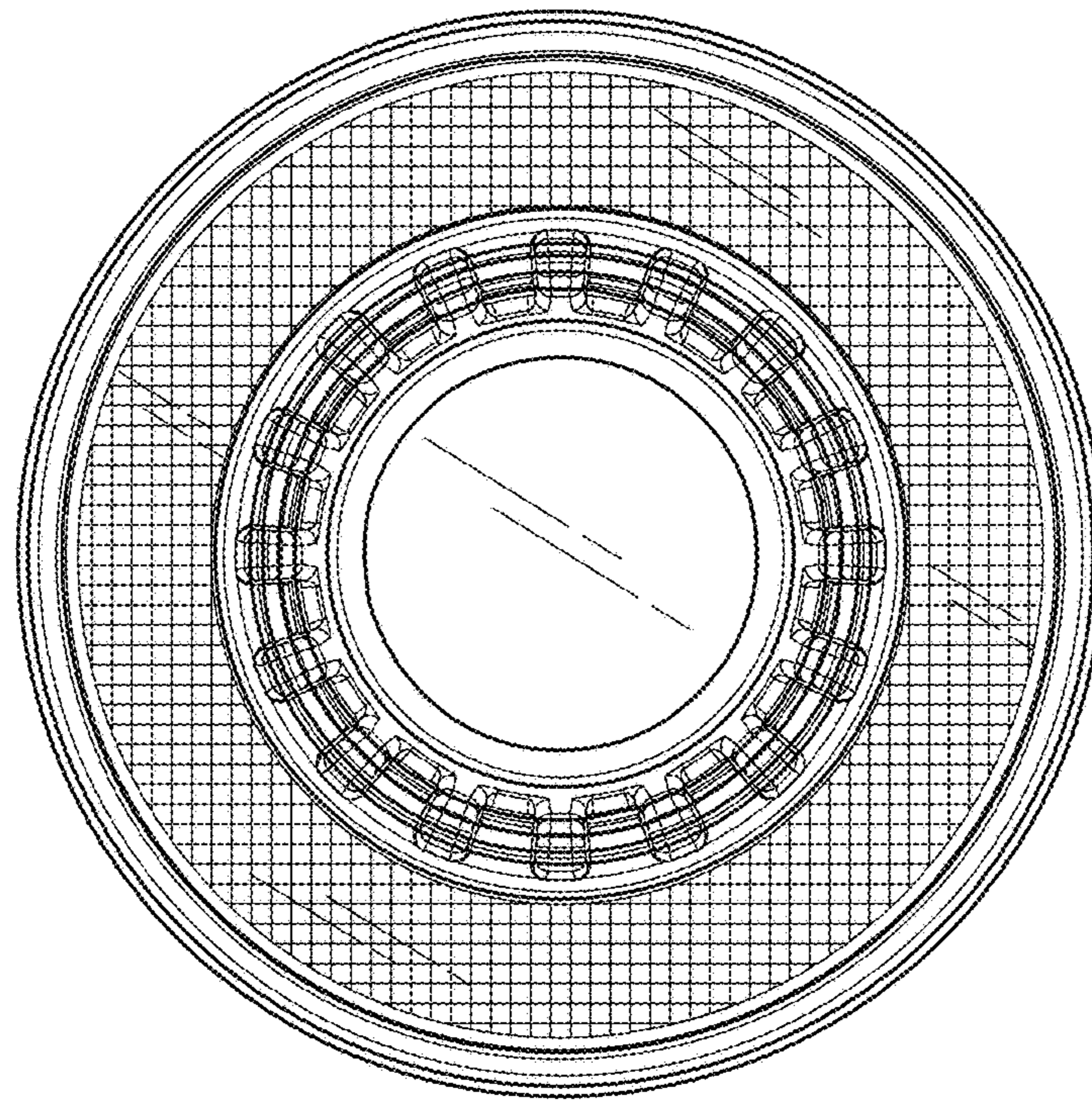

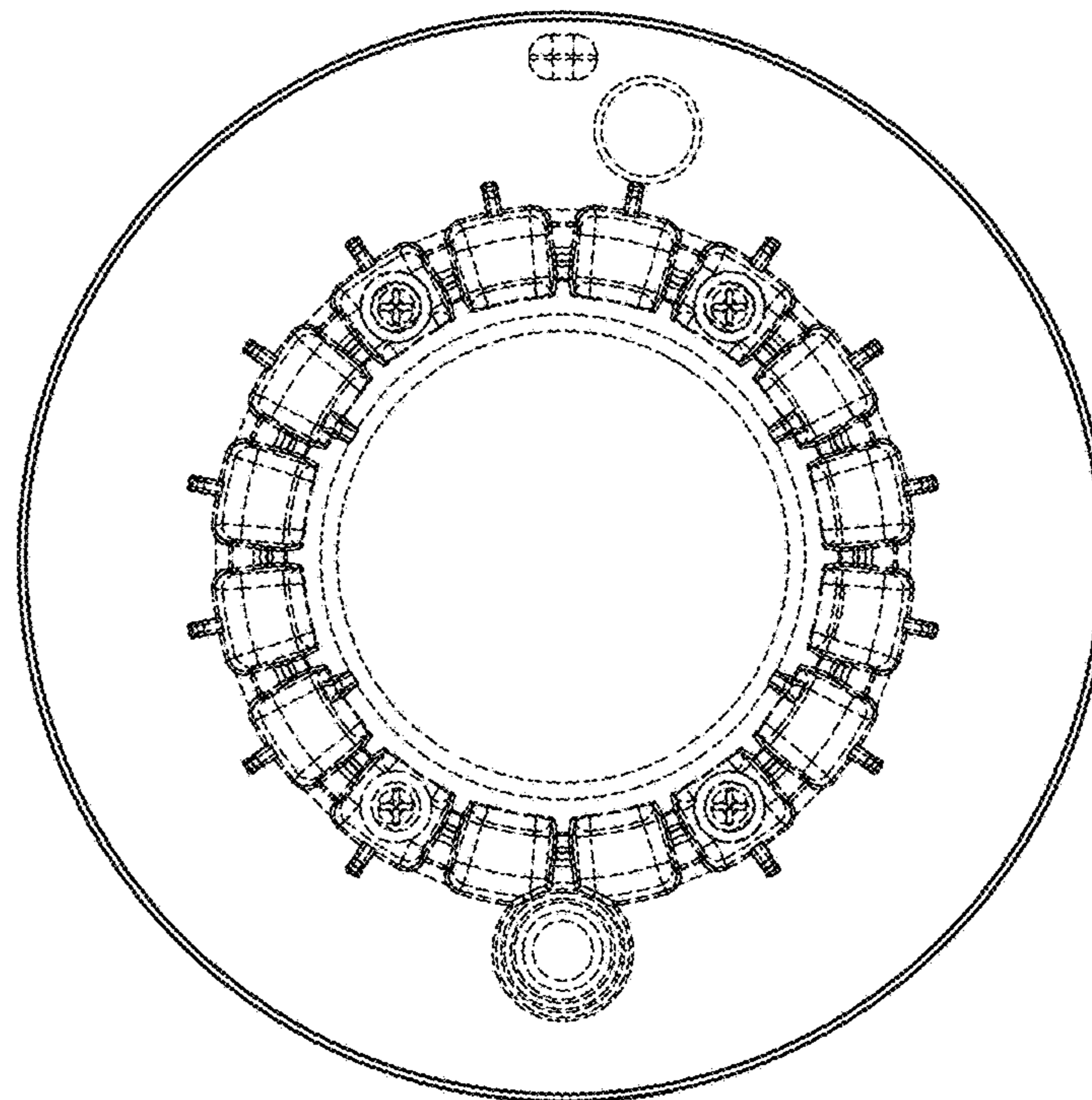

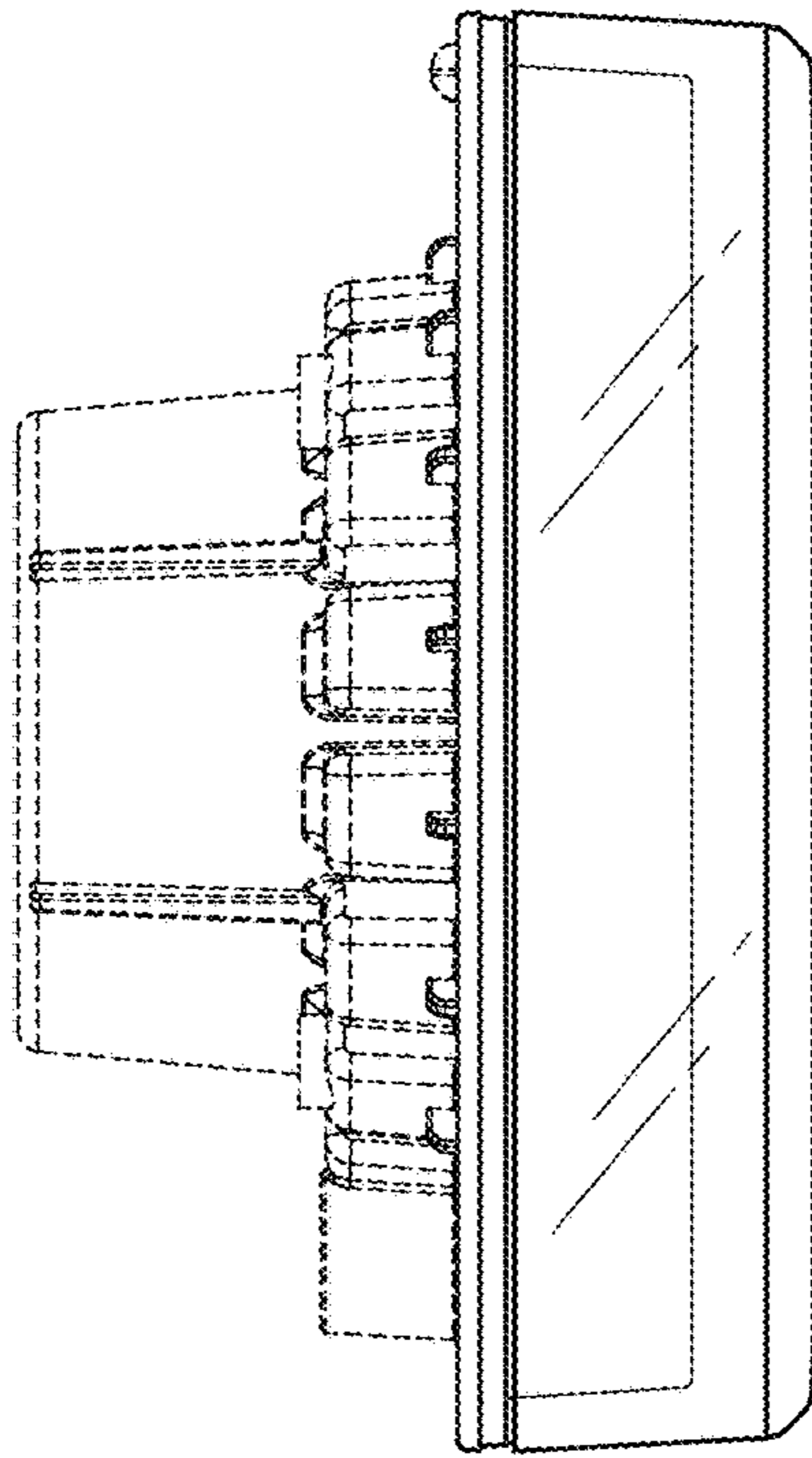

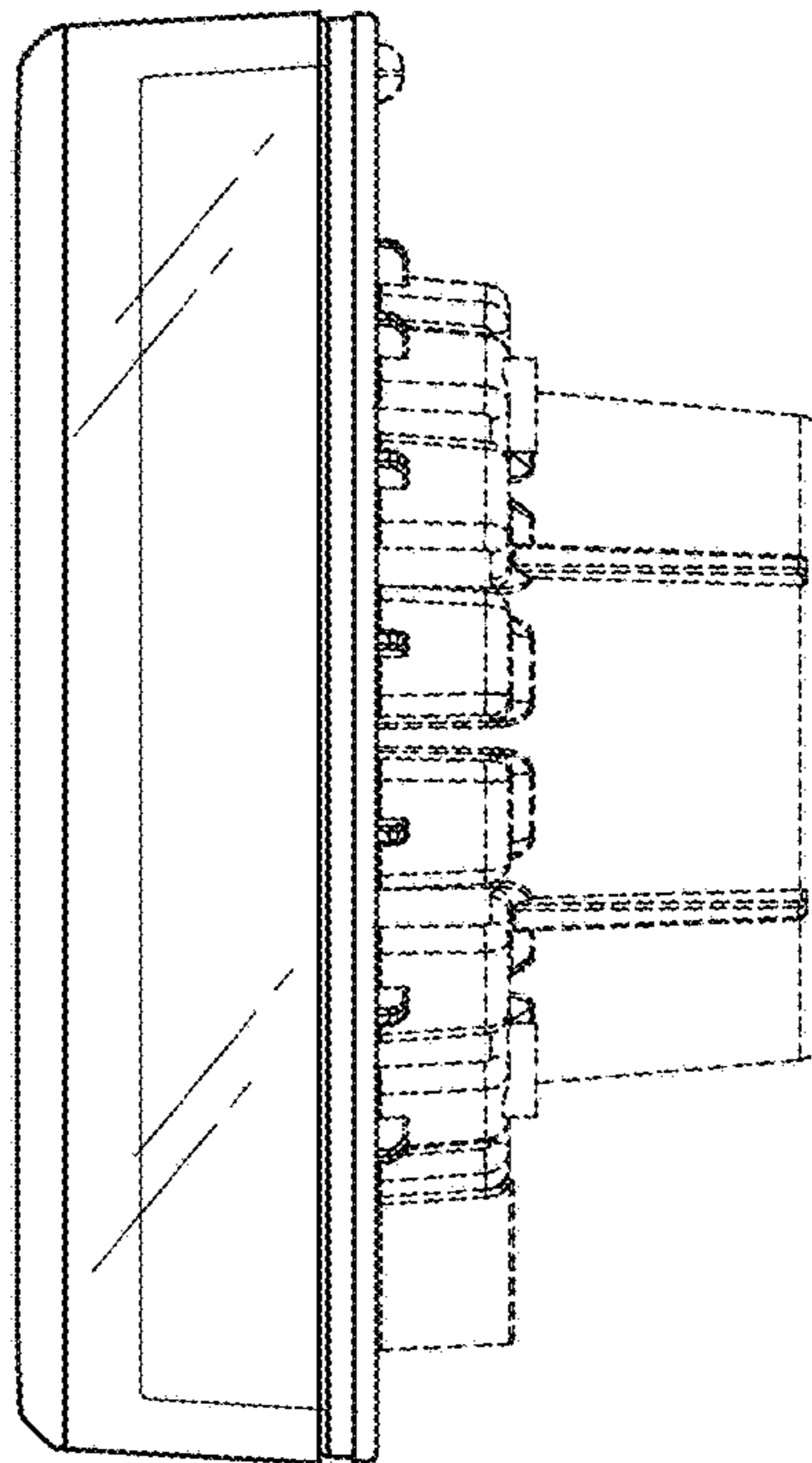

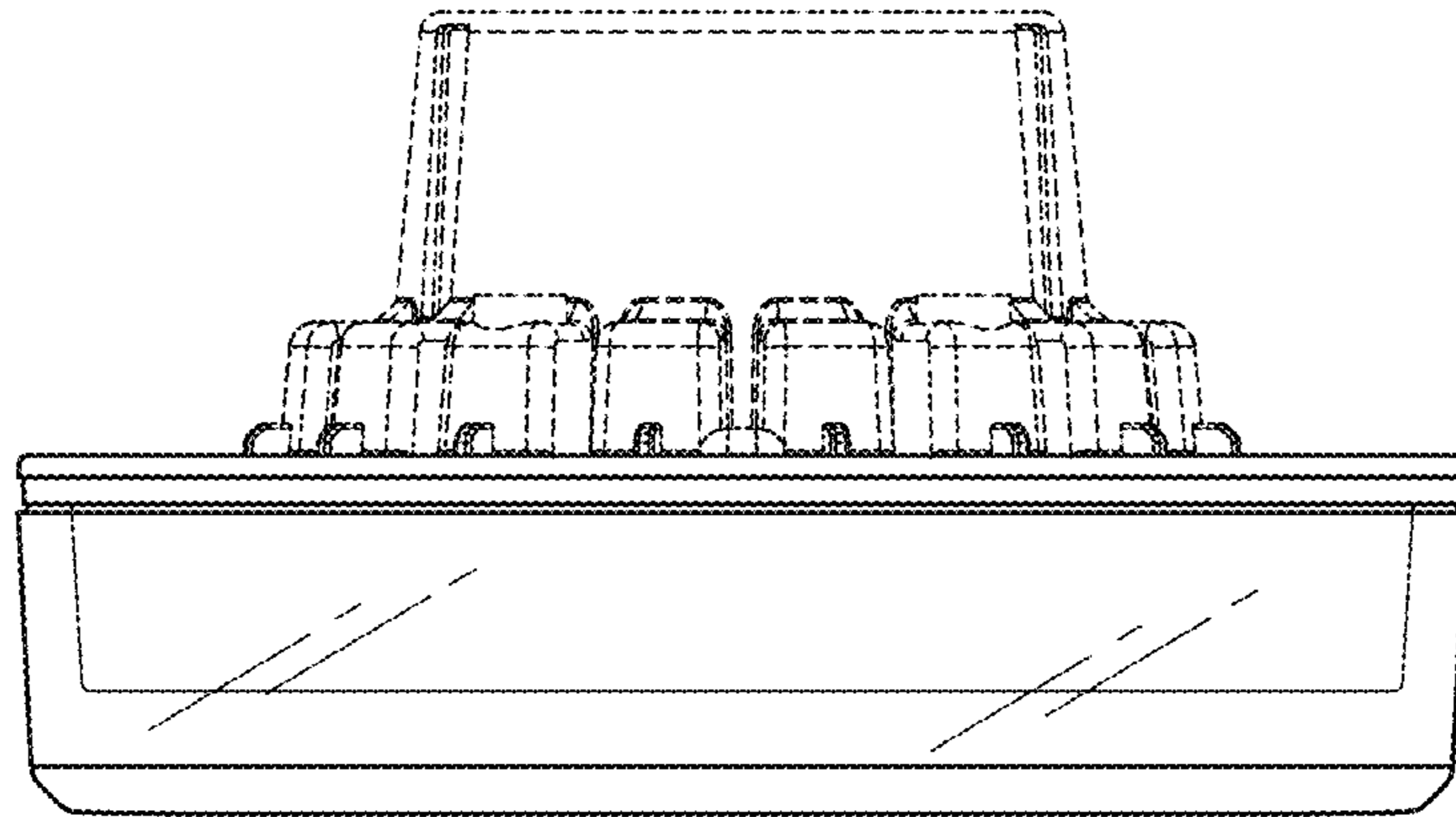

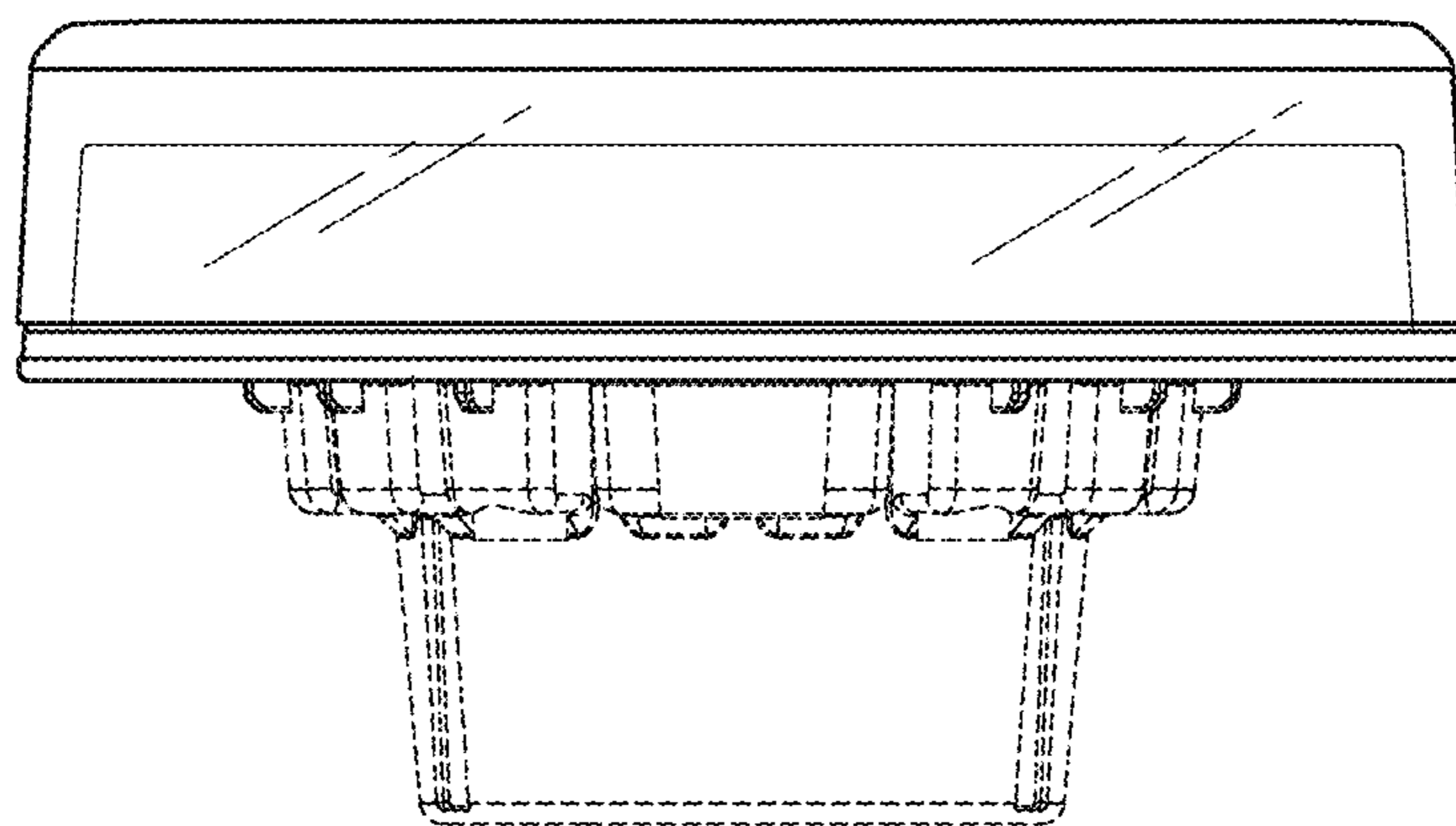
