The broken lines are included for the purpose of illustrating environmental and unclaimed portions of the grill cleaning device and form no part of the claimed design.

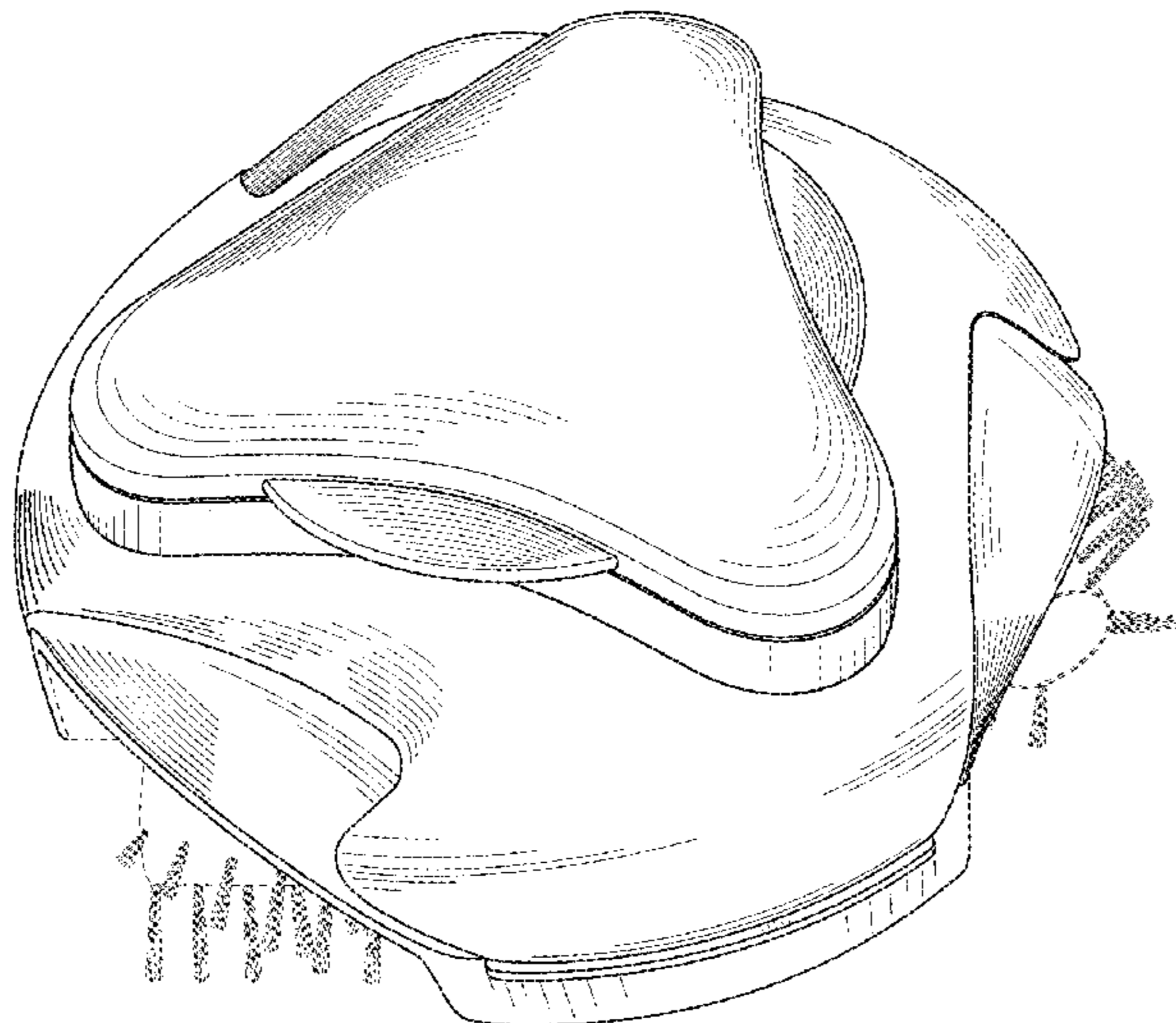

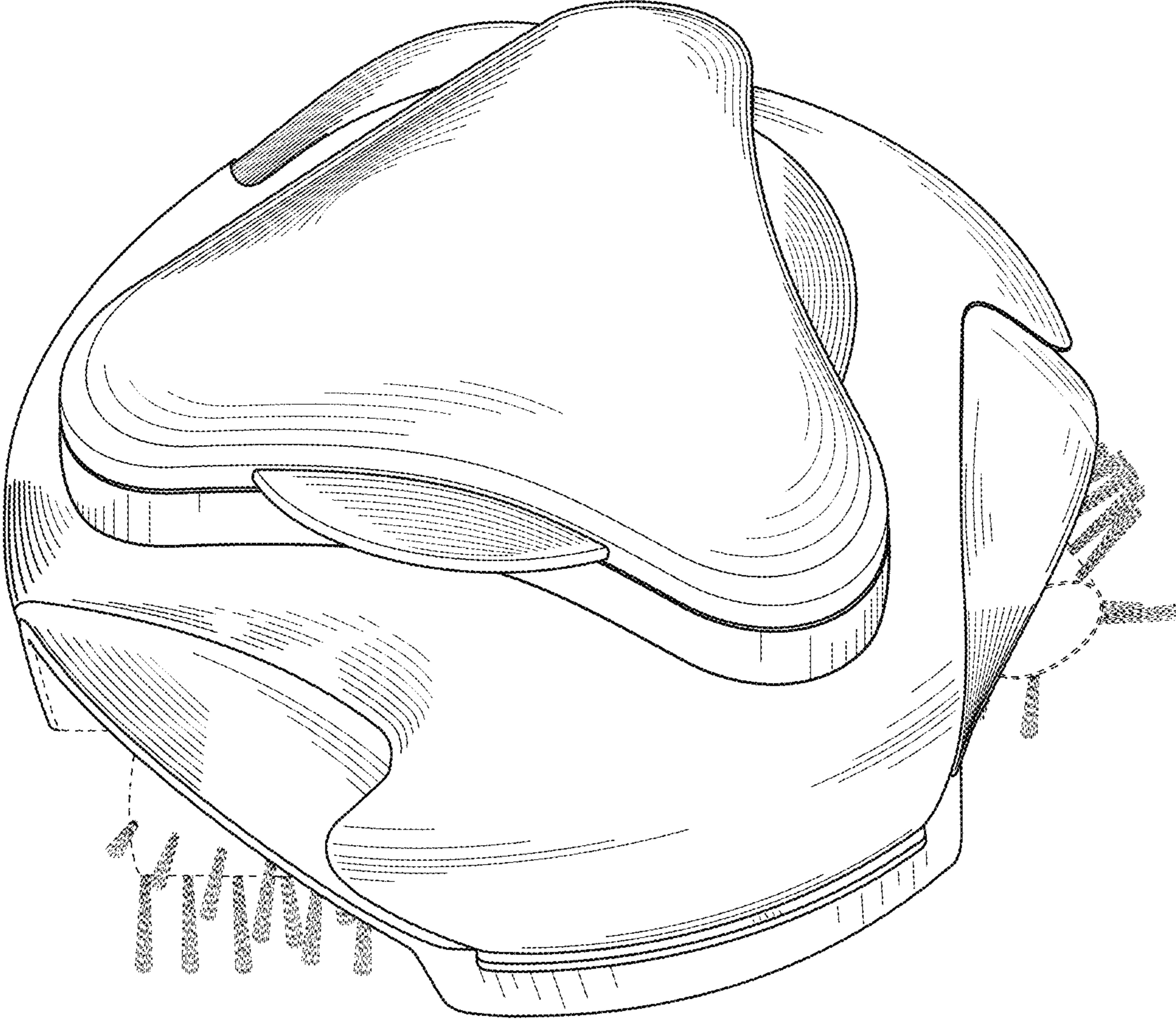

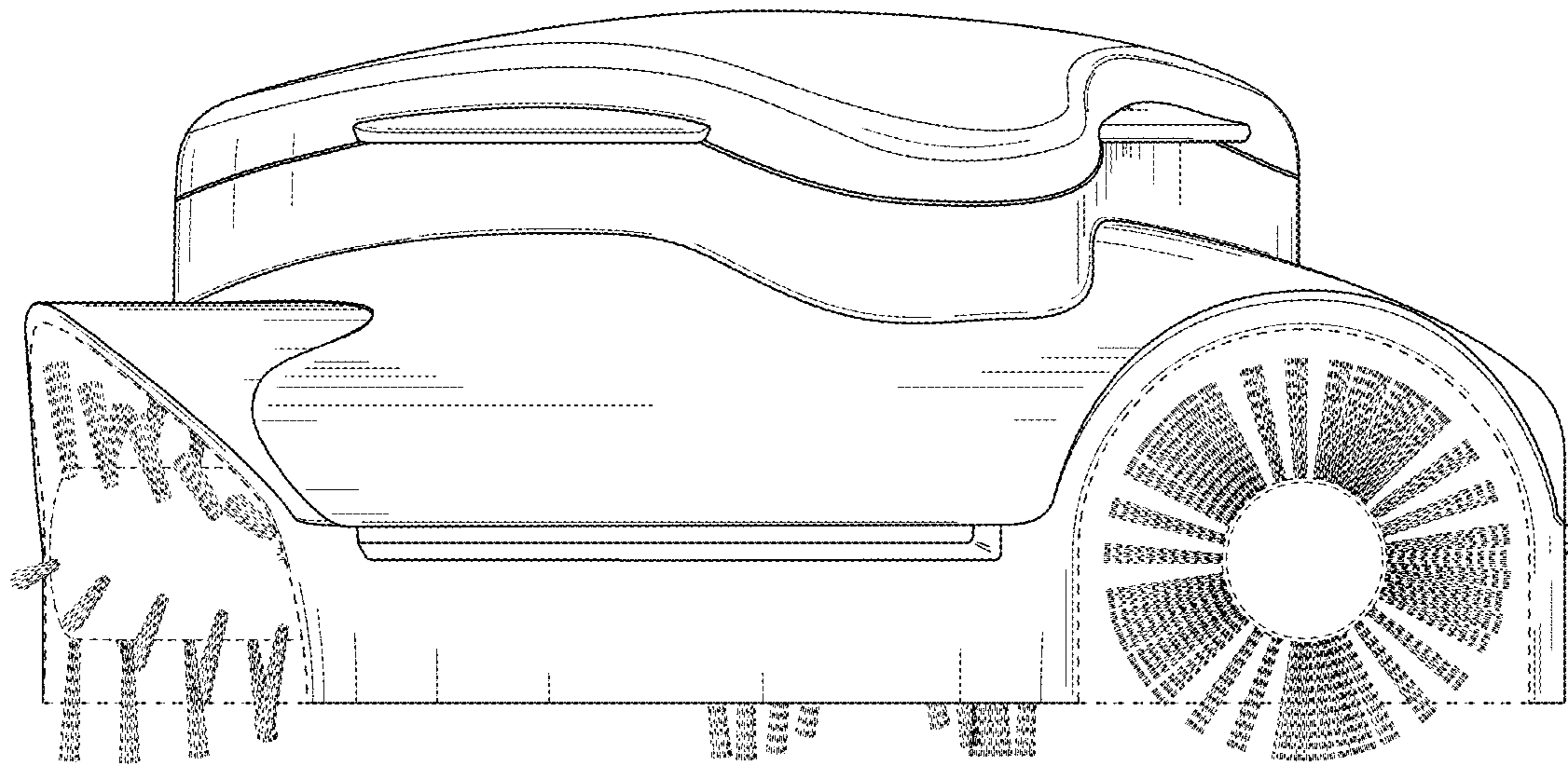

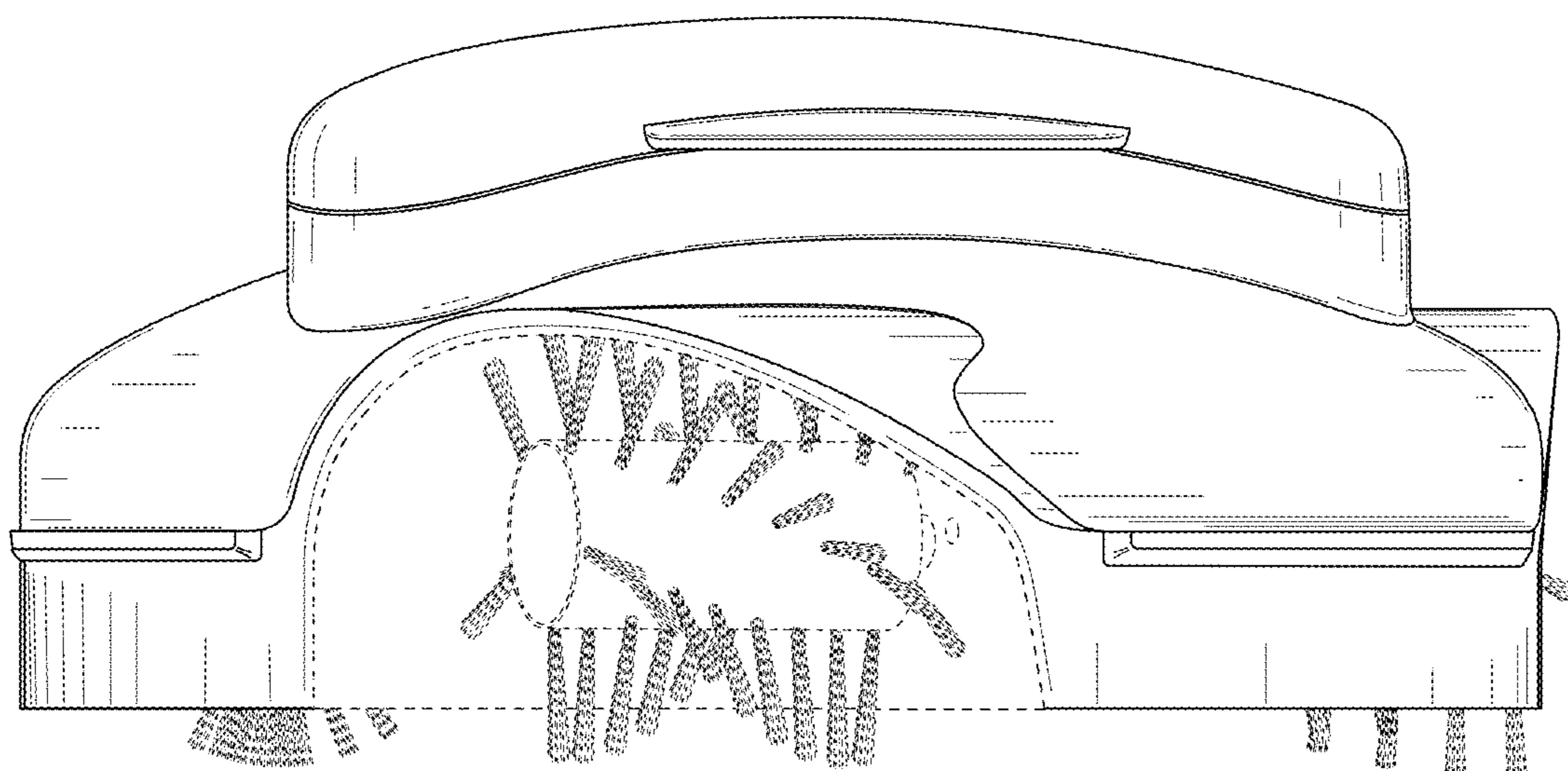

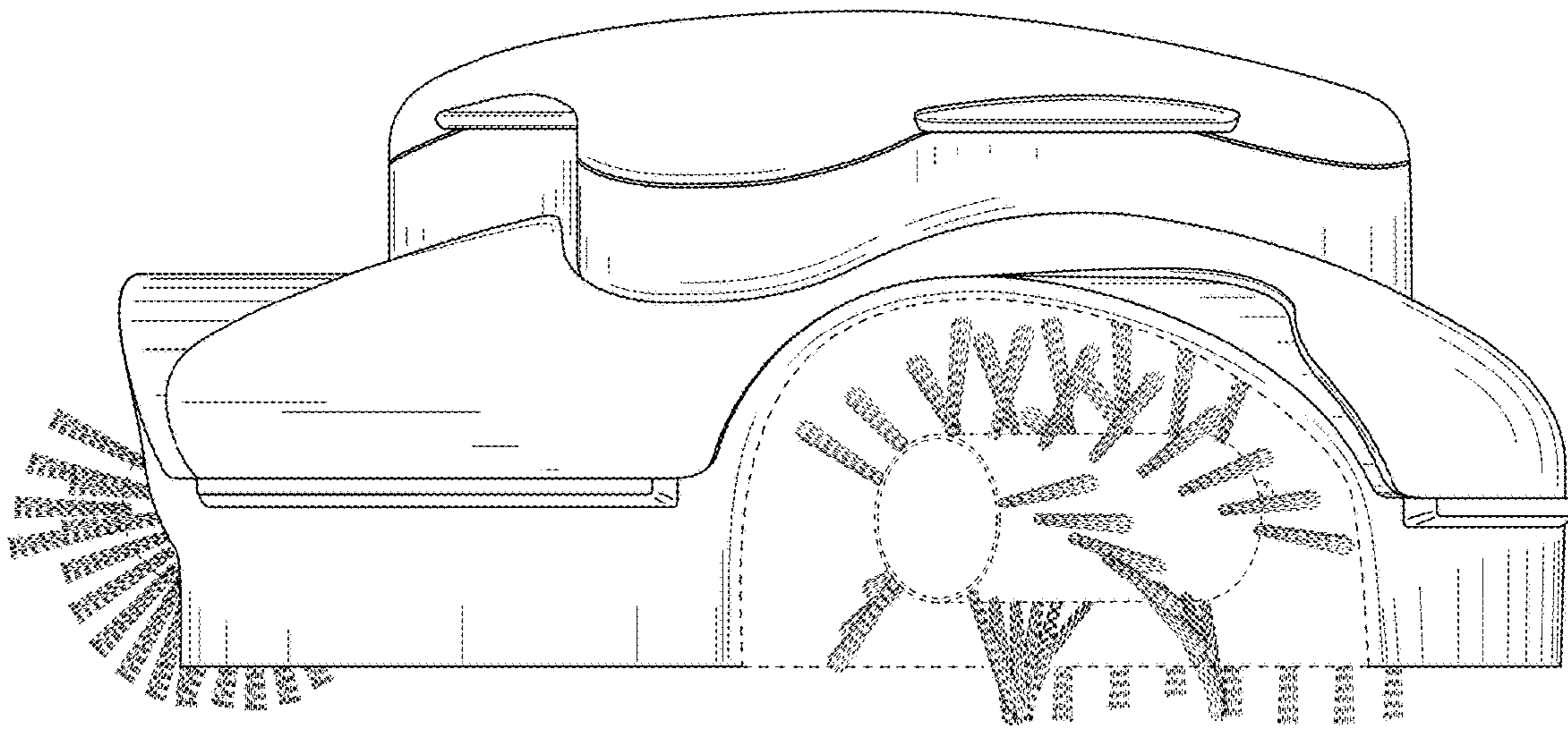

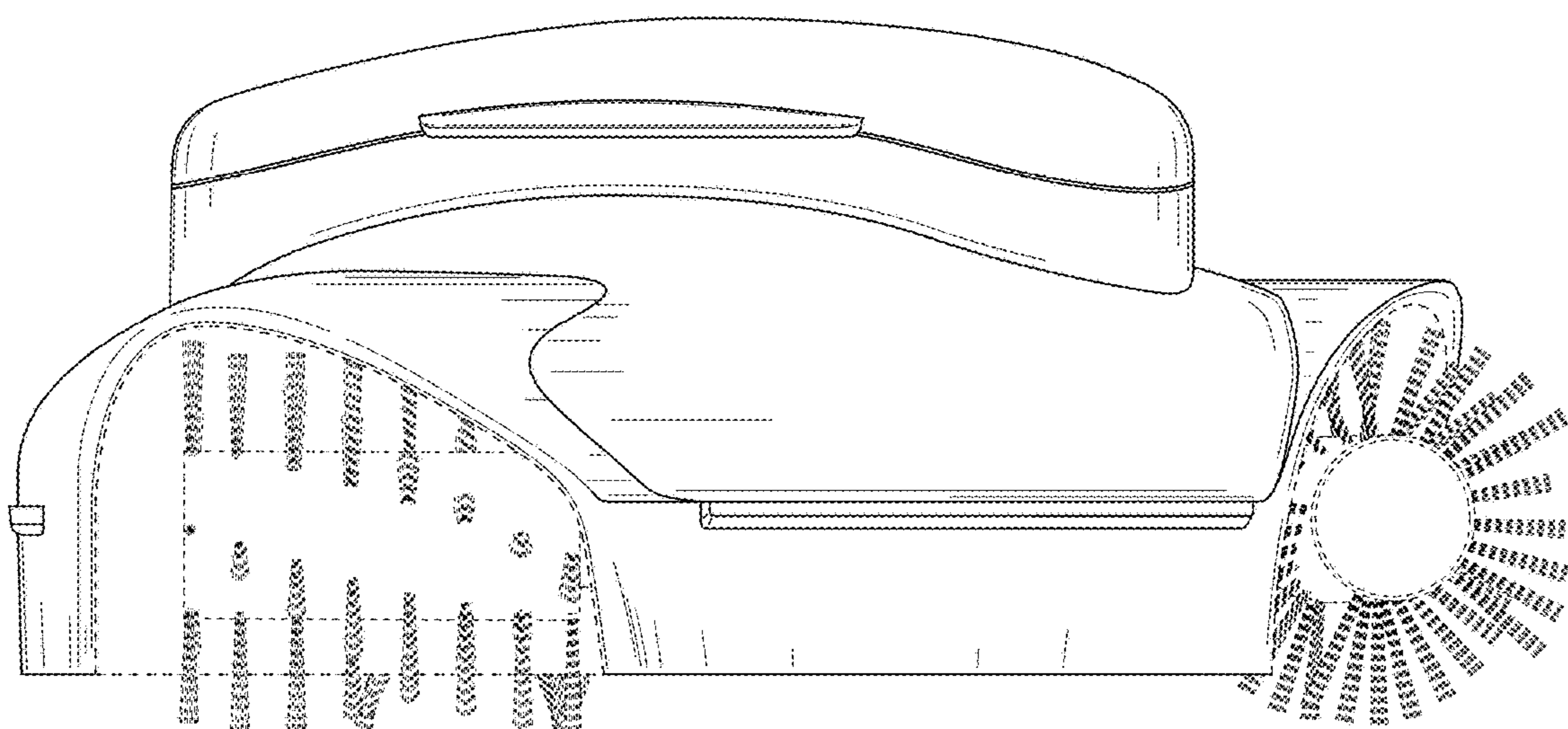

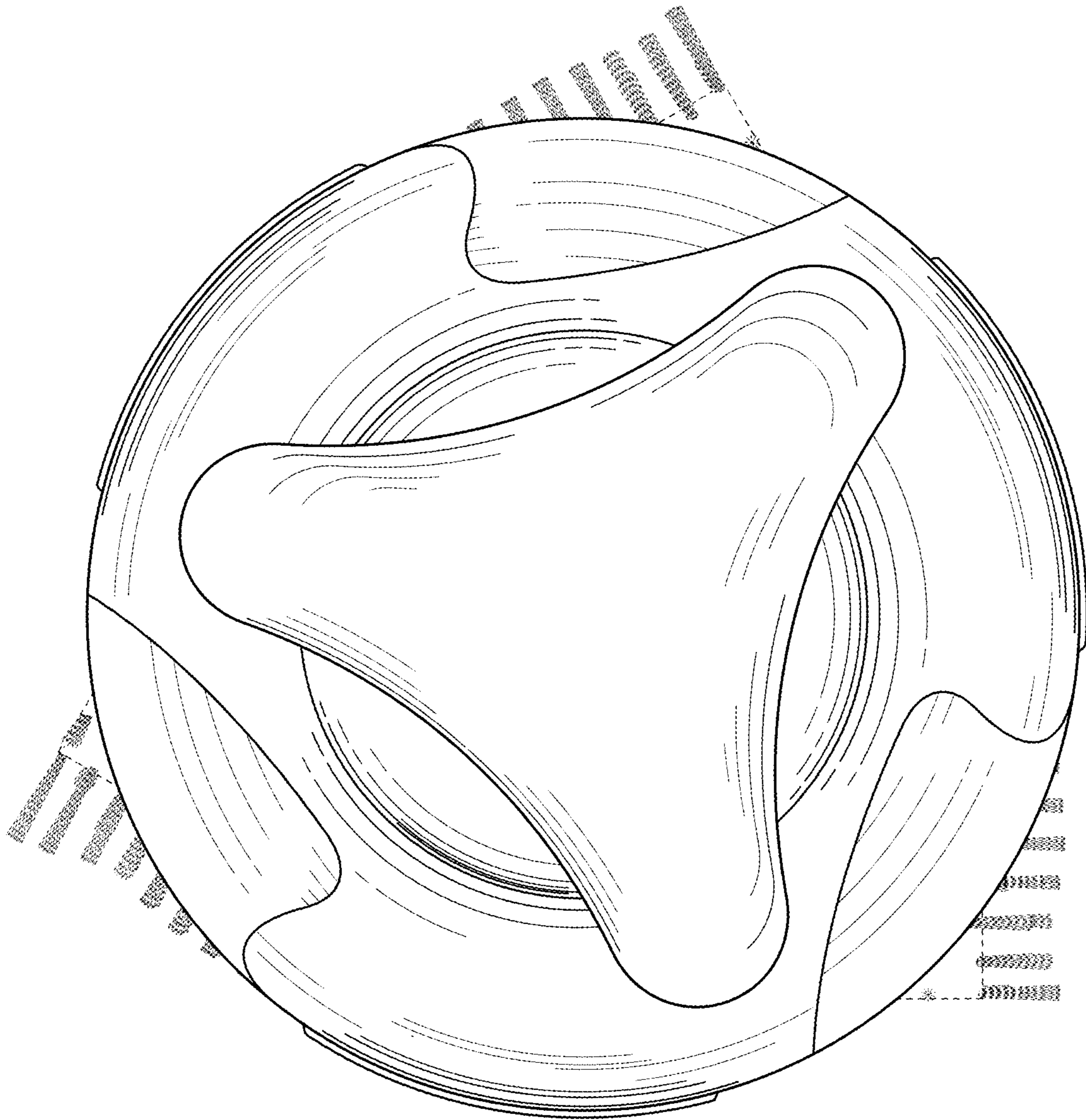
