DESCRIPTION

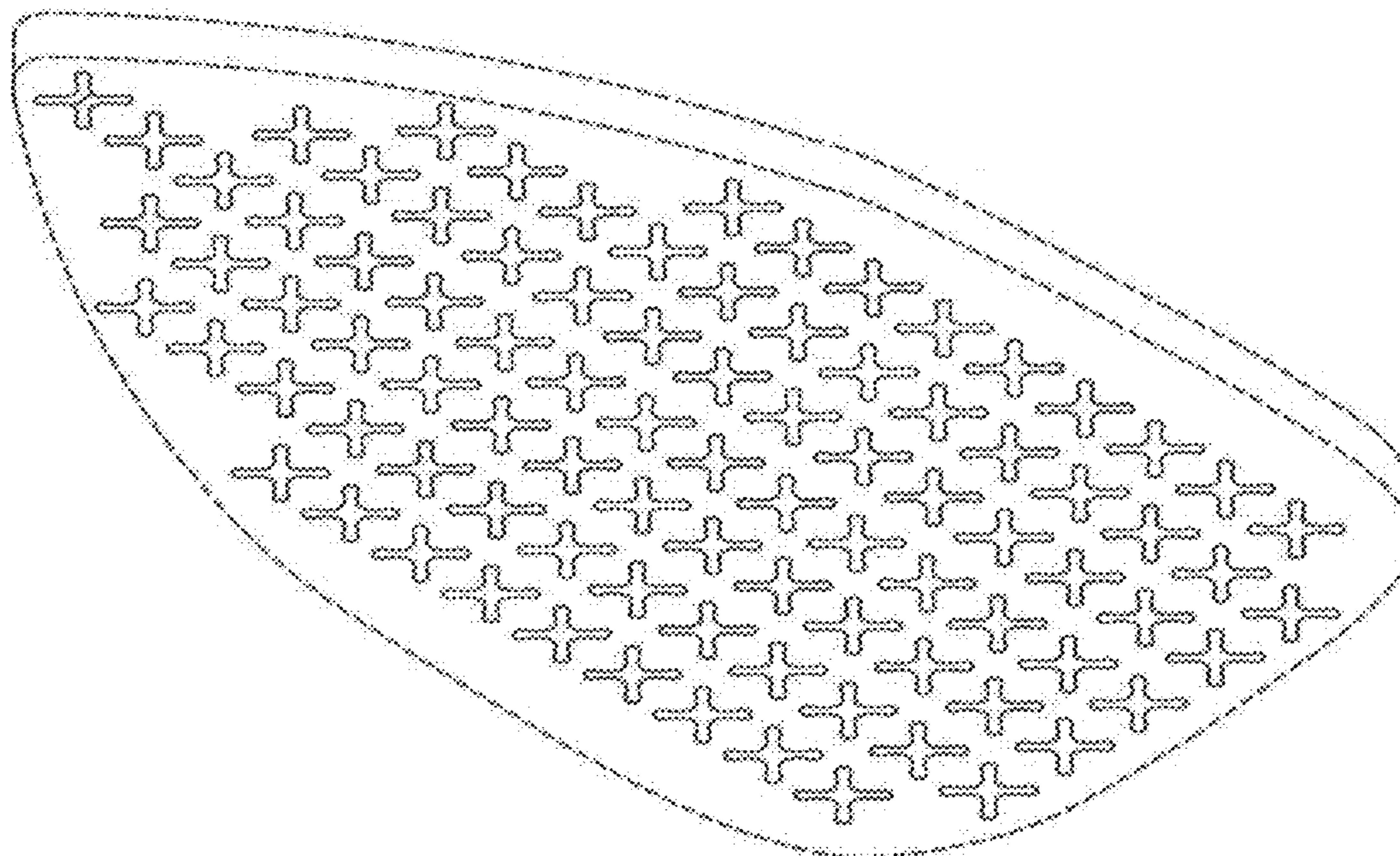
FIG. 1 is a bottom perspective view of a first embodiment of an iron soleplate;

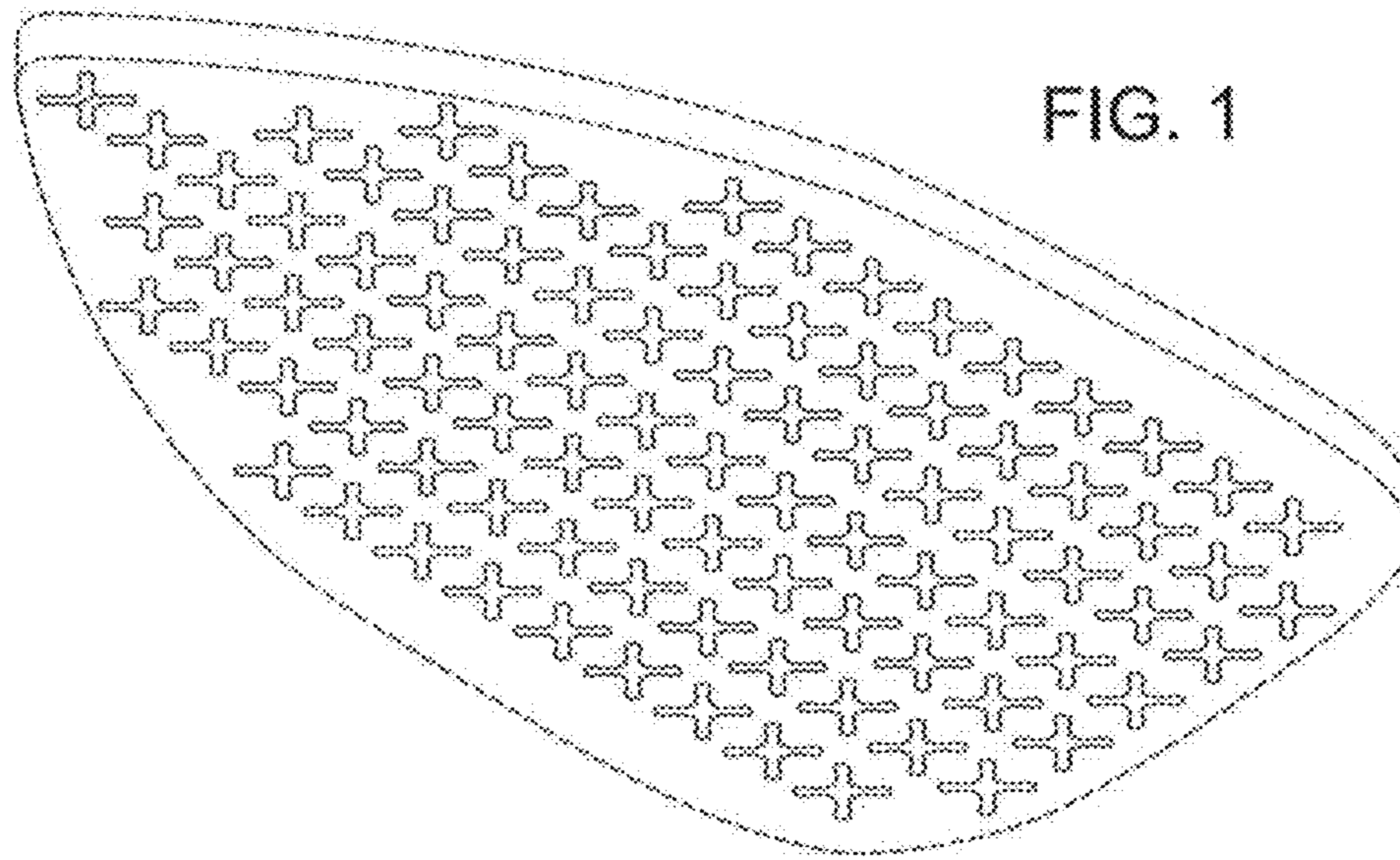

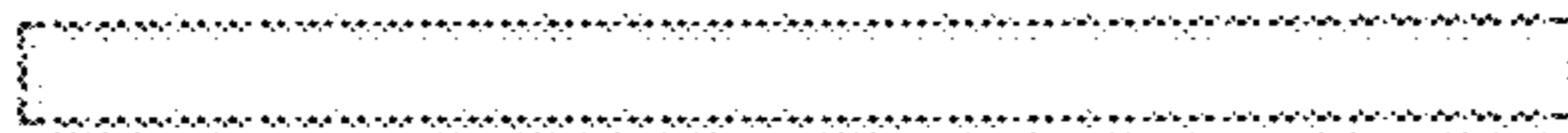

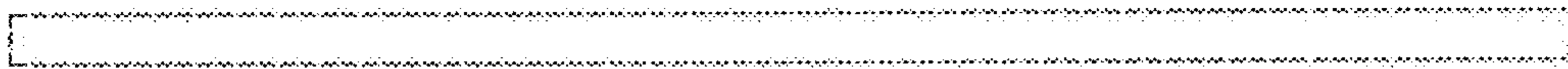
