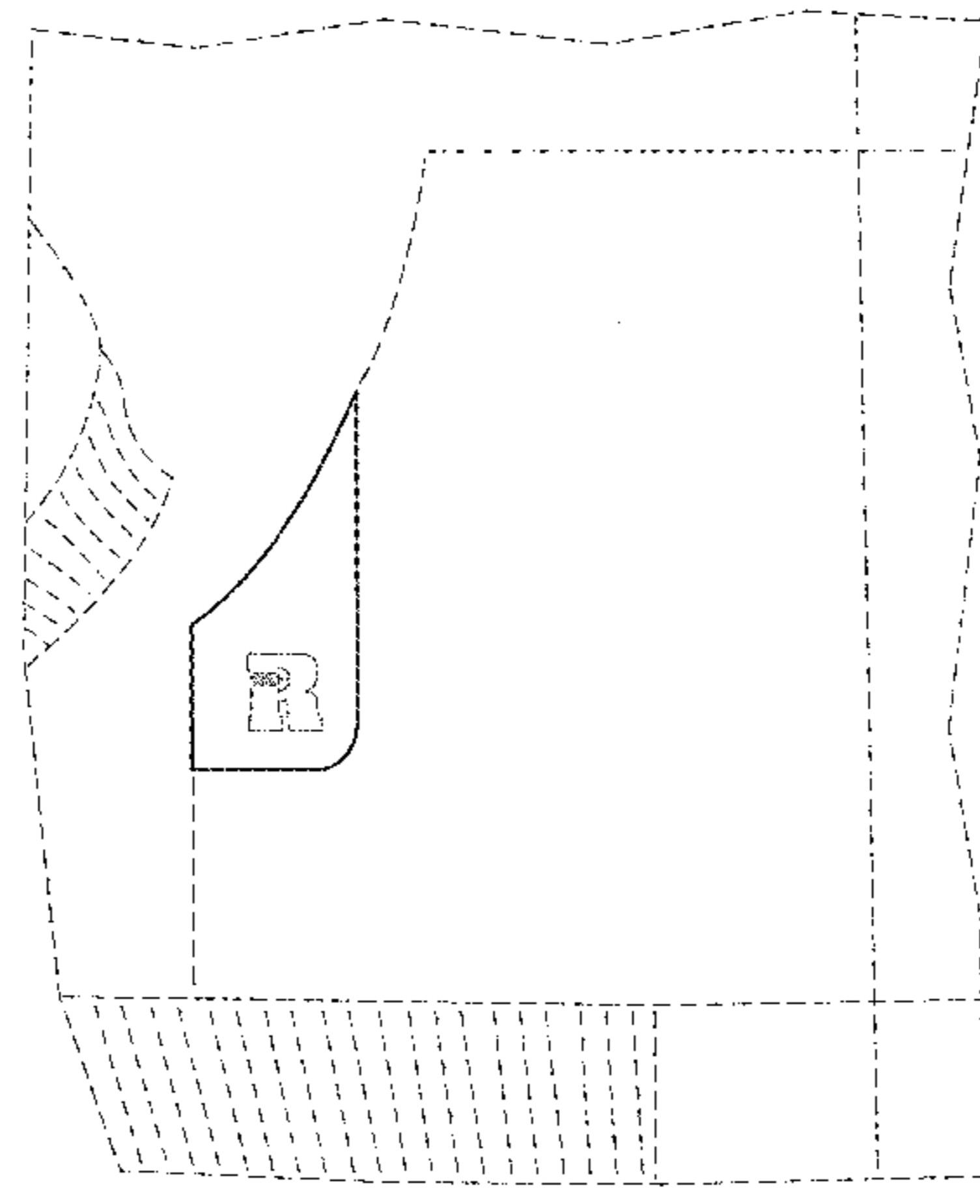
(57) **CLAIM**

The ornamental design for a jacket patch, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the jacket patch of the present invention disposed on an outer portion of a jacket; FIG. 2 is a side perspective view thereof, the opposite side unseen; and, FIG. 3 is another front view of the jacket patch of FIG. 1. The dash-dot broken line showing a portion of a patch is included for the purpose of illustrating portions of the article and forms no part of the claimed design. The dashed broken

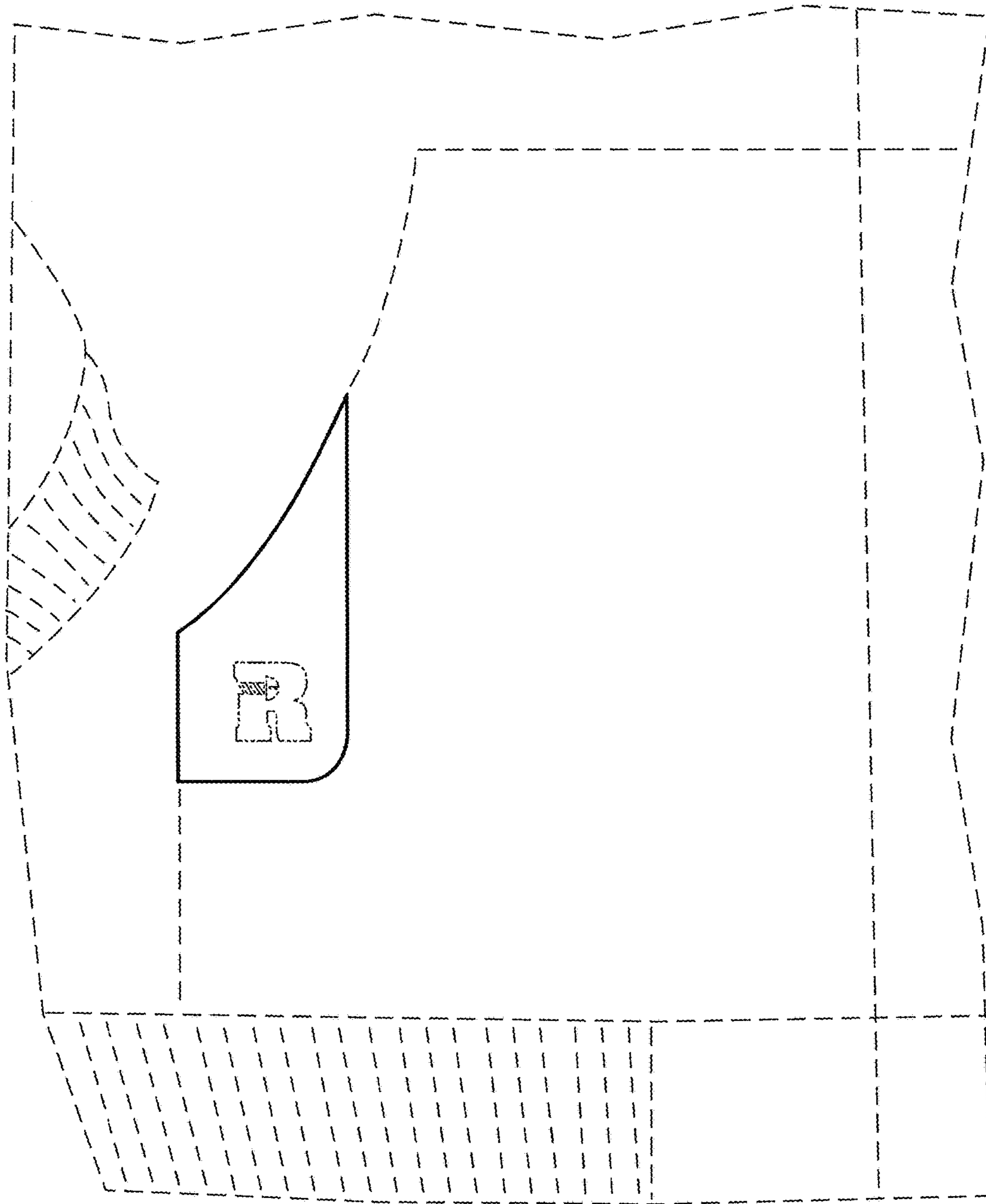

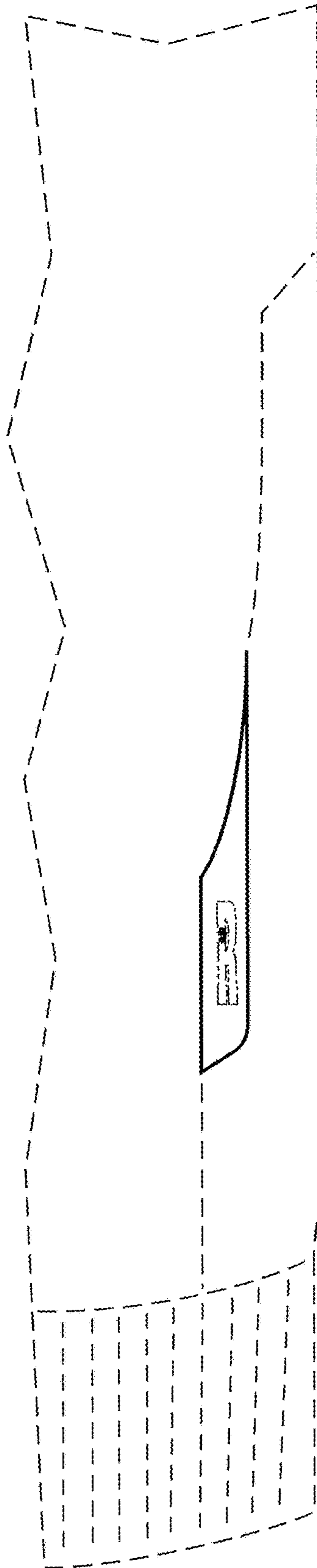

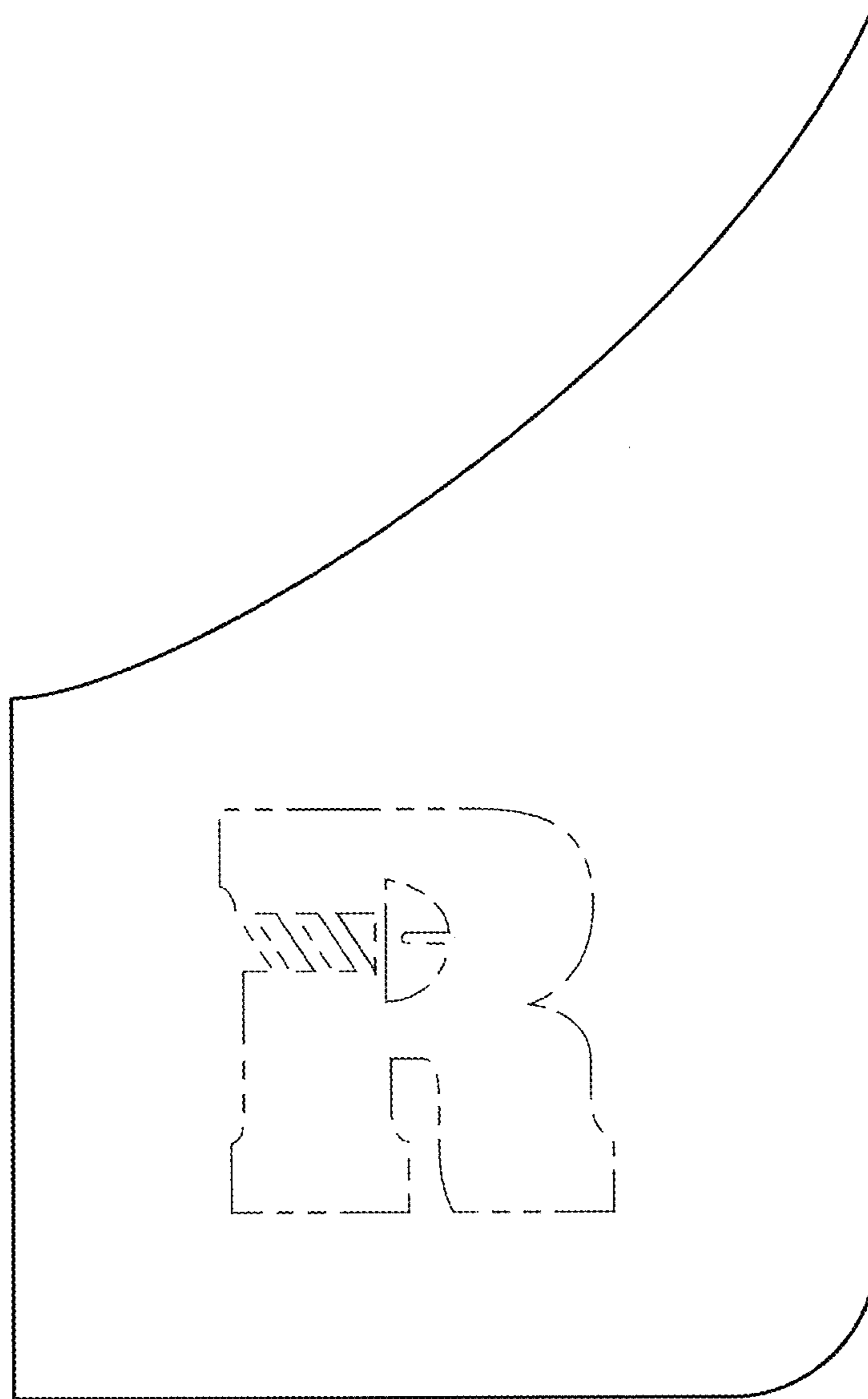
