DESCRIPTION

FIG. 1 is a front view of an article of clothing showing our new design thereof;

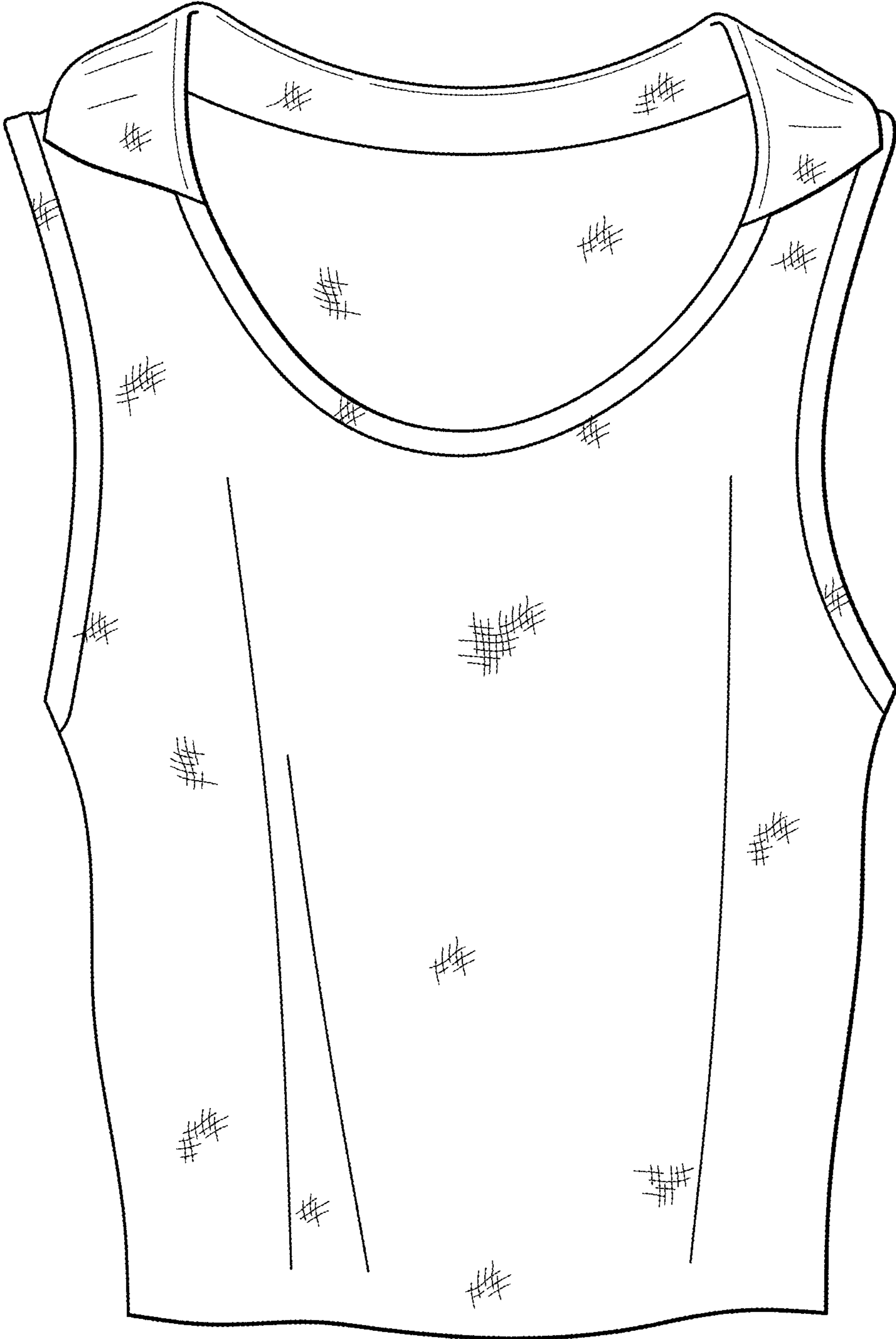

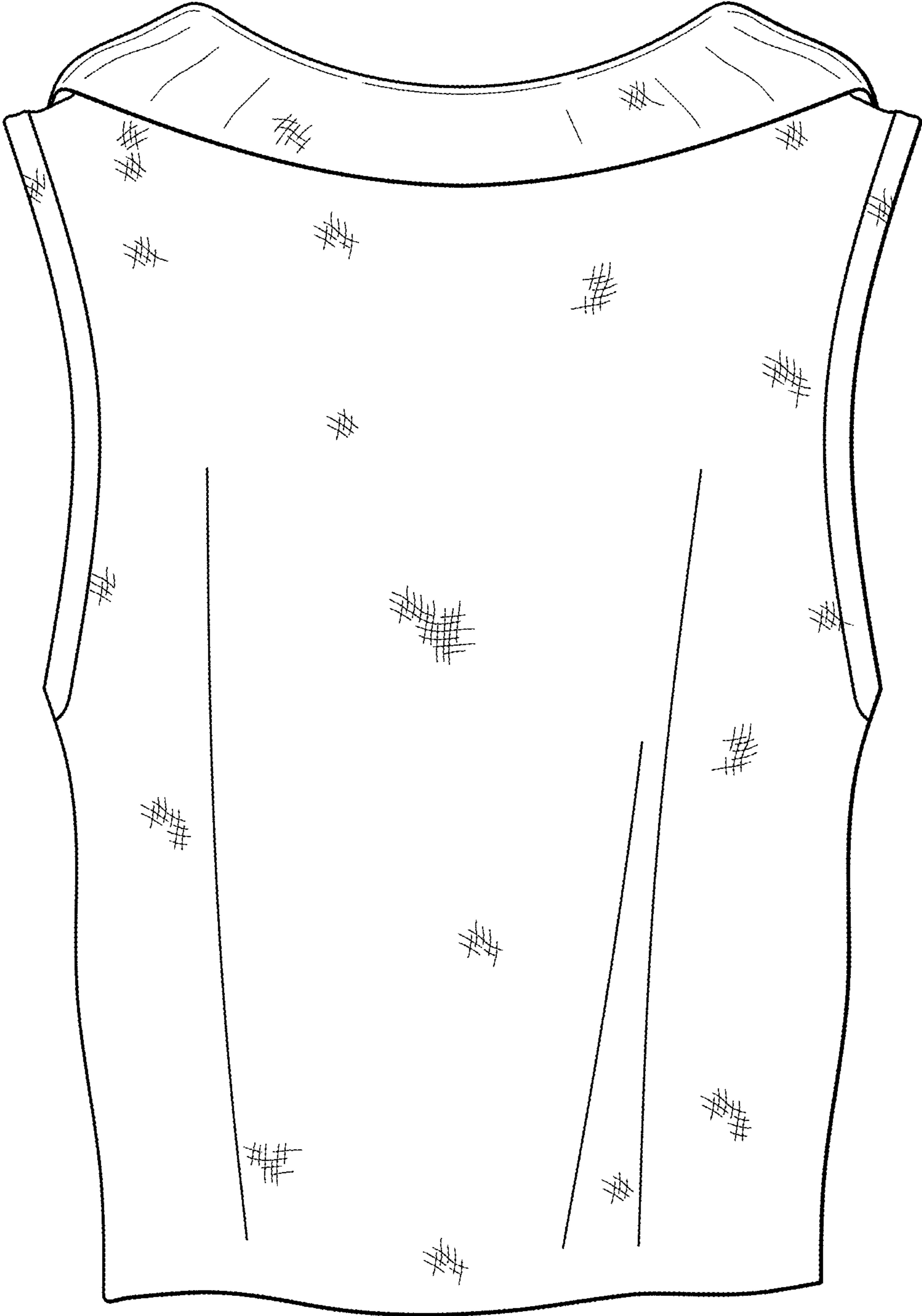

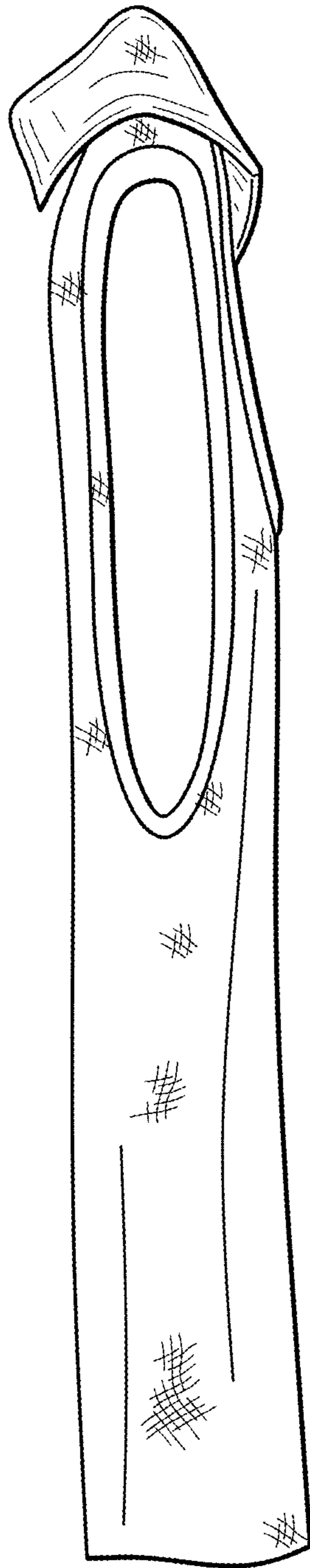
