The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

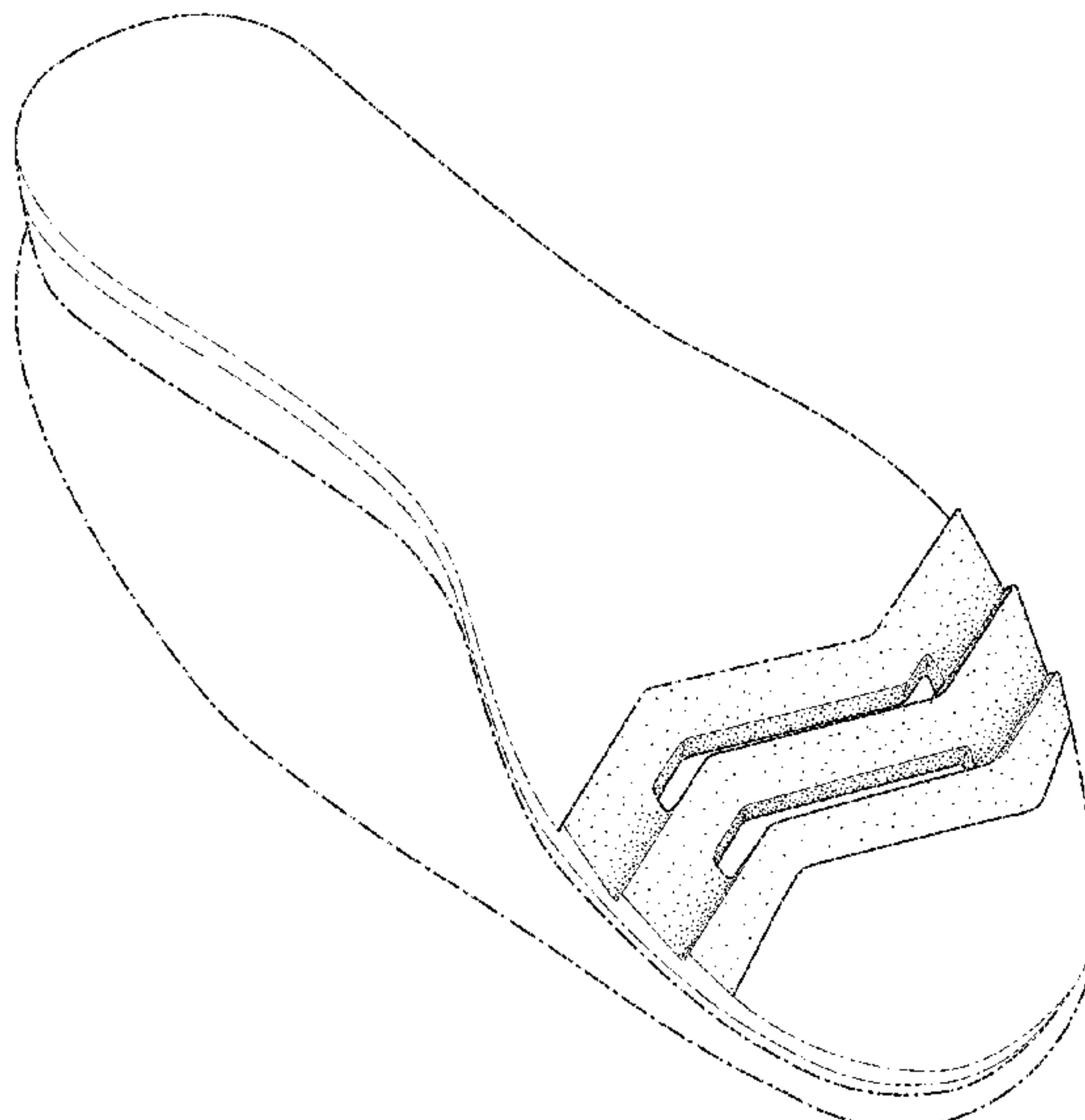
FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 2 is a bottom view thereof; and,

FIG. 3 is a rear perspective view thereof.

The broken lines immediately adjacent to the shaded area represent the bounds of the claimed design, and form no part thereof. The two unshaded regions within the shaded area form no part of the claimed design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

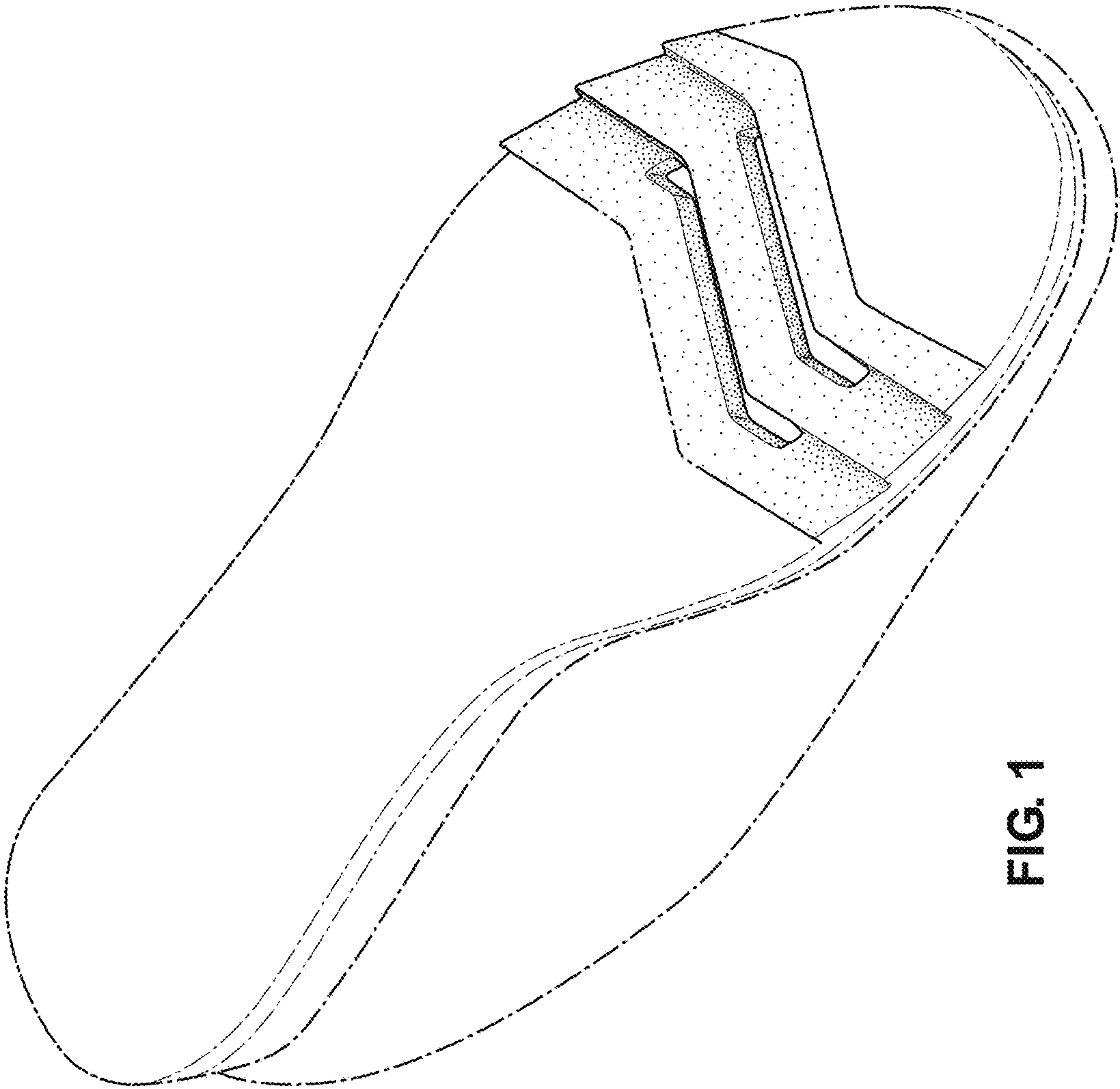

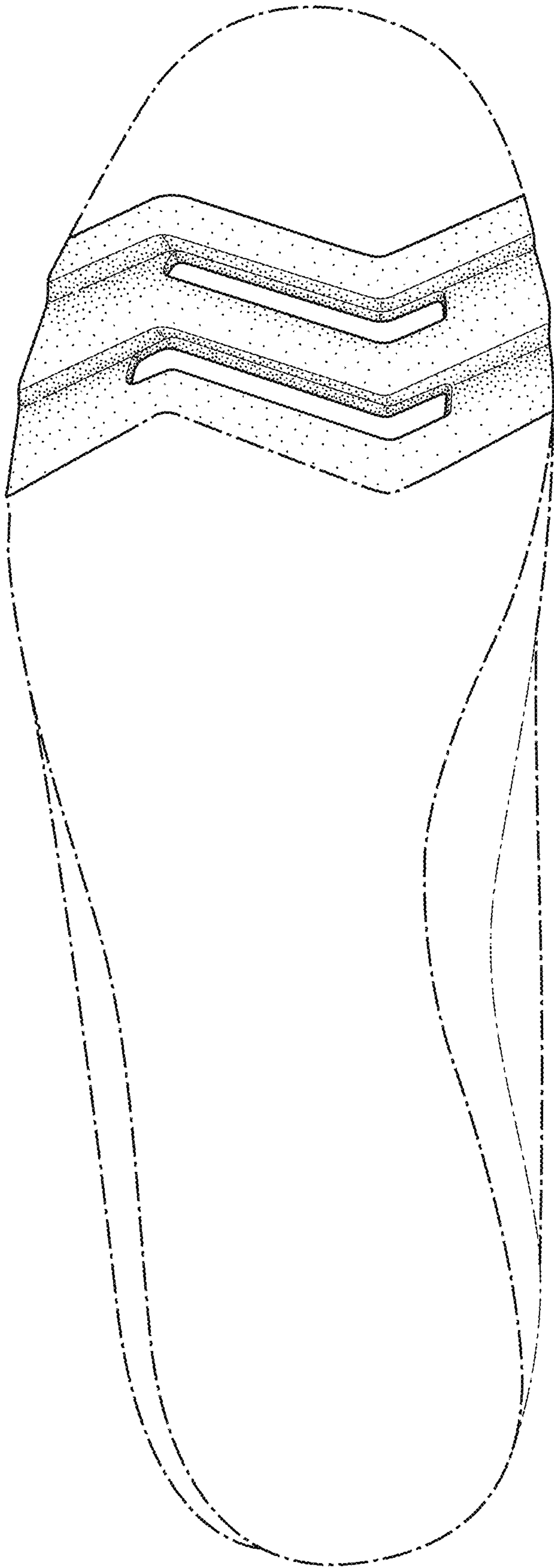

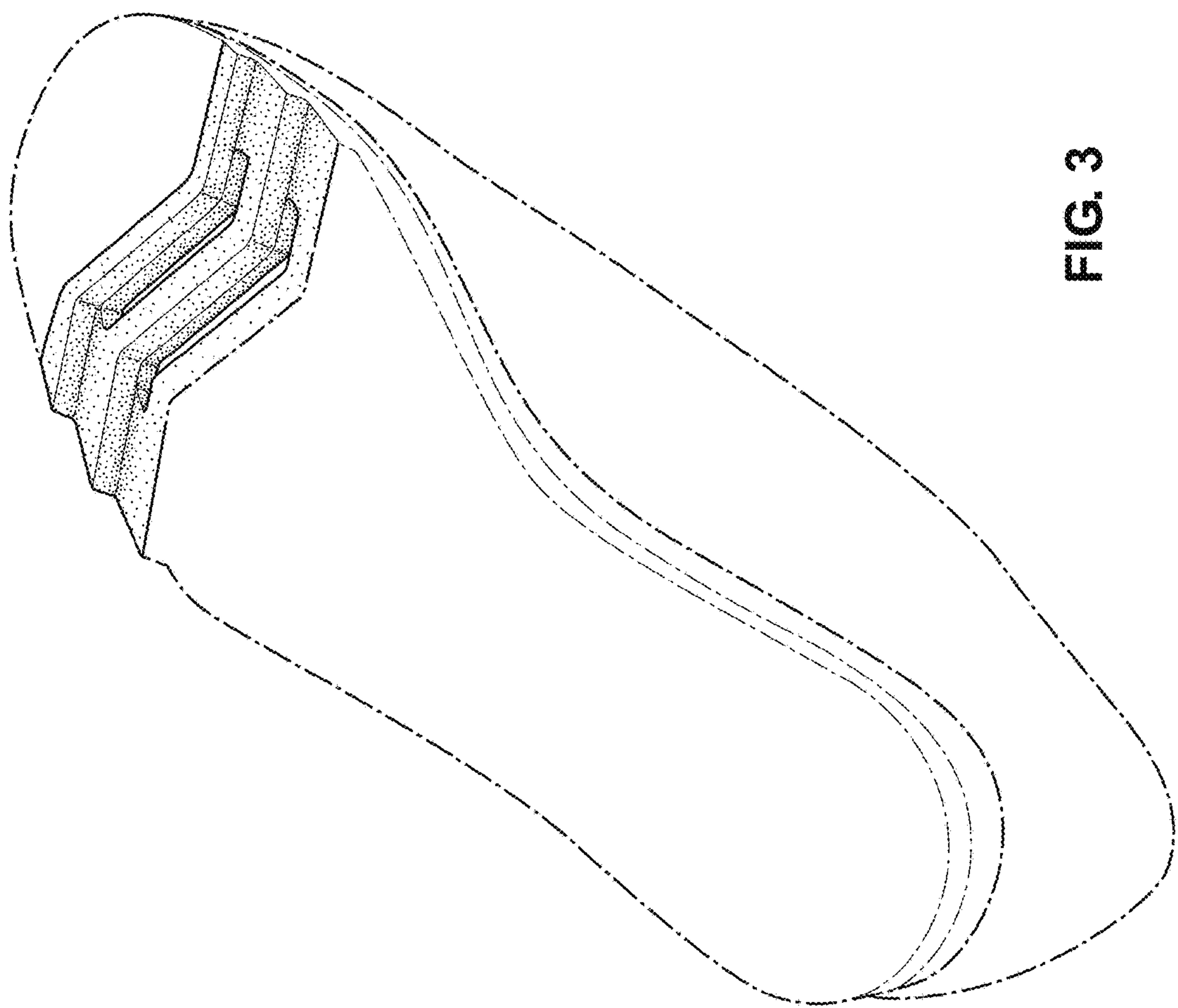
