The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

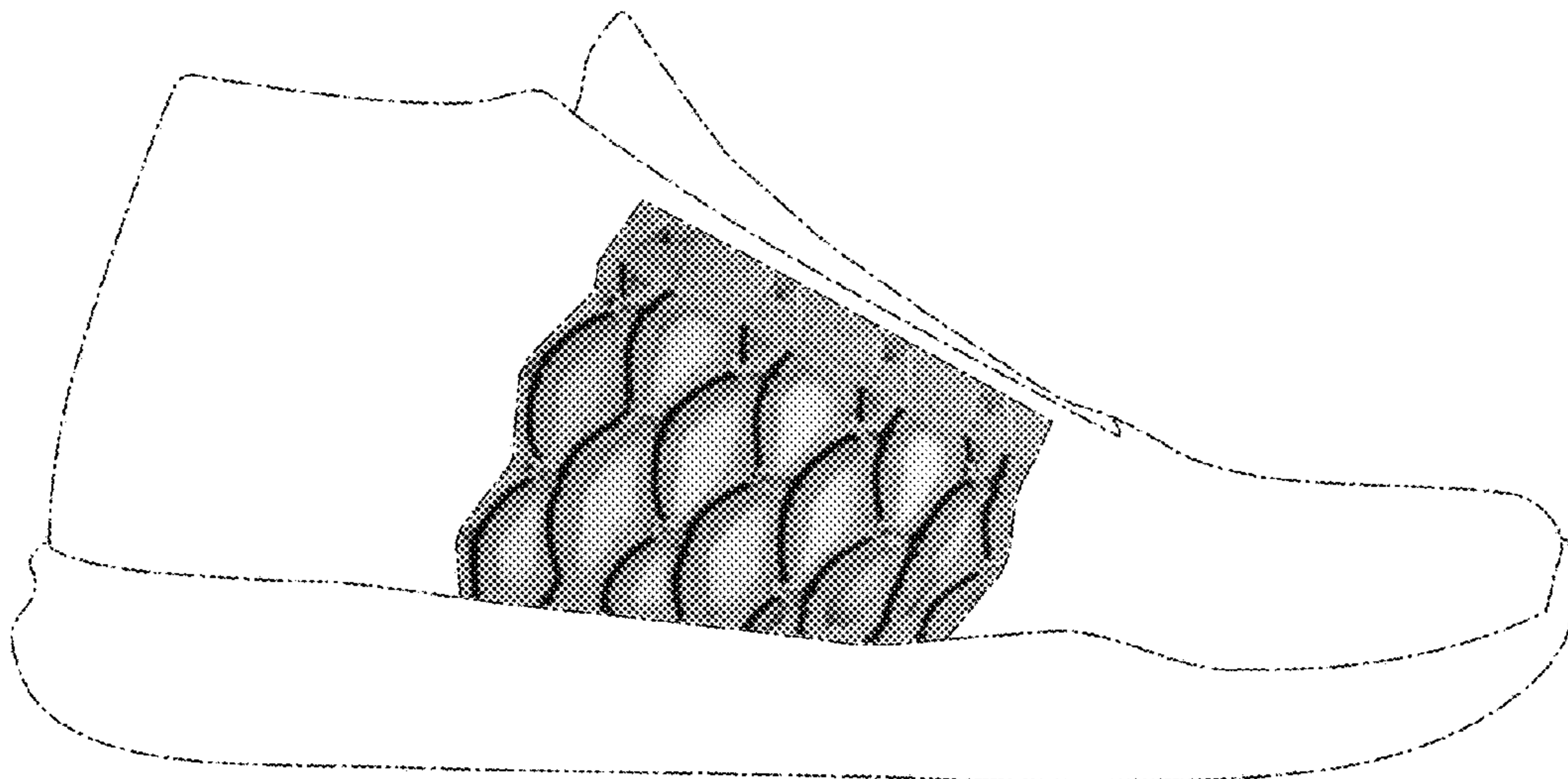
FIG. 1 is a front perspective view of a shoe upper showing our new design;

FIG. 2 is a side view thereof; and,

FIG. 3 is a rear perspective view thereof.

The photographic area is claimed. The broken line immediately adjacent to the photographic area represents an unclaimed peripheral boundary of the design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

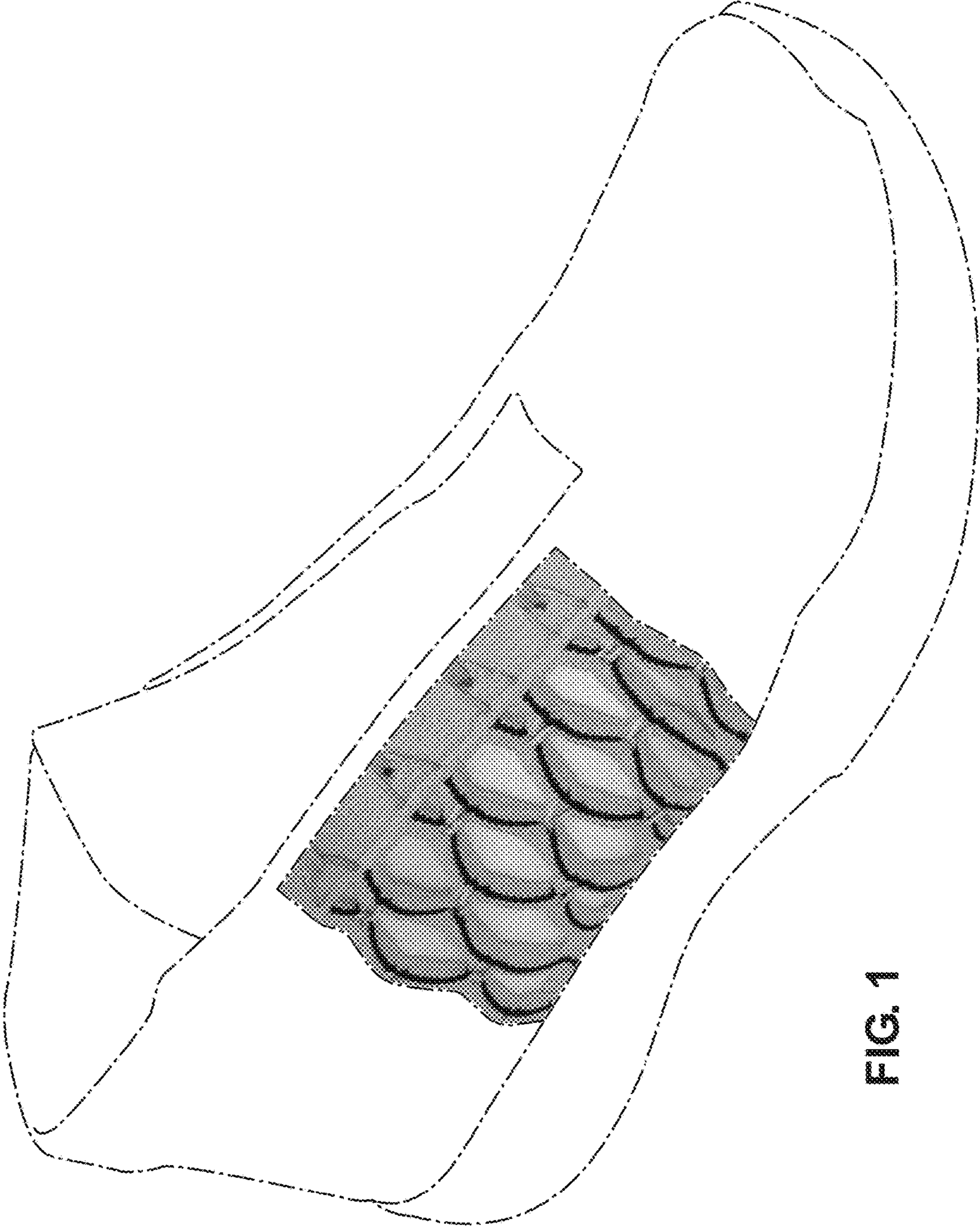

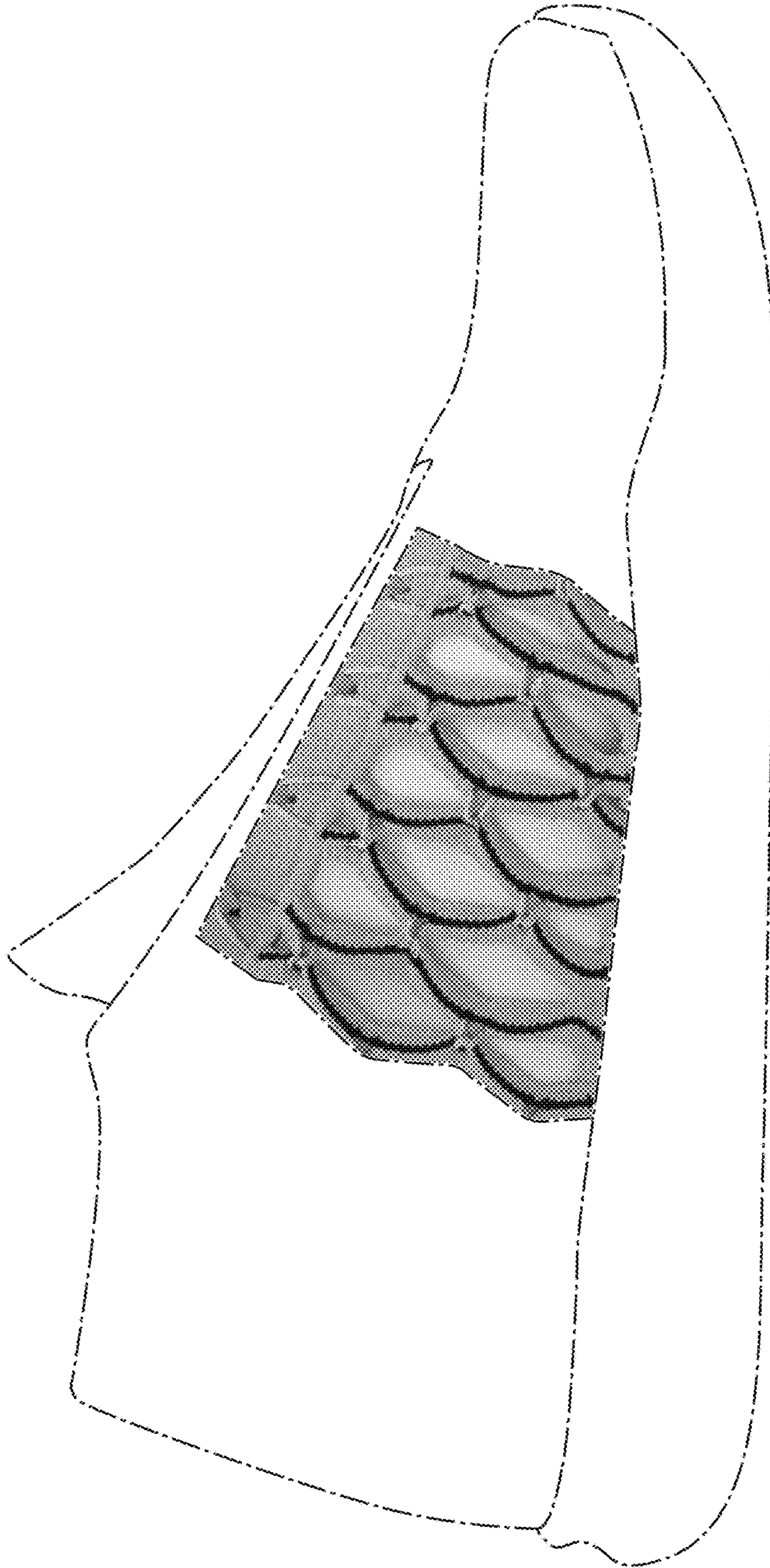

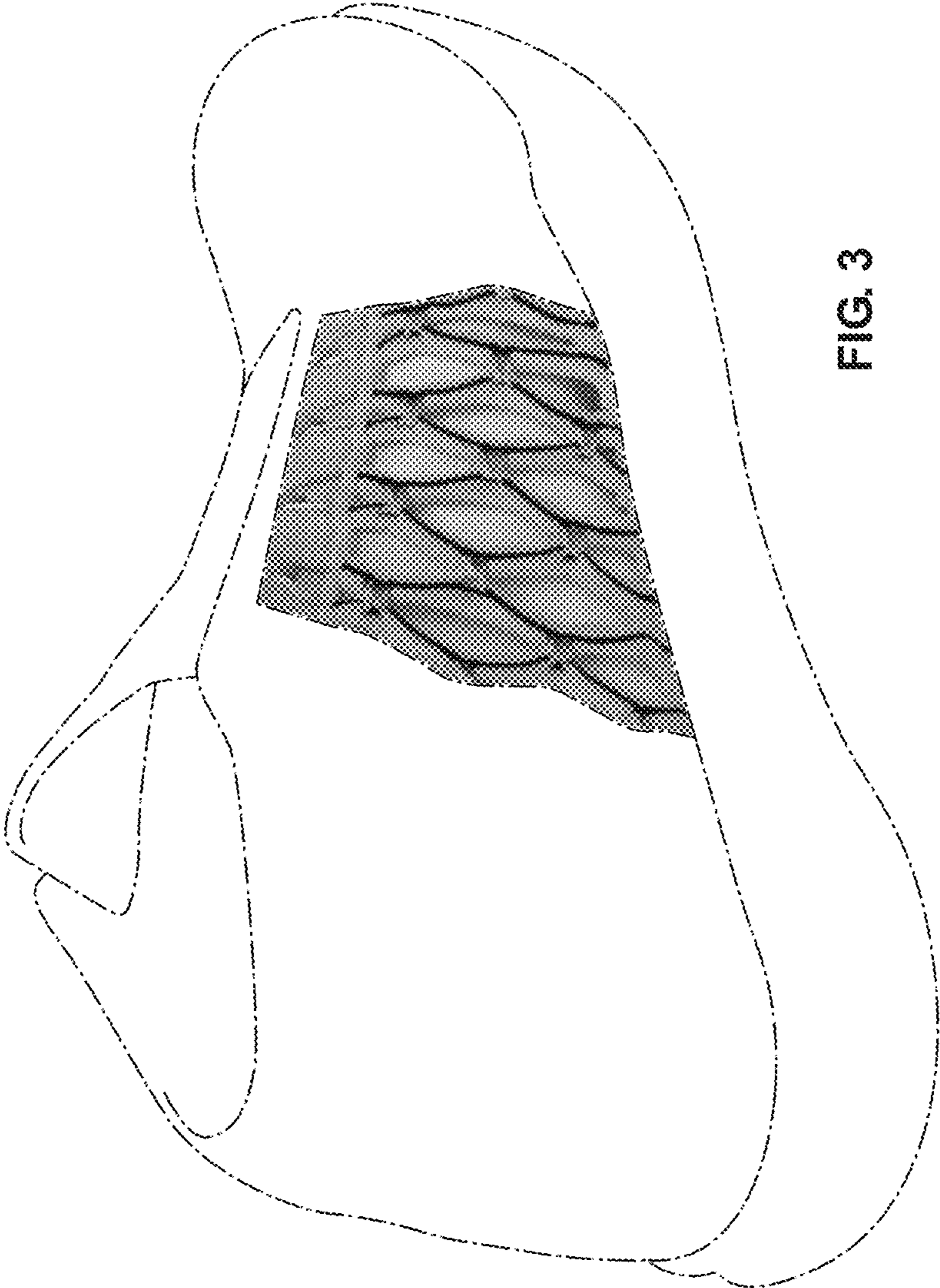
