DESCRIPTION

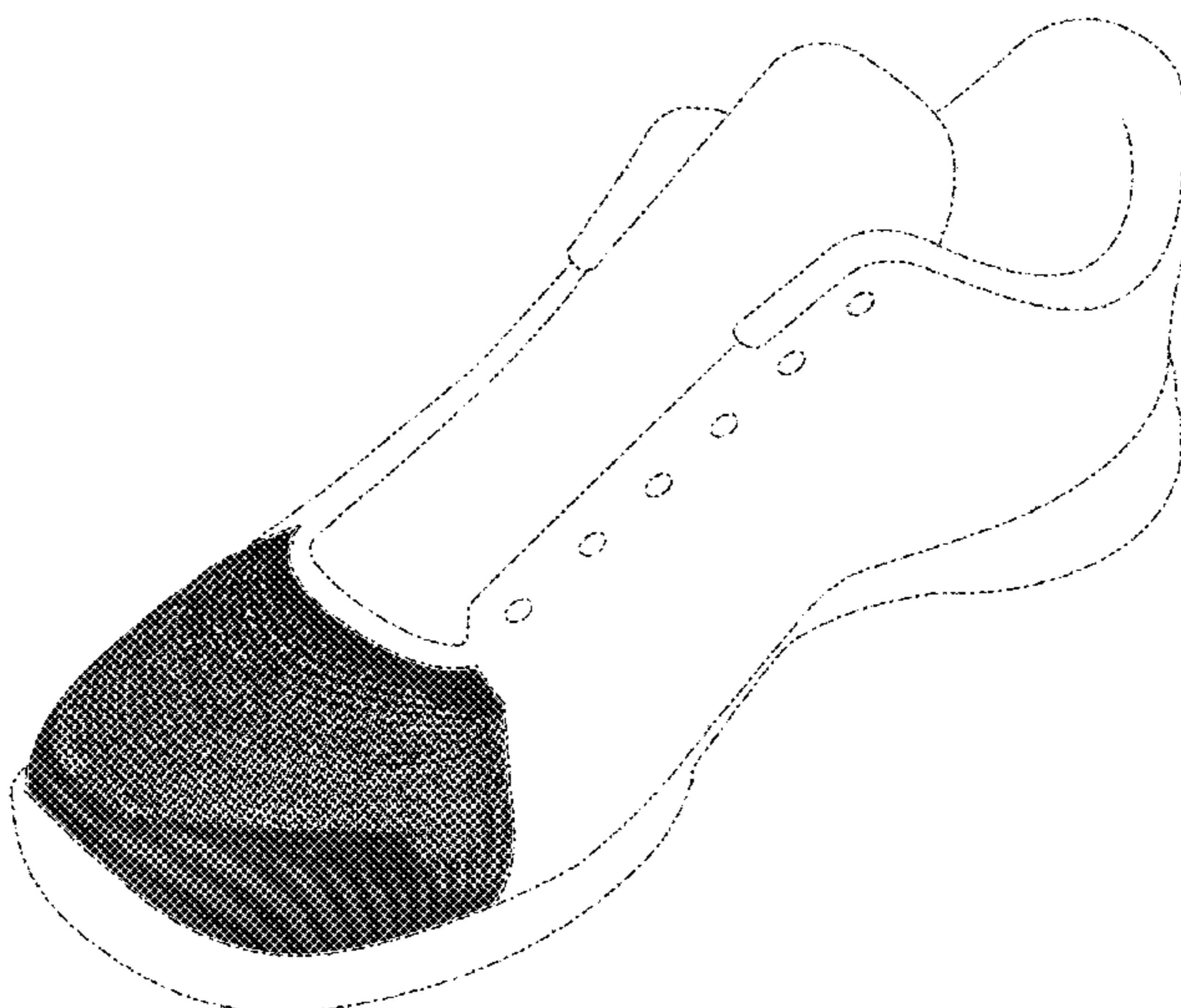
FIG. 1 is a left front perspective view of a shoe upper showing my new design;

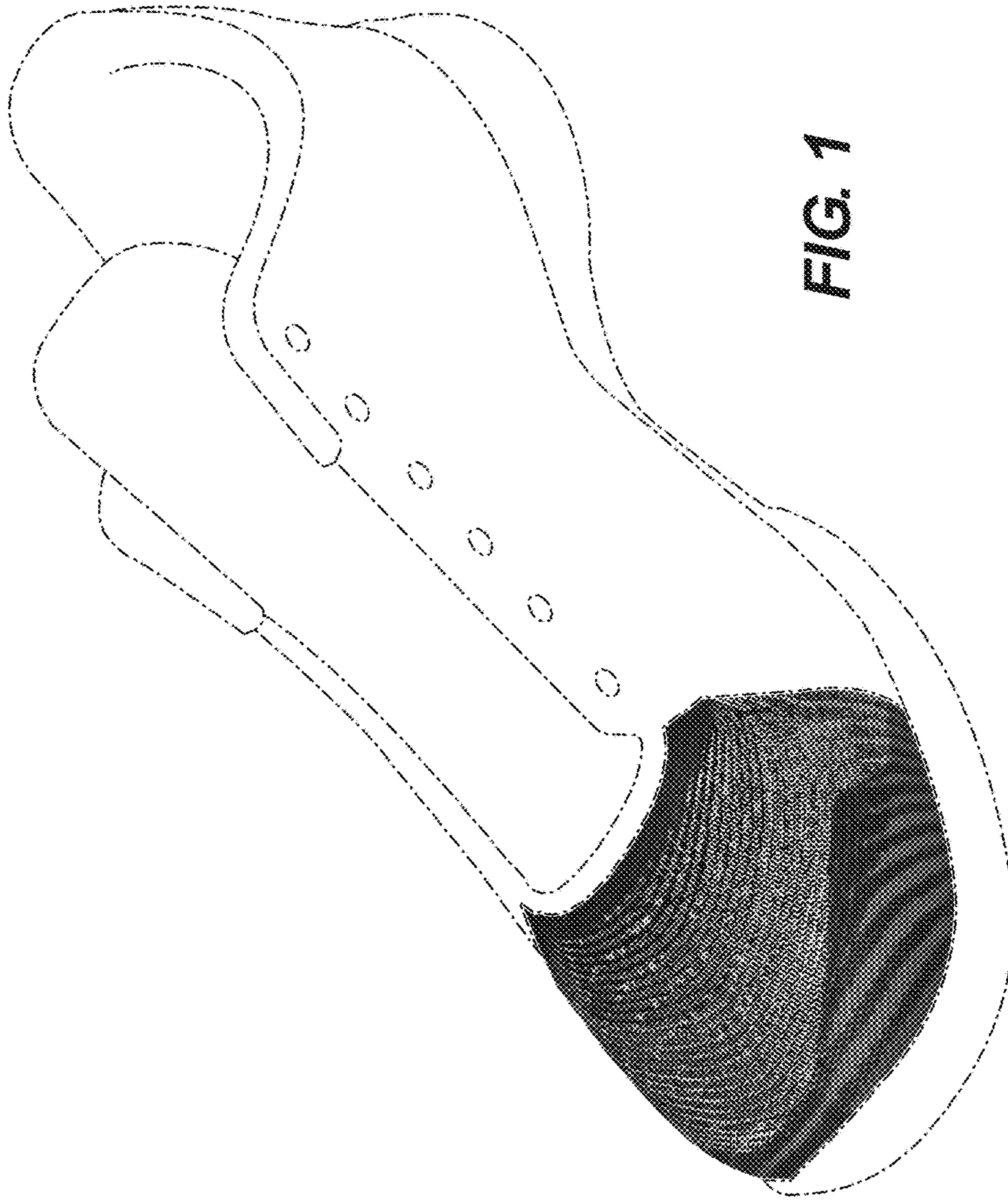

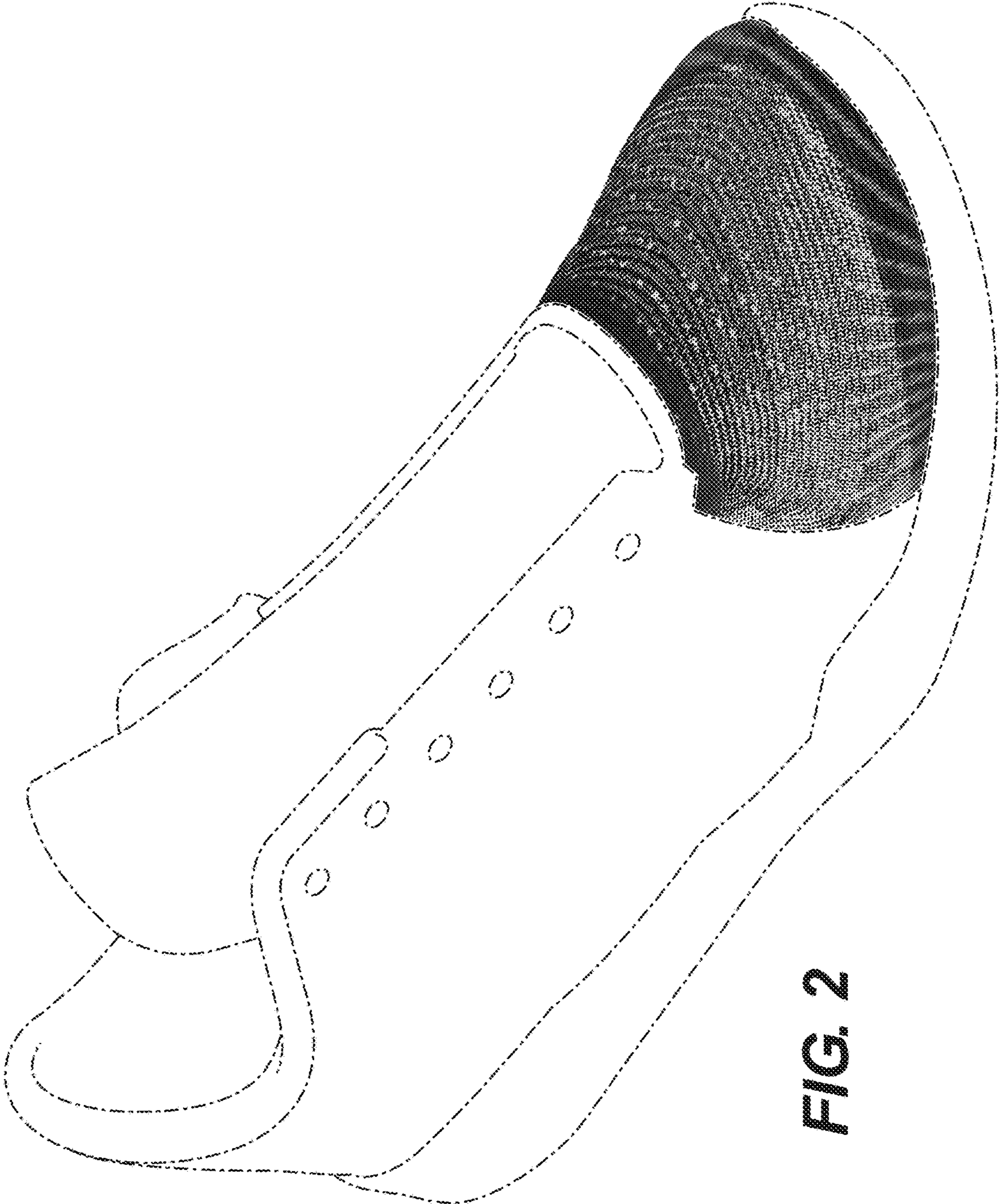

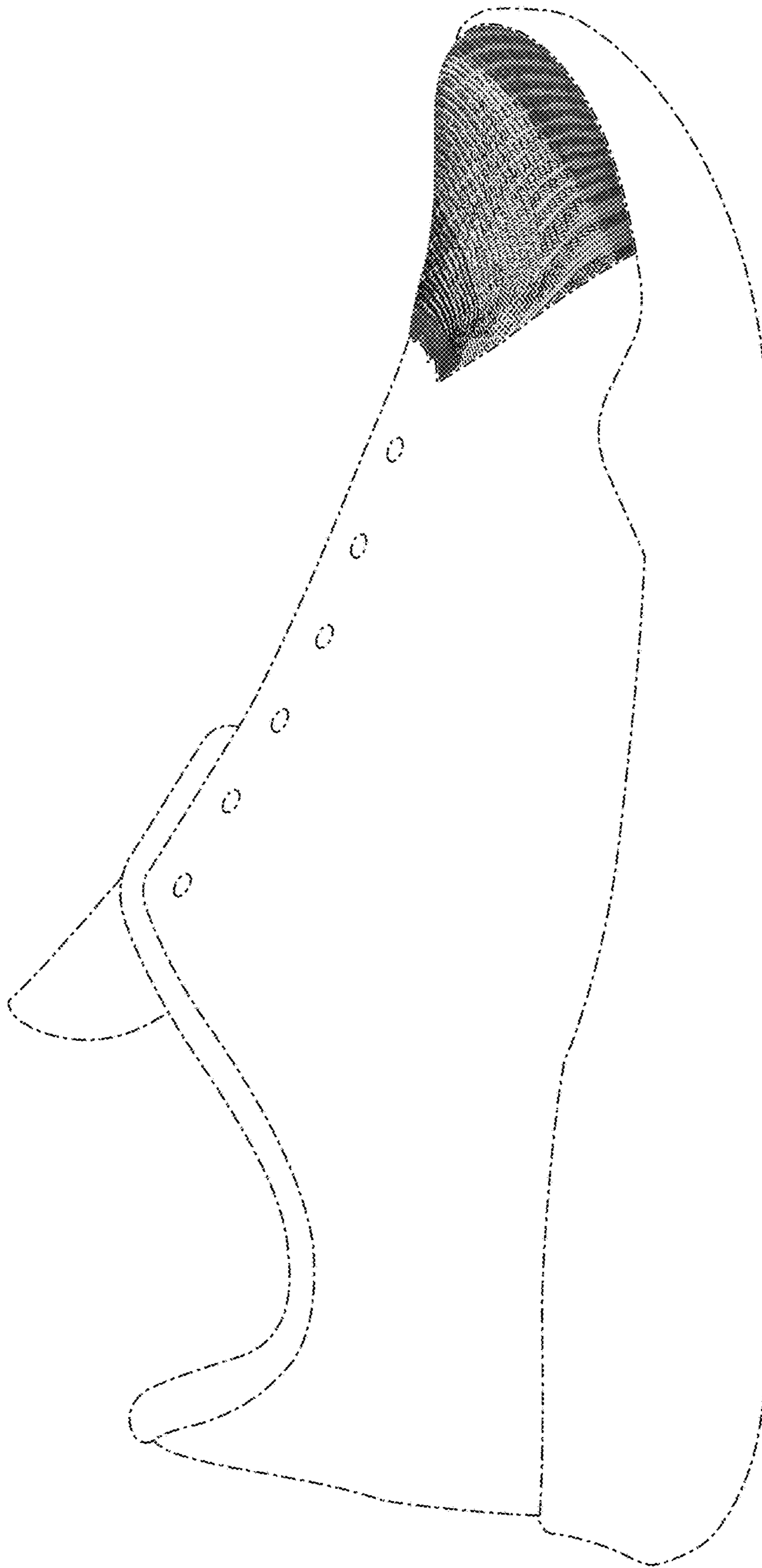

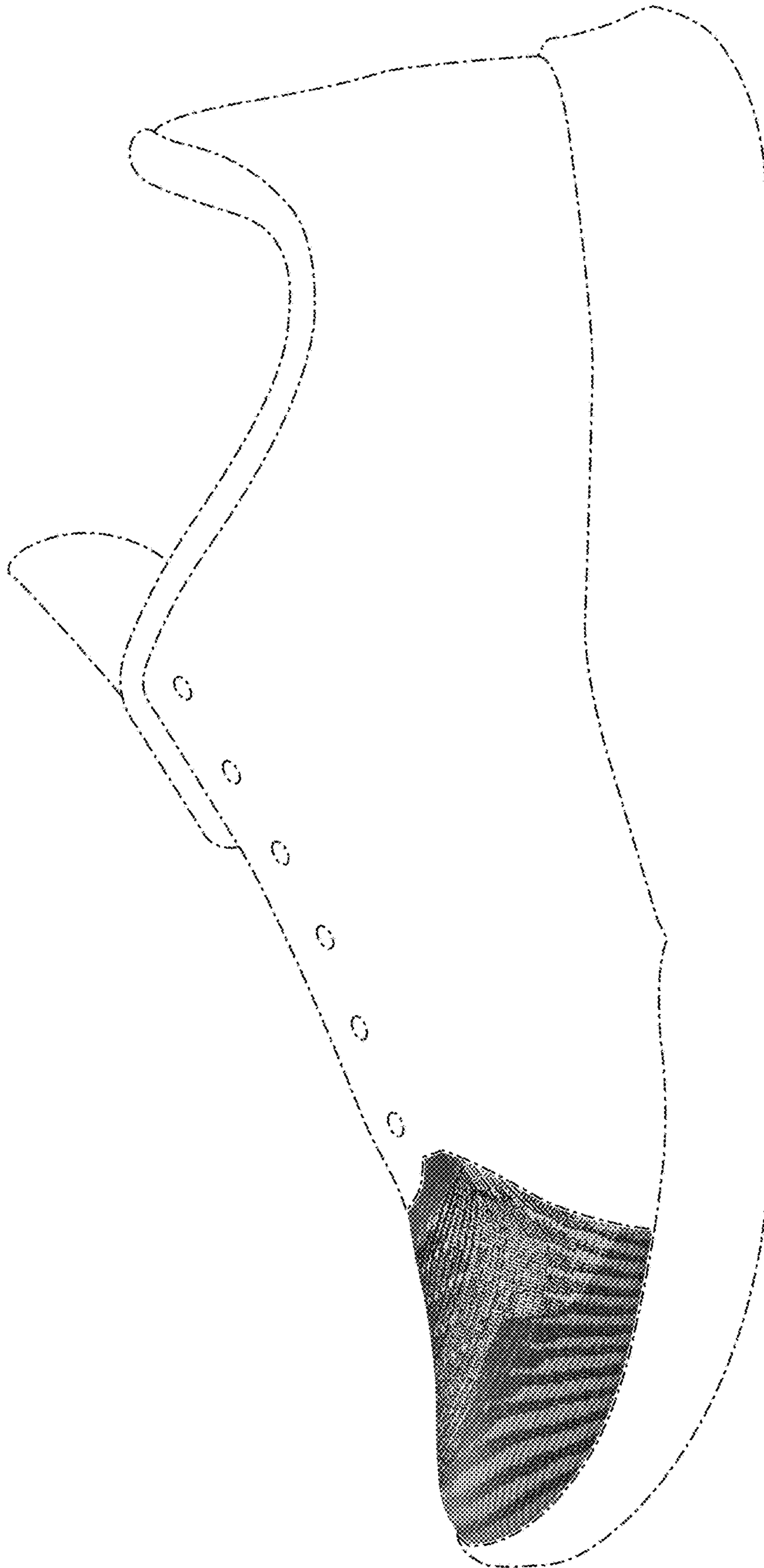

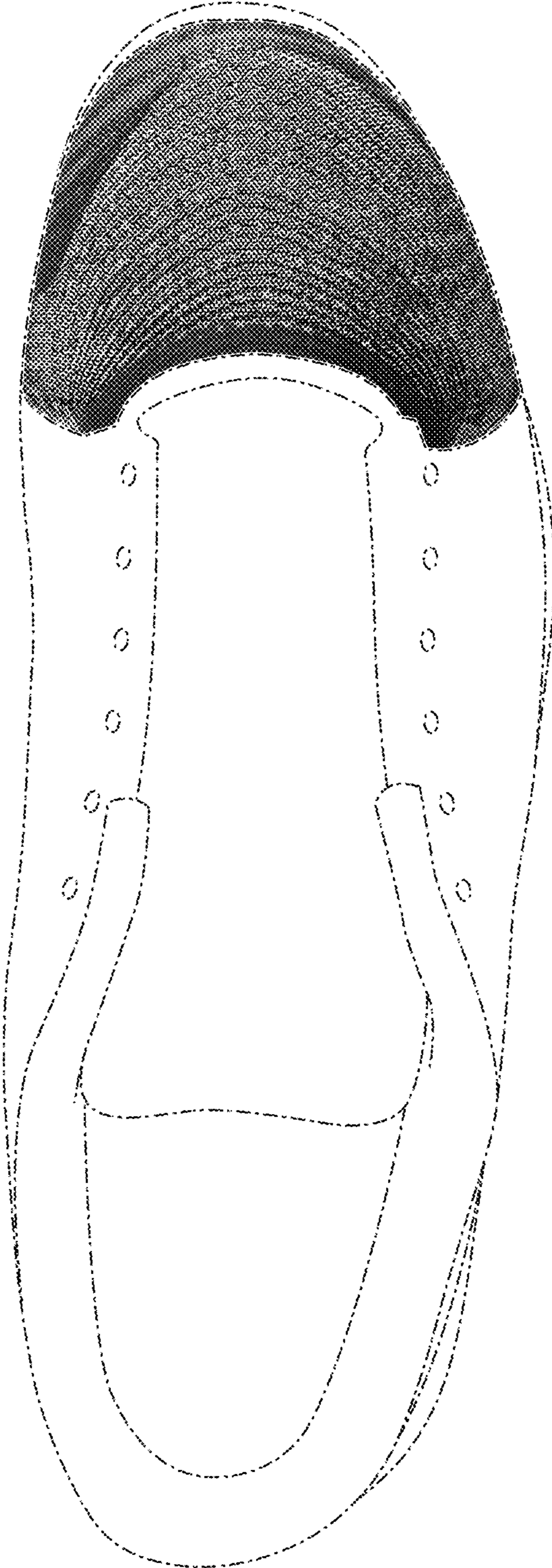
