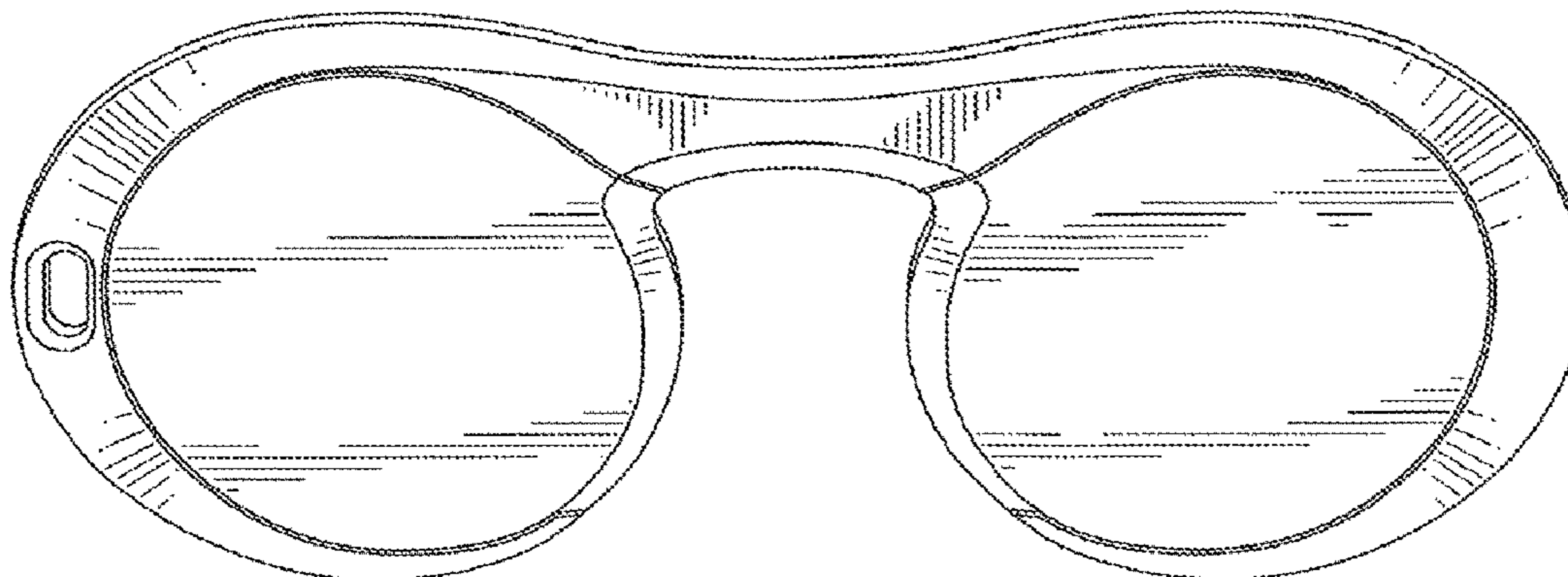
(57) **CLAIM**

The ornamental design for a pince-nez case, as shown and described.

DESCRIPTION

- 1. Pince-nez case
- 1.1 is a top plan view of the pince-nez case showing our new design, the bottom plan view being the same;
- 1.2 is a right side elevational view thereof, the left side elevational view being the same;
- 1.3 is a top, front and left side perspective view thereof;
- 1.4 is a front elevational view thereof; and
- 1.5 is a rear elevational view thereof.

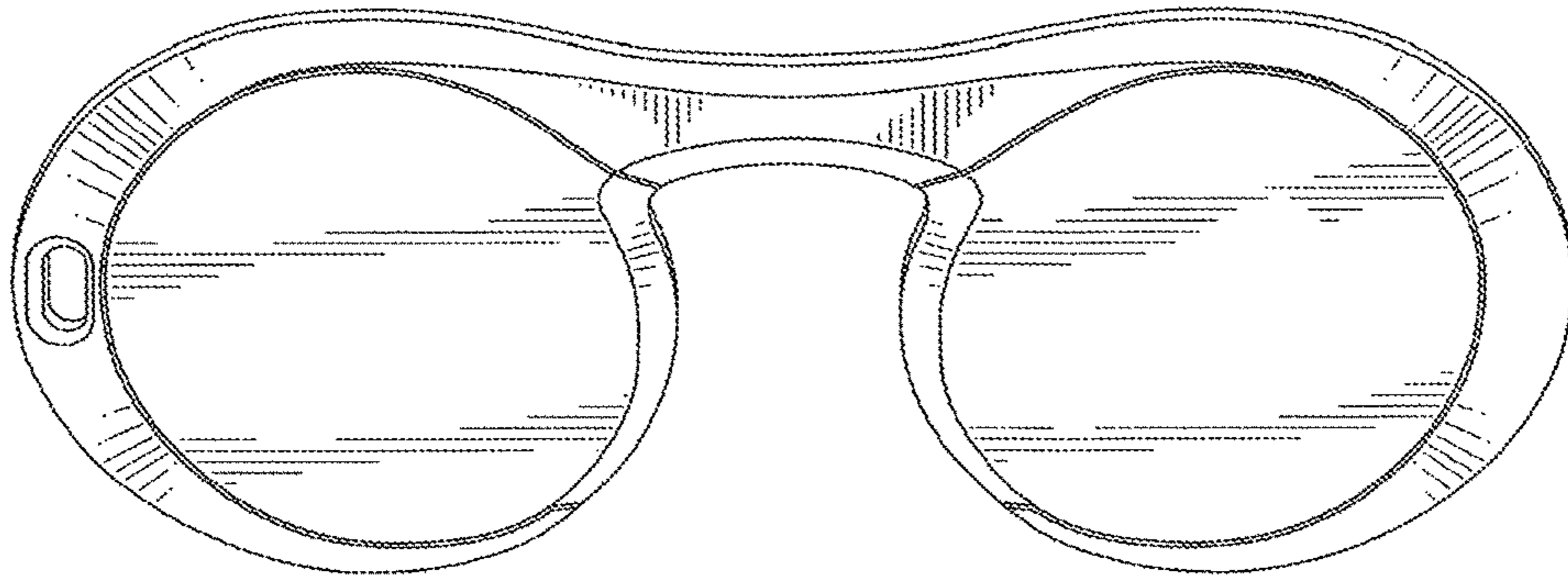

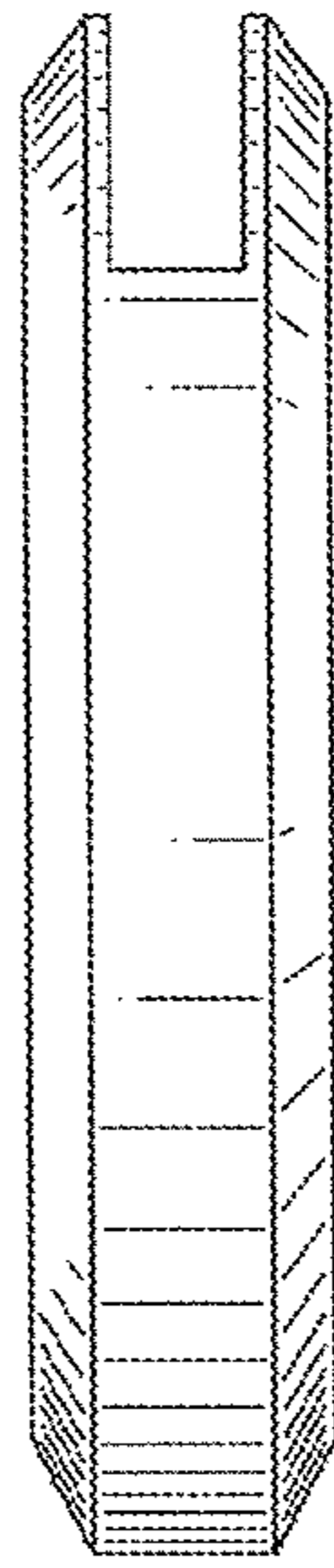

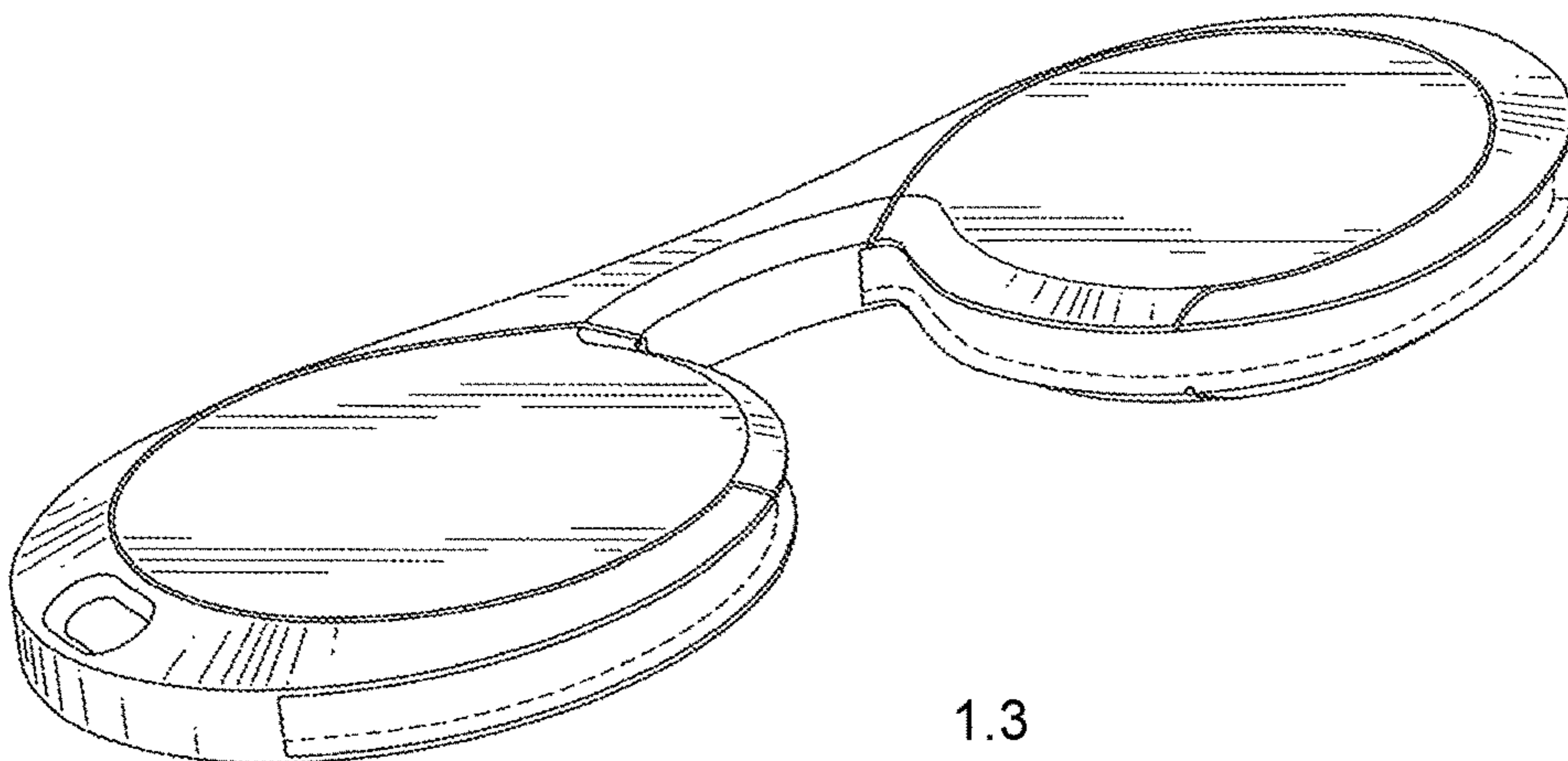

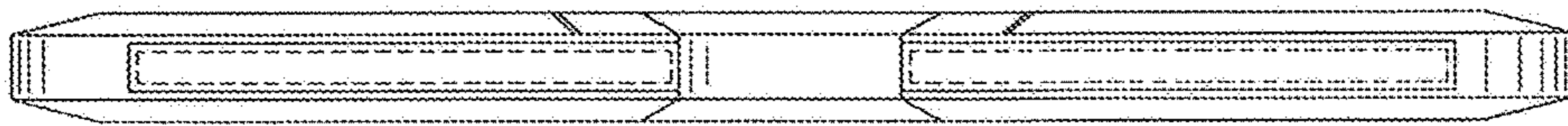
