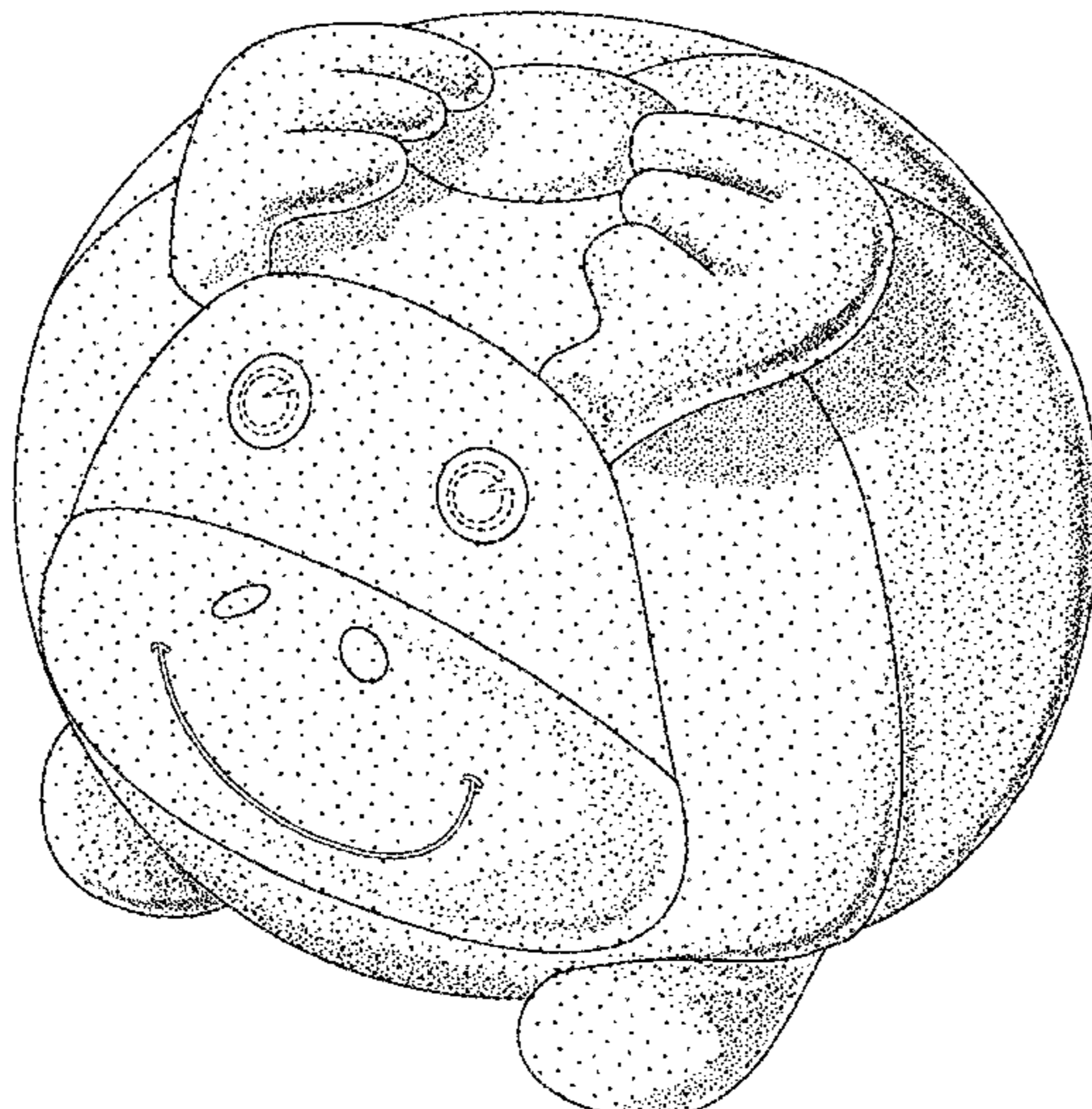
(57) **CLAIM**

The ornamental design for an animal chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an animal chair showing, in particular, the ornamental design thereof. FIG. 2 is a left side view of the animal chair of FIG. 1. FIG. 3 is a right side view of the animal chair of FIG. 1. FIG. 4 is a front end view of the animal chair of FIG. 1. FIG. 5 is a rear end view of the animal chair of FIG. 1; and, FIG. 6 is a top plan view of the animal chair of FIG. 1. The broken lines in the drawings depict portions of the animal chair that form no part of the claimed design.

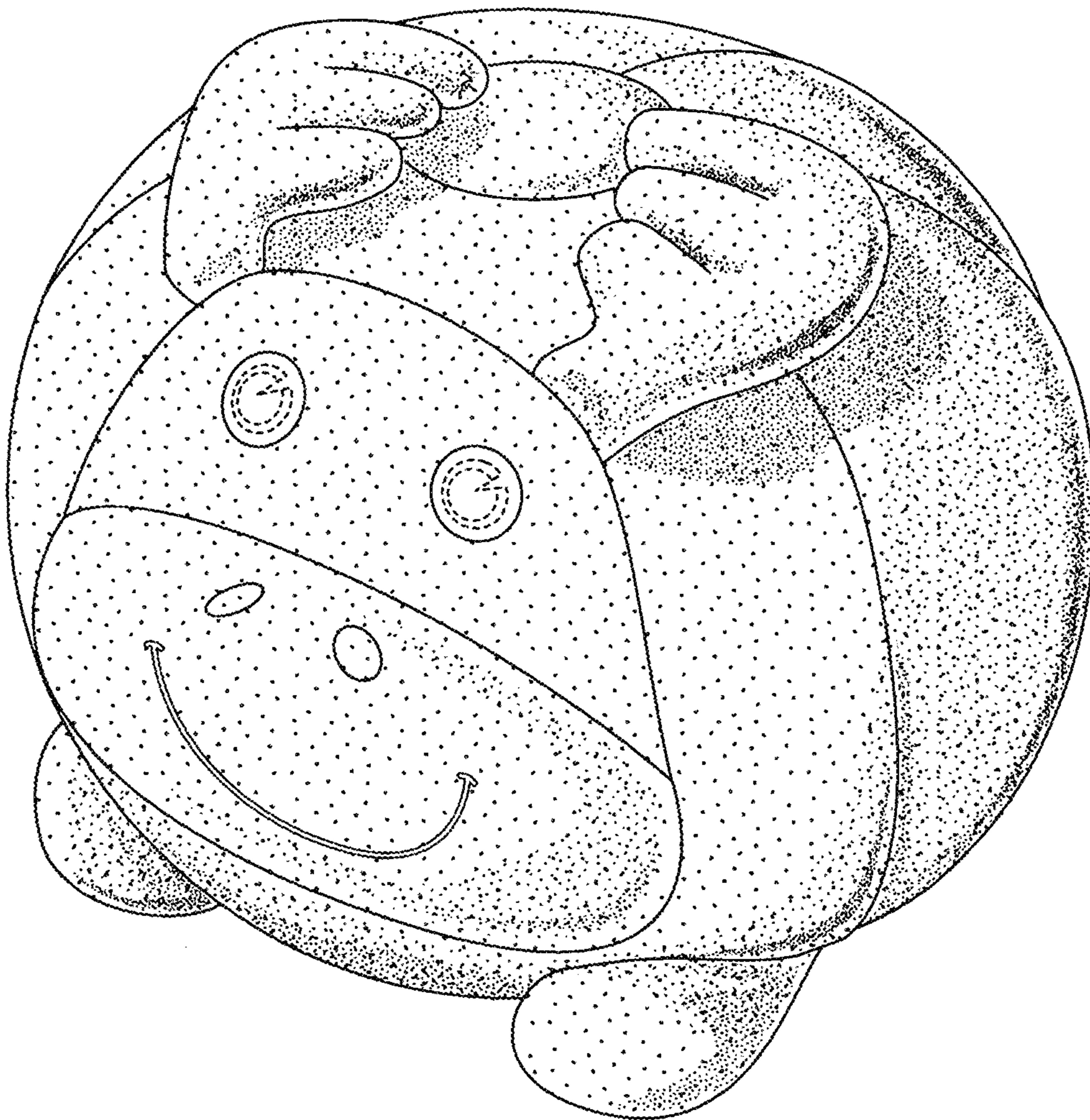

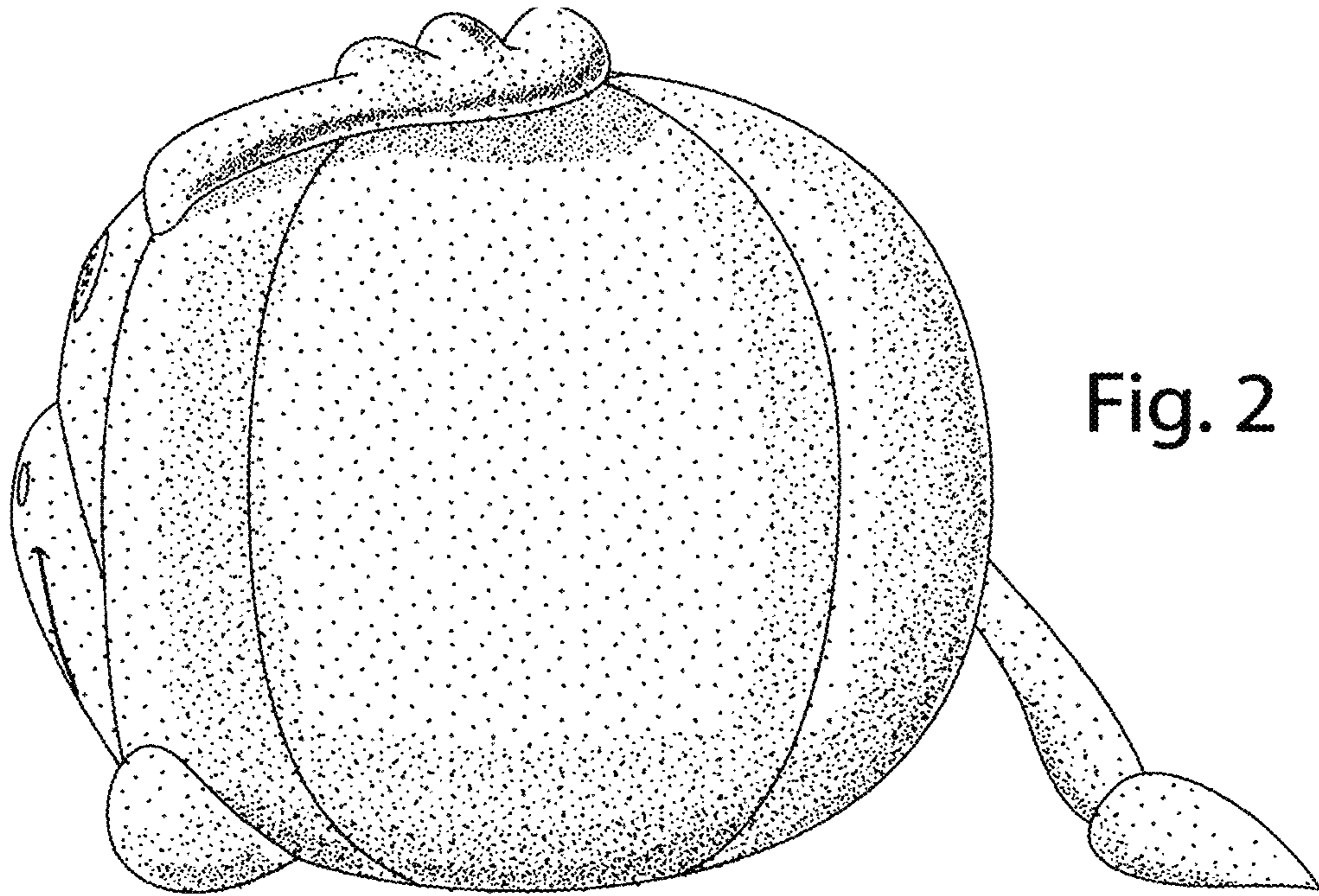

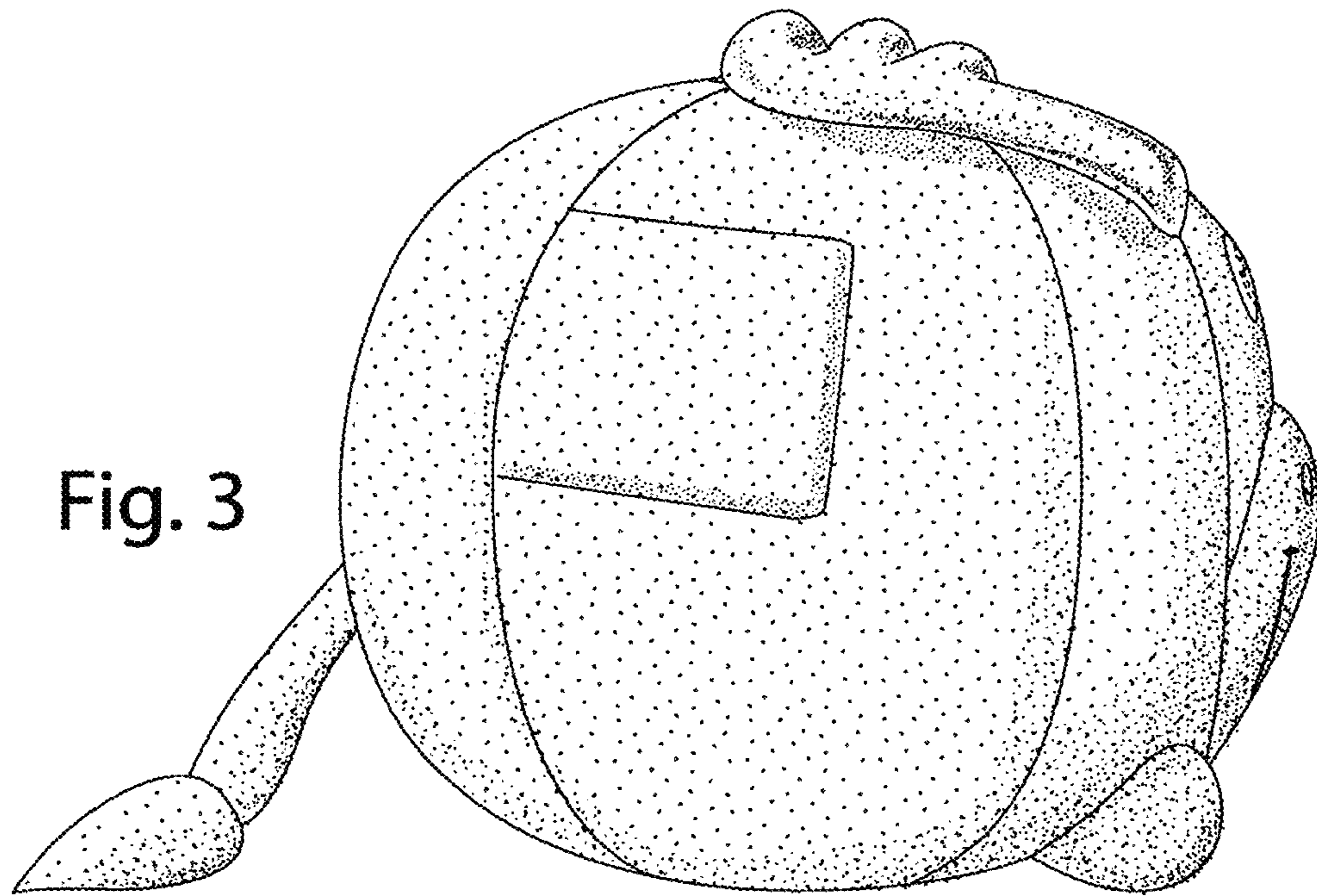

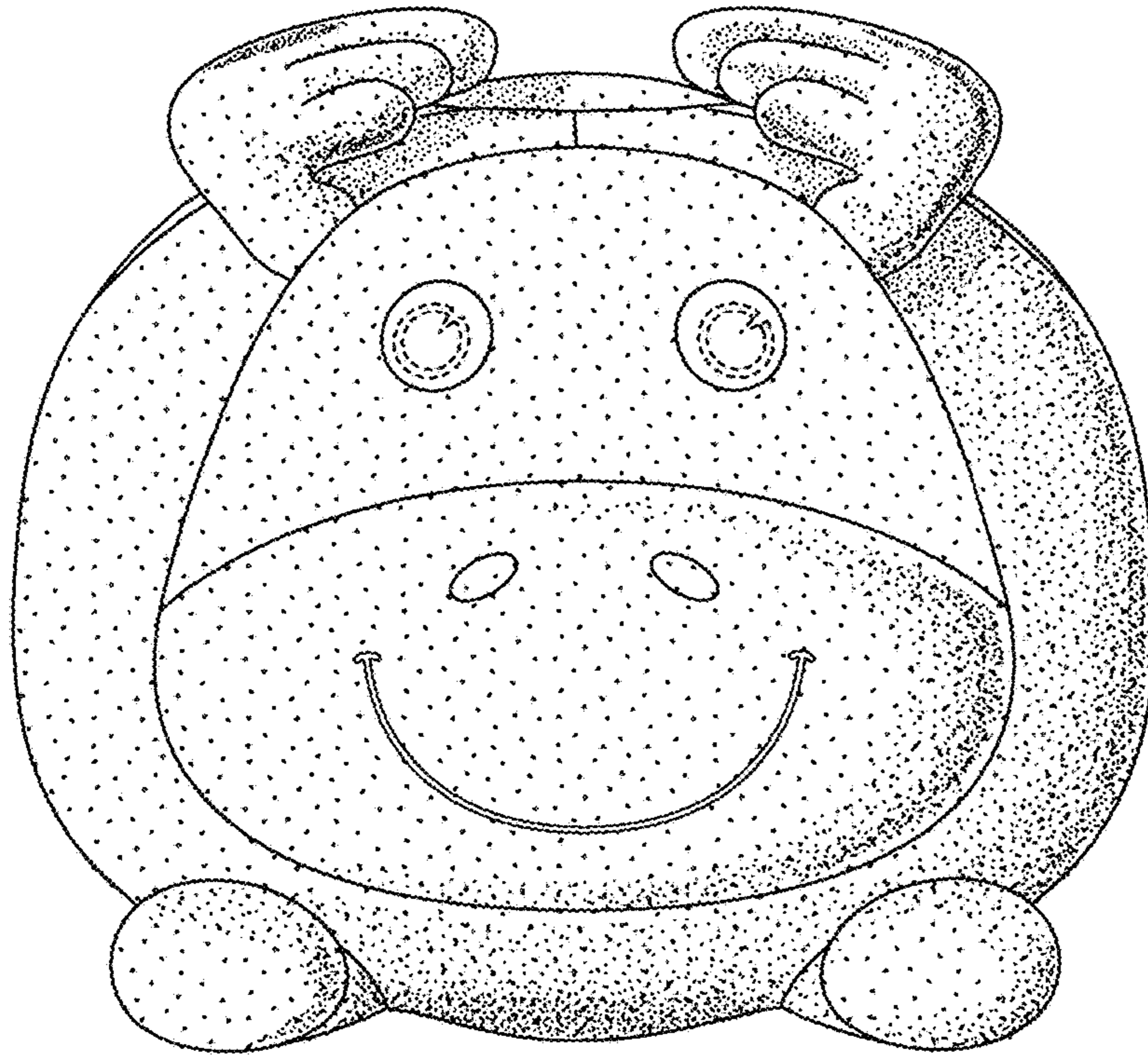

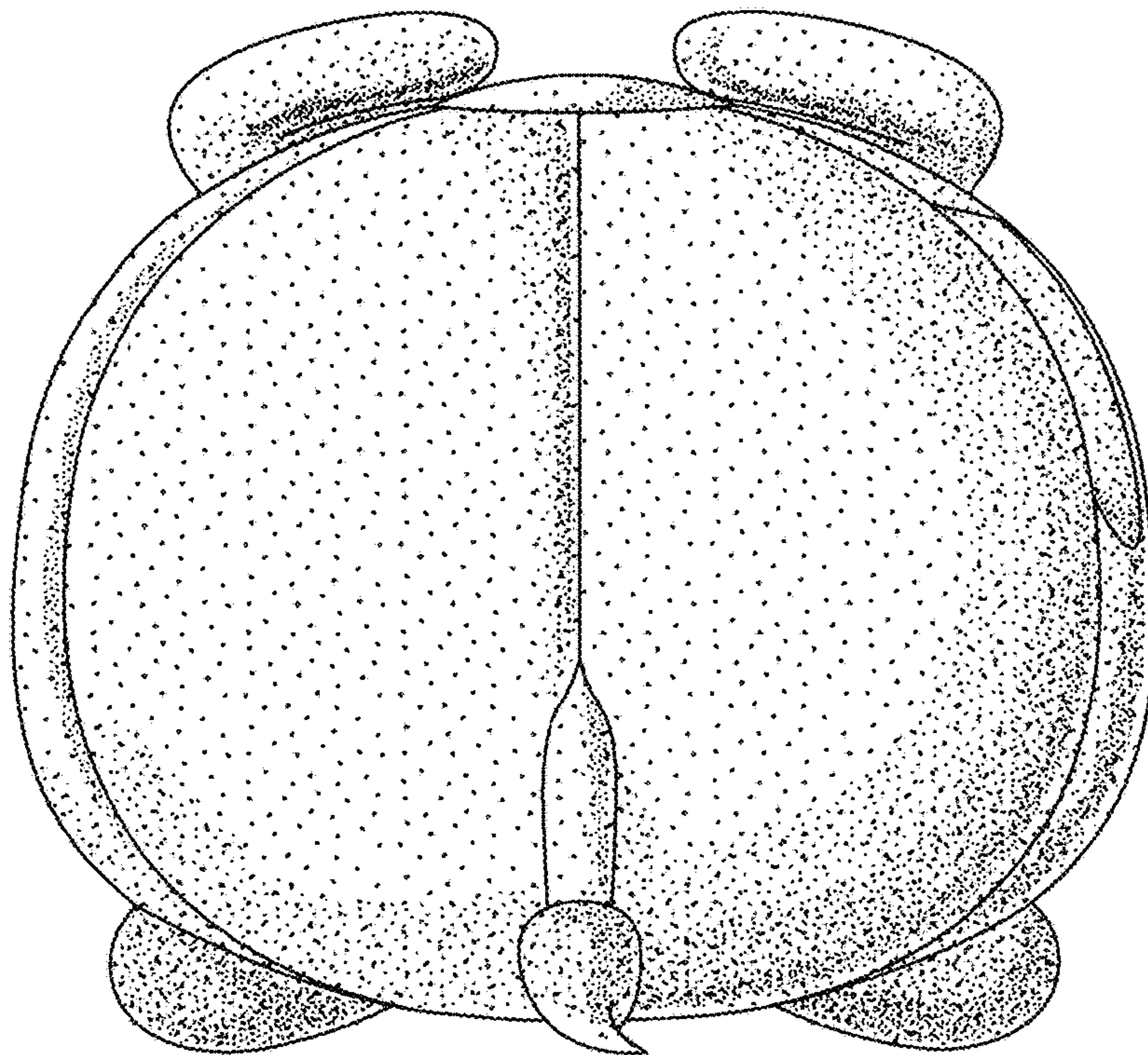

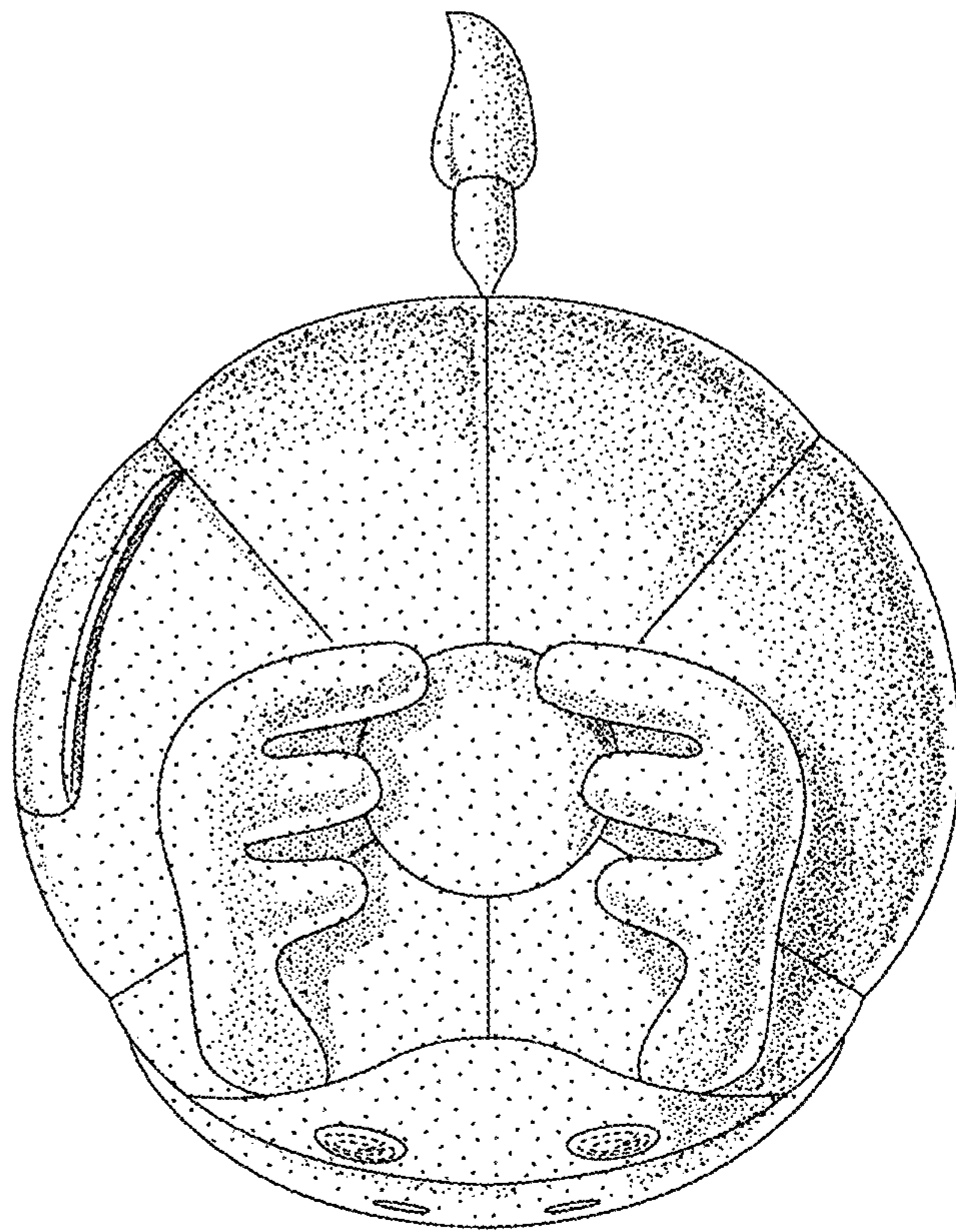
