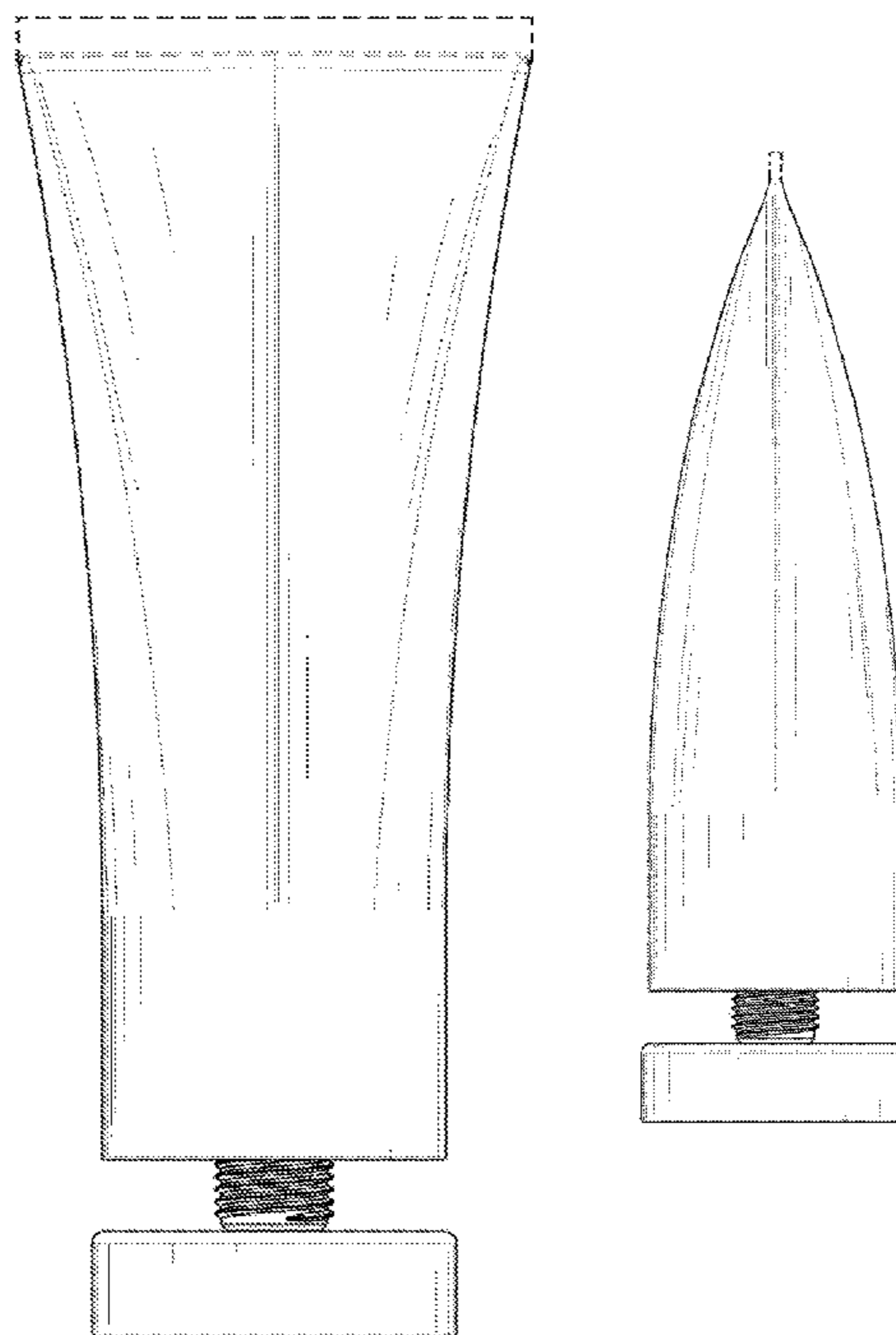

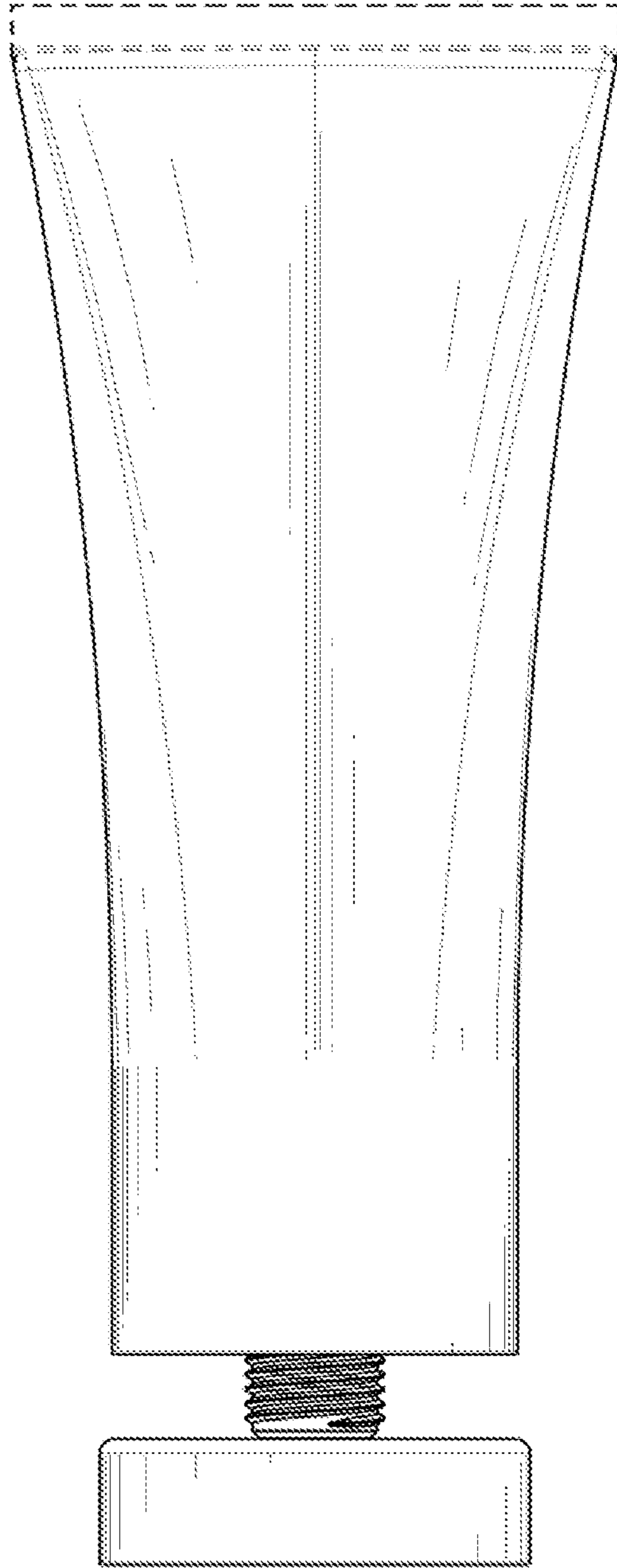
The ornamental design for a fluid dispenser, as shown and described.

DESCRIPTION

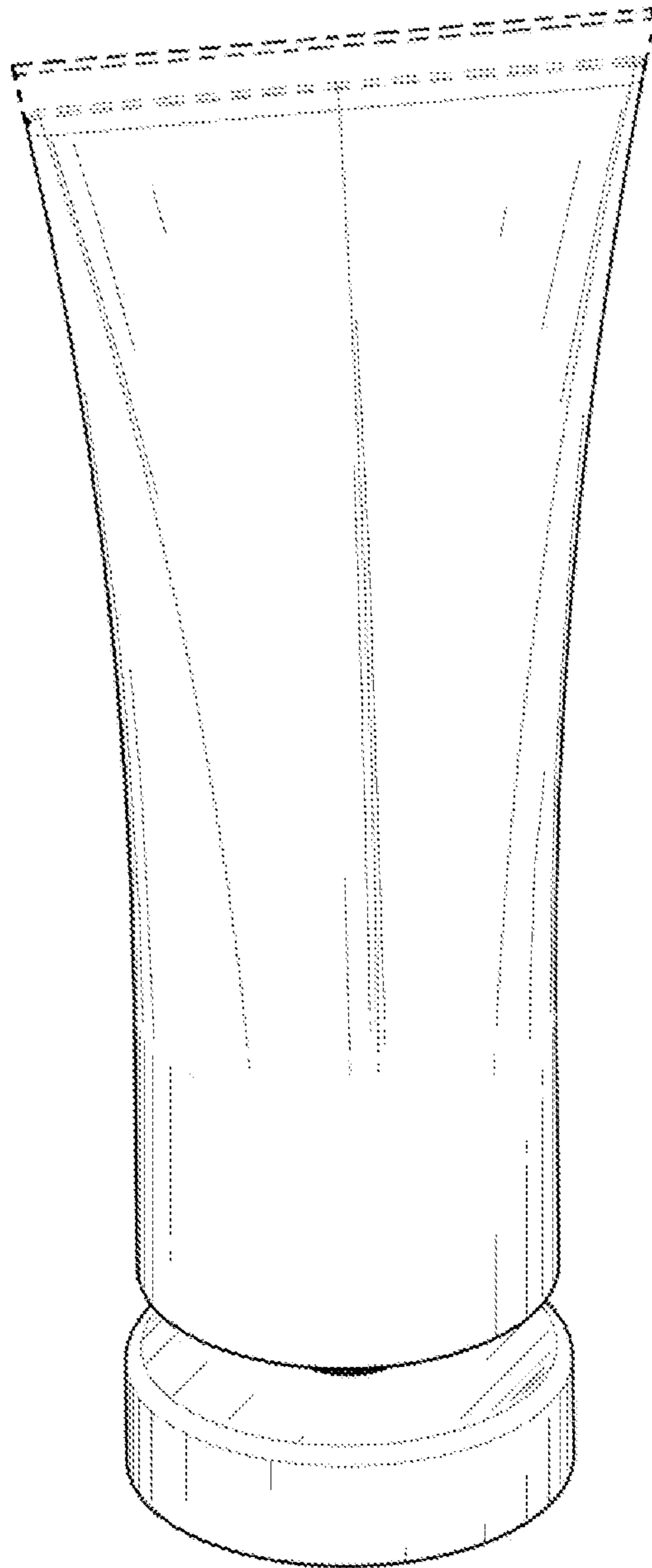
1.1 is a front view of a fluid dispenser showing the new design;

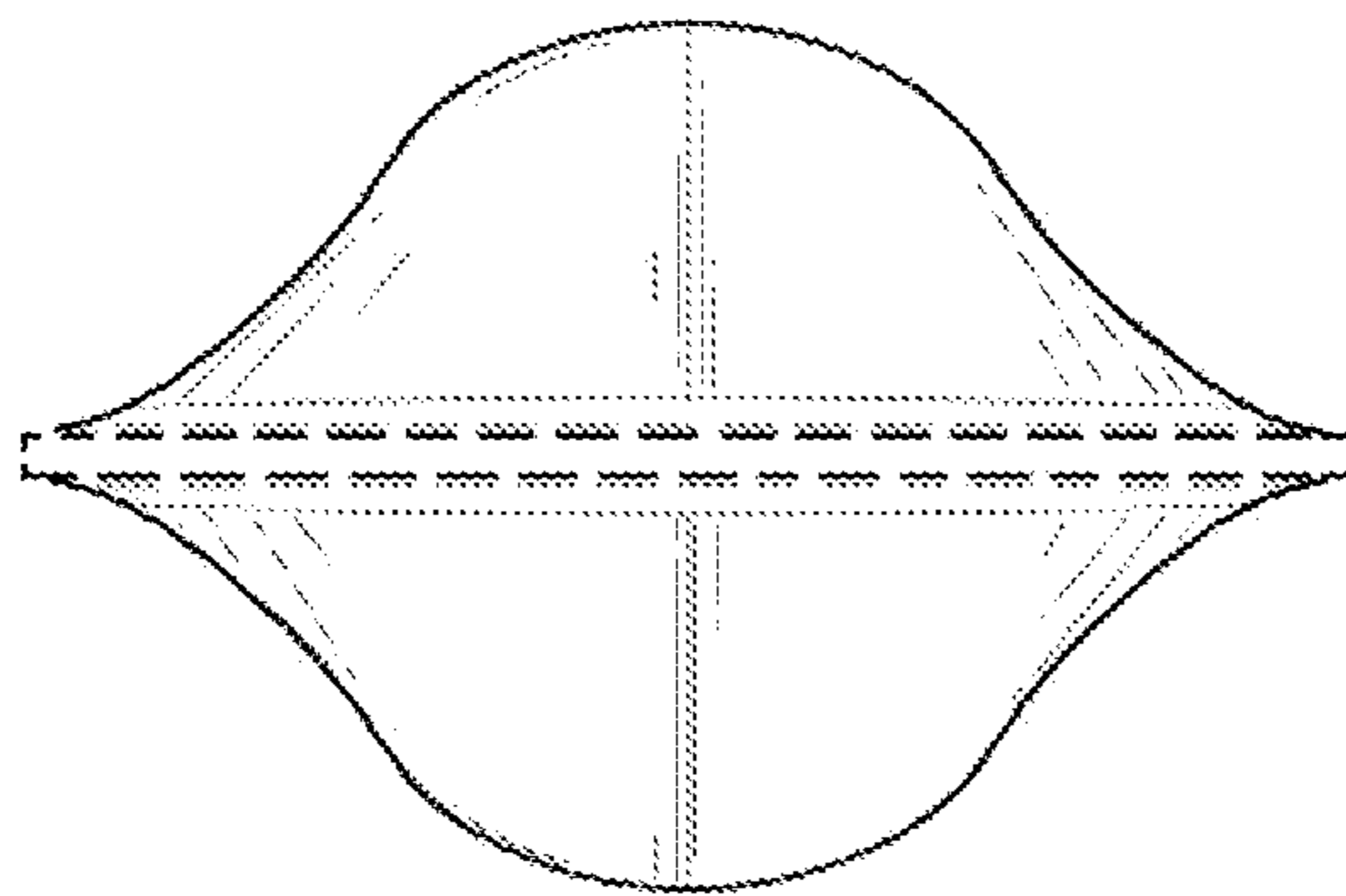




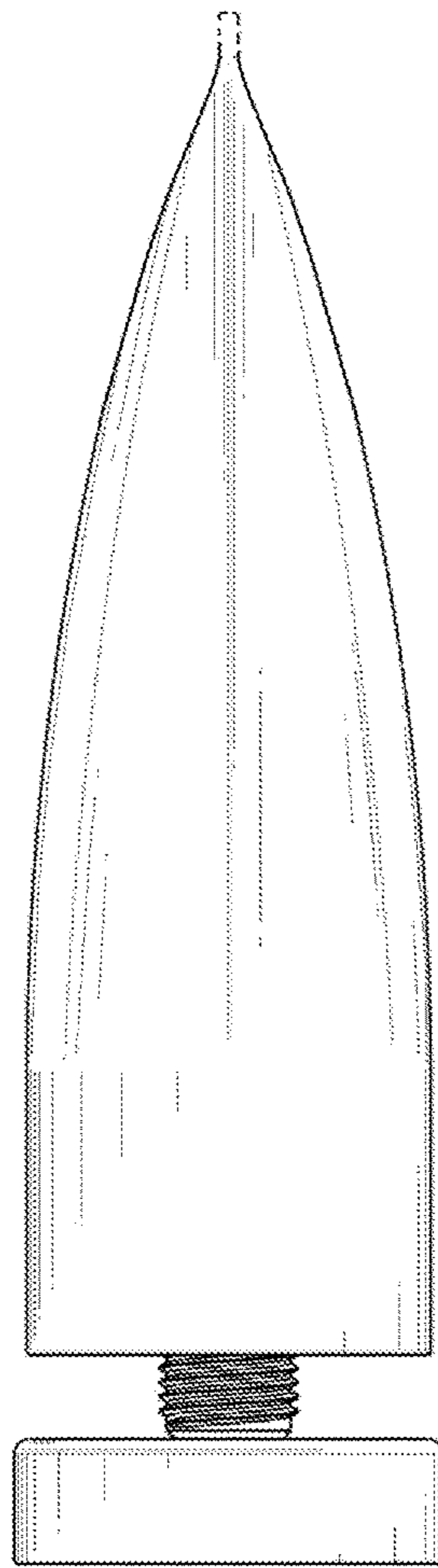
