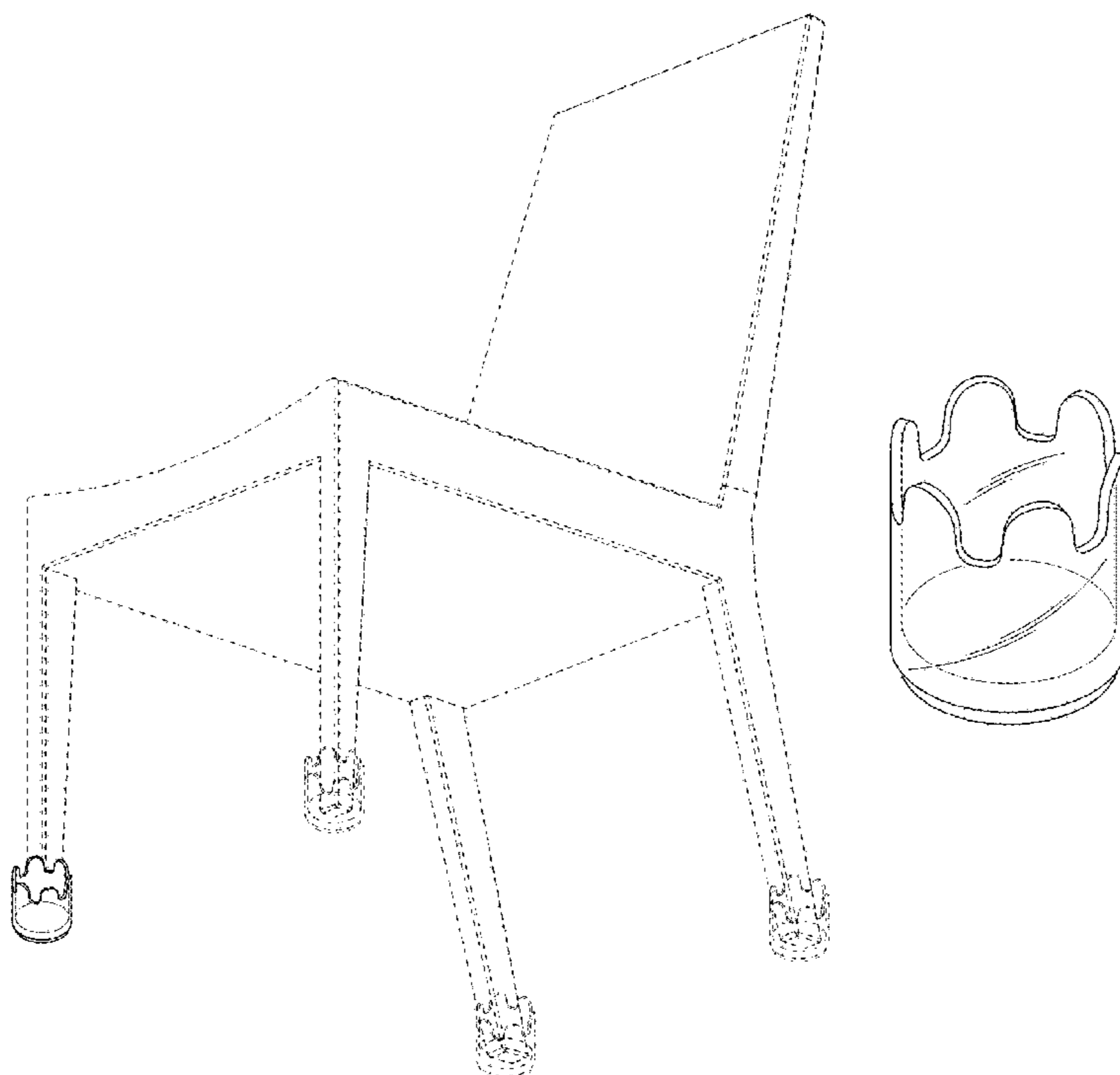
(57) **CLAIM**

The ornamental design for a furniture floor protector, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, bottom and one side of my design coupled to a bottom of a furniture leg; FIG. 2 is a perspective view showing the front, top and other side of my design; FIG. 3 is an elevation view showing the front of my design; FIG. 4 is an elevation view showing the rear of my design; FIG. 5 is a plan view showing the top of my design; and, FIG. 6 is a plan view showing the bottom of my design. 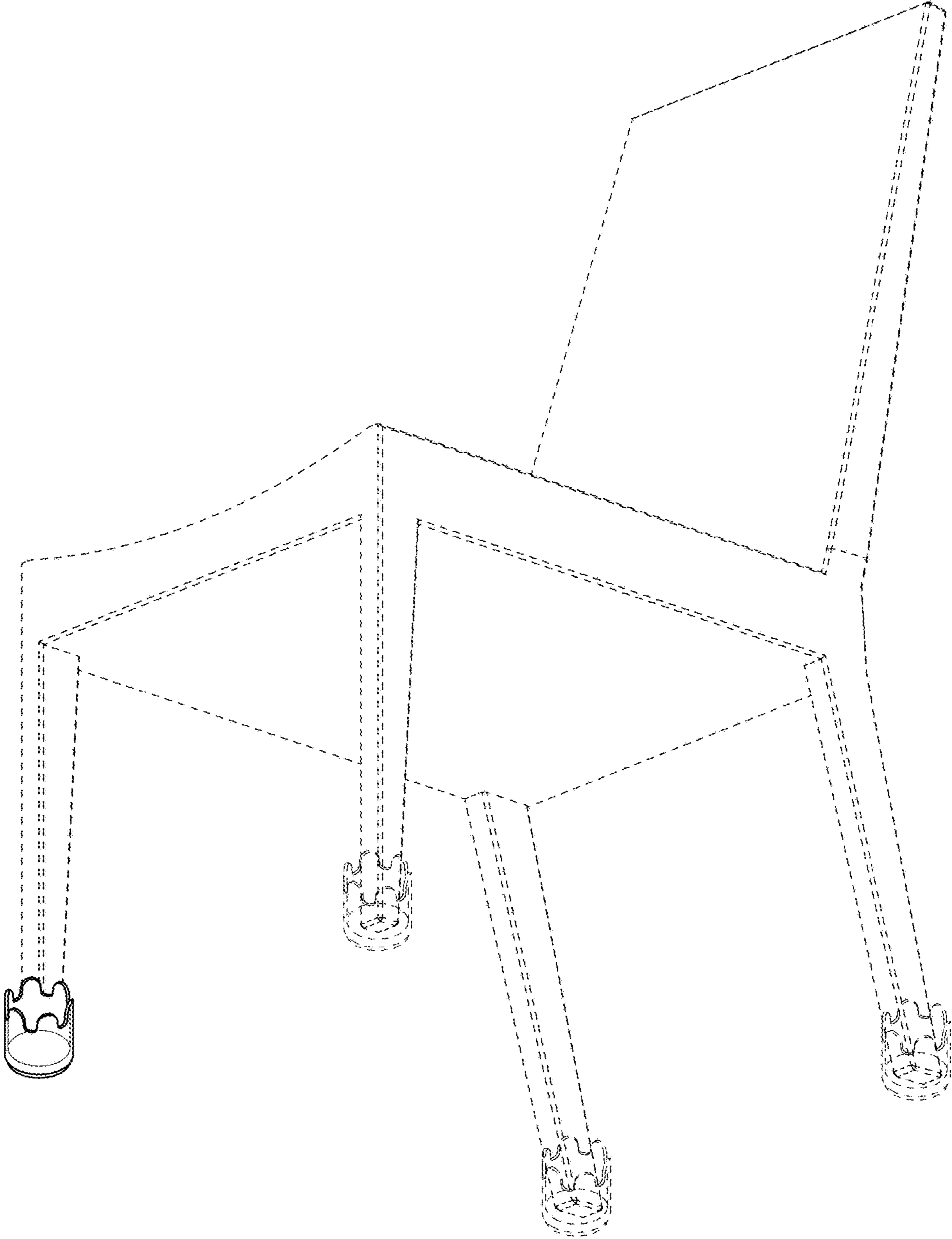

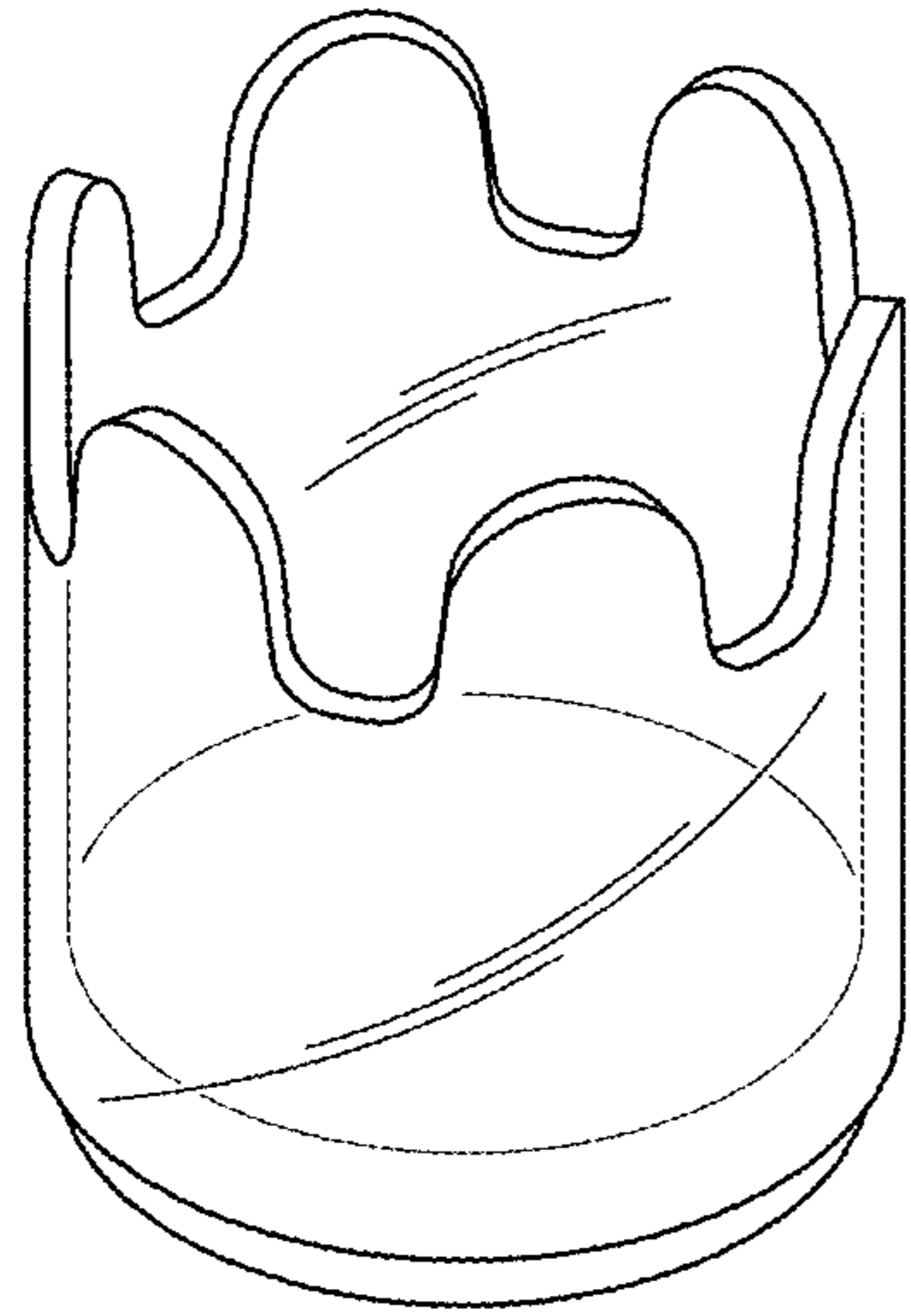

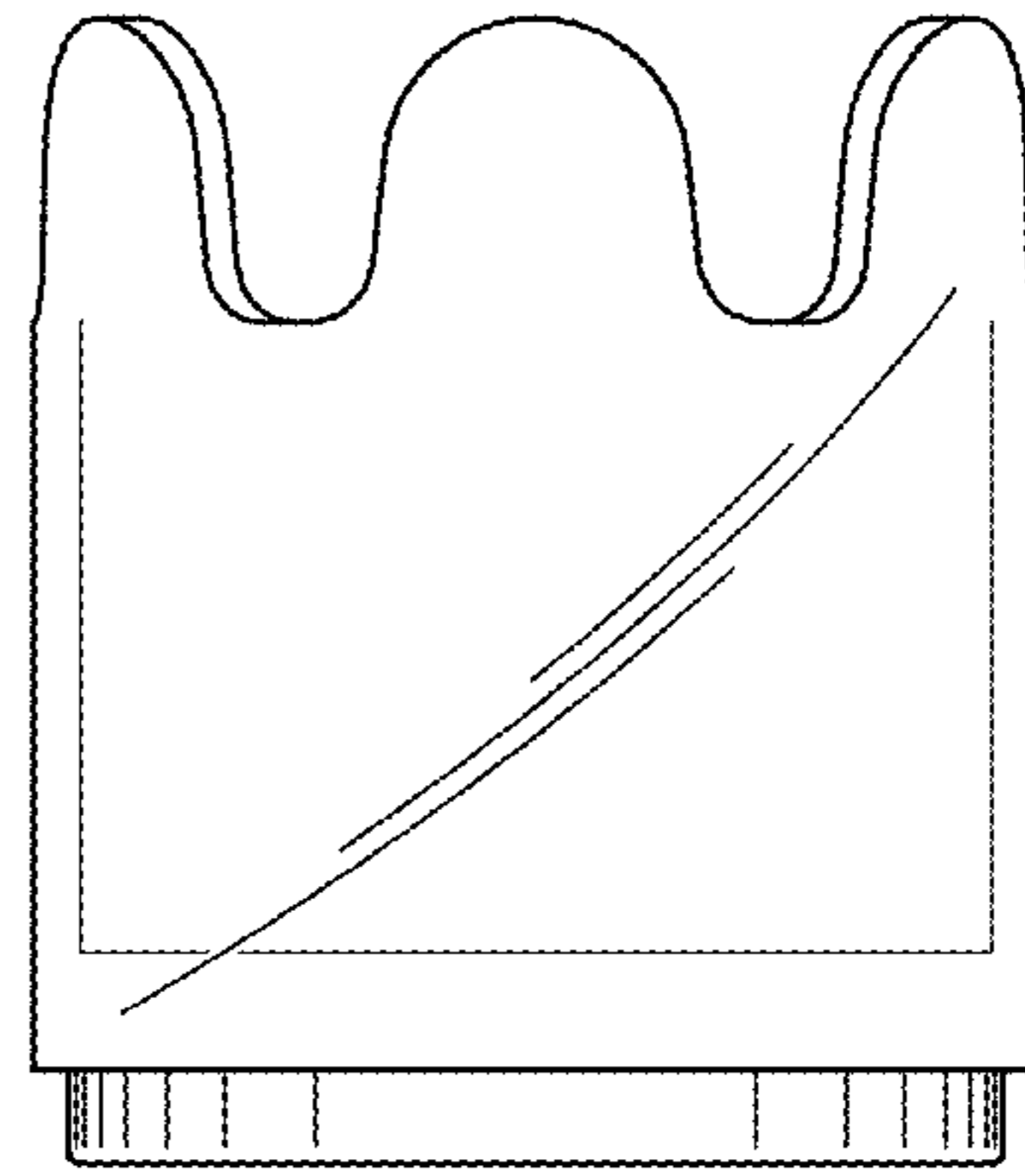

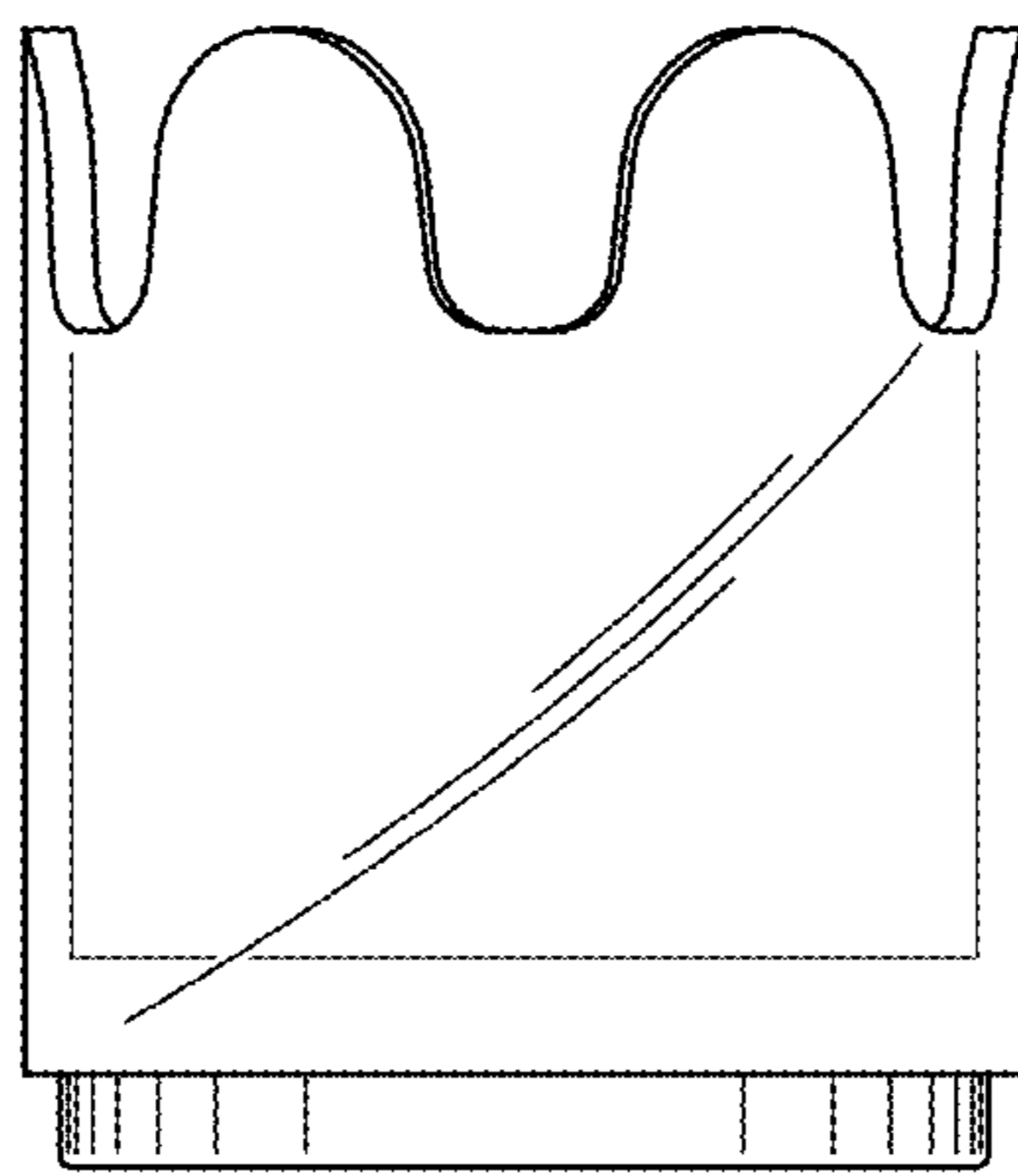

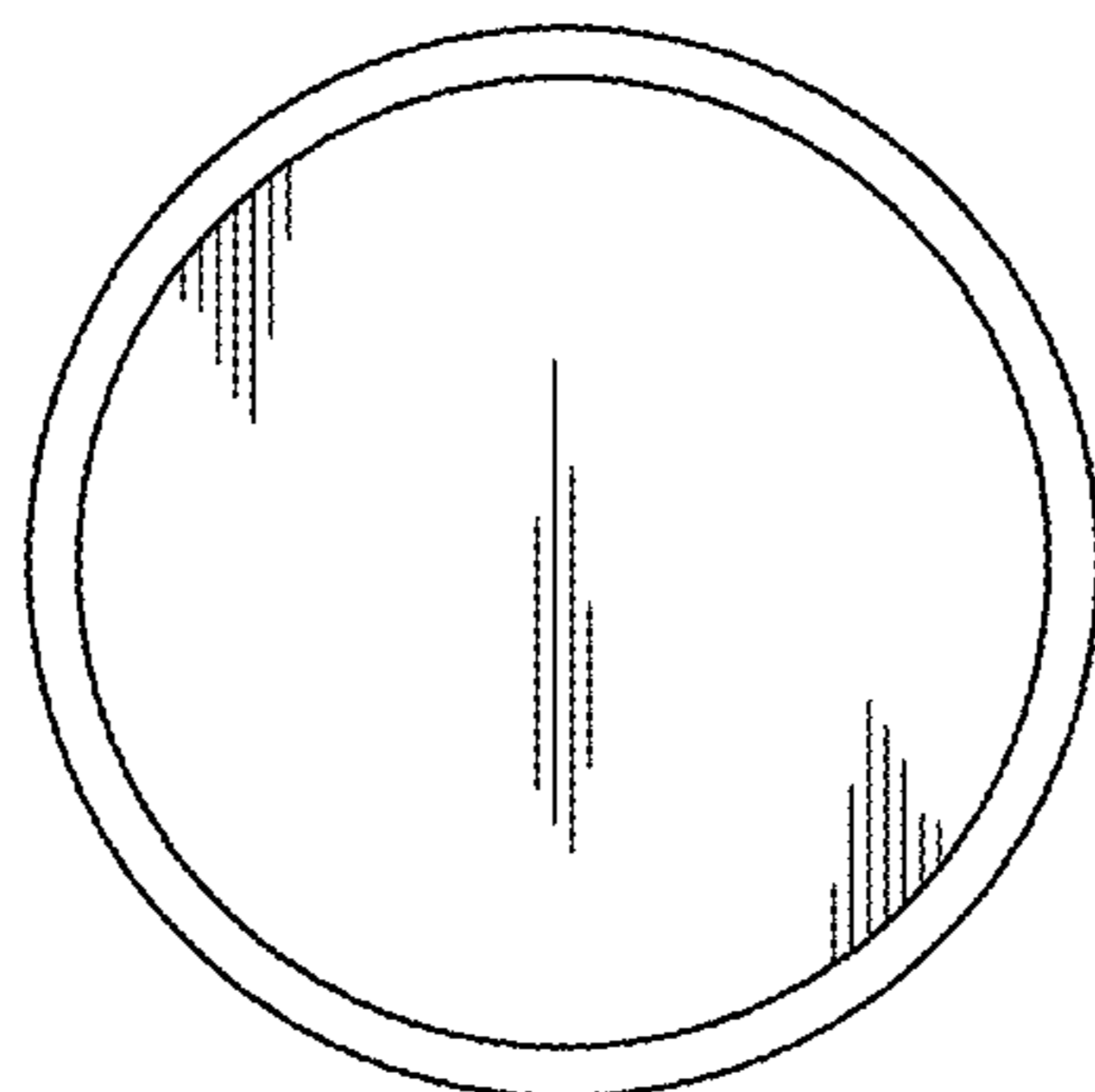

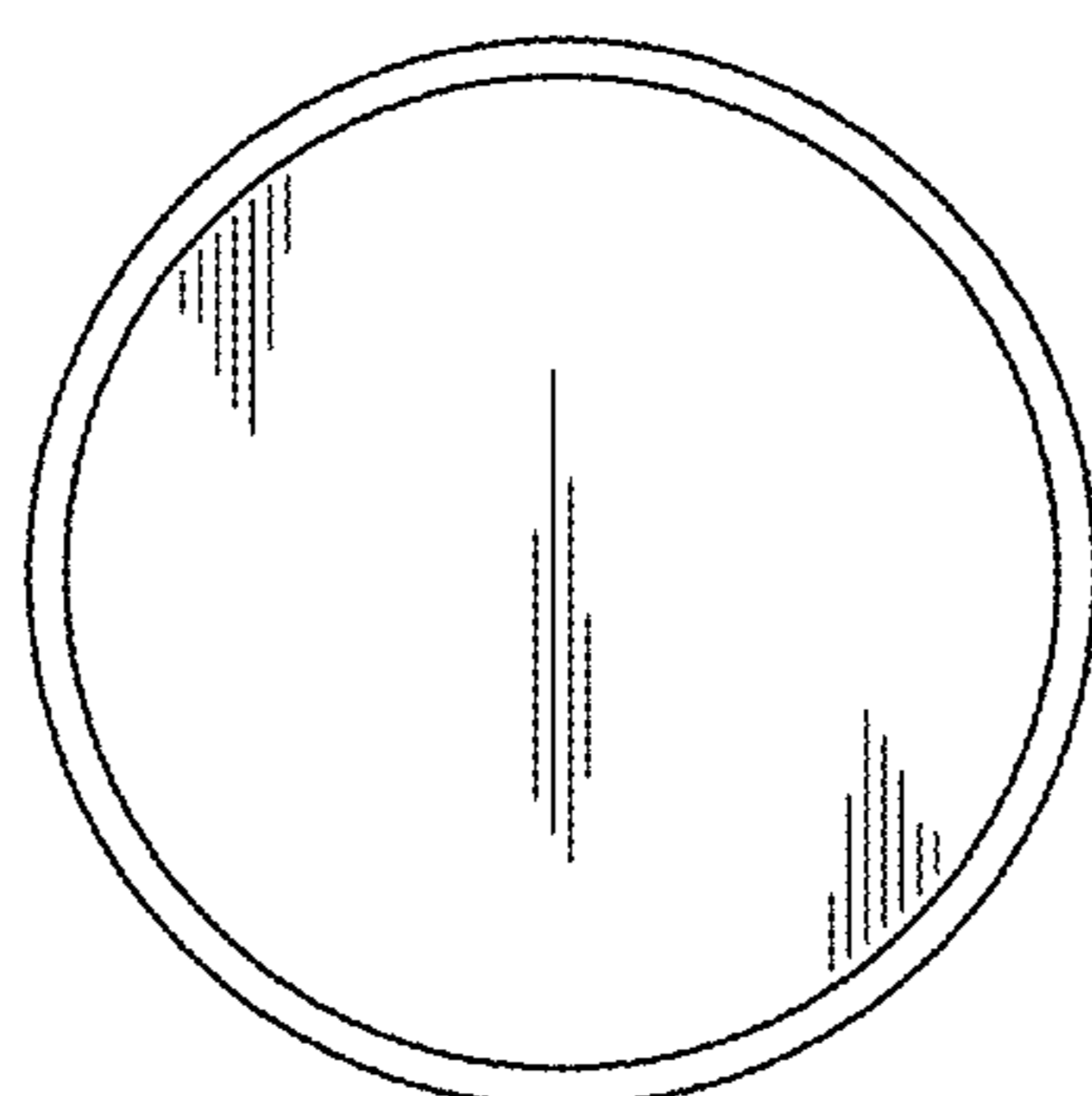
