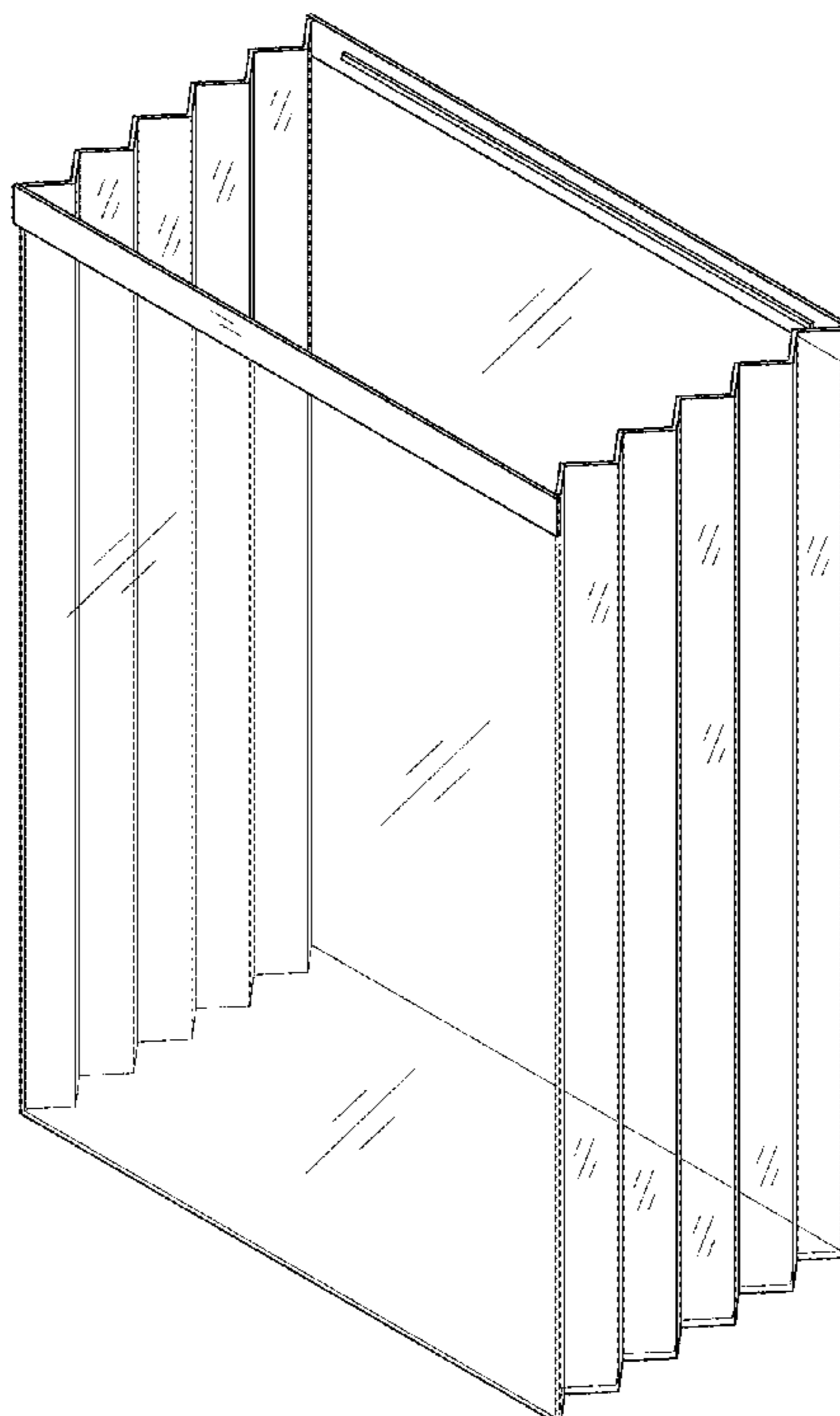
(57) **CLAIM**

The ornamental design for a pleated bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a pleated bag showing my new design, a rear view being identical;  
 FIG. 2 is a left side view of the pleated bag, a right side view being a mirror image thereof;  
 FIG. 3 is a top view of the pleated bag;  
 FIG. 4 is a bottom view of the pleated bag;  
 FIG. 5 is a top front side perspective view of the pleated bag;  
 and,  
 FIG. 6 is a top rear side perspective view of the pleated bag.

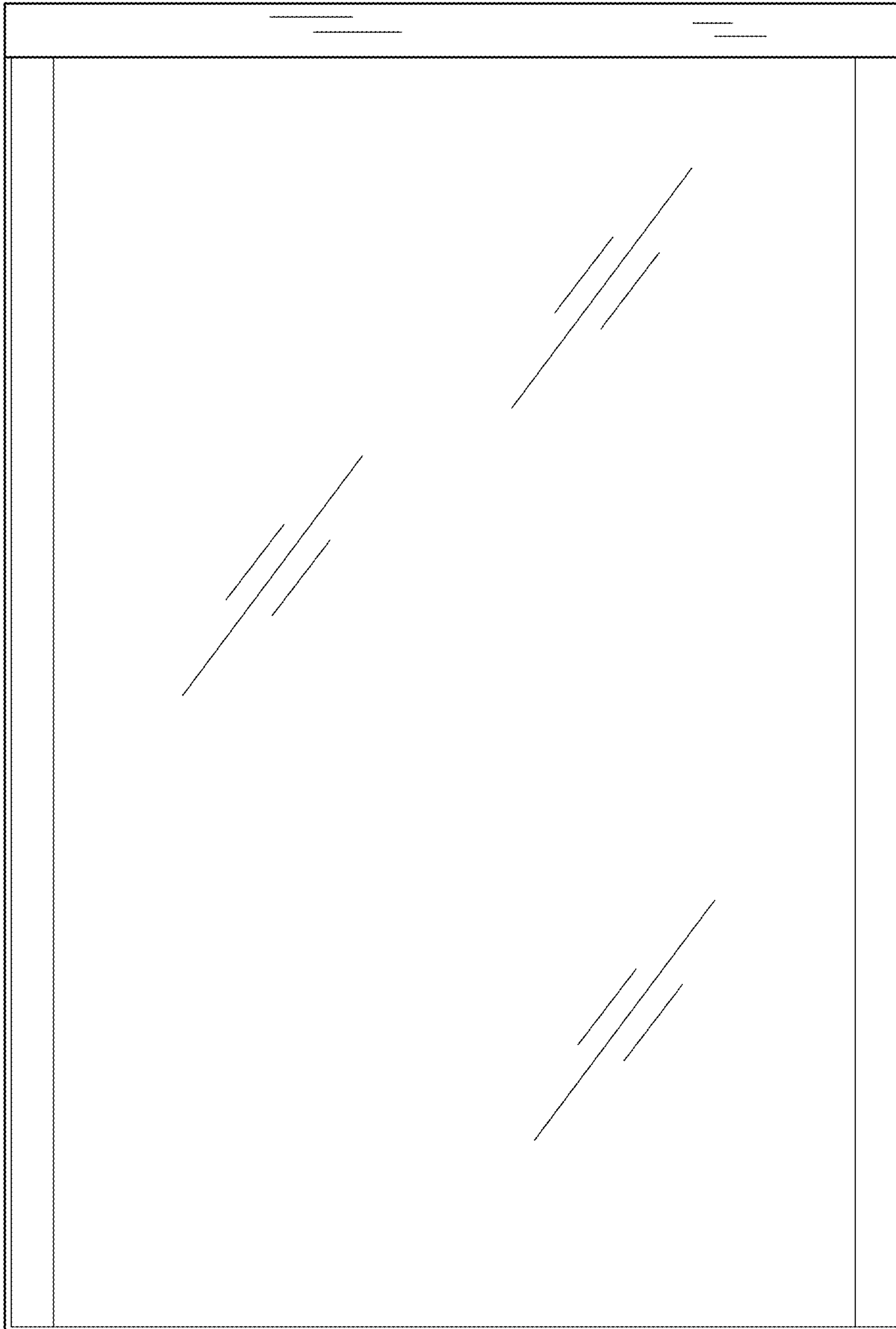

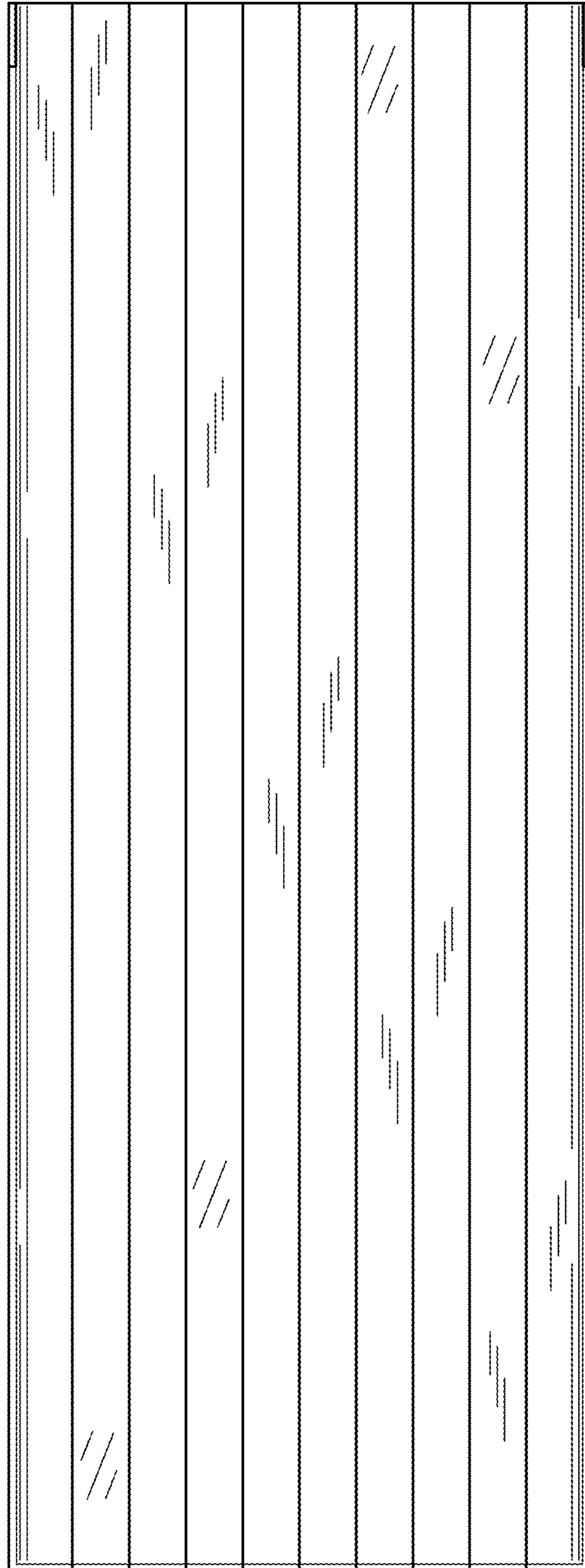

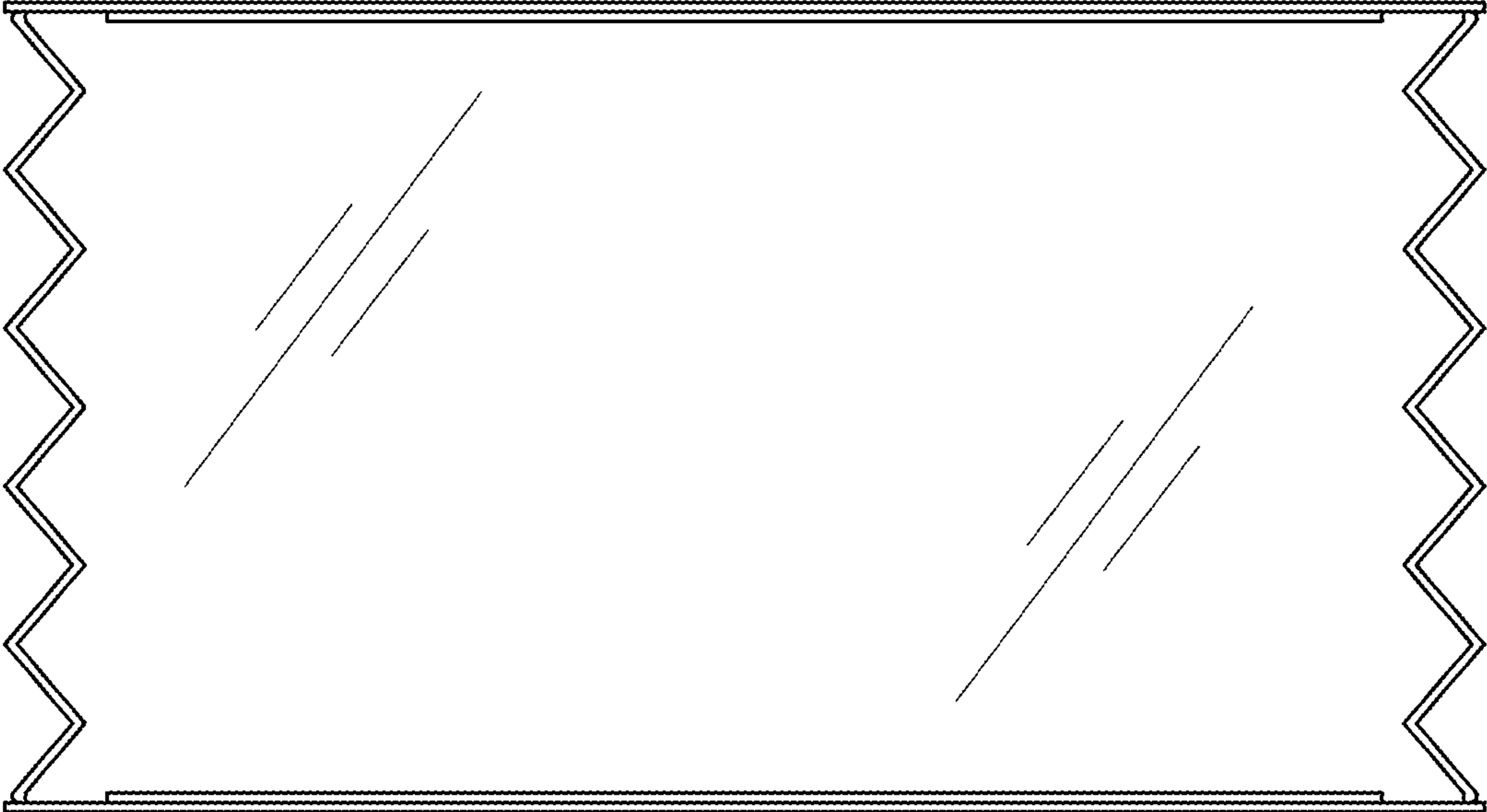

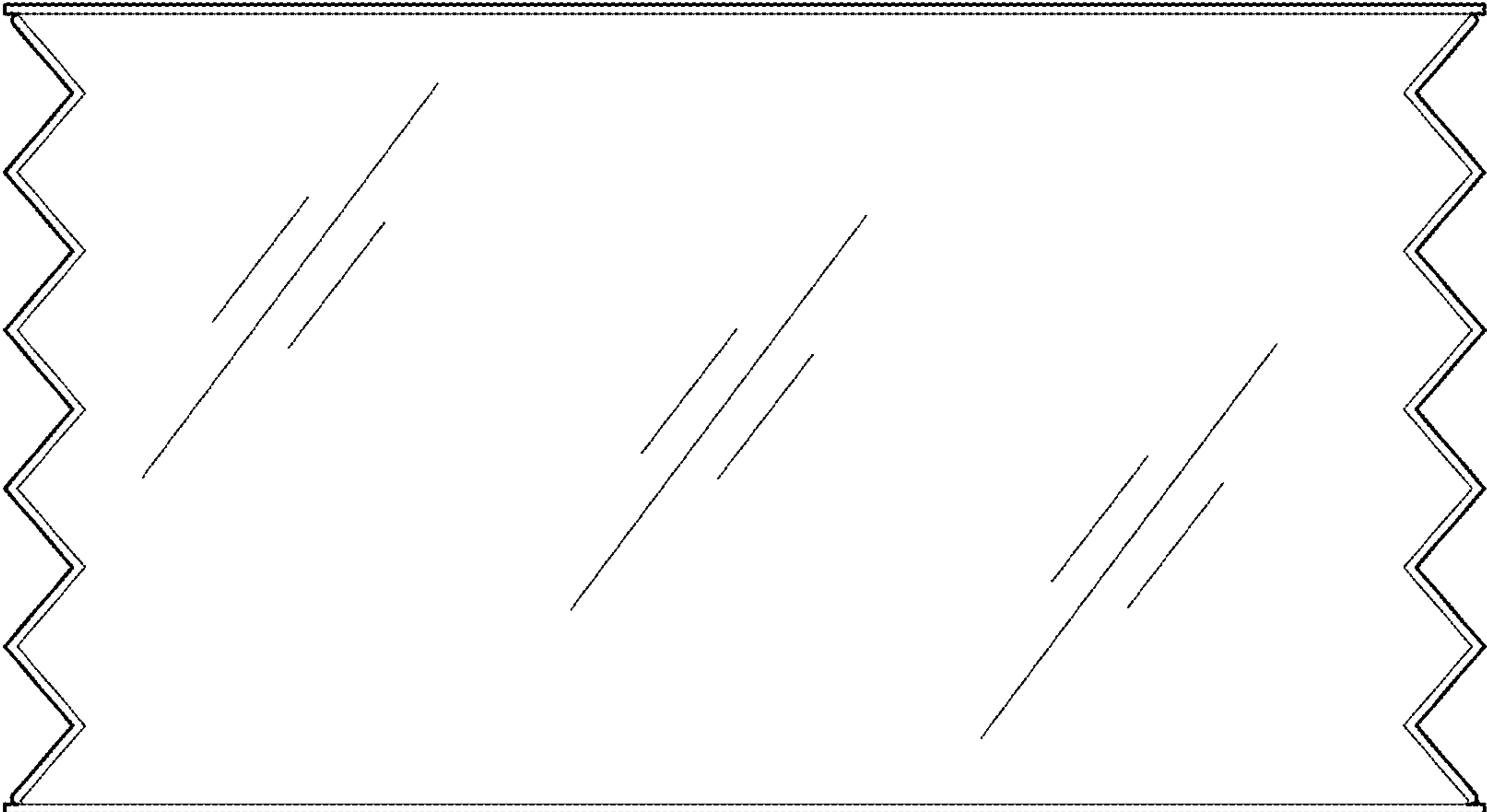

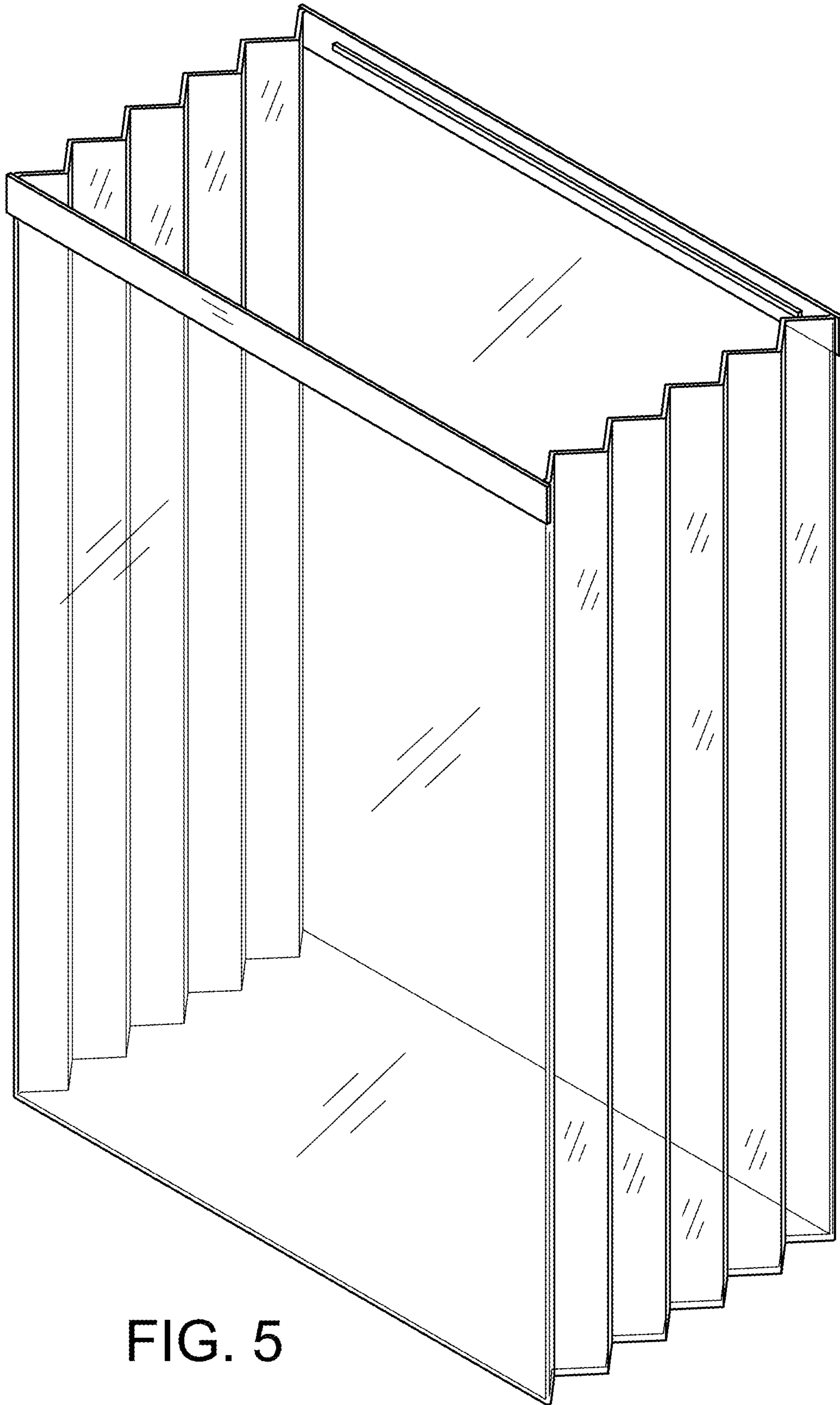

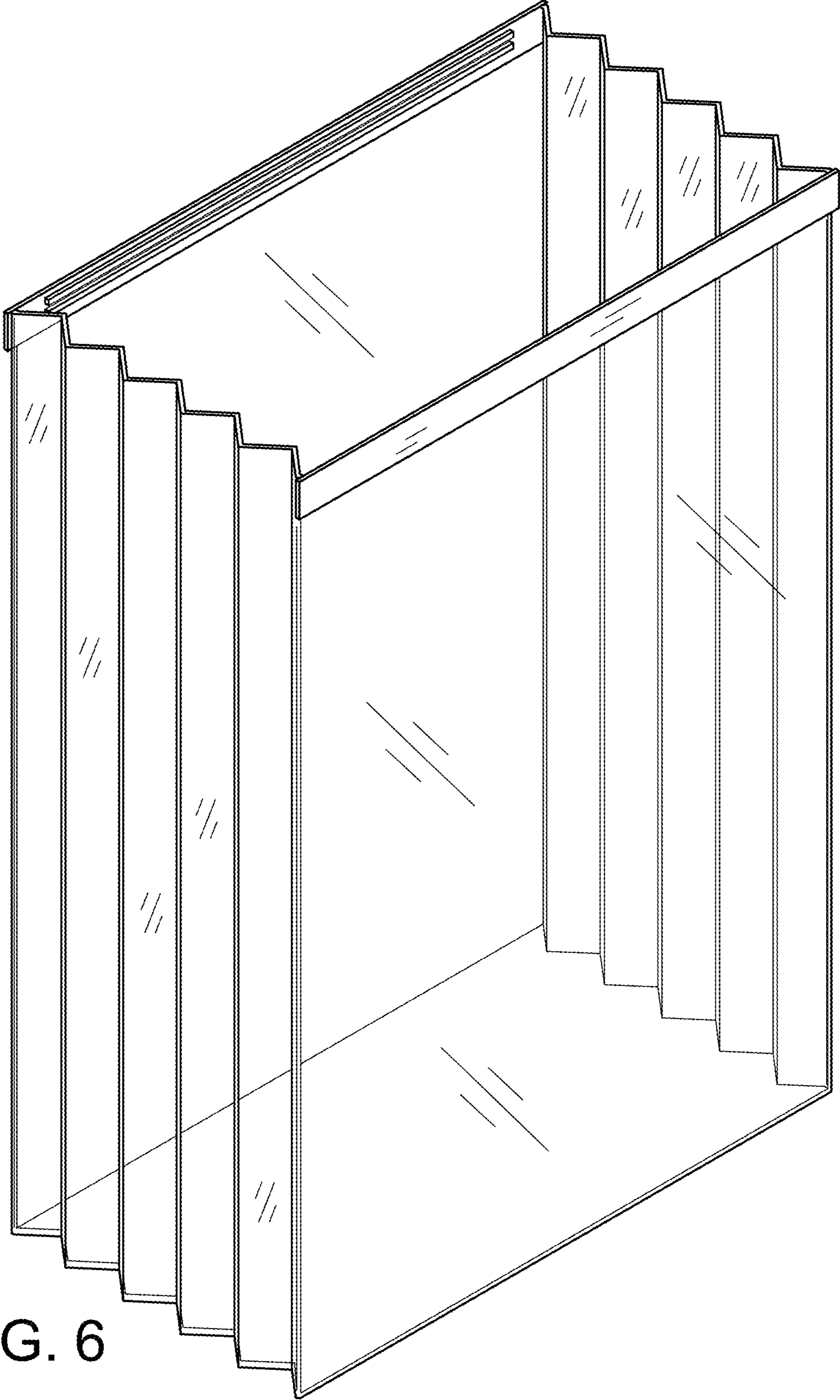
