**DESCRIPTION**

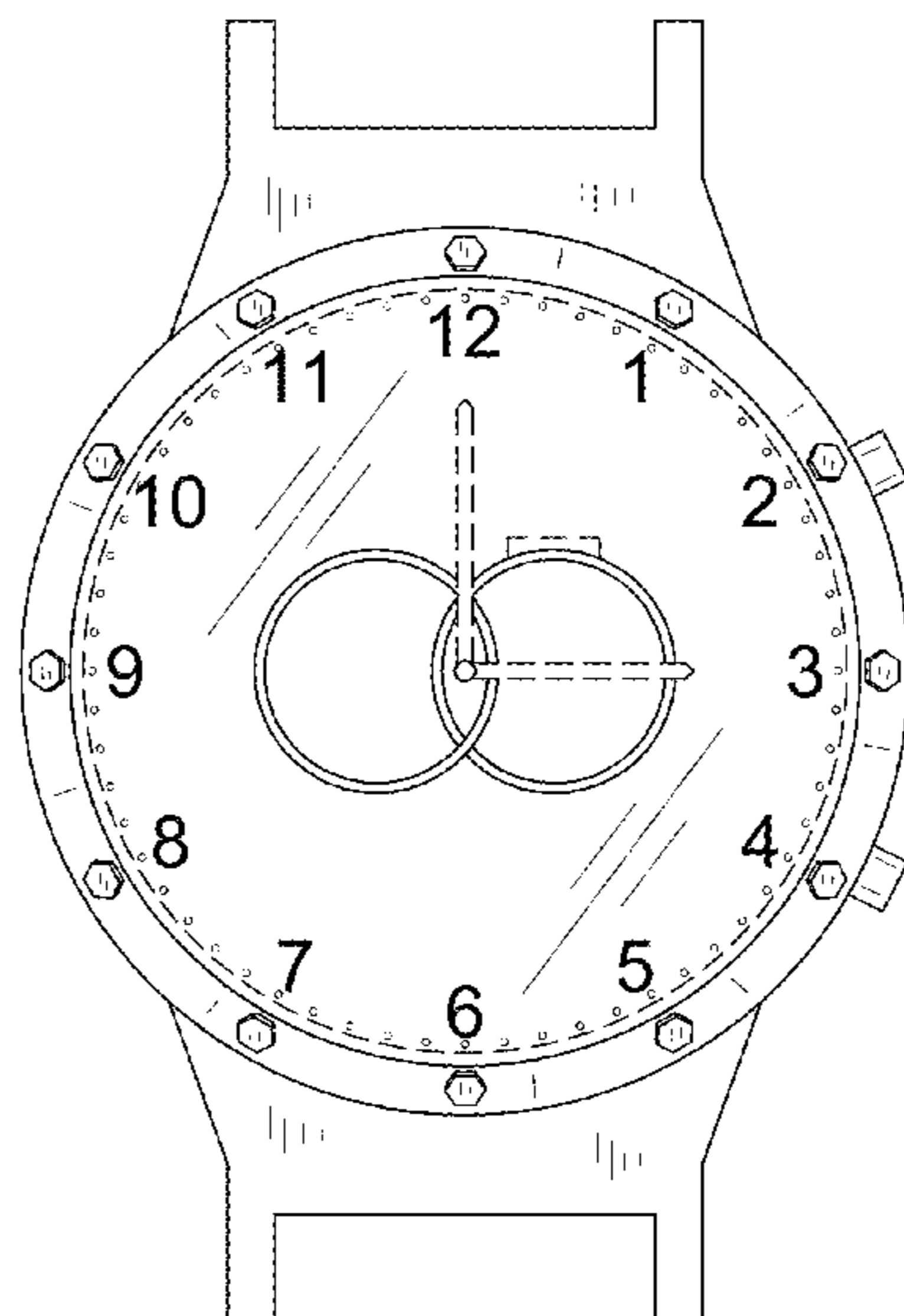

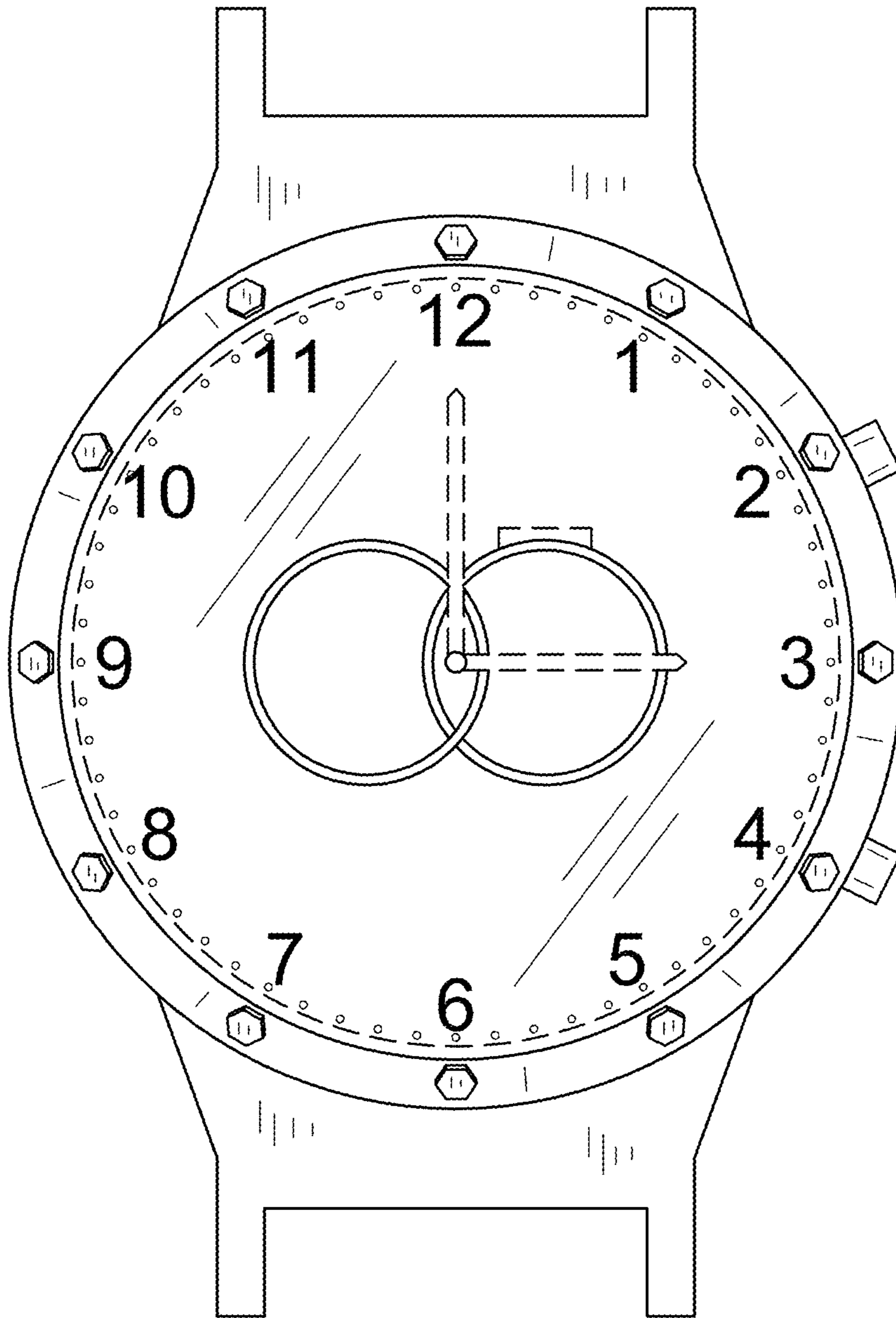

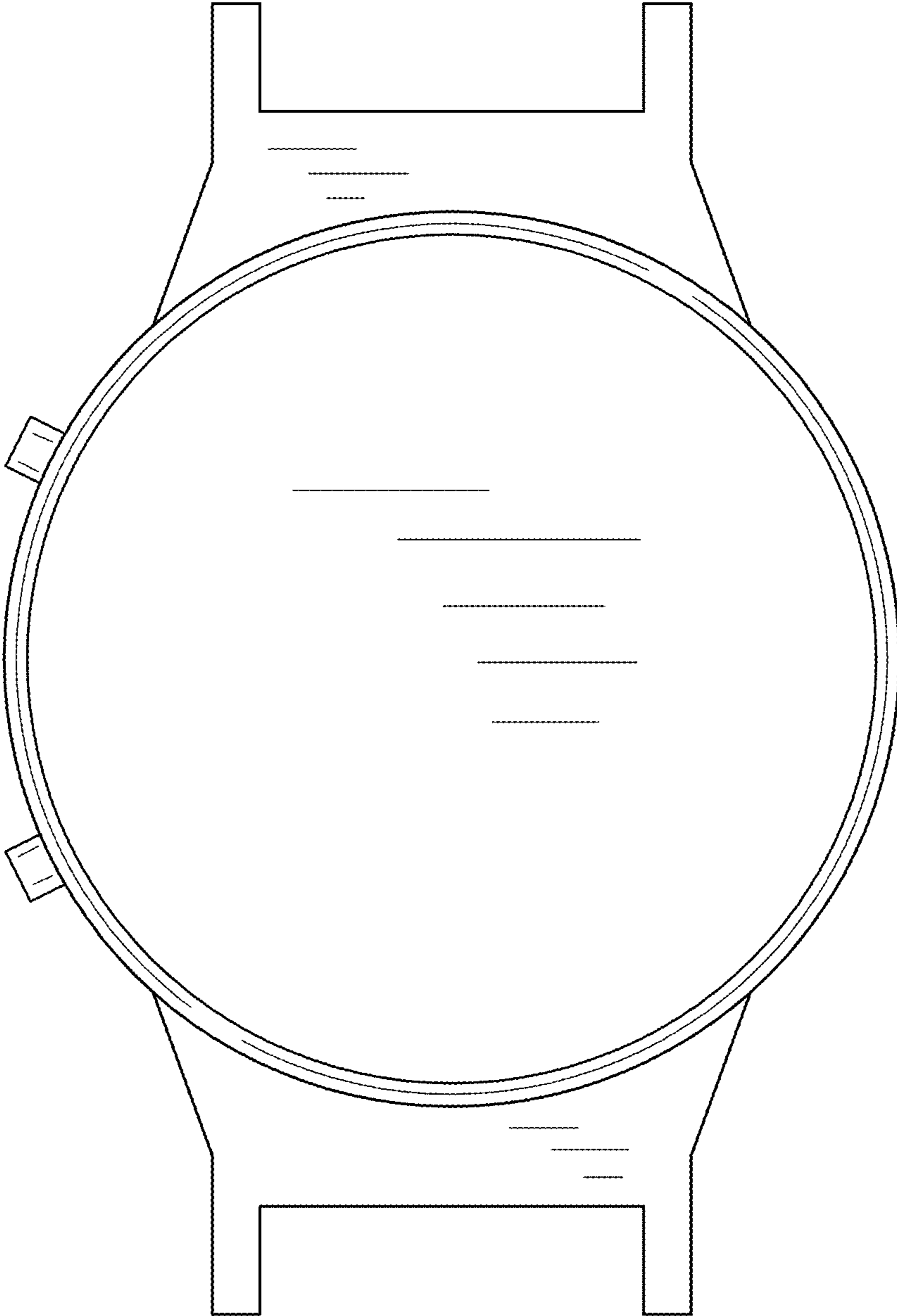

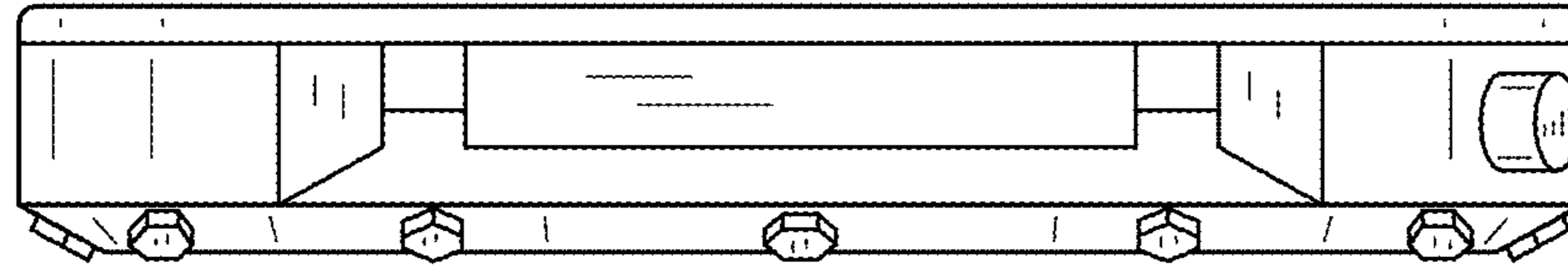

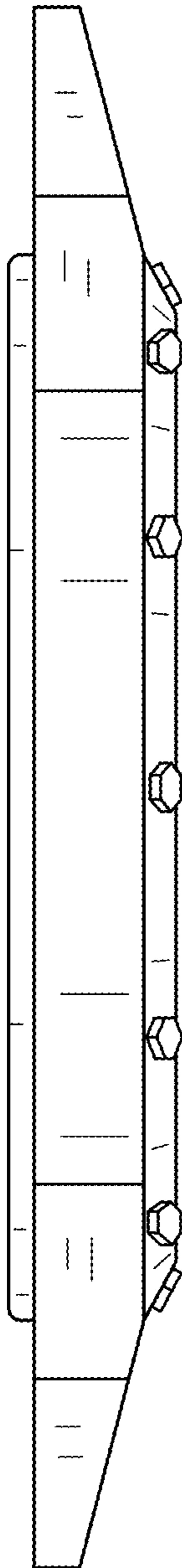

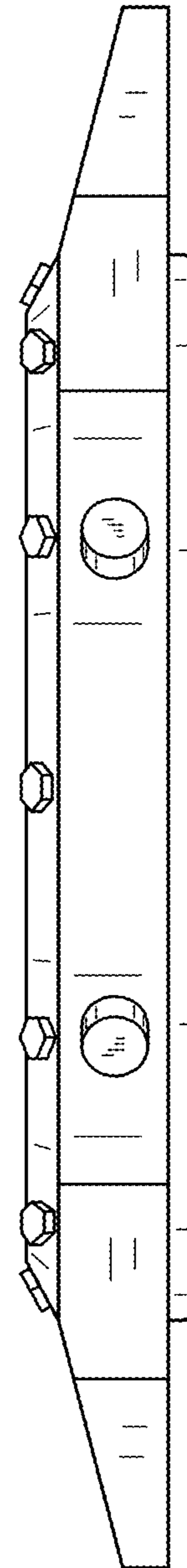
