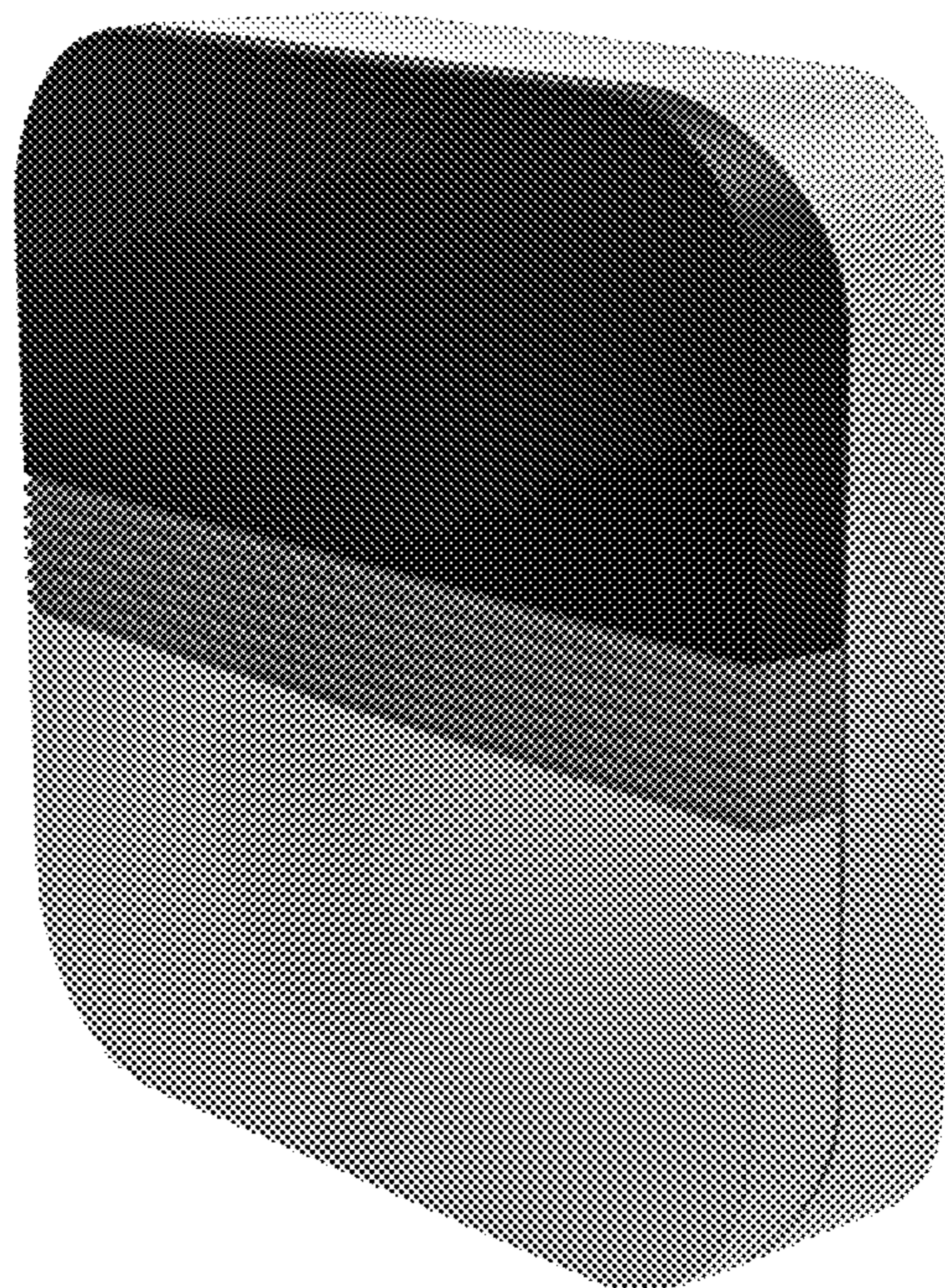
The ornamental design for a doorbell, as shown and described.

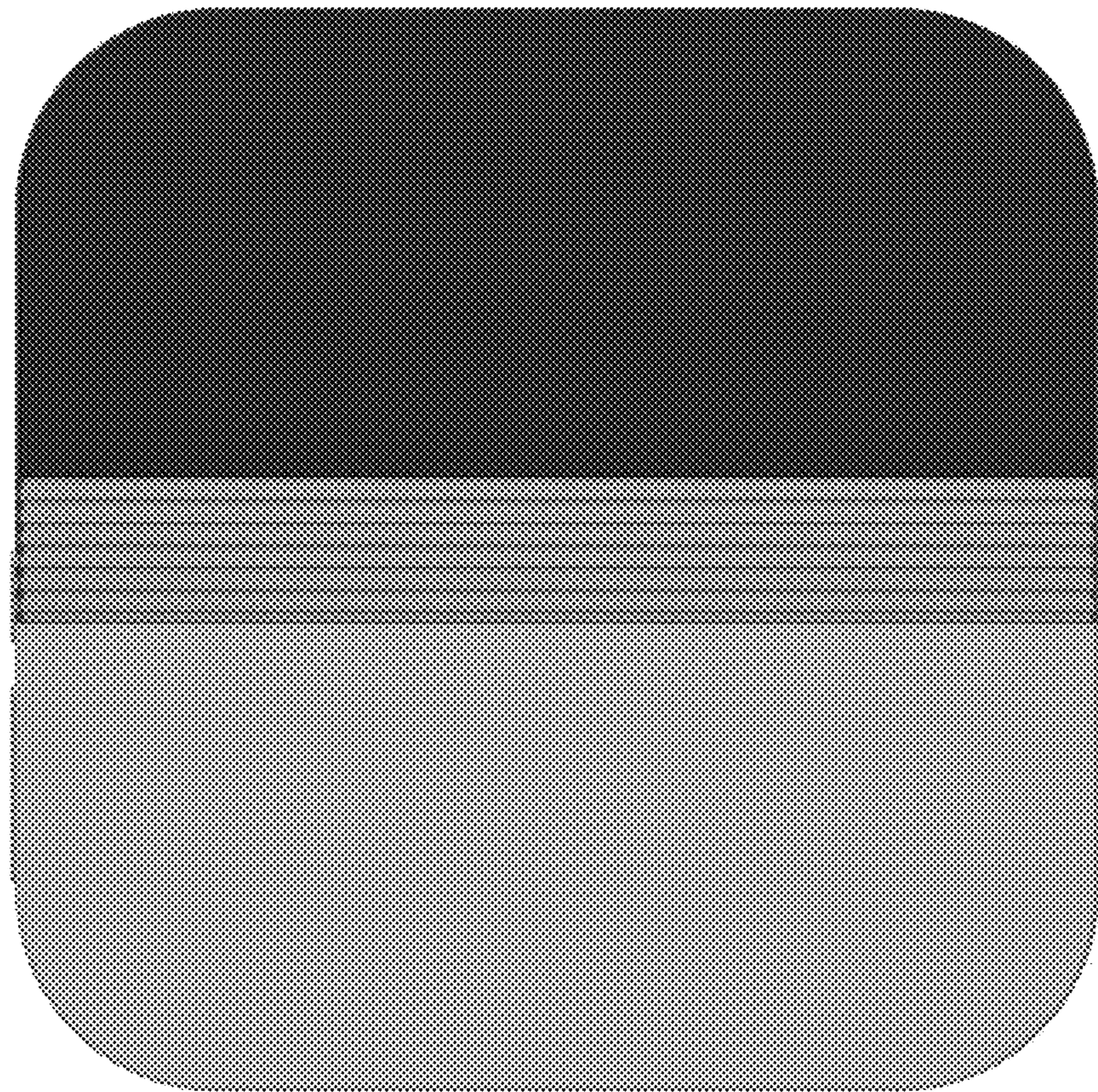

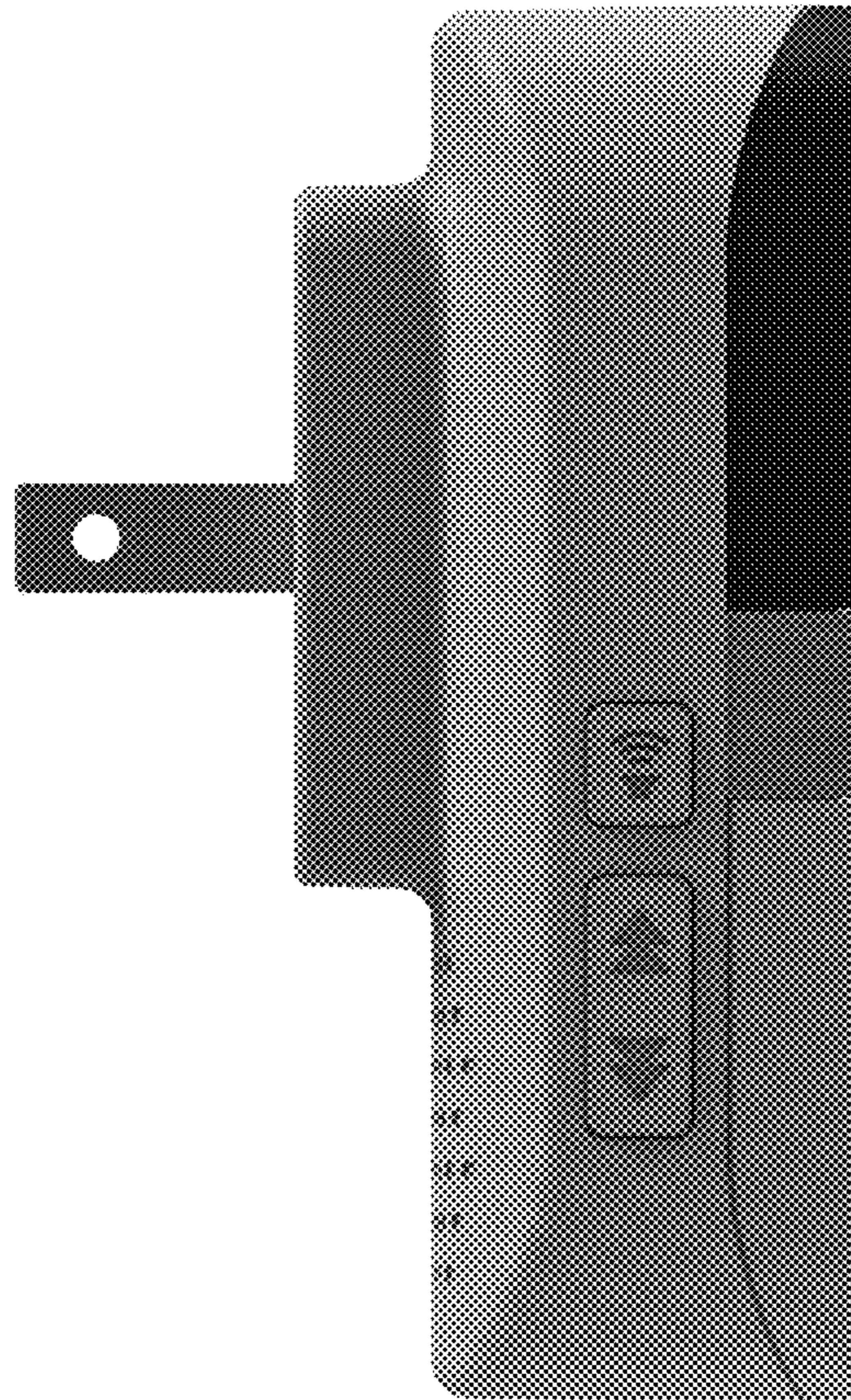

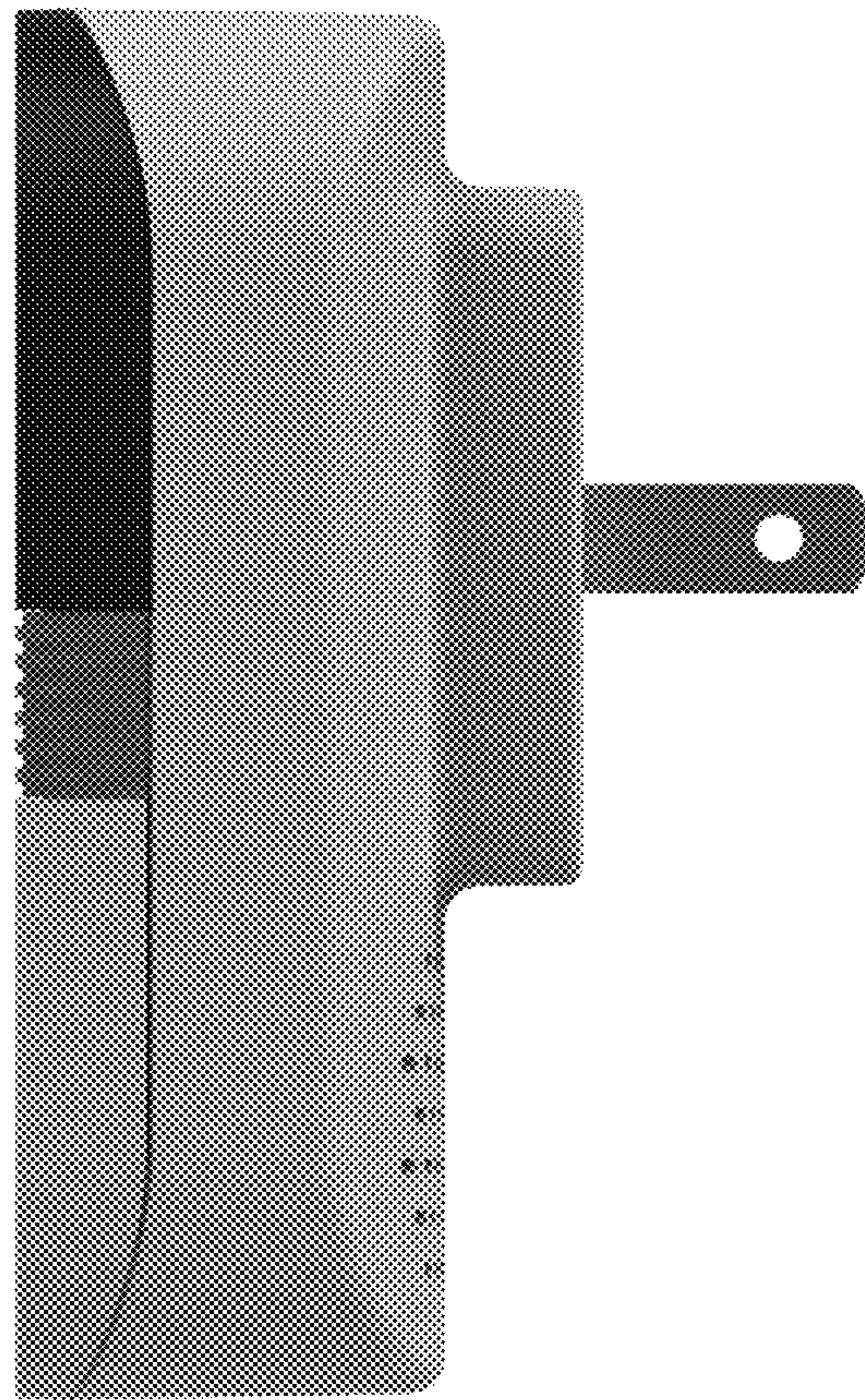

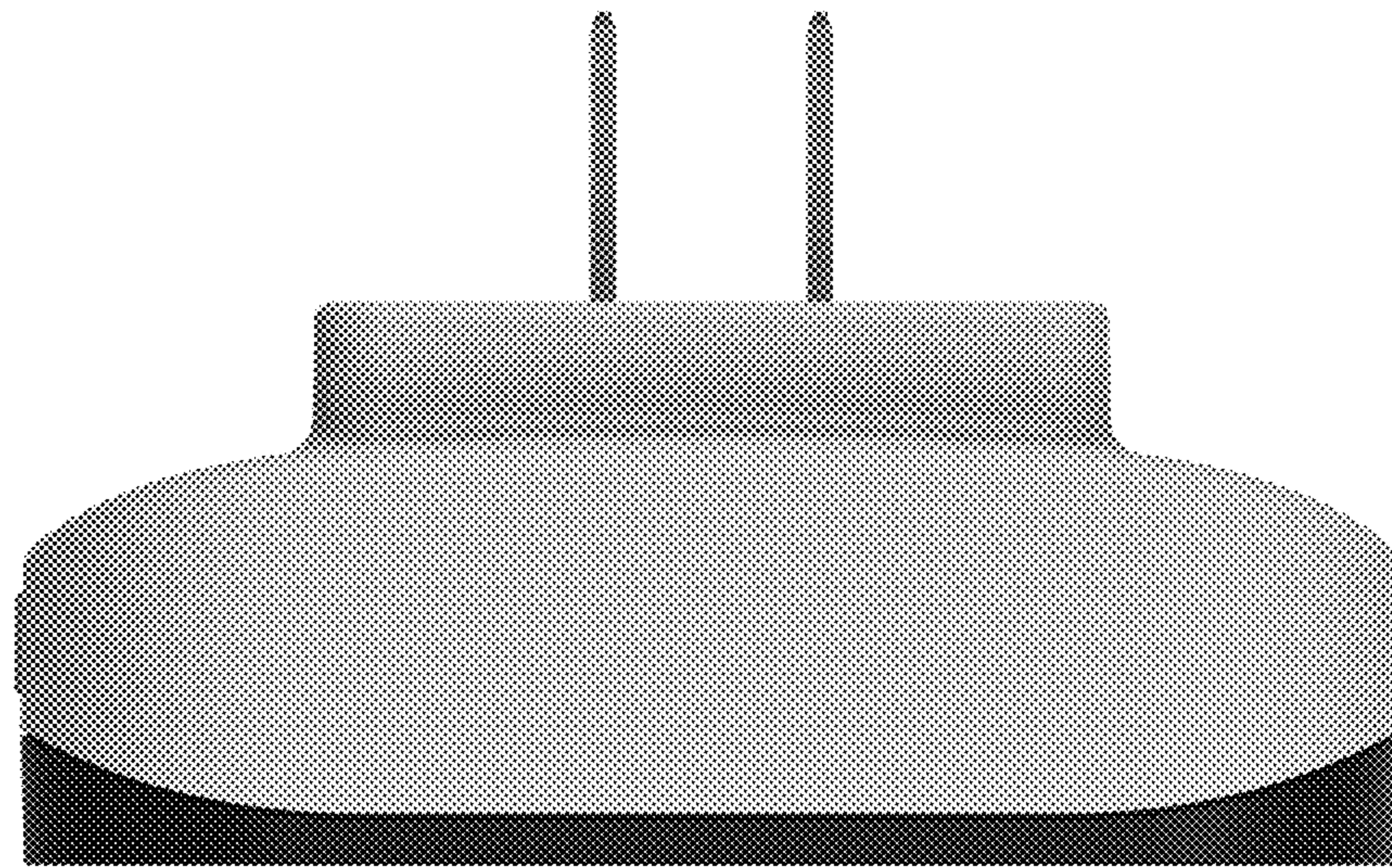

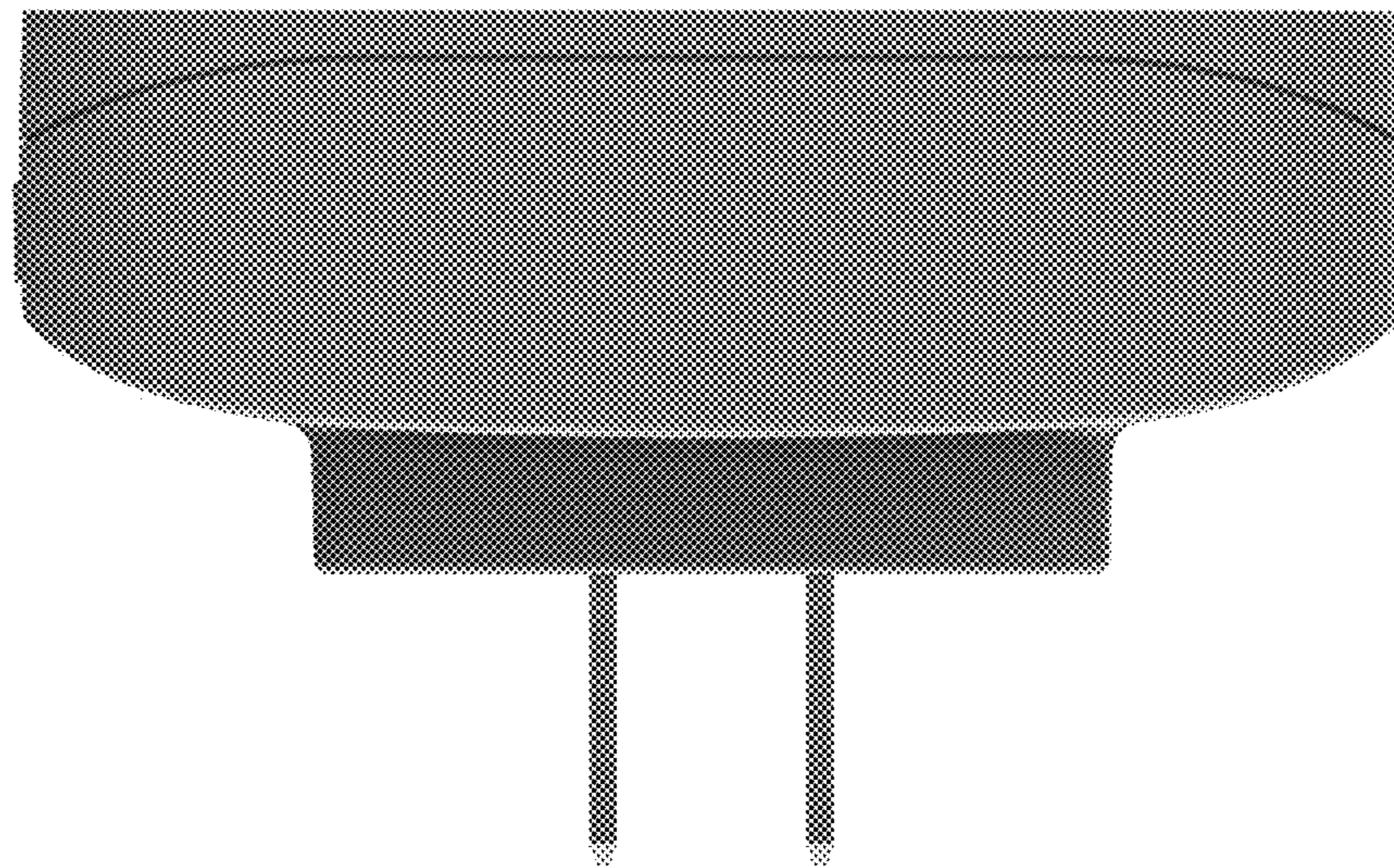

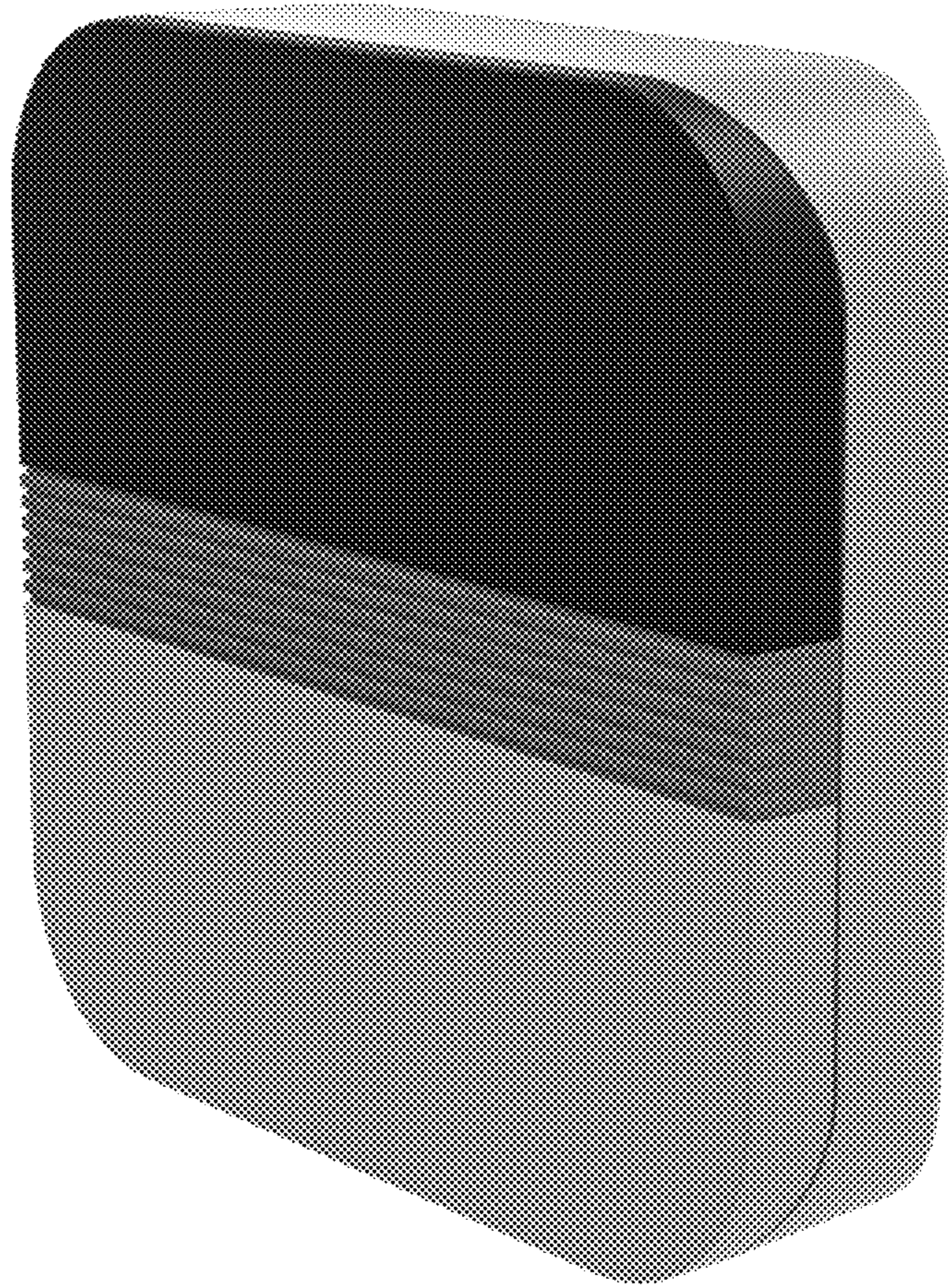

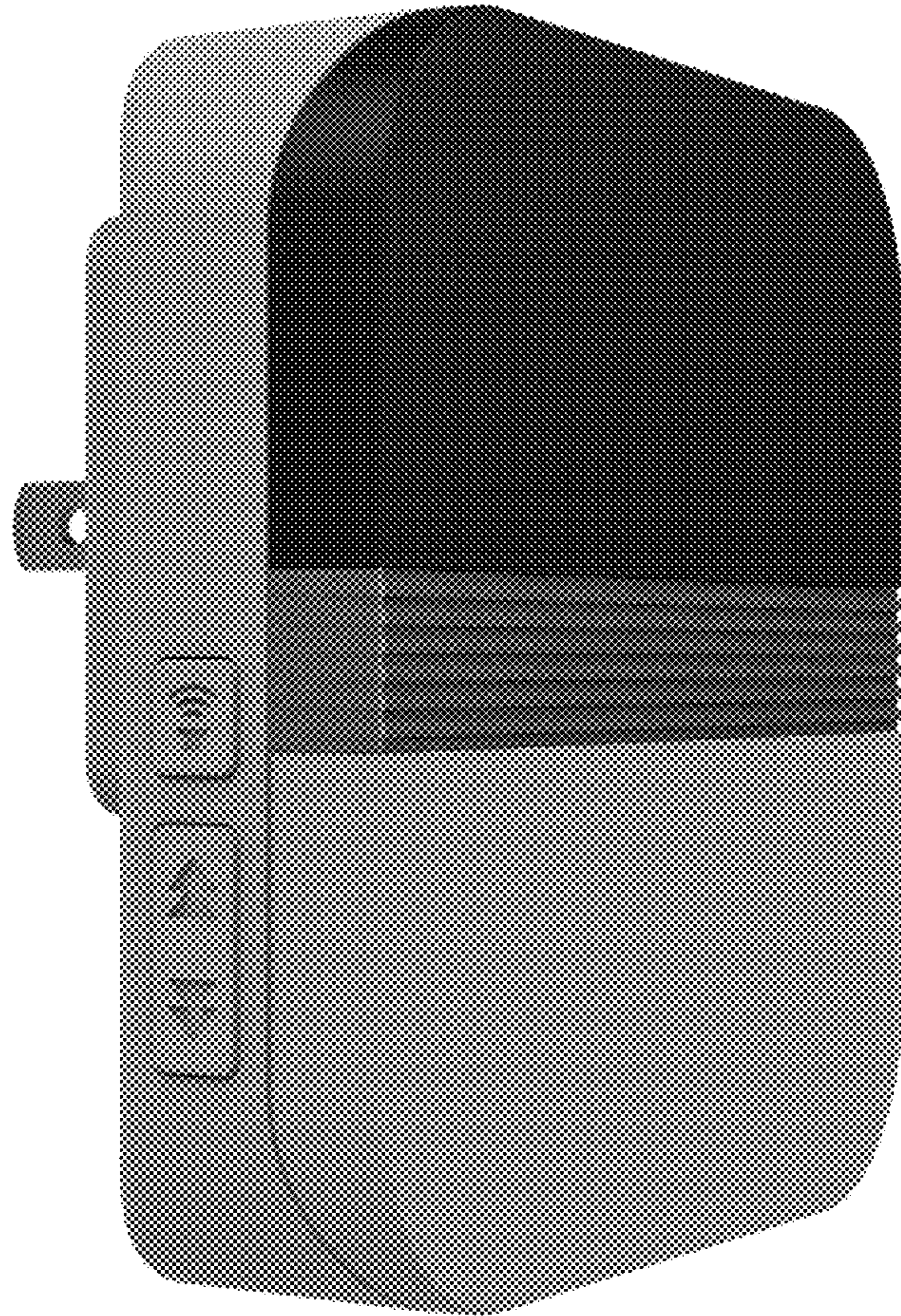

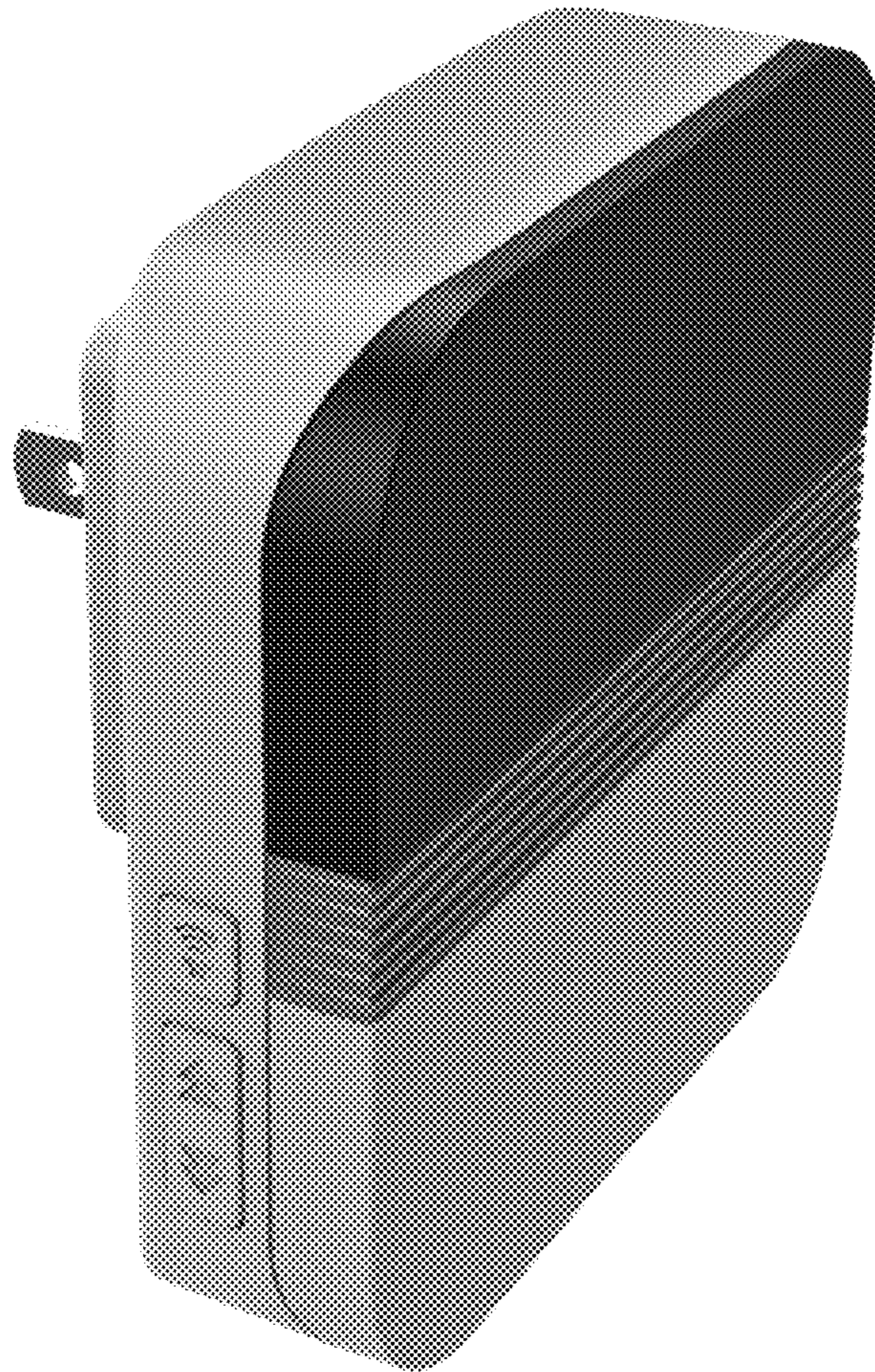

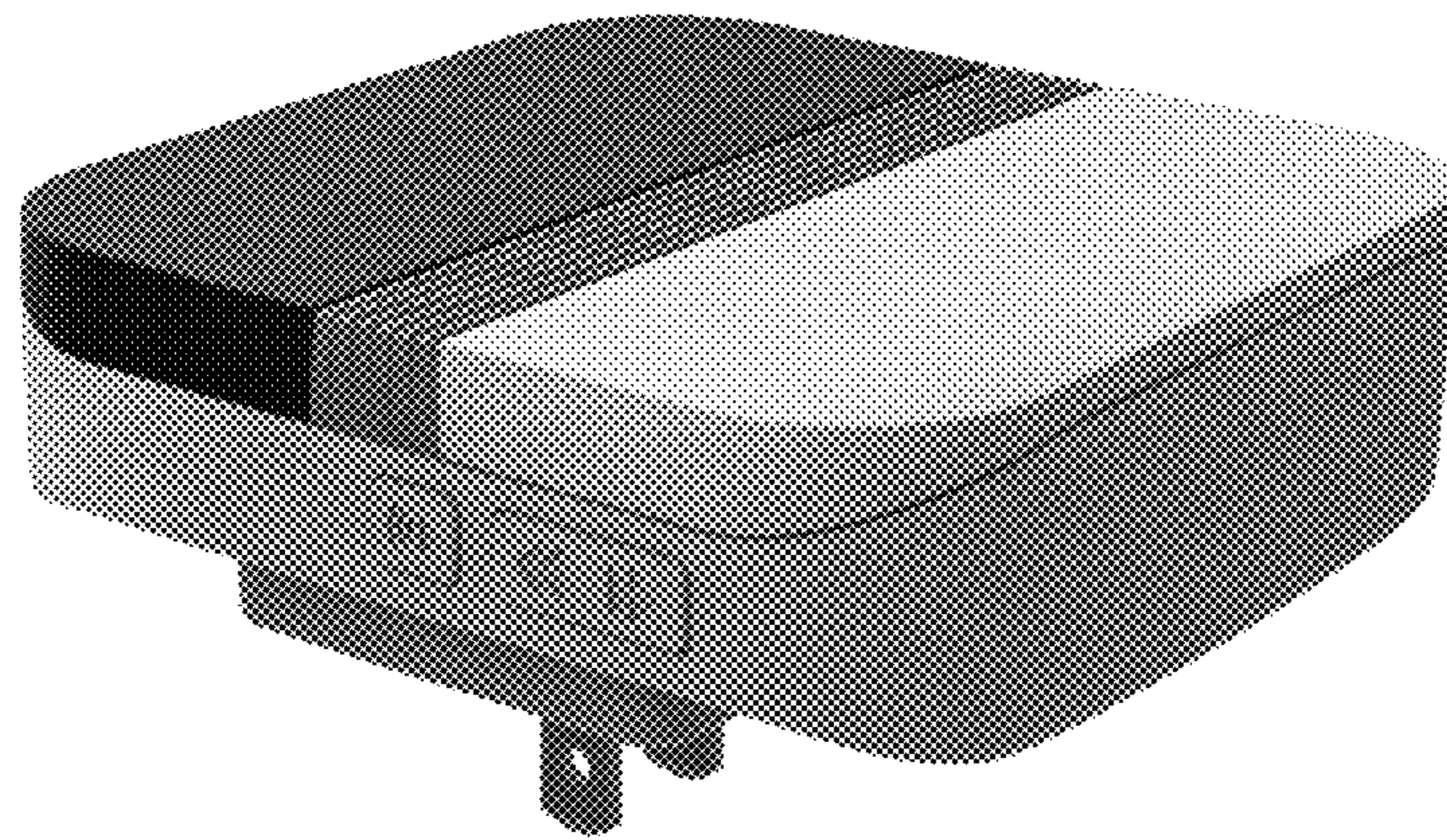
