(57) **CLAIM**

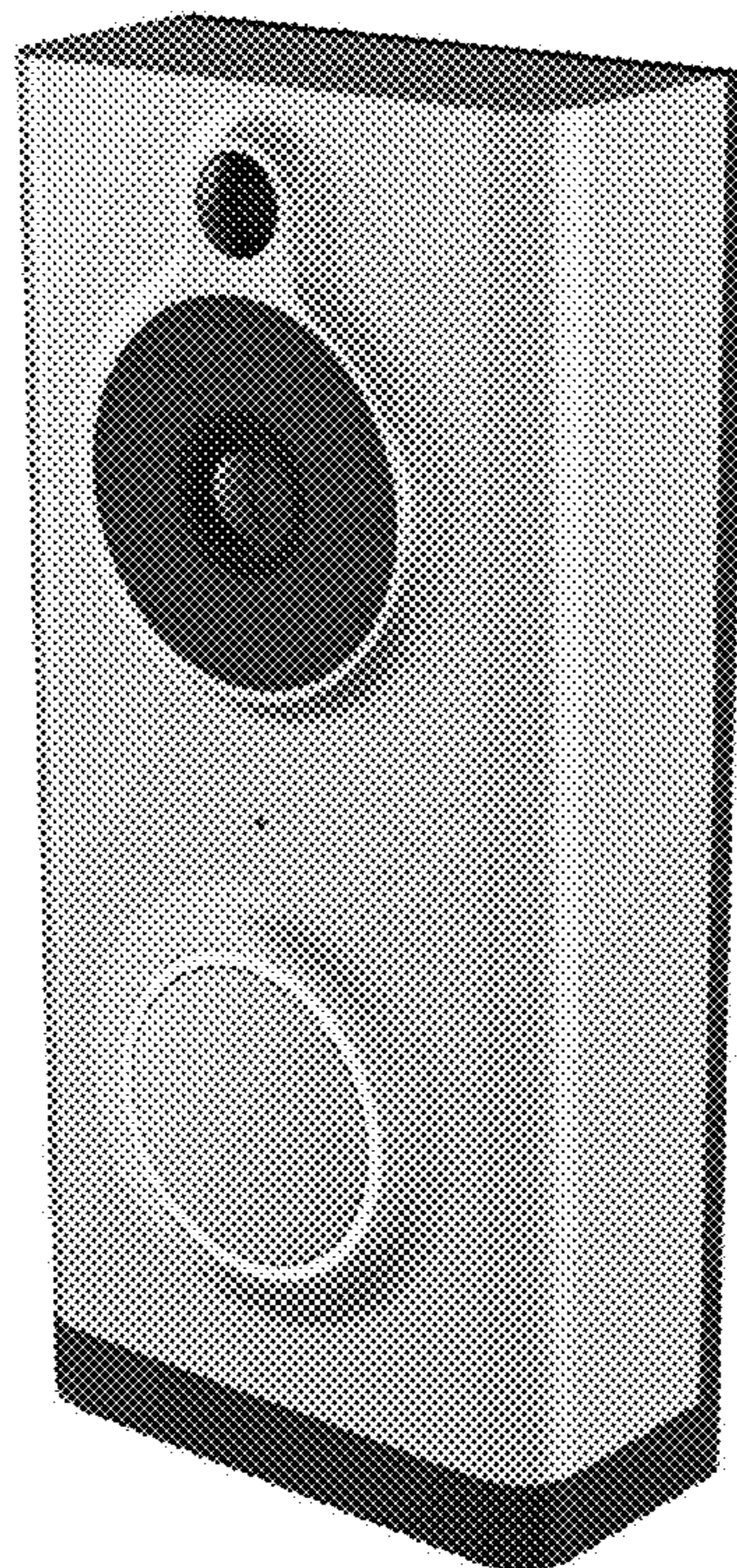
The ornamental design for a video doorbell, as shown and described.

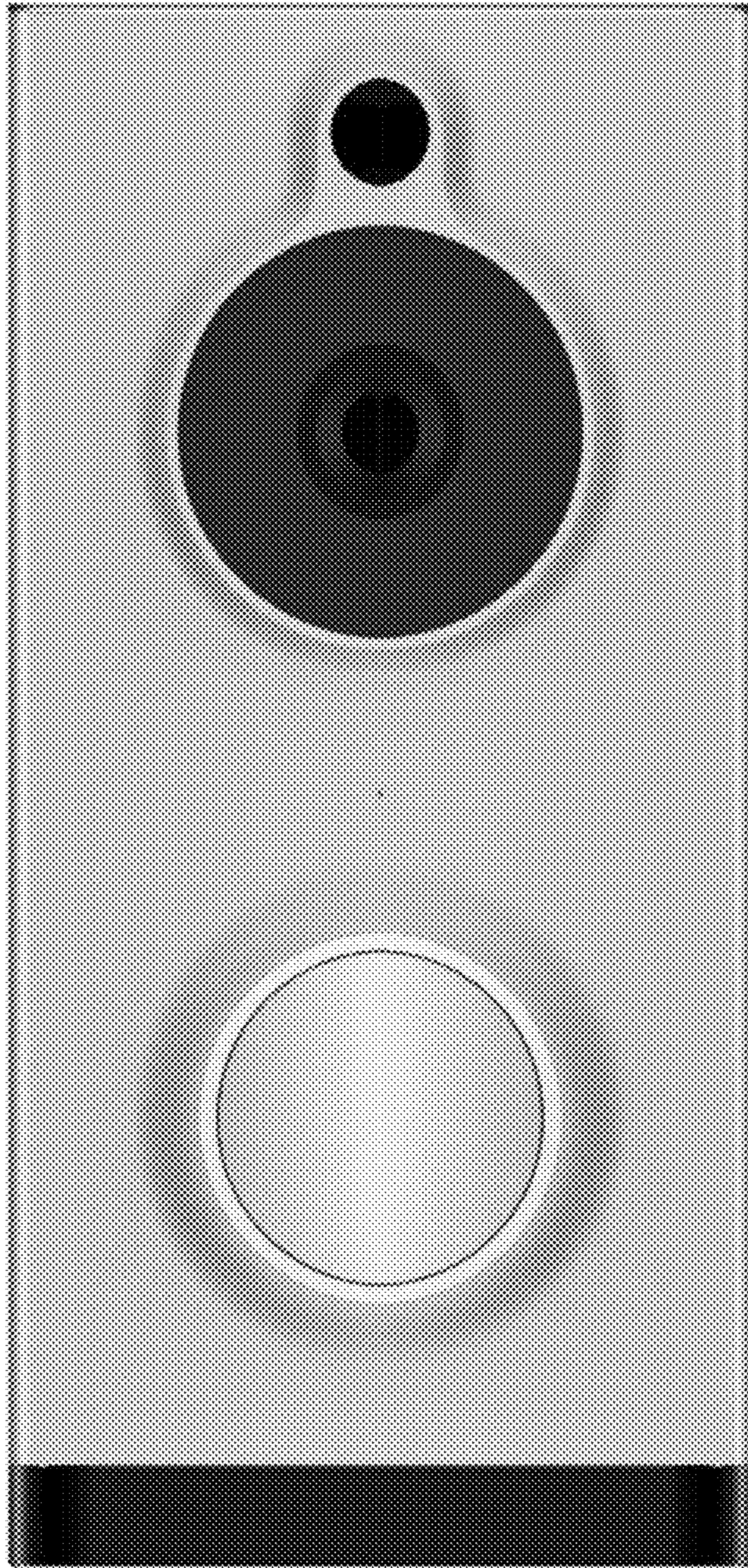

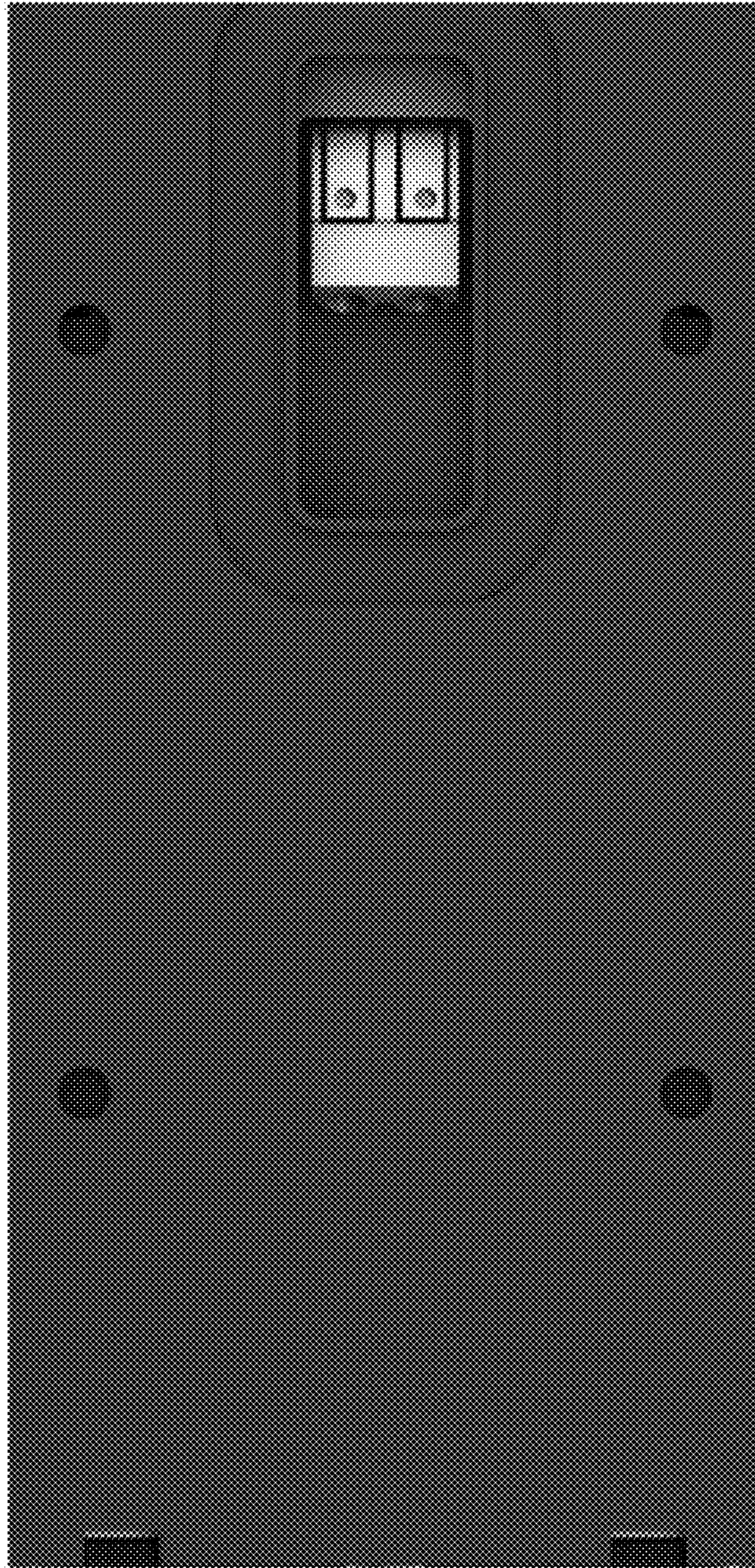

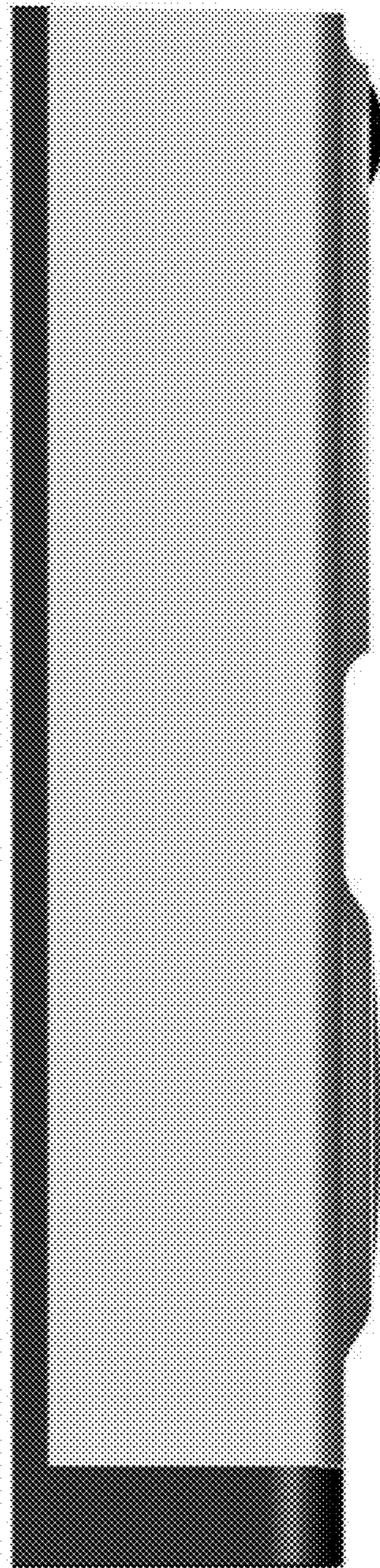

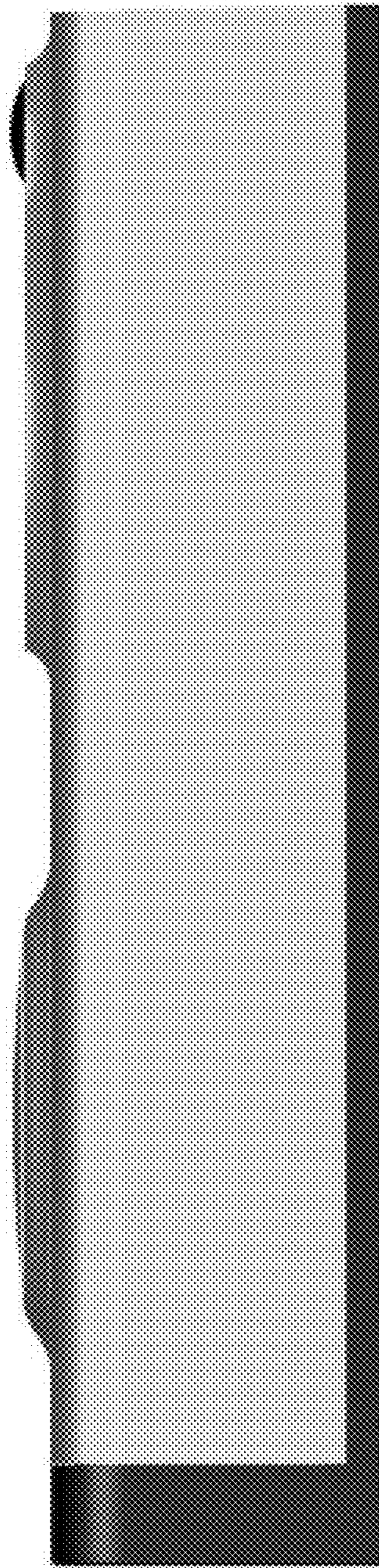

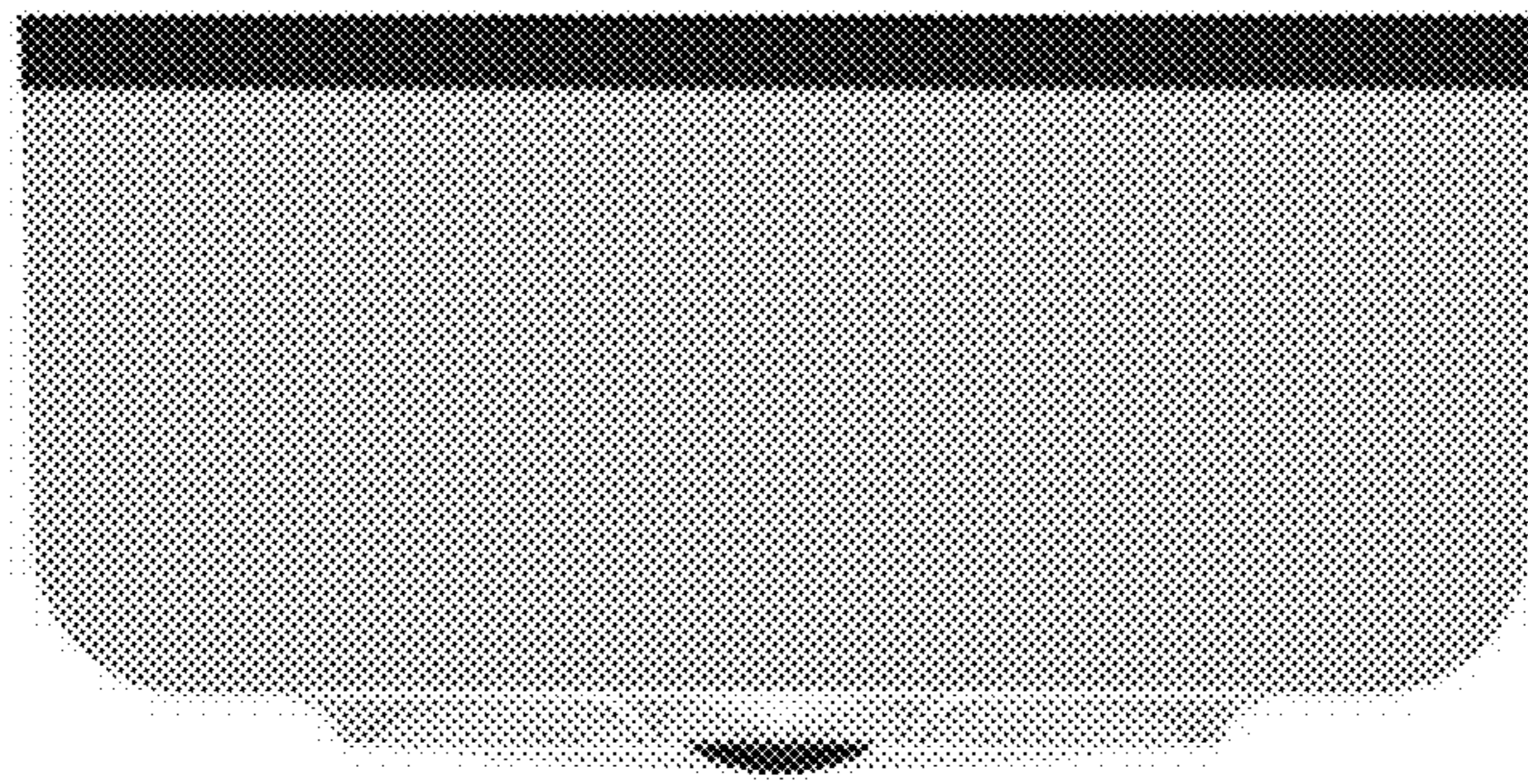

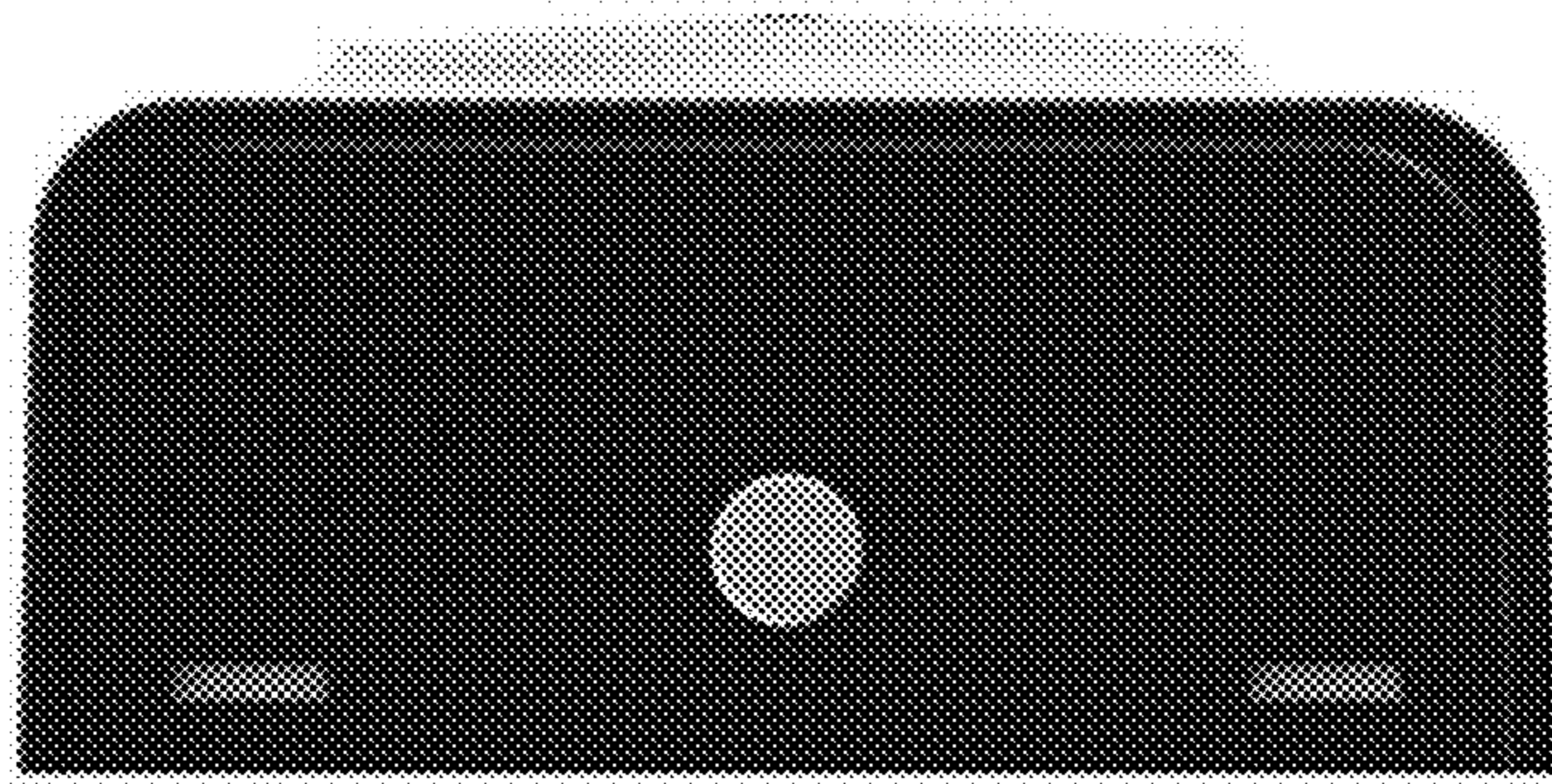

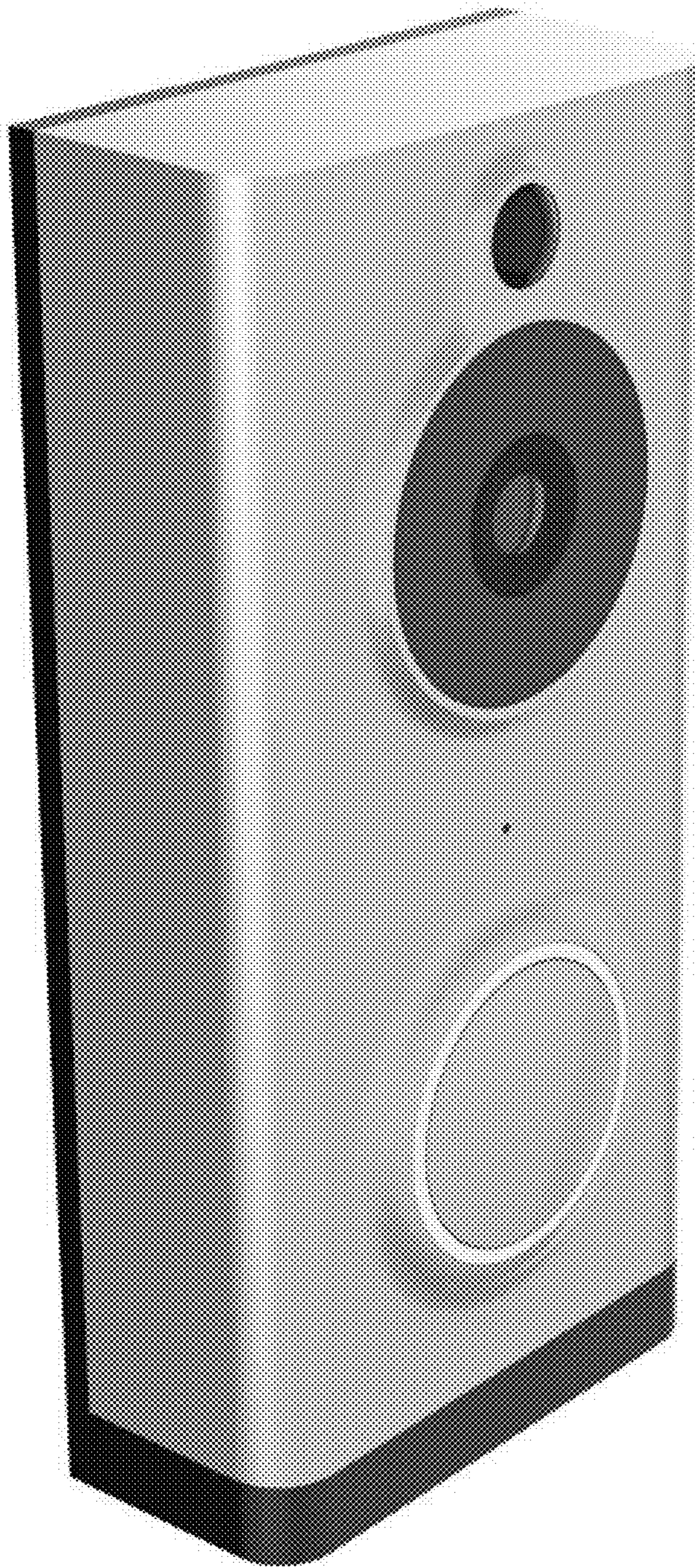

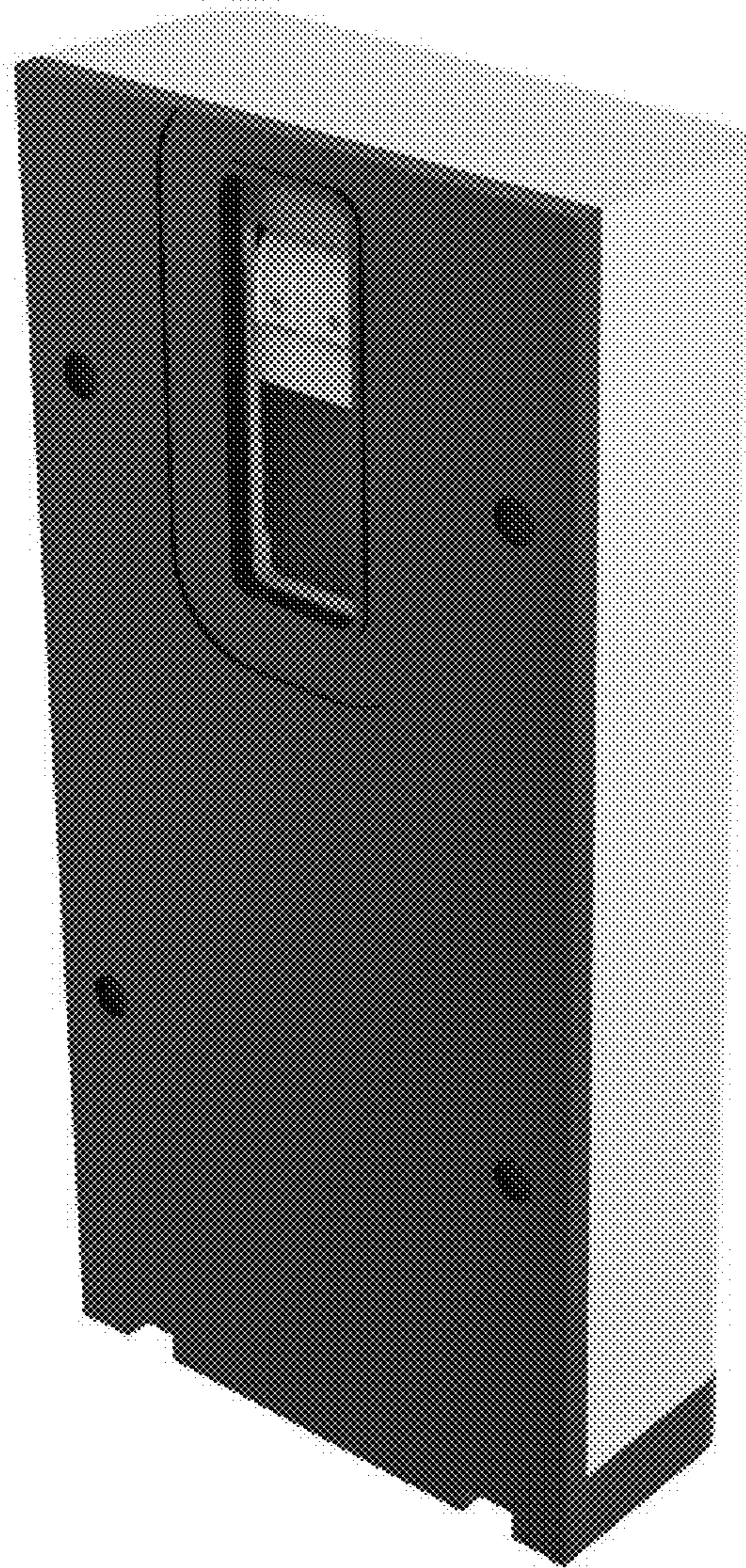
