The ornamental design for a vehicle bumper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vehicle bumper;
FIG. 2 is a left side elevational view thereof;

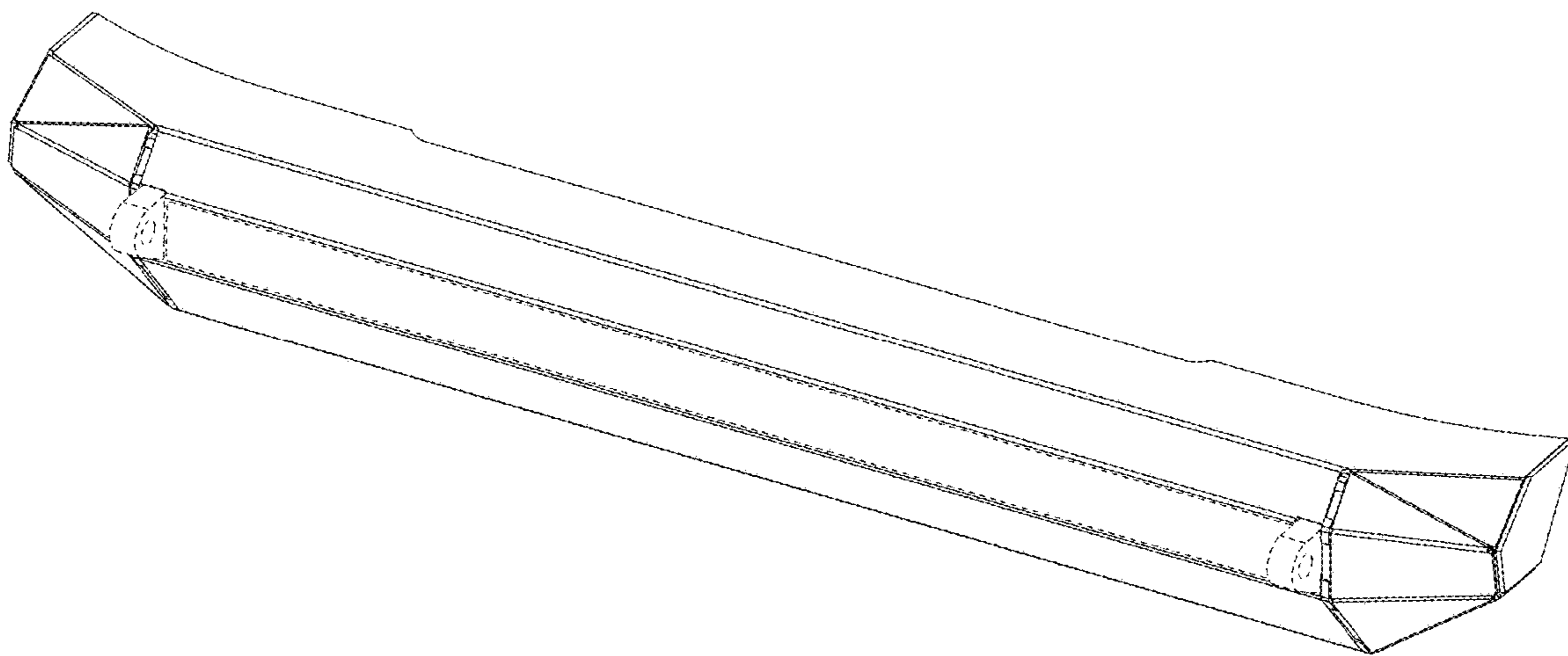

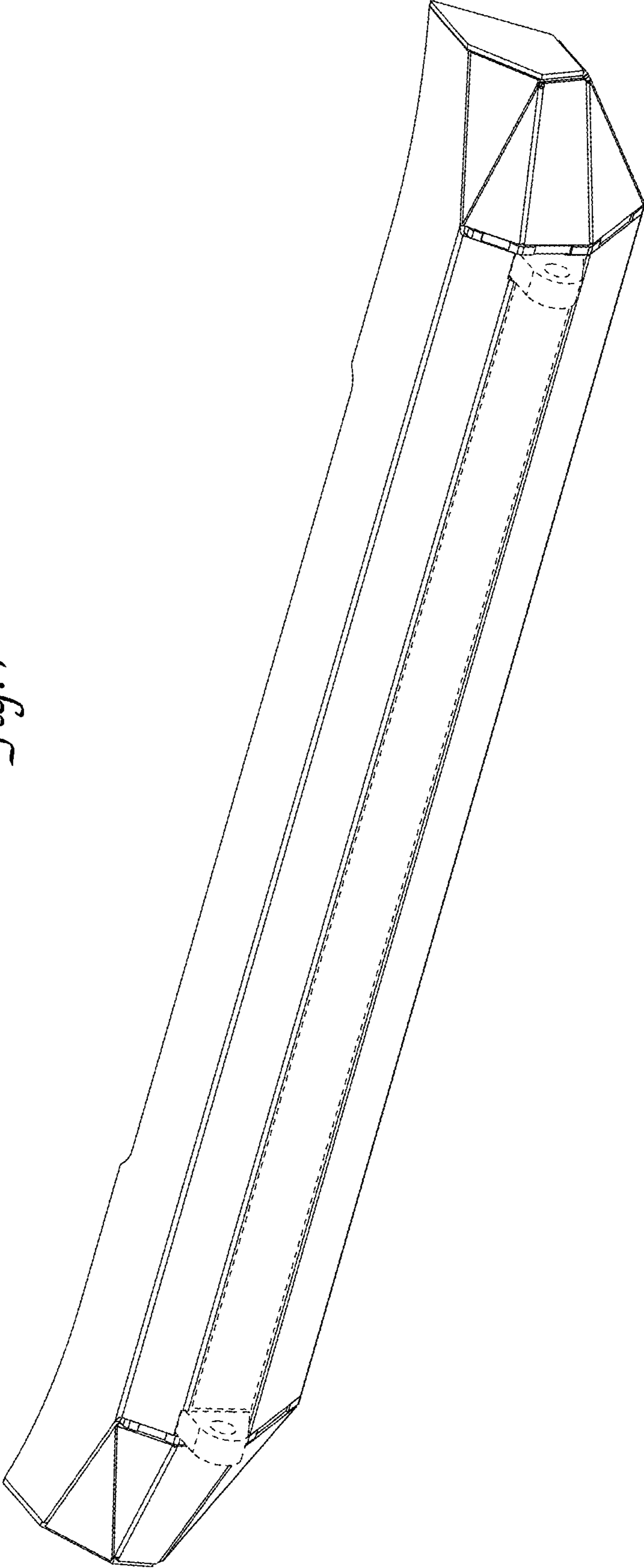

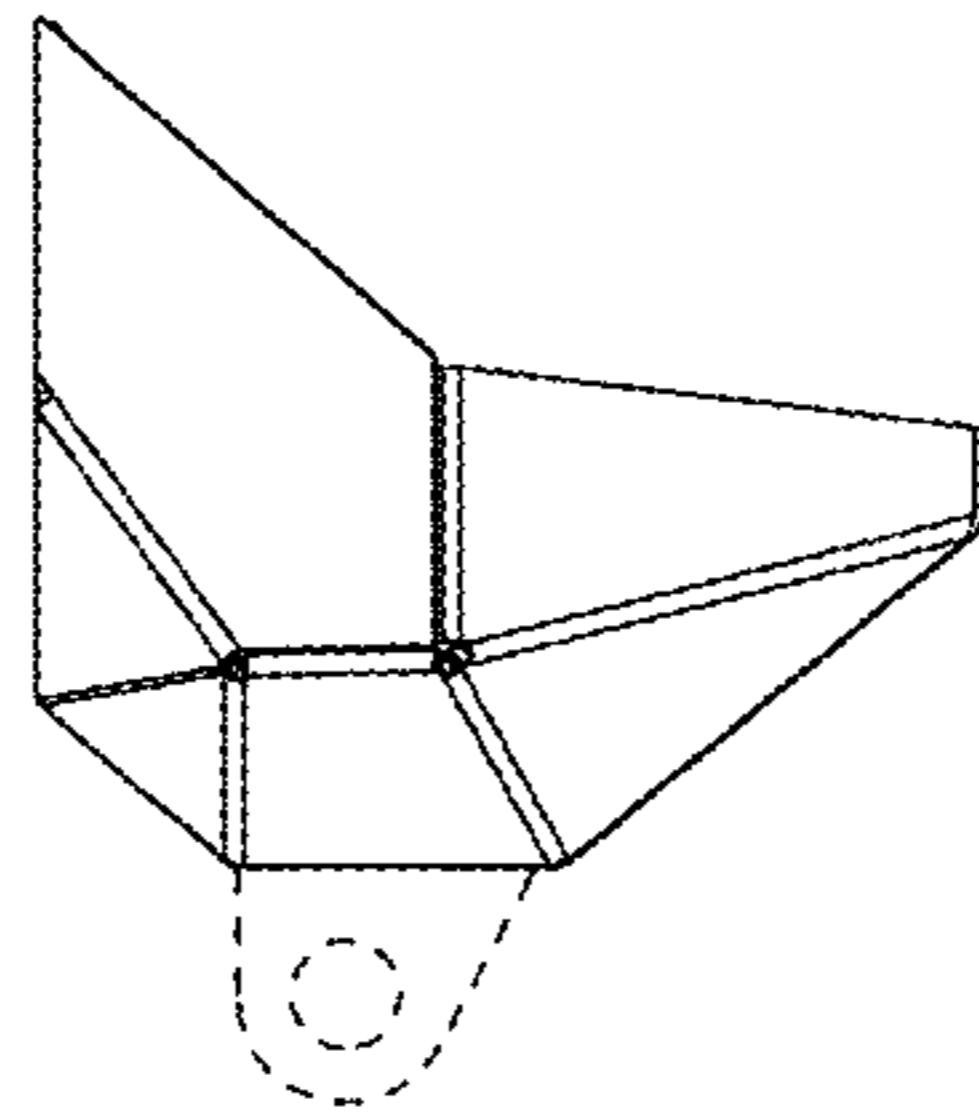

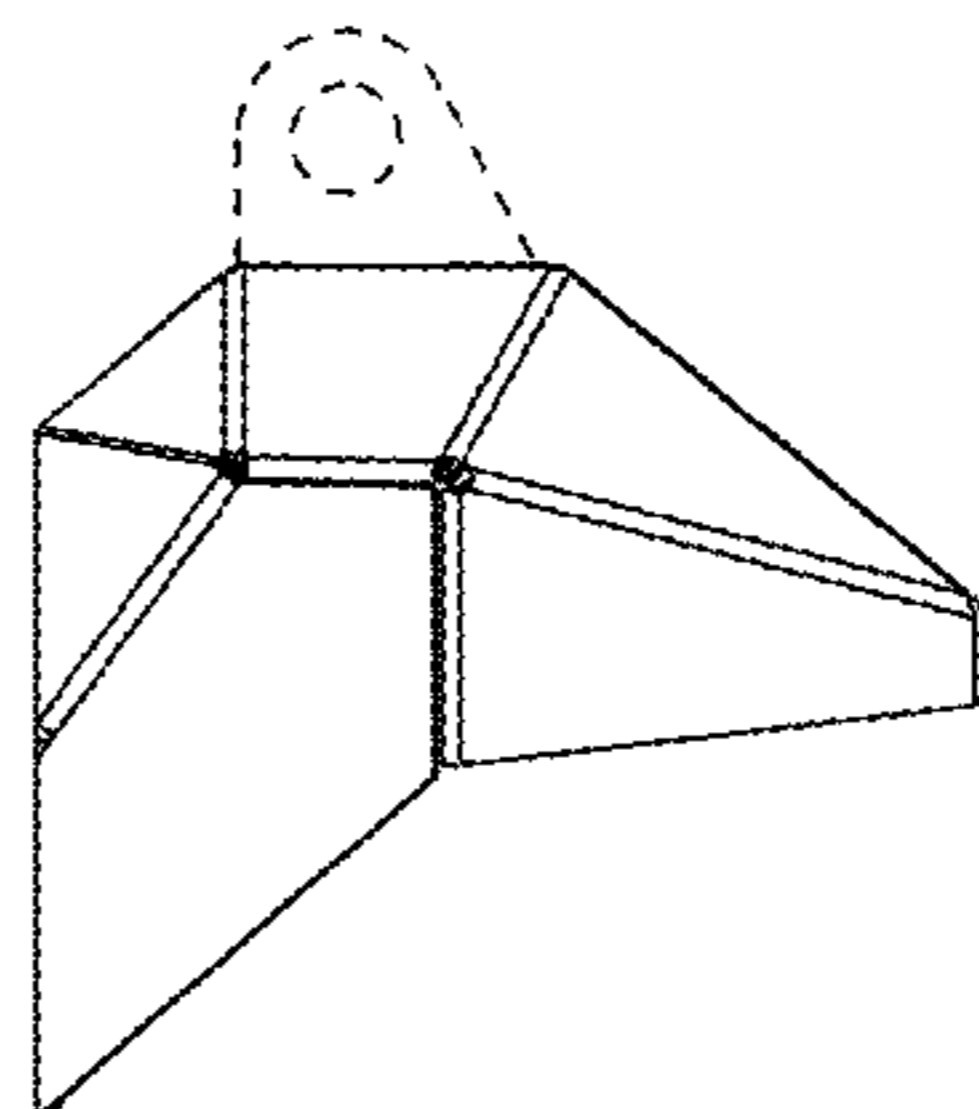

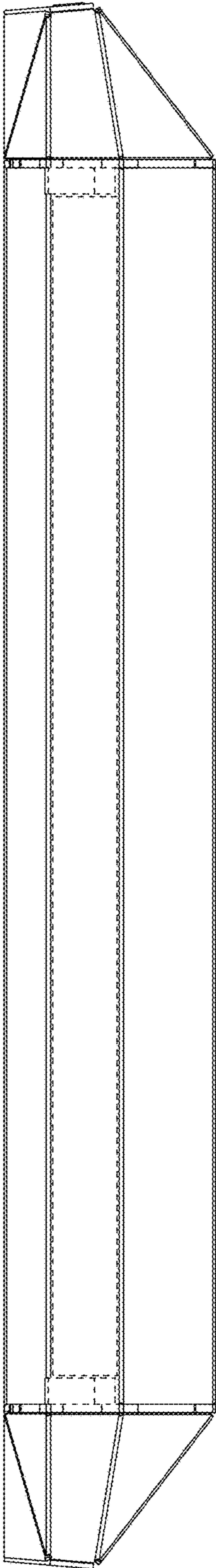

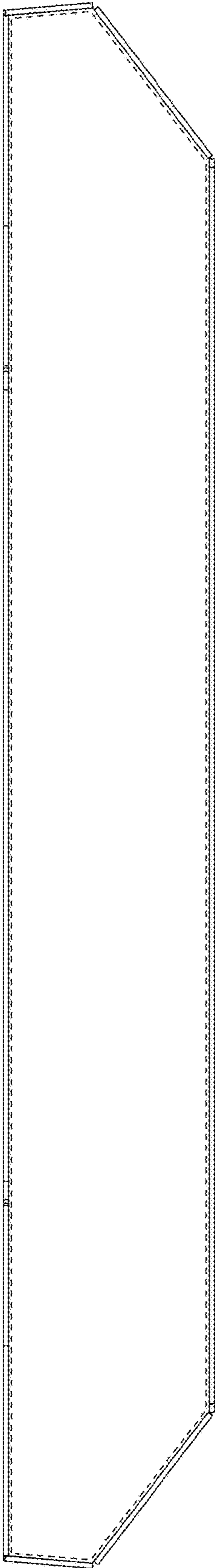

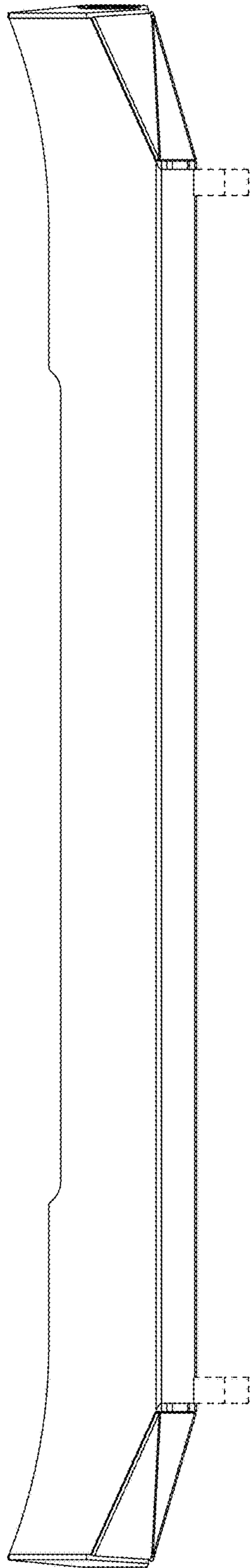
