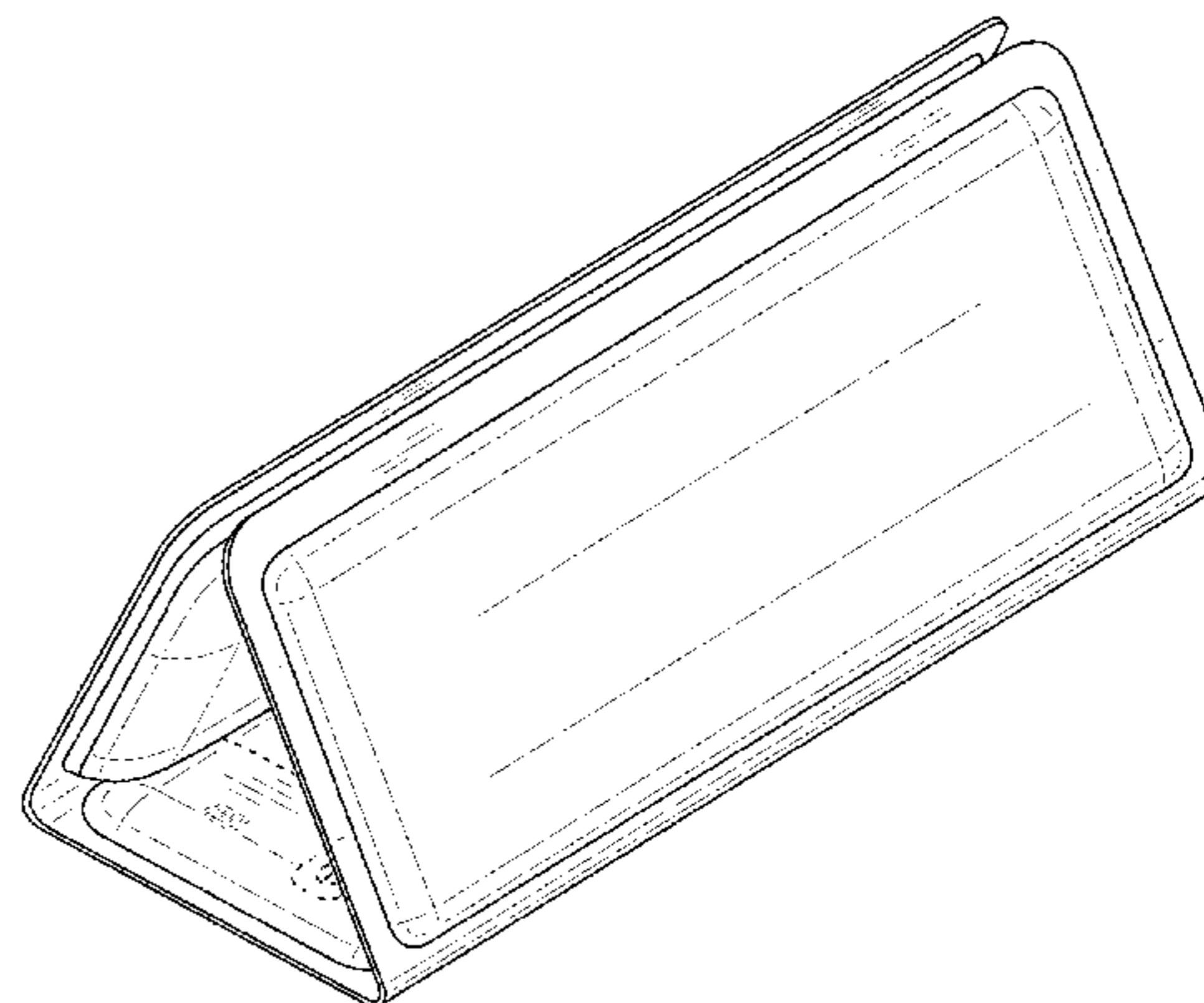
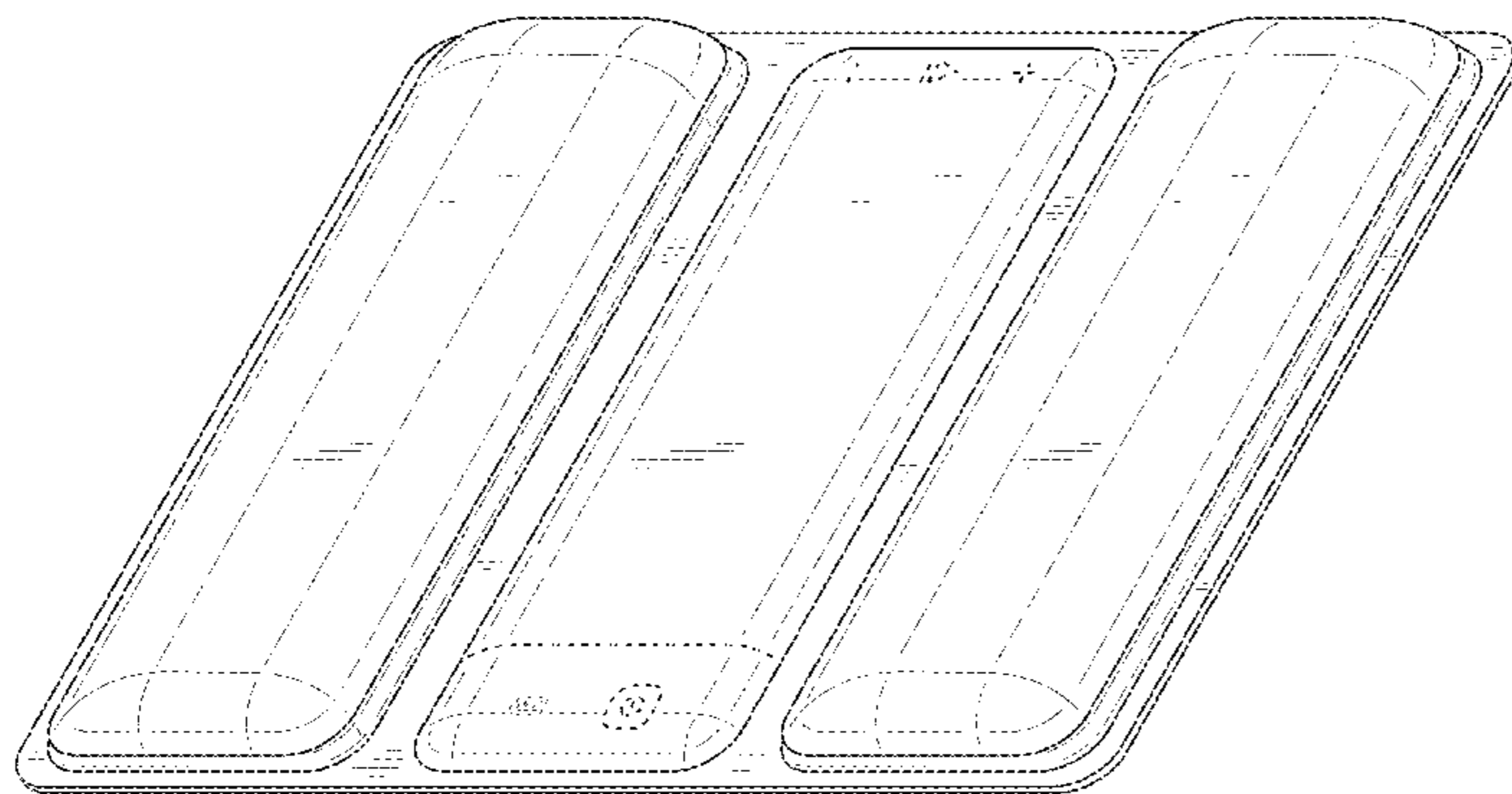
We claim the ornamental design for a speaker, as shown and described.

**DESCRIPTION**

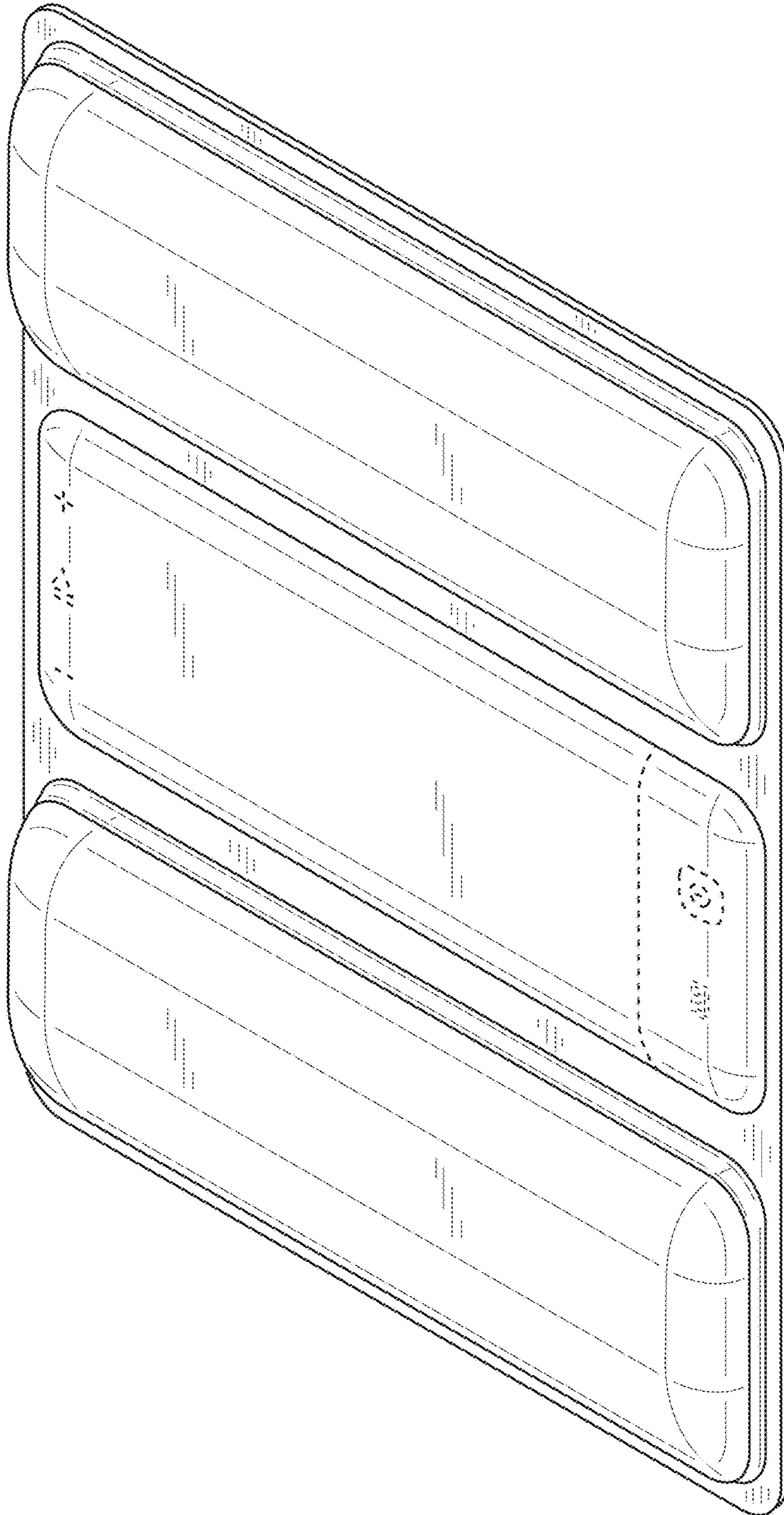

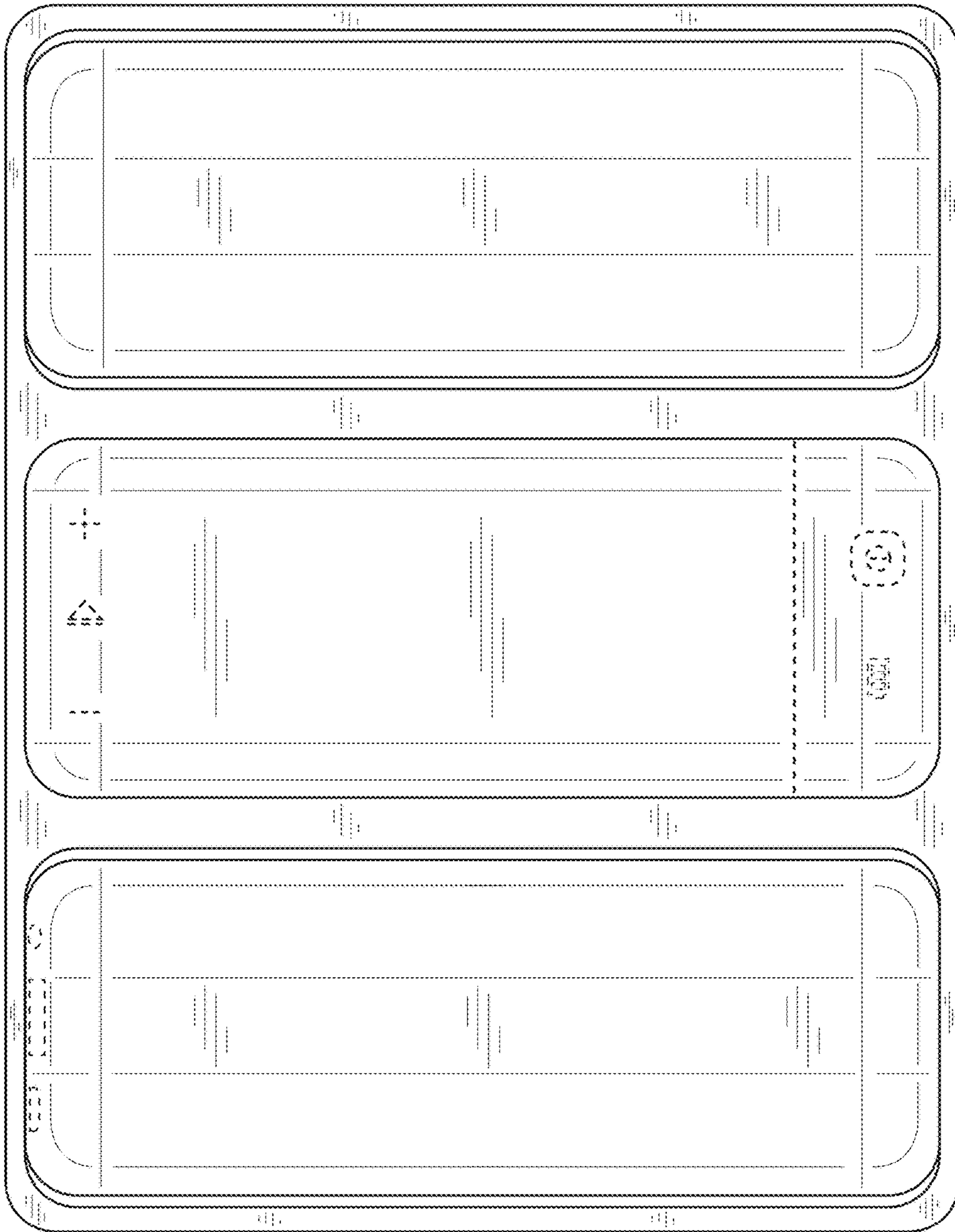

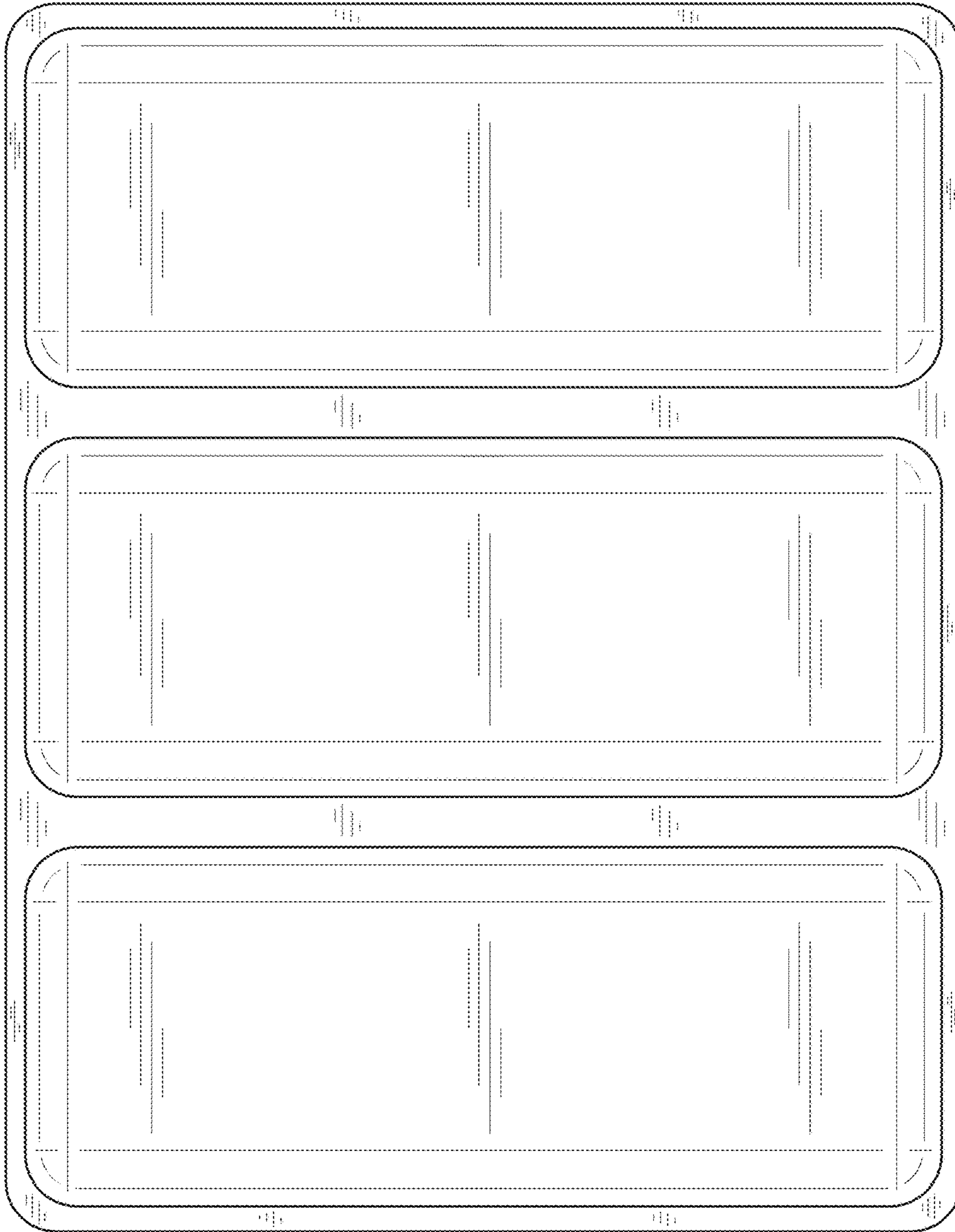

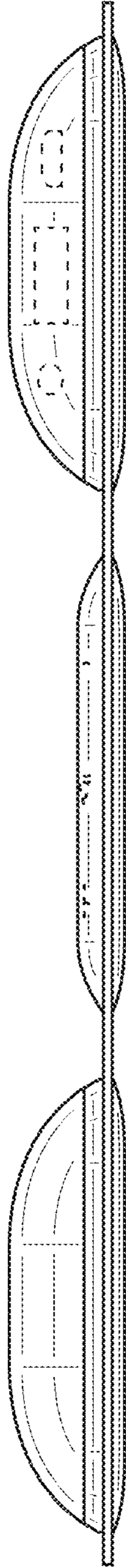

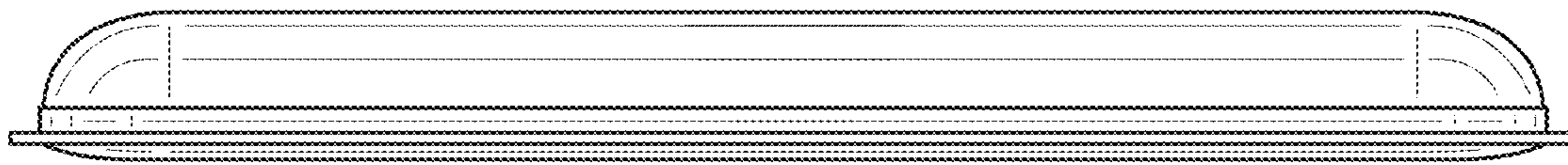

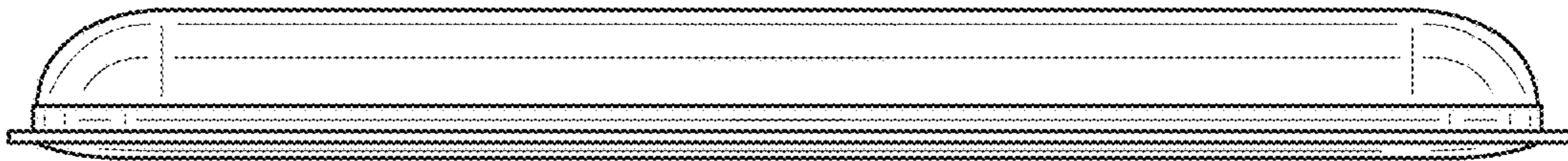

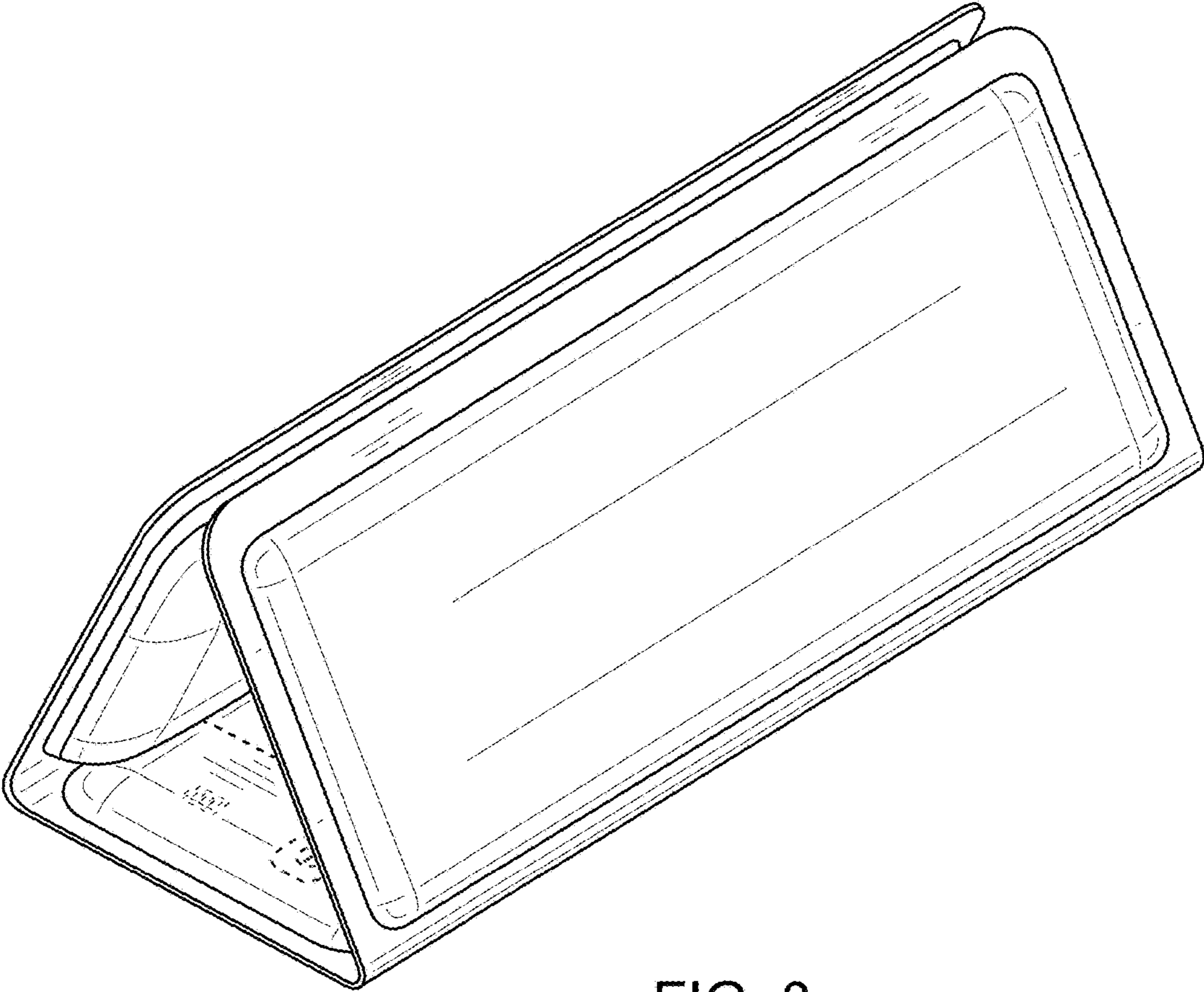

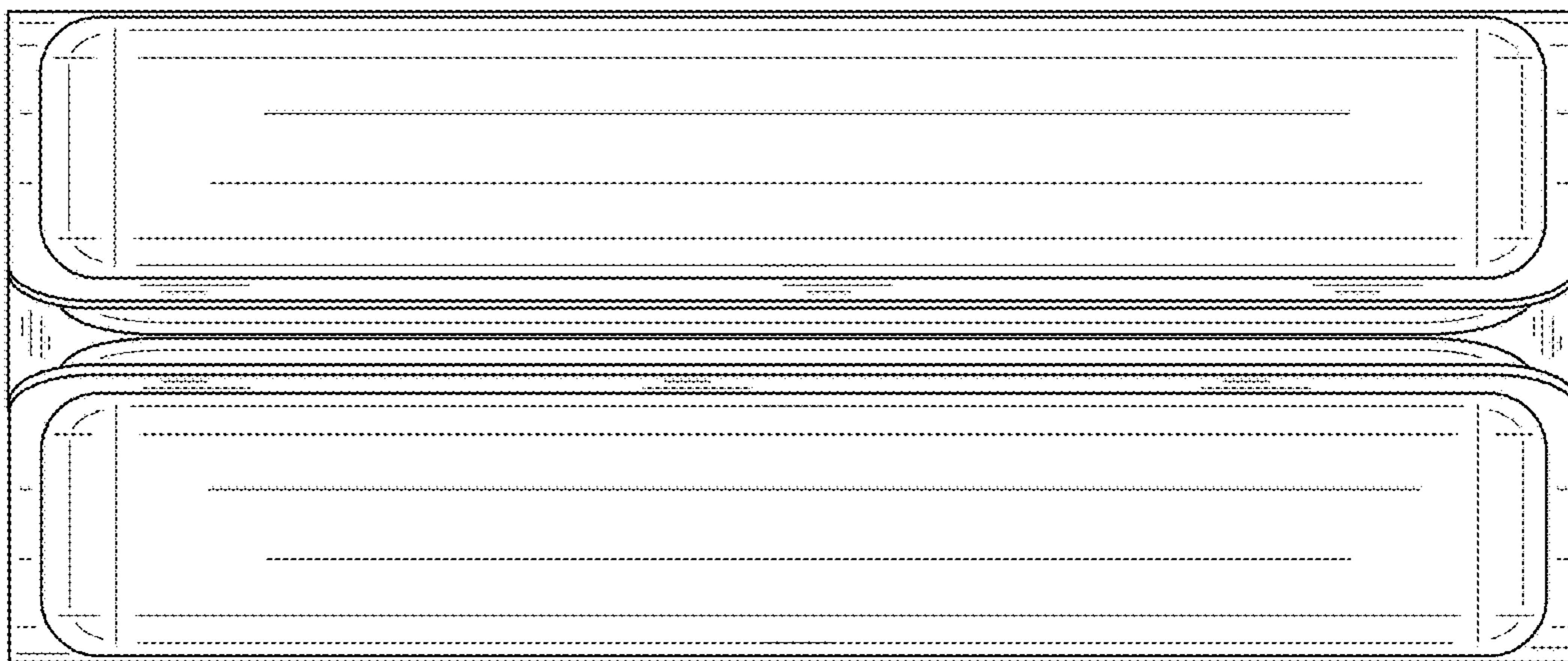

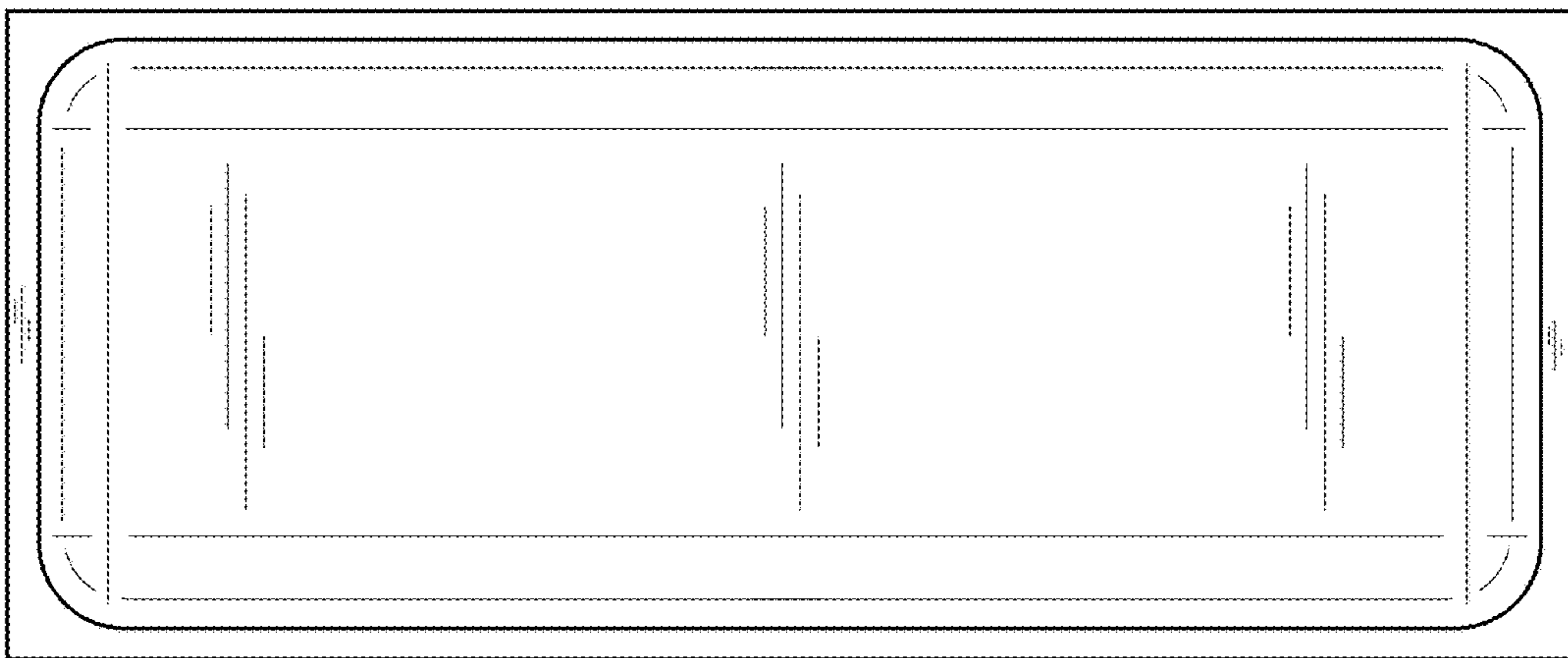

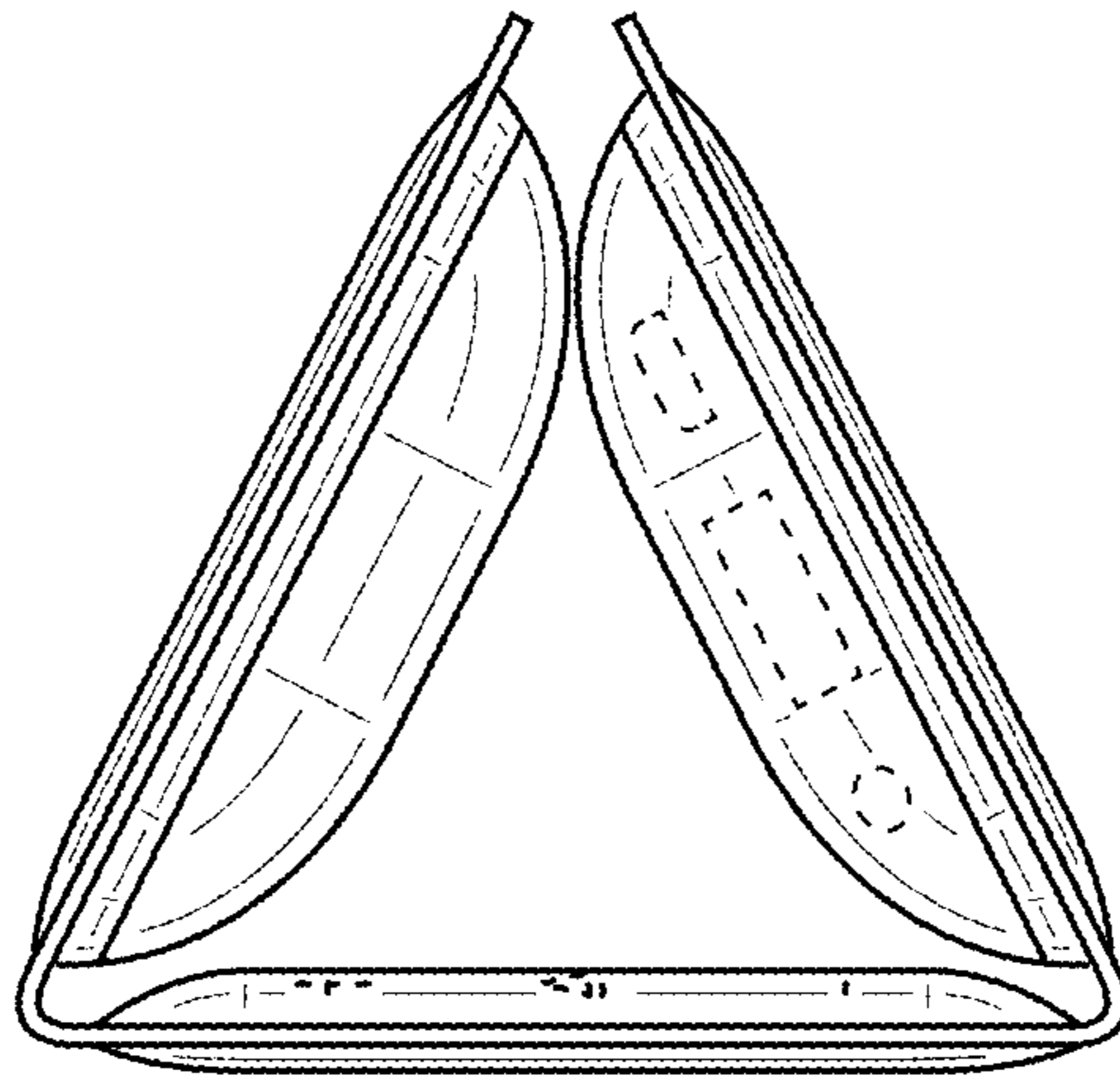

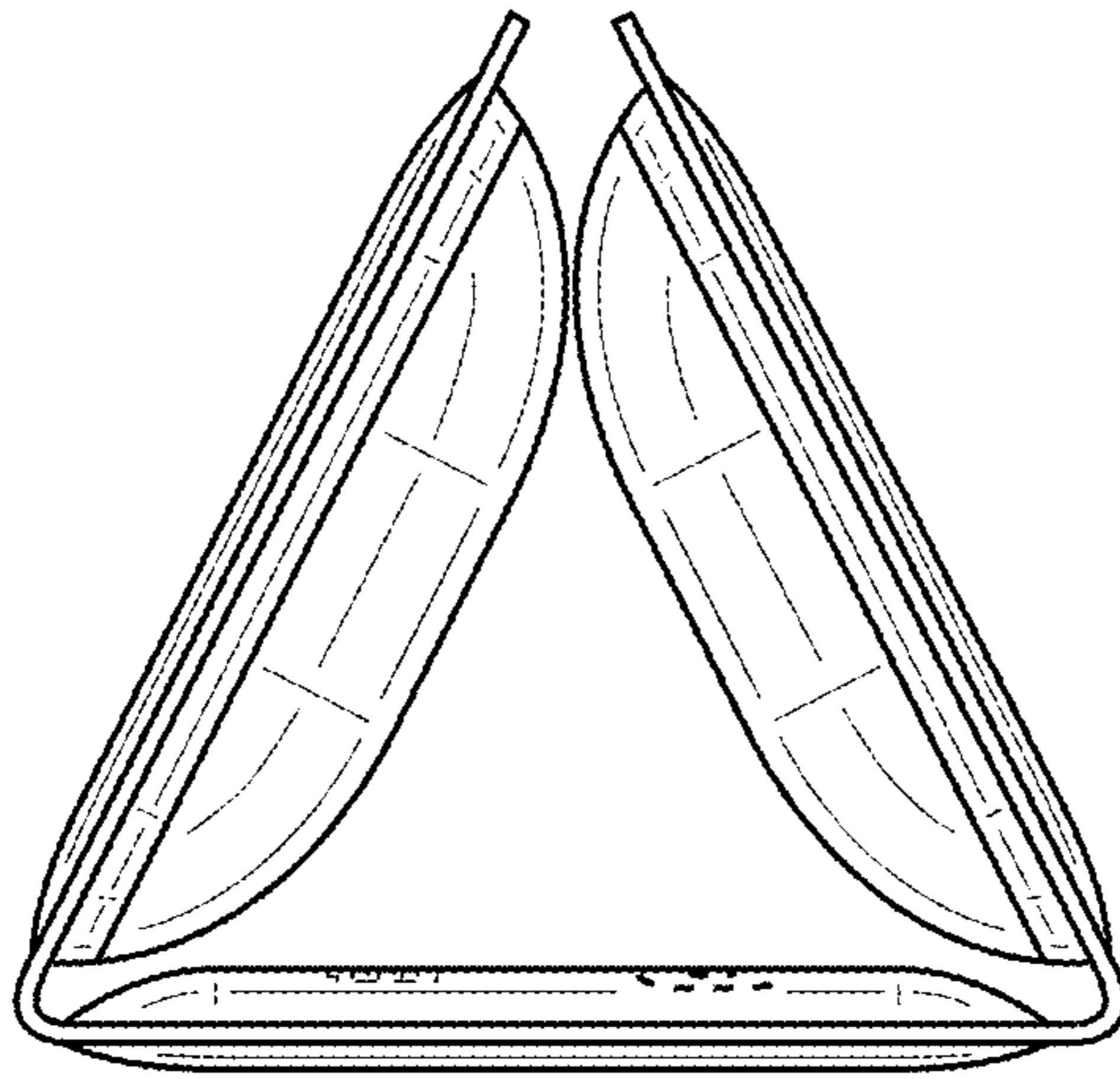

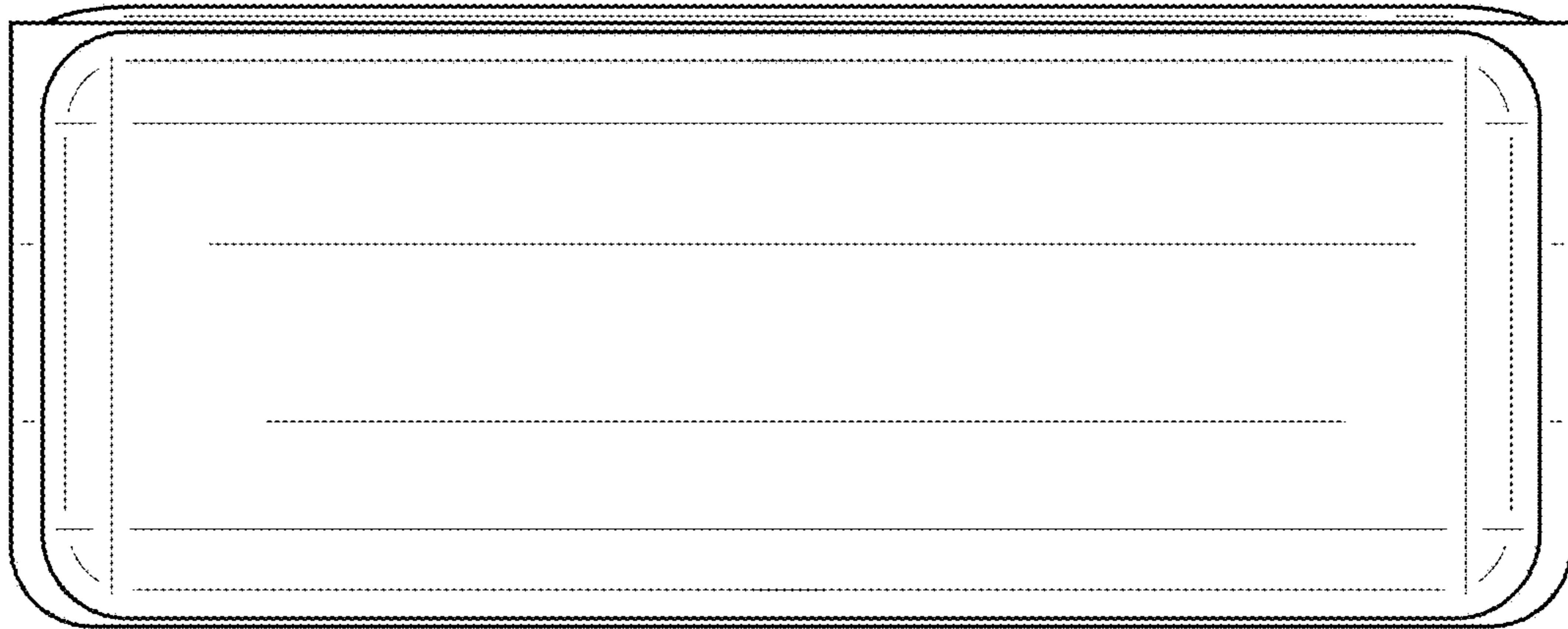

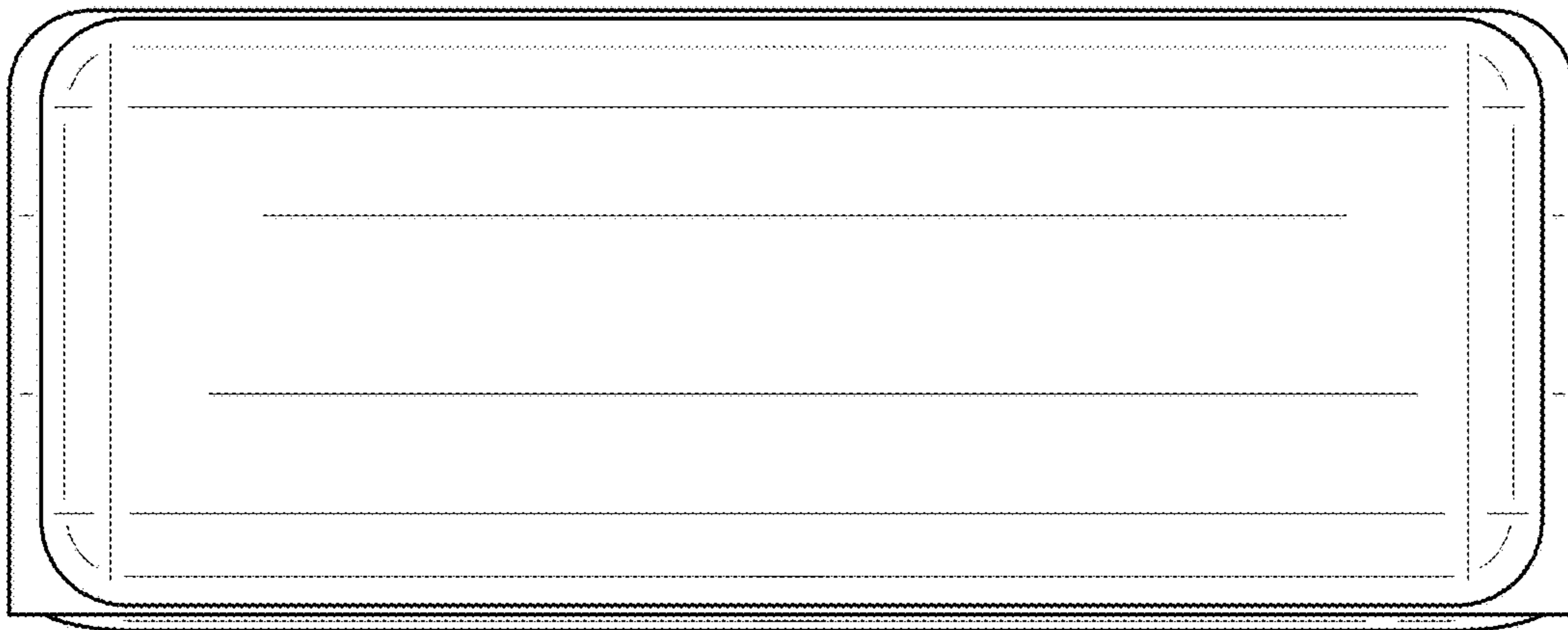
