We claim the ornamental design for a case for phone, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a case for phone of the claimed design;
 FIG. 2 is a front perspective view of the case for phone;
 FIG. 3 is a bottom rear perspective view of the case for phone;
 FIG. 4 is a bottom front perspective view of the case for phone;
 FIG. 5 is a front view of the case for phone;
 FIG. 6 is a rear view of the case for phone;
 FIG. 7 is a left view of the case for phone;
 FIG. 8 is a right view of the case for phone;
 FIG. 9 is a top view of the case for phone; and,
 FIG. 10 is a bottom view of the case for phone.

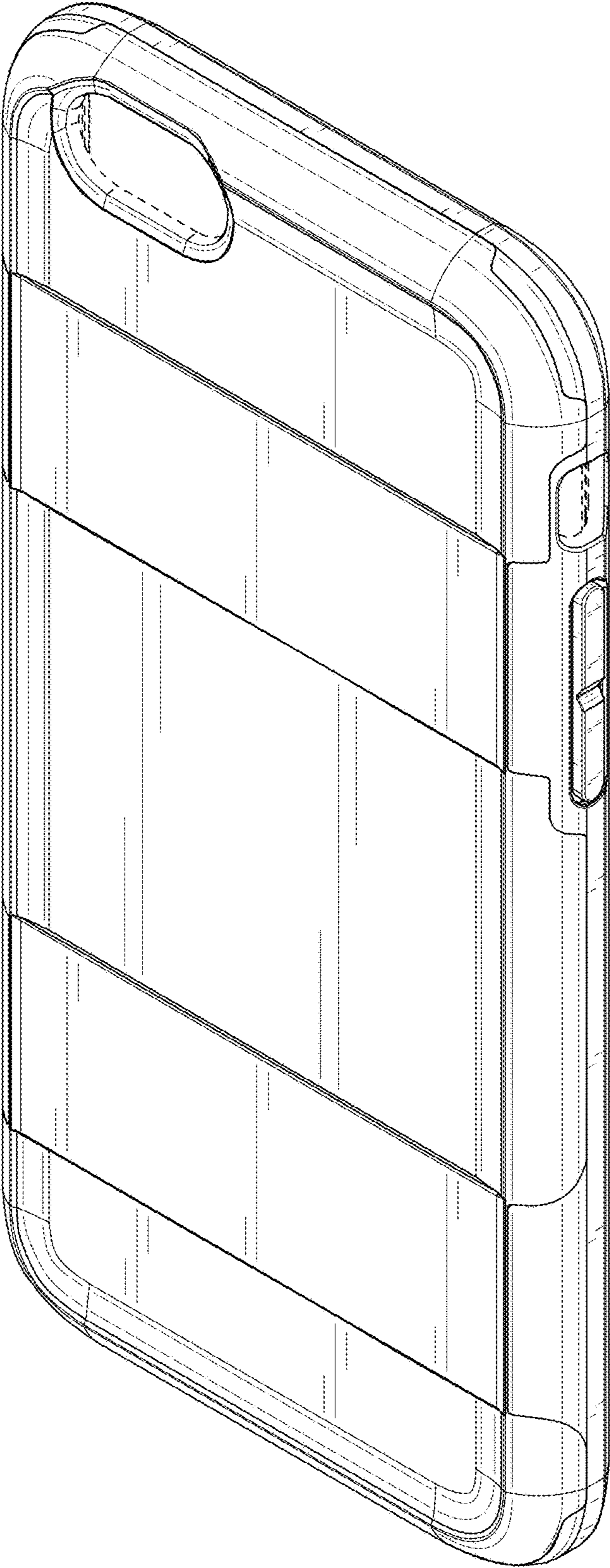

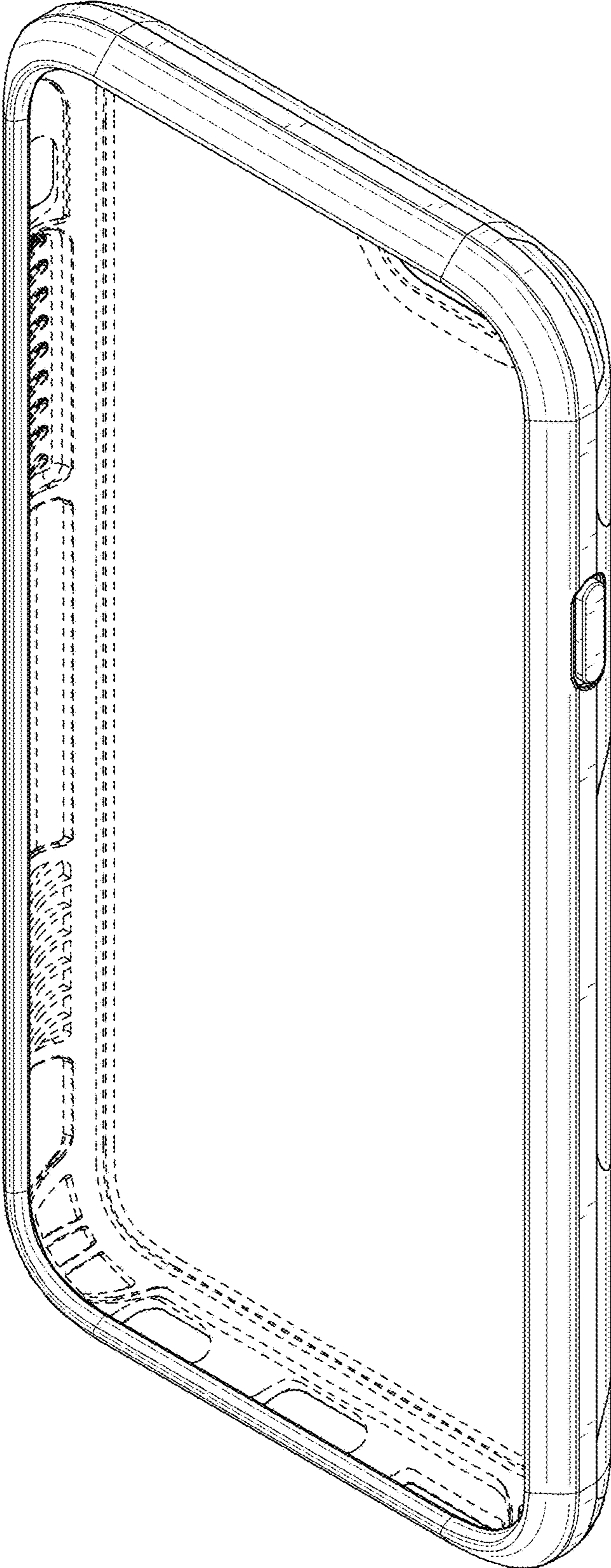

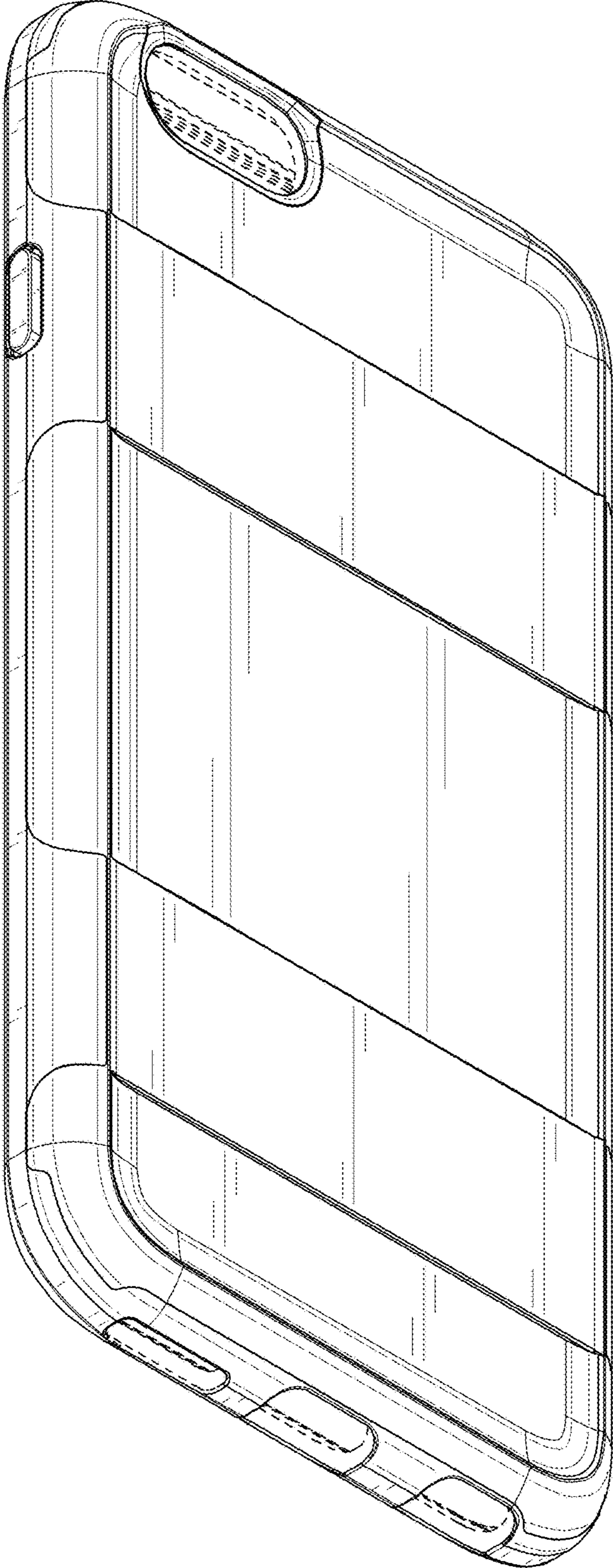

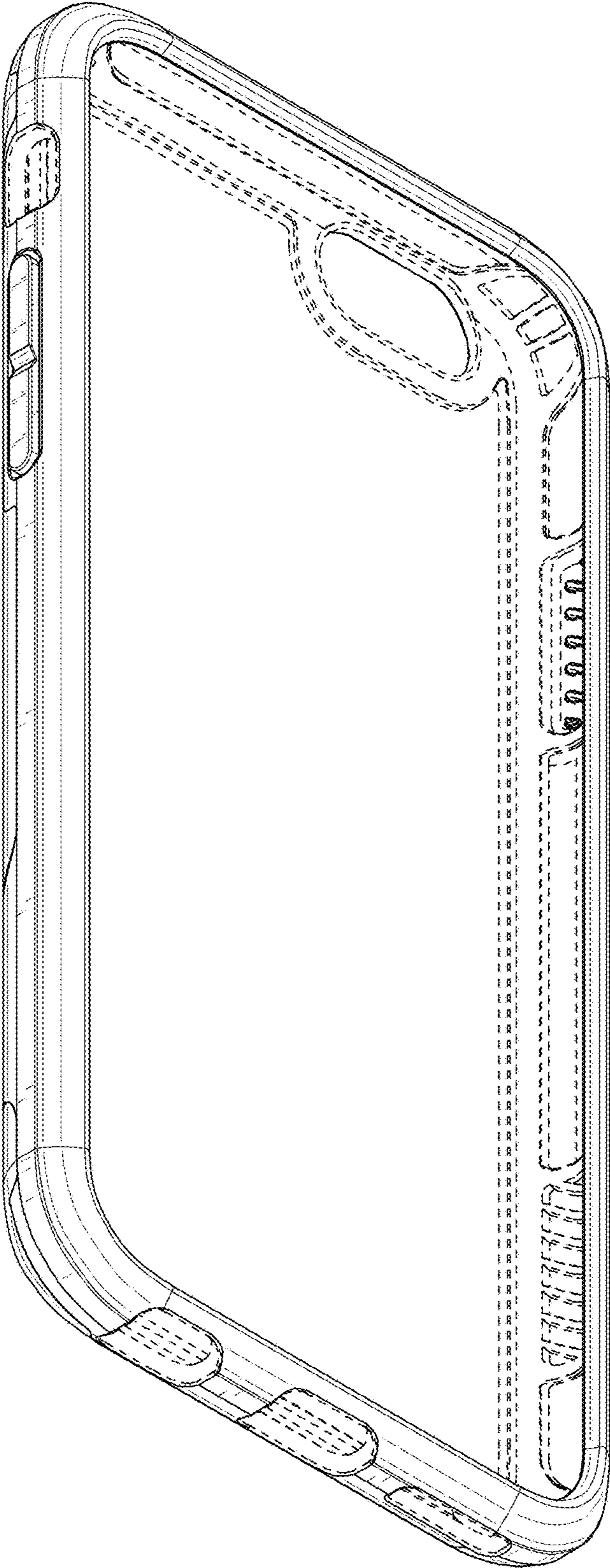

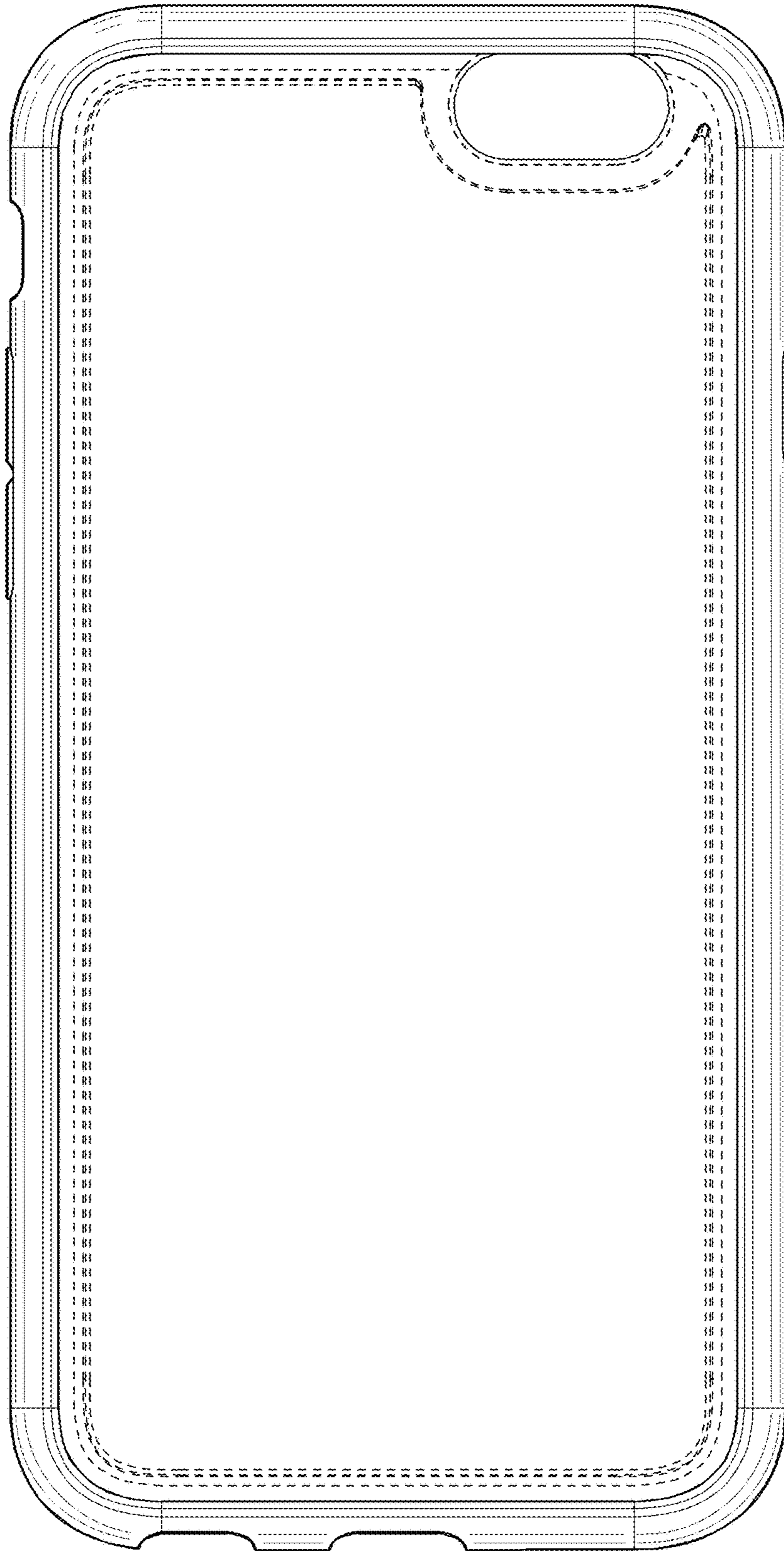

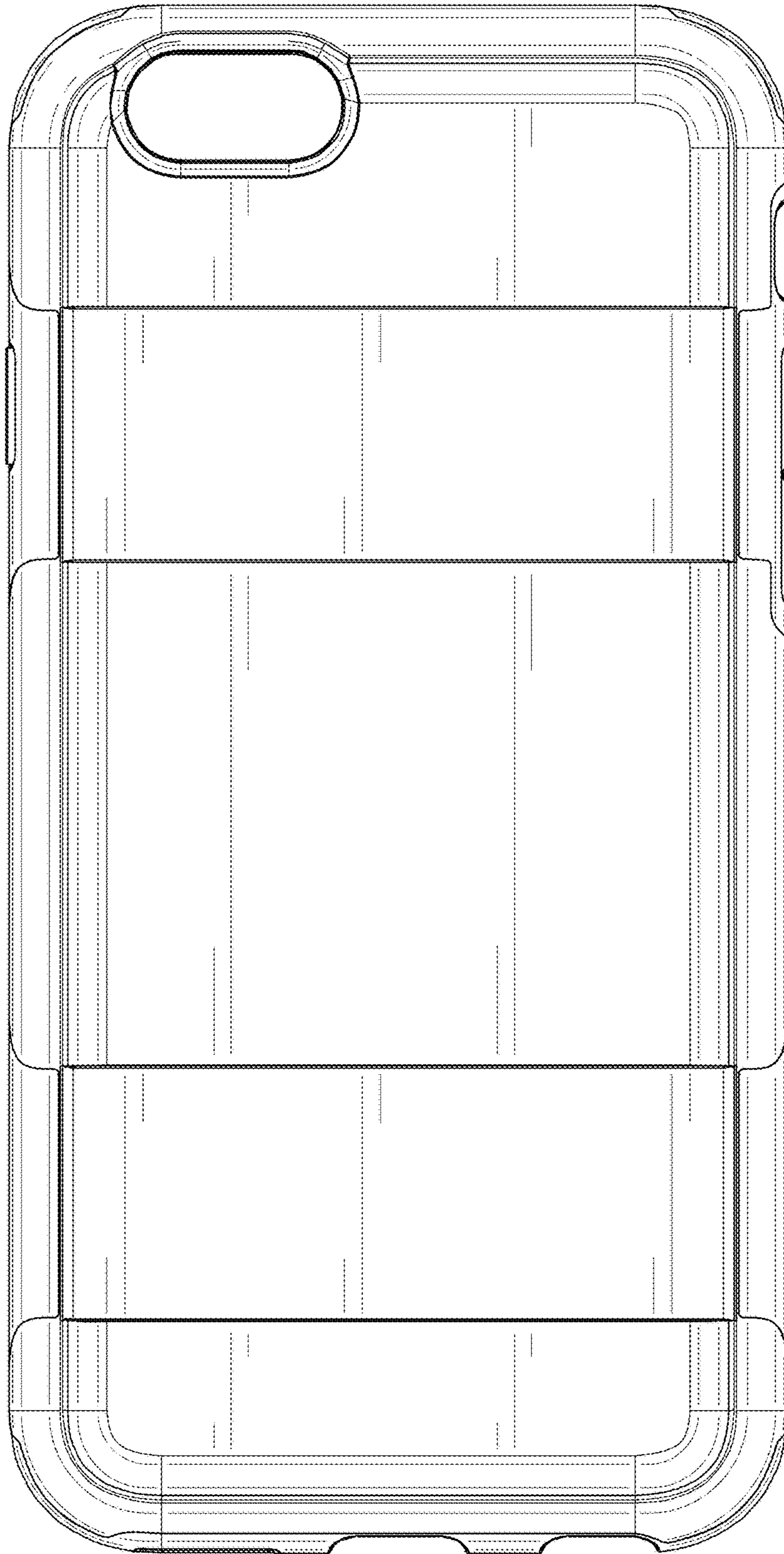

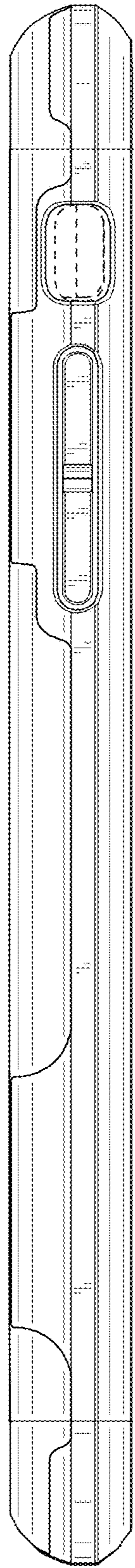

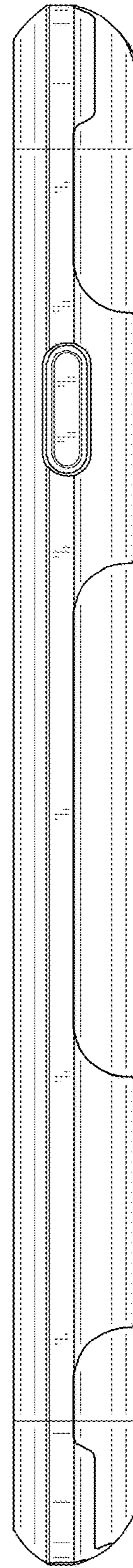

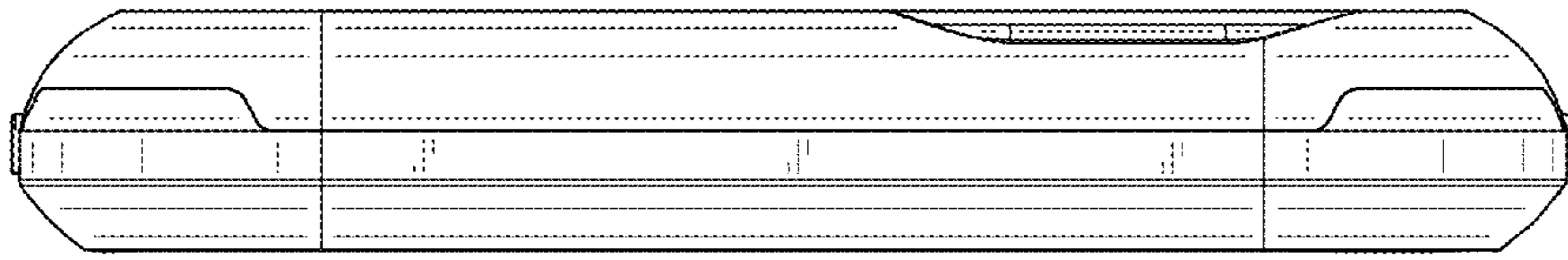

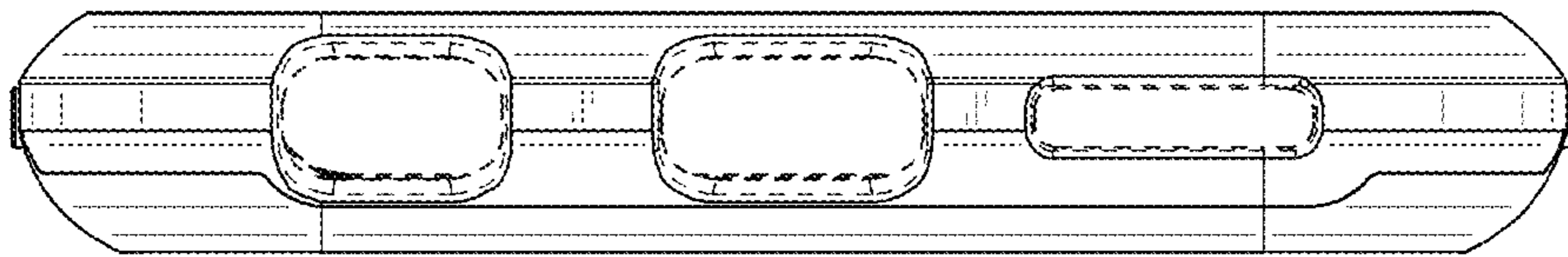
