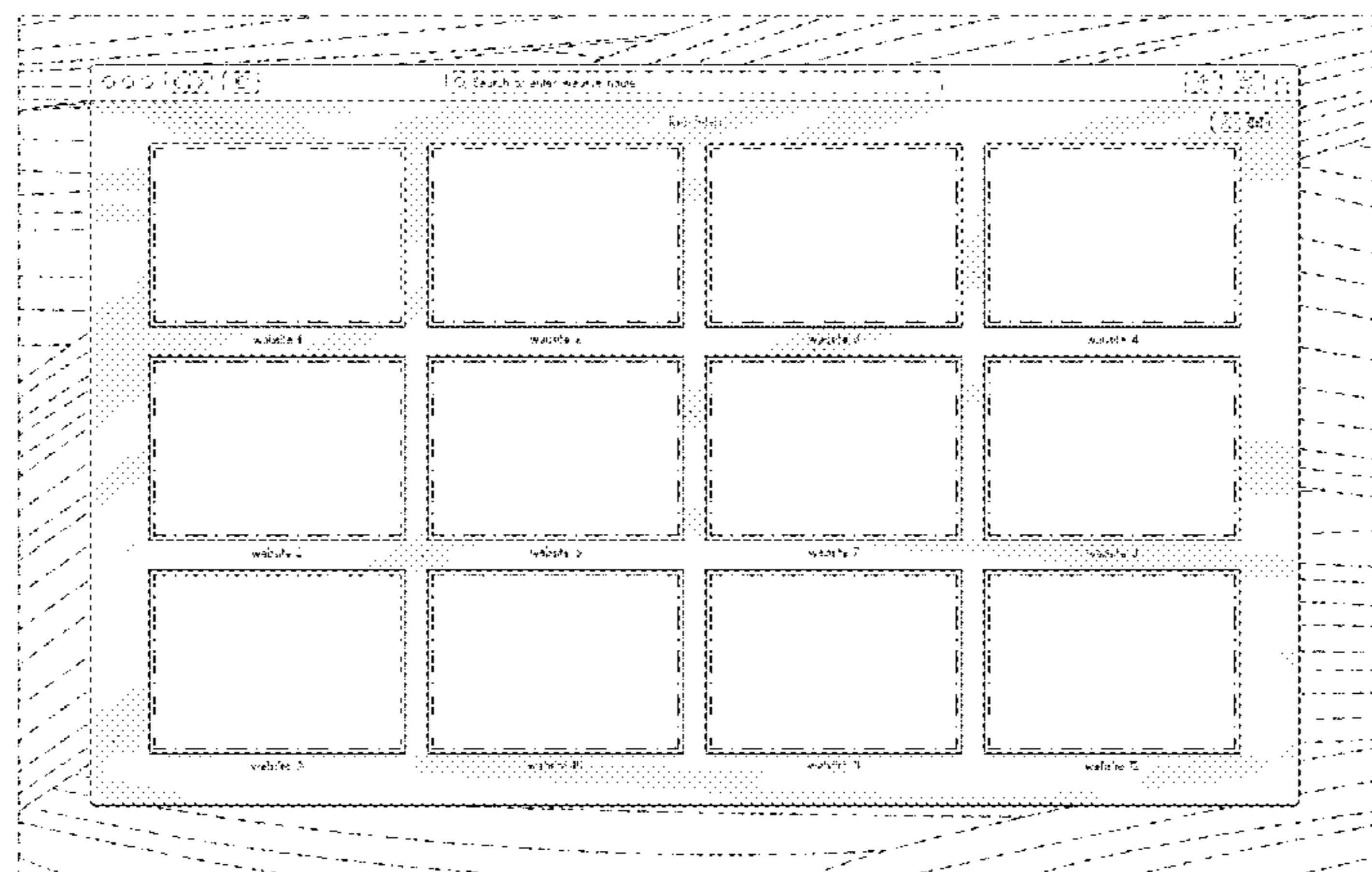

**DESCRIPTION**

The area shown in gray tone in the FIGURE portrays the illusion of translucency.
