(57) **CLAIM**

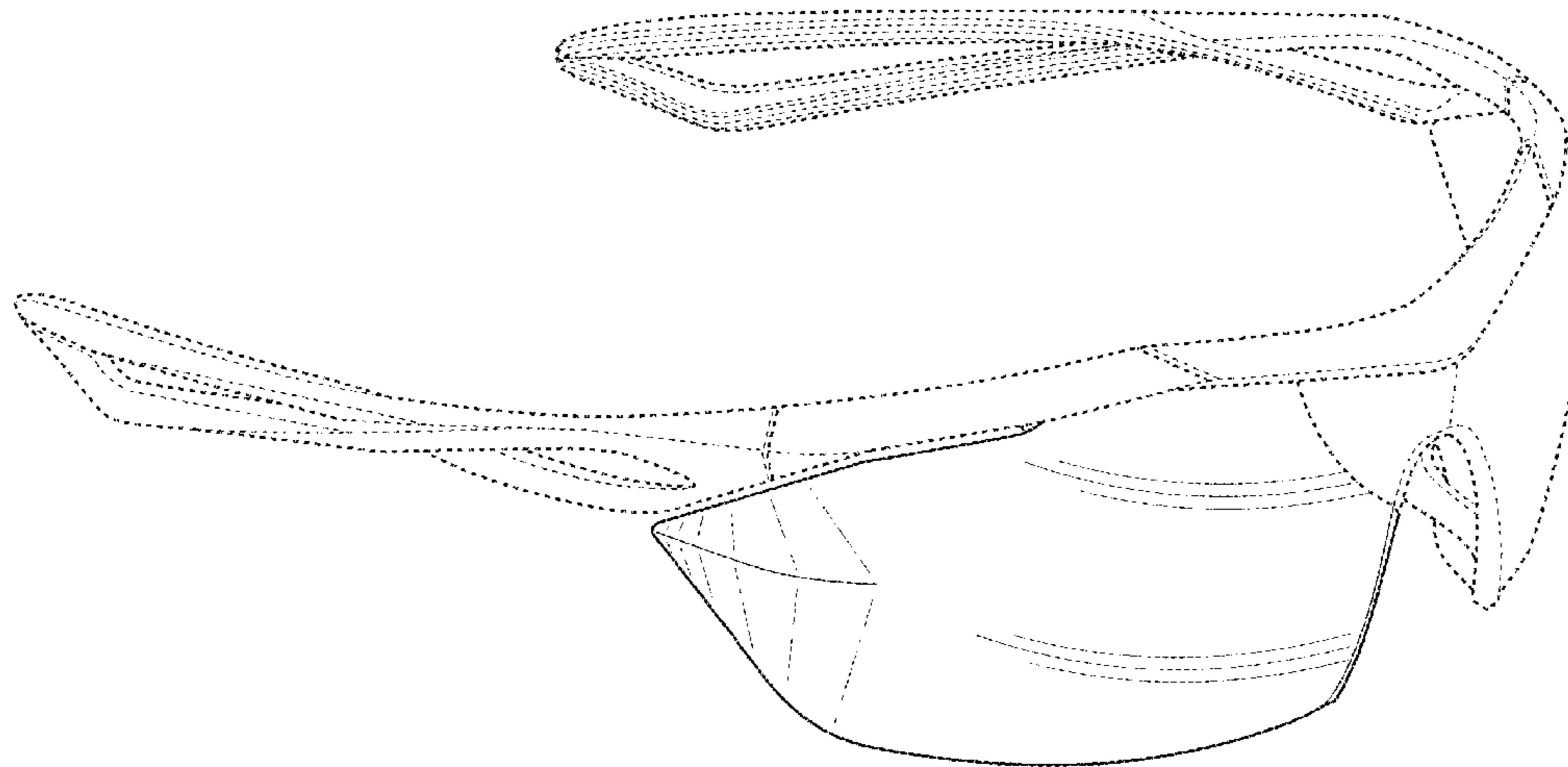
The ornamental design for an eyeglass, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an eyeglass showing our new design;

FIG. 6 is a rear view thereof;

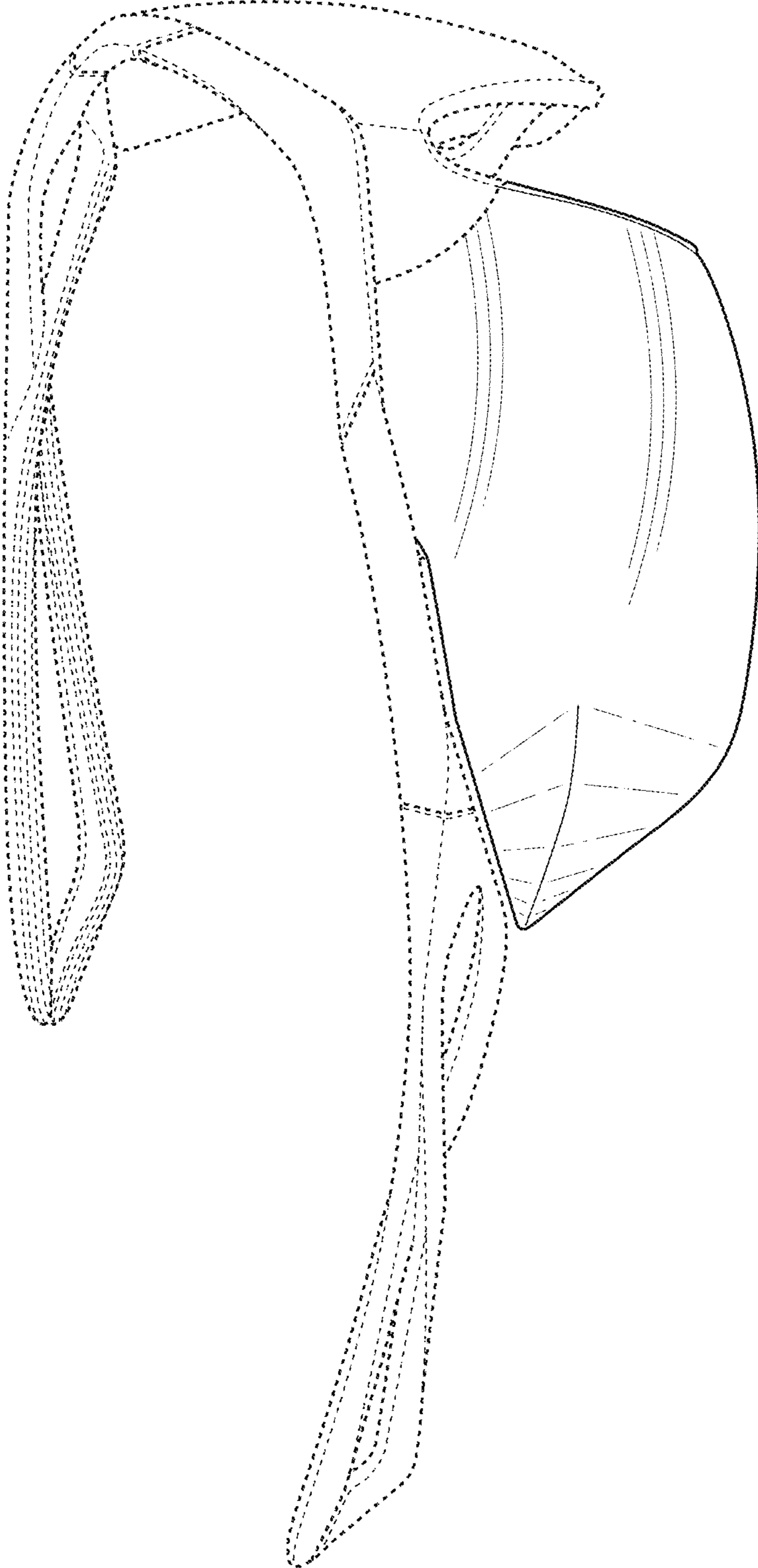

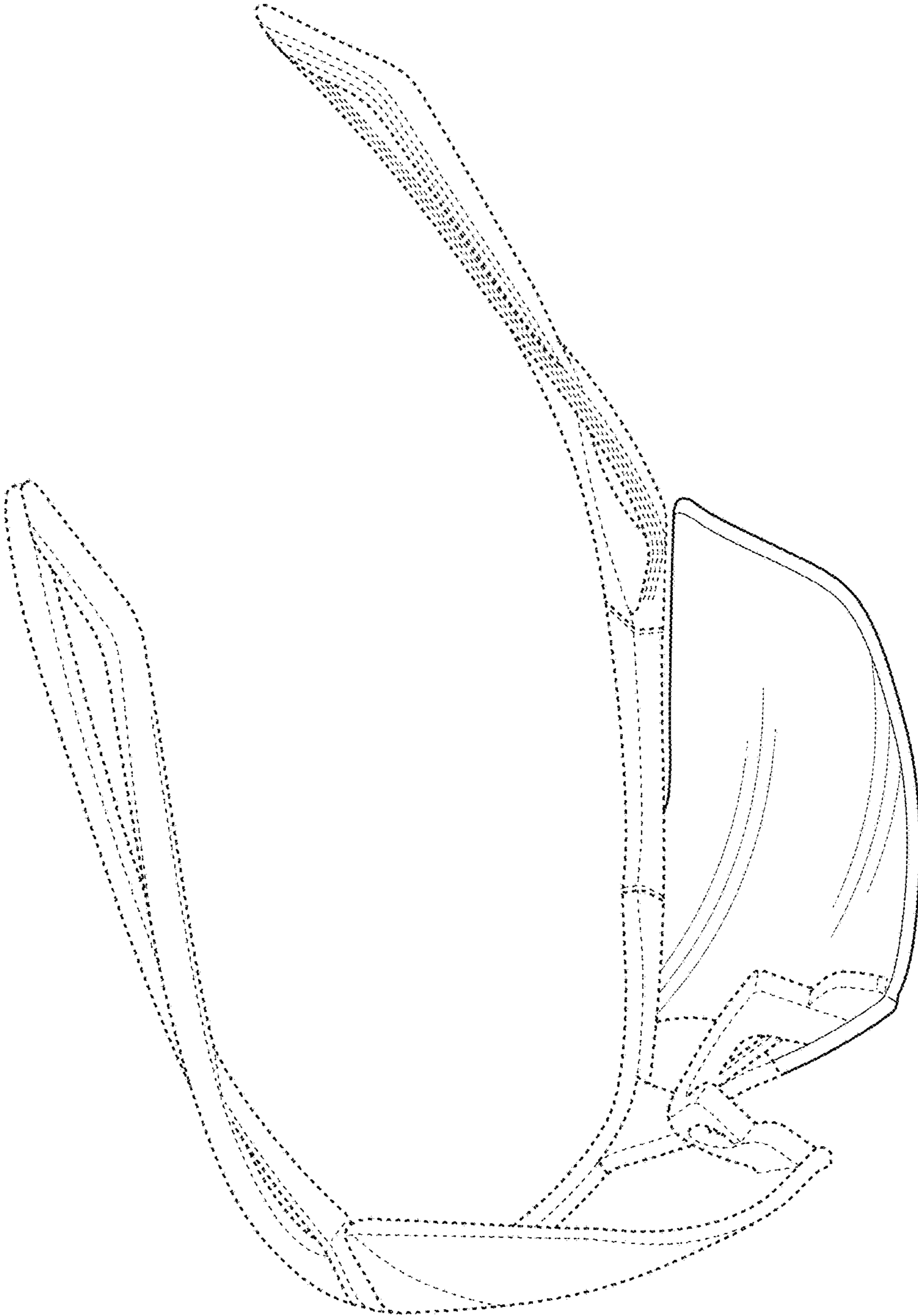

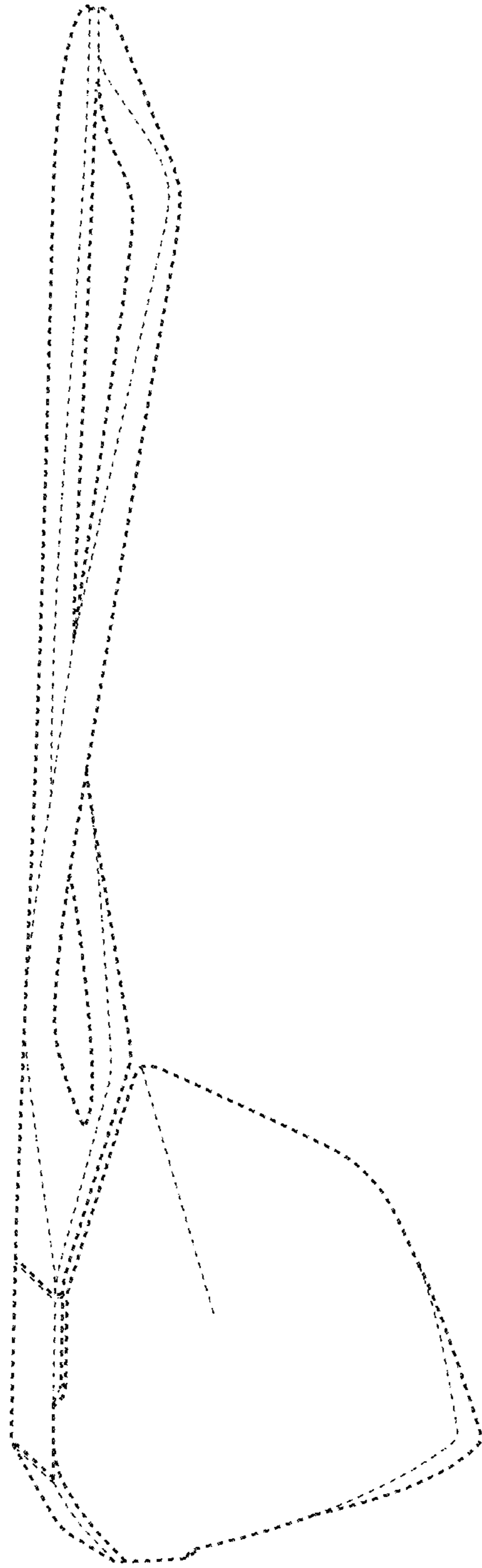

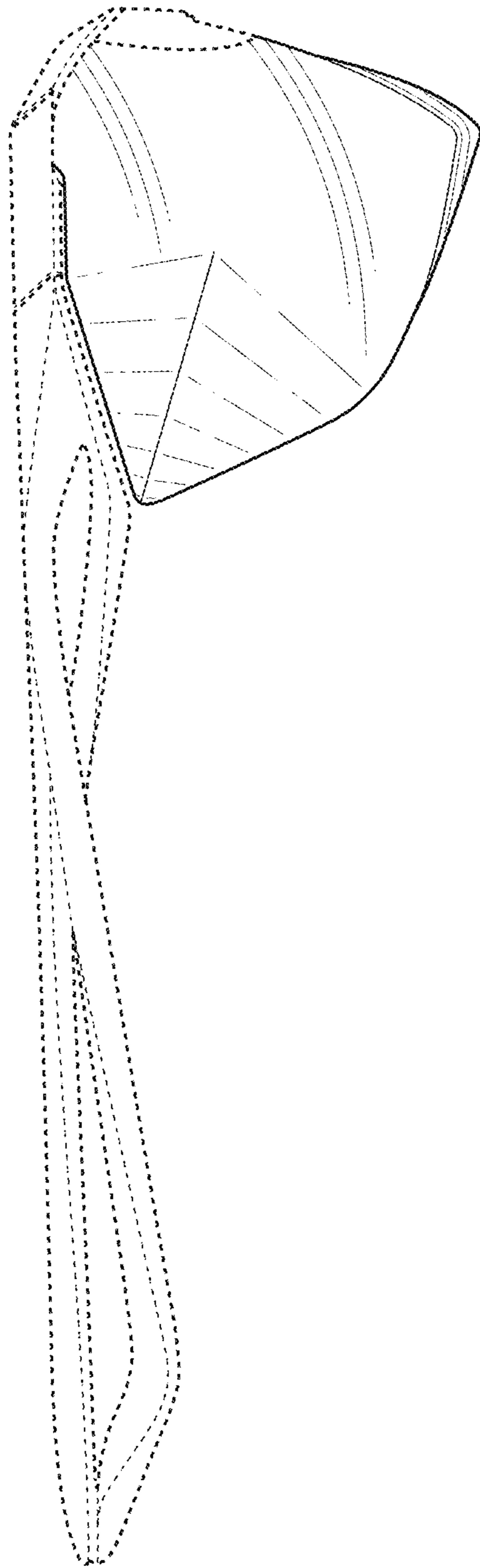

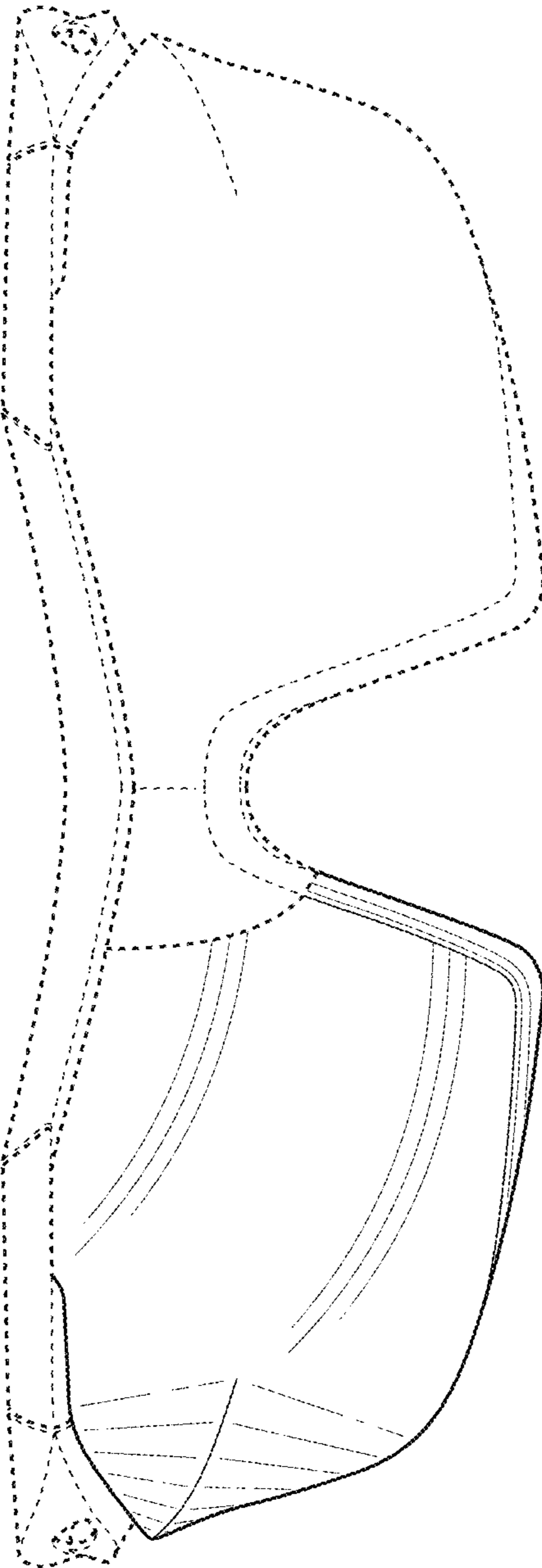

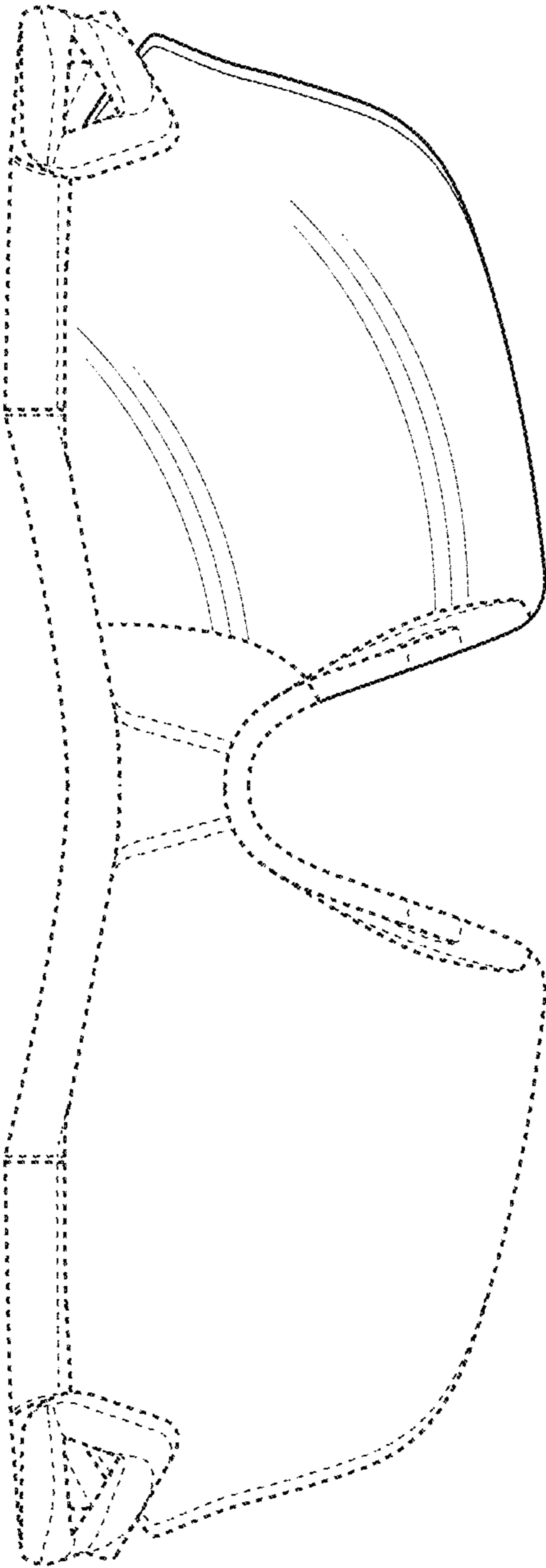

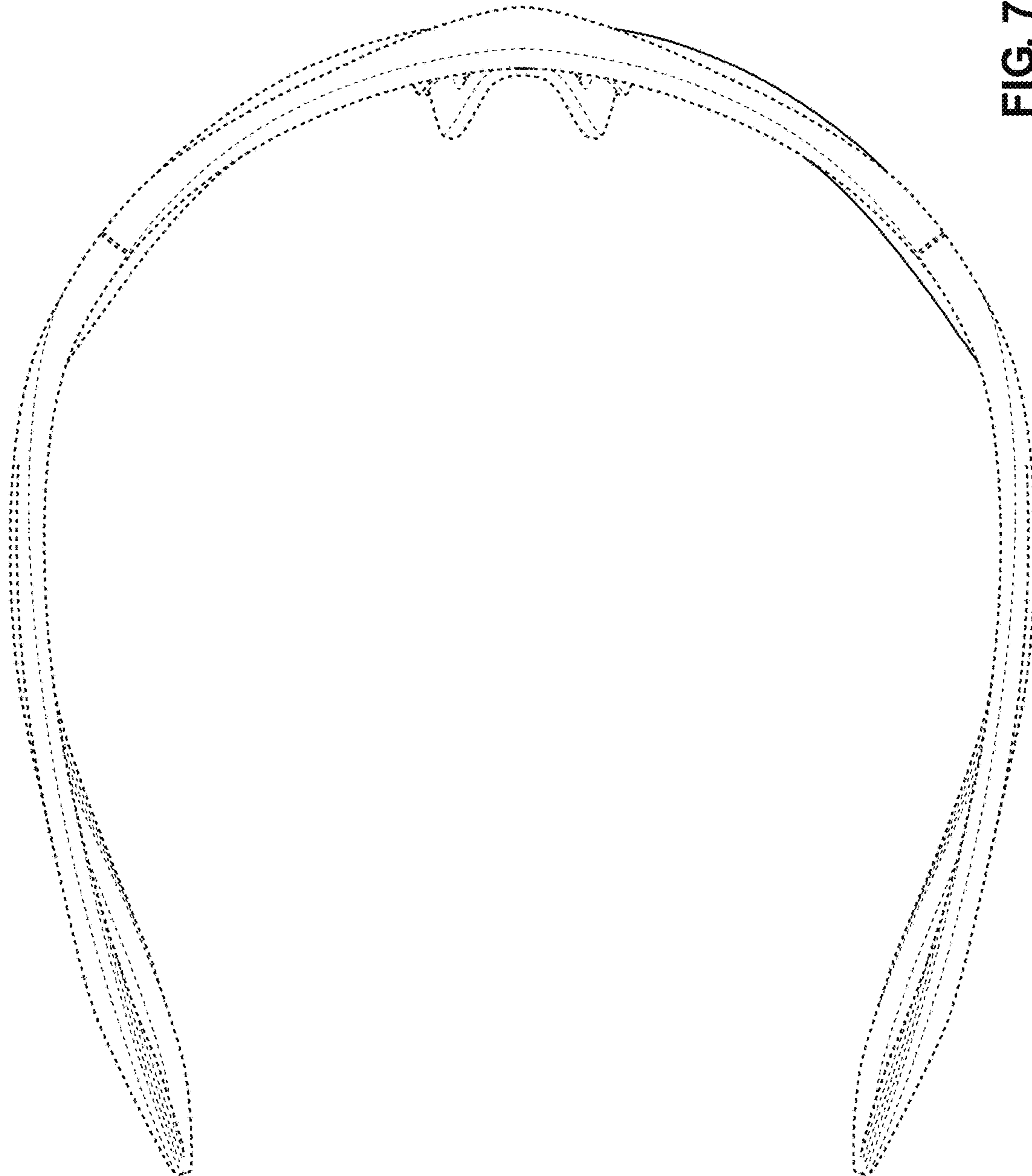

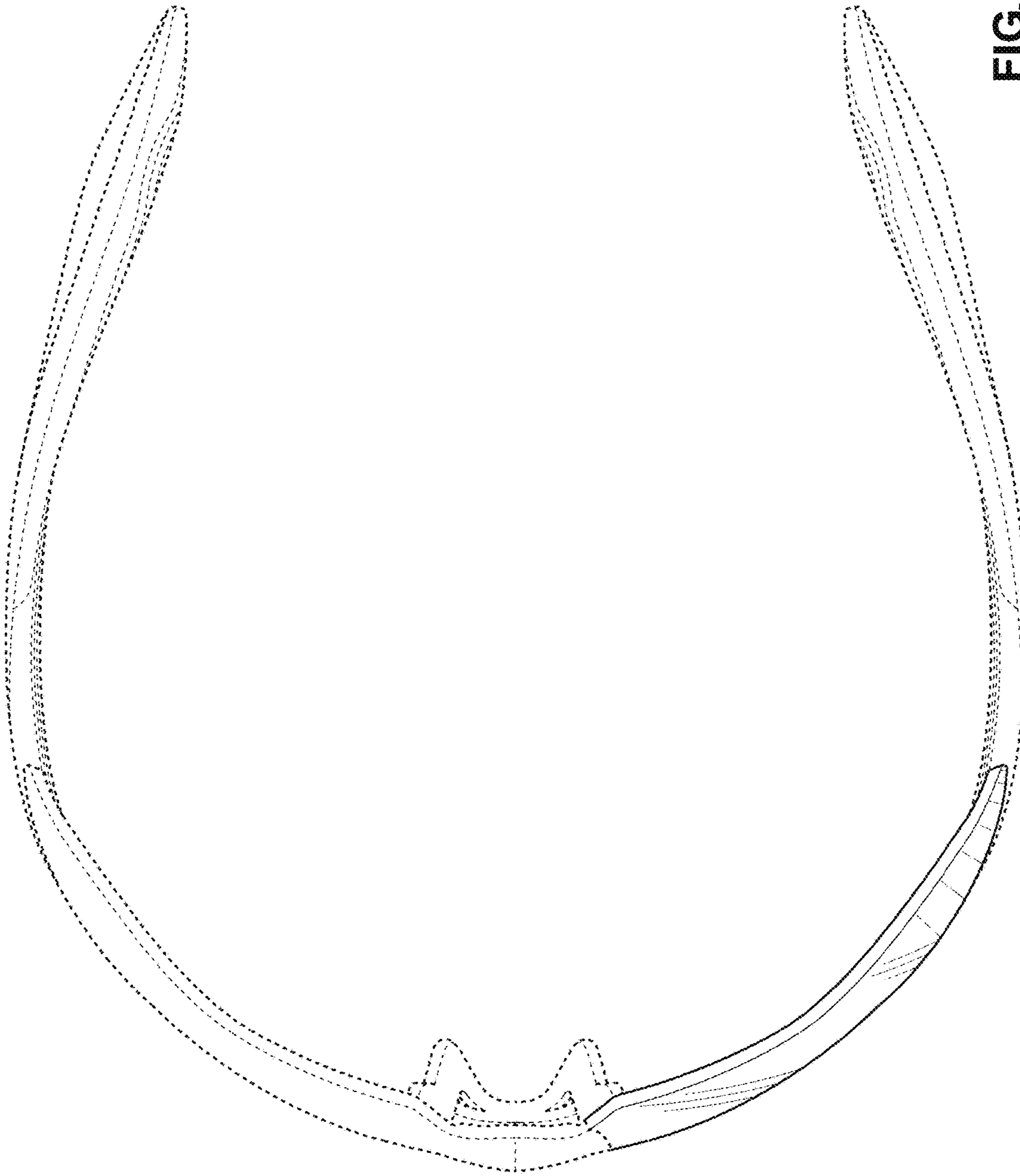
