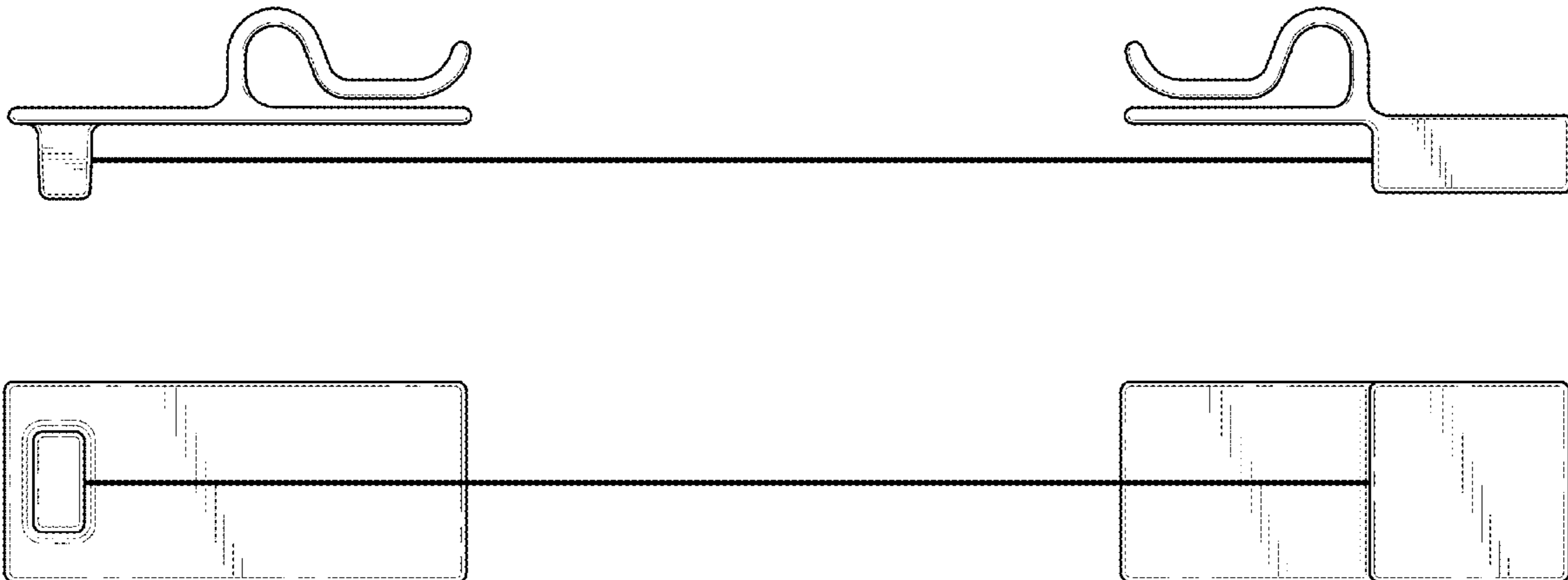
(57) **CLAIM**

The ornamental design for a page holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a page holder, showing our new design;  
FIG. 2 is a rear elevation view of the page holder of FIG. 1, shown in an alternate state;  
FIG. 3 is a top plan view of FIG. 1;  
FIG. 4 is a front elevation view of FIG. 1;  
FIG. 5 is a bottom plan view of FIG. 1;  
FIG. 6 is a left side elevation view of FIG. 1;  
FIG. 7 is a right side elevation view of FIG. 1; and,  
FIG. 8 is a perspective view of the page holder of FIG. 1, shown in a collapsed state.  
The evenly spaced broken lines and dot-dot-dash broken lines are directed to environment and form no part of the claimed design.

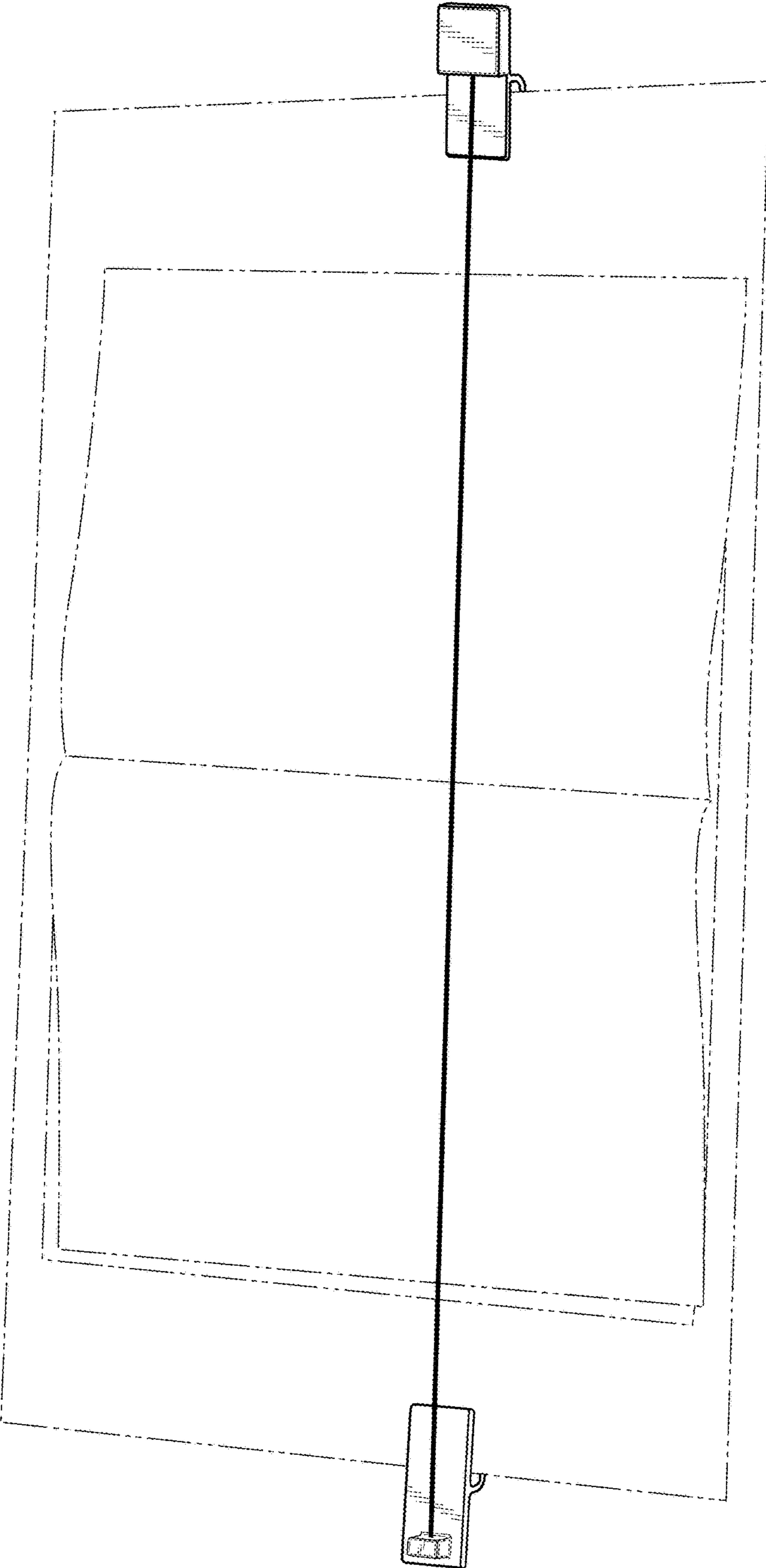
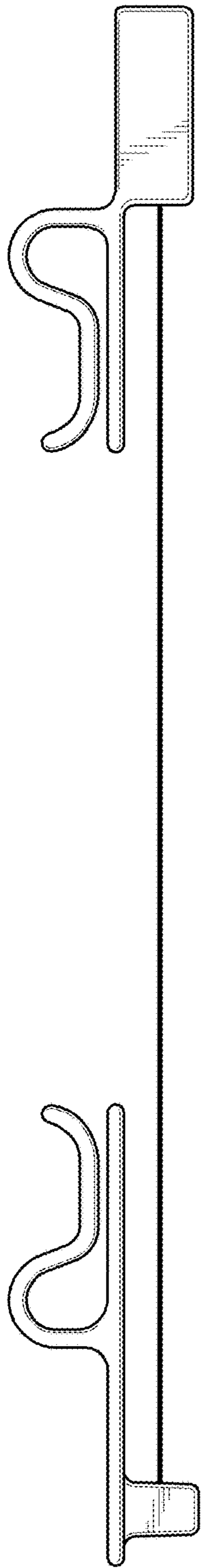
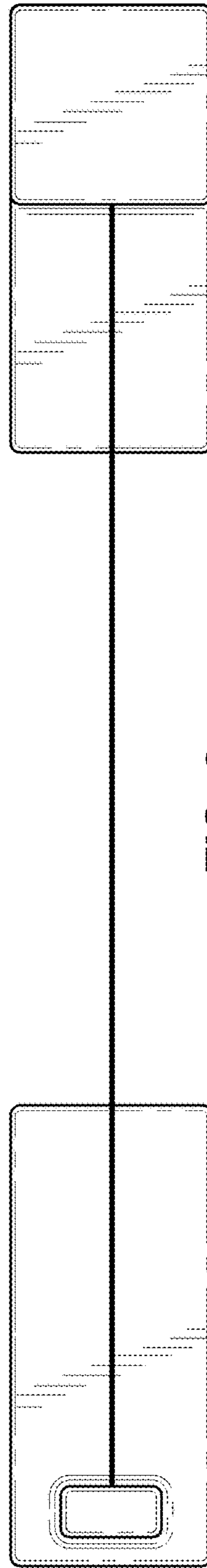

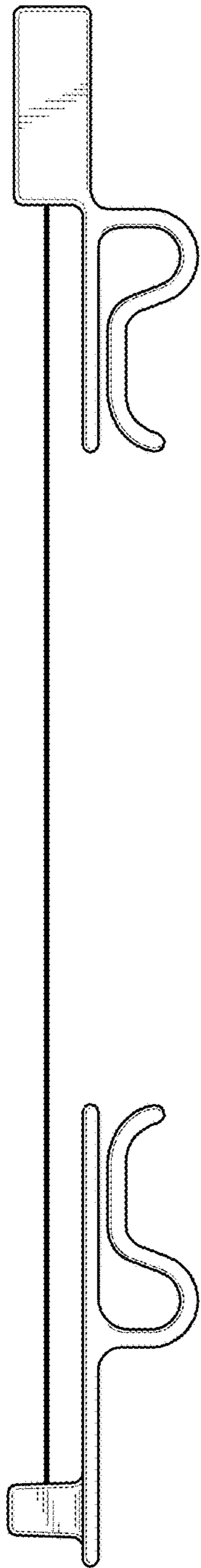

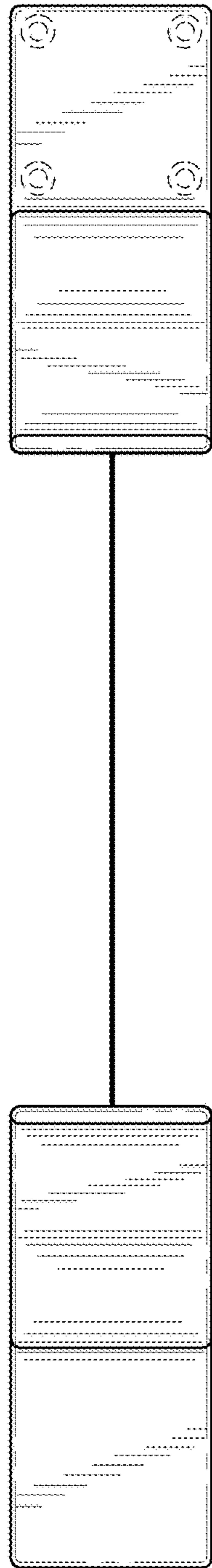

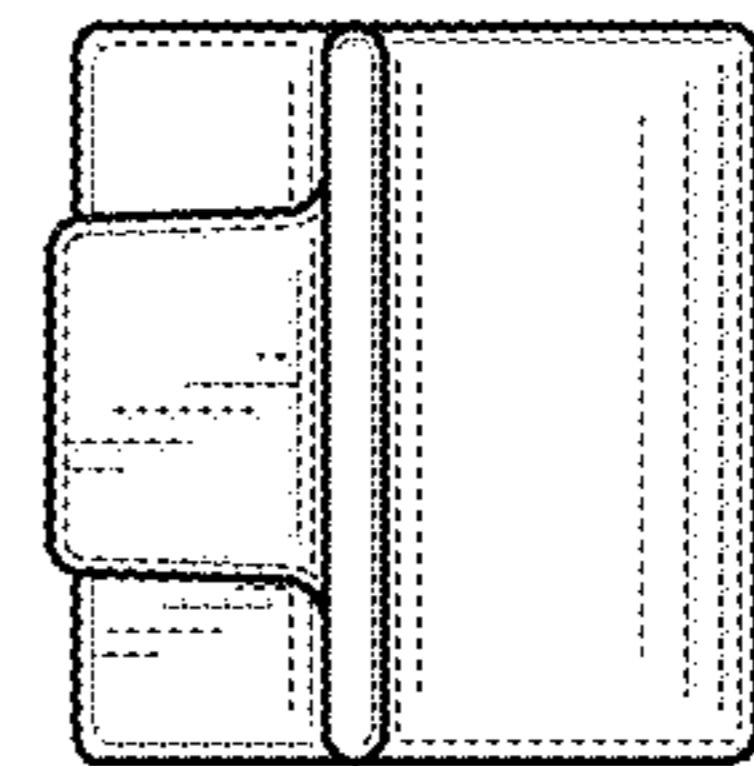

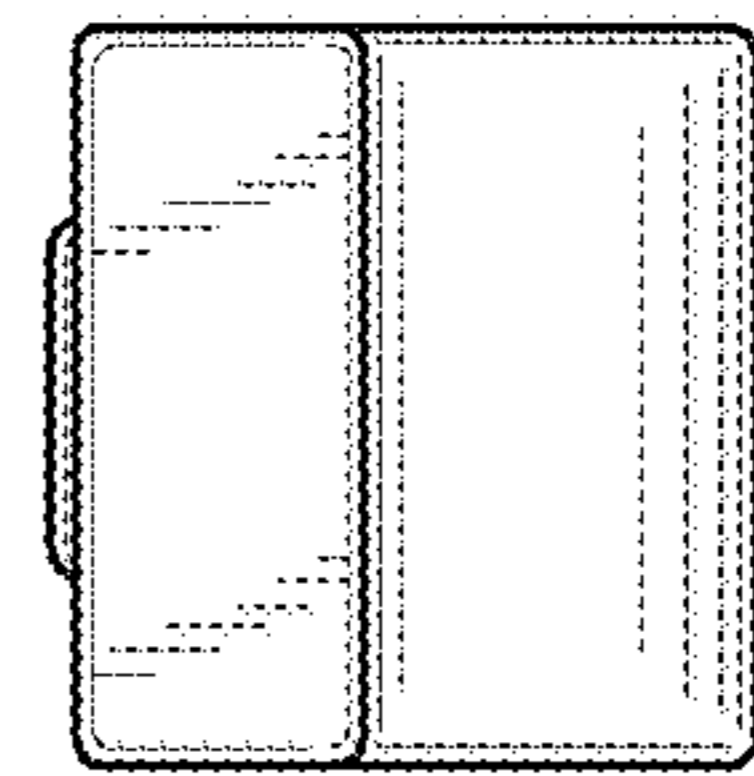
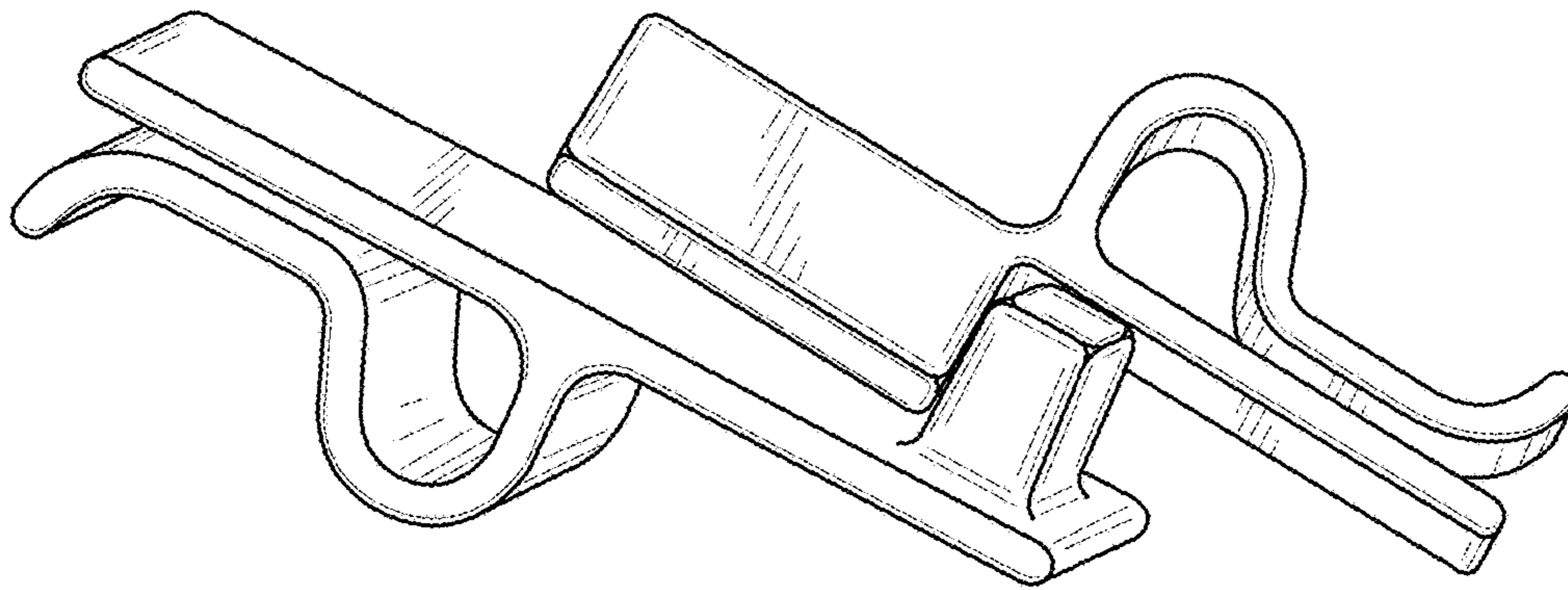
