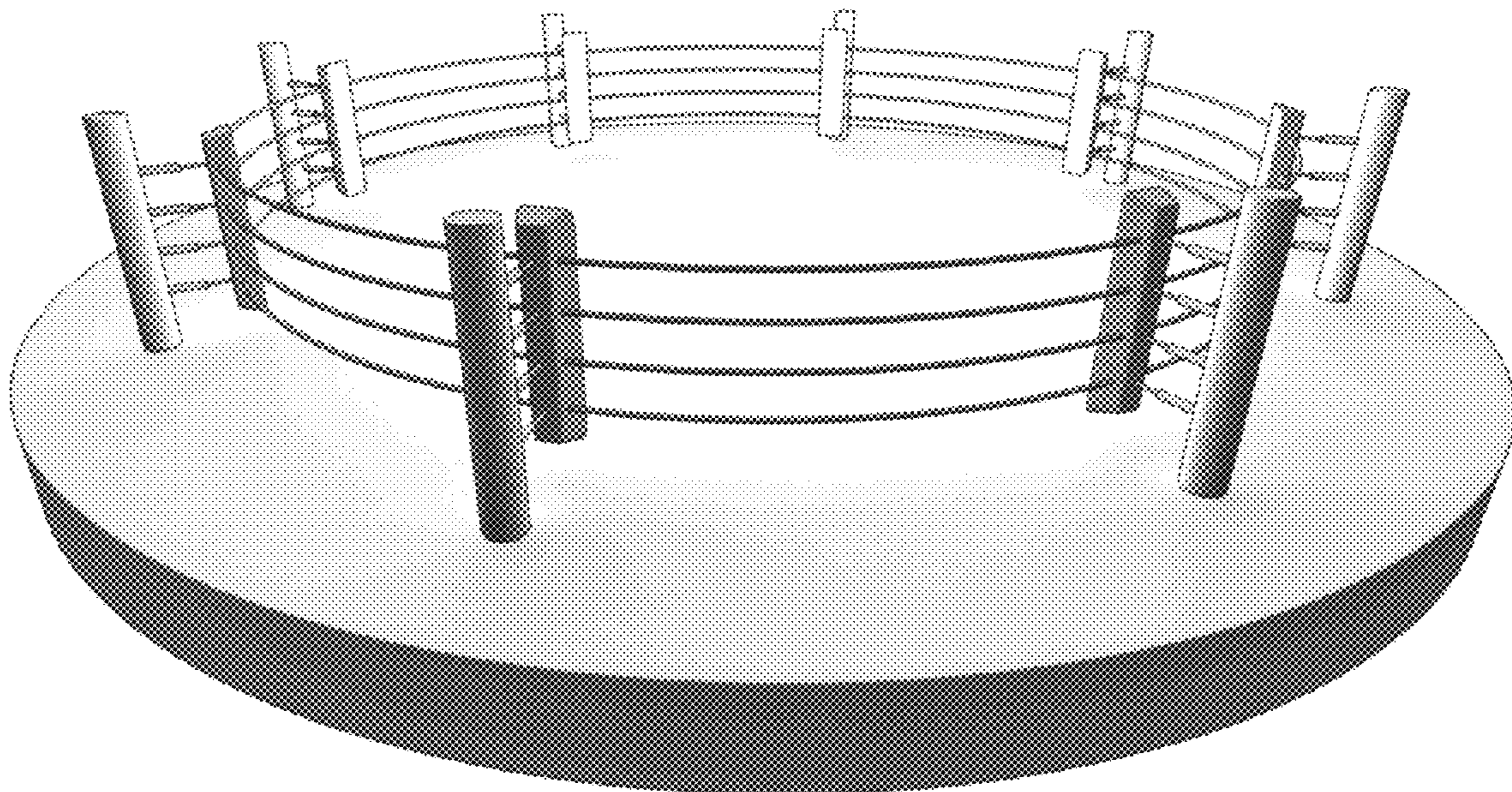

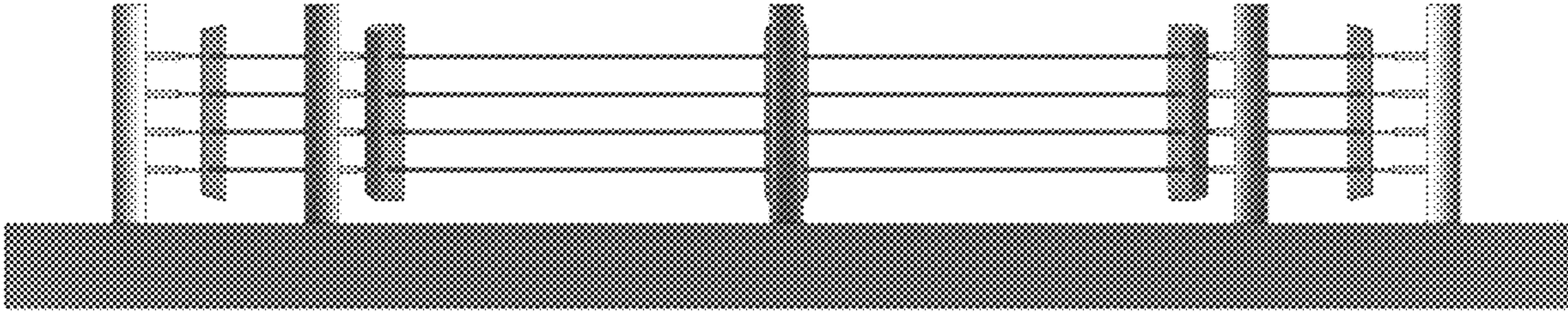
**DESCRIPTION**

Industrial design consisting in a circular platform for practicing all kinds of martial arts.

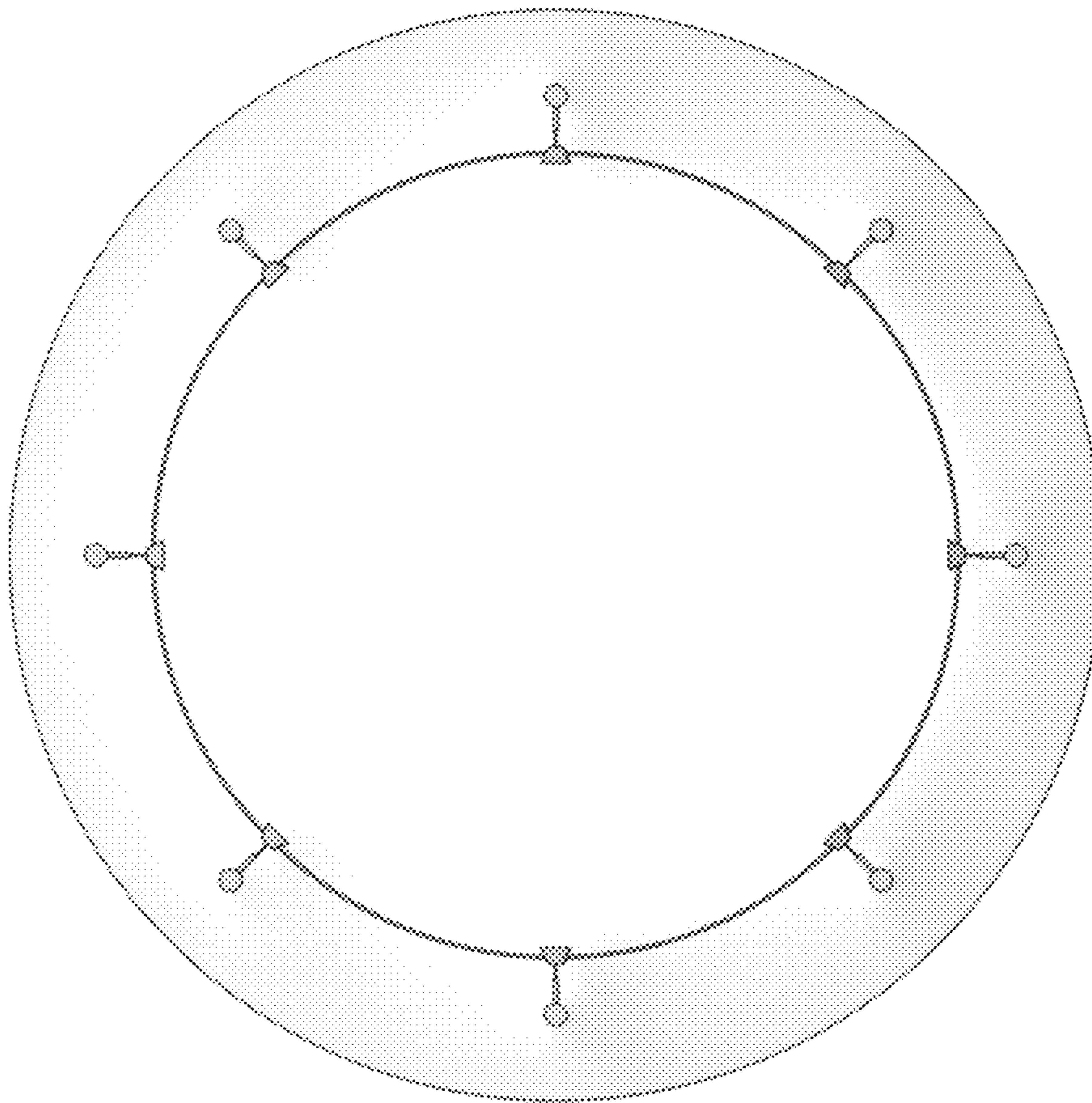

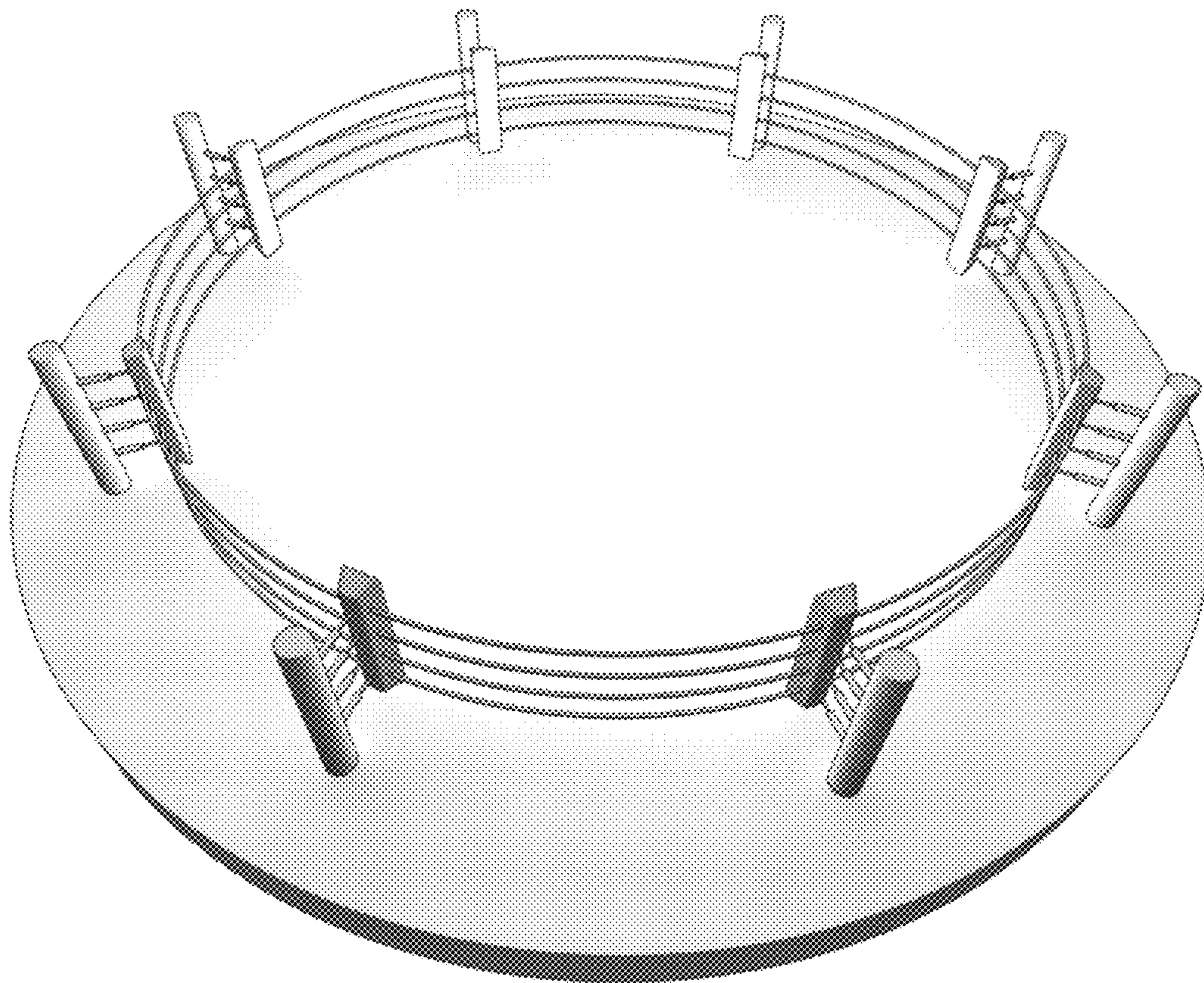

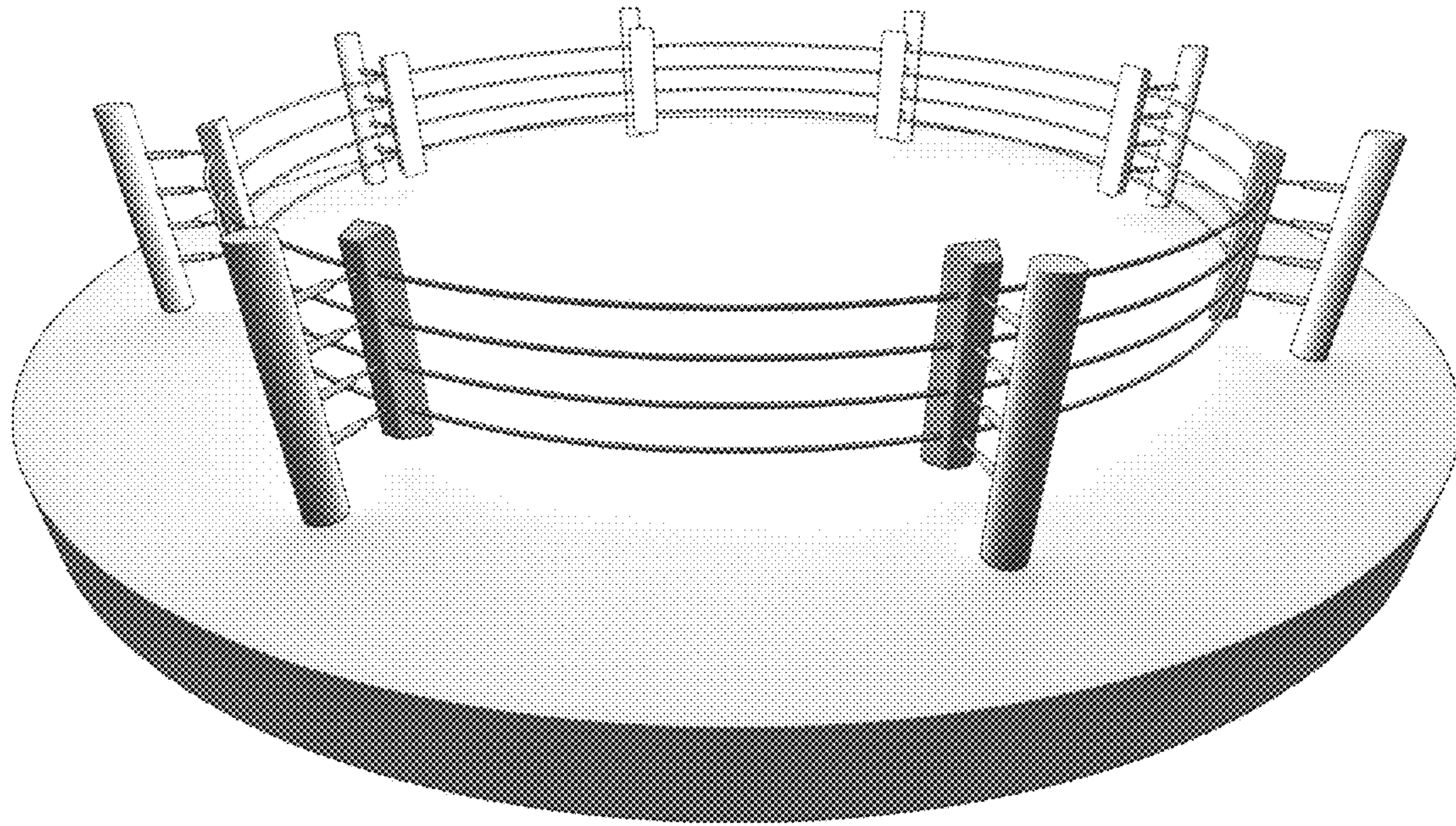
