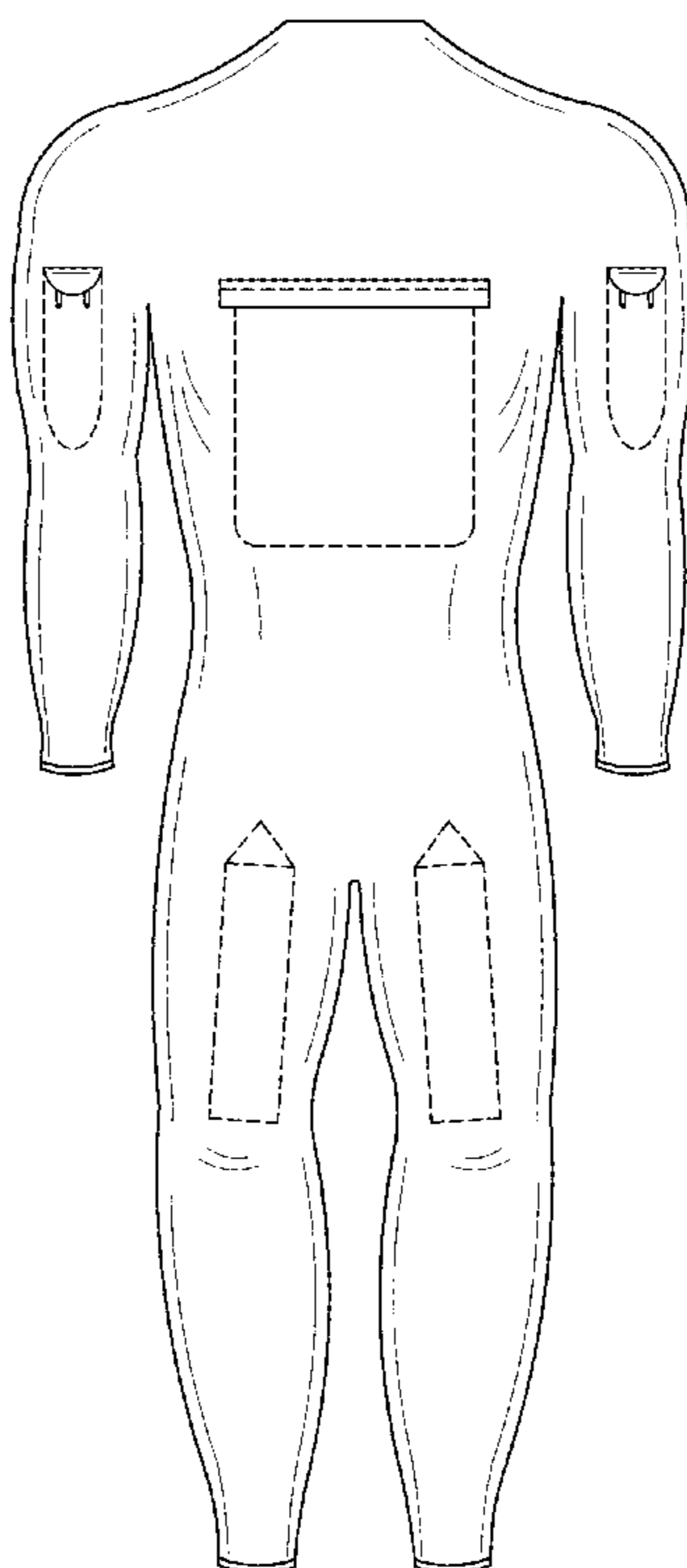
(57) **CLAIM**

The ornamental design for a heated garment, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a heated garment showing my new design;
FIG. 2 is a rear view of the heated garment;
FIG. 3 is a right side view of the heated garment;
FIG. 4 is a left side view of the heated garment;
FIG. 5 is a top view of the heated garment;
FIG. 6 is a bottom view of the heated garment;
FIG. 7 is a cross-sectional view of the heated garment taken along line 7-7 of FIG. 3; and,
FIG. 8 is a cross-sectional view of the heated garment taken along line 8-8 of FIG. 4.
The broken lines shown in FIGS. 1 through 8 illustrate portions of the heated garment that form no part of the claimed design.

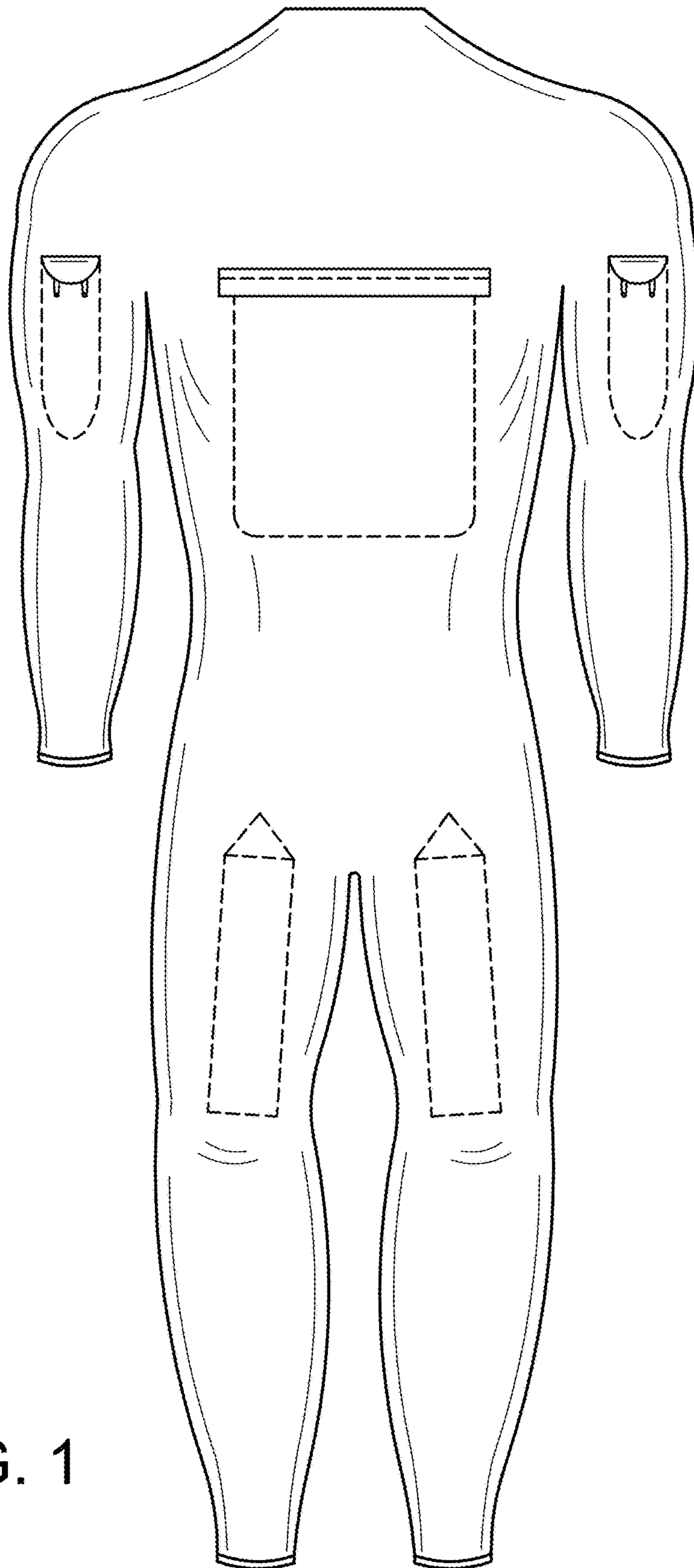

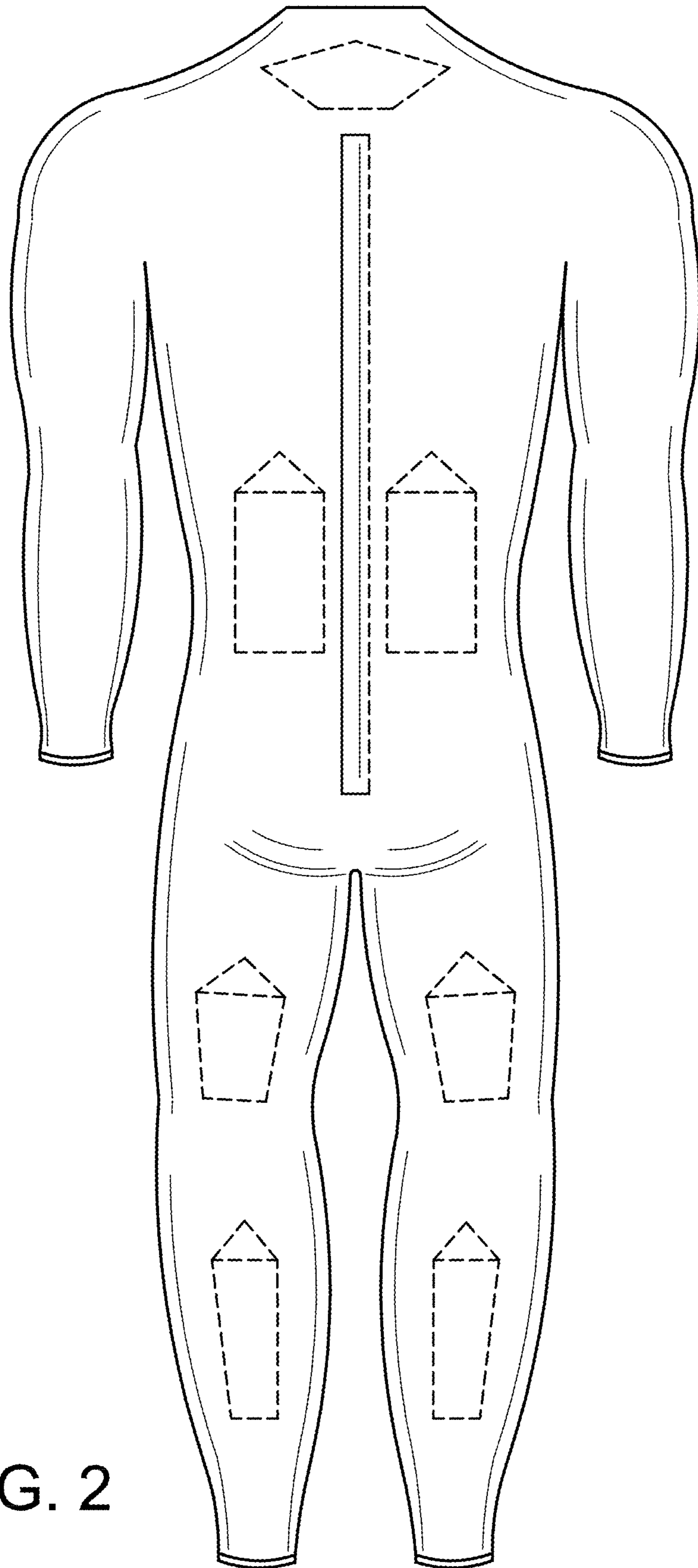

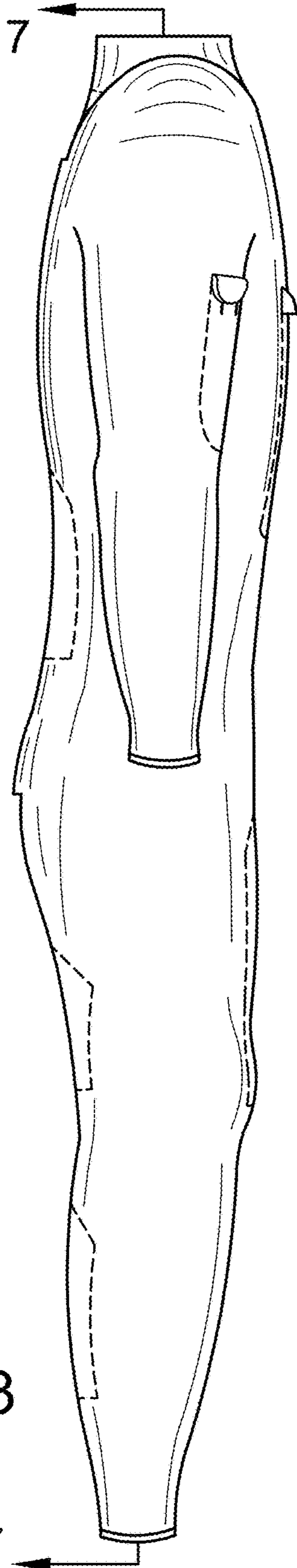

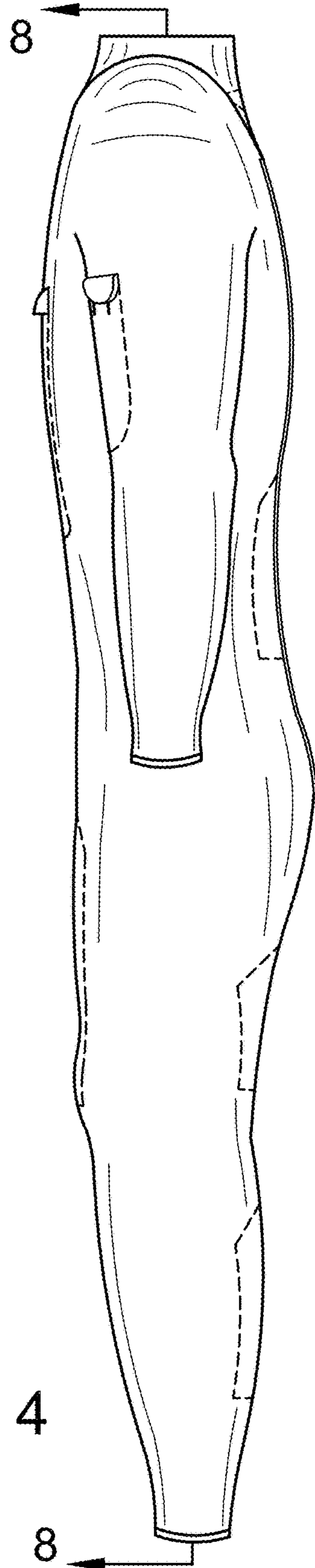

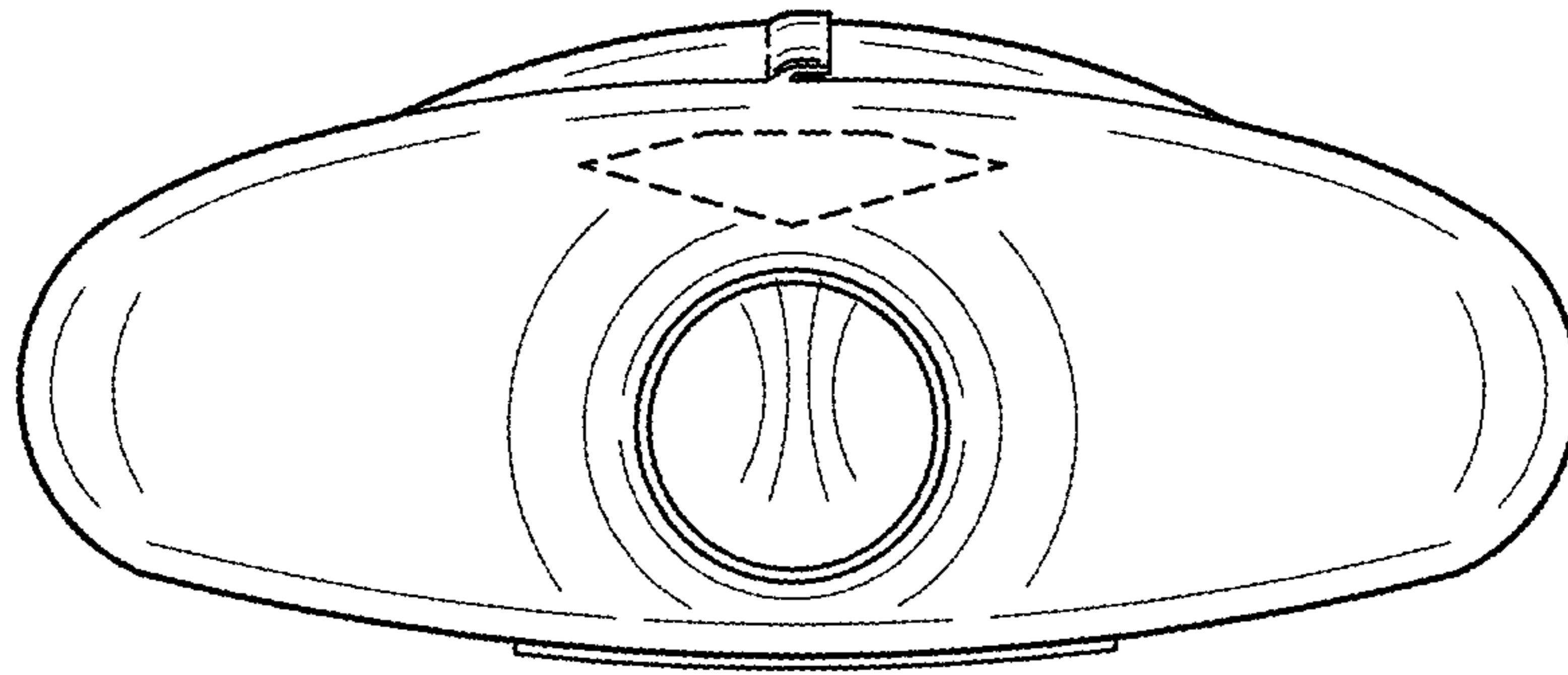

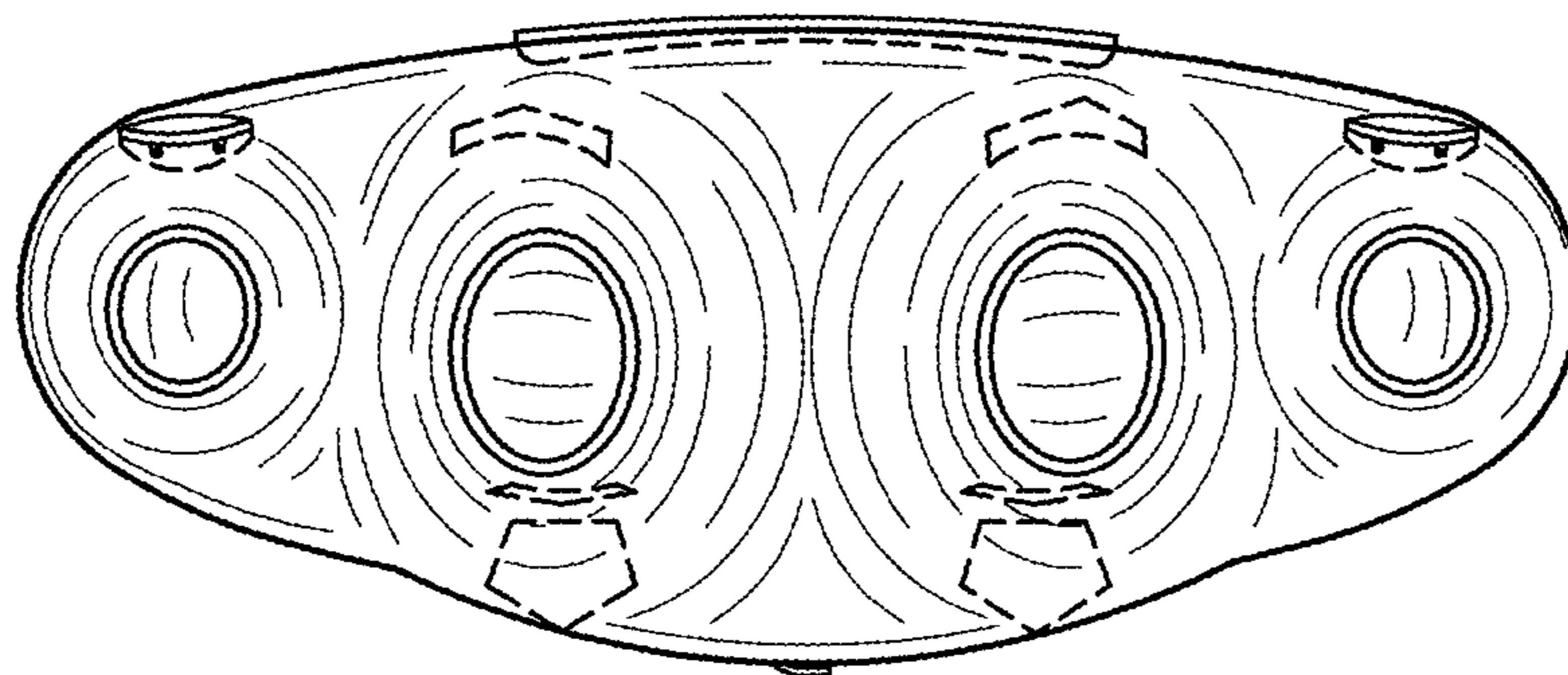

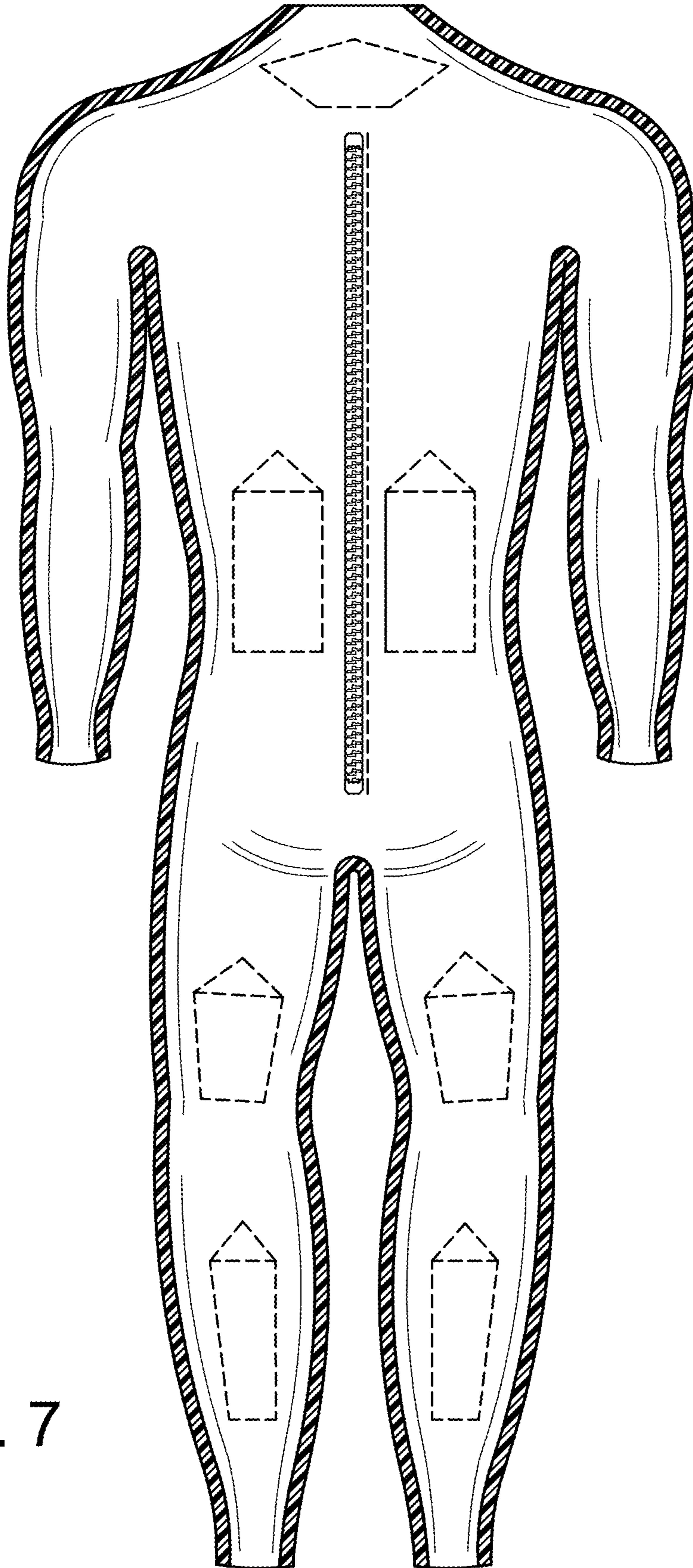

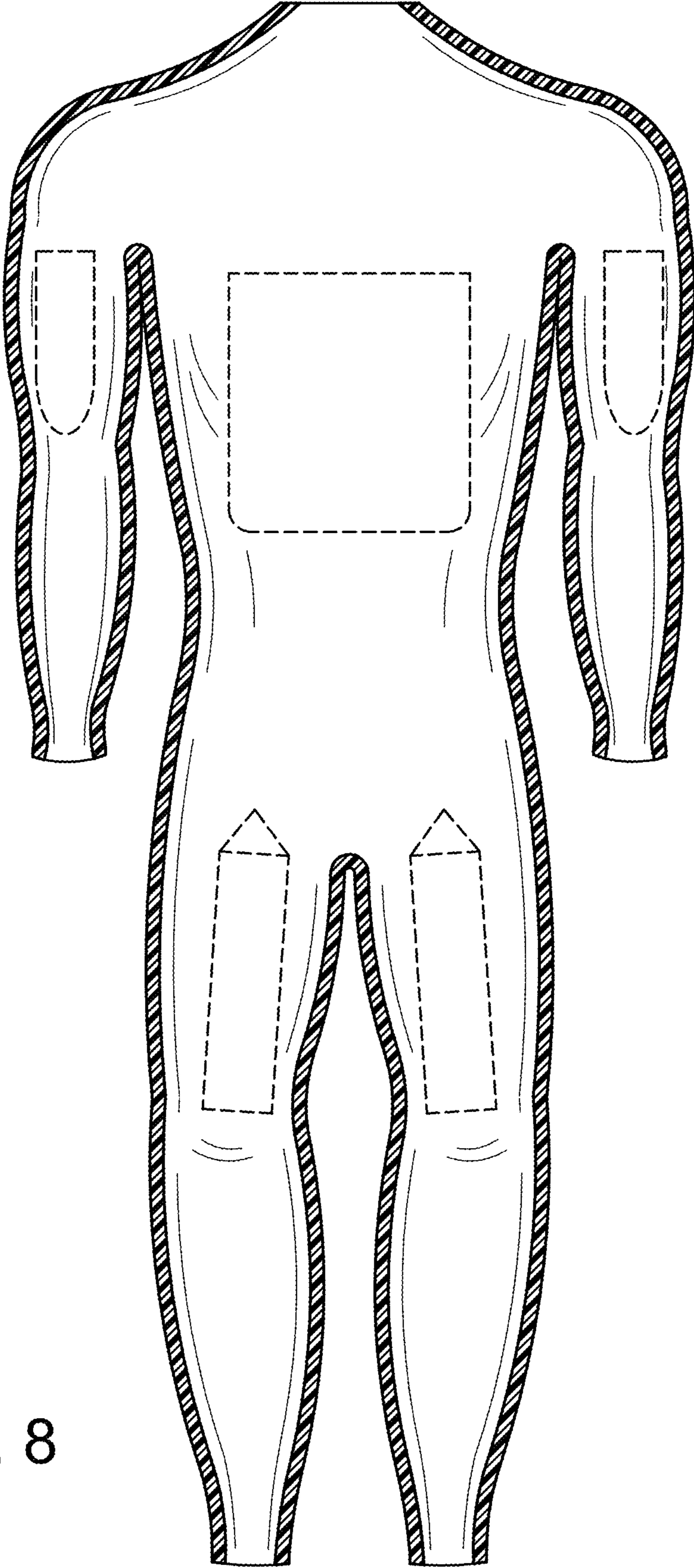
