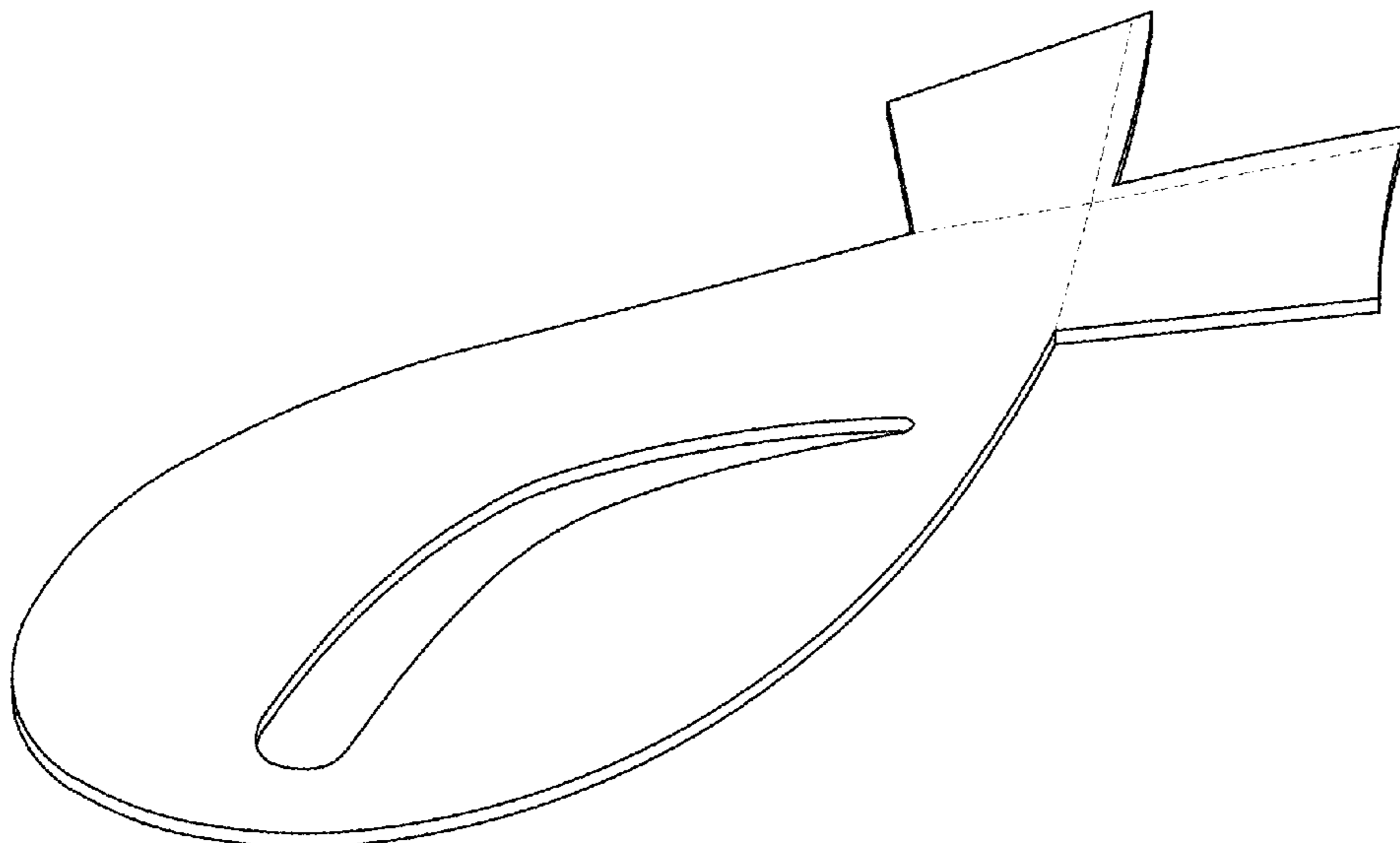
(57) **CLAIM**

The ornamental design for an eyebrow stencil, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an eyebrow stencil embodying my new design;
FIG. 2 is a back view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a first side view thereof;
FIG. 6 is a second side view thereof;
FIG. 7 is a bottom, front and side perspective view thereof;
and,
FIG. 8 is a top, back and side perspective view thereof.

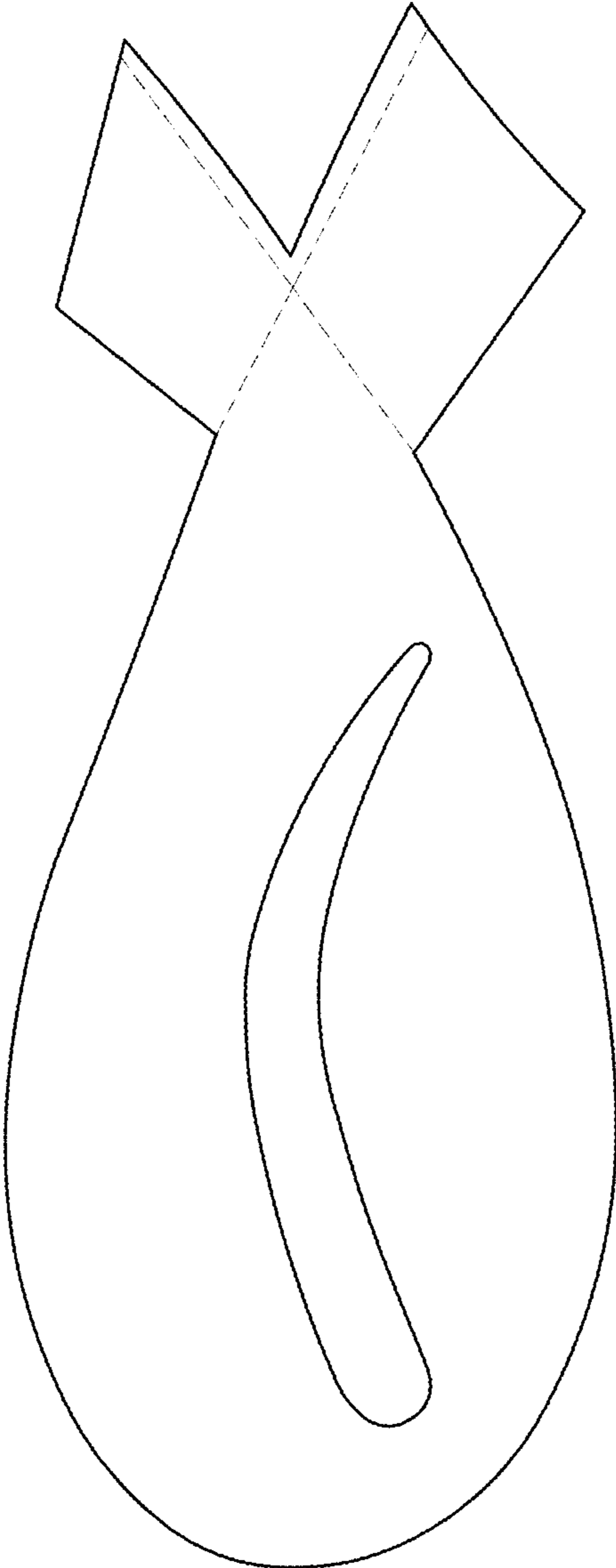

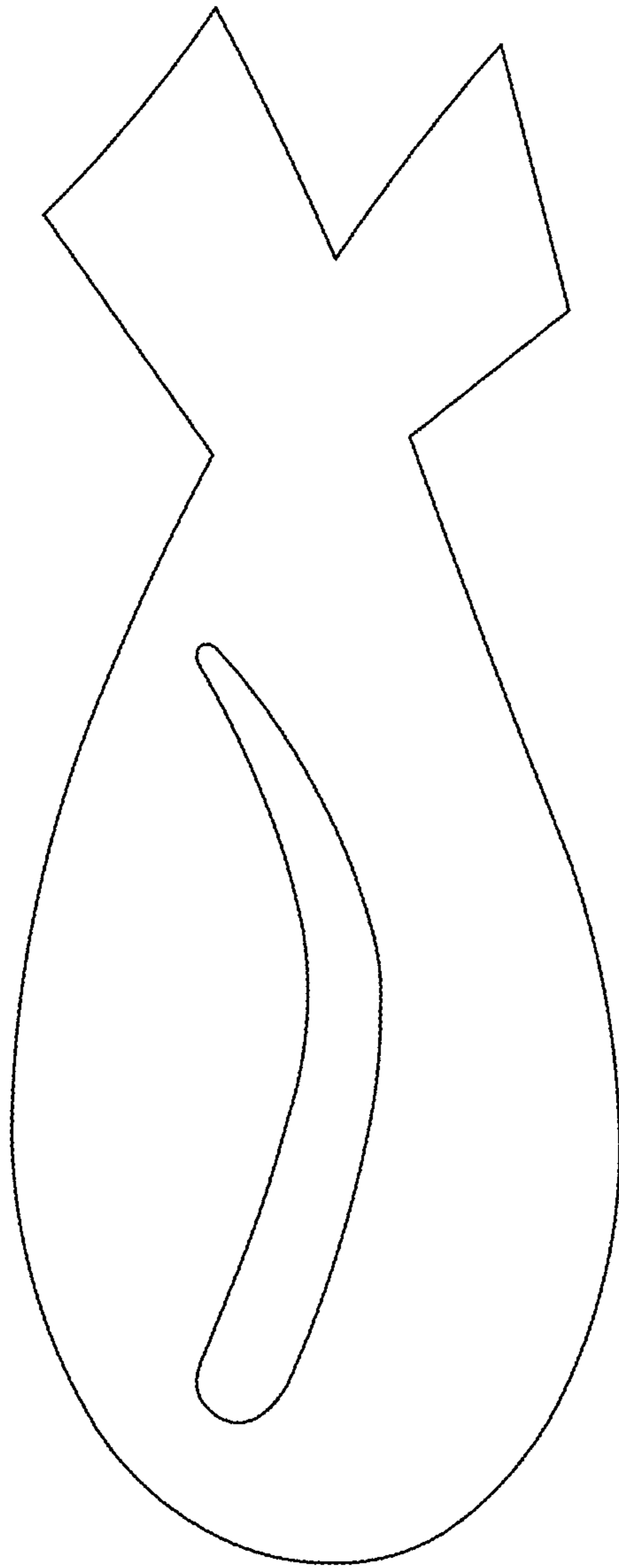

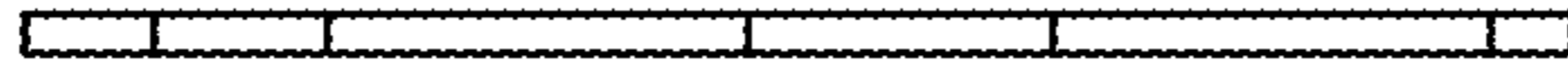

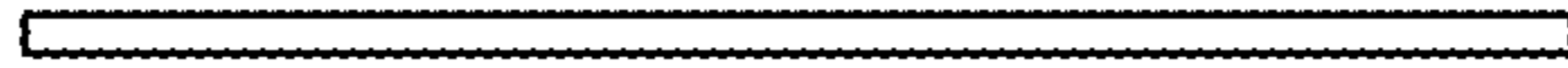

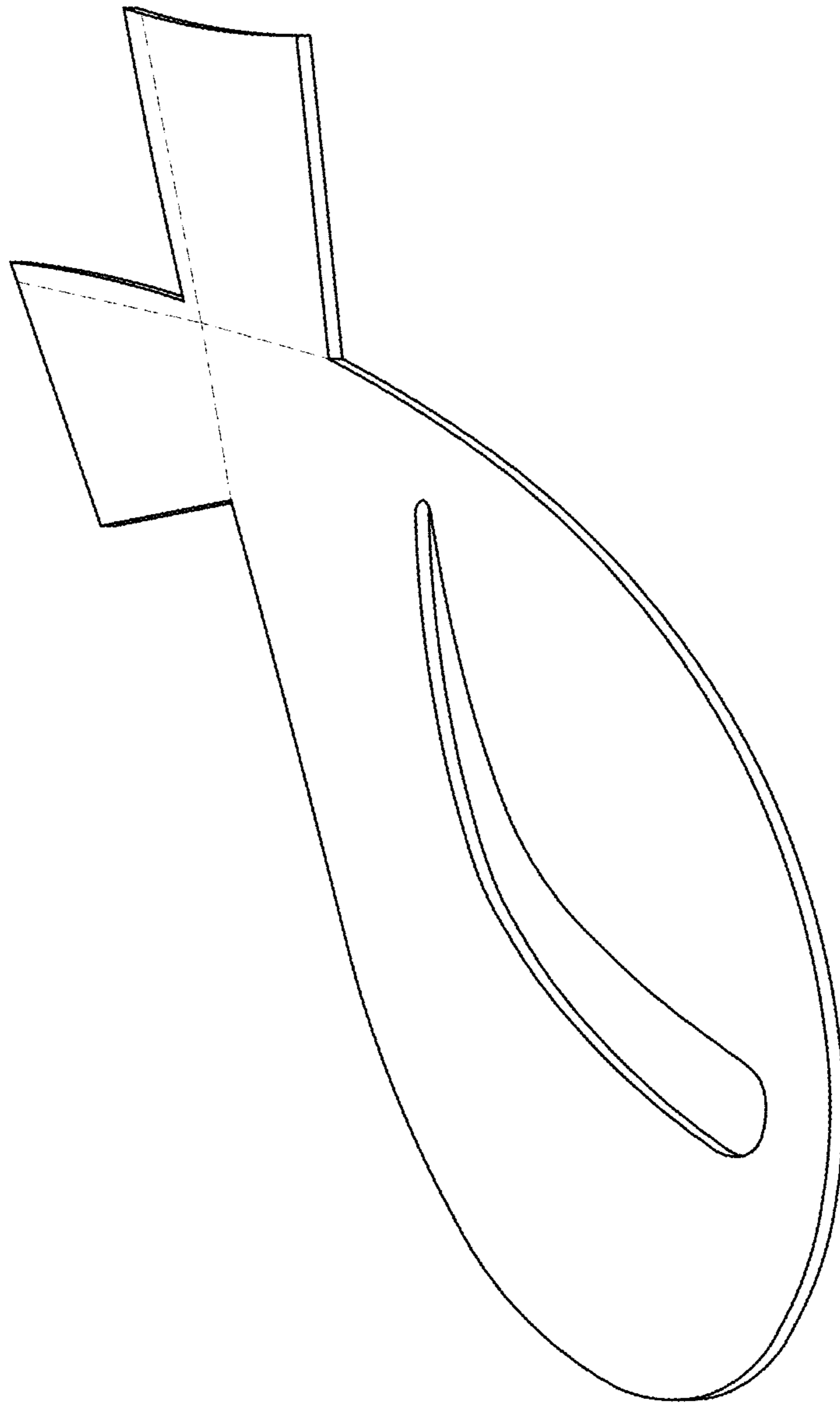

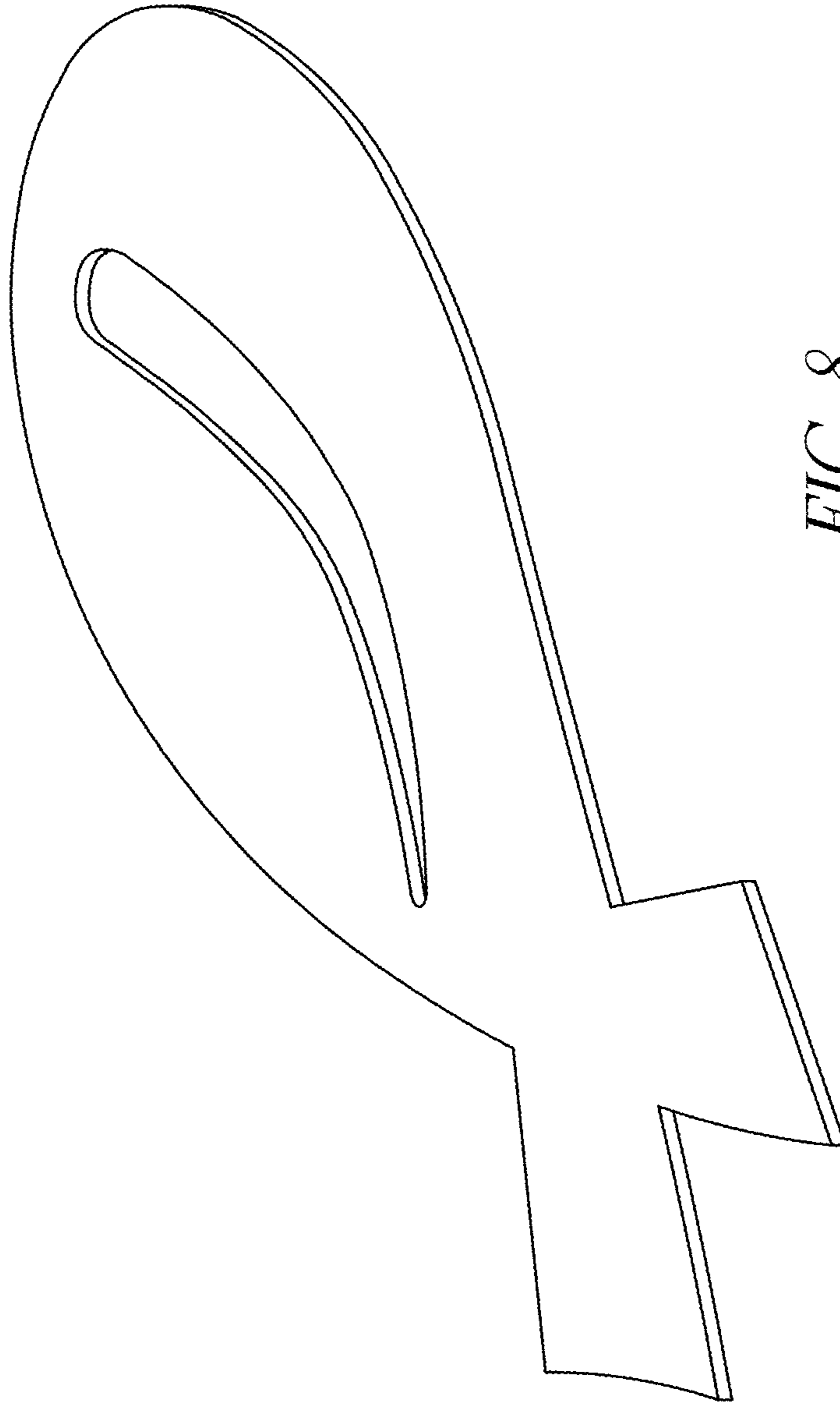
