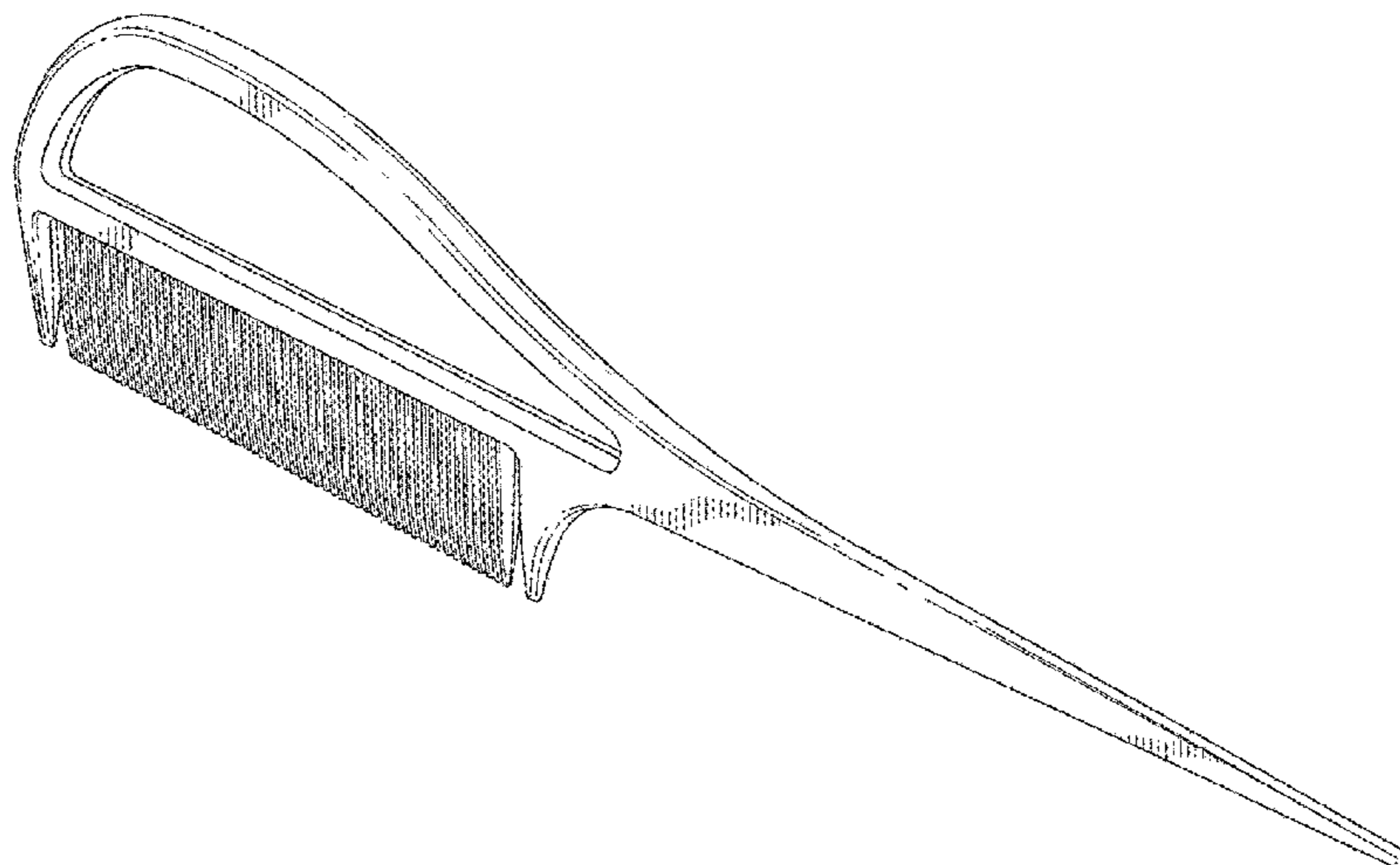
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom left perspective view of the styling comb;

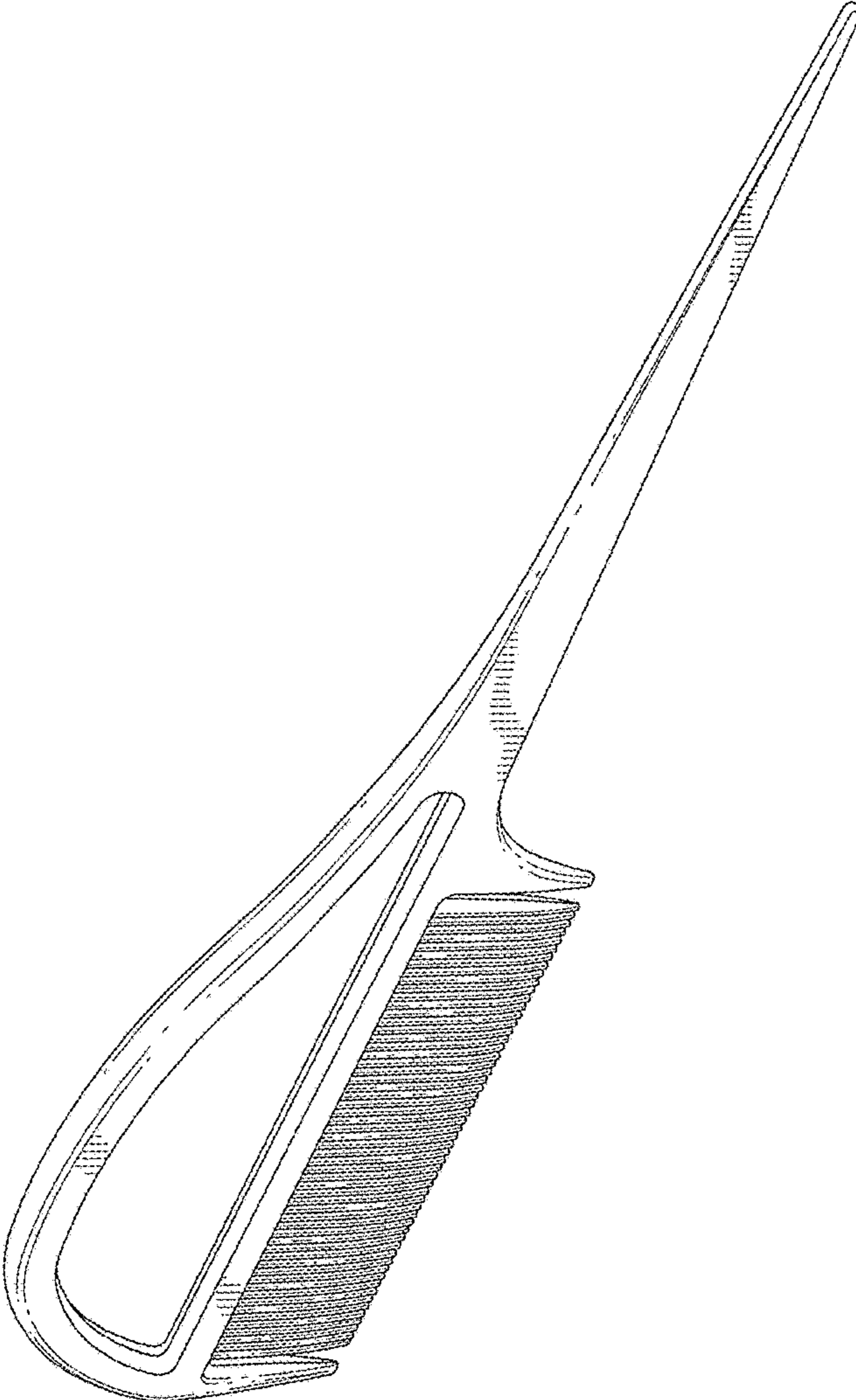

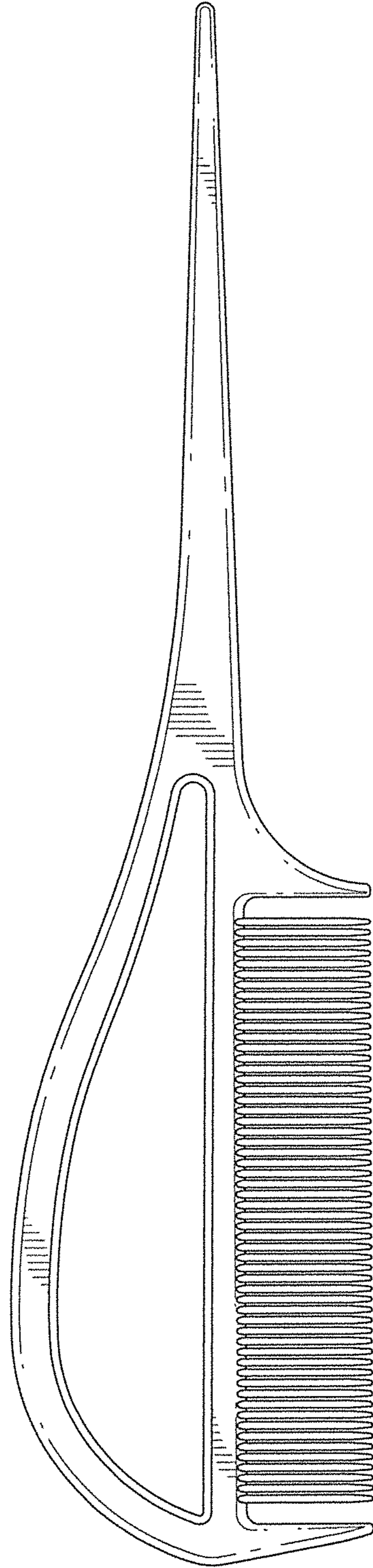

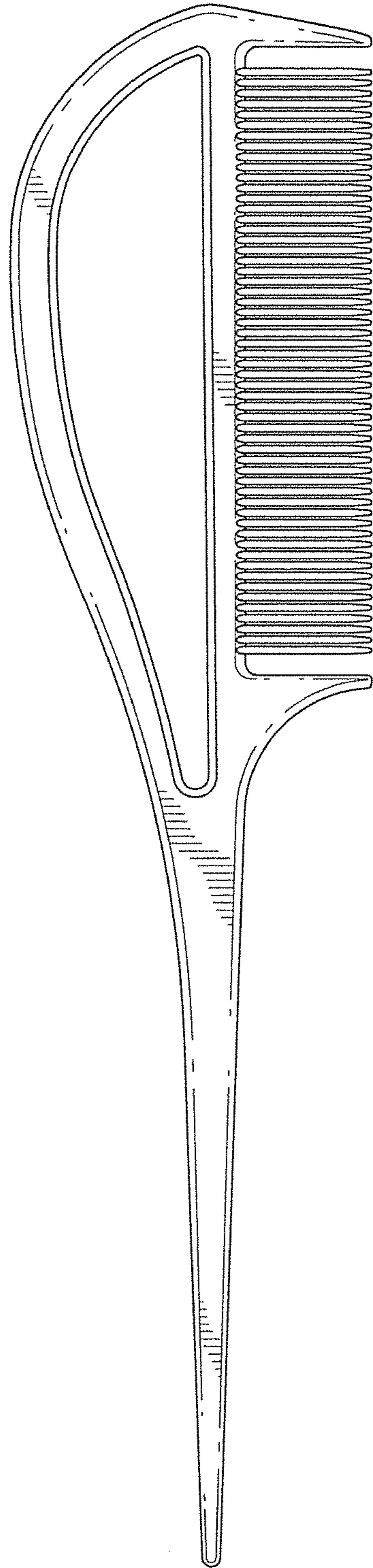

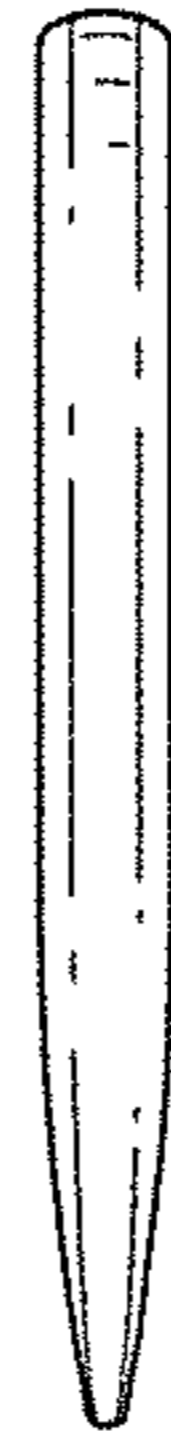

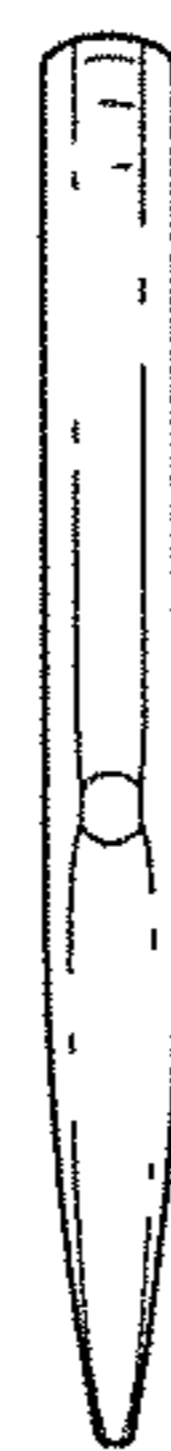

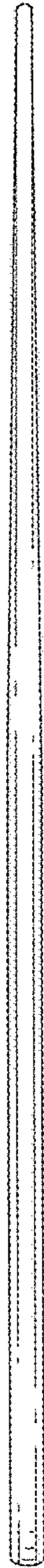
