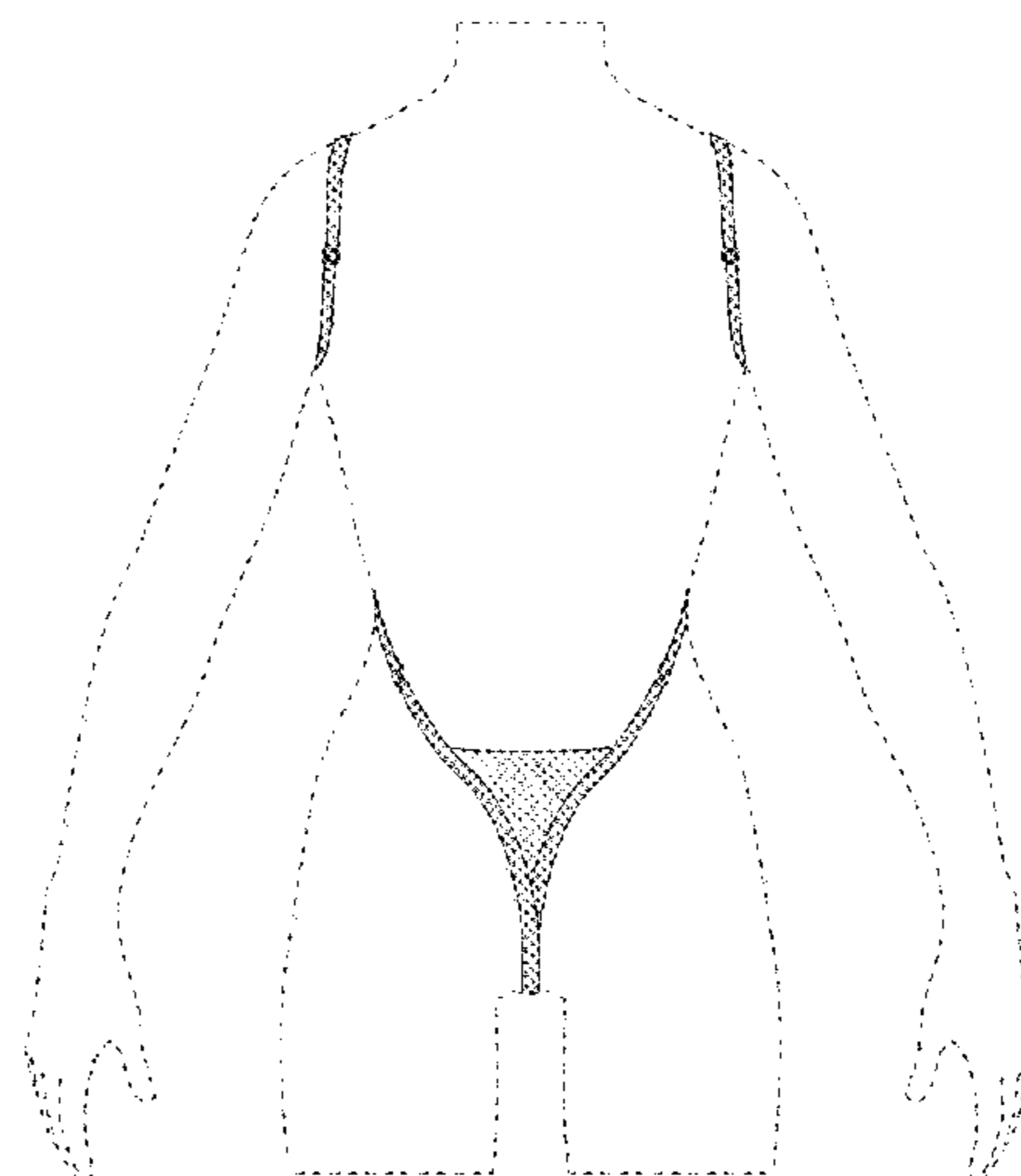
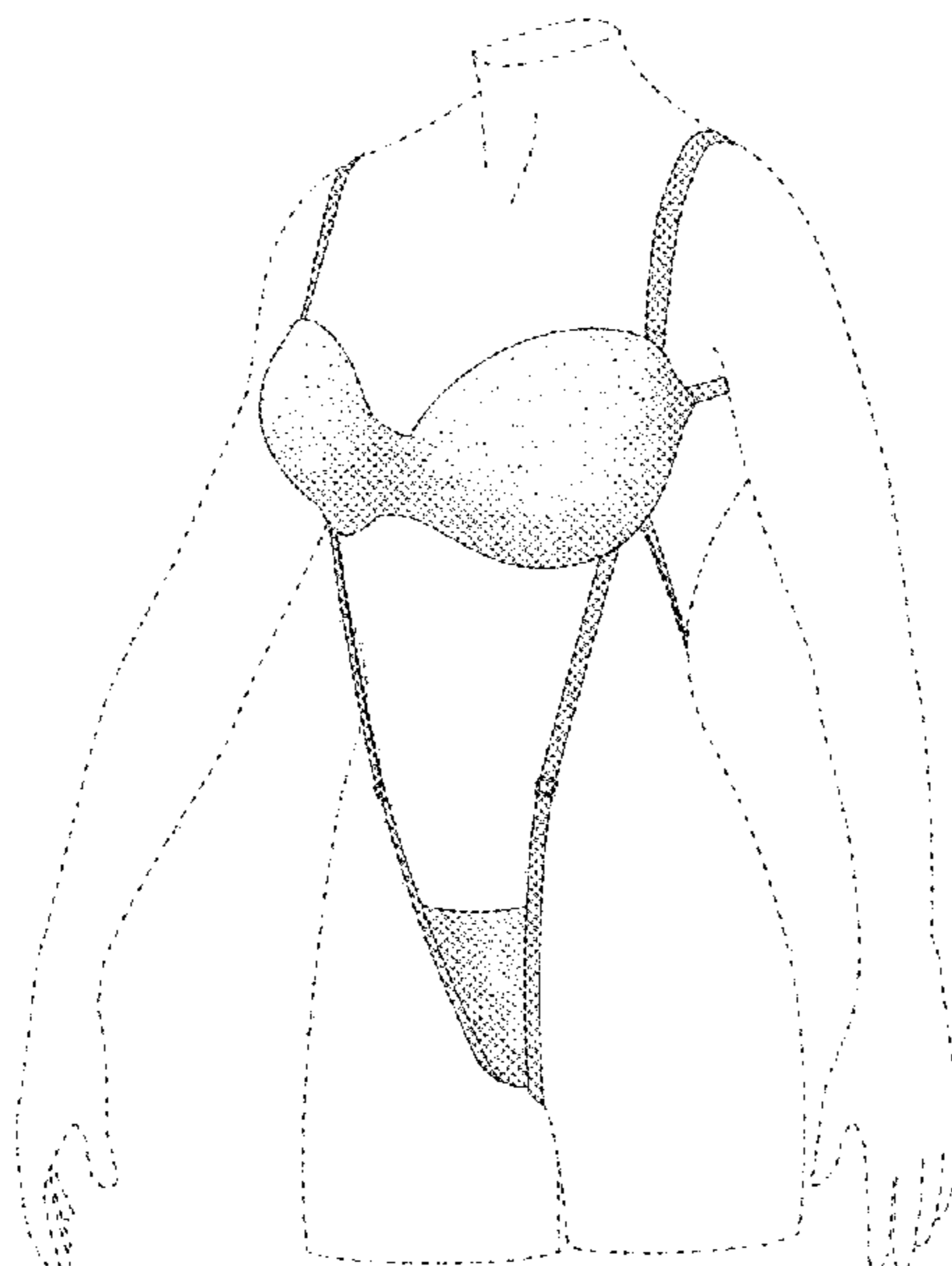

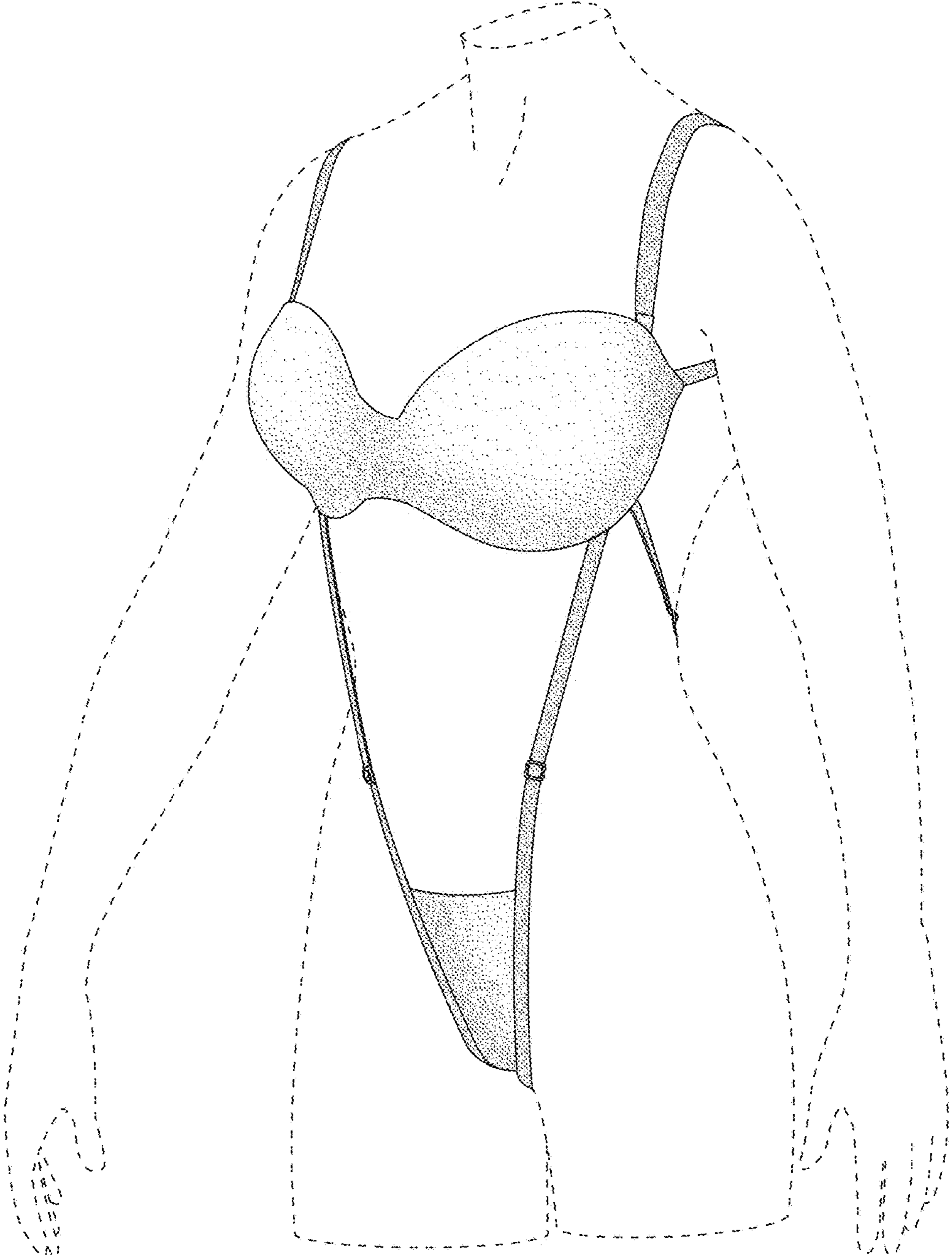
The ornamental design for a backless support bra with integrated underwear, as shown and described.

**DESCRIPTION**

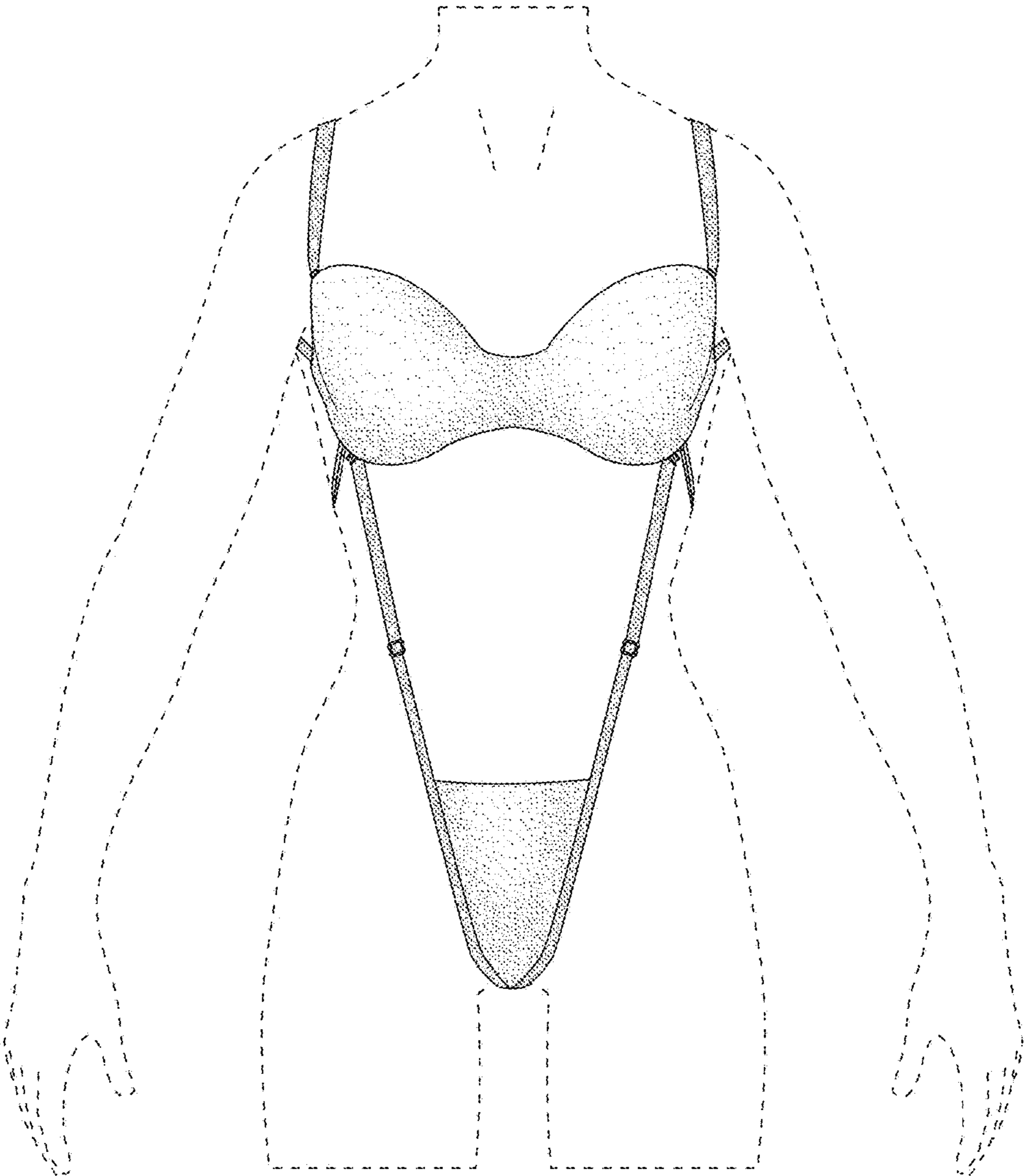

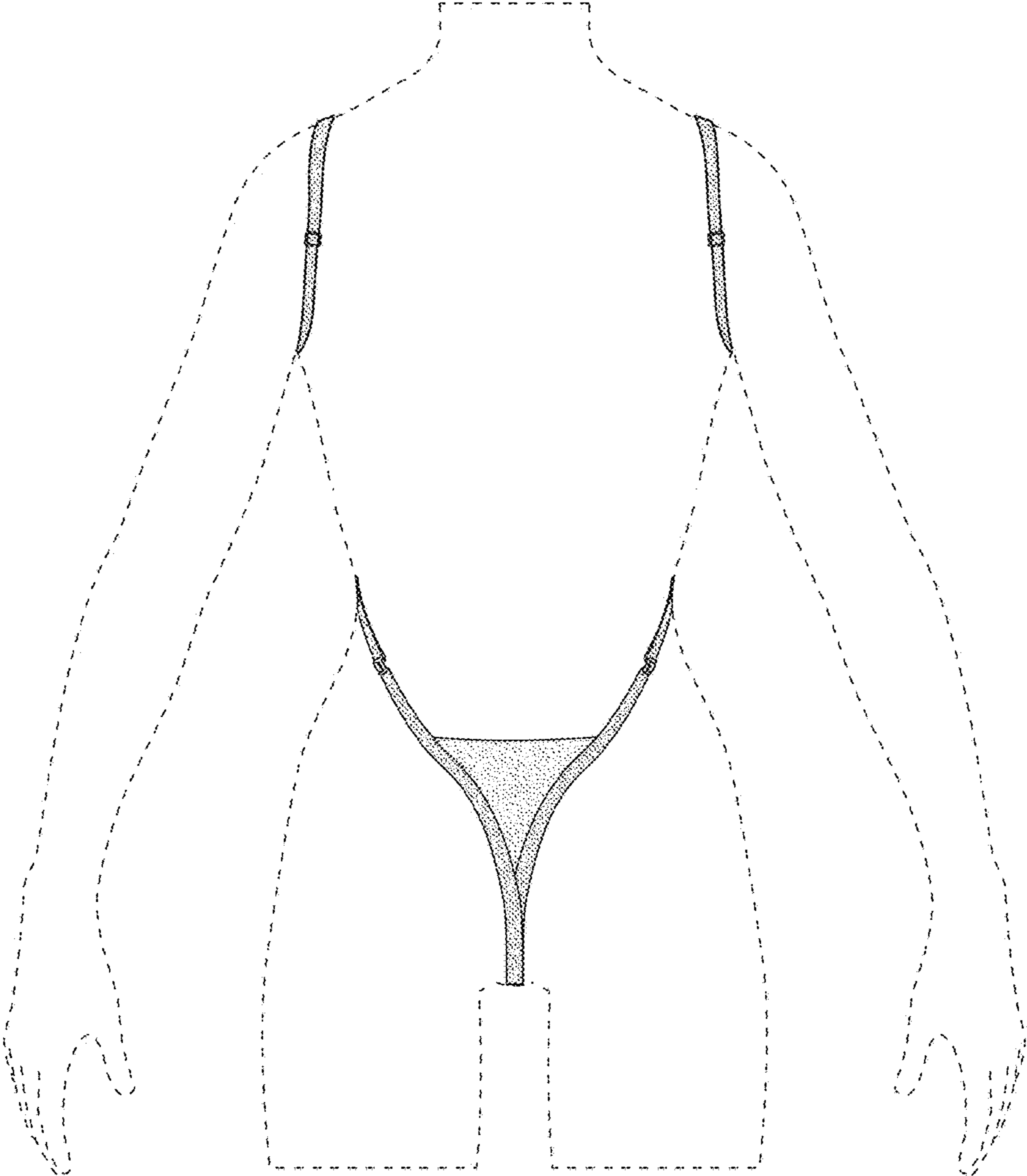




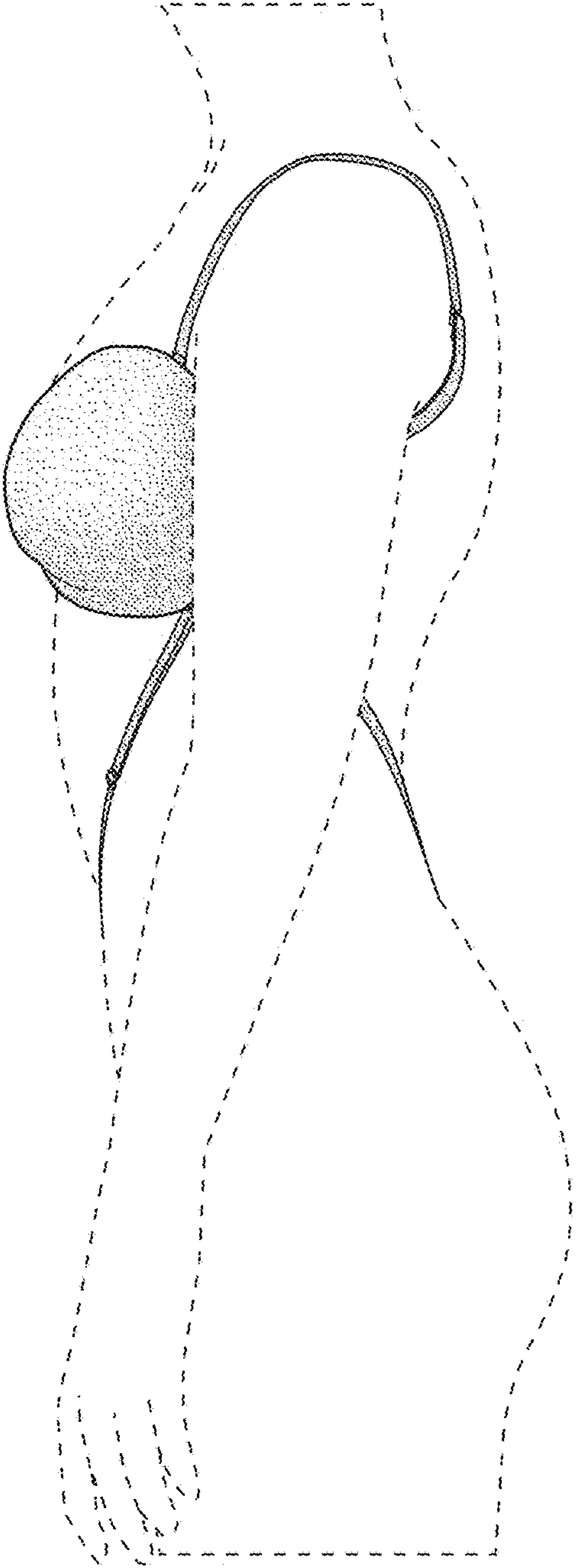

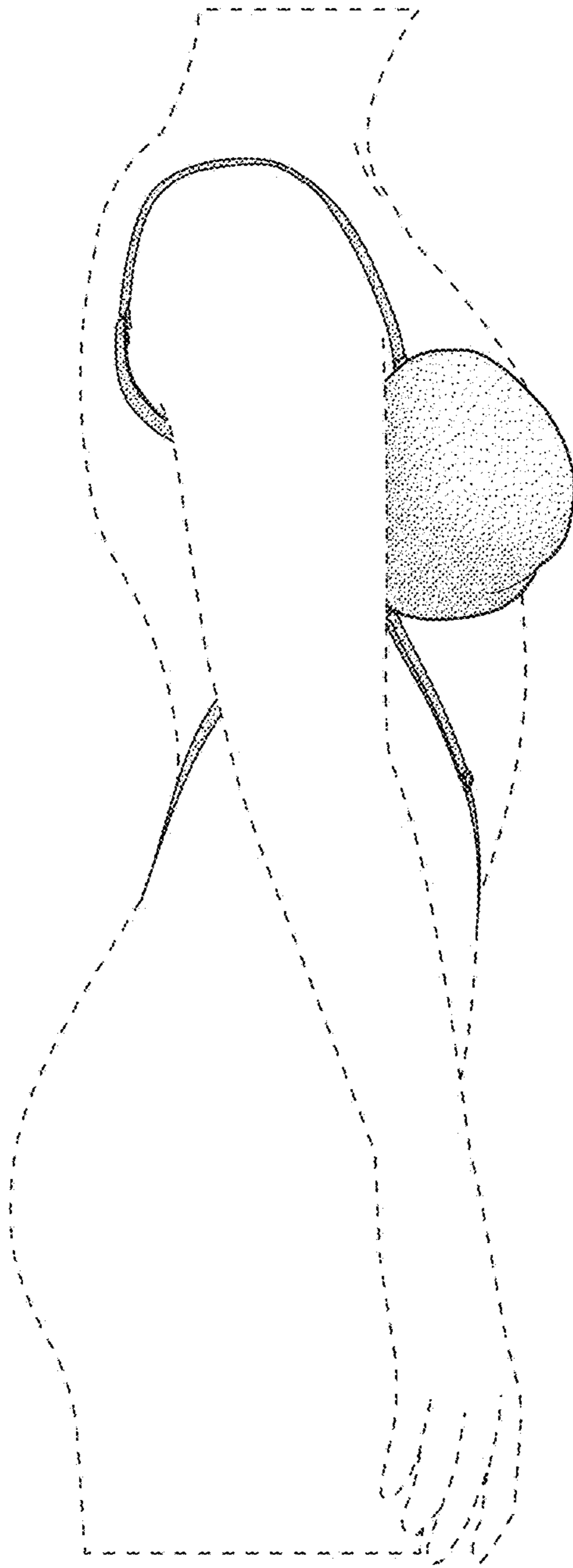

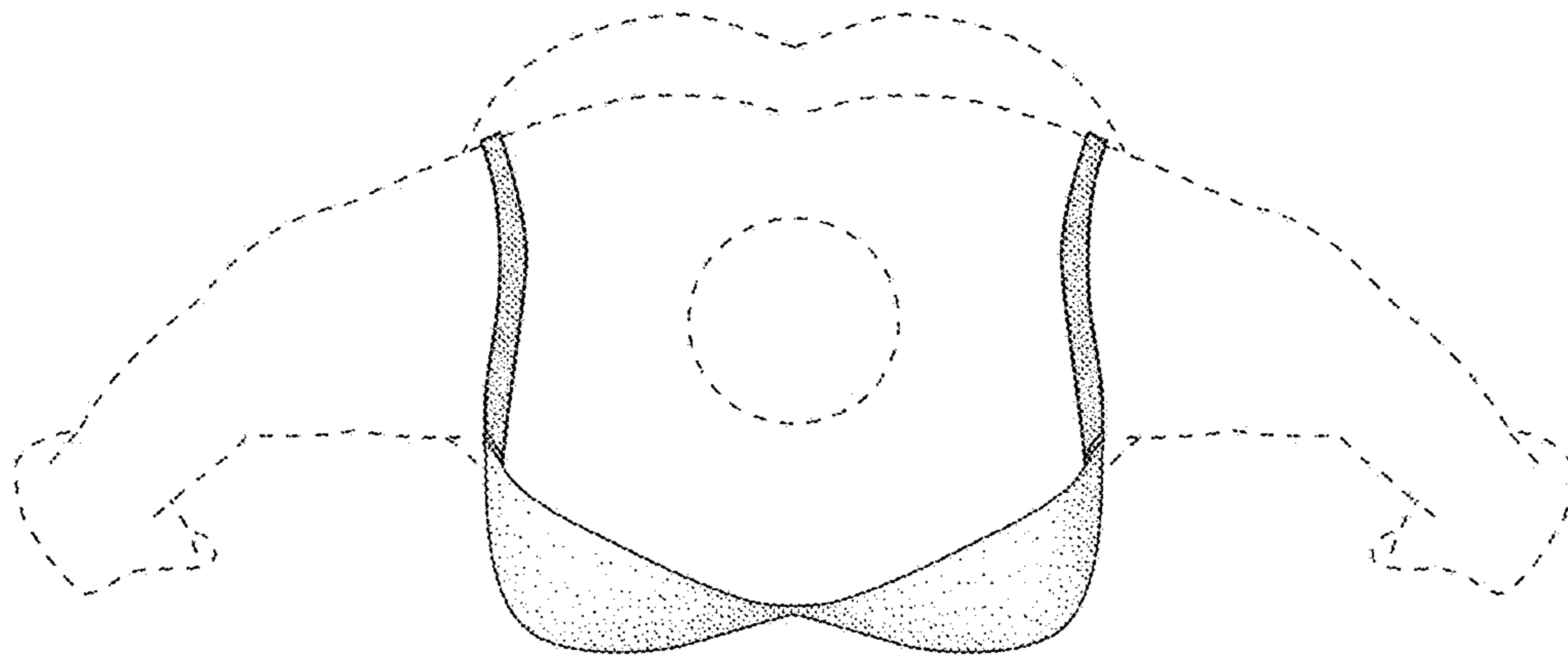

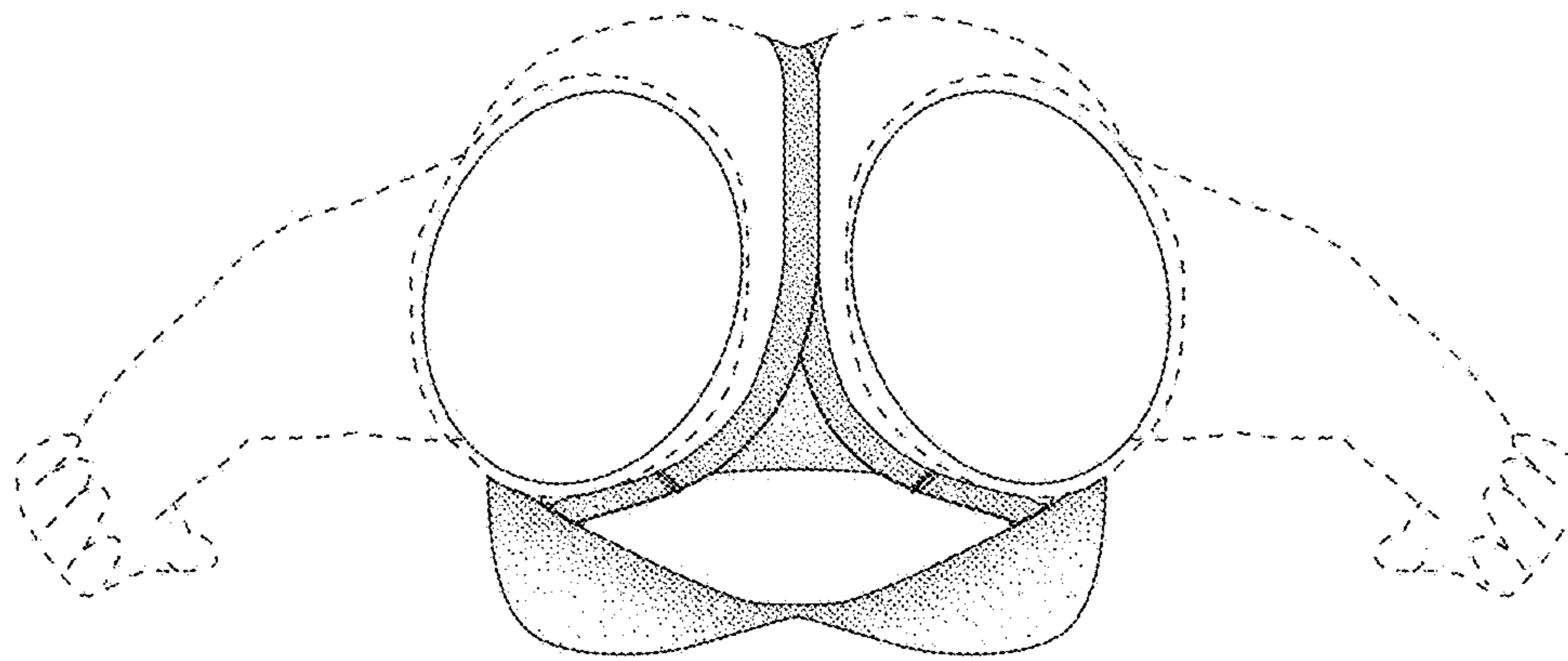
