DESCRIPTION

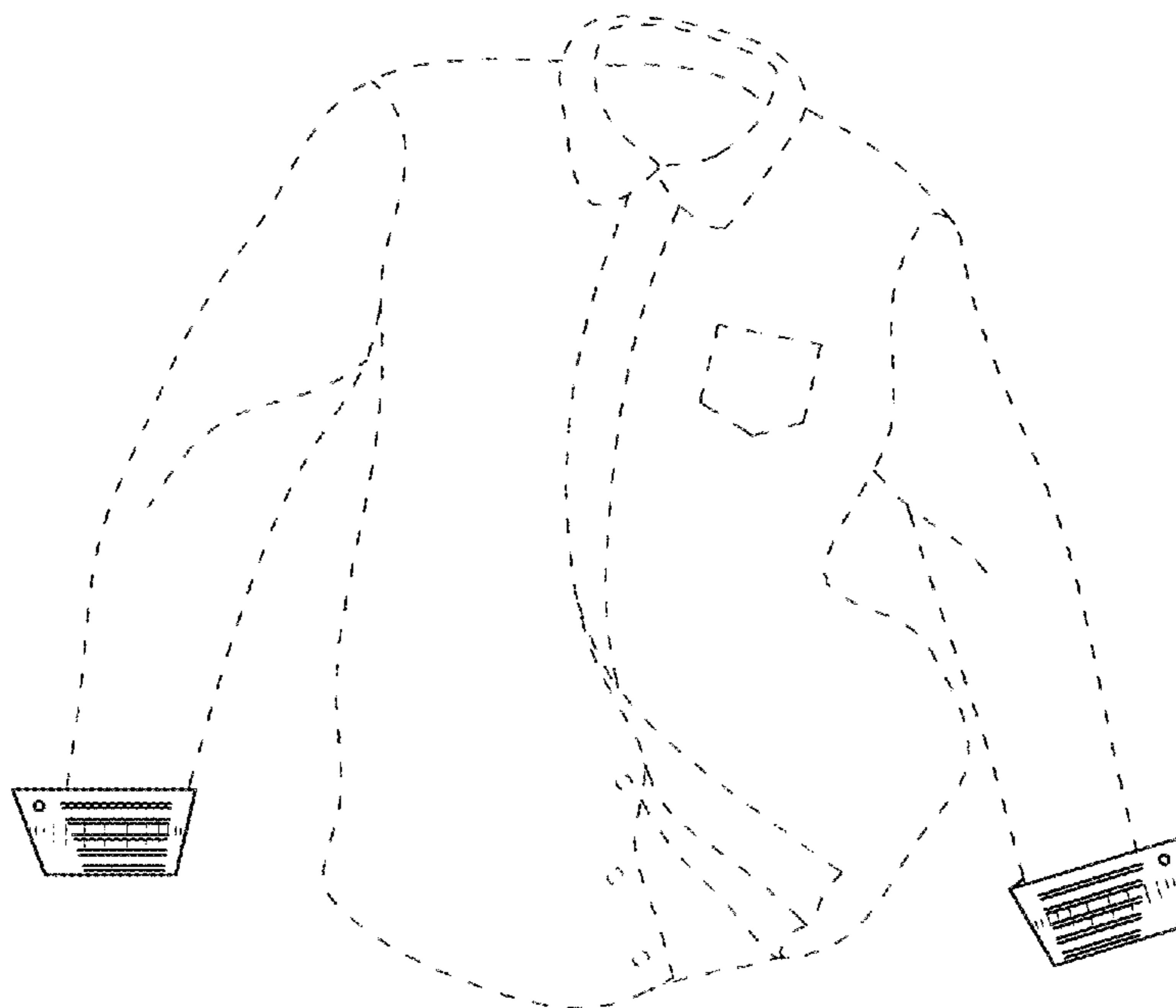
FIG. 1 is a perspective view of a vented cuff showing my new design in use with a shirt having a shirt pocket;

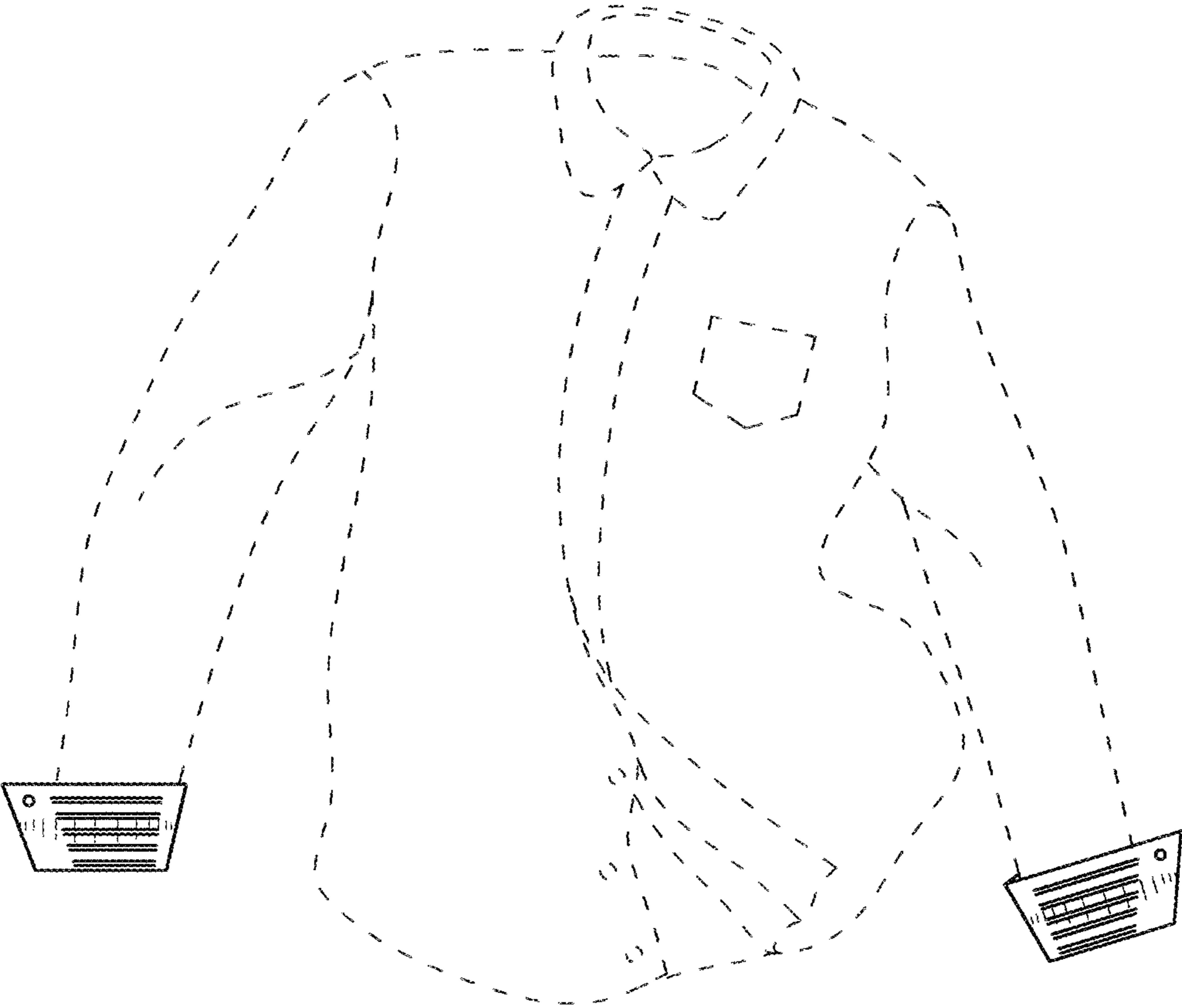

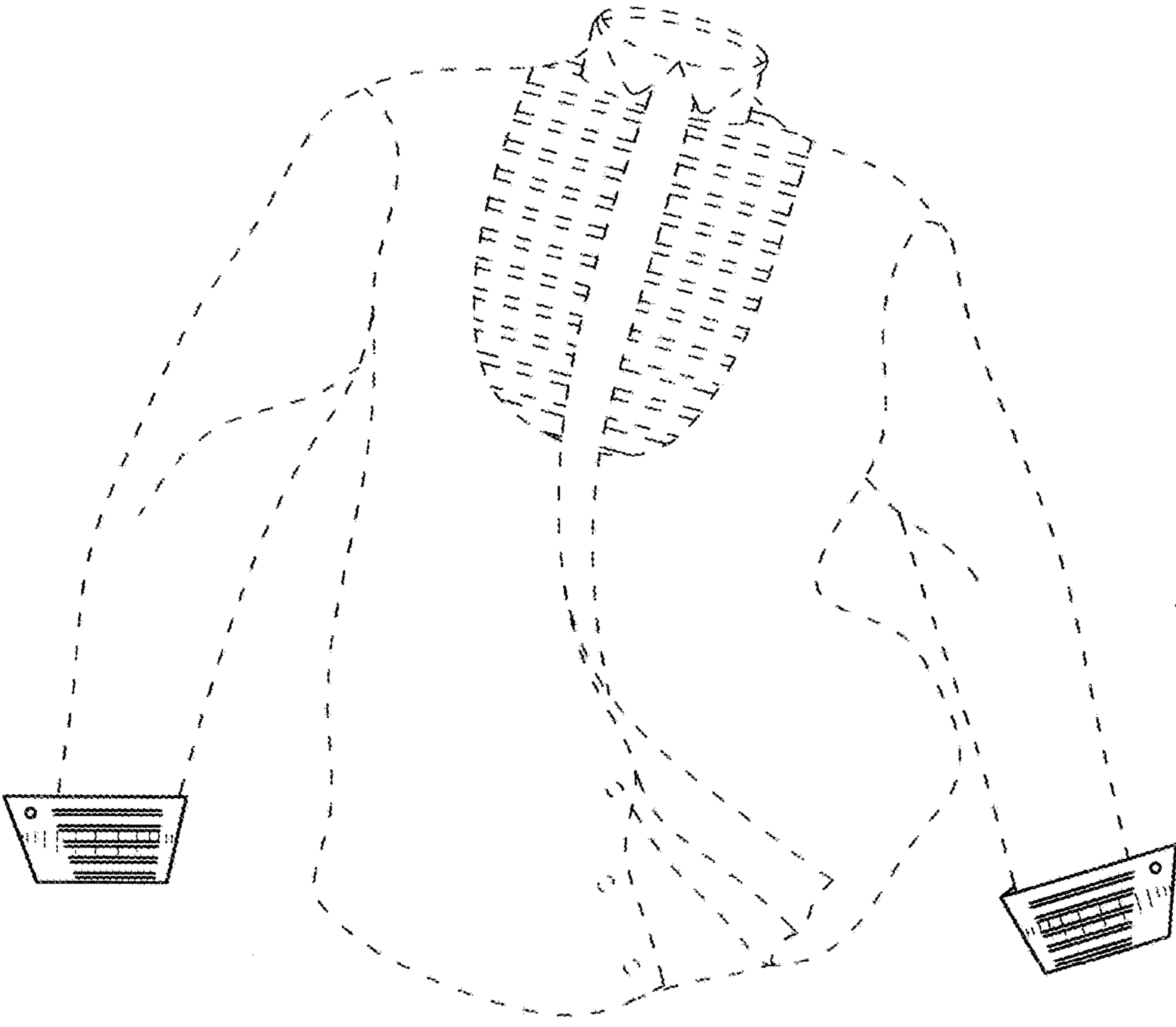

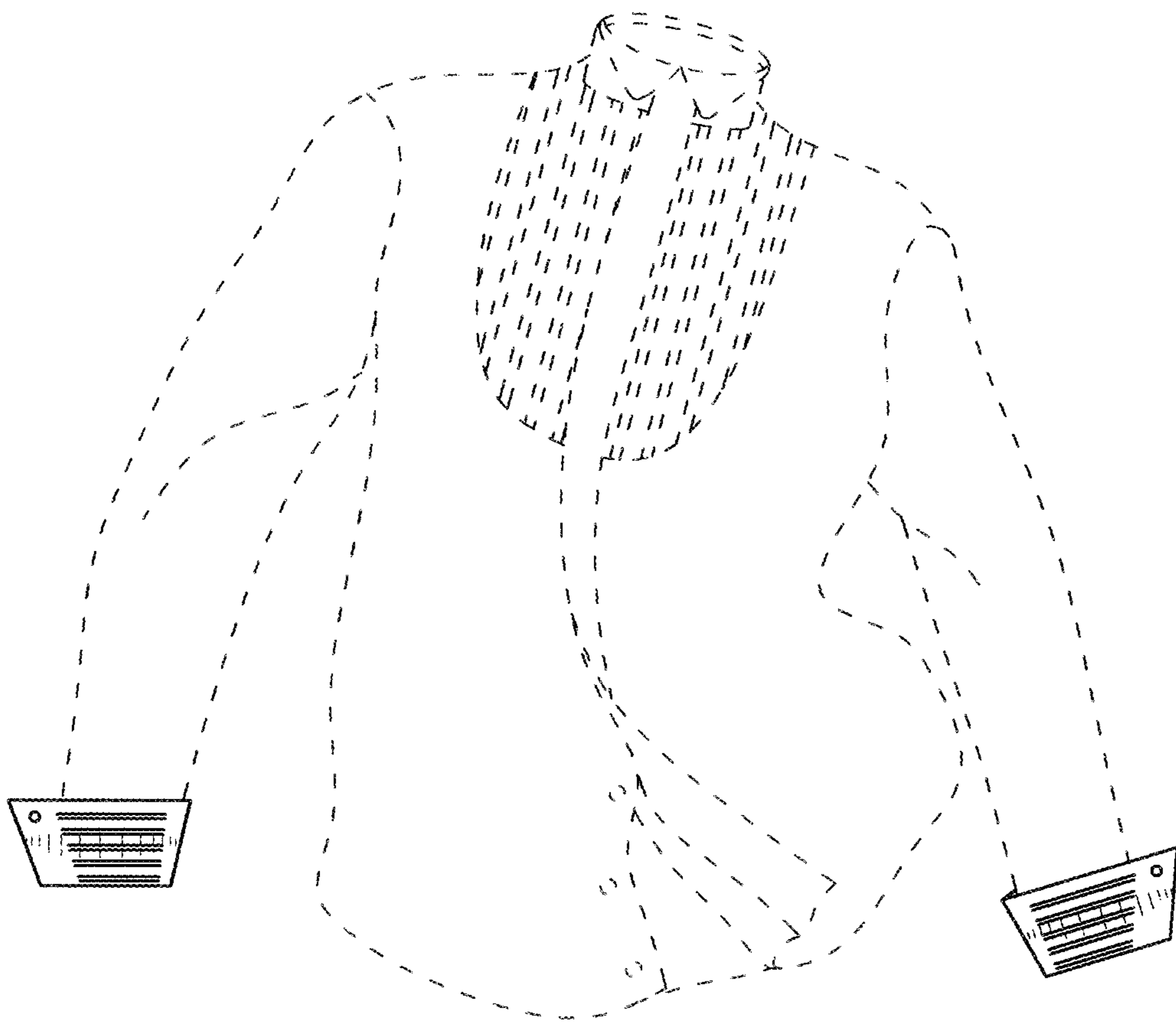

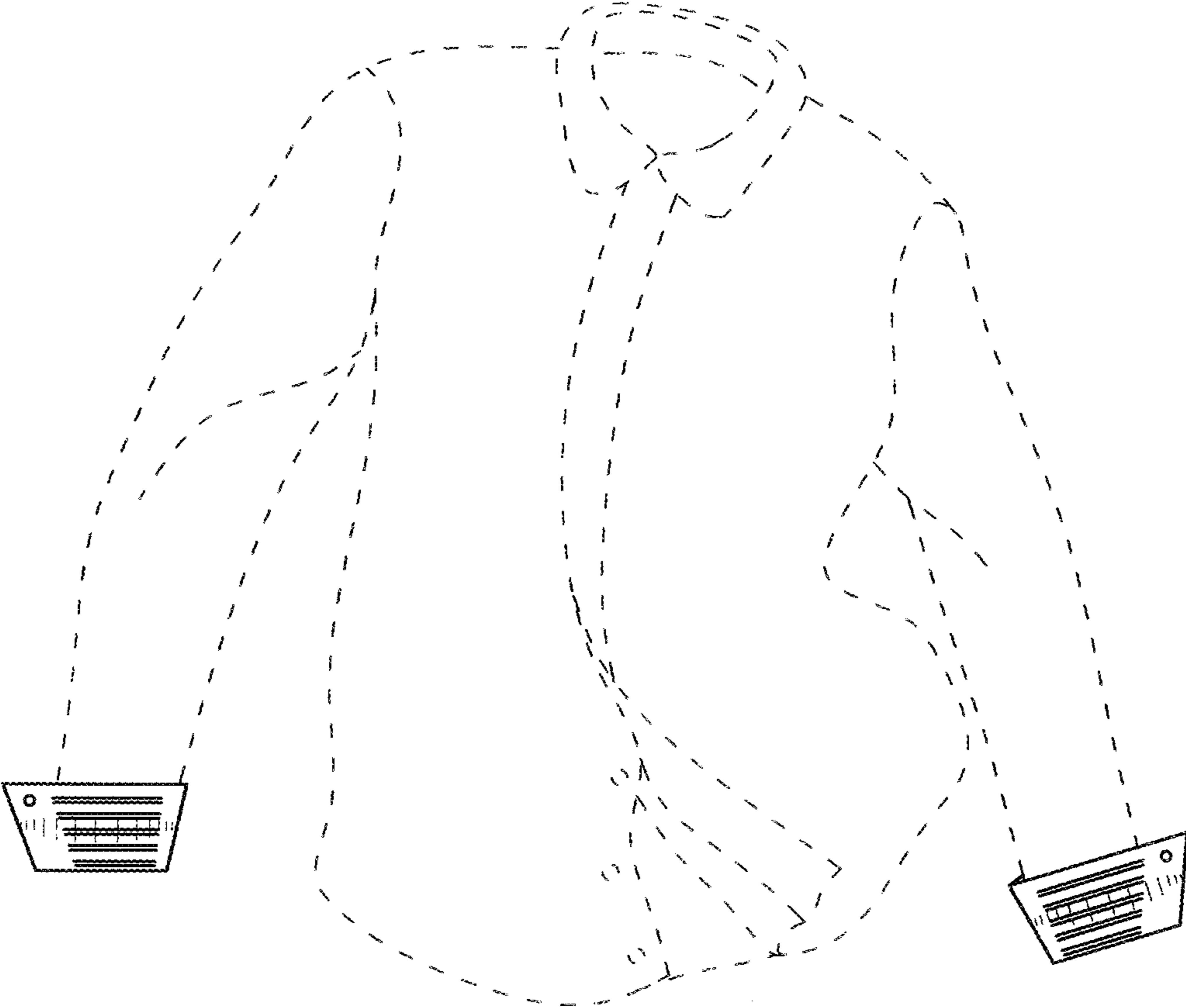

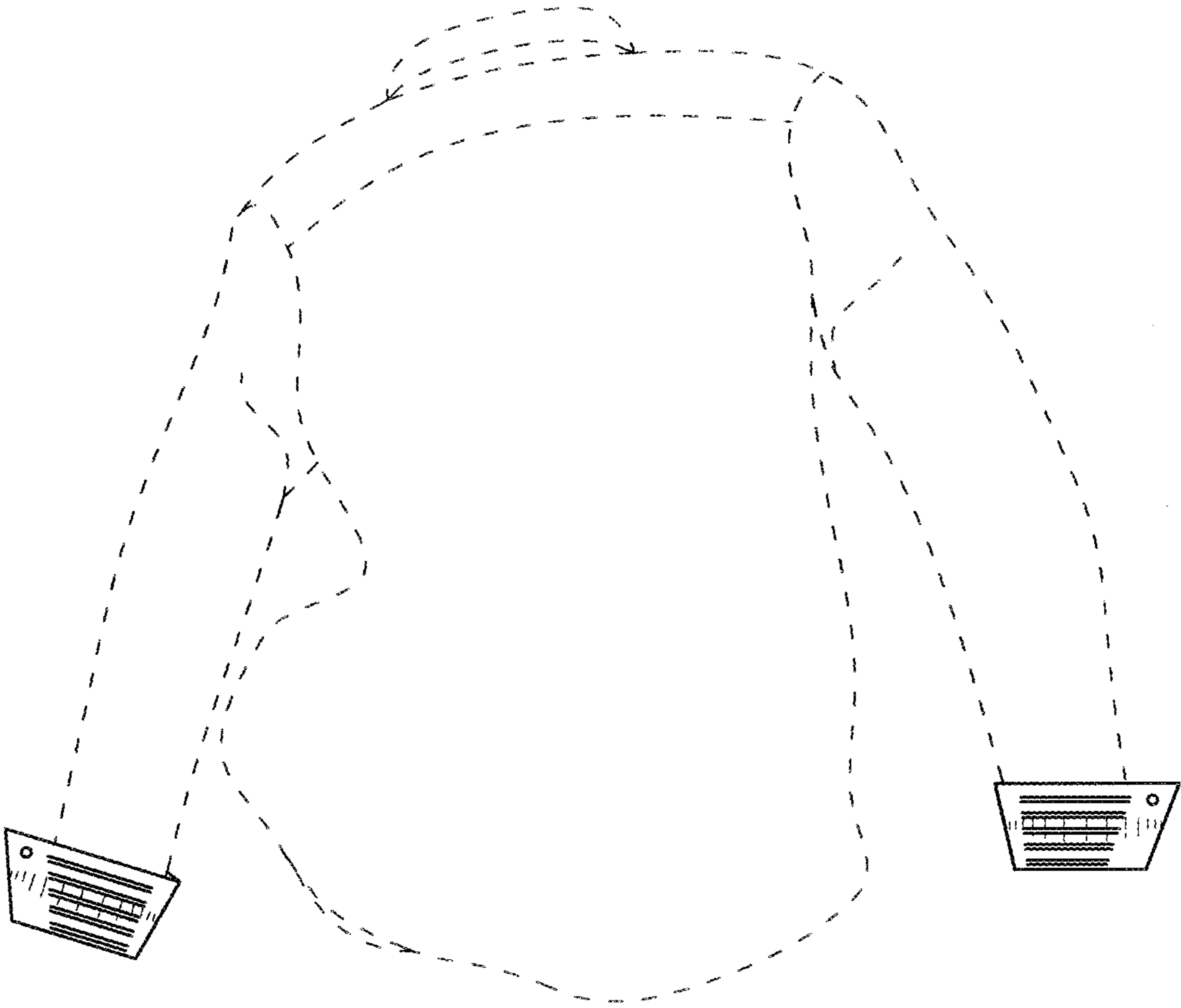

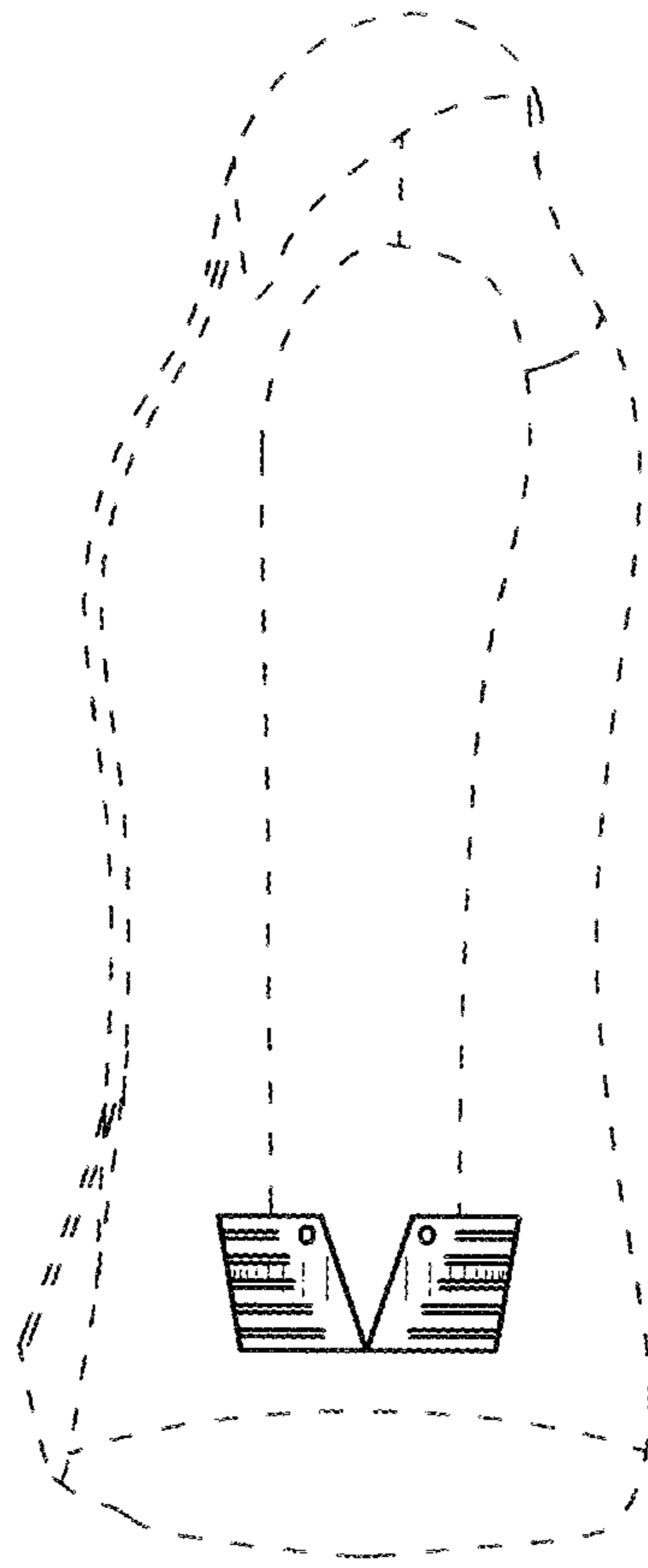

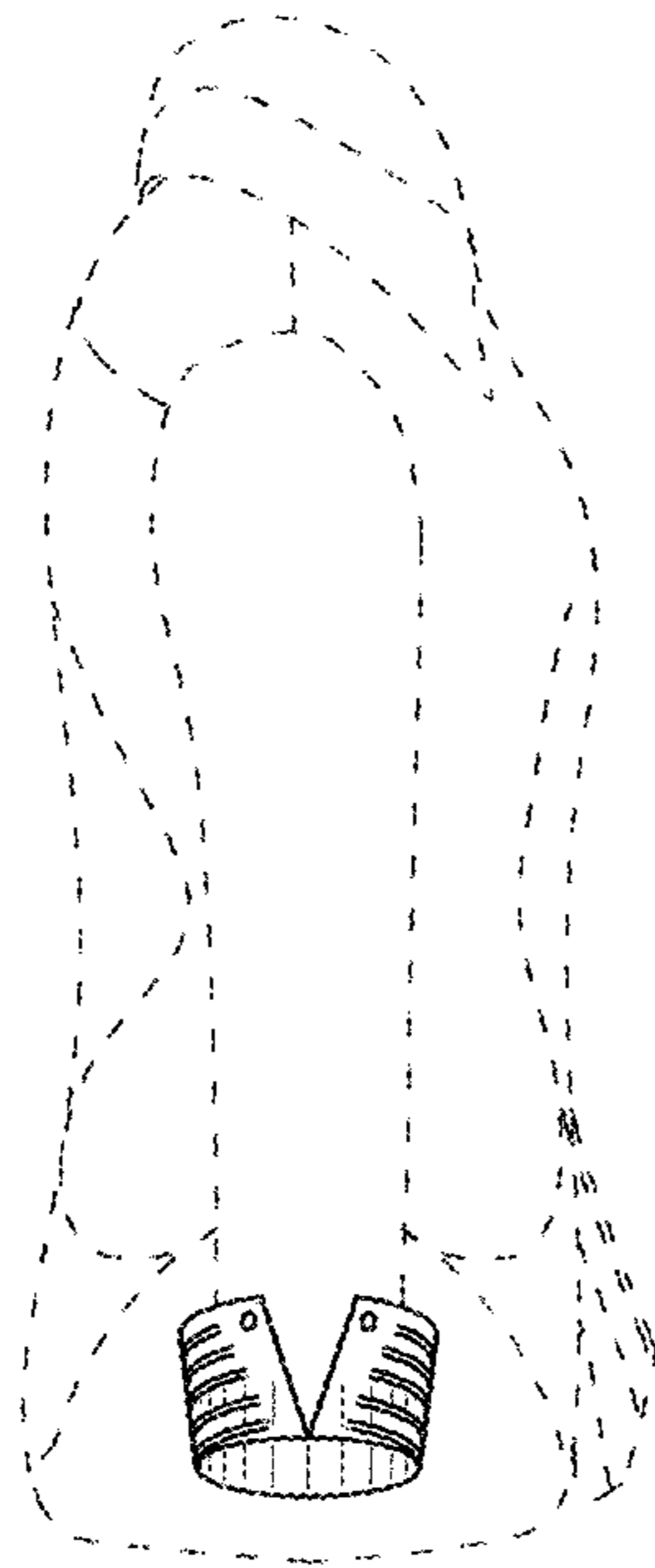

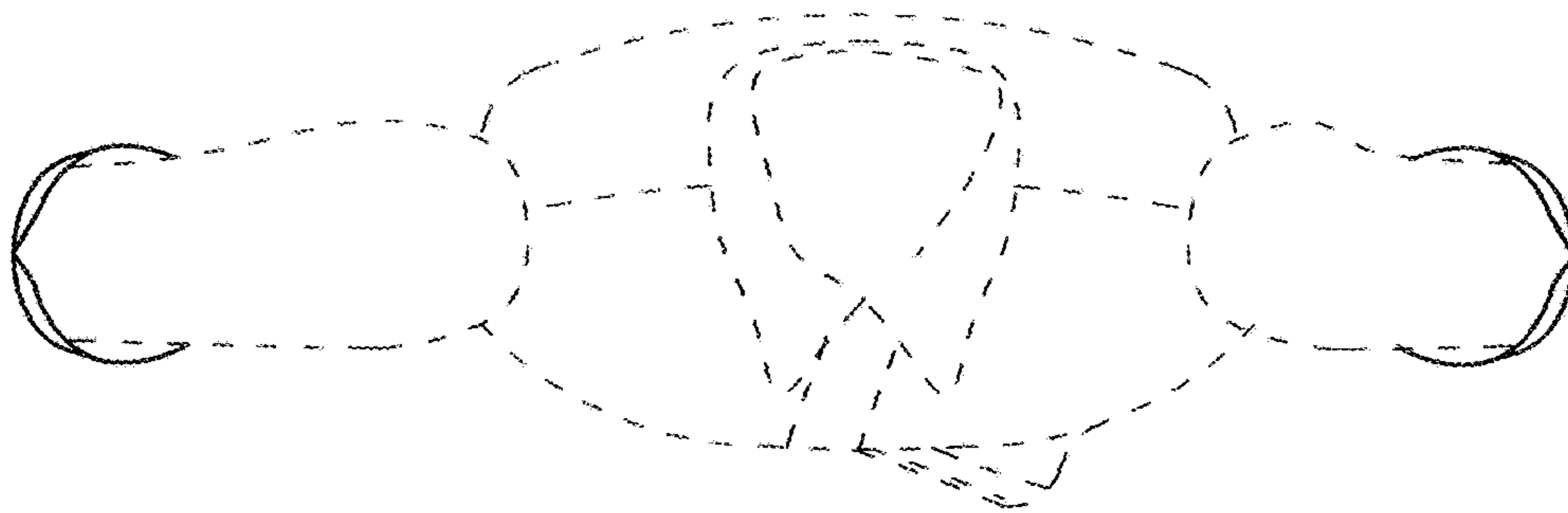

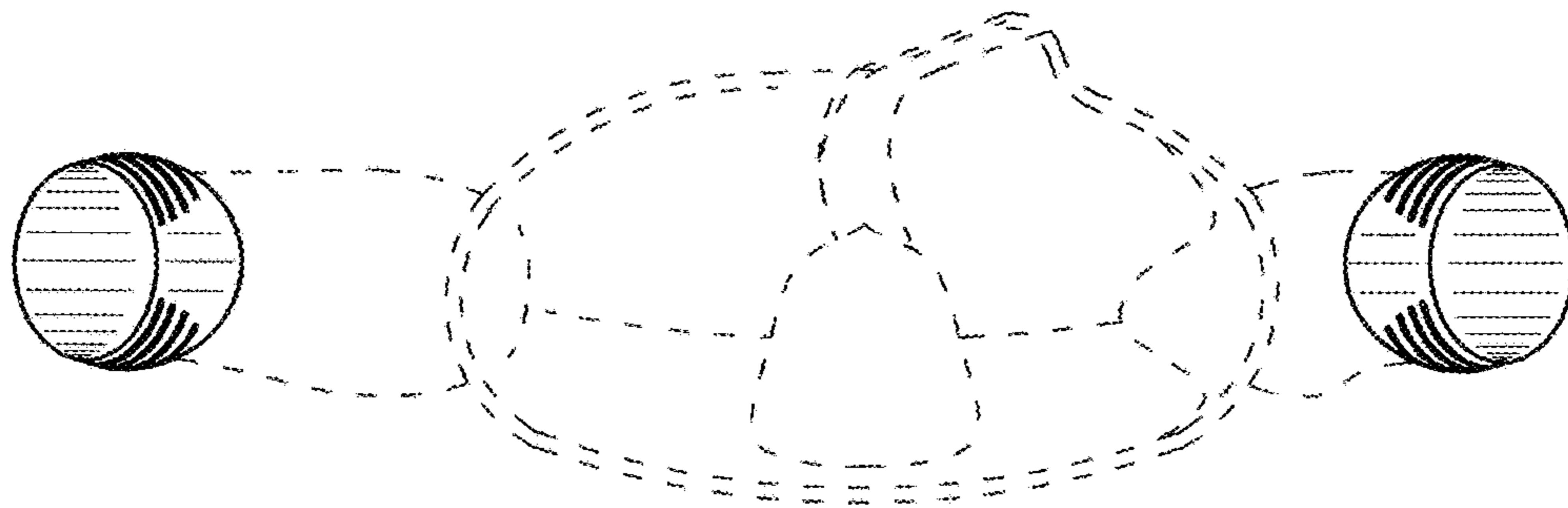
